# RE: Fingal County Council, proposed Part 8 for Moyne Road / Hole in the Wall Junction Improvement Scheme

Fingal County Council are currently preparing preliminary design drawings for Moyne Road/ Hole in the Wall Junction Improvement Scheme (see attached drawing). The majority of the roads scheme is within the administrate area of Fingal County Council but will require to be linked into the existing road network at the Hole in the Wall / Marrsfield Avenue junction. This will require the upgrade/ reconstruction of portion of the existing spur road constructed as part of the Clongriffin development south of the Mayne River which forms the boundary line between the administrative areas of Fingal County Council and Dublin City Council. To enable this partial road reconstruction to be incorporated into the scheme, Fingal County Council proposes to enter into a section 85 agreement, under the Local Government Act 2001, with Dublin City Council. This agreement will facilitate the full scheme, proceeding to public consultation under the Planning and Development Acts, 2000 – 2014, & Part 8 of the Planning and Development Regulations 2001 – 2013.

The Moyne Road extends from the Malahide Road (R107) at Balgriffen to the Coast Road (R106) between Portmarnock and Baldoyle. At present a non-signalised staggered junction arrangement exists between the Moyne Road (R123), The Hole in the Wall Road and the Drumnigh Road (R124). The aim of the scheme is to replace the current staggered junction arrangement with a standard controlled cross road arrangement. The upgraded junction/ road layout will enhance vehicular safety, provide dedicated controlled pedestrian/ cycle crossing locations and facilitate the upgrade of the public transport services by way of extensions to the current bus lane layouts in the Belmayne/ Clongriffin/ Donaghmede areas.

Dublin City Council Roads and Planning Division have reviewed the preliminary design drawings and are happy with the scheme to proceed subject to a Section 85 Agreement.

#### Proposal

A request to have the public right of way extinguished over the laneway to the rear of 128-138B Collins Avenue and 73-81 Collins Park was received from the Residents. The reason for the closure is to prevent anti-social behaviour. The proposed method of closure is by means of lockable gates. The extent of the proposed extinguishment is shown on Drawing No RM 24462 (copy attached).

Service Checks

A service check has been initiated.

#### **Statutory Requirement**

The statutory procedure involves giving public notice of the proposal in one or more newspapers circulating in the City and the affixing of that notice at each end of the right of way for a period of not less than 14 days. Any objections or representations made and not withdrawn shall be considered. The extinguishment of a public right of way is a function reserved to the elected members of the City Council.

#### **Recommendation**

I recommend that procedures be initiated under Section 73 of the Roads Act 1993 to extinguish the public right of way over the area indicated on Drawing No. RM 24462.

# With reference to the proposed disposal of a lease of the childcare facility at Kilbarrack Community Building, Swans's Nest Avenue, Kilbarrack, Dublin 5.

By way of Indenture of lease dated 12<sup>th</sup> February 2008, the childcare facility in the Kilbarrack Community Building at Swan's Nest Avenue, Dublin 5 shown outlined in red and coloured pink on Map Index No. SM2013-0247, was demised by Dublin City Council to Kilbarrack Community Childcare Services Limited for a term of 4 years and 11 months from 9<sup>th</sup> May 2005, subject to a rent of €40,000 per annum abated to €1,000 per annum provided the premises was used for the provision of childcare facilities.

The lease expired on 8<sup>th</sup> April 2010 and terms and conditions for a new lease commencing on 9<sup>th</sup> April 2010 for a period of 5 years were approved by the Dublin City Council at its meeting on 8<sup>th</sup> April 2013 (Report No. 122 of 2013 refers) and the matter was referred for the preparation of legal documents.

The legal formalities have not yet been completed and following further correspondence between Dublin City Council and the Solicitors for the proposed lessees it has been agreed to amend the term commencement date as follows:

"That the term of the lease shall be for a period of 5 years effective from 9<sup>th</sup> April 2014 to 8<sup>th</sup> April 2019 for the use of the premises shown outlined in red and coloured pink on Map Index No. SM2013-0247".

Rent on the premises is paid and up to date and all other terms and conditions agreed are to remain the same.
