This Area Committee resolves to step up its efforts to achieve a permanent resolution to the long-standing issue of the accommodation of the extended Gavin family. We recognise that the proposed removal of the family to the St Dominic's site is not a satisfactory or viable option. We believe that provision must be made for an alternative, appropriate and managed site in line with the statutory Development Plan and the Traveller Accommodation Programme. To this end we call on council management to work with all relevant stakeholders to identify and develop a suitable site as soon as possible, given the length of time this issue has been ongoing.
