That this Committee agrees that a plaque should be erected at Liberty House Park on Foley Street, Dublin 1 to remember the 38 children who were murdered by British forces in 1916.

The park is on the site where Corporation Buildings once stood. It was here in 1916 that one of the two youngest children to be killed during the Rising lived.

Her name was Christina Caffrey, aged two years old. She lived in 27 Corporations Buildings. Christina was killed on Tuesday 25th April, she was shot while being held in her mother's arms, the bullet entered mothers hand and through the child's back. Christina is buried in Glasnevin cemetery.

The other young child to be killed in Easter Week was John Francis Foster (2 years 10 months old), 18 Manor Place, Stoneybatter.

Motion in the name of Councillor Nial Ring

That this Committee notes that, under Objective ER11 of the Docklands SDZ, there is a requirement that DCC liaise with agencies and organisations to maximise employment and training opportunities for Docklands residents. To ensure that local employment is maximised in the Docklands this Committee requests that a formal Docklands Employment Steering Group/Forum be set up by DCC and that Councillors from Docklands partake in the forum.

Report

Objective ER11 of the North Lotts and Grand Canal Dock Planning Scheme states that Dublin City Council is *"to liaise with agencies and organisations to maximise employment and training opportunities for Docklands residents".*

The process has already commenced. The Council has developed a strategic partnership process with the two Local Employment Services (LES) which are located in Pearse Street and Amiens Street. Both LES work collaboratively with the prospective clients and the building contractors to maximise employment and training opportunities. A number of employment opportunities have been successfully filled in the construction of the new Central Bank site.

The establishment of the Docklands Consultative Forum is proposed in the Dublin Docklands Development Authority (Dissolution) Bill 2014 which is due to be enacted towards the end of the year. Upon enactment of the legislation, the forum will be established and will come into being following the dissolution of the Authority. Until then the existing Authority structures will remain in place.

Report

The application lodged under the branding name of "Project Wave" is application no DSDZ3350/15 for approx 28,000 sq.m. of office for Block 8D in the North Lotts and Grand Canal Dock SDZ. The application also includes a basement car park that will serve the entire block in the future. As part of the planning application the applicant has submitted a masterplan for the entire site, which sets out the area of the block that will in a future planning application provide for new housing. No housing has been included with the current application.

When the next phase of this master plan is presented to Dublin City Council as a planning application; which will include housing; the legal requirements of Part V will apply, and a condition will be attached to the decision reflecting this.

The planning permission, if and when such a permission is granted, will require that the entire permission is built out in accordance with the decision and conditions attached in order for the development to be legally compliant.

With reference to the proposed Disposal of Lands at Croke Villas, Ardilaun Road / Sackville Avenue, Dublin 3

The Dublin City Council in conjunction with the Pairc an Chrocaigh Teoranta (Croke Park Ltd) proposes to redevelop the Croke Villas land for the betterment of the local residents and the users of Croke Park Stadium. The project will deliver community gain in the form of new Social housing, improved public realm, a new handball alley and improved environment for the residents in the local area particularly on the days of Croke Park events. The Chief Valuer has reported that agreement has been reached to dispose of lands at Croke Villas, Ardilaun Road / Sackville Avenue, Dublin 3 to Pairc an Chrocaigh Teoranta (Croke Park Ltd) subject to the following terms and conditions:

- 1. That Dublin City Council in conjunction with the Pairc an Chrocaigh Teoranta (Croke Park Ltd), is prepared to redevelop Croke Villas area and this redevelopment will include:
 - i. The refurbishment of the 4 Houses no's 2,3,4,5 Ballybough Road into multi- unit dwellings
 - **ii.** A new infill housing development on the site of the former cottages in Dublin City Council's ownership at Sackville Avenue
 - **iii.** A new DCC housing development on the site of the Croke Villas flat complex (subject to de-tenanting and site clearance)
 - iv. A new Primary Route/Roadway into Croke Park Stadium, along Sackville Avenue
 - v. A new Pairc an Chrocaigh Teoranta (Croke Park Ltd) Sports Pavilion, Stadium Entrance Gate at Ardilaun Road and associated works to be developed by Pairc an Chrocaigh Teoranta (Croke Park Ltd).
- 2. That the areas transferring in Long Leasehold to the Pairc an Chrocaigh Teoranta (Croke Park Ltd) for a sports building and uses associated with Croke Park Stadium, are shown coloured pink and inlined red on the attached map index SM 2015- 0839.
- That the Pairc an Chrocaigh Teoranta (Croke Park Ltd) will pay the sum of €3,900,000 (three million nine hundred thousand euro) to Dublin City Council in compensation for the land take and as a contribution to Dublin City Council for the redevelopment of the Croke Villas flat complex, plus a fixed sum of €2,500,000 (two million five hundred thousand euro) for the new road installation viz. the design, supervision and construction elements, ie. a total amount of €6,400,000 (six million four hundred thousand euro). The roadway will be of standard construction with asphalt surface and footpaths (subject to detailed design & mapping).
- 4. That the payments from the Pairc an Chrocaigh Teoranta (Croke Park Ltd) to the Council will be on an instalment basis, as a percentage of the overall sum of €6,400,000 (six million four hundred thousand euro).

- i. 25% ie. a payment of €1,600,000 (one million six hundred thousand euro) on the execution of the Agreement to Lease and Building Licence as per term 5 below.
- ii. 25% ie. a payment of €1,600,000 (one million six hundred thousand euro) within four weeks of receipt of planning permission by the Pairc an Chrocaigh Teoranta (Croke Park Ltd) for the Sports Pavillion.
- iii. 50% ie. a payment of €3,200,000 (three million two hundred thousand euro) within 4 weeks of practical completion by Dublin City Council of their elements of the scheme ie all housing and roads.

Interest at a rate of 12% per annum will be charged on outstanding sums in the event of failure to comply with the above timelines. The amounts (i) and (ii) above, once paid are non-refundable with the exception that the amount at (i) becomes refundable only in the context as set out in condition 12.

- 5. That the City Council's Law Agent will forward the Agreement for Lease and Building Licence to the Pairc an Chrocaigh Teoranta (Croke Park Ltd) for their works within six weeks of the issuing of the Council's consent to the proposed disposal, which must be returned with the payment of €1,600,000 (one million six hundred thousand euro) and executed within 21 days of its issue. The Agreement for Lease and Building Licence will contain the terms and conditions deemed relevant to the proposed agreement by the City Council's Law Agent.
- 6. That the Pairc an Chrocaigh Teoranta (Croke Park Ltd) will apply within 9 months of Council approval to the disposal, for full planning permission to develop the Sports Pavilion, the new entrance into Croke Park Stadium, the associated works and any other intended development works on the DCC lands will progress in accordance with the Building Licence. A long stop date of 31st December 2020, will apply to the practical completion of all construction elements by the Pairc an Chrocaigh Teoranta (Croke Park Ltd) . Thereafter, the Council at its absolute discretion, may require the return of the site(s) together with any structures thereon, or may allow the Pairc an Chrocaigh Teoranta (Croke Park Ltd) to continue to occupy the sites under license but receiving a site fee, until such time as practical completion occurs.
- 7. That the lease shall be granted on the practical completion by the Pairc an Chrocaigh Teoranta (Croke Park Ltd) of all constructions elements set out in 6 above. The lease shall be for a term of 200 years subject to an annual rent of €1 (one euro per annum), plus VAT, if demanded. The rent will be subject to review every five years linked to changes in the Consumer Price Index from the date of the commencement of the lease to the last day of the fifth year of the letting and in 5 yearly patterns thereafter.
- 8. That within 9 months of Council approval to the disposal, Dublin City Council's Housing Department will be prepared to apply through the Part 8 process, for planning permission relating to the demolition, first phase housing, new road elements and associated elements as appropriate of the agreement.
- That the City Council will endeavor to redevelop the site be on a phased basis allowing a build period of c. 4- 5years in phases. Indicative phases would be . Phase
 1- the refurbishment of the Ballybough Road houses, Phase 2- the redevelopment of the former cottages on the North Eastern side of Sackville Avenue, Phase 3- the widening of the road at Sackville Avenue. Phase 4- the redevelopment of the Croke Villas flat complex site (excluding the area being disposed of).

- 10. That Dublin City Council shall be responsible for and bear the cost of the detenanting and demolition of the Croke Villas flat blocks, together with the settlement of any subsisting C.P.O. claims; excluding the Ardilaun block, which will be demolished by the Pairc an Chrocaigh Teoranta (Croke Park Ltd) as part of their development works.
- 11. That the Pairc an Chrocaigh Teoranta (Croke Park Ltd) shall take out and produce Public Liability Insurance in the sum of €6,500,000 (six million, five hundred thousand euro) and Employer Liability Insurance in the sum of €13,000,000 (thirteen million euro) for any incident on the licensed areas with a recognized Insurance Company with offices in the State and the policy shall indemnify the Council against all liability as owner of the property.
- 12. That in the event that either party, Dublin City Council or the Pairc an Chrocaigh Teoranta (Croke Park Ltd), do not receive planning permission for the development envisaged, or if planning is granted subject to onerous conditions, then either party may terminate the agreement and in such circumstances all monies will be refunded without penalty, with each party bearing their own costs.
- 13. That both parties shall be responsible for their own professional and legal fees incurred, together with any VAT or Stamp Duty Liabilities arising.


The dates for the performances of any of the requirements of the proposed agreement may be amended at the absolute discretion of the Executive Manager.

The disposal shall be subject to any such covenants and conditions as the Law Agent in his discretion shall stipulate.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.

With reference to the proposed grant of a licence of a premises in Mountjoy Square Park, Dublin 1 to St Brigid's Day Nursery Limited.

By way of Licence dated 21st July 2011 a premises in Mountjoy Square Park, Dublin 1 which is more particularly delineated on Map Index No.SM2010-0419 was let by Dublin City Council to St. Brigid's Day Nursery Limited for 4 years and 9 months from 1st January 2011 subject to a licence fee of €1.00 (if demanded) for the provision of community childcare activities.


This licence is due to expire on the 30th September 2015 and it is proposed to grant a further licence to St. Brigid's Day Nursery Limited subject to the following terms and conditions.

- 1. The licence shall be for a further period of 4 years 9 months, commencing on 1st October 2015.
- 2. The licence fee shall be €1.00 p.a. (if demanded) and the premises shall be used for the provision of community childcare activities.
- 3. The Council shall permit the licensee to carry out its activities between the hours of 7.00 am and 10.00 pm Monday to Friday of each week.
- 4. The licence can be terminated by either party by giving the other three months notice in writing.
- 5. In the event that the licensor terminates the licence where there is no breach of the licence agreement, the licensor shall provide alternative suitable accommodation for the licensee.
- 6. The licensee shall be responsible for all rates, taxes, electricity, waste, telephone charges and all other service charges which may be applied to the premises.
- 7. The licensee shall not assign, sublet or otherwise part with any part of the licensed area.
- 8. Keys to the premises shall only be held by actual employees of St Brigid's Day Nursery Limited who shall be responsible for their use and all security issues associated with their use.
- 9. The licensee shall be responsible for fully insuring the licensed area and shall indemnify Dublin City Council against any and all claims arising from its use of the premises. The licensee shall obtain a high level of Public Liability Insurance and Employers Liability Insurance and the Council will have an absolute right to set a minimum level of public liability and employers liability insurance and to review the

figures on a yearly basis (the current minimum levels are €6.5 million and €13 million respectively.

- 10. The licensee shall be responsible for the internal repair and decoration as is necessary to keep the internal parts of the premises in good condition during the term of the licence. The licensee shall not make any material alterations to the internal parts of the premises without the prior consent of the Council. The licensee shall ensure at all times that the premises are kept in a manner and condition which make it safe for the activities to be carried out therein.
- 11. The licensee shall comply with all terms of the Council's Waste Management Plan for Mountjoy Square Park and the premises herein.
- 12. On termination of the licence the licensee shall at their own expense remove all materials not belonging to Dublin City Council and shall leave the property clean and cleared to the satisfaction of the Council. Specified fixtures and fittings supplied by Dublin City Council shall not be removed from the premises.
- 13. The licence will be subject to any other terms and conditions deemed appropriate by the Council's Law Agent.
- 14. Each party shall be responsible for its own legal costs in this matter.
- 15. That the grant of a new licence shall be subject to the proposed licensee signing a Deed of Renunciation.

Halloween 2015

The Central Area's Halloween operation commenced early August and the first operational meeting with the Gardai from Store St, Bridewell and Mountjoy/ Fitzgibbon was held on the 2nd Sept 2015.

Removal of tyres and other bonfire materials will be a priority in the lead up to Halloween and once storage locations are identified we will liaise with the Gardai in how best to remove the materials safely.

Main point of contact in relation to bonfires, bonfire materials being stored etc is 1800 248 348

Audits have been carried out on a number of tyre garages in the Central Area and Waste Enforcement will be following up on these.

The owners of privately owned sites identified as vulnerable to bonfires/storage of bonfire material at Halloween have been contacted, advised and offered assistance with the removal of material.

Additional operational measures will be put in place in relation to the markets area prior to Halloween.

All Area Housing Managers are now prioritising the collection of bonfire material in all their complexes.

From a Community perspective the policy remains to encourage as many community groups as possible to provide programmes of activities for young people to divert from the traditional negative social and environmentally damaging behaviour.

The Area Community Development Officer is currently working with Community Groups in the Central Area to support and encourage activities for the mid-term break with significant activities planned for Halloween.

In 2014 eleven groups held various events on Halloween night from parades to intergenerational parties, community garden parties, Halloween camps for younger children, Youth Project trips etc and it is intended to expand on the number of groups holding activities for 2015.

With the support of DCC's Event Section a grouping involving several youth groups in the Smithfield area have planned for a week long programme to include activities such as FIFA competitions on big screens in a number of flat complexes culminating in a final on Halloween night on the Smithfield Plaza along with an Irelands Got Talent competition, zip lining and fancy dress competitions. It is hoped if successful that this can become an annual event.

DCC staff from various departments will be available the weekend prior to and the weekend of Halloween to remove materials and respond to any incidents.

North Inner City Housing Update

Chris Butler – Area Housing Manager

Vacant site, Railway Street

As previously advised Circle Voluntary Housing Association have proposed to develop this site for Social Housing. Such a development would complement the recently completed Peadar Kearney House and would provide much needed housing in the local area. Circle have engaged an Architect to examine the site and submit a preliminary plan. We will keep you updated as this project progresses.

St. Mary's Mansions

As previously advised there has been some welcome and significant progress on the potential redevelopment of St. Mary's Mansions. Cluid Housing Association appointed an Architect and Engineer to the Project in May. Cody Architects have been selected to work with residents to come up with a design plan which will meet their housing requirements and address the issue of anti-social behaviour which has been a problem in the complex. As you may be aware, Cody Architects were responsible for designing the recently completed Fr. Scully House and as such are aware of the difficulties and challenges of undertaking a development in a busy and densely populated urban area. It is generally acknowledged that Fr. Scully House is an excellent complex which provides high quality units which meet the needs of the residents and on that basis we are confident Cody Architects are very capable of providing a design which will meet with residents approval. A further meeting took place with Cluid, DCC, the Design team and residents on 23 August. This meeting updated tenants on the progress of the project, the next stage and on some of the properties Cluid are looking at leasing/purchasing. Tenants were also advised that site investigations will commence on the 5th October for a period of 2 weeks. Again there was good turnout of tenants with 19 attending the meeting. It is expected a further meeting will take place in November when it is hoped that the Design team will present more detailed plans.

As is usual at this time of year a number of incidents have occurred in the flats relating to the collection of bonfire materials. We have already removed tyres from the complex and will continue to do so right up to Halloween, should it be necessary.

Gloucester Place/Former IDA site

The former IDA site on Summerhill/Gloucester Place has been a centre of anti-social activity for the last number of years. The site has been used by rough sleepers and drug dealers and is the cause of great disturbance and annoyance to local residents. The site is not owned by DCC but we have secured it on a number of occasions and have been working with the Gardai and the owner to address the issues. A Planning application to build Student Accommodation on the site was submitted in December 2014 and, following the submission of further details from the developer, Planning approval was issued on 22nd May, subject to some conditions. An Appeal was lodged to An Bord Pleanala and An Bord Pleanala issued a grant of permission decision on 30th September, 2015 and it is now possible to progress the development.

We will continue to liaise with the developer to ensure the quick delivery of the project which will address a lot of the anti-social issues in the adjacent area.

James Larkin House

At the request of residents painting of the interior hallways is underway.

Fitzgibbon Court

Painting of the exterior has commenced on this complex. It is likely to take a number of months to complete the work.

Matt Talbot Court

A contractor has been appointed to undertake repair works around the chimney stacks and the water tanks on the roofs. Work is currently underway on one of the roofs and depending on the weather should be completed within a few weeks.

The Kiln/Forge

Work is underway to replace tiles on the exterior stairwells. The current tiles will be removed and replaced with an anti-slip cementicous product.

Sheriff Street Area waste collection pilot scheme

Following on the successful introduction of a waste collection service in tenancies in the Beaver St./Buckingham St./Rutland St. areas this pilot project has now been extended to cover the DCC tenancies on and in the vicinity of Sheriff Street. As with the previous pilot area a waste collection charge has been added to the tenants account and Greyhound have provided the bins and are carrying out the collection on behalf of DCC. After issues with the first collection the collections have been running smoothly and no further issues have arisen.

Brian Kavanagh – Area Housing Manager

Poplar Row, Taaffe Place, Annesley Avenue & Place – Pyrite Issues

The Pyrite remediation works are being carried out in three 10/12 week phases. The remedial works commenced on 12/01/2015 and the Contractor is McCallan Bros Ltd.

Phase 1 of these works has been completed successfully and all 6 residents have returned to their homes.

Phase 2 of these works has been completed with 7 residents having returned to their homes there are some snagging works that are currently been dealt with by the contractor.

Phase 3 residents have all been moved to their temporary accommodation within the area and works for this phase commenced in early September. It is hoped that this phase will be completed by the end of the year.

Croke Villas

There are now 9 dwellings out of a total of 79 occupied in the complex. The Area Housing Manager is liaising with the remaining individuals/families in trying to identify suitable accommodation in the areas they have requested. Efforts are ongoing in trying to meet the needs of the remaining residents.

Talks with the GAA have now concluded with a substantial monetary offer being made to assist finance the redevelopment of this site.

The Part 8 submission for the redevelopment of 2-6 Ballybough Road was approved at the March 2015 meeting of the full city council. Dublin City Council is currently in the tendering process for this redevelopment. There are currently some site investigations works been carried out on this site by contractors for City Architects Division.

Ballybough House

Housing Maintenance Division is continuing to refurbish the void dwellings in the complex.

The Estate Manager has been liaising with An Garda Siochana to identify any individuals causing problems in the complex and to take whatever action is required to resolve issues. An Garda Siochana are continuing to carry out raids in this complex and a number of people are before the courts. Dublin City Council has carried out a number of interviews for anti social behaviour as a result of these raids.

A trial of Choice Based Lettings in this complex has been successful with a number of people applying for the units advertised. Thirteen units were let as a result of this course of action with a high number of applicants applying. A further two units have now been advertised in this complex under Choice Based Lettings and will be let shortly.

The Area Housing Manager & Estate Manager is continuing to meet with the Resident's Association monthly.

Poplar Row Flats

Staff from the area office and staff from the Community Development Section have held a number of meetings with residents from Poplar Row flats around the revamping of play facilities in this complex.

St. Agatha's Court

The Peter McVerry Trust was asked by Dublin City Council to bring forward proposals for the site at St. Agatha's Court. The proposal put forward is to convert 16 units into 8 larger units and construct 4 additional units giving a total of 12 units. The units have been vacant for some time so it would bring them back into use. The Department of Environment Community and Local Government in May granted approval in principle to the construction of the 12 units at a cost of €1,170,000 with a view to starting on site in 2015.

Planning permission has been granted for this development. Site investigations have been carried out on this site by consulting engineers and the Peter McVerry Trust have tendered for a contractor to carry out the works. It is anticipated work will commence last quarter of 2015

Tom Clarke House

The Part 8 submission for the redevelopment of this complex was approved at the September 2015 meeting of the full City Council.

Some enabling works by Housing Maintenance have commenced on preparing of these units for the redevelopment.

St Marys Court

Housing Maintenance Division are in the process of improving the building energy rating (BER) by carrying out insulation works in this complex.

Killane Court

Housing Maintenance Division are in the process of improving the building energy rating (BER) by carrying out insulation works in this complex.

Sean Smith – Area Housing Manager - North West Inner City Housing Report

Dominick Street Lower

The Council has planning permission from An Bord Pleanala for 58 housing units, a community facility and shops on the eastern side of Dominick Street. The accompanying Masterplan provided for a new road and the closure of the existing roadway at Dominick Place and the provision of a site for a Gael Scoil.

In order to make the project economically viable and procure funding it has been necessary to redesign the project to provide for additional housing units, increased to 73, with a reduction in the number of commercial units, and alterations to the community facilities. Provided funding from the DOECLG for the housing is forthcoming the Council (Planning and Development Department) has agreed to use alternative funding for the commercial and community facilities element of the project.

The draft scheme has been discussed with the regeneration board and subject to the agreement of the DOECLG. A revised planning process will commence in the summer by way of a new Part 8 application.

Once there is certainty about the design, the funding and the planning process a report will be submitted to the Area Committee seeking their agreement to proceed to the next stage.

Luas Cross City Works

Residents of Constitution Hill, Dominick St Lower, Dominick House, Dominick Court and Dominick St Upper have been kept updated on the progress of the Luas Cross City (LCC). LCC staff and the Contractor (GMC) have discussed the programme of works with local residents. Contractor is currently on-site in Constitution Hill, Dominick Street Lower/Upper, Dorset Street/Bolton Street and Parnell Street.

To facilitate works required for the Luas Cross City Utilities contract, traffic will be restricted in the area. Dominick Place (from junction with Dominick St Lwr to the junction adjacent 20A Dominick Place), will be closed from 15th July to 1st October 2015. Pedestrian and local access will be maintained during the period of the road closure as the new road will be open during this time.

On Dominick Street Lower excavations for ESB testing and commissioning pits and commissioning of services (ESB and Eircom) are ongoing.

Updates for all diversions and disruptions are distributed to residents once approved by DCC and An Garda Síochána.

Blackhall Place/Marmion Court

Enhancement works in the Blackhall/Marmion Complex are ongoing. As part of these works, Murphy Playground Services are currently on site in the complex. The Construction of a new children's playground in the middle block is now complete. A new wet-pour playground facility has been installed in the centre block comprising of a two seat swing, a see-saw and slide suitable for 1 to 6/7 year olds. Discussions with residents are ongoing in relation to the remainder of the Councillors Discretionary fund for enhancement works.

Environmental improvement works involving pruning of Birch trees, cleaning of grassed areas and laying of bark mulch has commenced in the courtyard area's. In addition cultivation of 4 circular beds (one in each courtyard) has commenced, in advance of the planting of herbaceous perennial plants interspersed with bark mulch which will greatly enhance the visual aspect of the complex.

A glazing contractor is currently engaged in repairing all windows and doors in this complex.

Constitution Hill

Ongoing meetings with Residents, An Garda Siochana, Luas Cross City Staff, the Housing Manager and Project Estate Officer to keep Residents up-to-date on the proposed plans for Broadstone Gate.

Regular monthly meetings take place with the Residents Association and Estate Management. There are no outstanding issues and antisocial behaviour in the complex is continuously monitored by Estate Management and the Gardai. Next Residents Association meeting is scheduled for 13th October 2015.

Constitution Hill, Dublin Institute of Technology- Project Masterplan

A team of students from Dublin Institute of Technology have undertaken a project as part of their academic course. This project will involve students doing a case study and masterplan of Constitution Hill Flats. This case study will involve students creating their own Pricinct Improvement Plan. Students will focus on the upgrading and retrofit of the existing blocks, Sustainability and Environmental issues, site access, general urban strategy, community amenities, energy strategy etc. The relationship to the adjacent Broadstone and nearby Grangegorman sites will be considered as part of the masterplan.

In the development of their design proposals, student groups will meet with residents and community representatives. D.C.C Housing staff and Architects attended a briefing in D.I.T in September. The project will commence on the 6th October for a period of 10 weeks and the next briefing session for residents will be held on 13th October.

Dorset Street & Saint Marys Terrace

Ongoing meetings with Residents, Estate Management and the Gardai in relation to antisocial behaviour in the complex. The refurbishment/up-grading of the complex is currently being examined, report to follow.

Halloween – 2015

Meetings are ongoing with various sections off DCC and An Garda Siochana in relation to targeting collection of firewood and pallets in all complexes. Next meeting is scheduled for the 22nd October in the Parnell Street Housing Office.

Central Area Age Friendly Update

The Central Area Age Friendly Alliance is comprised of the following organisations :- Dublin City Council, DCETB, DIT, Gardai, Crosscare, Dublin Volunteer Centre, Croke Park, HSE, Friends of the Elderly, Larkin Unemployed Centre and Dublin Town.

This Alliance meets every two months and is combining its resources to implement a strategy to make the Central Area a good place in which to grow old. This strategy was developed through extensive consultation with older people in the area.

There is also an Older Persons Council comprised of 10 older residents representing different parts of the Central Area. Two members of the Older Persons Council also sit on the Central Area Age Friendly Alliance. The purpose of this Council is to ensure that the voice of older people is heard at policy level.

Successes to date in the Central Area include :-

Central Area Over 55's Open Day

The Over 55's Open Day covered a number of aspects relating to aging and services available, but also focused on the positive side of aging and on providing opportunities for older people to engage in their communities.

11 different organisations were represented including Third Age, Gardai, Age Action, Volunteer Dublin, Crosscare and the Larkin Centre. Many older people volunteered for or arranged to access these services.

A range of activities were demonstrated on the day and many people took part in balance & Mindfulness and Tai Chi classes. There was an opportunity to get a health check and also find out about the music resources available in the Central Library.

Tai Chi Classes in the ILAC Library

A Central Area initiative this year has been to set up a Tai Chi class for older persons as a pilot project which is now up and running. It is intended to expand this project in 2016.

Reclaim our Parks Day

Reclaim our Parks days were held throughout the Summer in Liberty Park. Activities included flower sales, Opera in the Park, Liberty in the Monto festival, music and dance and children activities. Further activities are planned for October, November and December.

Educational Projects

Marino College are running educational projects including a paired reading programme and information technology courses.

Larkin College organised a project with the National Museum where secondary students recorded video footage of older people talking about Jim Larkin and growing up in the Dublin1 area. This is now an APP.

Fire Prevention

Smoke detector alarms were distributed by Dublin Fire Brigade in East Wall and installed by older persons involved in the 'Men's Sheds' project.

Environmental Improvements

The Central Area Community Development section worked with older persons in Blessington Basin to improve the neighbourhood through planting flowers and environmental improvements.

The 'Men's Sheds ' project in East Wall landscaped and planted flowers in the grounds of the local church and in the locality.
