Cabra Area Office Report

MAIN DEVELOPMENTS

Cabra East pole painting

Lighting poles on St Jarlaths's, St Eithne's and St Fintan's Roads and St Fintan's Terrace will be painted before Christmas. This will extend the painting already done on St Attracta Road and will give a much needed uplift to the area.

Dunmanus Senior Citizens Complex Site

Clúid's original program was due to commence in late October. However, there have been delays in Departmental funding approval, and works will now commence in November.

Halloween

Dublin City Council will continue to provide a programme of activities in John Paul Park for the mid-term week (see Community Update). The Area Office will also work with Gardai to remove bonfire material reported to us and to monitor known locations used for the collection of same.

LUAS

There is no further update directly affecting the area since September report.

Works will continue in this area and all along the route until the line goes into operation in 2017.

The Royal Canal Development Group

Hedgerows – Irish Rail: Members have had various meetings with Garry Keegan, Irish Rail, to discuss the destruction of the hedgerows due to the current practice of flaying the hedgerows. Irish Rail are not prepared to cut the hedgerows manually and the machines they are using are not suitable for hedgerows more than 25 cms. To date no satisfactory compromise has been reached. Further representations are being made to Irish Rail.

Ratoath Road Community Liaison - Irish Rail project

Residents of Ratoath Estate have approved the landscaping plan. Irish Rail are now going out to tender as it is their responsibility to maintain the area for 18 months before handing over to the Parks Section.

A site meeting was held on 28th September between officials from Dublin City Council Roads Department and the local area office and Irish Rail to discuss concerns raised by residents of Ashington Mews. Garry Keegan of Irish Rail is liaising with the residents.

Rowan Hamilton Walk

The annual Rowan Hamilton Walk took place on the 16th October 2015 from Dunsink Observatory to Broombridge.

Waterways Ireland

The 1st Lock House at the North Strand has been made safe, cleaned up and whitewashed. However, there are no further plans at present. Waterways Ireland are open to any ideas for the cottage. Ground works and landscaping was carried out at the 4th lock with paths and walls being repaired. Repairs were also carried out to the gates at the 5th lock.

The Comhairle na nÓg A.G.M. will take place in Croke Park on Thursday 22nd October from 9.30am – 2pm. 





Report on Traffic Issues on Walsh Road, Ferguson Road and surrounding area.

Issues

High Volumes of Traffic

Both Walsh Road and Ferguson Road have experienced large volumes of cut-through traffic (rat running) for a number of years. Previous attempts to address the issue with time restriction turning bans have proved to be unsuccessful over the long term due to a continual and costly need for Garda enforcement.

Vehicles Blocking Footpaths

As the traffic volumes have increased more vehicles are parking further on to the footpath to prevent damage to the residents' private vehicles. This has had a compounding effect on the safety in the area by forcing pedestrians into the roadway, while the increased road width is allowing for faster vehicle speeds. It is proposed to attempt to address this safety issue in the short term.

Dangerous Driving and Speeding

The issues of dangerous driving and speeding are present in the area as they are also present in many areas across the city. However, they are not as dramatic as the issues in the area caused by traffic volumes and blocked footpaths. Any interventions proposed may not directly address the issues of speeding and will be aimed at improving Traffic Volume and Blocked Footpaths, however all interventions will consider the impact on speeds.

Interventions

Dublin City Council has received a large number of request to put interventions in place order to tackle the previously mentioned issues.

Peak Time Turning Restrictions

Turning restrictions have been in place for some time but have been routinely ignored and have proven ineffective. The Gardai may be able to deploy resources to enforce the bans on an intermittent basis but continual enforcement is too large a drain on resources for any time dependant turning bans to be successful over the long term.

Allowing a Right Turn from Richmond Rd:

The existence of a Pedestrian Crossing across Drumcondra Road Upper currently prevents the option to allow for a right turn from Richmond Rd. Drumcondra Road Upper is part of a

main arterial route for the city with significant traffic pressures. These pressures are compounded at this junction in particular due to its close proximity to the Tolka River with its limited number of bridges to cross it. The Intelligent Transport Systems section report that the junction has no remaining capacity to allow for any additional right turning phase. This issue is to be looked at as part of a Wider Area Traffic Cell Analysis that is to be conducted in the near future.

Closing the Top of both Walsh Road and Ferguson Road

Until an alternative route is found for Westbound traffic on Richmond Road it will not be possible to close all access to Home Farm Rd. No recommendation can be made on this request until the conclusion of the Wider Area Traffic Cell Analysis Study.

Closing the Bottom of Ferguson Road (Griffith Park End)

Similarly, until an alternative route is found for Westbound traffic on Richmond Rd it will not be possible to close all access to Ferguson Rd. This would force traffic from Richmond Rd and Millmount Road down Millbourne Ave which is not suitable for heavy traffic due to its narrow footpaths and the presence of the school and library at this location.

Pedestrian Crossing at Millbourne Ave (near library)

There is too low a pedestrian demand to warrant the introduction of a pedestrian crossing at this location. A School Warden is in place during peak school demand time and outside of these times there is a very low pedestrian demand that does not warrant the introduction of pedestrian crossing.

Multiple Barriers

A previous scheme that was explored was to place a number of barriers along Walsh Road and Ferguson Road in a layout similar to shown in. This would not block access but would make the route less attractive to cut through traffic. The closing of the top of Walsh Road may have had an effect on the AM peak traffic but the issue of traffic from Richmond Rd would still remain in the PM peak. The lengthening of the route would increase the impact of each individual cut-through vehicle as it travelled further through the area. As the plan is unlikely to significantly reduce the PM peak due to continued traffic flow from Richmond Rd it is no longer recommended in lieu of the upcoming Wider Area Traffic Cell Analysis.

One Way System

A one way system will allow residents to park their vehicles solely on the roadway and allow for clear uninterrupted passage of pedestrians on the footpaths.

Increased vehicle speeds may be an unintended consequence of introducing such as system. However by having parked vehicles fully on the road, introduction of a number of pinch points and chicanes the effective road width will be reduced limiting vehicle speeds. Continual monitoring of speeds will be conducted to ascertain if further Traffic Calming will be required. By removing parked cars and preventing the mounting of footpaths the overall safety of pedestrians will be greatly improved.

Further Actions:

 Contracts are being drawn up in order to appoint Consultants to perform a Wider Area Traffic Cell Analysis in order to explore possible methods of reducing the number of vehicles cutting through the area in both the AM and PM peak times.

- The works at the Cat and Cage have recently been completed so Traffic Counts and Speed Reviews will be conducted to see what improvements if any this has made.
- It is no longer recommended to put in place any interim measures until the
 conclusion of the Wider Area Traffic Cell Analysis as any changes to the road layout
 would adversely affect the quality, accuracy and integrity of any measurements and
 analysis made for the Wider Area Traffic Cell Analysis

Report on Reilly's Bridge

Since the opening of Reilly's Bridge in March 2015 there has been an increase in vehicle numbers of 52% (including a 77% increase in two wheeled traffic). Despite this increase in vehicle volumes residents of Ratoath Estate have reported that it is still possible to exit and enter the estate without much difficulty.

Traffic Speeds have not increased since the opening of the bridge with over 97% of vehicles adhering to the 50km/hr speed limit. With this high level of compliance and resident concerns of increased noise from rumble strips or ramps; no further Traffic Calming is recommended at this time.

To allay concerns of vehicles performing dangerous and illegal overtaking manoeuvres on Reilly's Bridge, it is recommended to replace the Dashed White Centre Line with a Continuous White Line in order to reinforce that no overtaking of motorised traffic should take place on the bridge.

Further Speed Checks and Counts are to be performed in the upcoming months in order to further evaluate the changes in vehicle numbers and speeds on Ratoath Rd as a result of the opening of Reilly's Bridge.

PUBLIC DOMAIN REPORT

Halloween

The Annual Halloween Festivals will take place at the Civic Centre, Mellowes Road and Ballymun Plaza on Saturday 31st October. In Cabra, a Halloween Camp will run in Cabra Parkside from Tuesday 27th to Friday 30th Octobe: suitable for children 6-12 years old. All are welcome to attend these fun, safe, family events. Watch out for information posters in your local area with further details.

Stock piling of bonfire materials should be reported to the Finglas Office on 2225496 / 2225412 / 2225400 or the Cabra Office on 222 7400 or Ballymun on 222 5715 / 2225610.

We will utilise all resources available to us in order to reduce the number and size of bonfires in the area. We will once again work closely with the Gardaí, Safety Fora and Residents Associations to minimise bonfires and incidents on Halloween. Warning letters in relation to the storing/distribution of materials for bonfires are been delivered throughout the area.

It is an offence to store or distribute material for bonfires under the Litter Pollution Act 1997. The area will be patrolled by Litter Wardens and Waste Enforcement Officers. Litter Fines of €150 will be issued to anyone in breach of the above.

We have called to industrial premises and all local garages to advise businesses of their responsibilities in relation to the storage of the pallets and tyres. Waste Enforcement Officers will carry out tyre audit inspections upon our request in local garages if deemed necessary.

North West Area Complaints received via CRM

It is important to note that a significant number of additional complaints were also investigated as all area staff pick up complaints when carrying out daily duties but due to lack of resources all complaints are not logged. The investigations carried out by the Litter Wardens during routine inspection are not logged either.

Enforcement

Inspections are on-going under Dublin City Council Bye-Laws for the storage, presentation and collection of household waste. We are currently working in the Finglas Area. We are also carrying out surveys on shop fronts and we are reminding business owners of our Bye-Laws for Control and Prevention of Litter in the coming weeks.

We are currently receiving a lot of reports from concerned residents in relation to illegal dumping. The information being provided is most helpful in investigating these cases.

Halloween shop posters

Once again the area is littered with Halloween shop posters as per previous years. All posters are inspected and removed if on Dublin City Council property and appropriate action is initiated under the Litter Pollution Act. We can only remove posters from private property were we have knowledge that the owner of the property has not given consent for the erection of such posters. A number of litter fines have issued to the offender in the past, but all remain unpaid. We have taken a number of cases to court and have been successful in securing conviction. However, in recent times the alleged offender has had a conviction over ruled on appeal.

Traffic Box Arts Initative

The North West Area is again calling on local artists to submit proposals for artwork on a number of our Traffic Light Control Boxes. This opportunity is open to all, both amateur and professional. Previous experience is not required. This is a chance to help Dublin City Council animate the city by proposing art work for the Traffic Light Control Utility Boxes dotted across the city. The boxes are gray in colour and under constant threat from tagging, graffiti, postering and stickering. A proposed solution was to put artwork onto the boxes, which would remove or reduce the need for maintenance and in turn animate and improve the public realm.

The overall award was presented to Courtlands Residents Association. This group are worthy winners and deserved citywide recognition for their flawless work throughout the year. They have been participating in the competition from many years now and each year they up their game by constantly searching for new ideas and enhancing different locations within their estate.

Blue Bag Leaf Collection Scheme

The North West Area promotes civic pride and will assist residents to take responsibility for their own neighbourhood/street. We will supply gloves, bags, brushes and paper pickers and will arrange for rubbish collected during a clean up to be removed.

We continue to promote our "Blue Bag Leaf Collection Scheme" every autumn, where we will supply bags to residents for leaf collection. We then arrange removal of the bags. These bags are not for personal use. Bags are to be distributed through approved groups e.g. residents associations. Groups who wish to partake of the blue bag scheme should contact Patrick Smith, Environmental Liaison Officer, on 222 5496 or northwestarea@dublincity.ie.

Litter Management Plan

Waste Management completed a non-statutory public consultation phase of the Litter Management Plan in April. They received 128 submissions from all sectors of the community. They have concluded a review of the old plan and are currently finalising the draft new Litter Management Plan for consideration by the **Environmental SPC in November**. Once the draft plan has been approved by the SPC it will be presented to the City Council for approval before the draft Litter Management Plan goes on public consultation.

The statutory public consultation process will mirror the earlier non statutory process. Advertisements will be placed in newspapers, local radio, Dublin City Council website, social media etc inviting members of the public, business community, elected representatives etc

to comment or contribute to the final plan. All submissions received at that stage will be examined and incorporated into the Litter Management Plan where appropriate.

The final draft of the Litter Management Plan will come back to the SPC and City Council for approval and they anticipate that the Litter Management Plan for 2016-2018 will be in place early in 2016.

Laneway between Connaught Street and St. Peters Road

At the September Area Committee meeting it was agreed to defer the decision of the proposed extinguishment of the public right of way over the laneway between 7-59 Connaught Street and 28-40 St. Peters Road to allow clarification of the current ownership of the laneway. Our searches to date in this regard remain inconclusive and a further update will issue in due course. Bohemian Football Club have confirmed that the laneway is an access route to and from the stadium and this lane is part of their evacuation plans.

However, Bohemian Football Club and Dublin City Council are willing to work with residents in the interim to do all possible to reduce the anti social behaviour in the laneway. The Public Domain Officer will meet with residents in the coming week to discuss same.

At the meeting there were lots of positive suggestions on how the residents with the support of Dublin City Council could try to alleviate the dumping issue on the green that faces them. The first action was to refurbish the flower bed. This was done with the assistance of NorDubco and Global Action Plan on 7th October 2015. NorDubco and Dublin City Council will continue to link in with the residents to see if some of their suggestions in relation to the green space can be accomplished.

Children's Halloween Part for Travelodge residents

NorDubco, DePaul Ireland, Shangan Child & Family Resource Centre & Dublin City Council are planning a children's Halloween party for the residents residing in the Travelodge. This event will take place on Thursday 29th October 2015 from 2pm -5pm in the Shangan Child and Family Resource Centre. Ballymun Men's Network

Dublin City Council, Ballymun Area Office provided the Ballymun Men's Network with sleeper packs for the men who use the centre.

Older Persons

Vantastic Shop Route Scheme is continuing until Christmas. 59 people have registered and 15 people travelled on the route on the 9th of October. It seems to be the same regular people from Shangan Gardens, Coultry Gardens, Belclare, Marewood, Sandyhill Garden and Sillogue Gardens who use the service. Vantastic are going to ring around a number of people who have registered to see why they are not using the service. There will be a review of numbers etc at the end of October.

Positive Ageing Week was launched on the 28th September. So far it is a great success with Burren Court table quiz which took place 6th October, the Mystery Tour on the 7th October where the group travelled to Wicklow, there was also a pamper afternoon and the Gala Concert will take place on the 15th October.

Active Living walking group are participating in a walking programme which will run for 8 weeks. They meet on a Tuesday morning and a representative from HSE attends the walk. The aim of the programme is to support the creation of vibrant walking communities

throughout Ireland and is suitable for people who are currently not engaging in physical activity.

St Margaret's Travellers Association

The Senior Community Officer hosted a work shop about the workings of local government and Local Authorities for the men's group from St Margaret's Halting Site. Topics covered included:

- The electoral system / P.R,
- Powers of the Councillor
- Powers of the executive
- The budget / estimate process
- Different Departments of Dublin City Council
- The role of Central Government in Local Authority affairs

Positive Ageing Week Gala Concert

On the 15th of October, Dublin City Council presented a concert featuring over one hundred musicians and singers to celebrate Positive Ageing Week. The audience was drawn from community groups, sheltered housing complexes and nursing homes in the Ballymun Ward. The theme of the event was music at the movies and the artists included the Glasnevin Coral Society, The Artane Senior Band and Ballymun Strings. Special collaborations were arranged between all three groups.

Ballymun Otherworld Festival

The annual "Otherworld Festival" will take place on October 31st from 6pm to 9pm. The event will include the following

Over 5,000 people visited the site last year and a similar number is expected again this year

2. Housing/Estate Management

Remaining Blocks

The two blocks at Balbutcher Lane and Joseph Plunkett Tower have been demolished. The programme of demolition should be completed by October 2015.

C.C.T.V

The C.C.T.V system is working well at present. The next planned Maintenance Programme will begin during this month and this includes cleaning and checking all the cameras and installing updates to the system in the control room.

Cleansing/Waste Management

Waste Management and the area office are continuing to combat illegal dumping at open spaces. These measures include using the C.C.T.V system to monitor and identify those responsible. The area office has targeted illegal dumping in St Margaret's Road, Balcurris Park East and Knowth Court over the last month and this resulted in a number of tenants being called in and warned about illegal dumping. Our cleansing crew is continuing with the cleaning of the Courts in Ballymun which are cleaned on a rota basis.

Public Domain

The Ballymun Office now has a member of staff assigned to issues relating to Public Domain. Issues which can be reported include illegal dumping, graffiti, broken footpaths and open spaces. This can also be used for reporting any wood being stored for Halloween. Complaints can be logged by calling to the public counter or by phoning 222 5610.

Ballymun West Area Report

Ard Na Meala- Balcurris Park

A number of complaints have been received relating to the volume of quad bikes and dirt bikes in this area, Dublin City Council are in constant contact with the Gardai and the parks department in an effort to reduce this problem. Dublin City Council have installed kissing gates on the foot path to the front of Ard Na Meala in an effort to stop the motor bikes/ quad bikes speeding up and down this foot path.

Doon & Knowth Court

Dublin City Council has been working with the residents of Doon and Knowth Court. The resident's have painted a large wall that has been a prominent area for antisocial behaviour. Dublin City Council has resurfaced the footpath and a wall has been erected to replace the concrete bollards. Kissing gates have been installed to stop access for motor bikes/ quad bikes. A public light that had been vandalised has been reinstated.

Four trees are to be planted to commemorate the young people that have passed away in the area. There has been huge resident's participation. The parks department have given topsoil, with a view to replant grass seed where fires have been set over the years. BRYR have agreed to carry out street games in this space also.

The residents of Doon and Graigue Court have also been working with Dublin City Council to improve the area. A painting programme has taken place where DCC provided the paint and the residents have painted the back walls themselves. Shovels, brushes, bags and pickers have been provided by DCC for the residents, they have edged all the grass verges on the foot paths and have carried out a number of tidy ups. A number of different departments have been involved in this piece of work. Parks, Cleansing, Public Lighting the Community department and Public Domain have all had a part to play. This work is ongoing. The huge effort that has been made by the residents has spurred other residents on from Cranogue Road and Knowth Court to engage with Dublin City Council with a view to achieving the same results as their neighbours.

Ballymun East Area Report

NorDubco are continuing to come up with new initiatives to encourage more community involvement, the current initiatives are growing with new areas forming committees and getting involved in local projects. Tenant engagement is growing with residents with nearly all areas having an input at this stage.

Tenant meetings are arranged now around current initiatives which are in place in Coultry and Shangan area with more planned through the tenant engagement service.

Whiteacre Park

The repair of the play area and replacement of play equipment has been very slow but it has started and it is expected to be completed in the coming month. Dublin City Council have engaged a lot of the local residents with planting and cleaning projects around the park and are currently engaging the young people that live around the park with fun days and sports days, this will be followed up with more organised events during Halloween with the support of the community development, sports development section and BRYR. The feature running across Whiteacre Park is getting cleaned and painted and the local children are going to create a mural on this feature. Waste management and the local area office are constantly surveying the areas and houses to establish the compliance of waste management By-laws.

This is mainly being carried out on bin collection days. Currently waste enforcement is targeted at individuals that have an accumulation of household waste and no obvious bin collection service.

Shangan

Snagging has been a slow process but it is still ongoing in the new houses on Shangan Avenue which is nearly completed. Contractors are continuing to work with BRL over the roofing issues and the solar systems, they hope to complete repair works in the coming weeks. Tenants in the Shangan Avenue area are now encouraged to clean the parking bays outside their houses along with their front gardens.

Waste management and the local area office are currently surveying the areas and houses to establish the compliance of waste management By-laws. Currently waste enforcement is targeted at individuals that have an accumulation of household waste and no obvious bin collection service.

Coultry

Winter planting and cleaning along with general repair work was carried out all along Coultry Drive during the summer with lots of residents getting involved, particularly the older residents. Residents that attended the planting course in Coultry Park also attended to lend a hand which proved very successful. Work on the shop van site has been completed after a lot of hard work from local residents, even after the area was vandalised by youths burning wheelie bins and spreading paint on the ground. New projects are currently being looked into by NorDubco so that the residents continue the good work and engagement in the area. Surveys are at an advanced stage in Coultry Gardens to alleviate the drainage and flooding problems in the area, a decision on this issue is at senior manager level and we are waiting on a decision in the near future. It is hoped that the works will include the resurfacing of the area. Dublin City Council is committed to finding a speedy resolution to this problem. Waste management and the local area office are currently surveying the areas and houses to establish the compliance of waste management By-laws. This is mainly being carried out on bin collection days. Currently waste enforcement is targeted at individuals that have accumulation of household waste and no obvious bin collection service.

Longdale and Woodhazel

All residents are constantly active in cleaning the front gardens and the street outside each house which has proved successful, Residents in this area have been looking to form an action group to go into other areas to clean up and show how easy it is to get involved, NorDubco have engaged residents in the Woodhazel area with the help from locals from Longdale which is beginning to prove successful with all the parking spaces being cleaned on Woodhazel Terrace. Waste management and the local area office are currently surveying the areas and houses to establish the compliance of waste management By-laws. This is mainly being carried out on bin collection days.

Currently waste enforcement is targeted at individuals that have an accumulation of household waste and no obvious bin collection service.

Forrestwood and Sallowood

NorDubco and the tenant engagement initiative are beginning to get a response from the residents here with more people looking to get involved. This has been a bit sporadic in the past. Most complexes in the area have now got a representative for clean up initiatives. It is hoped that Forrestwood and Sallowood Area's would work a lot better under the tenant engagement initiative.

Magenta Crescent

There is a newly formed 1916 commemorative committee from which the residents want to mark the occasion in their local area next year, their next meeting will be at the end of September. This committee are busy raising funds through car boot sales, raffles and have

applied for the commemorative grant from Dublin City Council. Dublin City Council has supplied cleaning equipment and arranged to take away any rubbish after any clean up's, clean up's are a constant feature of Magenta Crescent. The pedestrian crossing is still an on going issue which is still going ahead, the planning and design has been completed and funding is now the obstacle, Lidl has agreed to pay for the crossing subject to an agreed valuation.

3. Ballymun Town Civic Alliance

Ballymun Town Civic Alliance held a quarterly meeting on 1st of October. The Chairs of each sub committee gave an update on their work for the last quarter. The recent decision in relation to Metro North was welcomed, and the importance of ensuring that the Ballymun stop being located in the centre of Ballymun was emphasised. Pamela Connolly gave an update on the Local Area Plan. It was noted that Pieta House is being temporarily located in Santry Cross, but will be located in Coultry Neighbourhood centre in the near future. It was also noted that the Rediscovery Centre should be on site at the former boiler house in October, and that the demolition of the last tower is now underway.

The physical / environmental sub-committee met on 23rd September. It was noted that four proposed road schemes, which were part of the BRL deferred infrastructural works, have been included in the draft Section 48 Development Levy scheme. These are Balcurris Road extension, Silloge Avenue / Main Street link road, Balbutcher Lane South / Poppintree Park Lane West and Gateway Crescent extension. These schemes are at various levels of development, and identifying funding was a significant issue. Updates were given on the Northern site, detenanting of the shopping centre / new lettings in the Civic Centre, the LAP and neighbourhood retail units.

The Social Regeneration sub-committee will be holding a facilitated meeting in the near future to look at its operation. This committee has been in place for some time and is suffering somewhat from fatigue.

Economic Development

Economic Strategy

A draft 5 year economic plan has been completed. The plan will be reviewed by the Economic sub-committee at its meeting on 15th October.

An Information Event – 'Succeed in Business' took place on the 7th October in the Council Chamber. It included presentations from Krust Bakery (food) and Experience Gaelic Games (tourism) who shared stories of setting up and running a business. We also had presentations from the Local Enterprise Office and Tolka Area Partnership who highlighted the state supports available to small business. Finally we had a presentation from Innovate Ballymun who informed the audience about a new innovation hub being launched soon in Ballymun.

The event was held during the same week as 'Fingal Enterprise week' and the 'Start-up Gathering' which presented a challenge in attracting people to the event. However with the support of Tolka Area Partnership, LEO, Innovate Ballymun, B4B and twitter we succeeded in attracting 30 people to the event. Overall the event was very well received and the hope is to scale it up over the next few years.

Stimulating economic activity

Free Wi-Fi for Plaza – We have got the go-ahead to install the access point to the side of the building. The next step is a license agreement between DCC and Magnet for the provision of the free Wi-Fi.

The Plaza – a brief has been prepared to carry out a feasibility study on the Plaza. The objective of the study is to make it more user-friendly to increase usage on a daily basis which in turn might help the surrounding businesses – no update since last meeting Vacant Neighbourhood retail units – The Economic Development Officer now has access to all available units. Expression of interest has been received for Unit 2 in Sillogue and negotiations will take place with the Valuers. Terms and conditions have been agreed for a Café in Unit B in Coultry. A planning application for change of use is pending. A verbal expression of interest was received for Unit C in Coultry. However as there are remedial works being carried out on Unit C & D in Coultry these Units will not be made available for a number of weeks.

Ballymun4Business

A B4B network meeting took place on the 10th September facilitated by Liam Barry. Chairman Robert Murphy kindly supplied the tea, coffee and pastries. Over 80 businesses were contacted by email and letters by post. 12 businesses attended the meeting and we had a presentation from LEO on the Online trading Voucher initiative. AECOM who are carrying out the retail study conducted facilitation with the group to get their opinions on the retail mix in Ballymun. A number of other issues that are affecting trade were discussed at the meeting. Another meeting will be scheduled for early November. While we anticipated more businesses would attend it was still a good start and something that can be built on over the next 12 months. The businesses that did attend were satisfied with the level of content at the meeting.

<u>4. Safer Ballymu</u>n

Public Meeting 08-09-2015

The meeting started with several of the residents from Doon court giving an overview of how they had recently set about making improvements to their area. With the help of Dublin City

Council, they cleared rubbish, planted flowers, painted the back walls and railings and generally gave their area a facelift. They feel it has greatly reduced the level of anti-social behaviour and encouraged residents in other areas to get involved in their communities and do the same.

Some of the main issues raised at the meeting related to the CCTV cameras in the Ballymun area and how effective they are. It was agreed that for the next meeting information would sought relating to this. The issue of an alleged abduction of a child at the Holy Spirit School was addressed by the Garda.

The next Safer Ballymun public meeting is scheduled for 19th of October 2015 at 7pm, The Safety week will be launched by the Deputy Lord Mayor. A week of activities have been arranged to promote Safety in the Ballymun area.

5. Other Significant Updates

Shopping centre update

Dublin City Council has been engaging with the tenants of the Shopping Centre since summer 2014 and we are now preparing to carry out a CPO. In order to carry out the CPO it is necessary to carry out title referencing work, mapping etc of all outstanding interests. A standard letter notifying all outstanding interests of the proposed CPO was issued last week.

Northern site update

In early October Dublin City Council instructed our agent asking him to revert to interested parties seeking a revised bid for the site for a four storey development, bids to be received by 6 November.

BALLYMUN TOWN CIVIC ALLIANCE UPDATE- October 2015

The last meeting of the Civic Alliance took place on 1st October 2015 where Pamela Connolly gave an update on the timeline for the LAP. AECON consultants are carrying out the Retail Study of Ballymun and have conducted a mini workshop and a survey of Ballymun and Glasnvein. Preliminary findings of the survey will be presented to Civic Alliance members and the NWA Committee on 20th October. The results of the Retail Survey will feed into the LAP. The Issues Paper will be published in October, There will be a four – six weeks consultation period where there will be information sessions held in the Civic Centre. It was agreed that the consultation needs to be very inclusive to ensure a sense of ownership among the community. The decision on the preferred route for Metro North with stops at DCU, Ballymun and Northwood was discussed. It was agreed to invite a representative from the NTA to the next Civic Alliance Meeting in January.

The Physical/Environmental Sub Committee held a meeting on 23rd September where an update was given on the progress on detonating the shopping centre and Civic Office lettings. The City Council are preparing to issue CPO Order's on the remaining 3 tenants who have no agreements in place for re-location or compensation. The Post Office is moving to Supervalu when the necessary works have been completed. The AIB will be taking a unit on the ground floor in the Civic Centre, Innovate Ballymun will occupy the first floor in the coming weeks. It has been agreed to lease 25 units in the Plaza as transitional housing, as a temporary move to more permanent housing. There units should be ready within one month.

The Economic Sub Committee held a meeting on 15th October 2015 where Liam Barry gave an update on the free Wi Fi Project. The project is close to completion, approval has been granted to mount the access point on the 1st Floor of the Civic Centre and the next step is to ensure a licence agreement is signed and it should be up and running by Halloween. Liam

also provided an update on B4B stating the first meeting he chaired was held in September. The Succeed in Business event was a success with presentations from LEO, Innovate Ballymun and Tolka Area Partnership. There was an update on the Northern Site, the negotiations have gone back to the under bidder as the developer was unwilling to develop the land to the expected scale. It was agreed to hold a separate meeting in November to discuss the 5 year Economic Plan.

The Social Sub Committee will have a facilitated meeting in November for a strategic review of the work of the Committee.

With reference to the proposed grant of a 5 year Lease of the Community Unit, at Coultry Neighbourhood Centre, 22 Santry Way, Ballymun, Dublin 9 to Pieta House C.P.S.O.S. Limited.

The Community Unit at Coultry Neighbourhood Centre, 22 Santry Way, Ballymun, Dublin 9 has been unoccupied since 15th January 2015. The Community Unit was previously occupied by Ballymun Drop in Well Family Resource Centre Limited.

Through the Ballymun Area Office, Pieta House C.P.S.O.S. has expressed an interest in the Community Unit, as they want to use it as a centre for the provision of their services to the community. The Ballymun Area Office has recommended the granting of a five year lease of the Community Unit to Pieta House C.P.S.O.S., as a centre of this nature based in Ballymun will benefit the community by enhancing a number of local strategies regarding mental health and by servicing local needs. The Chief Valuer has agreed terms for the proposed grant of a five year lease of the Community Unit, to Pieta House C.P.S.O.S.

It is therefore proposed to grant a lease of Unit 3 at Coultry Neighbourhood Centre, 22 Santry Way, Ballymun, Dublin 9 to Pieta House C.P.S.O.S. Limited outlined in red coloured pink on Map Index No. SM-2015-0784 subject to the following terms and conditions:

- 1. That the subject property is shown outlined red coloured pink on the attached map Index No. SM-2015-0784.
- 2. That Pieta House shall be granted a five year lease of the ground floor unit at 22 Santry Way, for community use only, commencing as soon as practically possible subject to the necessary statutory approvals being obtained.
- 3. That the rent shall be the sum of €12,000 (twelve thousand euro) per annum, payable quarterly in advance by standing order or electronic funds transfer.
- 4. In the event of the property ceasing to be used for community use it shall revert to Dublin City Council without financial penalty.
- 5. That Pieta House must sign a Deed of Renunciation prior to the execution of the lease.
- 6. That Pieta House shall be responsible for all utilities and maintenance incl. installed security system etc.


- 7. That Pieta House shall be responsible for fully insuring the premises and shall indemnify Dublin City Council against any and all claims arising from its use of the premises. The Lessee shall take out and produce Public Liability Insurance in the sum of €6.4million and Employer Liability Insurance in the sum of €13 million for any incident with a recognised Insurance Company with offices in the State and the policy shall indemnify the City Council against all liability as owner of the property.
- 8. That Pieta House shall keep the property in good condition and repair during the term of the Lease and not carry out any internal or external alterations without the prior consent of Dublin City Council.
- 9. That the Lease can be terminated by either party giving six months notice in writing.
- 10. On termination of the Lease, Pieta House shall at its own expense remove all materials not belonging to Dublin City Council and shall leave the property clean and cleared to the satisfaction of the City Council.
- 11. That Pieta House shall not assign or sublet the premises.
- 12. That the Lease shall include any amendments and/or other conditions as are deemed appropriate by the City Council Law Agent.

The disposal shall be subject to such conditions as to title to be furnished as the Law Agent in his discretion shall stipulate.

The dates for the performance of any of the requirements of the proposed agreement may be amended at the absolute discretion of the Executive Manager.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.

855 57-75 Botanic Road, Dublin 9 Former Player's factory: granite facade, including railings, gate, piers, plinth walls and *red brick chimneystack*

Procedure Followed:

In accordance with the procedures set out in Section 54 and 55 of the Planning and Development Act, 2000, Dublin City Council indicated its intention to add **Chimneystack**, **Former Smurfit Printing Works**, **57-75 Botanic Road**, **Dublin 9** to the Record of Protected Structures (RPS). The proposed addition was advertised in the Irish Times on 22nd July 2015. The public display period was from 22nd July to 2nd September, 2015 inclusive.

Request for Addition:

Roisín Shortall, T.D., Dáil Eireann, Dublin 2

Summary of Applicants Reasons for Seeking Addition:

The old chimneystack should be listed as a protected structure as it is a significant and elegant local landmark and a monument to the previous use for the site. It was afforded a certain degree of protection when the Local Area Plan was drawn up for the site. However, listing it as a protected structure will afford it even greater protection and will ensure that it is retained in the event of the LAP being abolished as is currently proposed.

Furthermore the Phibsborough/Mountjoy Local Area Plan includes a key RPS objective (Objective 7) that the chimneystack be included in the Record of Protected Structures: Chimneystack, former Smurfit Printing Works (circa 1920-1930), round red brick chimney, representing a local landmark and the former industrial use of the site.

2011-2017 Development Plan Zoning & location map: The location of the chimneystack is shown in red. The zoning objective for the site is Z10: *To consolidate and facilitate the development of inner suburban sites for mixed use development of which office, retail and residential would be the predominant uses.*

Summary Description:

Red brick chimney stack, built *circa* 1935, with square base and tapered circular profile chimney shaft on south side of former tobacco factory site. The facade of the former tobacco factory and associated front boundary which fronts Botanic Road is already a protected structure: *'Former Player's factory: granite facade, including railings, gate, piers and plinth walls'*.

Historical Background:

2008 Record of site from the Dublin City Industrial Heritage Record:

Exterior Description: Former tobacco factory built c.1935, later functioning as a printing works and now in various uses. Multiple-bay, single-storey and a half granite entrance front (west elevation) with advanced terminating bays to north and south. Central Portland limestone entrance with carved detail incorporating 'JPS' monogram grouped under a segmental-headed pediment. Mansard roof to entrance front with alternating segmental and pedimental dormer windows. Granite entrance piers, cast-iron railings and gates to front of site (Botanic Road). Extensive single, two and three storey factory and warehouse range to rear (east) comprising a wide range of building phases. Features include north-light roofs, mild steel casement windows and loading bays. Red brick free-standing chimney to southeast of site with adjacent mass concrete water tower.

Appraisal: The former 'Players' factory illustrates the growth and development of the tobacco industry during the interwar period when cigarette sales were reported at an all time high. Though now in use as office and storage space, the external elevations appear to have altered little in recent years and as such the complex represents a rare surviving example of a purpose-built twentieth-century factory building. The architectural grandeur and impact of the entrance front façade and boundary railings contrast sharply with the utilitarian and functional factory ranges where decorative detail is at a minimum. The incorporation of the 'JPS' monogram, symbolising John Player & Sons, within the entrance reflects a confidence and faith in the longevity of their enterprise often no longer present in modern industry. As a major employer in the Dublin area, the site is also of social interest.

Assessment of Special Interest under the Planning & Development Act 2000:

The structure is considered to be of special interest under the following headings:

- Architectural: This structure, constructed, circa 1935, is an important part of the former tobacco factory complex and is a local landmark visible from several vantage points in the area. It is also a reminder of the former industrial use of the site.
- Social: As a major employer in the Dublin area the site is also of social interest.

Significance/NIAH Rating:

The National Inventory of Architectural Heritage (NIAH) has not been carried out for this area; however, its categories of special interest (architectural, historical, archaeological, artistic, cultural, scientific, technical & social) and its rating system has been used to assess the buildings in question. The NIAH identifies five categories of rating in seeking to rank buildings. The NIAH rating values are International, National, Regional, Local and Record Only (I, N, R, L, O). Structures which are considered of International, National, and Regional significance are deemed worthy of inclusion on the RPS. Using the NIAH System of rating this structure is considered to be of Regional significance. This is a structures or sites that make a significant contribution to the architectural heritage within their region or area.


Summary of Applicants Reasons for Seeking Addition:



Summary Description:

Detached, five-bay, two-storey house with central window in the front gable. The central entrance door is 18th century segmental headed with moulded architrave similar to the windows architraves at Dublin Castle. It is the only example of its type to survive in a Dublin house. The interior contains original features including a panelled hall, panelled window shutters and an original staircase. There are reputed to be two ornate marble fireplaces to two of the first floor rooms. The front elevation is finished with a cement render and painted while the side and rear elevations have been pebble dashed. (Planning permission ref. no. 1673/93 details on the original elements retained as conditions of planning. These include internal joinery finishes, staircase and roofing timbers).

Historical Background:

An Taisce have stated that it is a 1720's house and is one of the few early 18th panelled houses to survive in the Dublin area. On John Roque's 1756 map of Dublin, the area north of the Tolka River shows a certain level of development. The road is not clearly defined on the map so it is difficult to identify orientation of the houses. However the architectural design features and form of the house would date it to the early 18th century.



51 Glasnevin Hill set perpendicular to 49 Glasnevin Hill may have been the former dairy which was also reputed to contain an early panelled room. It was subsequently converted into a shop c.1900 and recently converted into a two bedroom residence, planning ref. no. 3056/12.

Assessment of Special Interest under the Planning & Development Act 2000:

The structure is considered to be of special interest under the following headings:

Architectural: This building has important architectural significance as a rare example of an early 18th century detached house with a panelled interior and makes a positive contribution to the streetscape and the urban setting.

Historical: The house is situated in a prominent elevated site above the Tolka River in the heart of Glasnevin village which in the 18th and 19th century was a favourite summer residence place of Swift, Addison, Sheridan and Parnell (Bennett, D, Encyclopaedia of Dublin, Gill and Macmillan, 1991 Pg. 84). In this respect, the building provides the link to the character of past age. It is a significant element of this 18th century village setting above the Tolka River.

Significance/NIAH Rating:

An official recommendation has not been received from The National Inventory of Architectural Heritage (NIAH) at this stage; however, its categories of special interest (architectural, historical, archaeological, artistic, cultural, scientific, technical & social) and its rating system has been used to assess the buildings in question.
