#### Re: Community Premises at Greendale Road - KADCA

Please find enclosed an update in respect of Item 4990 of the North Central Area Committee meeting held on 21<sup>st</sup> December 2015.

By way of background Dublin City Council under Indenture of Lease dated 17<sup>th</sup> November 1975 demised a site at what was then known as Thornville Road, Kilbarrack to Kilbarrack & District Community Association for a term of 99 years from 13<sup>th</sup> November 1975 subject to an abated rent of €33.01 per annum so long as the site is used for a community centre. It should be noted that the construction of the community centre itself was funded by KADCA. Accordingly in practical terms the Council only has a small residual interest in this property.

It would appear that at some stage part of the premises was occupied by KCCP and subsequently a dispute arose between KADCA and KCCP which led to the institution of legal proceedings by KADCA to have KCCP ejected from the building. As part of these proceedings KCCP claimed that they had an entitlement to a sub-lease in that portion occupied by them. I am not sure whether or not these proceedings were ever settled but the Property Management Section is aware that there were numerous attempts by various third parties to try and mediate a solution.

It appeared to Dublin City Council that matters had been settled when KADCA applied to Dublin City Council for consent to grant a sub-lease in part of the premises to KCCP which said consent was duly granted by way of letter dated 9<sup>th</sup> January 2014.

In November 2015 the Council's Property Management Section as part of their ongoing file review process sought an executed copy of the aforementioned sub-lease for their records from the Solicitors of KADCA. To the Council's surprise the Solicitors for KADCA subsequently advised that the sub-lease had not yet been executed but that they had been in correspondence with the legal representatives for KCCP and had received no reply and further legal action was being undertaken.

The role of the Council's Property Management Section is to ensure that the covenants of the lease between Dublin City Council and KADCA have been complied with and as the Council has no objection to KCCP occupying part of the property and has already given its consent to same there is no role for the Council's Property Management Section in what is effectively a legal dispute between two other separate legal entities and their advisors.
