HALLOWEEN REPORT 2015

Collection of Halloween bonfire materials started in September in South Central Area. For the main part this was accomplished through crews and plant supplied by Waste Services, with the option of using contractor's vehicles and labouring crews if the occasion demanded. Tonnages of materials collected by the main Departments are still being collated and a report by the corporate Halloween Working Group will follow.

As stated above, the Public Domain Unit use contractors to bolster DCC's own resources over the Halloween period. There were 78.2 tonnes of material collected by contractors engaged by Public Domain Unit. Out of a total of 78.2 tonnes, slightly over 40 tonnes were collected on 31st October (including approx 1000 tyres).

The security arrangements with An Garda Síochana worked very well and allowed plant & crews to operate between 6am and 5pm on Halloween without incident. These security arrangements were also adequate to cover part of South East Area.

The cost of the additional plant and crews arranged by Public Domain Unit over the four weeks prior to Halloween and on the 31st of October was €18,800.

COLD WEATHER INITIATIVE

The new Cold Weather Initiative is due to open on Friday, 20th November, with 100 emergency beds and is located in the Digital Hub (off Thomas Street).

PROJECTS IN THE AREA

New Public Park, Cork Street

Following agreement at the September Area Committee meeting a Part 8 planning application for a 0.6 hectare neighbourhood park on the site of the demolished Chamber Court and Weavers Court on Cork Street was advertised on 18th September. A copy of the plan was available for inspection in the Planning Department in the Civic Office for 6 weeks from that date. A report is listed on this months Area Committee Agenda.

Newmarket

A Public Realm Improvement Plan for Newmarket and its environs is due to be finalised shortly with a view to making a presentation at the December Area Committee meeting. The Plan will describe, support and guide the implementations of improvements to enhance the use and attractiveness of the area.

Francis Street

Following workshops with local residents and businesses in July 2014 the Francis Street Public Realm Improvement Plan was finalized at the end of last year. It is now intended to progress the plan to a Part VIII Planning Application stage and, as part of this process, an information meeting took place with businesses for 17th November in the Cross Gallery, 59 Francis Street.

St. Catherine's Park, off Thomas Street

It is planned to install 16 low level bollard lights in St Catherine's Park/Graveyard. The lights will be an attractive feature of the park and should help to attract additional visitors to the location.

City Walls, Cook Street

A contractor has been selected for the supply and fit of 11 floodlights at Cook Street to illuminate the old city wall. Following a favourable demonstration it is expected that the installation works will take place in late November.

St. Audeon's Park, High Street

St. Audeon's Park is included in the Liberties Greening Strategy. As part of the proposed improvements to High Street design works are ongoing to redevelop the park and to create a more open and publicly accessible area by removing railings and selective trees.

Dubline

It is planned to install information panels will be placed at strategic points along the Dubline route in early December. The locations in the South Central Area will include:

- Kilmainham Gaol
- Royal Hospital Kilmainham
- St. James Church
- BOI James Street
- NCAD Thomas Street
- City Wall, Thomas Street
- High Street

Dolphins Barn

Works to erect a boundary wall between the site of the now demolished City Council acquired buildings on the eastern side of Dolphin Barn and the rear limits of the houses at St. James Terrace are now complete. It will be necessary to carry out repairs to the footpath and to install new raised kerbing before a pop-up linear park is created in the area between the new boundary wall and the public footpath prior to its possible future development.

Oscar Park

It is planned to install seating as part of the central feature in Oscar Square, Dublin 8. This work is due to take late this year or early next year.

Vicar Street

Works to improve the pitch, including the repair and painting of the fencing, and to erect basketball hoops at Vicar Street are due commence in late November/early December. A target wall, ball catcher and mini goals will also be installed.

Re-roofing Programme

A programme to re-new the roofs in Thomas Court Bawn, School Street, Marrowbone Lane Flats and Meath Place was recently completed. Works to the roof lights, chimneys and tank houses were included.

Works to carry out similar works to the roofs in Braithwaite Street are due to commence shortly.

It is expected that work to the roofs in Summer Street South and Pimlico Terrace will be carried out early next year.

Basin Street Flats

Works to convert an additional 4 bedsits into 2 x 1 bedroomed flats started on 9th November following the completed conversion earlier this year of 4 bedsits in the same complex.

The upgrade of the surface of the playground in Basin Street commenced on 3rd November.

Oliver Bond House

Works to develop 6 bin corals in Oliver Bond House is ongoing. This will create an enclosed area for the bins at a distance from the entrances to the complex which should reduce illegal dumping and possible damage to vehicles.

COMMUNITY INITIATIVES

Rising Commemoration Fund for the South Central Area

47 groups in the South Central area have been allocated funding from the 1916 commemoration Fund. In the coming weeks the community team will contact the groups and meetings will be organised in the three area offices to help the communities coordinate their events. By bringing the groups together we hope to be able to pool ideas and resources and hopefully produce a varied programme of events.

Tips for Winter

Winter weather cards and leaflets are being prepared for older residents with useful information on safety & warmth, emergency contact numbers and household tips.

Age Friendly Activities

A list of achievements from the South Central Area is currently being compiled for the Dublin City Age Friendly report. A meeting of the South Central Area Age Friendly Alliance and the South Central Area Older Persons Council will take place on Friday 27th November 2015.

Older Persons Phone Audit

An audit is to be carried out by the Older Persons Council on how user friendly Dublin City Council's automated telephone routing and how Age Friendly the Customer Care staff are. This will take place on Friday 27th November in the three area offices.

Community Grant Scheme

The closing date for the Community Grants has passed and all staff are currently going through the applications to ensure eligibility requirements are met.

Swift Conservation Presentation

A swift conservation presentation will take place at Lyons Villa in Chapelizod Village. This is a follow on to the Swift Nest Box project which took place there earlier this year. This presentation will be given by Eric Dempsey on 27th November and is open to the general public. Presentations will also take place in St Patrick's School, Chapelizod on the same date. Light refreshments will be served.

Leaf Gathering Time - G

The Pupils from St Louise's School in Ballyfermot will once again be busy gathering leaves from The Civic Centre Garden in Ballyfermot during November. The leaves make wonderful mulch for the school's vegetable plot but most importantly its time out of the class room and an opportunity to connect with the colors, textures and smells of nature. Great Fun!!!!

Kilmainham Arts Festival

The Kilmainham Arts Festival takes place all around Kilmainham from the 12th – 16th November. Activities include poetry readings, workshops, film shows, masamba drumming and various other activities.

The Ballyfermot Garden Club
