Report from Traveller Accommodation Unit

Update from the February North Central Area Committee meeting:

The Traveller Accommodation Unit (TAU) commissioned a survey in order to complete improvement works around the Traveller encampments at Belcamp Lane. When the report is submitted, DCC will undertake improvement works

- to bank around the existing encampment,
- change the access to Belcamp Lane
- mitigate against the risks associated with the unauthorised openings onto the Newtown Court Access Road.

An Garda Síochána provided support to complete the survey.

In addition, there are likely to be actions arising from the recent Fire Review; however we have not yet received a copy of the final report.

There is no decision on long-term accommodation options, given the 2015 unauthorised occupation of St. Dominic's by another extended Traveller family. Alternative accommodation options would be a critical factor in any legal case.

Rapid Build Housing Delivery Update

DELIVERY OF 22 RAPID BUILD HOUSING UNITS (MODULAR HOUSING) IN POPPINTREE, BALLYMUN, DUBLIN 11

The delivery of 22 units of Rapid Build Housing in Poppintree is close to full completion.

The 22 houses are two-storey units, with three bedrooms and will provide temporary accommodation for families who are experiencing homelessness and who are currently accommodated in commercial hotels by the local authority, on an emergency basis.

Work is ongoing with Dublin City Council's Homeless Central Placement Service (CPS) to assess and appropriately place families in the new units in Poppintree.

The CPS are working with families to ensure suitability of placement, considering key elements such as vicinity to local schools and existing family supports.

INITIATION OF COMPETITION FOR FURTHER 131 RAPID BUILD HOUSING UNITS

Dublin City Council initiated a competition for 131 Rapid Build Housing Units, on Wednesday 2nd March 2016.

In order to facilitate optimum market participation in the competition, Dublin City Council will look for expressions of interest with individual completion dates for specific sites. This will take into consideration the specific number of units to be built on each site.

There are four sites selected and located in the Dublin City Council administrative area, they include;

1. **Drimnagh** – site will commence work in the beginning of April 2016
2. **Belcamp, Malahide Rd** – site will commence work in the beginning of July 2016
3. **Ballyfermot** – site will commence work in the beginning of April 2016
4. **Finglas** – site will commence work in the beginning of April 2016

The service diversions have already been completed on the Belcamp site.

A draft layout of the development is included in this report and will be issued to the residents for discussion following the area committee meeting.

An invitation will be sent to the Belcamp residents Association to view the houses in Ballymun at the end of March.

The rapid delivery houses meet all of the current building regulations and the ground floor has a solid red brick out leaf.

The intended timelines of this competition are working towards the completion of all units by Autumn 2016.

The four Dublin local authorities are working towards the further delivery of a further 350 units approximately across the Dublin region to address the temporary accommodation needs of families in commercial hotels. Further detail in relation to this will be provided.

Housing Allocation Directive for Homeless Priority Households- The Dublin local authorities continue to implement the ministerial directive which requires that **50%** of allocations are utilised for homeless households and other vulnerable groups

Tusla

A Homelessness Liaison Officer has recently been appointed with Tusla with the remit of co-ordinating child and family resources to dedicated supported family accommodation settings, particularly in relation to child protection. The Homelessness Liaison Officer links with the Dublin Region Homeless Executive around access for children and families to Family Resource Centres. It also provides guidance for Home School Community Liaison and School

Completion staff on helping children and families experiencing homelessness to maintain regular school attendance. School Completion Programmes have been asked to prioritise homeless children for services such as breakfast and homework clubs.

THE RED STABLES, ST. ANNE'S PARK, RAHENY, DUBLIN 5

PRE PART 8 CIRCULATION

ARCHITECT'S REPORT, DECEMBER 2015

The Red Stables (RPS reference 7572) are located in St. Anne's Park, Raheny, Dublin 5 and were originally part of the Ardilaun Estate, owned by the Guinness family. The estate was acquired by Dublin Corporation in the 1930's and opened for public use as St. Anne's Park. The stables were designed in the 1880's by George Ashlin, an architect renowned for his ecclesiastical work. They are of typical Victorian Style Sussex design, laid out in a courtyard format, with the stabling being located to the south east & south west sides of the courtyard, and the coach house area located to the north eastern side. There is a central tower feature to the south eastern side of the courtyard, where there was access to the hay lofts above the stabling, and also a clock tower with a fumarole to the roof.

The residential accommodation located in the north eastern corner of the building was originally for staff accommodation and is currently used as a Park Caretaker living accommodation. Both the ground & first floor areas of this section were not accessible & layouts are indicative & based on external features such as windows & chimney stacks. Further details for this area will be provided for approval once access is possible.

The stables were extensively refurbished in 2004 with a change of use to an Arts & Crafts Centre including two residential units for visiting artists and a café. Earlier this year, the café was relocated to the opposite side of the courtyard, originally a coach house.

Our current proposals include the following:

- change of use from residential to multi-purpose at first floor level above new café
- extension of the café into the north eastern corner of the building with a secondary entrance from the covered yard on the northern elevation
- relocation of passenger lift & stairs from the central bay allowing for the creation of a pedestrian route from the courtyard to the seaward side of the building – new doorway to replace 2 no. existing windows
- insertion of new passenger lift in north eastern corner of building (currently caretaker residence) & re-use of existing staircase.
- removal of modern partition walls at first floor level of central bay to create open-plan mezzanine
- reconfigure existing staff accommodation at first floor level on southern side of courtyard
- removal of non-original first floor structure, passenger lift, stairs & adjacent toilet accommodation in old café and creation of balcony & multi-purpose double-height space
- change of use from artist's studios / exhibition space to multi-purpose cultural use / exhibition space.

The above revisions are being proposed as a result of a review by the Parks Services/Culture Recreation and Amenity and City Architects of the operation of The Red Stables complex to improve its accessibility and potential for cultural activities/events/exhibitions. The improvements proposed will enhance the visitor experience of St. Anne's and ensure the future viability of this significant building.

- **School cricket sessions** are being held in St Francis, Priorswood and Our Lady Immaculate NS, Darndale during this period. There will be a competitive game between the schools, date TBC. Teacher training will be taking place from March to June.
- **After school Sports drop in youth services in area:** Over 150 young people take part in an after school sports drop in program in 4 youth services in the local area. This program is a joint initiative run by DCC Sports Officer, Sphere 17 and Kilmore Youth Project. This program is to introduce young people to different sports like cricket, Olympic handball, indoor tennis and basketball.
- **Boxing programme:** Over 30 young people from in Our Lady Immaculate and Scoil Fhursa Kilmore are taking part in a 12 week boxing programme. They have completed the Bronze and Silver phases and are onto the Gold stage with the hope to box for their school in the National Stadium in April.
- Kilmore and Harmonstown Youthreach groups will be taking part in a Boxing/Fitness session at the National Boxing Gym on the 8th of April at 10.30am.
- The 2nd class students of St. Pauls JNS Ayrfield will begin a 4 week Startbox programme on Monday 4th of April 10am.
- The 6th class students of Holy Trinity SNS Donaghmede will continue the 3rd part of a 13 week Startbox programme. Schools from across all areas of the city will come together at the National Stadium on Thursday 7th of April.
- **Athletics:** Scoil Catriona & Our Lady Immaculate Darndale are taking part in a track and field indoor athletics programme that will be part of a city wide event for schools. It will culminate in Street Olympics to be held in the city centre before Rio 2016.
- **Get Schools Rowing:** This is a pilot rowing programme in Darndale which hopes to get 8 young people trained to row for their school down the Liffey in April, competing against 3 other schools.
- **Kilmore Youthreach Fitness & Sport:** Kilmore Youthreach are involved in a women's fitness and health programme run by DCC every Thursday. This programme aims to teach the young women the importance of health and fitness in their lives.
- **School Completion Absentee Programme:** This programme is run in partnership with the FAI, school completion and DCC. It tries to improve school attendance of young primary school boys and girls through a soccer program run in the Oscar Traynor pitches. It is run on behavioural and attendance basis.
- **Ultimate Frisbee:** This is a new sports programme DCC are running in St Francis School. The idea of this programme is to teach young people that movement and functional games can be good for fitness and team work.
- **Boxercise for Girls:** This is a fitness class for 4th, 5th & 6th class groups in Scoil Ide, Kilmore. The premise is to help young girls enjoy fitness and teach them that their health is very important in their lives.
- **Travach soccer for girls:** Traveller girls to play soccer in the Glin Road centre. This is a 4 week programme culminating in a competition with other traveller groups.

- **Tag Rugby:** 6 week tag rugby programme in St Benedicts, St Pauls Ayrfield and St Marys NS, Kilbarrack. Tag rugby as part of community Easter Camp in Belcamp Park with Dean Swift Sports Club and as part of Active Schools in St Francis NS Priorswood
