Following completion of the Naniken Study upstream of St. Annes Park, I can report the following:

- On Tuesday, March 15th, the 18 houses that were recommended by the RPS under the option of individual house flood protection were called to.
- The houses visited and given an questionnaire were numbers 55, 53, 51, 49, 47, 45,43,41,41A,39A,39, 37,35,33,31,29,27 and 25.
- Each house was given a specially prepared questionnaire(see attached).
- Of the 18 doors knocked on only got 8 answered.
- As of today we have received 5 completed questionnaires back.
- As a month has now passed since our first visit, we plan to call again to the residents which have not returned the questionnaire with the hope of getting it completed.

- Active Schools Week: This is a week of sports organised for schools in the area from 25th 29th April. DCC Sports Officer will supply coaches and funding to help the schools. OLI School Darndale area going for the Active School Flag; the 3rd school in the area to achieve this in the past three years.
- **Olympic handball**: This is a new programme running in Scoil Fhursa, Kilmore a great opportunity to take park in a new sport. Taking place on Thursday mornings in Kilmore hall.
- After School Sports Drop In: Over 150 young people are taking part in an after school sports drop in program with four youth services in the local area. This is a joint initiative run by DCC Sports Officer, Sphere 17 and Kilmore Youth Project. It introduces young people to different sports including cricket, Olympic handball, indoor tennis and basketball. This programme runs Mondays, Tuesdays, Wednesdays & Fridays.
- **Boxing program:** 12 young people from OLI school and Scoil Fhursa Kilmore are taking part in a 12 week boxing programme. Having completed Bronze and Silver stages, they have progressed to the Gold stage and will hopefully box for their school in the National Stadium on 27th or 28th April.
- Athletics: Scoil Caitriona & OLI Darndale are been funded by DCC sports officer to participate in a track and field indoor athletics program that will culminate in a city wide event for schools. This will also form part of the Street Olympics to held in the city centre before Rio 2016 all details TBC.
- **Get Schools Rowing**: A pilot rowing program will be run in Darndale with the hopes of get young people trained to row for their school down the Liffey in April/May, competing against 3 other schools. Also a city wide rowing programme will finale in take place in City Hall on 20th April.
- **Kilmore Youthreach Fitness & Sport**: Kilmore Youthreach participate in a women's fitness and health program run by the DCC sports officer every Thursday at 2pm. This program is trying to teach the young women the importance of health and fitness in their lives.
- School completion absentee program: This very successful program is run with the FAI, school completion officers and DCC. This program tries to help young primary school boys and girls attend school though a soccer program run at the Oscar Traynor pitches. The program is based on behavior and attendance and will recommence every Wednesday from the first week of May.

- **Ultimate Frisbee**: This is a new sports programme running every Wednesday in St Francis School. The idea is to teach young people that movement and functional games can be good for fitness and team work.
- **Boxercise for Girls**: This program is a fitness class for 4th,5th & 6th class in scoil ide school in Kilmore the idea is to help young girls enjoy fitness and teach them that health is very important in there lives, this runs every Thursday from 12pm to 2 pm.
- Travach Soccer for Girls: This programme takes place in the Glin Road Centre. And will culminate in a competition with other traveller groups. Travach is the new youth service opened in Priorswood working with travellers in the area.
- 4v4 Soccer Coach Education Course taking place on the 19th April at Clontarf Pitches.
- School cricket sessions are being held in OLI NS, Darndale on Fridays from 10 11.30am and in St Francis, Priorswood on Fridays from 1 2.30pm. Both teams are in the Leprechaun Cup where they play a game against each other (date TBC).
- Schools Swimming Lessons: Thursday and Fridays from 1 2pm at Coolock Swimming Pool. Started 7th and 8th April for 6 weeks.
- **Sport Ireland Community Walking Programme**: Starting one morning per week from 25th April, exact details TBC. All ages/abilities.
- New Communities Partnership, Information Sharing Day: Saturday 23rd April, Wood Quay Venue. Sports Officers will be on hand to provide information about their work and how people can get involved in sports and physical activity in their area.

RED STABLES MARKET, ST. ANNE'S PARK

Following an invitation to tender which was advertised in October 2015, the concession to operate a full day weekend farmers market in St. Anne's Park was awarded to Jackie Spillane. The concession will be for a three year period, with the option, at the sole discretion of Dublin city Council, to extend for a further two periods of one year each.

The current operators of the market, ALA Markets and Events will remain in situ until Saturday 30th April 2016 and Jackie Spillane will then commence operating the market on Saturday 7th May 2016. The market will be re-branded as The Red Stables Market and will operate every Saturday from 11.30am to 4pm. The market will focus on providing high quality artisan produce, in season vegetables and arts and crafts stalls. The operator will promote the market through a newsletter, which will be made available in electronic format and there will also be a leaflet drop to residential properties in advance of the commencement date.

St. Anne's Park is one of the most popular parks in the city and currently provides a wide variety of public amenities. It is anticipated that the re-invigorated market will enhance the enjoyment of the park by providing an additional and alternative retail experience for park users. Research from both Europe and the US, indicates that well run public markets tend to boost adjacent retail business and the market can also provide an alternative option to businesses in the area to take a stall and promote their products to a wider audience. It is hoped that the Red Stables Market will not only raise the profile of the park itself but the wider area generally.

Kilbarron Road

Kilbarron Road and surrounding Roads adjacent to Beaumont Hospital are standard 6m wide residential streets with off road parking available to most residents. The public carriageway is free to all & residents have no rights over others regarding parking outside their homes. Parking arrangements are usually based on common courtesy between neighbours; however problems can arise when there is a deficit of on street parking due to multi vehicle households or intrusion from outside as is the case with overspill parking from the Hospital.

Parking restrictions have been provided where appropriate on residential roads adjacent to Beaumont hospital while at the same time being mindful not to inconvenience local residents with further restrictions.

Parking restrictions and other measures are generally not provided in situations that are already covered under the Road Traffic Act, where enforcement can be carried out by the Gardaí or Dublin Street Parking Services.

Dublin City Council cannot provide for 'Residents only Parking' on a particular road as there is no legal basis to restrict parking on a public road to the residents of that road.

A measure to address the situation in the Cul De Sac on Kilbarron Road has been recently recommended by The Traffic Advisory Group on 23/02/2016.

In order to prevent parking on the concrete island and to regularise on street parking, it has been recommended that indented parking be provided on the southen side of the island. This will be included on a future works programme when there is available funding. This measure together with the existing double yellow lines at either side of the entrance to the cul de sac should relieve the parking situation on this section of Kilbarron Road.

Dublin City Council will continue to deal with parking issues as they arise on a case by case basis in the appropriate manner.

With reference to the proposed disposal of Dublin City Councils fee simple interest in the City Estate premises now known as No. 26 Marino Mart, Fairview, Dublin 3.

By way of Indenture of Lease dated 20th October 1928, Dublin City Council demised a plot of ground referred to in the said lease as sites numbered 25 & 26 at Marino Mart to National Irish Bank for a term of 150 years from 25th March 1928 subject to an annual rent of €25.39 (£20.00) and the erection of a building now known as No. 26 Marino Mart, Fairview, Dublin 3.

The current lessee is Ranata Limited who is in receivership and the receiver David Carson of Deloitte & Touche has applied to Dublin City Council to acquire the Council's fee simple interest therein.

The Chief Valuers Office reports that agreement has been reached and accordingly it is proposed to dispose of the Council's fee simple interest in the premises now known as No. 26 Marino Mart, Fairview, Dublin 3 to David Carson of Deloitte & Touche being the Receiver of the interest of the lessee Ranata Limited subject to the following terms and conditions:

- 1. That Dublin City Council holds the fee simple interest in the property.
- 2. That the property which is more particularly delineated outlined red and coloured pink on Map Index No. SM2015-0959 and is now known as No. 26 Marino Mart is held under Indenture of lease dated 20th October 1928 between Dublin City Council and National Irish Bank Limited, for a term of 150 years from 25th March 1928, subject to a yearly rent of €25.39 (£20.00).
