To the Chairperson and Members of the North Central Area Committee

TRINITY ADULT RESOURCE GROUP FOR EDUCATION AND TRAINING (TARGET).

Trinity Adult Resource Group for Education and Training Limited (TARGET), based in St. Kevin's Junior National School, Newbrook Road, Donaghmede, Dublin 13, provide a range of important counselling, educational and recreational services in the community and we have had a positive and good working relationship with the group over a long period. The situation now being faced by TARGET, where they were informed of a decision by the Board of Management of St. Kevin's, indicating that the school was not in position to renew the lease into the future, was considered at the last Area Committee meeting and is the subject of a motion on today's agenda in the name of Councillor Michael O'Brien.

Earlier in the year, we became aware that the school was seeking the return of two rooms used by TARGET from September 2016. However, at that stage it was anticipated that a large room currently used by a number of groups, including the Donaghmede Men's Shed, would be subdivided and the users facilitated in this new two roomed arrangement. To take the pressure off the available space, we facilitated a move of the Donaghmede Men's Shed to Unit 60 in Belmayne. We understand that the school submitted an application in June 2015 to the Department for Education and Skills, for the refurbishment of existing accommodation to create two classroom-sized spaces to provide a mainstream classroom and a resource room for special education in line with that agreement. We are advised that the Department subsequently approved that application and the funding was provided. Why this arrangement, which had been accepted by TARGET, was not implemented remains unclear. However, the Department has indicated that there was pressure on enrolments at the school, which had experienced a 57% increase in the period between 2011 and 2015. That trend is continuing.

Nevertheless, we share the concern of the group and the local community with regards to the impact of the decision by St. Kevin's Junior school to take back the space which it had made available to TARGET and the timing and manner of the delivery of that decision. It should be pointed out; however, neither the council, the City of Dublin Education and Training board (CDETB) nor the Department for Education and Skills had any advance notice of that decision.

Whilst our local Community & Social Development staff are in regular contact and provide assistance to the group, they are not a major funder and indeed the range of services provided by TARGET go well beyond the remit of even the Department of Education and Skills, which specifically support them in respect of adult education provision through the CDETB. The Department also has a major role in relation to the school.

There is a shortage of buildings available in the North Central Area for community purposes and we are working with a number of groups on similar issues. Unfortunately, there is no easily available or practical solution to meet the shortage of space. We are aware that this particular group are examining a number of options, including other buildings or sites which might support possible prefabricated buildings. Dublin City Council is not involved in the existing lease/license arrangements between St. Kevin's Junior School and TARGET. Therefore the council has no direct role in the matter. However, we are aware of developments and it was our belief, expressed at that last Area Committee that there was an opportunity for a suitable arrangement to emerge, through discussions then taking place with the Department of Education and the City of Dublin Education and Training Board (the main funder of TARGET).

Finding a suitable building within the timeline available to facilitate TARGET's community services (childcare, counselling service and counselling course, not to mention the other services already displaced) and the large amount of equipment, e.g. cookers, sewing machines, computers, tables chairs etc; is a huge task and one that they are simply unable to meet.

Our present understanding is that following a meeting on 28th June with the Parish Priest and a representative from Archbishop House, a letter issued which merely confirmed the original stance taken by the Board of Management, with the only compromise being that TARGET could remain on the ground floor until the end of June 2017. The impact of this decision has resulted in the loss of the cookery room, computer room, home furnishings, photography class and the canteen, as well as the Community Garden. In addition, other restrictions have been proposed, purportedly to comply with child protection requirements, which will further inhibit use.

Finally, we have concerns about a number of other community based activities currently located in schools, which we believe are in imminent danger of facing the same kind of issues, that has led to the displacement of TARGET. Given the commitment in the programme for Government, that "schools buildings must be utilised out of hours, both throughout the day and throughout the year", we believed that this would increase rather than diminish the use of school buildings, particularly in North Central, where there is a deficit in purpose built community space. However, the present situation has only added to the uncertainty, at least in the short term.

However, in spite of our overall dissatisfaction with the present situation and emerging trends, given the lack of any buildings available to us, we cannot see how we can usefully get involved in resolving the situation in the short term, other than to prevail on the Department of Education and Skills and the other key players involved, to examine all possibilities and work to resolve the present situation.

DUBLIN CITY SPORT & WELLBEING PARTNERSHIP 18TH JULY 2016

- The Football Development Officer for the area will be rolling out the following Soccer Camps: 11-16 July in Oscar Traynor; 18-23 July in Kilbarrack; 25-29 July in Killester (August Camps TBC)
- A soccer based programme continues every Thursday at 3pm in Kilmore Community Centre. This initiative, run by DCC Sports Officer in conjunction with the HSE, aims to use sport & physical activity as a tool to help men with mental health issues.
- Rugby: The Metro 7's Programme for U14's continues every Monday evening in Coolmine RFC, running until
 mid August.
- Our Cricket Development Officer will be liaising with DCC Sports Officers in the area to organise the running
 of cricket programs for the coming months. He will also be present at any Family/Sports days that have been
 arranged in the area during the July/August period.
 There are a lot of children from this area that are involved in our boys and girls provincial squads (U11-U17)
 and we will be holding training sessions and competitive games for those involved especially in the Clontarf
 area
- The Dales Physical & Wellbeing Programme is an initiative jointly run by our DCC Sports Officer and The Dales Drug Programme, Darndale. The 12 week programme takes place every Wednesday for 2 hours and targets people with addiction problems. The programme compromises 6 weeks of boxercise in Darndale Boxing Club followed by 6 weeks of yoga. The idea is to teach participants that a healthy body & mind can assist in overcoming addictions.
- After-School Sports Drop-in: This ongoing programme is a partnership initiative between DCC Sports Officer, Sphere 17 Regional Youth Service & Kilmore Youth Project. So far over 150 young people have been introduced to sports such as cricket, Olympic handball, indoor tennis & basketball. The programme runs every Monday, Tuesday, Wednesday & Friday.
- DCC Sports Officers will be linking with a number of projects & schemes in the area to help provide an increased range of exciting activities as part of their Summer Camps/Programmes.
 These include: Darndale Youth Project, Kilmore Youth Project, Kilbarrack Youth Project, Donnycarney Youth Project, Kilbarrack Coast Community Youth Project, Trinity Youth Project, St. Monica's Youth Centre, Donnycarney CE Scheme & Donnycarney Family Support Group, catering for approx 400 young people and young adults in total.

Summer Programme Activities will include: Zipit Forest Adventure, Pier Jumping, Speed Boating in Dun Laoghaire, Tag Rugby, Arts & Crafts, Ultimate Frisbee, Footee Golf, Biodiversity Activities on Dollymount Beach, Tennis Sessions, Swimming, Mountain Biking, Crystal Maze, Bowling, Crab Fishing & National Aquatic Centre visits.

CONSTRUCTION OF SPRINGDALE PARK SPORTS CHANGING BUILDING REPORT FOR INFORMATION PURPOSES ONLY:

Works Period

Dublin City Council Parks and Landscape Services are advising the North Central Area Committee of their intention to commence with the construction of the new Springdale Park sports changing building on August 2nd 2016 and it is expected to be complete by 27th January 2017.

Location

The building will be located on a plateau along the northern edge of Springdale Park behind a screening of trees along Springdale Road between the junctions of Edenmore Park and Edenmore Avenue, Raheny, Dublin 5. A new pathway will provide direct access to the building which will be enclosed in 2.4m high fence enclosure. The building will be 24 hour CCTV monitored.

Working times

8am to 6pm Monday to Friday and 9am to 1pm Saturday.

Building Contractor

The contractors for the project are Tolmac Construction Ltd, a Dublin based company established in 1978 with a reputation of delivering projects to the highest of standards. Tolmac have successfully completed a number of projects for Dublin City Council Park's Department including recent projects in Herbert and Harolds Cross Parks. The company operates a quality management system that is accredited by and certified to ISO 9001:2008.

Health and Safety

Tolmac are accredited A-Grade on the most recent Safe-T-Cert audit in March 2016. The Health and Safety of both the public and those involved with the construction project will be of paramount importance for the duration of the project. On appointment the contractor will prepare the construction stage health and safety plan for the building project. Following discussions with the design team, Dublin City Council's Parks and Landscape services and Dublin City Council Roads Department the contractor will prepare a detailed site setup plan before works commences. This will indicate the site hoarding set out, access to site, parking for construction personnel, traffic management, site accommodation etc.

PART 8 NOTIFICATION – BULL ISLAND, CAUSEWAY ROAD: PROVISION OF DISABLED PARKING IN PROXIMITY TO THE BEACH AND RE-ALIGNMENT OF CAR PARKING ON THE CAUSEWAY ROAD.

Parks and Landscape Services propose to create 10 parking bays for disabled vehicles close to the beach off the causeway road. The loss of natural area will be mitigated by the removal of an equal area of tarmacadam along the access road to the beach where the material from the disabled spaces will be transplanted.

On the causeway road itself, the earth bunds which were put in place some years ago to prevent traveller encampments will be reduced in width to provide for cars to be parked at 45 degrees from the road alignment. The parking bays will resurfaced in a 'honeycomb' geotextile which will allow these areas to recolonise with the natural vegetation of the island.

The location selected for the toilets is the site of an existing boules pitch between the Red Stables and the playground. The boules pitch will be moved to a location agreed with the boules players.
