- 1. The Lord Mayor opened the meeting by informing the Members that he was proceeding immediately with the agenda items that were left at the conclusion of the monthly City Council meeting on the 3rd November 2014.
- 2. Submitted Report No 332/2014 of the Chairperson of the Transportation Strategic Policy Committee (Councillor Ciarán Cuffe) Dublin City Council Parking Control Byelaws 2014. It was moved by Councillor M Flynn and seconded by Councillor R McGinley "That Dublin City Council notes the contents of Report No 332/2014 and hereby resolves to make Dublin City Council Parking Control Bye-laws 2014 as outlined in the report". The motion was put and carried.

- 3. Submitted Report No. 333/2014 of the Chief Executive, Dublin City Council Amended Dublin City Council Strategic Policy Committees Scheme 2014 2019. It was proposed by Councillor R McGinley and seconded by Councillor V Jackson "That Dublin City Council notes the contents of Report No 333/2014 and hereby approves the Amended Dublin City Council Strategic Policy Committees Scheme 2014 2019 as set out therein" The motion was put and carried.

Submitted Report No 298/2014 of the South East Area Committee Breviate for the month of October 2014 *Councillor Mannix Flynn, Chairperson.* It was proposed by Councillor M Flynn and seconded by Councillor R McGinley "That Dublin City Council notes the contents of Report No298 /2014" The motion was put and carried.
- 22. Submitted Report No 297/2014 of the Protocol Committee Breviate of the meeting held on 2nd October 2014 *Councillor Dermot Lacey, Chairperson.* It was proposed by Councillor D Heney and seconded by Councillor M Flynn "That Dublin City Council approves Report No 297/2014" The motion was put and carried.
- 23. It was proposed by Councillor S Stapleton and seconded by Councillor C Ni Dhalaigh "That this Council opens an 'Unused Properties Register'. The owners of private properties that have been unused/empty for a period of more than six months (as per CSO Census 2011 and other official statistics) will be required to register their intention for use with Council. Where these properties remain idle for a period exceeding three months of registration date or where Council is not satisfied with intended use, by the powers granted to it under Section 213 (2) (A) of the Planning and Development Act (2000), this Council will immediately requisition these properties for immediate use as emergency housing, paying no more than a nominal transaction fee to the owner"

An amendment to 'six' months' was made by Councillor Stapleton to the sentence above starting 'Where these properties remain idle for a period exceeding three months of registration date'........... The City Council agreed that this time would be amended to six months. The amended motion was put and carried.

The Chief Executive clarified the legal position in relation to implementing this motion. He informed the City Council that he does not have the power to set up a register as requested nor to compulsorily acquire properties in the manner outlined in the motion.

24. It was proposed by the Lord Mayor and seconded by Cllr. B Smith "That the Chief Executive states if a suitable premises can be found for the Children & Youth Working Group NWIC. (A group is made up of representatives from various projects/services in the NWIC, who work with children, young people and families - (i.e. Aosog Child & Family Project, Step By Step Child & Family Project, Bradog Youth Service, MOST Youth Project, Schools Completion Programme, An Siol Project, JLO, Child & Family Agency, Education Welfare Service). They are badly in need of a premises for their various projects" The motion was put and carried. Councillor P Bourke declared an interest in this item and left the Chamber for the duration of the discussion and decision.

The meeting concluded at 6.45pm to allow the Budget Meeting to commence and all items remaining on the Agenda were deferred to the next meeting of the City Council to be held on the 1st December 2014.
