# Motion 1 from Councillor Dermot Lacey

This committee agrees to consider what steps to now initiate following the publication of the National Transport Authority (NTA) Report on Wilfield Road and Brighton Gardens.

# Motion 2 from Councillor Frank Kennedy

Following the response to my question 12 at the October 2016 SEAC Meeting, and the disgraceful state of the Irish Rail owned land at the footbridge over the Dart line between the Merrion Gates and Sydney Parade Avenue (which is the bridge from behind Ailesbury Mews and the OSG office building into Merrion Parish Church) (see photos attached), this committee resolves to write to Irish Rail calling on it to remedy this situation and clean the site without delay. It has now become a health and safety hazard.

(Q.12 at October 2016 SEAC meeting: To ask the Area Manager to arrange for the area surrounding the footbridge over the Dart line between the Merrion Gates and Sydney Parade Avenue (which is the bridge from behind Ailesbury Mews and the OSG office building into Merrion Parish Church) to be cleaned as it is currently very dirty. This question refers in particular to the footpath and surrounding area between the railway line and the OSG building / Ailesbury Mews.)

#### **Motion 3 from Councillor Claire Byrne**

This area committee opposes the new measures to keep dogs on leash on Sandymount Strand and calls on the Area Manager to outline the rationale behind this decision, to clarify whether this requires a change in bye-laws and to explain why this decision did not come before the area committee in advance of these signs being erected.

# 708. Motion from Councillor Paddy Smyth

This committee calls on the Manager to identify an area of paving in the area which is heavily affected by dog fouling (e.g. outside Herzog Park or the junction of Claremont Road and Serpentine Road) and, after consultation with local residents and businesses, paint a large set of eyes (approx 3 to 5 metres wide) on the pavement that is clearly visible to passers-by.

There is considerable evidence to suggest that this would serve as a cheap but effective method of deterring anti-social behaviour such as dog fouling.

- The surfacing of the cycle lane going south from Rathgar to Terenure is in very bad condition and parts of it need resurfacing where it is badly pitted and uneven.
- Terenure Road West was recently resurfaced right down to the traffic lights at the Bank of Ireland branch in Terenure.
- Going south when the road lines were repainted the cycle lane was left out from the lights at Bol to Eddie Rockets. There are two lanes of traffic - one for Templeogue Road and other Terenure Road West. When traffic is moving and busy it is very dangerous for cyclists as they are getting pushed off the road by vehicles accelerating onto Templeogue Road.
- Need a cycle lane to be marked onto the road or the concrete dishing into the car park of Eddie Rockets needs to be changed in some way.

### 712. Motion from Councillor Mary Freehill

That the DCC / SDCC be re-established as a matter of urgency. Tymon Park has run out of time. This relates to measures to prevent the Poddle River

from overflowing and this proposal was motivated by the 2011 flooding in Harold's Cross and beyond, which resulted in houses being, flooded the loss of life of a woman in a basement in Parnell Road. Currently house owners in the areas affected cannot get house insurance, and some have difficulty in selling their houses.

We have to see if it is possible to retrieve the process without having to start from scratch? At very least it is essential that Dublin City Council plays its part in progressing measures to make Harold's Cross a safer place to live and ensures that the Office of Public Works makes the available necessary funding for this tank.

# Q.1 Councillor Ruairí McGinley

To ask the manager to deal with pothole on Mayfield Road East.

#### Reply:

Road Maintenance will have the pothole filled on Mayfield Road East.

# Q.2 Councillor Dermot Lacey

To ask the manager if she would examine the possibility of providing street signs or directional signs for Elm Park Green as outlined in the email submitted with this question (details supplied).

#### Reply:

I understand that Elm Park Green is a private development and therefore Road Maintenance Services Division would not be in a position to put up a street nameplate.

Road Maintenance Services do not put up directional signs.

#### Q.3 Councillor Paddy Smyth

To ask the manager to re-assign the on street parking outside 26 - 30 Upper Rathmines Road (The Uppercross House Hotel) to allow for a loading bay with enough space available to park a coach overnight in order to facilitate coach tours to the area.

# Reply:

The above request is listed as an appeal for examination and report by the area traffic engineer. The councillor will be informed of the recommendation in due course

# Q.4 <u>Councillor Frank Kennedy</u>

To ask the area manager (a) to install addition "No Cycling" signs stencilled onto the promenade on Sandymount Strand in circumstances where there are a number of points where cyclists can enter the promenade without seeing a no cycling sign, and (b) to arrange for the Parks Department to conduct a review of the extent of impermissible cycling which takes place on the promenade between 8 - 9am and 4.30 - 6pm on weekdays.

#### Reply:

(a) Road Markings are prescribed as per the Department of Transport Traffic Signs Manual; there is no provision for the installation of "No Cycling" road markings. Dublin City Council is currently finalising a Road Safety Strategy with the focus on public awareness education with particular reference to non-cycling on footpaths. The 'RESPECT' campaign is due to roll out in early 2017.

The operator of Coca-Cola Zero dublinbikes has been contacted with regard to the proposal to initiate a public awareness complain with regard to the rules of the road, with particular reference to non-cycling on footpaths. Coca-Cola Zero dublinbikes members will be reminded to always obey the rules of the road and to never cycle on footpaths. This message is already on bike stands and online for members, and will be communicated to members to coincide with commencement of similar safe cycling initiatives by Dublin City Council.

(b) Parks and Landscapes Service will review the issue of cycling at this location in conjunction with the Cycling and Walking promotions Officer.

# Q.5 Councillor Frank Kennedy

Having regard to the serious litter problems at (a) Ringsend Park, Sean Moore Park and the road between the two parks; and (b) Sandymount beach and Irishtown Nature Park all the way to the South Wall, to ask the area manager to put in place the following measures:

- (a) To install more bins at these locations, in particular along the stretch from the walkway into Irishtown Nature Park (which begins at the meeting point of the end of the beach and the entrance to Sean Moore Park) and out to the South Wall where, with the exception of one blast cast iron bin which has been recently installed, there are no bins following an act of vandalism some time ago when bins were burned out; and
- (b) To introduce more scrutiny and imposition of fines for litterers at these locations.

#### Reply:

- (a) Waste Management Services will have a litter bin installed on the nature walk by the end of September 2016.
- (b) The areas mentioned were inspected last week and were all found to be in a relatively clean and litter-free condition. However, these areas will continue to be monitored and the number of public litter bins in the vicinity will also be looked at. Fines of €150 under the Litter Pollution legislation have very recently been issued in this area to some people who failed to clean up after their dogs.

# Q.6 Councillor Frank Kennedy

To ask the Area manager to install more bicycle racks / stands in Sandymount, especially at the location beside the Tesco on Sandymount Road. Bicycle racks / stands in Sandymount at present are insufficient to meet demand.

#### Reply:

The location will assessed for the installation of additional cycle stands in due course based on the existing occupancy levels and the suitability of available footpath capacity to cater for additional stands.

# Q.7 <u>Councillor Frank Kennedy</u>

To ask the area manager why was the lease for 1 Scarlet Row (Temple Bar) granted to an ice cream and waffle restaurant where the competitive tender application was clearly marked no food retailers need apply?

#### Reply:

This commercial retail unit was formally put on the Market in April 2016 by Temple Bar Cultural Trust (TBCT). The original advertisement for this vacant unit is still online and the advertisement does not restrict or state food ventures are prohibited. The advertisement states current planning permission for this unit (1 Scarlet Row) is for retail and retail use. The Temple-Bar project team engaged Owens Commercials, Estate Agents with the assistance of the Chief Valuers office in Dublin City Council and neither of these offices gave an instruction to the agent to restrict any interest in this unit, including food or stating food/café interest should be prohibited.

The successful applicant was aware of the current planning permission (retail) when his proposal for this venture was accepted by the TBCT board. This issue (relevant

planning permission) has been formally captured in the lease between TBCT and the tenant. The tenant has been made responsible for any planning issues/risks and to regularise them with Dublin City Council's planning department. The lease is subject to the tenant getting full planning permission for a change of use for the premises, and to use the premises as an ice cream shop will require permission from the Planning Authority.

The Board of TBCT in making the decision on this tender process was keen to achieve a business which would create increased foot-fall and animation for the area. In making this decision the Board was advised by the Temple Bar Project Team and the City Valuer's Office. Any premature development work at the premises prior to Planning Permission will be subject to enforcement proceedings.

There was one other contender in the final phase of the tendering process.

The other unit mentioned at 1 Pudding Row was previously awarded to an Italian business family following a tender process. The original planning permission was for retail and the tenant formally secured a change of use to operate as a restaurant/Italian cookery school, where there are regular cookery classes during the week and on Saturday mornings. I understand the Italian business family employed a number of Irish contractors to assist them with the fit out of the premises. The investment by the tenant at this previously troublesome corner site has been significant and it has made a big difference in visual terms to the area.

The original developmental guide for this west end part of Temple-Bar includes retail, culture, media, offices and food/café units. The mix includes culture and heritage but is not limited to culture and heritage. Over the last 3 years a number of bespoke operators have surrendered their leases in a number of units in this area which has resulted in a high turnover of new tenants. These lettings reflected the economic reality a number of years ago and the difficulties of operating in the West End for small bespoke businesses.

As such the mix in the area has changed due to these difficulties, as recently presented by a tenant in this area, who vacated a unit in August due to a lack of footfall and difficulty in making the business work from a financial perspective.

# Q.8 Councillor Frank Kennedy

To ask the area manager (a) to provide an update on and (b) to grant the application by [Details supplied].

#### Reply:

A decision was made on 15/9/2016 regarding this applicant's request to be considered under the Exceptional Social Grounds Scheme. No priority was recommended in this case.

The applicant (details supplied) is currently on the Transfer list for two bed accommodation with the following position:

Area B (Coolock /Darndale) Position 211

Unfortunately, Dublin City Council are now allocating properties based on time on the list and currently there are applicants on the Waiting list of longer standing who have to be considered as suitable vacancies arise. It is not possible to indicate accurately the prospect of an offer for any applicant. The number of vacancies arising will be a

determining factor in the length of time applicants could expect to be on the waiting list.

# Q.9 Councillor Frank Kennedy

To ask the area manager whether it would be possible for [details supplied].

#### Reply:

The applicant (details supplied) is on the housing list in Band 2, for a two bedroom unit in Area M. No. 159 for Area M (City Quay, Irishtown, Mount Street, Pearse Street, Ballsbridge, Ringsend, Donnybrook and Georges Quay).

Unfortunately, it is not possible to give an indication of when the applicant may be reached for an offer as No. 159 is not a high position on the list. However, it has been noted on (details supplied) file that she wishes to live away from her current location. In order to expand her areas of choice, the applicant needs to add further areas to her application. She can do so by calling to speak to a Housing Advisor in Housing Allocations or by sending her request in writing to Housing Allocations, Block 2, Civic Offices, Wood Quay, Dublin 8.

# Q.10 Councillor Frank Kennedy

Having regard to the serious problem of litter, dumping and graffiti in South East Docklands Area, especially along the Liffey campshire, and the obvious need for more bins, bottle banks, more frequent and regular bin collections, clearing and sweeping of footpaths and campshire areas, eye-catching posters and surveillance by wardens on foot or on bicycle along the quays (especially at the campshires) followed by consequences for offenders, to ask the Area manager to coordinate an effective and imaginative programme to deal with these issues involving cooperation between Dublin City Council, the OPW, the Gardaí and community institutions such as libraries and schools.

#### Reply:

An Inspection of this area last week showed the areas mentioned to be in a clean and litter free condition and with sufficient public litterbins that are regularly serviced. This area is not suitable for bottle banks. It is proposed to launch a "Think Don't Tag" video on social media in November and this will be rolled out to schools and other relevant areas through various Dublin City Council staff and the Gardaí.

# Q.11 Councillor Frank Kennedy

To ask the area manager to address the problem of aabandoned cars on Oaklands Park and Drive, off Serpentine Avenue, which is becoming a serious issue? Residents have recently counted four such cars which have been parked at this location for at least the last six months. These cars have no up to date tax or insurance and some have neither. There is one car with UK registration which has been at the location for approximately a year.

#### Reply:

The four cars in question were inspected on the 27<sup>th</sup> September 2016.

Car registration no. 1 has current tax disc displayed and so could not be deemed abandoned.

Car registration no. 2 has been inspected and the owner contacted. I am happy that this vehicle is not abandoned.

Car registration no. 3 has been inspected on two previous occasions and the owner contacted. Again I am happy that vehicle is not abandoned.

Car registration no. 4 - the owner has been written to for clarification of status.

# Q.12 Councillor Frank Kennedy

To ask the area manager to arrange for the area surrounding the footbridge over the Dart line between the Merrion Gates and Sydney Parade Avenue (which is the bridge from behind Ailesbury Mews and the OSG office building into Merrion Parish Church) to be cleaned as it is currently very dirty. This question refers in particular to the footpath and surrounding area between the railway line and the OSG building / Ailesbury Mews.

#### Reply:

Waste Management Services had the parts of this location which comes under the remit of Dublin City Council cleaned on the 27<sup>th</sup> September 2016. Contact will be made with Irish Rail to ensure that they clean up their property at this location.

#### Q.13 Councillor Frank Kennedy

To ask the area manager to put in place the following arrangements to address the problem of coaches on Burgh Quay:

- (a) To write to all coach operators who stop at Burgh Quay and request that they instruct their drivers to switch off the engine when stopped to allow passengers to board and disembark in order to reduce noise pollution and vibration of adjacent buildings:
- (b) To require coach operators to provide a waiting area for patrons (as City Link on Crampton Quay provide), or for the Council to build a shelter to prevent passengers from using the entrances and steps of adjacent buildings as a waiting area; and
- (c) To provide a report on what the "additional bus priority measures" for Burgh Quay referred to in the College Green Traffic Management plan entail.

#### Reply:

In response to each item:

- (a) Please see Q84 and its reply from September 2016 meeting:
  - "Tail pipe and sound emissions are an inherent consequence of operating a bus fleet. The buses are licensed to pick up and set down passengers at this location. If they are overstaying in contravention of their license condition, with the subsequent running of their engines, it is a matter for enforcement of the license conditions. To request the turning off of engines while picking up or dropping off passengers might only encourage a longer stay by buses at this location, contrary to their existing permission for the boarding and alighting of passengers only. These issues fall outside the remit of the Air Pollution Act 1987 and the Environmental Protection Act 1992."
- (b) The provision of bus shelters is not within the remit of Dublin City Council. Dublin City Council has the role of assessing planning applications for the provision of bus shelter when submitted.
- (c) In relation to our proposal to introduce additional bus priority measures on Burgh Quay, as referred to in our 'College Green Traffic Management Measures', no detail has been concluded. Any proposal which may be developed will be subject to public consultation as part of the overall project.

# Q.14 Councillor Paddy McCartan

To ask the manager to have area around Kerlogue Road, Ringsend cleared of weeds and growth, see photo attached.

#### Reply:

The second round of weed-spraying throughout the South East Area commenced at the end of September. Kerlogue Road, Ringsend is included in the spraying schedule.

# Q.15 Councillor Paddy McCartan

To ask the manager to have the road at the entrance to Mount Sandford, Milltown Road resurfaced. This section of the road is under the remit of Dublin City Council and has become very uneven with potholes.

# Reply:

This area of carriageway is not in charge. The area which is in charge runs along the line of the boundary wall. It does not include the road entrance to the private gates.

This area appears to be private and as such does not come under the city council's remit. However, further enquiries are being made to establish the ownership.

# Q.16 Councillor Paddy McCartan

- a) To ask the manager to arrange with Dublin Bus to have a Real Time sign erected outward bound at Pearse Street, Stop number 351, Opposite Pearse Street Library.
- (b) To ask the manager to arrange with Dublin Bus to have a Real Time sign erected outward bound at Ringsend, stop number 356, adjacent to the charity shop.

#### Reply:

The provision of Real Time Information signs is a function of the National Transport Authority (NTA). This question has been referred to the NTA for consideration and a report will issue to the Councillor when a reply is received

# Q.17 Councillor Paddy McCartan

To ask the manager to have the area around the Seaman's Monument cleared and cleaned. It is located on the green area at the entrance to the Seán Moore Road, Ringsend.

#### Reply:

This area has been added to the works programme and will be attended to over the coming weeks.

# Q.18 Councillor Paddy McCartan

To ask the manager to undertake meaningful temporary repairs at Chatham Street, Dublin 2, adjacent to Neary's Pub. This area has been in a dreadful state of repair for the last two years. Businesses in the area are aware of the planned upgrading of this area, but in the interim, temporary measures need to be implemented.

#### Reply:

Road Maintenance inspected Chatham Street and carried out temporary repairs by removing loose bricks and replacing them with tarmac. More permanent repairs will be carried out when a crew becomes available.

# Q.19 Councillor Paddy McCartan

To ask the manager what is being done with the reports of rat infestation on Sandymount Strand, and has poison been laid recently to eradicate the vermin.

#### Reply:

There is a natural rat population who live along the shoreline and which scavenge on food and material washed in with the tides and shelter in the rocks in this area. Parks and Landscape Service will continue to monitor the situation in conjunction with the Public Domain Officer with the intention of laying bait where the population becomes excessive.

# Q.20 Councillor Paddy McCartan

The pathway leading up to the Sea Scouts, Pigeon House Road is unusable due to overgrowth. Could the manager arrange to have the pathway cleaned and brought back into use? See photo attached.

#### Reply:

This pathway will be cleared of all overgrowth and brought back to condition suitable for use.

# Q.21 Councillor Paddy McCartan

To ask the manager to deal with the issue of uneven and broken paving stones outside the Radisson Hotel and the Argentinian restaurant on Golden Lane, Dublin 8.

#### Reply:

These repairs will be put on Road Maintenance Services works list to be carried out when a crew is available in this area.

# Q.22 Councillor Paddy McCartan

To ask the manager to deal with the following issue: A lime tree in front of 14 and 16 Irishtown Road needs to be trimmed and cut back. There are cracks in the path at the base of the tree. Residents do not want the tree removed, but they do not want to be overshadowed either. Photo attached.

#### Reply:

This work has been included in our works programme and will be undertaken over the coming four to six weeks.

# Q.23 Councillor Paddy McCartan

To ask the manager to have the following four abandoned cars on Oaklands, off Serpentine Avenue, Sandymount removed. See pictures in email to follow.

#### Reply:

The four cars in question were inspected on the 27<sup>th</sup> September 2016.

Car registration no. 1 has current tax disc displayed and so could not be deemed abandoned.

Car registration no. 2 has been inspected and the owner contacted. I am happy that this vehicle is not abandoned.

Car registration no. 3 has been inspected on two previous occasions and the owner contacted. Again I am happy that vehicle is not abandoned.

Car registration no. 4 - the owner has been written to for clarification of status.

#### Q.24 Councillor Paddy McCartan

To ask the manager to arrange to have a row of planes trees trimmed at Cambridge Square, Ringsend. Currently, due to their height and density, they are overlooking and shading the apartments at the Cambridge Court residential complex.

#### Reply:

The trees at this location have been included in our works programme for the area and will be pruned over the coming four to six weeks.

# Q.25 Councillor Claire O'Connor

Are there plans for a Local Area Plan for Harold's Cross?

# Reply:

The Dublin City Development Plan was adopted at a Special Council meeting on the 23<sup>rd</sup> of September 2016. The plan will come into effect on the 21<sup>st</sup> October 2016.

Harold's Cross has been added to Table F which sets out the proposed Statutory Local Area Plan (LAP) / Strategic Development Zones to deliver the core strategy. The ordering of the delivery of such LAPs to be determined by city councillors.

# Q.26 Councillor Claire O'Connor

To ask the city manager whether double yellow lines can be installed on both sides of the laneway behind the houses at 11 - 29 Ormond Road. Such lines are needed as a fire engine was not able to get down the laneway in order to extinguish a fire during the summer.

#### Reply:

The request for double yellow lines on the laneway behind house numbers 11 - 29 Ormond Road has been referred to the Traffic Advisory Group for examination and report. The councillor will be informed of the recommendation in due course.

#### Q.27 Councillor Claire O'Connor

Can the manager arrange for the graffiti to be removed from Larkfield Gardens?

#### Reply:

No graffiti was visible in the vicinity of \*details supplied as per an inspection of the area carried out on Wednesday 5<sup>th</sup> October 2016.

#### Q.28 Councillor Claire O'Connor

Can the footpath outside 65 Lavarna Grove be repaired?

#### Reply:

Road Maintenance inspected the footpath outside 65 Lavarna Grove. This section of footpath has been added to our works programme. These works will be carried out when a crew becomes available.

# Q.29 Councillor Claire O'Connor

Can the trees on Edenvale Road be replaced?

#### Reply:

The pavements in Edenvale Avenue are very narrow and replacement planting would require the excavation of the footpath. This would be costly and will be considered in the context of future works programmes. There will be no provision for this however in 2017.

#### Q.30 Councillor Claire O'Connor

Can the manager explain and set out the objective criteria behind why certain residents on Casimir Road are given dual parking permits to park on adjoining streets?

#### Reply:

It is the policy of the council to include an additional road on a Resident Parking Permit, upon request from a resident, where the applicant resides in a dwelling adjoining the additional road being sought.

Other than residents whose dwelling satisfies the above requirement, the inclusion of an additional road on any Resident Parking Permit is considered strictly on a case by case basis, and will only be considered where the council is satisfied that there is very high demand on the road on which the applicant resides and that there is sufficient spare capacity remaining on the road being sought to cater for the additional demand for parking.

There are 90 Pay and Display and Permit Parking spaces on Casimir Road and currently 89 Resident Parking Permits issued to residents of the road. Of these, 15 have been issued with a permit that also includes an additional road, 5 with Casimir Avenue, 9 with Sion Hill Avenue and 1 with Wilfrid Road.

### Q.31 Councillor Claire O'Connor

Can the ramp outside Number 6 Larkfield Gardens be replaced?

#### Reply:

Road Maintenance inspected the ramp at 6 Larkfield Gardens and found it to be serviceable. No works are programmed for this ramp.

#### Q.32 Councillor Claire O'Connor

Can the manager arrange for the light outside Number 42 Gulistan Road to be repaired?

#### Reply:

The light on pole no. 6 located here was repaired 06/10/16.

# Q.33 Councillor Claire O'Connor

Can the manager arrange for more street lighting to be installed on Mountain View Road to facilitate visitors to the community centre?

# Reply:

An additional light standard was installed here and all of the lighting was upgraded as part of our 2011 programme of improvement works. We have no plans to install any further lighting here but will arrange for the lamps to be replaced and lanterns cleaned to improve the overall light output.

#### Q.34 Councillor Claire O'Connor

Can the drains outside 6 Derravaragh Road be unblocked?

#### Reply:

The blocked shore at this location has been cleared.

# Q.35 Councillor Claire O'Connor

Can the manager put double yellow lines on the corners of Mount Argus Close in circumstances where there is poor visibility caused by parked cars?

#### Reply:

The request for double yellow lines on the corners of Mount Argos Close has been referred to the Traffic Advisory Group for examination and report. The councillor will be informed of the recommendation in due course.

# Q.36 Councillor Chris Andrews

Can the manager have the dampness on the exterior and interior of \*details supplied. On the outside wall the dampness can clearly be seen running down the wall and at this stage it is leading to moss growing at this point.

#### Reply:

Clarification has been sought from the councillor. The matter will be investigated on receipt of the clarification sought.

#### Q.37 Councillor Chris Andrews

Can the manager have gates installed to the rear of 4 - 5 - 6 - 7 Leukos Road as there is serious antisocial behaviour taking place as can be seen in photo attached?

#### Reply:

No photo was attached with the councillor's question. The area was inspected on 5/10/2016 there was no evidence of anti social behaviour. There were a number of paving stones apparently being stored in the laneway which allegedly belong to one of the households with access to the laneway. The rear gate of one the houses is also in a poor state of repair. There is no record in the area office or knowledge of any complaints of anti social behaviour in this laneway. The housing section does not propose to erect a gate to this narrow area of land which is a part of a larger laneway however there would be no objection if residents decided by consensus with the relevant households to erect a gate at the location at their own expense.

Efforts are being made to have the paving stones removed and the gate in question repaired.

#### Q.38 Councillor Chris Andrews

Can the manager have the tree stump outside \*details supplied removed and the pavement repaired as there is now a large stump after a tree was removed and it is a serious trip hazard

#### Reply:

The removal of the tree stump at this location has been added to our works programme and it is proposed to have it removed over the coming weeks.

These repairs will be put on Road Maintenance Services works list to be carried out when a crew is available in this area.

# Q.39 Councillor Chris Andrews

Can the manager have gates installed in lane to the rear of \*details supplied as there is considerable local dumping and anti social behaviour taking place

#### Reply:

The laneway was inspected on 5/10/16. There was no evidence of anti social behaviour or illegal dumping. However, the office is aware of issues in the past with illegal dumping in this area.

The laneway in question is accessed from three pathways which provide access to approximately thirteen houses, a number of which are in private ownership. A raised

grass area runs along the boundary of the wall of the laneway which makes it accessible at almost any point along this boundary wall. A gate or even three gates at each access point is not recommended, as the entire length of the laneway would remain accessible from the raised grassed area. It should be noted that if households wish to continue to pursue the closure of the laneway they may have to do so formally in accordance with the procedures laid out in Section 73 of the Roads Act 1993.

#### Q.40 Councillor Chris Andrews

There was a fire in a house on Arnott Street last night - 25th Sept. The fire engines had difficulty passing the parked cars. Have the parking arrangements on this street been reviewed by Dublin Fire Brigade? The engines did eventually manage to clear the cars on the corner, but if they had not the consequences should be obvious.

# Reply:

The existing parking arrangements on Arnott Street are in accordance with the current Dublin City Council requirements. A minimum width of 6.5m is necessary to accommodate double sided parking and 4.6m for single sided parking. The South end of Arnott Street has an average width of 7m and has double sided parking arrangements. The North end of Arnott Street has an average width of 5.9m and has single sided parking on the Western side and double yellow lines on the East. There are parking restrictions in the form of double yellow lines around the corner of Arnott Street.

Parking issues when identified by Dublin Fire Brigade are referred to the Roads and Traffic Department. Illegal parking can delay Fire Brigade response. In an emergency if access is required by the Fire Brigade and is blocked by parked vehicles the offending vehicles will be moved by whatever means is necessary by the responding Fire Brigade Units.

#### Q.41 Councillor Chris Andrews

The junction of Harrington Street, South Circular Road, Heytesbury Street and Stamer Street is dangerous. Several incidents have occurred here recently to our knowledge - a cyclist was knocked off his bike by a car breaking the lights at this junction. It is not unusual to have to jump out of the way of cars breaking the pedestrian lights, and a child was knocked off his bike and run over on the way to school in the last couple of weeks. Cars (and bikes and pedestrians) regularly ignore the lights and yellow box at this junction. I would like to ask for more enforcement from the Gardaí, and also an upgrade of the junction. It has a pedestrian crossing at only two sides and this should be upgraded to all four sides?

#### Reply:

The matter regarding dangerous driver behaviour will be referred to the Gardaí at the next Traffic Advisory Group meeting. The junction will be assessed and considered for its suitability to incorporate a full wrap around pedestrian phase.

The request to upgrade the pedestrian crossing at the above junction has been referred to the Traffic Advisory Group for examination and report. The councillor will be informed of the recommendation in due course.

# Q.42 Councillor Claire Byrne

To ask the area manager to please bring a report to the October meeting of the Committee with details including mapping show all sites within the Pembroke South Dock Area that are proposed for inclusion on the Vacant Sites Register under the

Urban Regeneration and Housing Act 2015 and that may be subject to a 3% annual levy on their value.

#### Reply:

Under the new Urban Regeneration and Housing Act the council has a requirement to produce a Vacant Site Register. A report on the preparation and production of this register was brought to the SPC meeting for discussion and was agreed.

The Urban Regeneration and Housing Act makes provision for a vacant sites levy in areas in which housing is required and in areas in need of renewal. The draft Dublin City Council Development Plan clearly defines these areas within the Council's functional area. Each Planning Authority is to establish and maintain a vacant sites register from 1<sup>st</sup> January 2017 as the owner is to be notified before 1<sup>st</sup> June 2017 that their site is on the register and the levy is payable in arrears. Each site must be surveyed, mapped and its market value and ownership ascertained. The Act outlines the procedure for sites on the register, appropriate notices, market value, appeals, the amount of the levy etc.

As part of this programme the survey for the inner city area is nearing completion. The Active Land Management team is systematically progressing though the rest of the city to create a complete register of vacant sites within the functional area of Dublin City Council.

# Q.43 Councillor Claire Byrne

To ask the area manager to examine what options might be available to improve safety for pedestrians, cyclists and motorists at the junction of Harrington Street, South Circular Road, Heytesbury Street and Stamer Street as several incidents have occurred here recently. Perhaps extending the pedestrian crossing to all four sides might be a solution.

#### Reply:

The matter regarding dangerous driver behaviour will be referred to the Gardaí at the next Traffic Advisory Group meeting. The junction will be assessed and considered for its suitability to incorporate a full wrap around pedestrian phase.

#### Q.44 Councillor Claire Byrne

To ask the area manager what can be done to ensure that Emergency Services have sufficient access to the houses in Arnott Street, Portobello and whether the street has been reviewed by Dublin Fire Brigade recently as the cars parked on street proved to be an obstruction when fire services where trying to attend a fire on the street last month.

#### Reply:

The existing parking arrangements on Arnott Street are in accordance with the current Dublin City Council requirements. A minimum width of 6.5m is necessary to accommodate double sided parking and 4.6m for single sided parking. The South end of Arnott Street has an average width of 7m and has double sided parking arrangements. The North end of Arnott Street has an average width of 5.9m and has single sided parking on the Western side and double yellow lines on the East. There are parking restrictions in the form of double yellow lines around the corner of Arnott Street.

Parking issues when identified by Dublin Fire Brigade are referred to the Roads and Traffic Department. Illegal parking can delay Fire Brigade response. In an emergency if access is required by the Fire Brigade and is blocked by parked vehicles the

offending vehicles will be moved by whatever means is necessary by the responding Fire Brigade Units.

# Q.45 Councillor Claire Byrne

To ask the area manager to please clean the gullies on Gordon Street as a matter of urgency and if she could also carry out an inspection and analysis of all the shores in the area as the streets are at high risk of flooding.

#### Reply:

14 of the 15 gullies on Gordon Street were cleared on 30/9/16.

# Q.46 Councillor Claire Byrne

To ask the area manager what is the purpose of the bollards on Grafton Street, if there are plans to repaint them in the near future as the paint is chipping off despite only being in place for just over a year, and if not would the Manager consider removing them altogether.

# Reply:

The South East Area Office will liaise with the Road Maintenance Services Division regarding repainting the bollards in the 2017 works programme.

# Q.47 Councillor Claire Byrne

To ask the area manager whether \*details supplied may be eligible for a rates exemption as they are they have not for profit status and are a registered charity.

#### Reply:

Details supplied is subject to commercial rates. Commercial rates are based on the valuation of the relevant property determined by the Valuation Office which is an independent statutory body. Dublin City Council has no function in the determination of valuations.

The matter should be referred to the Valuation Office to determine if it is eligible for exemption.

# Q.48 Councillor Claire Byrne

To ask the area manager whether the replacement planting in Merrion Square has been completed, if not how many trees have yet to be planted and when that planting will be completed.

#### Reply:

85 trees were planted this year and there will be further planting next year.

The improvement to the park will continue for at least two more years and the planting of natural, naturalised, and ornamental trees will continue subject to available funding.

#### Q.49 Councillor Claire Byrne

To ask the area manager why there are no public recycling facilities in the city centre and if she could please consider re - installing bottle banks in the city centre.

#### Reply:

The issue of bottle banks in the city centre is one that we are currently examining. However finding an appropriate location in the city centre is a challenge. Any bottle bank site has to fit three criteria:

- 1. Access for a truck to remove full containers.
- 2. Ensuring no overhead electrical wires are present.
- 3. There is a minimum 50 meter distance rule from residential property, save with the consent in writing of the owner or occupier.

We would be delighted to examine any suggested locations for suitability, in the meantime please be advised that we have centrally located bottle banks at the following locations:

- North Strand Civic Amenity Site, Shamrock Terrace, Dublin 1.
- Parkgate Street, Dublin 7.
- Smithfield, St. Mary's Car Park, Michen Street (beside the fruit market), Dublin 7.
- Civic Offices, Winetavern Street, Dublin 8.

# Q.50 Councillor Claire Byrne

To ask the area manager if she would consider removing some of the parking spaces on Pembroke Street Upper from Fitzwilliam Square South to Leeson Street Lower and to replace them with a cycle lane in order improve safety conditions for cyclists along this stretch of road.

#### Reply:

Pembroke Street Upper is not included on the National Transport Authority's (NTA's) Greater Dublin Cycle Network Plan. The Cycle Network Plan includes the cycle schemes which Dublin City Council is dealing with at present. It is understood that the NTA will be conducting a feasibility study on a proposed Cycleway, located onstreet inside parked vehicles ('parking protected' cycleway), from Fitzwilliam Place to Holles Street. In light of the above, there are no proposals to remove parking along Pembroke Street Upper.

# Q.51 Councillor Kieran Binchy

To ask the manager to address the issue of abandoned cars on Oaklands, off Serpentine Avenue, Dublin 4 as per details attached in email to be forwarded separately.

#### Reply:

The four cars in question were inspected on the 27<sup>th</sup> September 2016.

Car registration no. 1 has current tax disc displayed and so could not be deemed abandoned.

Car registration no. 2 has been inspected and the owner contacted. I am happy that this vehicle is not abandoned.

Car registration no. 3 has been inspected on two previous occasions and the owner contacted. Again I am happy that vehicle is not abandoned.

Car registration no. 4 - the owner has been written to for clarification of status.

#### Q.52 Councillor Kieran Binchy

To ask the manager to address the following lighting issues \*details supplied.

#### Reply:

The lighting on details supplied was out due to the loss of electrical supply. The power has since been restored to five of the seven light standards here. A night

inspection of the lighting along Sir John Rogerson's Quay is scheduled on 06/10/16. Any faults recorded will be repaired as soon as possible.

# Q.53 Councillor Kieran Binchy

To ask the manager to pro-actively tackle the litter problem in the following areas \*details supplied.

#### Reply:

Waste Management Services will ensure that the roads and footpaths in the above mentioned areas are kept as clean as possible.

The areas mentioned were inspected last week and were all found to be in a relatively clean and litter-free condition. However, these areas will continue to be monitored and the number of public litter bins in the vicinity will also be looked at. Fines of €150 under the Litter Pollution legislation have very recently been issued in this area to some people who failed to clean up after their dogs.

The above mentioned Parks are cleaned regularly and litter removed from site. I will arrange to have them monitored.

# Q.54 Councillor Kieran Binchy

To ask the manager to investigate the following issue, and to provide a full report on same:

#### Reply:

This commercial retail unit was formally put on the market in April 2016 by Temple Bar Cultural Trust (TBCT). The original advertisement for this vacant unit is still online and the advertisement does not restrict or state food ventures are prohibited. The advertisement states current planning permission for this unit (1 Scarlet Row) is for retail and retail use. The Temple-Bar project team engaged Owens Commercials, Estate Agents with the assistance of the Chief Valuer's Office in Dublin City Council and neither of these offices gave an instruction to the agent to restrict any interest in this unit, including food or stating food/café interest should be prohibited.

The successful applicant was aware of the current planning permission (retail) when his proposal for this venture was accepted by the TBCT board. This issue (relevant planning permission) has been formally captured in the lease between TBCT and the tenant. The tenant has been made responsible for any planning issues/risks and to regularise them with Dublin City Council's planning department. The lease is subject to the tenant getting full planning permission for a change of use for the premises, and to use the premises as an ice cream shop will require permission from the Planning Authority.

The Board of TBCT in making the decision on this tender process was keen to achieve a business which would create increased foot-fall and animation for the area. In making this decision the Board was advised by the Temple Bar Project Team and the City Valuer's Office. Any premature development work at the premises prior to Planning Permission will be subject to enforcement proceedings.

There was one other contender in the final phase of the tendering process.

The other unit mentioned at 1 Pudding Row was previously awarded to an Italian business family following a tender process. The original planning permission was for retail and the tenant formally secured a change of use to operate as a restaurant/Italian cookery school, where there are regular cookery classes during the

week and on Saturday mornings. I understand the Italian business family employed a number of Irish contractors to assist them with the fit out of the premises. The investment by the tenant at this previously troublesome corner site has been significant and it has made a big difference in visual terms to the area.

The original developmental guide for this west end part of Temple-Bar includes retail, culture, media, offices and food/café units. The mix includes culture and heritage but is not limited to culture and heritage. Over the last 3 years a number of bespoke operators have surrendered their leases in a number of units in this area which has resulted in a high turnover of new tenants. These lettings reflected the economic reality a number of years ago and the difficulties of operating in the West End for small bespoke businesses.

As such the mix in the area has changed due to these difficulties, as recently presented by a tenant in this area, who vacated a unit in August due to a lack of footfall and difficulty in making the business work from a financial perspective.

# Q.55 Councillor Kieran Binchy

To ask the manager for an update on the provision of a disabled parking space on Cambridge Avenue, Ringsend.

#### Reply:

The criteria for the provision of a disabled parking bay outside a private residence on Cambridge Avenue was forwarded to the resident on 29<sup>th</sup> June, 2016. No further correspondence has been received to date by the City Council in relation to this matter.

# Q.56 Councillor Kieran Binchy

To ask the manager to address the issue of fruit falling from the trees on Carlisle Street and Emorville in Portobello, in the short term by ensuring adequate street cleaning, and in the long term by replacing the trees with the agreement of the residents.

#### Reply:

Waste Management Services Division operates a leaves and fruit removal programme during the autumn and winter months. Priority is given to tree-lined streets with heavy pedestrian use and areas particularly prone to flooding. We will ensure that the above mentioned streets are included as often as possible during the course of this programme.

These trees are a particularly heavy cropping variety of pear tree (*Pyrus* sps.) and I am willing to arrange for their removal and replacement with a more appropriate species subject to receipt of written consent from the local residents association and / or a petition for their removal from residents on the streets.

# Q.57 Councillor Chris Andrews

To ask the area manager to ensure that the shower that has been sanctioned is put into \*details supplied as a matter of urgency given the very bad health of the tenant.

#### Reply:

The provision of a shower under our Scheme for persons with Disabilities was approved for this tenant in July 2016. These works, together with approximately 30 other similar works are currently being tendered for.

When the tenders have been examined and accepted, a contractor will be selected to carry out all the shower adaptations on the tender.

It is not possible to give a date of commencement until a contractor has been appointed, however this work is scheduled to be carried out relatively soon.

Also Loading / unloading is permitted directly opposite on the Advisory cycle lane for a maximum 30 mins.	It is not recommended to introduce parking restrictions where restrictions are already covered under the law, such as placing Double Yellow Lines across entrances, as this would lead to a proliferation of same and additional expense due to maintenance. Section 5 (e) of the Road Traffic Act states " a prohibition on the parking of a vehicle imposed by article 36(2)(a) shall not apply to a vehicle parked while goods are being loaded in or on to it or unloaded from it, for a period not exceeding thirty minutes from the commencement of the parking. Therefore installing double yellow lines would allow for an exemption to vehicles loading / unloading and would be in conflict with the existing solid white line directly opposite.  There are already parking restrictions in place outside no. 27 Beach Road which are enforceable under the law. 


## **SITE LOCATION & LAYOUT**

Dublin City Council wishes to give notice that it intends to initiate the process leading to an application under Part 8 of the Local Government Planning & Development Regulations 2001 as amended for the refurbishment of Peace Garden, Christchurch Place, Dublin 8.

The Peace Garden proposal is based on the development of the public realm along the Dubline tourist trail. This route incorporates many of the defining historic and cultural heritage attractions of the capital.

The objective of the proposal is to improve the heritage and amenity value of Peace Garden for the city. It is acknowledged that it is situated in a most historic and culturally important area which forms links between different, bustling parts of the city and this is to be balanced with creating a pocket park / sanctuary.

In 2016 Dublin City Council commenced drafting a design for the refurbishment of Peace Garden. The proposed layout seeks to balance the needs of all stakeholders and rejuvenate the park. It is envisaged that the rejuvenation of the park will act as a catalyst for further improvements in the surrounding city environment.





The agreement of the South East Area Committee for the initiation of the Part 8 process is requested. The approval of a Part 8 is a reserved function of the city council.

With reference to the proposed disposal of a site at 43 Aungier Street and 1 Digges Street Upper, Dublin 2.

Following public advertisement for the disposal of 43 Aungier Street (protected structure) and 1 Digges Street Upper, six offers were received. All offers were considered by an assessment panel and Rustic Way Ltd. (Pressup / Oakmount Group) was recommended as the preferred bidder.

It is now proposed to dispose of 43 Aungier Street and 1 Digges Street, as shown outlined in red and coloured pink on Map Index No. SM-2016-0330-001, to the applicant Rustic Way Ltd., subject to the following terms and conditions, as recommended by the Chief Valuer:

- 1. That the consideration shall be in the sum of €831,000 (eight hundred and thirty one thousand euro) plus VAT, in full and final settlement, payable as follows:
  - a. 20% deposit on signing of contracts, which must be within six weeks of council approval
  - b. A further 70% payable when going on site to commence building works
  - c. The 10% balance on transfer of title to the applicant

Interest at the rate of 12% per annum shall apply to outstanding amounts which have not been paid as they have fallen due.

- 2. That the property is as shown outlined in red and shaded pink on the attached map index no.SM-2016-0330-001.
- 3. That the applicant must lodge a planning application (for the entire refurbishment proposal as outlined and attached to the applicant's offer letter) within two months of signing of contracts. If this does not occur the council, at its absolute discretion, may decide to rescind this agreement.
- 4. That the applicant shall be allowed one opportunity to submit a planning application to Dublin City Council and, if necessary, an appeal to An Bord Pleanála. In the event that a satisfactory planning permission is not achieved or planning is refused at this stage, then the full deposit paid by the applicant will be returned (without payment of interest).
- 5. That if planning permission for the refurbishment is either refused (by Dublin City Council or An Bord Pleanála), or granted subject to onerous conditions, then the applicant may rescind the agreement within four weeks of the refusal or final grant of planning permission without penalty or compensation due to Dublin City Council. All planning application related costs to be borne by the applicant.
- 6. That the applicant must commence work on site under licence from the city council within three months of the date of final grant of planning permission and must complete the refurbishment programme under one building contract within twelve months from the date of final grant of permission.

- 7. That the applicant, Rustic Way Ltd., a newly incorporated company, shall be guaranteed by the Press Up and Oakmount Group.
- 8. That all site investigations (including archaeological investigations), ground works, services connections, planning fees, development and associated professional costs incurred in the delivery of the completed development on the site shall be borne by the applicant.
- 9. That the vaulted area beneath the pavement does not form part of this disposal. The applicant shall be required to construct a retaining wall (to be designed by a Structural Engineer) along the building line below ground in the cellar of 43 Aungier Street / Digges Street Upper. Any services such as drainage access chambers should be relocated if access is to be required into the future. The cellar should be filled in with CI.808 compacted in layers in accordance with CI.802. The new footpath is to be constructed with concrete paving slabs and all historic granite and coal hole covers and surrounds are to be retained. All works are to be carried out in accordance with Dublin City Council's standards booklet: 'Construction Standards for Roads and Street Works'. On completion, the finished surface should be offered to Dublin City Council Road Maintenance Services to be taken in charge.
- 10. That the applicant's conservation architect shall liaise with Dublin City Council Architects in respect to all aspects of the refurbishment.
- 11. That in the event of the applicant failing to commence and / or complete the building works within the specified periods in accordance with condition No. 6, the council shall be entitled to re-take possession of the property, together with any building or structures erected thereon.
- 12. That the applicant shall ensure that all necessary safety precautions are taken in accordance with Health & Safety Regulations and all other statutory requirements.
- 13. That during the building period, the applicant will insure the buildings against fire and all other insurable risks with an approved insurance company and pay all necessary premiums or in the event of the applicants bankruptcy or insolvency save in the case of a financial institution which has entered into a mortgage with the applicant for the purposes of financing the refurbishment of the property.
- 14. That the insurance shall be in the joint names of the applicant and the city council and will be for such an amount as will provide cover for full reinstatement value of so much of the building as is erected at any time together with a sum for professional fees and removal of debris charges. The applicant's financial institution may be a mentioned party on this insurance policy.
- 15. That this agreement is non-assignable or transferable to any other party, save in the case of a financial institution which has entered into a mortgage with the applicant for the purposes of financing the refurbishment of the property, which mortgage must be approved by the city council in writing and must have been entered into specifically for the purpose of financing the applicant to undertake the refurbishment of the property.
- 16. That the applicant and his design team shall also indemnify the city council against any claim for compensation which may be made by any party arising


out of building works being carried out at the property, or any working areas or on any access points thereto.

- 17. That the applicant shall be responsible for fully insuring the premises during the building works, pending transfer of title and shall indemnify Dublin City Council against any and all claims arising from the refurbishment of the said premises. The applicant shall take out and produce public liability insurance in the sum of €6.5 million and employer's liability insurance in the sum of €13m for any incident with a recognised insurance company with offices in the state and the policy shall indemnify Dublin City Council against all liability as part owner of the property.
- 18. That the applicant shall be responsible for any stamp duty and VAT liability arising from this transaction.
- 19. That the freehold title or equivalent to the subject property shall be transferred on full completion of the approved development, as certified by the City Architect.
- 20. That any of the dates / time frames outlined above may be extended by the Chief Executive at his absolute discretion and all notices must be given in writing.
- 21. That the above proposal is subject to the necessary approvals and consents being obtained.
- 22. Please note that no agreement enforceable at law is created or intended to be created until exchange of contracts has taken place.

The dates for the performances of any of the requirements of the proposed agreement may be amended at the absolute discretion of the Assistant Chief Executive.

That the agreement shall be subject to any other such terms and conditions as deemed appropriate by Dublin City Council's Law Agent.

## **Environmental Services Unit Report**

#### **Leaf Collection**

In residential areas many residents groups, associations and individuals are now involved in helping to manage their own areas by carrying out leaf clearing initiatives. The South East Area is providing bags and equipment to these groups and arranging for the removal of the collected bagged leaves free of charge.

#### Halloween

Bonfire material was collected in the South East Area up to as late as possible on Monday 31<sup>st</sup> October. This operation was in conjunction with other Dublin City Council departments and would not have been possible without the assistance of the Gardaí. Safety campaigns were promoted through DCC Fire Brigade Services and DCC Media Relations and also by the Gardaí.

#### **Weed Control 2016**

Weed Spraying throughout the South East Area is now complete.

#### **Dog Fouling Enforcement / Awareness Campaign**

This current campaign throughout the South East Area began in May and will end shortly. It was found at times of patrol that the vast majority of dog walkers in our area were compliant. It is expected that additional bins, specifically for dog dirt, will be installed within a short period of time.

#### **Enforcement**

- 1. Authorised staff supported by An Garda Síochána patrolled public areas, mainly parks, to observe the behaviour of dog walkers. Fines of €150 were issued to dog owners who failed to clean up after their dog. Eight Fines have been issued so far under Section 22 of the Litter Pollution Act 1997 and at least two of these are likely to lead to prosecution due to non-payment. Dog walkers were observed and monitored in the following parks and surrounding areas: Pearse Square, Belgrave Square and Dartmouth Square, Ringsend, Sean Moore, Herbert, Dartry, Orwell, Herzog, Palmerston, Bushy, Harold's Cross, Mount Argus, Eamonn Ceannt, and St. Patrick's parks, Ranelagh Gardens, Irishtown Nature Park, Sandymount Strand and also along the Dodder Walkway and the Grand Canal. Patrols were carried out mainly at weekends, but also some early mornings and evening times were included.
- 2. Dog wardens also patrolled some of our parks over the last few months. They requested dog walkers to produce evidence of poop bags. In addition, sixty 10 day

notices were issued by them to dog walkers in respect of the following: (1) dogs not on a leash in specified areas at specified times, (2) un-muzzled restricted breeds and (3) failure to produce a valid dog licence.

## **Awareness**

- 1. International rugby player Jamie Heaslip was engaged to produce a short video for social media encouraging dog walkers to clean up after their dog. A poster campaign is currently taking place with the same message featuring Jamie with his dog. - Authorised staff while on patrol spoke to numerous dog walkers about their responsibilities and also rewarded some of the many who were compliant with small gifts.

#### **Housing Projects and Local Area Improvements**

## **Southern Campshires Flood Protection Scheme**

The contractor moved on site on 23rd October 2014. The works are being carried out by the Office of Public Works (OPW) and various sub-contractors and supervised by various consultants for different aspects of these works. A number of ground condition problems have slowed this project down to date. The estimated cost of this whole project from Butt Bridge to Cardiff Lane is €3.5m and the current programme is to substantially complete the works by end of 2016.

#### **Grand Canal Sub Group**

The latest meeting of the Grand Canal Sub-committee was held on 5<sup>th</sup> October 2016. Ms. Terre Duffy has been appointed by Waterways Ireland as Dublin Docklands Development Manager and will attend the next meeting. Clean-ups have been arranged in Grand Canal Dock. The next meeting of the Grand Canal Sub-committee will be held on 9<sup>th</sup> November 2016.

#### Rathgar Village Improvement Plan (VIP)

The finalised Rathgar Village Improvement Plan (VIP) was approved at the January 2015 South East Area Committee. New lamp standards have been installed. New pedestrian crossing will be in place in 2016. REDscape, Landscape Architects, were appointed to design a plan for Herzog Park. The Draft Landscape Master plan was open to informal public comment until Friday 8th April 2016. 27 submissions were received. Pre Part 8 went before the SEAC on11th July and Part 8 Planning Application was advertised on 21<sup>st</sup> September 2016. The final day for making submissions or observations is 17<sup>th</sup> November 2016.

#### Ranelagh Gardens Park

The Part 8 was approved at the City Council meeting on Monday 6th July 2015. The tender for the playground has now been awarded and works are due to commence in December 2016.

## Ringsend Irishtown Local Environment Improvement Plan (LEIP)

Consultation commenced in January 2016, beginning with meetings with local business groups and others, followed by an open morning in Ringsend Library on Thursday 28<sup>th</sup> January 2016. Following tender process, Mitchell and Associates were appointed to deliver the Local Environment Improvement Plan in March 2016. Initial internal consultations with relevant Dublin City Council departments and Mitchell and Associates took place during March and April 2016. A draft presentation of the plan was presented at a public workshop in Ringsend Irishtown Community Centre on the 8<sup>th</sup> June 2016 to further canvass the views of local residents, businesses, community groups and other stakeholders. Proposals have been refined by Mitchell and Associates based on comments received at the workshop and subsequently, and a further workshop will be held on 30<sup>th</sup> November 2016 to present a revised draft plan and take further comments. It is proposed to submit a draft Local

Environment Improvement Plan to the South East Area Committee for adoption in early 2017.

## Terenure 2030

In 2016 6 no. new lamp standards were provided in the village along with cycle parking and new litter bins. Village greening projects were ongoing in 2016 as part of Vibrant Villages.

#### **Crampton Buildings**

The lettings are practically complete. A number of outstanding snagging issues are being remedied.

## **Charlemont Street**

This project is on target for completion in December 2018. Dublin City Council continues to operate the Project Office at 40 Tom Kelly. The Regeneration Board in conjunction with the city council issue a bi-monthly newsletter. The Project Office issue regular communications to the residents regarding works on site. The first of a number of information events for residents was held on the 19<sup>th</sup> of November, it was well attended and the information was well received.

#### Moss Street / Gloucester Street

Co-operative Housing Ireland received preliminary approval under the 2015 Capital Assistance Scheme (CAS) Programme to carry out a feasibility study on the Gloucester Street / Moss Street site. However, the adjoining landowner has approached Dublin City Council with a view to developing both sites which would yield approximately 20 social housing units. Discussions are ongoing and councillors will be informed in the monthly Housing Report to the council meeting.

#### **Luke Street**

Preliminary discussions are ongoing regarding development possibilities for this site. All development opportunities to maximise the potential for the site are being explored and up to date information will be made available to councillors as part of the monthly Housing Report to the council meeting.

#### **MEET AND TRAIN**

A running group has started up in Irishtown on Tuesday evenings. The group is mostly female novice runners who are just starting out or seeking to improve. Group meet at 7pm outside Irishtown stadium and will run for around an hour. Newcomers welcome.

#### **FITNESS CLASS**

A fitness class for women in the Irishtown / Ringsend area will take place every Monday morning at 10am in Irishtown stadium. Open to all ages and fitness levels.

#### **MARATHON KIDS**

Three schools in the South East Area are participating in a programme with 6<sup>th</sup> class students to complete a marathon over eight weeks. The schools will all come together on Sunday 20<sup>th</sup> November in the National Sports Campus, Abbotstown, to complete their final mile and celebrate their achievement.

#### **FOREVER FIT**

Chair-Fit classes for older adults will take place on Wednesday evenings at 6.15pm for the residents of Mount Drummond Sheltered Housing Complex. This is a great way for the residents to improve strength and flexibility for day to day living.

**YOGA - LANTERN CENTRE:** Yoga classes take place every Tuesday morning for women in The Lantern Intercultural Centre in Synge Street. These are of huge benefit to the women and help them to integrate with the community.

## Whitfield Grove/Garrán Whitfield


A request has been received from PA Architects, Suite 141, The Capel Building, Mary's Abbey, Dublin 6 to name and number a new development at Church Avenue / Church Gardens, Rathmines, Dublin 6.

The applicant seeks approval to name the site being developed as Whitfield Grove / Garrán Whitfield. The rationale for the name is that "Philip Whitfield Harvey, editor of the Freemans Journal, lived in Grove House, Rathmines who had family links to Henry Grattan. The applicant proposes to number his parts of the development 1, 3-6, and 11 19 Whitfield Grove. Two other developers will each apply separately to number their units, the remaining ones, within the overall scheme. All three developers have agreed to the name proposed.

The development is indicated on the drawing R.M. 36631.

The Heritage Officer considers the proposed name appropriate and accordingly the scheme is recommended for approval.

Can the manager issue a full report in relation to the recent issue of noise on Pigeon House Road that was emanating from the MTL facility and Dublin Port? This matter was recently before the court.

Can the area manager indicate whether there will be any major Christmas Market event that is to be organised by Dublintown or others, in the South East Area?

## Q.11 Councillor Mannix Flynn

Can the manager issue a report and update with regards the order of protected structure that has been initiated around the Central Bank and Plaza which was agreed by the South East Area almost a year ago?

## Q.12 Councillor Mannix Flynn

Can the manager initiate for 2017, a festival of Valentine at Aungier Street District and area? The St. Valentine Area and Whitefriar Street Church are the heart of the Valentine's Day that is celebrated around the world? Dublin City Council, through its community resource, has a fantastic opportunity here working with local community, groups and business to initiate the first Valentine Festival. There is a huge amount of new activity and business and residents in this area. It is a thriving locality. It is surrounded by many schools and there are thousands of students and young people in the area. This initiative has a great potential to engage with young people on the theme of love and respect, as well as engaging with the whole idea of romantic love. Recently a motion by Valerin O Shea from An Taisce was adopted at the Planning Strategic Policy Committee to this effect. It is now time that this was followed through with action.

## Q.13 Councillor Mannix Flynn

Can the manager issue a full report and update with regards the sale and the future use of the stables at the back of 13/14 St. Stephen's Green - Dawson Street - which were recently sold by Dublin City Council? This report to include a full account of all monies received and what use these monies will be put to.

#### Q.14 Councillor Mannix Flynn

Can the manager issue a full report with regards the effectiveness of the new busking byelaws? There are still far too many complaints of noise and excessive amplification in the Temple Bar, Grafton Street areas and on occasion the George's Street / Wicklow Street area. Many residents and complainants are dismayed at the lack of response from Dublin City Council and An Garda Síochána. They also cite threatening behaviour from certain buskers and a wholesale disregard for the law with some individuals having no license to perform at all. This situation now is fast becoming out of control in these areas and many residents feel they are being intimidated.

To ask the manager if she will arrange for the seriously large tree at approximately 248 Merrion Road that is blocking light to the adjoining homes and creating a major footpath tripping point to be seriously pruned and the footpath adjacent to it repaired as a matter of urgency.

#### Q.18 Councillor Claire O'Connor

Can the council erect flexible plastic bollards on the double yellow lines on both sides of the road at the entrance to Kimmage Grove and on the corner to allow free movement of traffic using the football club and residents wishing to access and egress from their houses?

Can the uneven footpaths in Annesley Park be repaired?

Can the lampposts on Castlewood Park be painted?

Can extensive road, footpath and kerb repairs be carried out in Rathdown, Terenure?

Can the pavements outside 11, 13 and 15 Garville Avenue be repaired in circumstances where building works have taken place recently on Garville Drive and caused the respective damage?

#### Q.24 Councillor Claire O'Connor

Can a sign be erected at the entrance to Elmwood Avenue indicating that children are at play?

Can the footpaths in Mount Drummond be repaired?

Can a seat be put in the park in Neagh Road outside of the playground area for elderly people who do not necessarily want to sit in the playground?

## Q.29 Councillor Frank Kennedy

To ask the Area manager to ensure that the tree outside No. 2 Merlyn Drive (and opposite No. 44) is topped in circumstances where the branches are demonstrably entangled in an overhead power line, thus giving rise to a serious health hazard (see photo attached).

## Q.30 Councillor Frank Kennedy

To ask the area manager to repair the footpaths on Merlyn Drive and in particular the footpath outside No. 2 which is uneven and dangerous (see photo attached). Such is the risk that several elderly residents choose to walk on the road rather than the footpath, which gives rise to serious risk of injury.

## Q.31 Councillor Frank Kennedy

At present when the traffic lights on the Merrion Road (where Nutley Lane meets the Merrion Road at a T-junction) are red, during busy periods traffic will invariably back all the way to the intersection of Merrion Road and Ailesbury Road. An effect of this is that the pedestrian crossing on the Merrion Road outside the Merrion Shopping Centre is traversed with cars even when these lights are red, because cars will be sitting on the crossing before the lights turn red. This problem could be easily resolved by placing a yellow box the width of the pedestrian crossing outside the Merrion Shopping Centre. One has been installed to considerable success at the pedestrian crossing near the Frascati Shopping Centre, Blackrock. The area manager is asked to replicate this with a similar yellow box to cover the width of the pedestrian crossing outside the Merrion Shopping Centre.

## Q.32 Councillor Frank Kennedy

In circumstances where residential properties (houses and apartments) often leave bins in parking bays on roads with residents' permit parking schemes, which take up parking spaces, to ask the area manager whether it is possible for clamping companies to ensure that bins are removed from parking spaces and placed on the footpath when reviewing parking on city streets?

## Q.33 Councillor Frank Kennedy

To ask the Parks Department of Dublin City Council to take urgent action to address anti-social behaviour happening in Ringsend Park behind the houses on Ringsend Park. During mid-October, every night, for a week, there were fires lit directly behind these houses. Petrol was used to ignite the fires and create petrol bombs to throw at the surrounding trees behind the residents' houses. There is an access point to the Park at the rear of one garden which a resident allowed the fire brigade to use to extinguish the fires. Unfortunately, this seems to have caused retaliation which resulted in a large rock being thrown directly though the back fence into that resident's garden, and parts of the fence where ripped down and used for subsequent fires (see attached pictures).

#### Q.34 Councillor Frank Kennedy

Having regard to recent signage placed on Sandymount Strand and at Irishtown Nature Reserve requiring dogs to be kept on a leash, to ask the Area manager:

- (a) When the most recent signs were erected?
- (b) Is this area governed by national legislation, bye-laws, or both?
- (c) What are the relevant legal provisions?
- (d) If the position is governed by bye-laws, when were they introduced and what is the motivation behind them?

#### Q.35 Councillor Frank Kennedy

In circumstances where the Markievicz Centre will re-open in mid-December 2016, and fully in January 2017, to ask the Area manager to provide an update on the review of the level of provision of classes at Irishtown Stadium referred to in the answer to my motion No. 515 at the January 2016 SEAC meeting, and to ensure the continued provision of classes at Irishtown Stadium.

(Motion 515 at the January 2016 SEAC meeting: When the Markievicz Centre re-opens the classes which are currently being provided at Irishtown Stadium will revert to the Markievicz Centre. This committee welcomes the re-opening of the Markievicz Centre but calls upon this council to provide classes at Irishtown Stadium to replace the classes which are now reverting to Markievicz Centre. These classes were very popular with local residents. This

committee notes and appreciates that in due course a review of the provision (or lack thereof) of classes at Irishtown Stadium will take place and will, subject to resources, attempt to address any shortcomings to meet the demand. This committee welcomes the review and states its desire that the effect of the review will result in the provision of classes at Irishtown Stadium.)

## Q.36 Councillor Chris Andrews

Residents in the Portobello area have contacted me about concerns over the development of 22 Portobello Road Dublin 8 - Planning Ref. 3644/12.

- Can you state that this property is not in contravention of previous planning applications?
- Residents in Brendan's Cottages in Ringsend have expressed concern that the owner of the property to the rear and to the side of 19 Brendan's Cottages is going to put some unauthorised works into the property to the rear can you tell me what the process is if they wish to do so and what sort of works have they permission to install?

## Q.37 Councillor Chris Andrews

Can the manager have the gates locked at night at the Sundrive Road side of Eamonn Ceannt Park?

## Q.38 Councillor Chris Andrews

Can the Environmental Health Officer (details supplied), who has been dealing with the issues around the ongoing noise and air pollution caused by the operation of Irish Rail's storage and maintenance of its fleets of trains at both sides of Macken Street give a report for the meeting.

## Q.39 Councillor Chris Andrews

Can the manager arrange to have the wooden slats that are missing on the boundary of Beechill Villas replaced and indicate when this work will be completed?

#### Q.40 Councillor Chris Andrews

Can the manager give a report on what restrictions a dog owner must adhere to when they are walking their dog in?

- 1) Sandymount Strand
- 2) Irishtown Nature Reserve
- 3) Promenade in Sandymount
- 4) Ringsend Park

Are there any differences in terms of restrictions in these areas?

#### Q41. Councillor Chris Andrews

Can the manager arrange to have the leaves in Beechill estate removed and give particular attention to the lane leading from Beechill down to Beaver Row?

## Q.42 Councillor Chris Andrews

Can the manager remove the trees along Beechill Avenue where the roots are pushing up the pavement and making it particularly dangerous for older people?

#### Q.43 Councillor Chris Andrews

Residents of Pearse Square contacted Dublin City Council Planning Department on number of occasions over the past weeks regarding the planning notice at Planning Ref. 3854/16, 5 Pearse Square. They were assured that the time period for lodging observations or objections would commence only when the planning application, accompanied by the plans were publicly available on the DCC website. They have been checking DCC planning website regularly and have seen that the notice and plans have appeared over the past few days.

However, they now see that the closing date for observations is 1st November, the date of lodgement was 3rd October, apparently.

Can you please advise the following:

- 1. The date when this notice appeared on your website
- 2. The date when the plans / drawings appeared on your website
- 3. Confirm the closing date for lodging observations
- 4. Confirm process and timelines for these milestones on a planning application

The timescales we have received for this application is not sufficient for us to study the plans in detail or to engage an architect, if residents deem this necessary.

They are requesting the notice period is extended for a further 2 weeks at least. Can this request be accommodated?

## Q.44 Councillor Chris Andrews

Can the manager arrange to have double yellow lines outside 10 Grove Avenue, Harold's Cross, Dublin 6 as a matter of urgency, as currently cars are parking outside of this address and as a result blocking an emergency exit and the elderly residents are unable to climb over cars parked at their front door?

#### Q.45 Councillor Chris Andrews

Can the manager indicate who owns the land indicated with the red dot on map below to the rear of details supplied and if Dublin City Council is not sure where and how would I find out ownership of this land?

## Q.46 Councillor Chris Andrews

Will the manager arrange to have the leaves cleared on City Quay and in particular around the Elizabeth O'Farrell monument and off the pavements on boundary of the park?

## Q.47 Councillor Paddy McCartan

The paths adjoining Strasburg Terrace, Irishtown have become cracked and broken with the inherent dangers to local residents. Could the manager arrange to have these paths resurfaced?

#### Q.48 Councillor Paddy McCartan

To ask the manager to arrange for the installation of disability designated parking outside the new Ringsend Medical Centre, at 5 Fitzwilliam Street, Ringsend. There is a loading bay usually occupied by trucks and it would be very convenient for patients who have disabilities or are wheelchair using to park outside the surgery.

## Q.49 Councillor Paddy McCartan

To ask the manager to initiate repairs to the footpath at the front of 22 Gilford Road, Sandymount. This is a safety issue as the surface has become broken and uneven.

#### Q.50 Councillor Paddy McCartan

To ask the manager to deal with the issues raised by this constituent, details supplied. Could a dog warden inspect the area?

## Q.51 Councillor Paddy McCartan

To ask the manager to ascertain how many complaints have been made for the first ten months of this year regarding smells and odours emanating from Ringsend sewage treatment plant? On the outgoing bank holiday weekend there were particularly strong odours and I receive regular reports of same.

#### Q.52 Councillor Paddy McCartan

To ask the manager to respond to these issues: New notices have gone up on Sandymount strand that dogs must be kept on a leash. Why has the city council put this measure in place? To this point many people have walked their dogs on the beach without causing hindrance to other beach users.

A constituent was approached by a dog warden in the Nature Reserve in Irishtown and was informed of new bye-laws saying dogs should not be let off the leash in what is a Nature Reserve. Could the manager provide specific details on the contents of the bye-laws as they affect both Sandymount Strand and the Irishtown Nature Reserve?

## Q.53 Councillor Paddy McCartan

To ask the manager to update the committee on Dodder flood works at Ballsbridge, specifically what is the status of the planning application for the upgrading of the walls at Anglesea Road across from the RDS.

## Q.54 Councillor Paddy McCartan

Dolphin House, also known as the Bottlemakers' Hall is situated at 1A Irishtown Road. It was constructed in 1915. Various attempts to establish ownership of the premises have come to nought. The Bottlemakers' Hall was placed on Dublin City Council's Protected Structures List 36 years ago.

That such a fine building remains derelict is a blight on the landscape in Irishtown. Until ownership has been confirmed, seemingly nothing can be done with this building for the benefit of the community. Can Dublin City Council once and for all find out who owns it?

Also, in response to a request of mine in 2013, a major clean-up of the gardens of the building was undertaken. Could a similar clean-up be carried out again?

## Q.55 Councillor Claire Byrne

To ask the area manager who is proposed new lessee of the Pigeon House Hotel and what are the terms and conditions of the new lease agreement.

## Q.56 Councillor Claire Byrne

To ask the area manager to investigate complaints of bin collection services taking place on multiple days of the week in the Portobello area and if the service providers are found to be in breach of their licence agreements, what action will be taken to address this issue?

## Q.57 Councillor Claire Byrne

To ask the Area manager when the measures for Leeson Street Bridge agreed by the Traffic Advisory Group in May 2016 and outlined below will be implemented:

 Rescind the Pay and Display Parking on the southern side of Sussex Road from a point approximately 8 metres east of lamp standard No.26 extending eastwards for 11 metres, and replacement at the same location with a loading bay with hours of operation Monday to Saturday 07.00 - 18.00.

- Rescind the loading bay in front of Leeson Lounge, Leeson Street Upper.
- Relocate Dublin Bus Stop No. 847 south in front of Leeson Lounge, Leeson Street Upper (in the rescinded loading bay area).
- Partially remove the existing build-out adjacent to relocated Bus Stop No. 847, to facilitate a third bus.
- Install an extended Primary Signal Pole or cantilevered pole at the pedestrian crossing adjacent to the Lesson Lounge, to ensure adequate visibility when buses are stationary.

Road Maintenance inspected and filled in potholes on Oakley Road. Oakley Road is on Road Maintenance's 2016 programme for resurfacing.

Would the manager please state when the traffic lights will be installed on Grove Road, Harold's Cross junction? Furthermore, why is the Road Maintenance Section currently doing resurfacing of the road at this junction, which will have to be reopened to install the traffic lights?
