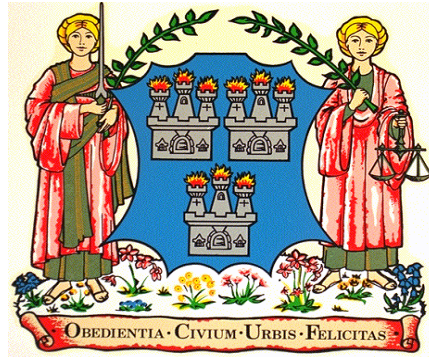

1 Lord Mayor's Business

The Lord Mayor opened the meeting by offering congratulations to the following:

- a) Shane Curran and Terenure College for the recent win at the Young Scientist & Technology Exhibition held in January
- b) Conor Turner from Santry who finished 2nd in the World Ice Swimming Championships held recently in Germany and who, together with the Irish Ice Swimming Team, was received in the Mansion House last Friday.

The Lord Mayor then requested approval for Members to attend a national conference in Enniscorthy on Thursday, March 2nd, which Wexford County Council is co-hosting and which is relevant to the core objective of delivering the highest quality affordable social housing. Attendance was approved by the City Council. The Lord Mayor then reminded Members who not already done so to return their Ethics Declarations by the end of February.

The Lord Mayor then informed the Members that he wished to propose the granting of the Freedom of Dublin City to Barrack and Michelle Obama, former President and First Lady of the United States. Accordingly, the following resolution was proposed by the Lord Mayor and seconded by Councillor P McAuliffe:

***“That the Honorary Freedom of the City of Dublin be conferred on Barack Obama and Michelle Obama and that they be elected and admitted to the Honorary Freedom of Dublin City pursuant to the provisions of the Local Government Act 2001 as amended”.***

- (c) In light of the ongoing planning process surrounding the Clerys site, the Members of Dublin City Council wish to reiterate, repeat and restate their continued support for previous motions passed in relation to this iconic building and business. They also wish to highlight the need for any plan concerning the future development of the site to properly adhere to, having regard to the Dublin City Council Scheme of Special Planning Control for O'Connell Street and Environs.

The Members of Dublin City Council, at a Special Meeting held on 29th June 2015 to discuss the Clerys issue, agreed motions which contained the following clauses that continue to have the support of this Council:

- This Council confirms by this resolution that it will not agree to alter the use of the entire Clerys building because of the iconic status of Clerys and resolves that it must continue to be used as retail space which is an essential part of



the retail experience of the city centre and that change of use is not appropriate and will not be entertained.

- DCC calls on the Government to amend company law to protect our economy and society.
- Dublin City Council calls on the Directors of Natrium to meet with Clerys staff and their trade union representatives to discuss the liquidation of the company, the manner of the liquidation and its impact on the loyal workforce.
- Dublin City Council calls on Natrium to guarantee employment of the current workforce in any new development.
- Dublin City Council demands the Government to review and amend current legislation, including Protection of Employees Act and the Companies Act, with a view to ensuring the unacceptable treatment of Clerys staff cannot be repeated again.
- That Dublin City Council refuses to grant any “change of use” planning application in respect of the Clerys Store on O’Connell Street to Natrium (the new owners of the Clerys store) unless the company meet with workers representatives to discuss securing jobs and/or compensation by way of enhanced redundancy payments to the former employees of Clerys.

The Members of this Council also state our continuing and full support for the vision statement of the Scheme of Special Planning Control O’Connell Street and Environs which is:

“To re-establish O’Connell Street and environs as a place of importance in the social and cultural life of citizens and visitors, where buildings and their uses reflect a civic dignity and pride, and property owners and occupiers acknowledge their obligations as stakeholders and workers are assured fair working conditions in this area of special significance to the Irish Nation.”

In order to advance this vision, we, the Members of Dublin City Council call for:

- The establishment of codified protocols in relation to the implementation of commitments exchanged between the proposed developers of the Clerys site and Dublin City Council in relation to the training in apprenticeships and other employment programmes, as well as recruitment of local residents so they can be employed in both the construction and operational phases of the development.
- The designation of a cultural space within the development to enable displays/performances relating to the site and local area. This space should be open to and free to use for local civic, social and community organisations. The Members of Dublin City Council believe that by the adoption and proper monitoring of the implementation of the above measures, the narrative of Clerys can be restored to being one of a positive contribution to our city rather than one that continues to be overshadowed by the dark chapter that was its sudden closure, with the resultant mistreatment of its workforce and customers.

In light of the above statements, the Members of Dublin City Council call on the Chief Executive and the Lord Mayor to immediately meet with all the investors/ owners of the Clerys Site and relate the concerns, suggestions and proposals of the Members of Dublin City Council, as articulated in the motions passed at the Special Meeting of the Council on 29th June 2015 and reproduced above, and request that these investors/owners take appropriate action to address these concerns, suggestions and proposals.

**Submitted in the names of Councillors N Ring, D Lacey, C O’Moore, M O’Brien, E Ryan and J Lyons,**

The motion was put and carried. It was further agreed that this motion be forwarded to Minister Coveney and to the Planning SPC.

- 52 The Lord Mayor vacated the Chair at 8.15pm and returned at 8.30pm. The chair was taken by Deputy Lord Mayor, Councillor Rebecca Moynihan in his absence.

- 53 It was proposed by Councillor P Dunne and seconded by Councillor C O'Moore:  
*“Should the proposed creation of a public pedestrianised plaza at College Green be approved, that Dublin City Council and Bank of Ireland enter into discussions to ensure the enhancement of the plaza by removing the railings surrounding the old parliament building”*

Councillor Dunne later amended the motion to include the words 'or relocating' after the word 'removing'. The amended motion was put and carried.

- 54 It was proposed by Councillor D O'Farrell and seconded by Councillor M Flynn:  
*“That this City Council supports the 2nd year of the successful Team Dublin Clean up initiative and looks forward to its further growth in the future”*

The motion was put and carried.

- 55 The City Council agreed to a proposal by Councillor D Lacey that he be allowed swap his motion standing as Motion No 3 on the Agenda Paper with Motion No 26 in the name of Councillor P McAuliffe. Accordingly, it was proposed by Councillor P McAuliffe and seconded by Councillor C Ni Dhalaigh  
*“Dublin City Council calls on the Planning Department to open negotiations with JCDecaux to extend the Coca-Cola Zero dublinbikes scheme to the urban villages of the City along the national primary routes or other routes branching out from the current cluster. This expansion would include the provision of new digital high profile advertising sites in the outer city with particular focus at or near M50 junctions”*  
The motion was put and carried.

The meeting concluded at 9.30pm in accordance with Standing Orders and all items remaining on the Agenda were deferred to the next meeting of the City Council to be held on the 6<sup>th</sup> March 2017.

**CHIEF EXECUTIVE'S REPLY:**

The traffic camera network is for the monitoring of traffic, detection of incidents, accidents and unauthorised road works. It is not designed to count vehicles or complete surveys in the manner requested.

**Q.19 COUNCILLOR NIAL RING**

To ask the Chief Executive to confirm exactly how many and the exact location of the parking bays which would be removed if the Liffey Cycle Route were to go ahead. Also, to ask the chief Executive to detail the permanent annual loss of revenue to DCC if these parking bays are removed (from figures given to me at a recent presentation to the Central Area Committee this loss of income may be estimated at €250,000 plus per annum - on top of the €1.8m permanent loss of income from the removal of the c.400 parking bays to facilitate the Luas cross city project for which I assume DCC are still, as indicated to me, negotiating compensation for from the NTA). Finally, to ask the Chief Executive to confirm that the Environmental and Economic impact assessment to be commissioned as part of the process will include the economic impact of the loss of parking bays both in direct monetary terms and direct and indirect economic impact of the proposal on city centre retail business.

**CHIEF EXECUTIVE'S REPLY:**

The current proposals for the Liffey Cycle Route would see the removal of the following parking spaces:

Inn's Quay

33 spaces

Ormond Quay Upper	35 spaces
Blackhall Place	8 spaces

The Parking Policy and Enforcement Section have estimated the potential loss of income due to the removal of these parking spaces at €500,000 per annum.

Dublin City Council will carry out screenings for both an Appropriate Assessment and an Environmental Impact Assessment. This screening will be carried out by an independent consultant. The outcome of this process will inform on the appropriate statutory planning process. It is envisaged that this process will be completed by the end of April 2017. If an EIA is required, Dublin City Council will consult with An Bord Pleanála to finalise the various headings on which the EIA will be carried out. This may include an economic impact assessment.

**Q.20 COUNCILLOR NIAL RING**

To ask the Chief Executive if there are any plans to include a facility on the successful Parking Tag scheme whereby a car can be registered to two users (and mobile phones) to facilitate cases where, for example, a couple have one car which they both use at different times and require parking. **CHIEF EXECUTIVE'S REPLY:**

It is not possible to include this functionality in the Parking Tag system in its current configuration. It is intended to commence a tender process for provision of the Cashless Parking Payment System for on-street parking shortly, commencing with Technical Dialogue with potential service providers and the feasibility of including this functionality can be discussed and considered at that time.

To ask the Chief Executive to detail what, if any, checks are in place to ensure non-abuse of Disabled Parking permits. I ask this question because of complaints I have had by members of the public who note able bodied people getting into and out of cars parked in Disabled Parking Bays and international surveys which suggest that up to 25% of cars parked in Disabled Parking Bays are done so illegally. In particular, can the Chief Executive detail the following?

- a. Number of Disabled parking Bays in Dublin City and cost of providing this much needed facility (i.e. income foregone, maintenance etc.)
- b. Staffing etc. used to check for abuse of the facility.
- c. Sanctions available against people misusing Disabled Parking Bays.
- d. Number of people caught misusing Disabled Parking Bays (2014, 2015 and 2016)
- e. Number of parking passes confiscated for misuse (2014, 2015 and 2016)

**CHIEF EXECUTIVE'S REPLY:**

Disabled Parking Permits are issued by the Disabled Drivers Association and the Irish Wheelchair Association. Permits which are valid for use in a Disabled Parking Bay. Without time restriction or payment. They are issued by those bodies for a significant number of complaints, illness and disability. It is not necessarily apparent to any observer what the nature of any permit holders disability may be despite the individual being fully entitled to hold a permit. Additionally, any individual whilst

transporting a permit holder may also validly display the permit and rely on the permit when parking. Dublin City Council also allows holders of Disabled Parking Permits Park in any regular Pay and Display Parking Bay free and with no maximum stay time limit.

Offences associated with Disabled Parking Bays and Disabled Parking Permits include non-display of the appropriate permit when parked in a Disabled Parking Bay and inappropriate use of a Disabled Parking Permit, e.g., displaying a permit when the permit holder is not present or being transported. Dublin City Council has previously engaged with the bodies concerned with the intention that appropriate details of permit holders be made available Dublin Street Parking Services Crew for the purposes of carrying out enforcement of inappropriate use of permits. However, due to Data Protection Regulations this information could not be provided.

- a. There are 155 on-street Disabled Parking Bays located within the City Centre area. In residential areas Disabled Parking Bays are generally provided in response to specific request from residents who submit the required medical evidence to support their request. Disabled Parking Bays are not provided for use by any individual or resident and may be used by any individual entitled to do so. Maintenance of Disabled Parking Bays is carried out as part of a general maintenance programme. It is not possible to provide a reasonably accurate estimate of the cost of maintenance. It is conservatively estimated income forgone to provide the free parking service to Disabled Parking Permit holders is €500,000 per year.
- b. Enforcement of illegal parking including those related to Disabled Parking Bays and display of Disabled Parking Permits is carried out by the Council's Parking enforcement Contractor, Dublin Street Parking Services as part of regular routine enforcement patrols and in response to specific complaints of illegal parking. Approx. 60 operational staff carry out enforcement activities on a shift basis.
- c. Sanction for all illegal parking is by way of immediate clamp requiring payment of €80 and/or removal to the pound where appropriate thereby incurring additional related charges.
- d. In 2014, 2015 and 2016 there were 602, 495 and 486 enforcements respectively for offences related to Disabled Parking Bays.
- e. Dublin City Council does not have the authority to prevent the use of or confiscate any Disabled Parking Permit.

**Q.32 COUNCILLOR REBECCA MOYNIHAN**

**CHIEF EXECUTIVE'S REPLY:**

The criteria for the consideration of requests for Pay and Display and Permit Parking Schemes require that written supporting evidence in favour of parking controls be received from 25% of households before the request is referred to the Traffic Advisory Group for examination. The full criteria were forwarded to the Councillor on behalf of residents of New Ireland Road on 4<sup>th</sup> November, 2016. A copy of the correspondence is being forwarded to the Councillor for information.

In relation to Haroldville Avenue, the criteria were forwarded to a resident on 9<sup>th</sup> January, 2015. No further correspondence has been received from the resident to date. On submission of the initial 25% supporting evidence from households of the road, the request for a Parking Scheme will be referred to the Traffic Advisory Group for examination and report. Where a Scheme is recommended, the residents concerned listed on the Register of Electors will be balloted. The returned ballot determines whether or not the City Council proceeds with the proposed Scheme.

A report regarding the City Council's parking policy was submitted to the Transport and Traffic Strategic Policy Committee (now Transportation SPC) at its meeting of 12<sup>th</sup> September, 2012. The report set out revised policy for (i) the introduction of Parking Schemes and (ii) the survey of residents, and was agreed by the SPC at the time. The revised policy came into effect in September, 2012. A copy of the report is being forwarded to the Councillor.

**Q.34 COUNCILLOR CIARAN CUFFE**

That the Chief Executive state how applications for an extension of working hours have been sought in 2016 that derogate from the terms of the Planning Permission granted in the North Inner City and Pembroke South Dock Ward, and could he give



details of the Planning Reference, address, reasons for derogation, and could he make a statement on the matter?”

**CHIEF EXECUTIVE'S REPLY:**

**Background**

An Bord Pleanála approved the North Lotts & Grand Canal Dock SDZ Planning Scheme on the 16<sup>th</sup> of May 2016. Since the scheme came into operation there have been 79 applications granted permission for development. A number of these are for multi storey complex buildings on sites in close proximity to residential developments. Development has commenced at a number of these sites both North and South of the Liffey. The standard working hour's condition attached to the permissions granted states the following; “The site and building works required to implement the development shall only be carried out between the hours of Mondays to Fridays - 7.00am to 6.00pm, Saturday - 8.00 a.m. to 2.00pm, Sundays and Public Holidays - No activity on site.

Deviation from these times will only be allowed in exceptional circumstances where prior written approval has been received from Dublin City Council. Such approval may be given subject to conditions pertaining to the particular circumstances being set by Dublin City Council”.

**Relevant sites that have applied for extension of standard working hours to date.**

**Method of dealing with requests**

A request is made by the developer outlining the works that are required to be carried out, the reason why they can only be done outside standard working hours and also the required duration and time for completion of said works. The requests are assessed by the Planning Department having regard to, health and safety, traffic management issues, structural requirements, i.e. large concrete pours and associated power floating and also potential disruption to residents/businesses in the area.

The developers in all cases are instructed to notify any residents affected by permitted extended working hours. The Planning Department only grant permission

for extended working hours where they are satisfied that the works concerned cannot reasonably or safely be carried out during standard working hours. On sites that have generated complaints to date the Planning Department have met with a senior member of the site development staff and have reiterated the requirement for the developer to keep residents informed of progress and any out of hours works that have been applied for and permitted. They have also been requested to outline and explain the reasons behind the required hours extensions.

The construction of multi-storey buildings is a complex matter and at various stages during construction exceptional circumstances arise which can necessitate working outside normal permitted times. In order to construct these buildings safely there is a requirement for large scale concrete pours with associated power floating, which has to be completed in one cycle once commenced. Works that generate noise that would cause any undue disturbance are not permitted unless the works are required for Health and Safety reasons. We are anticipating that in the future concrete pours and power floating will be the primary required reason for extended hours of works on the sites concerned, with power floating being the primary work on site after 6pm. This work is generally low impact work from a noise point of view and the Planning Department will limit the number of such pours during the course of any given week.

Dublin City Council is currently reviewing the protocols in place on all sites in the Docklands SDZ area with a view to streamlining the procedure. The council is also exploring additional possibilities, where appropriate and practical, to facilitate the putting in place of further mitigation measures by the developers to further protect residential amenity, during extended working hours.

**Q.35 COUNCILLOR CIARAN CUFFE**

That the Chief Executive state how many Dublin City Council staff are authorised to undertake inspections of premises and vehicles for the marketing, sale and distribution of bituminous fuel. Could he state how many prosecutions and fixed payment notices were issued under the Air Pollution Act for breaches of the Regulations occurred in the last year for which figures are available, and could he state how many of these were successful, and what was the total in fines and costs collected. Could he also give details of any breaches including the names and addresses where the breaches occurred?"

**CHIEF EXECUTIVE'S REPLY:**

The Air Quality Monitoring and Noise Control Unit carry out inspections of these premises and vehicles during the heating season between October and March each year.

During the 2015-2016 and the 2016-2017 to date heating seasons a total of 235 inspections were carried out. In the course of these inspections non conformances were found on 9 occasions. These non-conformances may range from technical issues with record keeping up to and including sale of specified fuels. As a result, 6 warning letters were issued and 1 fixed payment notice for €500 was served. It was not necessary to initiate further legal proceedings as follow up inspections were carried out to see assess and verify compliance.

There is 9 staff members of the Air Quality Monitoring and Noise Control unit authorised under the provisions of this legislation.

**Q.36 COUNCILLOR CIARAN CUFFE**

That the Chief Executive present a report on actions that Dublin City has taken to render 19 & 21 Connaught Street, Phibsborough, Dublin 7 non-derelict, and to

present any opinion that he may have (including advice from the Law Agent) indicating that the properties are no longer derelict given that they are boarded up, have Buddleia bushes growing out of the roofs, and decaying masonry, and are located in a Residential Conservation Area, and could he outline what action he now intends to take to ensure that these homes are made available to assist in the tackling of Dublin's housing crisis. Furthermore would he agree that the empty state of these homes for more than a decade necessitates a more proactive approach by the Council?"

**CHIEF EXECUTIVE'S REPLY:**

No's 19 & 21 Connaught Street, Phibsborough, Dublin 7 was removed from the Derelict Sites Register on 15<sup>th</sup> June, 2012, following the carrying out of improvement works by the owners to render them non-derelict. The Derelict Sites Section will arrange for the sites to be inspected to assess their current condition and the Councillor will be updated on the findings.

I wish to affirm that the eradication of dereliction in the City is a key priority for the City Council. In order to achieve this objective and to ensure that properties are redeveloped and returned to active use the Council is actively exercising its legislative powers under the Derelict Sites Act, 1990 (the 1990 Act) to acquire sites on the Derelict Sites Register, in circumstances where all efforts to secure the carrying out of improvement works by property owners have been exhausted. In relation to the issue of empty homes it should be noted that the power of compulsory acquisition under the 1990 Act only extends to derelict sites and that vacant homes are not de facto derelict by virtue of them being vacant. The issue of vacant homes is being looked at by a Steering Group chaired by the Housing Agency.

Currently the City Council is at the final stages of the compulsory acquisition process for seven properties that stand entered on the Derelict Sites Register. The process will conclude in early March at which point the properties will have vested in the City Council. The Housing and Residential Services Department is currently reviewing the properties to determine those most suitable to be utilised for social housing purposes, the remainder of the properties, if any, will be put up for sale, by the Planning & Property Development Department, with strict terms and conditions to ensure that they are redeveloped and returned to active use within stated timelines.

The Council is currently identifying a further list of derelict sites for compulsory acquisition.

**Q.37 COUNCILLOR EDEL MORAN**

To ask the Chief Executive to give me the details of the land that is available to DCC for housing in the north central area and that is ready to start in the next 6 months.

**CHIEF EXECUTIVE'S REPLY:**

Housing Department are progressing housing developments at Belcamp "B" & Belcamp "C" which will provide 12 and 16 units respectively of general needs and senior citizen accommodation. We are in the process of appointing a Design Team who will prepare plans and tender documentation for these developments.

Construction has commenced on the Belcamp "H" site. This Rapid Build scheme will provide 38 units of accommodation and will be completed during the 2nd quarter of 2017.

Construction of 35 units at Buttercup in Darndale will also be completed during 2017 with houses scheduled for handover on a phased basis.

Housing Department report on a monthly basis to the City Council and on a quarterly basis to the Area Committees and also the Housing SPC regarding all current developments and future proposals for development of public housing in the city.

Details of all proposals in the North Central Area are contained in these reports.

**Q.38 COUNCILLOR JOHN LYONS**

To ask the Chief Executive to provide this councillor with a report on the number of applicants removed from the housing list in each of the city council administrative areas as a result of the recent review.

**CHIEF EXECUTIVE'S REPLY:**

There are currently 142 Caretakers assigned to both Flat Complexes and the Mobile Units. There were 154 Caretakers assigned to the same duties 3 years ago this month.

**Q.44 COUNCILLOR CHRIS ANDREWS**

To ask the Chief Executive is there any plans to privatise the position of Caretakers for the flat complexes?

**CHIEF EXECUTIVE'S REPLY:**

There is no proposal to privatise this service.

A recent review of the caretaker service generally was commissioned to look at the delivery of the service to City Council flat complexes, traveller specific accommodation and senior citizen schemes in light of on-going financial challenges. The review recommended certain changes in the current delivery of the service intended to achieve greater efficiencies and value for money. While the Review also raised the possibility of certain specialised service elements being contracted out it recommended that the bulk of the service should remain in-house.

The report and its recommendations are under review and it is intended to meet with the Unions to discuss the recommendations and implementation of the proposals this month.

**Q.45 COUNCILLOR CHRIS ANDREWS**

Can the Chief Executive have the bollard that was in place for just two days outside number 1 Pembroke Cottages in Donnybrook replaced and put more than one in this time as clearly there is a problem with trucks mounting the footpath and it is very dangerous for pedestrians and the home owner?

**CHIEF EXECUTIVE'S REPLY:**

Arrangements will be made to replace this bollard and the possibility of installing additional bollards will be examined.

**Q.46 COUNCILLOR CHRIS ANDREWS**

Can the Chief Executive have an engineering survey of Glovers Court carried out to establish why the water service is so bad in these flats and why there is an ongoing flooding problem due to blocked drains?

**CHIEF EXECUTIVE'S REPLY:**

Dublin City Council Housing Maintenance are currently repairing 3 breaks in the drains of Glover Court. We would expect this work to be complete by mid February.

Once Drainage works are complete, it is our intention to investigate the feasibility of installing pumps to address the water pressure issue.

**Q.47 COUNCILLOR MANNIX FLYNN**

Can the Chief Executive issue a full report detailing all of the events surrounding the unlawful occupation of Apollo house. This report to include all financial costs for Dublin City Council's operations at that site. Details of all of the accommodated from that site. All procedures and responses press and otherwise that Dublin City Council

initiated in response to the allegations that were levied and were put into the public domain with regards the failures in Homeless Services.

Also, what efforts have been put in place to respond to such incidents that may take place in the future similar to the Apollo house incident?

Have DCC or any lawful authority made any efforts to ascertain the whereabouts of the many financial and other donations that were given in good faith by the public to the organisers of this event.

**CHIEF EXECUTIVE'S REPLY:**

On the 15<sup>th</sup> December 2016 a group calling themselves the Home Sweet Home initiative occupied a building know as Apollo House on Tara Street, Dublin 2. Following a High Court order on the 21<sup>st</sup> December 2017 Peter MC Verry (PMVT) staff entered the building on 22<sup>nd</sup> December and began working with the homeless individuals inside in order to carry out assessments and secure alternative accommodation. As of 13/01/2017 PMVT had carried out a grand total of 85 assessments. The table below shows the number of moves and where they progressed to.

Dublin City Council did not incur any additional costs for the operations at Apollo House. PMVT provided the above services by way of an existing contract.

The Dublin Region Homeless Executive answered a number of press queries in relation to Apollo House which outlined that we had sufficient capacity in place to meet the needs of rough sleepers across the Dublin Region. We also provided

details on the number of persons who were moved out of Apollo House and into more suitable accommodation over the four week period.

The Deputy Chief Executive and Chief Executive both gave radio and press interviews in relation to the availability of appropriate beds in the system to deal with the homeless demand.

Should a similar incident occur again the DRHE would once again use the homeless action teams to engage with the homeless persons.

DCC is not aware of any lawful authority making a request to ascertain the whereabouts of any financial or other donations that were given by members of the public.

**Q.48 COUNCILLOR MANNIX FLYNN**

Can the Chief Executive engage with the community and the management at the Carmelite Community Hall, Whitefriar Street in order to assist in the continuing provision of the Creche facilities at this centre? This is a vital community service for the many children and families in this area. Indeed, it is the only Creche facility available. There is now a shortfall in funding and also a shortfall in trained staff. This is something that DCC community section can get involved in. Also, in terms of the local area discretionary fund and DCC's community fund. All efforts to keep this Creche open must be made and I'm asking the Chief Executive to please address this issue as a matter of the utmost urgency and to use DCC's resources to assist.

**CHIEF EXECUTIVE'S REPLY:**

We are currently discussing the issue with management of this crèche and with the other statutory agencies involved.

**Q.49 COUNCILLOR MANNIX FLYNN**

Can the Chief Executive issue a full report with regards to overtime that is being allocated to Waste Management section particularly with regard to street cleaning and emptying of bins etc. Also have Waste management staff/workers been instructed to lift black plastic bags that are untagged that are belonging to private waste collectors. Also can the Chief Executive supply a full breakdown of all staff deployed in this area including road sweepers, drivers and supervisors and inspectors. And what is the overtime budget allocation between the various grades and roads.

**CHIEF EXECUTIVE'S REPLY:**

Overtime is worked by the Waste Management section for the following reasons:

- To provide a service at weekends in suburban areas
- To service events (mid-week and weekends)
- To service Bring Centres
- To boost numbers in the City Centre particularly Apr – Sept.
- To carry out litter enforcement duties

To provide specific service where required to deal with issues such as:

- Illegal dumping in Inner City
- Cleaning crew at Cumberland Street market
- Halloween
- Christmas Tree Collection
- Power washing at certain locations.

Waste Management staff have not been instructed to remove bags belonging to private waste collectors except for the purposes of carrying out enforcement investigations. Untagged black bags are investigated where possible before removal as they are dumped and are not prepaid for collection by an authorised waste collector.

At year end 2016 there was 435 operational staff in the Waste Management section. Of these 178 are B Licensed Drivers. 64 are C Licensed Drivers.

The overall budget allocation for overtime in 2017 for all waste management operations is €1,564,698 of this €165,675 is the budget allocated to the inspector grades and the remainder to the other grades. Approx 25% of the total staff complement are available to carry out overtime.

The Council does not divulge details of the specific properties that we acquire for social housing. Accordingly, I regret that I am not in a position to respond to your query regarding the location of units acquired. However, in assessing the suitability of properties for acquisitions, we seek to acquire units throughout the city and avoid over concentration of acquisitions within any one street, estate or area.

All Council acquisitions for social housing are funded by the Department of Housing, Planning, Community and Local Government and the Council's procedure with regard to such acquisitions is to assess the housing need, condition of the property, standard of any extensions or alternations to the premises and whether or not any such alterations are compliant with planning regulation etc.

The Housing Department report on a monthly basis to the City Council and, on a quarterly basis, to the Area Committees and also the Housing SPC regarding all current private acquisitions.

**Q.51 COUNCILLOR PAUL HAND**

To ask the Chief Executive does he think it is appropriate that Dublin City Council sponsors the Temple Bar Tradfest alongside Smithwicks, a company piggybacking on a music festival promoting the use of alcohol in this city. Although the festival is independently organised, on all advertising the DCC logo appears beside that of Smithwicks, which gives the perception that Dublin City Council is promoting and supporting the use of alcohol at events. Can the Chief Executive confirm that it is not Dublin City Council policy to promote alcohol use and can the Chief Executive give me assurance that for any future events DCC will pull out from advertising events with alcohol companies?

**CHIEF EXECUTIVE'S REPLY:**

Tradfest was established in 2006 by the Temple Bar Company to draw footfall to Temple Bar during a quiet month in the City's calendar. Since then, the festival has grown significantly and now includes an impressive cultural programme, which aims to grow domestic and international audiences, in line with the recommendations of the Grow Dublin Strategy.

Tradfest is now considered to be a key element of Dublin City's calendar of events. It continues to be supported through Dublin City Council's annual Festival and Events programme, and a requirement of this funding is that Dublin City Council is recognised as a sponsor on all publications and advertising. The sourcing of additional sponsorship, however, is at the discretion of the festival organisers and Dublin City Council has no authority to influence this.

Any changes to Dublin City Council policy on supporting events with alcohol companies should be referred to the Arts, Culture and Recreation Strategic Policy Committee.

**CHIEF EXECUTIVE'S REPLY:**

Any structure (or part of a structure) to be added to the Record of Protected Structures (RPS), shall form part of the architectural heritage and be of special architectural, historical, archaeological, artistic, cultural, scientific, social or technical interest.

The assessment of special interest of a structure of architectural heritage is an executive function and the programming of assessments is an operational matter for the Planning & Development Department.

At present, there is a backlog of approximately 330 requests for the proposed addition of structures to the RPS which have yet to be assessed by the Conservation Section.

Assessment of special interest is also undertaken by the National Inventory of Architectural Heritage (NIAH), under a national, rating system. The NIAH is currently undertaking a comprehensive survey of Dublin City, which informs the Minister for Arts, Heritage, Regional, Rural and Gaeltacht Affairs, in the making recommendations to the City Council for the addition of structures to the City's Record of Protected Structures. No recommendations have been received to date for this Sandymount area of the city.

Given that the City already has a Record of Protected Structures (RPS) with, in excess of 8,500 entries, it is considered both prudent and good practice to await any recommendation regarding proposed additions to the RPS to be made by the NIAH, arising from its current survey of Dublin City, including the formal recommendation to be made by the Minister. This is also relevant, given the legal and other liabilities of owner(s) and occupier(s) of a structure where it is added to the RPS.

Following the adoption of the new Development Plan, the assessment of additions to (or indeed deletions from) the Record of Protected Structures has commenced, in association with:

- the consideration of recommendations for additions to the RPS published by the NIAH/Ministerial Recommendation, and
- the surveying of 10 priority areas to be considered for potential designation as an Architectural Conservation Area (ACA) as provided in the Dublin City Development Plan 2016-2022, which came into effect on the 21<sup>st</sup> October 2016.

The available resources of the Conservation Section will focus as much as possible over the coming years on the survey, review and drafting work associated with the programme for the preparation of these 10 priority ACAs for the historic core of the

city, along with associated additions to (amendments of or deletions to) the RPS for these areas, as required under the newly adopted City Development Plan.

A file for the proposed addition of the "keeling" at the first lamppost on left hand side after St. Johns Church, (approximately outside number 70) Park Avenue, Sandymount, has been opened and added to the list of candidate additions to the RPS to await consideration in the future. The additional, historic details provided in relation to the "keeling" structure, are appreciated and have been attached to the file.

**Q.55 COUNCILLOR JOHN LYONS**

To ask the Chief Executive to provide this councillor with a detailed report on the Chartered Land application for an extension of planning permission (Reference 2479/08X1): on what grounds was the application for an extension made; what evidence was produced by the applicant to support their extension application; what criteria did the city council use when scrutinizing and deciding upon the validity of the extension application; what evidence did the city council request of the applicant; the report to include also all details and communications in relation to this planning extension application process.

**CHIEF EXECUTIVE'S REPLY:**

On 5<sup>th</sup> May 2016, an application for extension of duration of planning permission was sought for a site consisting of the majority of a city block bounded by Parnell Street, Moore Lane, O'Rahilly Parade, Moore Street, Henry Street, Henry Place and O'Connell Street Upper (Plan No. 2479/08). The developer sought an extension of duration on the basis that: that there were *considerations of a commercial, economic or technical nature beyond the control of the applicant which militated against the commencement of development or the carrying out of substantial works pursuant to the planning permission*. The application was assessed in accordance with Section 42 of the Planning and Development Act 2010 (as amended) which required assessment under 4 main criteria. In conclusion, it determined the following:

1. there were considerations of a commercial, economic or technical nature beyond the control of the applicant which substantially militated against the commencement of development,
2. there had been no significant changes in the development objectives in the development plan or in regional development objectives in the regional planning guidelines for the area of the planning authority since the date of the permission such that the development would no longer be consistent with the proper planning and sustainable development of the area,
3. the development would not be inconsistent with the proper planning and sustainable development of the area having regard to any guidelines issued by the Minister under section 28, notwithstanding that they were so issued after the date of the grant of permission in relation to which an application is made under this section,
4. an environmental impact assessment was carried out before the permission was granted, that no appropriate assessment issues arose.

The Planning Authority was also satisfied that the the application was made in accordance with article 43 of the Planning and Development Regulations 2001 and made prior to 23 March 2017.

**Judgement of the High Court and Statutory Context**

The judgement made by the High Court on 18<sup>th</sup> March 2016 following the lodgement of three related sets of proceedings in respect of this site was also noted, as was the appeal lodged by the Minister for Arts, Heritage and the Gaeltacht to the Supreme Court relating to the judgement in this matter.

While the Planning Authority gave due consideration to the judgement of the High Court, it was also cognisant of the relevant statutory provisions for assessing an application to extend the ‘appropriate period’ of a particular planning permission i.e. Section 42 of the Planning and Development Act 2010 as amended and to relevant case law in this matter.

The nature of the jurisdiction of the planning authority to extend the duration of a permission was considered by the High Court in *McDowell v. Roscommon C.C...* While in that case Finnegan J. was considering the original section 42, as opposed to the modified version of section 42 (substituted by Section 28 of the 2010 Planning and Development (Amendment) Act), one observation of the High Court in *McDowell* is particularly noteworthy:

*“The wording of section 42 is clear. It provides that if the Planning Authority are satisfied on certain matters the Planning Authority must grant an extension. It is clear on the authorities that to take into account any other matter, fact or circumstance is ultra vires.”*

Thus as the application satisfied all the material considerations for the Planning Authority as set out in section 42(1)(a)(ii) and section 42(b), (c) and (d), the application for extension of duration of the planning permission was granted for a further 5 years.

**CHIEF EXECUTIVE'S REPLY:**

There are traffic signals directly outside Brady's Pharmacy but no pedestrian crossing facilities.

Pedestrian crossings are situated at this junction on both Harcourt road and Richmond Street South approaches.

Clarity of exact location of pedestrian crossing in question is required to further investigate this matter.

**Q.63 COUNCILLOR FRANK KENNEDY**

To ask the Chief Executive to install pedestrian lights at the crossing at Harold's Cross Bridge on the Canal where crossing from the bookmakers to the north side of the Canal on the Bridge, and also on the other side. A major junction without a pedestrian crossing is extremely dangerous.

A pedestrian crossing is being provided across Parnell Road, further to the two pedestrian crossings recommended across Grove Road and Harold's Cross Road, at the above junction. Following completion of the current construction works, all arms of the junction will have pedestrian crossings. The current crossing on the city side of the junction is also being moved closer to the junction.

**Q.64 COUNCILLOR ALISON GILLILAND**

To ask the Chief Executive to provide full details regarding the development of DCC owned Bunratty Road, D17, site (Phase 3). This site has been subject of several conflicting reports including media reports asserting that the units will be stackable module units and may or may not be for homeless families - this site was originally to be developed for social housing from the general allocation system. Therefore full clarification regarding the type of development and details of who will occupy the units when completed is sought

**CHIEF EXECUTIVE'S REPLY:**

The Council are in the process of procuring a design team to develop plans for this site. It is proposed to develop the site as a pilot for rapid system build apartments under the housing delivery programme. It is expected that the development will be completed in 2019 with the 60 units to be provided currently designated for use as general needs housing.

**CHIEF EXECUTIVE'S REPLY:**

NAMA contact the Housing Agency in the first instance in relation to its properties. The Housing Agency carries out due diligence on these properties and the Council works with the Housing Agency on properties offered for social housing.

The Council does not divulge details of specific properties that we acquire for social housing but, in assessing the suitability of properties for acquisition, the Council seek to acquire units throughout the city and avoid over concentration of acquisitions within any one street, estate or area.

The Council are in active discussions with the receivers for the Gateway property with a view to acquiring the unit. The Council have also been in communication with the owners of the properties in Oldtown Road who are currently not in a position to dispose of the legal interest of the properties to the Council. The owner of the properties was attempting to resolve these issues and our interest in the properties has been noted by them. If there is no progress on title matters, the Council will refer

the properties to the Development Department for whatever action may be taken under derelict sites or vacant lands legislation.

**Q.68 COUNCILLOR ANDREW KEEGAN**

Is DCC management aware that commercial premises are being used by homeless people, young and old and are at best not documented and that these homeless people are being charged to reside within these commercial premises with little or no facilities, sleeping on office chairs, under desks and on the floor, and are forced to beg on the streets to pay to whomever is in charge of these premises. I have counted 4 number premises this weekend and have confirmed that the people are being charged to keep out of the cold.

**CHIEF EXECUTIVE'S REPLY:**

Dublin City Council and the Dublin Region Homeless Executive are currently seeking further opportunities to provide an additional 100 hostel beds in the city to address the needs of people experiencing homelessness.

Has Dublin City Management noted and consulted with the Dept. of Communications, Climate Action & Environment and the Dept. of Transport, Tourism & Sport that within the Ministers' **Rebuild Ireland Proposal** that no mention within the proposal of concrete plans to build transport infrastructure for the North Side of our city, (**not proposals but definite dates to turn sod**) where there is a veritable transport black hole from the Eastern Sea Board to Blanchardstown and northwards

out to the Fingal communities and has DCC advised the Minister that under no circumstances should there be thousands of homes or business premises built or proposed to be built, along the M1, M50 and the M2 transport corridors, without provision of proper high-speed transport, underground or over ground, infrastructure before any construction of homes and/or business premises. And that the proposal to wait until 2030 for any transport to be considered for the North Side of Dublin and the communities in Swords and Navan is not sustainable.

**CHIEF EXECUTIVE'S REPLY:**

The Action Plan for Housing and Homelessness, launched in July 2016, is part of the Government's "Rebuilding Ireland" Programme. It concentrates on ways of tackling the housing shortage and addressing homelessness, and complements other Government strategies such as the National Transport Authority's (NTA) 2035 strategy. The promotion and implementation of these transport strategies are included in the City Development Plan. Examples include the proposed Metro line from the City Centre, through Drumcondra and Ballymun, the new Luas line linking north-west to the Maynooth line at Cabra and proposed Bus Rapid Transit Line from Swords and Blanchardstown through the northern suburbs to the City Centre. The Phoenix Park tunnel rail link via Drumcondra opened recently. In addition Dublin City Council submitted an application under the LIHAF (Local Infrastructure Activation Fund) to the DHPLG, for road infrastructure in the Belmayne-Clongriffin LAP area and in Ballymun, which is currently under consideration.

Generally what happens when we need to make changes to the Scheme is that Allocations and Transfers put together a draft Scheme and present it to the Housing SPC. Once agreed by the Housing SPC the Draft Scheme would go to the full City Council for adoption.

The current Scheme is due to be reviewed as provision has to be made for the Housing Assistance Payment scheme which is due to commence in Dublin city on the 1<sup>st</sup> March 2017.

To ask the Chief Executive: What is this council's policy regarding dual tenancies when both parties no longer can or want to live together. Will the council allow them to make two separate transfer applications?

The Council has previously registered their interest in acquiring these properties. However, there are significant legal issues relating to title which would need to be resolved prior to any acquisition.

**Q.85 COUNCILLOR PAUL HAND**

To ask the Chief Executive why did the DCC Housing Department give me an incorrect and misleading answer to one of my Council Questions (Question 42, January 2017 South Central Area Committee) where they stated no Part 5 housing units were refused in the South Central Area by DCC over the past 10 years. I have asked previous questions regarding Clancy Quay and Clancy Barracks, Islandbridge and was told that of the 475 housing units built at those locations, DCC refused the 10% Part 5 accepting a financial contribution instead.

**CHIEF EXECUTIVE'S REPLY:**

Section 96 of the Planning and Development Act 2000-2002 outlines proposals as to how an applicant can propose to comply with Part V. Under Section 96 (3)(b) of the Act, a payment of an agreed amount in lieu of units can satisfy Part V compliance. Therefore, Part V was not refused in the South Central Area but rather another option was utilised in this instance in order to comply.

To respond to the varying needs of persons requiring homeless accommodation, there are different categories of homeless accommodation services funded via DRHE:

1. Supported Temporary Accommodation (STA): stable placements for up to 6 month for persons/ families with higher support needs, with staff competent to respond to and manage higher support needs, and support people into housing.
2. Temporary Emergency Accommodation (TEA) stable placements for up to 6 month for persons/ families with lower/ accommodation-only support needs, with staff who are competent to respond to and manage lower support and needs and support people into housing.
3. Private Emergency Accommodation (PEA) (either hotels or non-hotels): provides accommodation placements with lower support levels, either visiting or on-site.
4. One Night Only Accommodation: provides accommodation placements with lower support levels, either visiting or on-site.

The cost in 2016 of providing emergency accommodation in 45 services was €21.2m.

**Q.94 COUNCILLOR CHRISTY BURKE**

To ask the Chief Executive if DCC will put in place a dry hostel free of alcohol and other substances and if units for couples be also put in place at homeless hostels.

**CHIEF EXECUTIVE'S REPLY:**

Dublin City Council and the Dublin Region Homeless Executive are currently seeking further opportunities to provide an additional 100 hostel beds in the city to address the needs of people experiencing homelessness.

There are already a number of emergency accommodation services that are funded through DCC's section 10 funding that provide units for couples as shown in Table 1.1. Supported Temporary Accommodation (STA) services provide supports onsite for people dealing with alcohol and other substances abuse but have policies in place where by such substances cannot be consumed on site. This also applies to Private Emergency Accommodation (PEA). Temporary Emergency Accommodation (TEA) services provide units that are free of alcohol and other substances.

the collections and programmes of The National Concert Hall and Chester Beatty Library.

Spoken word artist Stephen James Smith is working with a range of other artists, engaging communities from both theatre and Traveller backgrounds through spoken word and poetry. Musician Sam Kavanagh is working through music and film with 10-14 year olds from both Irish and Filipino heritage based in the Bosco Youth Centre. They are working on mapping their area through sound and will both make a film and compose the soundtrack. Funding

Funding has been secured to continue with the National Neighbourhood Project in each of the 5 Areas of Dublin City Council, working again in collaboration with the Area Offices, City Arts Office, Dublin City Libraries and the 8 National Cultural Institutions in Dublin on projects that are lead with community groups and artists working collaboratively on matters important to them. Groups will be invited to join in from March 2017 onwards.

**Q.108 COUNCILLOR HAZEL DE NORTUIN**

To ask the Chief Executive what is happening to address the dumping and burning in Labre Park? This has been ongoing for a couple of years now with no evidence of it been addressed with the entire residents been held to ransom because of the actions of one or two. It is my belief that individuals causing this have been reported to DCC.

**CHIEF EXECUTIVE'S REPLY:**

Issues of dumping and burning of waste have been ongoing in Labre Park for many years. In 2016 DCC received 3 anonymous complaints regarding burning of waste at the site. DCC's Anti-Social Behaviour Policy requires that complainants give their name and address on condition of confidentiality. Without complaints and/or evidence relating to the persons who are involved in anti-social behaviour Dublin City Council cannot proceed with action.

Nonetheless, in view of the evidence of dumping and burning at the site, the Traveller Accommodation Unit engaged in a targeted operation with Waste Enforcement and An Garda Síochána and actions from this operation are proceeding. There are further, planned waste enforcement operations for 2017 to respond to the ongoing reports of dumping and fires at the site.

There have been regular clear-ups of dumping at, and in the vicinity of, the site. This is likely to continue in 2017. As requested by residents and the Advocacy group, large boulders were placed in an area identified as being used for burning and other site works are planned to address estate management issues.

**Q.109 COUNCILLOR HAZEL DE NORTUIN**

Has anyone, group, developer, individual expressed any interest in the lands around the De la Salle school in Ballyfermot for Housing, recreation, leisure or any developments? Has DCC agreed to acquire any of these lands?

**CHIEF EXECUTIVE'S REPLY:**

The Council are interested in acquiring lands which are suitably zoned for residential purposes. I note these lands are zoned to provide for institutional, educational, recreational, community, green infrastructure and health issues. Any change of use of these lands would require consultation with the Planning Authority as per the City Development Plan.

**Q.110 COUNCILLOR JOHN LYONS**

To ask the Chief Executive to provide this councillor with the city council guidelines regarding the assessment of bedroom requirement for families living in temporary emergency accommodation, if such guidelines exist; and if not, to provide this councillor with the protocol and standard practice city council officials use to ensure that siblings nine years of age and older have separate bedrooms.

**CHIEF EXECUTIVE'S REPLY:**

Properties contracted to Dublin City Council for the provision of emergency accommodation are subject to the standards and conditions set out in the



“Information and Guidelines for Service Users and Service Providers” which came into effect in 2016.

Dedicated self contained housing units ensure separation of living space for parents and children when families are housed via social letting our Homeless Assistance Payment (HAP). In emergency accommodation, it is not possible to provide dedicated self contained housing units, therefore adults and children are sharing individual sleeping space within their own unit of emergency accommodation, whilst the families work on an exit from homelessness into housing.

**Q.111 COUNCILLOR CIERAN PERRY**

In relation to illegal dumping can the Chief Executive confirm the tonnage collected in the council area for the past 5 years?

**CHIEF EXECUTIVE’S REPLY:**

It is not possible to provide a comprehensive figure in respect of the question as not all illegally dumped waste is isolated from other waste before it is transferred to an authorised facility for disposal. Illegally dumped waste may be combined with other street cleaning and litter bin waste before transfer from waste management depots for disposal.

It has previously been estimated that the tonnage of illegally dumped waste collected and disposed of by Dublin City Council was approximately 2600 tonnes in 2014/15. It is estimated that the figure may rise by up to 10% for 2016/17.

**Q.112 COUNCILLOR CIERAN PERRY**

Can the Chief Executive list the organisations working in the homeless area which receive funding from the Dublin Region Homeless Executive and the amounts allocated per organisation?

**CHIEF EXECUTIVE’S REPLY:**

The attached table outlines the organisations working in the homeless area and the amounts paid Quarter 3 2016 and estimated budget for 2016.

Funding allocations are made on an individual project or service basis as opposed to funding allocations to an organisation. The funding allocations are made under Section 10 of the Housing Miscellaneous Provisions Act 1988 with the Department of Housing, Planning, Community and Local Government recouping up to 90% expenditure with the four Dublin Local Authorities sharing the balance by agreement.

As agreed by the SPC there will be no further changes proposed to the scheme until this report is brought to the SPC for discussion. As soon as this report is completed I will forward a copy to Councillor Perry.

remaining 23 units, for which demand was confirmed are now unlikely to complete for various reasons including in some cases the high acquisition and ongoing costs

While staffing levels and associated costs will continue to be carefully managed, reviews are taking place in a number of areas including Housing Maintenance and Cleansing Services, which, if agreed, will result in greater efficiencies and recruitment in certain key areas.

That Dublin City Council try & come up with a solution to the ongoing littering at the public seating at Ballyfermot Road opposite the Ballyfermot Credit Union every night / morning the area is littered with waste from the adjoining take-aways. Residents are deeply annoyed with this ongoing problem and are looking for some solution to the problem, can the bin be located right beside the benches & additional signage / cleansing done to deter waste at this location.

**CHIEF EXECUTIVE'S REPLY:**

Waste Management Services have the Ballyfermot Road cleaned on a daily basis and we will ensure that particular attention is paid to the area at the public seating opposite the Ballyfermot Credit Union. There is a litter bin a few feet away from this public seating which doesn't cause any obstruction to the people availing of this seating. The adjoining take-aways will be approached and reminded of their responsibility to keep the area outside their premises as free of litter as possible.

**Q.134 COUNCILLOR ANDREW MONTAGUE**

Will the Council install LED lighting on Coolatree Road, to replace the current lighting. The residents are concerned that the current lighting is too low for their street.

**CHIEF EXECUTIVE'S REPLY:**

There is no public lighting improvements programme for 2017. However, Dublin City Council Public Lighting Services are replacing all the existing low pressure sodium (orange coloured) lighting throughout the city with LED lights over the next few years and the existing lighting on Coolatree Road will be included in this replacement programme. Until such time as the existing lights on Coolatree Road are replaced with the LED lights, we will continue to carry out routine maintenance works on the existing lights and will replace existing lamps as required.

**Q.135 COUNCILLOR ANDREW MONTAGUE**

Will the Council make changes to the Parking Tag system to allow people park until the motorist returns to the car and turns the tag off? The current system requires the motorist to estimate how long they will require parking, which they can top up as needed. Some would prefer just to turn the parking tag on when they park the car, and turn the tag off when they return.

**CHIEF EXECUTIVE'S REPLY:**

The Parking Tag system functionality to some extent mimics the process which applies to motorists making payment and at a Pay and Display Ticket Machine. Payment is made for the required period of parking and may be topped up as and when required if necessary. Parking Tag enhances this process by way providing a reminder at the appropriate time that a period of parking is set to expire. The functionality described would require motorists to ensure that they initiate parking and also remember to cease parking through Parking Tag at the appropriate time, without the benefit of any reminder to do so. It is likely that such a fundamental change to the system would lead to considerable error by motorists who inadvertently pay for parking while not actually parked, having forgotten to terminate their parking on Parking Tag when returning to their vehicle.

It is not possible to include this functionality in the Parking Tag system in its current configuration. It is intended to commence a tender process for provision of the Cashless Parking Payment System for on-street parking shortly, commencing with Technical Dialogue with potential service providers and the feasibility of addition of this functionality can be discussed and considered further at that time.

**CHIEF EXECUTIVE'S REPLY:**

At present there is an application for a School Warden for the Educate Together School, Glasnevin. The application has been recommended and it has been given a positive decision by the Traffic Advisory Group at their last meeting in December 2016. The matter is now with the Gardai as part of the statutory consultation process. In the event of the Gardai giving a positive reply a School Warden will be put in place as soon as possible.
