483 **Councillor Tina MacVeigh deferred from the January Meeting**

This Area Committee supports the occupation of Apollo House by housing activists and calls on Dublin City Council management to implement the following motion agreed at the city council meeting on 10th November 2014:

That this Council open an 'Unused Properties Register'. The owners of private properties that have been unused/empty for a period of more than six months (as per CSO Census 2011 and other official statistics) will be required to register their intention for use with Council. Where these properties remain idle for a period exceeding six months of registration date or where Council is not satisfied with intended use, by the powers granted to it under Section 213 (2) (A) of the Planning and Development Act (2000), this Council will immediately requisition these properties for immediate use as emergency housing, paying no more than a nominal transaction fee to the owner

489 **Councillor Michael Mullooly**

This Area Committee welcomes the introduction of the Bulky Household Waste Collection Service. This service is for items that are too large to be collected by a regular waste provider and is an important initiative to prevent the illegal dumping or burning of this material. As the system has been successfully launched, this Area Committee recommends that the service be reviewed to reduce the number of items that can be collected with a new pro-rata charge. When more than five items are collected a new charge is levied and this makes the cost prohibitive. This Area Committee recommends that the list of items suitable for collection be extended and the service target certain areas with free collection days.

To ask the Area Manager to support the redevelopment of Labre Park and recognising Traveller Ethnicity. I am asking the Area Manager to allocate some of the lands between the canal and Labre Park for the development of a horse project. This will facilitate the horses currently in Labre Park and critical to Traveller culture to be accommodated during and post redevelopment.

DISCRETIONARY FUND MEETING

A meeting has been scheduled for Tuesday the 31st of January 2017 in Eblana House, Marrowbone Lane, to discuss a list of proposed area projects for the 2017 allocation of the Discretionary Fund. **Time to be agreed with the Members.**

Community Grant Scheme 2017

Work has been completed on the Community Grant Scheme and the Informal Education Grant Schemes.

SOUTH WEST INNER CITY AREA OFFICE REPORT

New Public Park, Cork Street

A Part VIII Planning Application for a 0.6 hectare neighbourhood park on the site of the demolished Chamber Court and Weavers Court flats on Cork Street was agreed at the December 2015 City Council meeting. A preferred contractor has been selected and it is expected that site works will commence next month.

Dolphins Barn

A Public Realm Improvement Plan for Dolphins Barn is being prepared at present. The cost associated with the plan is provided for in the 2016 Discretionary Fund. A very well attended community workshop took place in St. Andrews Community Centre on 28th November. Councilors will be informed of a second community workshop which is expected to take place next month.

Crane Street/Sugar House Lane

It is planned to enhance pedestrian access along this important and busy tourist route. The works include the widening of the existing footpaths and the narrowing of the carriageway. A Part VIII planning application was agreed at November City Council meeting with construction likely to take place this summer/autumn.

Francis Street

A consultant has been appointed to facilitate the preparation of a Part VIII planning application for the Francis Street Environmental Improvement Scheme. Stakeholder meetings with local residents and businesses are due to take place next month.

St. Luke's Church

Enabling work commenced in late September last year in relation to the conservation and adaptive reuse of St. Luke's Church. Dublin City Council will, at the same time, create a small urban park in the north graveyard (facing St. Luke's Avenue) and carry out improvements to the south graveyard (access via Newmarket Square). The tendering process for the park/graveyard works is underway and I expect to have a timetable shortly.

Michael Mallin House

Works to convert 4 bedsits into 2 x 1 bedroomed units are due to commence in early January with an expected completion date of March 2017. Similar work is ongoing in Basin Street to convert 8 bedsits into 4 x 1 bedroomed units.

Public Light Improvements Thomas Street-James Street

A programme to install 48 heritage-style lighting columns on Thomas Street and James Street has commenced and is expected to be completed in March. The programme forms the last part of the Thomas Street and James Street QBC Improvement Works.

Shopfront improvement Scheme 2017

A callout for applications for the Shopfront Improvement Scheme for businesses in the main commercial streets of The Liberties will be made by the end of January. The 2016 scheme supported 16 projects throughout the area, and it is hoped to attract a similar take-up in 2017.

Promoting The Liberties to Small Business

A series of small business guides and a retail prospectus have been developed to highlight the attractiveness of The Liberties as a location for small and medium enterprise, niche shops, cafes and restaurants and tourism-focused businesses. The guides are hosted on the Business Pages of www.libertiesdublin.ie

Tourism Boost for The Liberties

2016 proved to be a bumper year for visitors to The Liberties, Kilmainham and Inchicore and wider Dublin 8. Many of the city's major attractions are located in this area of the city including the Guinness Storehouse, Kilmainham Gaol, IMMA and St Patrick's Cathedral. Preliminary figures suggest visitor numbers rose across the board last year, with Guinness Storehouse recording 1.6m visits, almost 600,000 to St Patrick's and 100,000 to the new Teeling Distillery at Newmarket.

2017 will see new attractions and further developments in the area including Pearse Lyons Distillery on James Street (opening spring 2017) and a new visitor attraction at John Street. A number of applications are live for hotel and accommodation developments in the area, while permitted hotels are under construction at Mill Street and New Street.

St Patrick's Festival

The Area Office hopes to offer practical support to a series of events at Newmarket on 18th March as part of the St Patrick's Festival. A craft fair, talks and entertainment on the square is being planned by Teeling Distillery. In addition SCAO will be actively encouraging institutions and businesses in the area to 'go green' by floodlighting landmarks.

Liberties/South Inner City Community Update

Birds of Ireland Presentations

Eric Dempsey one of Ireland's leading ornithologist will deliver a number of workshops to local schools and scout troop in the South Central Area on the 25th of January 2017.

Community Connect

The South Central Area community development team will identify projects in the area that will benefit from Volunteer Ireland linking business and community together to take on enhancement projects locally.

Marrowbone Lane & District Resident Assoc

After recent environmental improvements to Marrowbone Lane flats. This resident association intend to carry on the improvements by involving residents and children in a planting scheme for the flats.

Love Yourself

14th February in St Andrews Community Centre – Working with Sports Partnership to encourage people to love themselves by taking part in Holistic Treatments, Marie Keating Foundation and other mind yourself treatments and activities.

Ceannt Fort

Work continuing with Ceannt Fort to celebrate the centenary of their housing estate. Playground refurbishment has begun and is expected to be complete in the next few weeks. Dublin City Council Architects have surveyed the area and made recommendations regarding the retaining walls.

Playgrounds in Jim Mitchell Park and Bluebell

Works to refurbish the playgrounds in Jim Mitchell Park, Inchicore and in Bluebell commenced on Monday, 16th January and are due to be completed by the end of February/beginning March.

CRUMLIN AREA OFFICE REPORT

New Children's Playground – Stannaway Park

Works to create a new children's play area in Stannaway Park are due to commence at the end of January/beginning February. This small play area will cater for young children between 2 and 7 years of age and will be natural in style to blend in with the grassland of the existing park. Play features will be constructed of natural materials and will be set into the landscape within gentle mounded forms. Seating will be provided as part of the works. The play area will be funded from the South Central Area Discretionary Fund 2016.

Improvement works at Cashel Avenue and Captains Avenue

Improvement works at Cashel Avenue and Captains Avenue, consisting of new parking zones, new footpaths and a plinth wall surrounding the green commenced on 16th January and are due to be completed by end February. The works are funded from the South Central Area Discretionary Fund 2016.

Brickfield Park

Works to install all weather pitch in Brickfield Park are progressing well. The synthetic carpet and shock pads will be laid this month subject to weather conditions whilst it is anticipated that works will be completed in February /March again dependent on favourable weather.

Bunting Park

The boundary hedging surround Bunting Park along Balfe Avenue was removed and replaced with new railings in December 2016. The works were funded from the South Central Area Discretionary Fund 2016.

Crumlin/Kimmage Community Update

Residents Groups

We are supporting the residents of various areas to start/restart Residents/Community Groups in order to support areas in environmental improvements, deal with issues, support family/youth projects etc across the area.

Blarney Park

Blarney Park allotment licenses are up for renewal. All license holders have been informed and dates for payments are set. Health & Safety issues have been identified and are to be addressed with allotment holders and Dublin City Council.

Age Friendly Actions

St Mary's Bowling Club, Crumlin and St James Bowling Club, James Street received new bowling mats under the SCA Age Friendly budget.

DMAP

Support offered to DMAP to continue work with people with disabilities in the Crumlin Area.

BALLYFERMOT AREA OFFICE REPORT

Ballyfermot Environment Improvement Project

A Public Consultation meeting regarding the proposed Ballyfermot Road Public Realm Improvement was held on 17th October 2016. The Consultants engaged put together their initial thoughts taking into account all that was discussed at the Consultation and these were reviewed on 1st December with the South Central Area Manager and local officials.

A number of residents were contacted following this meeting and a walk along the route took place on 8th December. The views expressed by these residents and at

the meeting of 1st December will now be taken into account by the Consultants and explored.

It is intended to further progress this matter and to consult with both Dublin City Council Internal Stakeholders and to have further public consultation when the Consultants have finalised their initial Report.

Ballyfermot/Drimnagh Community Update Bluebell Environmental Project

Bluebell environment group are working with the Council to erect a commemorative plaque at the entrance to the area where 16 trees to commemorate the executed members of the 1916 Rising were planted in 2016. Bluebell bulbs will be planted under the trees to restart the Bluebells for Bluebell Project which previously began on this site. It is hoped to secure the funding to complete this project in early 2017.

Ballyfermot / Chapelizod

The Council are working with the Cherry Orchard community to support the organising of the 2017 Summer Fair in Cherry Orchard. Various Dublin City Council sections and departments including Parks, Sports and Community Development will be engaged to support the project.

Springvale Allotment

The Council is in the process of renewing the existing allotment licenses. A draw will take place for the allotments in the coming weeks

Drimnagh

The Council is consulting with local Resident groups regarding the location of Welcome signs for Drimnagh. The cast iron signs will be erected at the three main entrance points to Drimnagh.

Crumlin/ Walkinstown Community Forum

The City Council will continue to provide ongoing support to the Community Forum. Staff from the Ballyfermot office and Eblana House will support the committee.

479 Councillor Tina MacVeigh

Noting:

- the historic importance of the Iveagh Markets;
- the lack of community amenities in the Liberties Village;
- the length of time the Markets have remained undeveloped and the contribution this makes to the severe dereliction of the area of special character of John Dillon Street and surrounds, this Area Committee requires that Dublin City Council should :

- 1) Fulfil its own mission to tackle dereliction and take back responsibility for the development of the Iveagh Markets including a consideration of acquiring the building if necessary/possible;
- 2) Commit and secure funding to develop the building within a two years as a central hub for community, cultural, social enterprise, tourism and heritage activities in the Liberties.

This redevelopment of Iveagh Markets should be addressed urgently as it affects the development of the surrounding area and impacts negatively on local communities.

We also agree to forward this motion, if agreed, to the next meeting of Dublin City Council for consideration'.

Order: Agreed without debate and to refer to the City Council Meeting. Report to Councillors.

480 Councillor Daithí Doolan

This Committee commends the residents of Tyrone Place on the recent report into dampness in the flats. That Dublin City Council compiles and publishes, within 8 weeks, a report outlining the best option for Tyrone Plane. The report will include exploring the options of DCC accessing finance to carry out refurbishment of the flats or detenating the flats and redeveloping the site.

Order: Agreed. The members suggested that DCC use fans/dehumidifiers to rectify the existing problems.

This Area Committee asks the Council to have the laneway at the rear of Balfe Ave, Walkinstown (Entrance opposite the Up's A Daisy Crèche on Somerville Park.) to be concreted. The surface of the lane way is very uneven and the residents in the area are quite elderly and I feel this is an accident waiting to happen. This laneway is also attracting a lot of dumping and if it is concreted also it would make it easier to try and keep clean.

That this Area Committee notes with concern that local drug and alcohol projects have not had any funding increases in nearly a decade (in fact they have had their funding hacked by nearly 50% in the same period), despite the fact that front line services have been seriously stretched in the intervening period. To improve social services locally and nationally we request that the Minister for Communities and the National Drugs Strategy increase funding by at least 10% to all locally funded projects through the HSE and to all Regional and Local Drugs and Alcohol Task Forces nationally by at least the same amount. Re: Site for the Development of Public Housing at Bonham/Island Street.

The site of the former Bridgefoot Flats complex (now demolished) has been vacant and mainly derelict now for a significant number of years. Under the previous Dublin City Development Plan 2011 – 2017 this particular area was zoned for residential and community use.

However under the current Dublin City Development Plan 2016-2022 the area has been zoned for open space/park/recreation.

The zoning for site currently grassed at Bonham St./Island St. has not been changed.

It is now proposed to develop the site at Bonham St./Island St. adjacent to the existing private apartment complex for much needed public housing and to hand over the site at Bridgefoot Street to the Parks Department to develop a Park and allotments in consultation with the Local Community.

Therefore we are seeking approval of the South Central Area Committee to progress this integrated proposal

- a) Develop the grassed area on Island St./Bonham St. as quality apartment for public housing. Consideration will be given to some local transfer list applicants for re-housing into these new apartments when constructed.
- b) Develop the existing vacant site of the former Bridgefoot Street flats complex for a park/open space and allotments.

If approved we would intend to immediately move towards a Part 8 planning proposal for the Bonham St./Island St. site including local consultation etc. and request the Parks Department to move towards the development of a plan for the other larger site again with full local consultation.

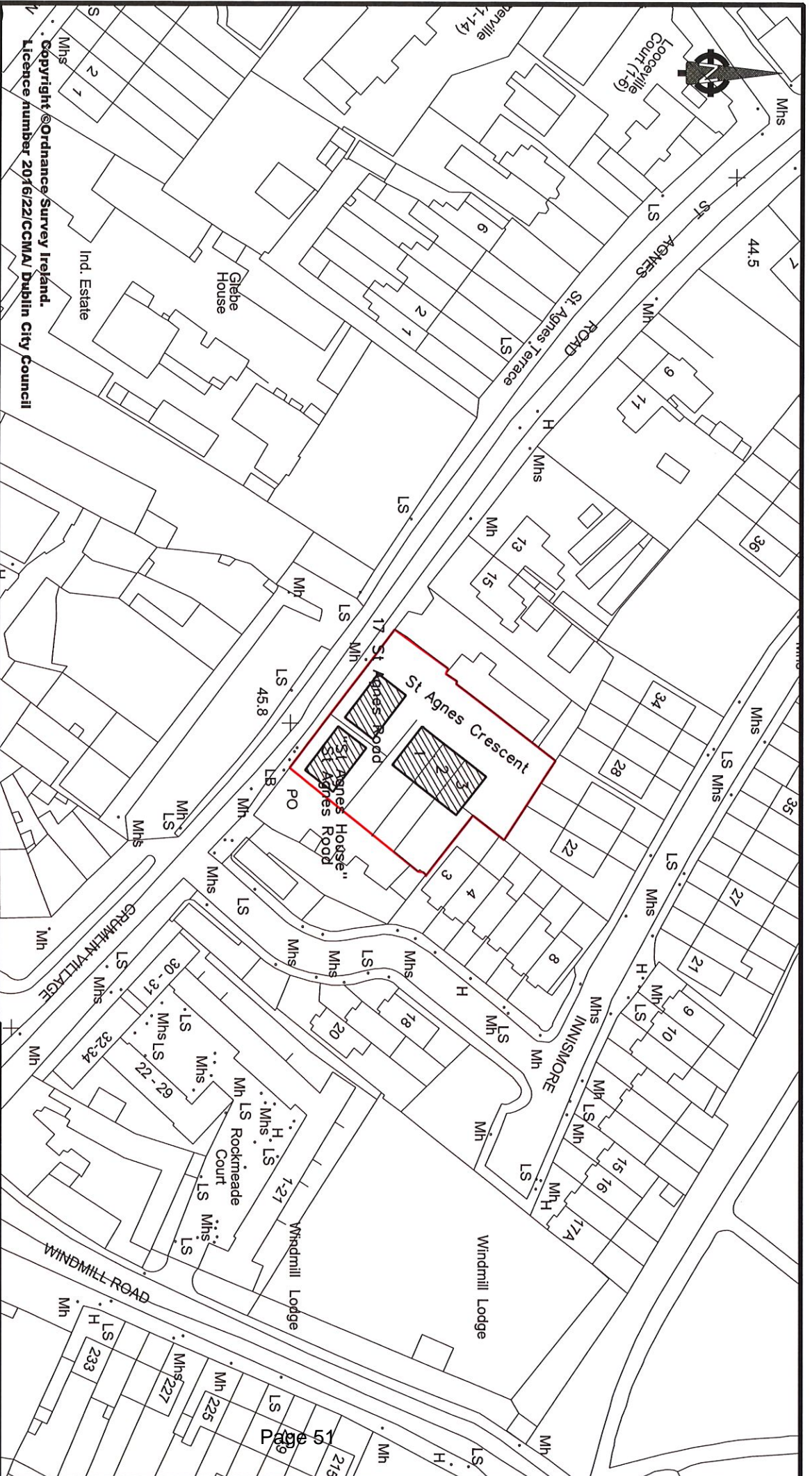

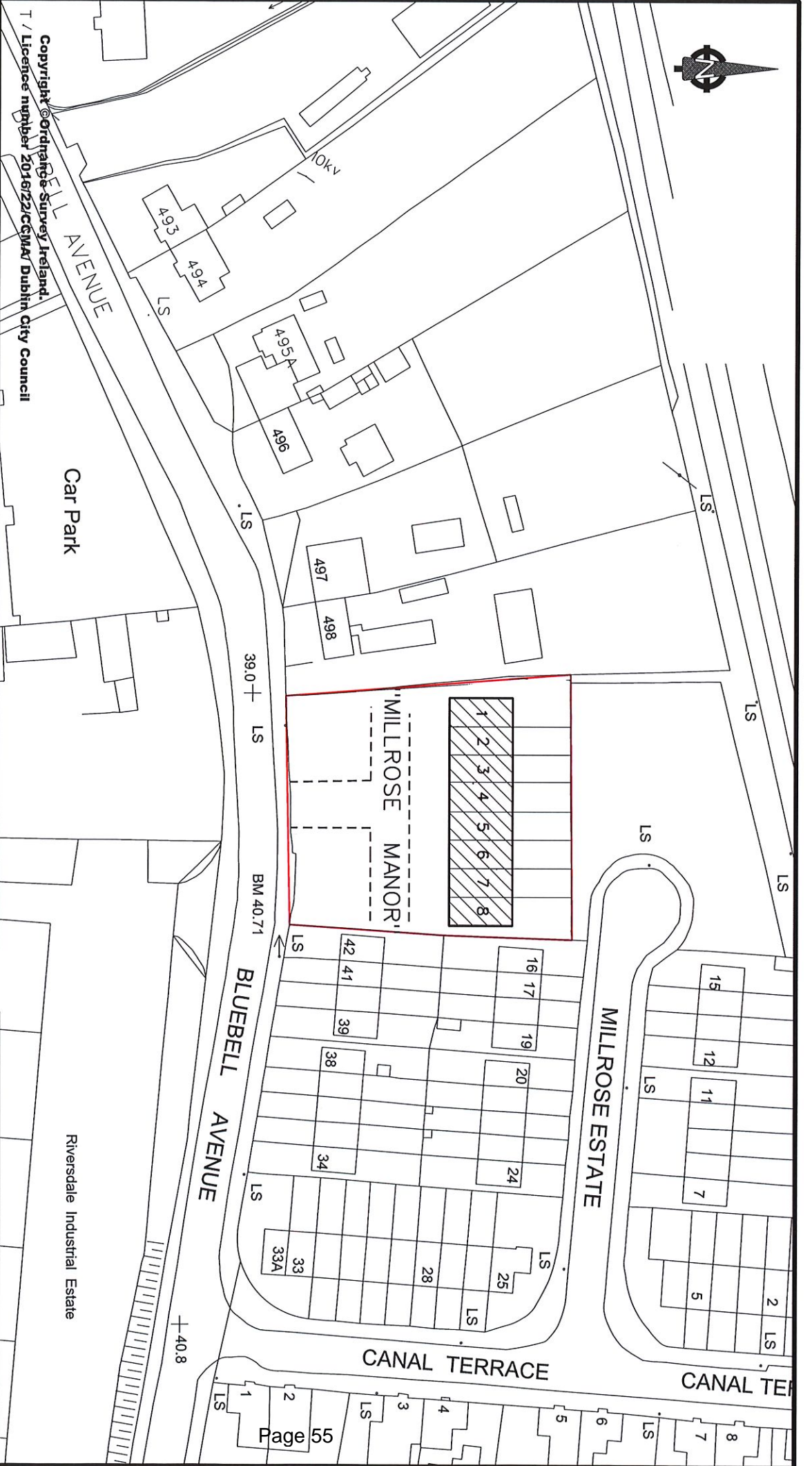

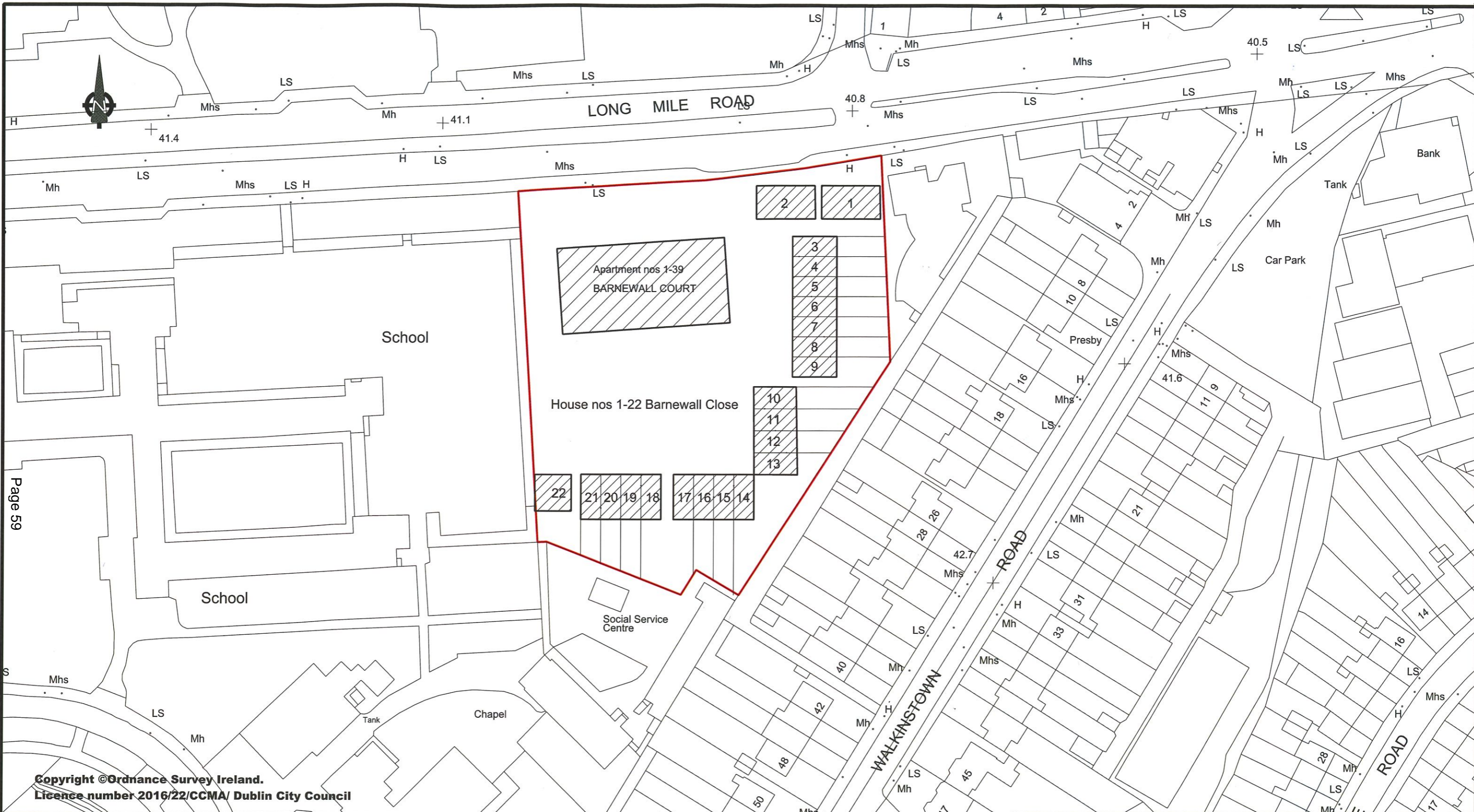

Operation Transformation 5K Run

This event will take place on Saturday 18th February in the Phoenix Park. It is open to everyone and more information is available on the TV Show's official website. DCSWP will be promoting the event via social media in the days leading up.

Ballyfermot Swimming & Water Sports sessions continue each Monday from 5-6pm in Sports & Fitness Ballyfermot. A number of DCSWP Sports Officers are involved. The programme is open to referrals from the local welfare officer. The Monday pool sessions have been running since March 2016 and cover swim technique/fitness, water safety, snorkeling and sea swimming outings in the Summer. Participants must have a good baseline standard of swimming as the training is of a high intensity.

Opportunities are available for those interested to progress onto a Pool Lifeguard Course and achieve certification in this area (7 of our participants are taking this course this month – a fantastic achievement!). This may, in turn, open up employment prospects for them. However, the focus of the programme is to use the experience of successful candidates within the group in a peer to peer leadership model in order to sustain success.

School Rowing Ballyfermot

In September, St. Louise De Marillac NS & St. Raphael's NS will begin a year long rowing programme with Dublin City Council Staff in the Dublin Municipal Rowing Centre, Islandbridge. They will be joining other local schools (Mary Queen of Angels & Caritas College), who have enjoyed use of the facility and participation in the sport for almost ten years. If anyone has interest in getting their local groups or individuals involved in rowing, please contact DCSWP Sports Officer Gareth Herbert.

Ballyfermot Ladies Cycling Group

This is an open programme for anyone interested in cycling and achieving a good level of fitness in a relaxed and friendly environment. The cycling group meets at Ballyfermot Sports & Fitness on Fridays at 10.30am. The aim is primarily to get participants comfortable and confident on the bike and safely cycling in groups. The medium term goal is to build up to a long cycle of 40km during the Easter break.

The Liberties Club (Youth Justice Project)

The local DCSWP Sports Officer will be assisting youth workers from The Liberties Club to provide a soccer drop-in every Monday night from 8-10pm in St. Catherine's Sports Centre. This acts as a form of outreach to young people in the area and the hope is that they will join the club and get involved in activities on an ongoing basis.

TULSA Programme South City Family Support Services

The DCSWP Sports Officer is working with the South City Family Support Services TULSA to help build resilience for a group of young people aged 8 to 12 years of age, allowing them to find their voice.

The group will be taking part in a 12-week Water Confidence / Snorkelling programme taking place in Crumlin Swimming pool on Tuesday afternoons from 3-4pm. The Programme will run from January to April.

Teen Gym - Introductory Programme

The DCSWP Sports Officer, with the support of the St. Catherine's Gym staff, has organised another rolling four week block of Teen Gym sessions for new participants. This introductory programme is held on Saturday afternoons after the gym is closed to the public. The teens are given exclusive access to equipment and instructor supervision.

Once teens have completed these four weeks they may then use the gym after school on weekdays and up to 6pm daily during the school holidays. We constantly have new teens signing up for this programme and we have also retained a large number of teens who have progressed from Teen Gym to a full gym membership.

The cost of Teen Gym is €2 per session and is open to any teen from the age of 13 – 16 years. Teen Gym also operates every Wednesday & Thursday in Clogher Road Sports Hall (St. Kevin's College).

Fountain Youth Project/Foróige DAN Youth Justice Project Mid-Term Programmes

The DCSWP Sports Officer will be assisting the two projects with their school mid-term activities. Groups will be travelling to the National Aquatic Centre and to Skill Zone in Stillorgan.

Foróige DAN Youth Justice Project - Snorkeling Programme

The DCSWP Sports Officer is facilitating and assisting the project by delivering an introductory pool snorkelling programme on Tuesday evenings in Crumlin Swimming Pool. The young people need to log 5 open water snorkeling sessions, with their initial session being planned during the February mid-term break. The group will be working towards the Irish Underwater Council's 'FUNdamentals' certification.

Liberties Community Training Centre Programme (CDETB)

The DCSWP Sports Officer will be working with approx 50 young people aged 16 to 21 years to achieve a range of certificates. The young people are currently working towards FETAC Level 3/4 certification covering four distinct areas being Sport & Leisure, Hospitality & Tourism, Woodwork and Metalwork. To help keep the group active and achieve the relevant skills they will be taking part in gym sessions and outdoor activities. The Sports Officer will also assist in getting students certification in First Aid and Safeguarding. The current crop of students expects to graduate in July.

SICCCA Life-skills Health & Lifestyle Programme

The DCSWP Sports Officer will be working with a group of 12 adults on a year long life-skills FETAC Level 3/4 Programme. To help with keeping the group active they will be taking part in gym sessions in addition to outdoor trail walks.

Club Support

The local DCSWP Sports Officer supports and works with the coaches from *St. Catherine's Boxing Club* & *Tae Kwon-Do Club* who both train on various evenings in St. Catherine's Sports Centre and are always willing to take on new members. Likewise with *Liberty Saints Rugby Club U13's & 17's* who train on Tuesday & Thursday nights in Liberty Park on Basin Lane.

Annual 5th & 6th Class School Soccer Blitz

This 5th & 6th class school soccer blitz has been running for the past 12 years in St. Catherine's Sports Centre. Ten of the local primary schools attend with representative teams from both the 5th and 6th Class streams. The programme is a joint initiative between the JLO Garda in Kevin St., the DCSWP Sports Officer and the FAI Football Development Officer. This year the girl's blitz will take place on Friday 3rd March from 9am to 3pm, with the Boys blitz taking place on Monday 6th March. Approx. 300 young people take part in this event.

Safeguarding Training

The DCSWP Sports Officer will be facilitating three 'Safeguarding 1' courses during March and April for local community clubs, volunteers and coaches.

A 'Safeguarding 2' Children's Officer course will be taking place in St. Catherine's Sports Centre on Monday 27th February and a 'Safeguarding 3' Designated Liaison Person's course will be taking place in St. Catherine's Sport Centre on Monday 6th March.

Swim Ireland Participation Programme

The DCSWP Sports Officer team has been working with the new Swim Ireland Participation Officer to increase the usage of the Dublin City Council pools.

A 6-week 'Learn to Swim' pilot programme will commence in Crumlin Swimming pool for 12 to 17 year olds from the Liberties and Crumlin area. The programme is scheduled to commence the first week of March on Tuesday and Wednesday evenings from 7pm to 8pm.

A pilot programme targeting local men's sheds will have an open swim on Friday afternoons from 3pm to 4pm also in Crumlin Pool. This is scheduled to commence in early March.

Bluebell Change For Life – This 8 week general health and fitness based programme consists of a health check, body measurements, weekly weigh-ins, nutrition advice and then final reassessments. Three fitness classes are also provided as part of the programme - Zumba on Mondays from 7-8pm, Walking/Jogging on Wednesdays from 6-7pm and Step Aerobics on Thursdays from 7-8pm. All classes take place in Bluebell Community Centre. This programme is open to all adults in the local community.

Fatima Change For Life – As above. Three fitness classes are also provided as part of the programme – Step Aerobics on Mondays from 6-7pm, Walking/Jogging on Wednesdays from 6-7pm and Circuit Training on Thursdays from 6-7pm. All classes take place in the F2 Centre. This programme is open to all adults in the local community.

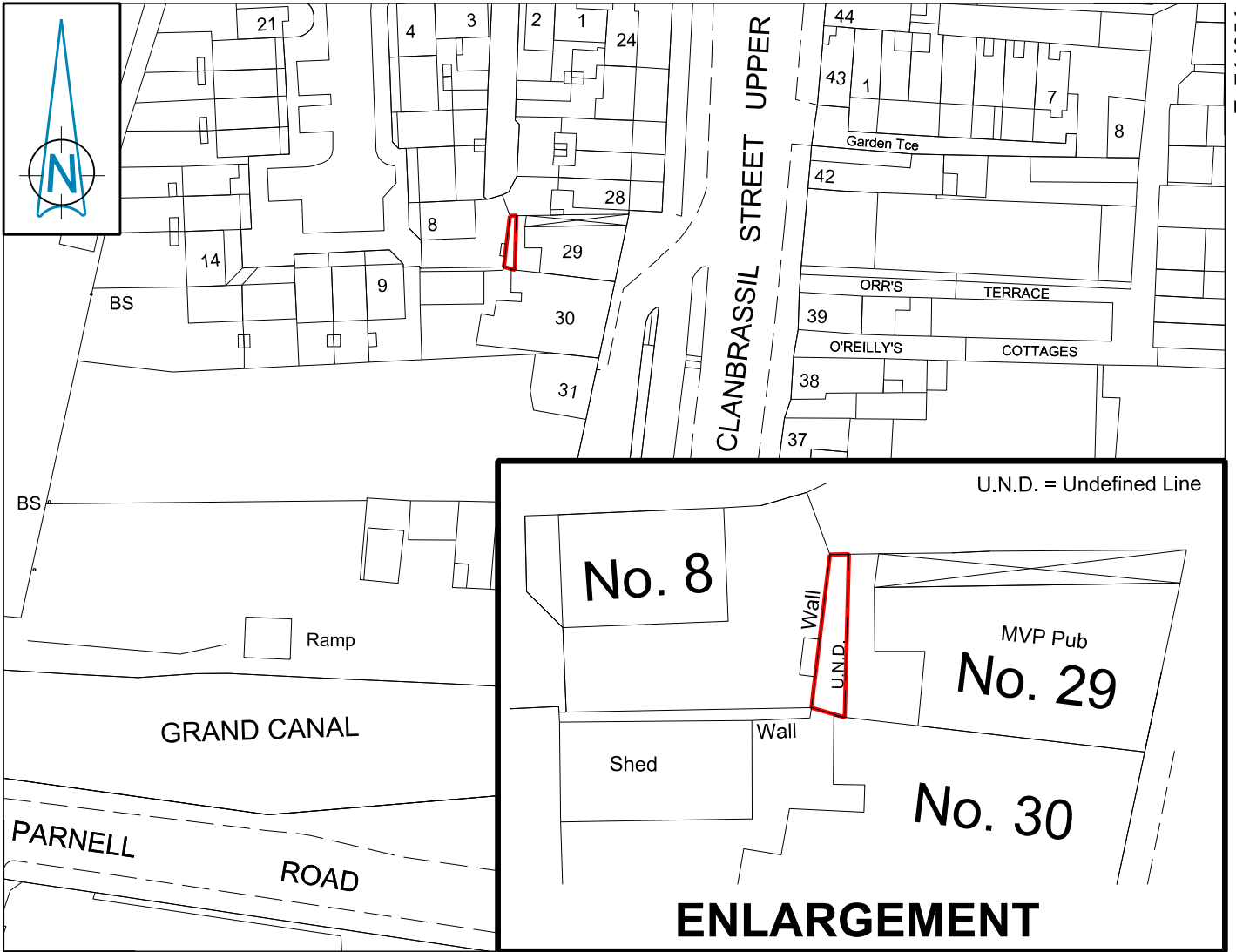
