Minutes by Paula Ebbs

The Chair welcomed the new PPN member Sarah O Neill and thanked Ciaran Reid for his contribution to this SPC.

The Chair informed the Sectoral members that all future meetings will be paperless and stated that they can now log onto Modern.gov to access all documentation in relation to the SPC or they can receive all information by e-mail. Sectoral members to contact the Secretariat Section.

1. Minutes of meeting held on 14<sup>th</sup> November, 2016

Action: Agreed.

### 2. Presentation on the Library and Archive Services – Digital Images Collection – New Online Service – Brendan Teeling, Deputy City Librarian

Brendan Teeling, Deputy City Librarian gave an overview of the new online service – Digital Images Collection. He stated that one of the things that the 1916 commemorations has done was to highlight the importance of the archival and local studies collections which will give the public access to the primary materials of history through publications, exhibitions, lectures and online publications.

In 2016 Dublin City Libraries began using a new cloud-based application called VITAL which will allow, to put in place, efficient systems to digitize, store, search and publish collections. The VITAL site is live and will begin promoting and publicising this new free resource shortly.

Action: Welcomed and Noted. E-mail link to Members.

The Chair took Item 3 and 4 together as elements of Cllr. Lyons's motion are included in the Dublin City Libraries Commemorations Programme.

### 3. Report on Dublin City Libraries Commemorations Initiatives 2017 – Brendan Teeling, Deputy City Librarian.

Brendan Teeling, Deputy City Librarian outlined a proposed list of projects and programmes for 2017. Building on the success of 1916 commemorations, the aim of the 2017 commemorations programme is to keep Dubliners connected to their own stories and their role in shaping the Ireland of 2017 and coming years up to 2022 when the Decade of Centenaries officially concludes. Based on the funding approved by the City Council some of the projects include the Commemorative Plaques Scheme, Historian-in-Residence, Women and World War 1, the 100<sup>th</sup> anniversary of the Bolshevik revolution etc.

**Action:** The Chair and Cllr. Lyons indicated that they wished to work more closely with the Library Service in relation to the development and delivery of the 2017 programme of events.

#### 4. Motion submitted by Cllr John Lyons:-

"As part of the decade of Commemorations, Dublin City Council to organise a series of public talks, lectures, panel discussions and exhibitions in 2017 to mark the centenary of the Russian Revolution, an event of world historical importance, exploring not only its initial successes and ultimate failures, bur exploring also the emancipatory achievements of the revolution such as granting women the right to vote and contest elections, the legalisation of abortion and the repealing of laws outlawing homosexuality; and to explore also the political and cultural links between Revolutionary Russia and Revolutionary Ireland during the period beginning in 1917" A working sub-group to be established from this SPC to liaise with Dublin City Council Libraries to assist in the creation of a programme of events.

**Action:** Motion agreed. All members are welcome to feed into and make suggestions to assist in the creation of a programme of events. The

Chair stated that a working sub-group was not required.

5. Motion referred from City Council meeting 9th January 2017:-

"This Committee calls on Dublin City Council's Sports Section to immediately suspend the excessive increase in the cost of the Passport for Leisure due to begin in January 2017, until Councillors are given an opportunity to discuss the issue. An increase of almost 100% for over 55's is unacceptable and such decisions should be made by the relevant SPC".

a) Motion submitted in the name of Cllr N. Ring, Cllr C. Perry, Cllr C. Cuffe

"Having regard to last Monday evening's Emergency Motion referred to this SPC in relation to the Passport for Leisure Scheme, this SPC agrees that the proposed price increase be cut by 50% for 2017 and that the remainder of the increase be deferred pending the outcome of discussions with the other Dublin authorities, benefiting but not yet participating in the scheme".

The Chair stated that due to a miscommunication Cllr. Perry's name was to be removed from this motion.

A detailed discussion took place regarding the pricing structure for the Passport for Leisure Scheme. Jim Beggan, A/Executive Manager outlined the operation of the Passport for Leisure Scheme since its inception in the mid 2000's, its pricing structures, the services that are available and the current proposed pricing increases. Issues were raised by members regarding the % increase in the Scheme and notification to members of the increases. Members also stated their dissatisfaction that they were not informed prior to the price increases.

**Action:** Motion (a) passed. Management may bring a review of the Passport for Leisure Scheme to the SPC during the course of the year. E-mail members the old and revised prices for the Passport for Leisure.

**6.** Review of St. Patrick's Day Festival 2016 and an Advance Programme Overview 2017 (Referred from Commemorations Sub Committee) - Brendan Teeling, Deputy City Librarian.

Brendan Teeling, Deputy City Librarian stated that the inclusion of the Review of St. Patrick's Festival came about due to some members of the Commemorations Committee being unhappy with the coverage of the 1916 Commemorations in the St. Patrick's Day Festival. Following a discussion of which most members highly commended the Festival Board and some disagreed, the Deputy City Librarian stated that he would pass on the views of the members to the Festival Committee and the Commemorations Committee.

**Action:** Noted. Committee to be informed of what funding/support DCC provides to St. Patricks Festival. It was suggested that the Chair of this SPC should be invited to sit on the Festival Board for continuity / updating purposes for the Arts SPC.

7. Report on the New City Library at Parnell Square - Margaret Hayes, Dublin City Librarian

8. Report on City Arts Grants - Ray Yeates, City Arts Officer

The Chair thanked Cllr. Lyons and Cllr. Jackson for their involvement in the City Arts Grants applications process.

**9.** Verbal update on the Implementation of the Cultural Strategy - Ray Yeates, City Arts Officer

Ray Yeates, City Arts Officer updated the Committee on the National Neighbourhood Projects where the 8 National Cultural Institutions are working with City Neighbourhoods. He stated the delivery point for 2016 will be in February 2017. It is hoped to renew the National Neighbourhood Projects with the National Institutions. There will be a short review period for a week or two with everyone that has been involved. There is now an Advisory Committee in each administrative area of the city consisting of Libraries, Community Development/Area Offices, Arts Office and National Cultural Institution.

The Cultural Audit is split in two parts - Quantitative audit of cultural infrastructure which will conclude in the 1<sup>st</sup> quarter, the Qualitative audit will conclude before June.

The fellowships that were given to Business To Arts funding was provided by the City Council to build fundraising fellowships in four Cultural Organisations. The organisations chosen were – Dublin Theatre Festival, Helium Arts, Fishamble Theatre Company and Temple Bar Galleries. These organisations are in addition to building their own fundraising capacity to partner with community organisations to support their fundraising ability and it is hoped to have these community organisations chosen before the next SPC.

The EU funding unit will have 10 applications of which there is already a successful one in the North West Area. There will be a major workshop before the end of February within the City Council and for external organisations. Mattjis Maussen, an expert in EU funding will be leading this workshop along with several experts which will be a real opportunity to develop policy and strategy to increase EU funding into the city. Rather than confine the workshop to EU Cultural Funding, it will focus on funding that helps cities improve city experience for residents and visitors.

10. Report on the temporary use of the Boys Brigade pitches on the SDRA 12

Declan Wallace, Assistant Chief Executive informed the Committee that City Architects Department are currently working on a new revised schematic masterplan for the area to see what is the best way to configure the site to include a sporting facility in the South West Inner City. The temporary use of the site will also be looked at.

**Action:** A report will be brought to a future SPC when the new layout of the site is available.

11. Sport and Wellbeing Partnership Statement of Strategy: STRIDE 2017 - 2020

This is the first strategy of the Sport and Wellbeing Partnership which sets out its priorities for the next 4 years. The plan is progressive, ambitious and consists of 16 initiatives and 26 actions under 4 strategic goals which are – Places and Spaces, Programmes and Services, Promoting Sport & Inspiring People and Good Practice.

**Action**: Report welcomed and noted.

Sarah O'Neill, Crosbie Yard Residents Committee, made 2 enquiries (a) the maintenance of outdoor gyms (b) query on scrambler tracks. Both these queries come under the remit of the Parks and Landscape Services.

**Action:** Leslie Moore, City Parks Superintendent to contact Sarah directly.

12. Report on Columbarium Walls - Leslie Moore, City Parks Superintendent

Following on from a Motion submitted by Cllr Lacey regarding columbarium walls, a scoping exercise was carried out and it is believed there is potential to develop columbarium walls in some of the older burial grounds. Bluebell Cemetery presents the greatest opportunity for a Columbarium Wall. Parks Section will look at each individual location, examine costs and planning issues and report back to this SPC with a further update.

**Action:** A progress report on this matter will issue to a future SPC meeting.

#### 13. Management Update

Cllr Freehill requested a meeting to discuss Dublin City Council's plans for George Bernard Shaw House.

Cllr Byrne enquired as to when the Part VIII for Merrion Square Tea Rooms will be published. Also enquired on the Part VIII for the Chocolate Park.

The Chocolate Park Part VIII is complete, but there are some issues with the Developer. An update will be brought back to this SPC.

Cllr. Freehill requested additional information on the cultural and economic visit to Nice and the Dublin Civic Delegation to San Jose. Also enquired as to the position of the International Relations Working Group

## Terms of Reference for Advisory Group on Luke Kelly Statue

## History

- In 2004 Cllr. Christy Burke proposed a Statue of Luke Kelly to Dublin City Council. A Motion supporting this was passed.
- In 2009 Public Art Policy including the erection of statues was passed by Dublin City Council.
- In 2015 The Lord Mayor through the use of these guidelines and with the Public Art Manager support, Chaired a competition to commission a statue of Luke Kelly

## History Cont.

- A competition was run and each artists shortlisted produced a maquette. After consideration by the panel (including The Lord Mayor) Vera Klute was selected and her design approved.
  - In parallel The Lord Mayor kept the Kelly Family informed of developments.

## Finance and Kelly Family approval

- No budget has yet been allocated to the Vera Klute design. A combination of finance from Docklands, City Council funding and Crowd
   Funding is proposed
  - The Kelly Family were in the main unhappy with the design, the location proposed in Docklands and any form of crowd funding

## John Coll (Artist) Statue of Luke Kelly

- Meanwhile a Statue of Luke Kelly was privately commissioned, completed and offered to Dublin City Council in 2016
- As with all gifts of this nature it was put before the Arts and Cultural Sub Group.
  - No decision was made as the Vera Klute commission was not resolved. An Advisory Group was proposed.
  - The SPC formed an Advisory Group to consider the options. (City Arts Officer, Public Art Manager, Cllr Áine Clancy, Róisín Lonergan (LECP Rep.) Anna O Sullivan (Butler Gallery)

## **Options**

- Commission no Statue as agreement not possible
- Accept both proposals and place at different locations
- Commission/Accept one of these Statues
- Honour Luke Kelly in some other way.

## **Advisory Group Process**

The Group seeks permission of the SPC to

- 1. Meet Both Artists and consider the aesthetic value of each proposal anew
- 2. Consult with residents and community groups as appropriate to hear their views
  - 3. Speak to Kelly family again about both proposals

## **Advisory Group Cont**

- 4. Consider the costs involved of all options
- 5.Pay particular attention to the fact that an artist was selected and is now in 'limbo' awaiting a decision.
- 6. Make recommendations to the SPC in July 2017.

#### Molly Malone by Jeanne Rynhart

The sculpture of Molly Malone by Jeanne Rynhart located on Grafton Street Lower, which was gifted to Dublin City Council in 1988 as part of the Millennium Celebrations, had to be removed as part of the Luas Cross City works in 2013. Rather than placing the work in storage for the duration of the works, it was agreed by the Arts and Cultural Advisory Group and Strategic Policy Committee that it would be temporarily located outside St Andrews Church, St Andrew Street, to keep it on display for public enjoyment during the Luas Cross City works. The Railway Procurement Agency now Transport Infrastructure Ireland (TII) managed and paid for the relocation including undertaking important conservation works on the bronze and plinth.

The location has proved to be very successful, offering an excellent setting for the sculpture, and facilitating tourists to photograph and be photographed at it. There is no condition or agreed prerequisite in the Railway Order, governing the development of Luas Cross City to state that the sculpture has to be returned to its original location. Therefore, as the works on the Luas Cross City are nearing conclusion, it is proposed that the statue remain at its present location. This proposal is based on the success of the temporary location but also because there is no suitable location on Grafton Street Lower, which would facilitate viewers and tourists as safely as at the present location. Other sections including the South East Area Office, City Architects and Luas Cross City team were consulted in this process. The proposal was unanimously approved by the Arts and Cultural Advisory Group at its meeting on the 1st of February, 2017.

#### Report on the Implementation of the Cultural Strategy

#### **Dublin's Culture Connects**

#### 1. The Passion Project

Dublin City Council (via Dublin's Culture Connects, South Central Area Office, Dublin City Public Library Ballyfermot and Dublin City Arts Office) is partnering with Ballyfermot Community Civic Centre on The Passion Project. It will take place on 8<sup>th</sup> and 9<sup>th</sup> April 2017 in Ballyfermot and Cherry Orchard and is being devised, developed, delivered and performed in collaboration with the support of many local community groups.

Through co-creation with theatre company Brokentalkers, we will develop a contemporary, Ballyfermot/Cherry Orchard grown version of the Passion of Christ, The Passion Project.

The project will include a series of scenes from the well-known story throughout the area of Ballyfermot. The scenes will include dance, music, theatre and visual art. The story will be interpreted in such a way as to highlight some of the issues faced by a Ballyfermot mother living in fear for her children moving within the wrong circles, which can be potentially tragic, while at the same time showing the positive aspects that the community nurtures, such as the talent and facilities within the area. Community groups will consist of local schools, colleges, the men's shed, writing groups, women's craft groups, dance and drumming groups. There will be two professional actors headlining the performances.

Venues will consist of the local Equine Centre, the local college BCFE, the streets and local parks. The project aims to include a procession right through the town, stopping in these venues along the way for performances. Some of Ballyfermot's well known talent will be included in a "last supper" showcase event. BCFE film course students will be filming the project. The Project aims to be as inclusive as possible within the locality with a view to fostering new strong community, artistic and business relationships and developing future cultural projects in the area.

#### 5. Dublin's Culture Connects - The National Neighbourhood Events

Many of the Projects were brought to realization in partnership with Dublin City Council Area offices, City Arts Office, Dublin City Public Libraries, Dublin City Gallery The Hugh Lane and the 8 National Cultural Institutions in Dublin in collaboration with community groups and artists.

Events took place in The Abbey Theatre, the Chester Beatty Library, National Museum of Ireland, National Library of Ireland in Sandymount, Ringsend, Pearse Street, Finglas, Cabra, Drimnagh, Ballyfermot, Santry, Whitehall and Ballymun, North Inner City, Irishtown and online. #### 6. Fundraising Fellowship Dublin

After a competitive application process and convening of an assessment panel in 2016, four cultural organisations – Helium Arts, Fishamble, Temple Bar Gallery + Studios & Dublin Theatre Festival- were selected to participate in the Fundraising Fellowship, Dublin programme. Each of the selected organisations agreed to recruit a Marketing and Fundraising or Fundraising Fellowship to participate in a training and mentoring programme operated by *Business to Arts*. All organisations are currently in the final stages of recruiting Fellows with guidance from *Business to Arts* and *Dublin's Culture Connects*. These contracts will be confirmed in March with the training programme commencing in June 2017.

Each cultural organisation will be partnered with a local community organisation to develop their marketing and fundraisings skills. From April 2017 there will be an open call and application process for local community and cultural organisations to participate in this skills development & mentorship strand of Fundraising Fellowship, Dublin. The deadline for applications is Friday, June 16<sup>th</sup>.

#### 7. EU Funding Lab

The EU lab under Dublin's Culture Connects is working to follow themes and ideas from within Dublin City Council sections to secure EU funding applications.

To date, 1 application has been successful, 2 submissions are pending and 3 projects are in the pipeline. Dublin City Council staff from 7 sections are engaged in developing projects across economic and social development, planning, tech, arts, culture and enterprise. Development workshops are underway both internally within Dublin City Council and also with potential EU partners to develop ideas and advance further application opportunities. Relationships have been established with cities in Northern Ireland, England, Wales, Netherlands, France, Finland, Belgium, Denmark, Greece, Spain, Italy, Czech Republic, Germany and Poland to build EU partnerships.

#### MANAGEMENT UPDATE REPORT

#### **DUBLIN CITY PUBLIC LIBRARIES AND ARCHIVE**

#### **NEW POLICY/STRATEGIC ISSUES**

#### **Creative Ireland**

At the request of the Minister for Arts, Heritage Regional, Rural and Gaeltacht Affairs and under the Government's national Creative Ireland plan, a City Council Creative Ireland Team has been convened. The Team is led by Dublin City Librarian, Margaret Hayes and the members are:

- Margaret Hayes, Dublin City Librarian (Chair)
- Barbara Dawson, Director, Dublin City Gallery The Hugh Lane
- John Downey, Dublin City Council Licensing/Planning
- Charles Duggan, Dublin City Council Heritage Officer
- Mary Foley, Senior Executive Officer, International Office
- Ruth Johnson, City Archaeologist
- Alison King, Administrative Officer, Dublin City Council Events
- Brendan Teeling, Deputy City Librarian (Creative Ireland co-ordinator)
- Ray Yeates, City Arts Officer.

The team has held its first meeting and begun work on framing a DCC plan to deliver the objectives and actions under the programme.

#### PROGRAMMES/NEWS

#### Pilot national delivery Service for Inter-Library Loans

A pilot delivery system to handle the delivery of library items between thirteen Library Authorities, excluding the four Dublin services, has been in operation since July 2016.

Following on from this pilot, the LGMA, CCMA, and the Department of Housing, Planning, Community and Local Government, have agreed to extend the current pilot to include deliveries between all library authorities. The four Dublin library services will join this pilot delivery scheme from 1<sup>st</sup> March 2017. The delivery scheme will provide for the collection and delivery of interlibrary loans (i.e. loans between different library authorities) from each branch on a twice weekly basis.

Once the pilot is in place Dublin City borrowers will have access to the stock of all library services in the country (and *vice versa*) with a branch-to-branch delivery time of five days.

Dublin City's current internal branch deliveries system is not affected by this pilot, which will run for six months with a possible extension of six months subject to review and agreement of the sector.

#### **Home Energy Kit - LAMA Award & Expansion**

Dublin City Council and Codema won a LAMA award for Best Energy Smart Initiative for the Home Energy Saving Kit project on 4<sup>th</sup> February. The kit was piloted with success in Dublin City Public Libraries over the last year and in a second phase the kits will be available to borrow from all Dublin City library locations. SEI Sustainable Energy Ireland has joined the project as partners and will engage with volunteer citizens to follow up on any behavioural influences of the project.

Phase 2 of the Home Energy Savings Kit project was launched on 7<sup>th</sup> March.

#### **Citywide Reading Campaign for Children**

Knight of the Borrowed Dark by Dave Rudden is the featured book for the 2017 campaign, which runs from January until 19th March with over twenty events in branch libraries, the National Library of Ireland, the Dublin City Gallery the Hugh Lane, and the St. Patrick's Festival's Big Day Out in Merrion Square. More information about the campaign is available on <a href="https://www.dublincityofliterature.ie">www.dublincityofliterature.ie</a>, with extra content about the book and online writing competitions at <a href="https://www.daverudden.com">www.daverudden.com</a>.

#### World Book Day event, 3rd March

Dublin UNESCO City of Literature is involved for the first time in co-organising *The Biggest Show on Earth* to celebrate World Book Day. This special event for children was held in Liberty Hall on Friday 3<sup>rd</sup> March with authors Judy Curtin, Dave Rudden, David O'Doherty, Chris Judge, Anna Carey and PJ Lynch.

#### Readers-in-Residence

As part of the Dublin North East Inner City Initiative, Dublin City Libraries is providing three Readers in Residence to schools and youth clubs in the area, to run programmes throughout the remainder of this school year and recommencing in September 2017. The aim of the project is to promote a love of reading for pleasure and to encourage engagement between children, their families and the local library. The project is being managed by the Dublin UNESCO City of Literature office.

#### **Dublin: A Year In Words**

Dublin: A Year in Words celebrates the breadth and diversity of our City's living poets through a year-long series of poetry videos filmed across twelve Dublin bookshops. These videos can be viewed on <a href="www.dublincityofliterature.ie">www.dublincityofliterature.ie</a>. This project is sponsored by Dublin UNESCO City of Literature with a new poem being uploaded each month to the City of Literature website.

#### **Dublin One City One Book**

Echoland by Joe Joyce, this year's choice for Dublin: One City One Book will be published by New Island Books, with the festival launch taking place at Collins Barracks on March 22nd. The festival will take place throughout the month of April and will include lectures, walking tours, film screenings and panel discussions. All events are free.

#### Coder Dojo

A Coder Dojo programme is being planned for both Charleville Mall and Central Libraries, with funding from the North East Inner City Project and co-operation from the Coder Dojo Foundation. A project co-ordinator is being recruited and CoderDojo sessions are expected to begin in April.

#### **Start Your Own Business**

In partnership with the Dublin City Council LEO, the Business Information Service will deliver a socially-inclusive Spring & Autumn "Start Your Own Business" programme. Consisting of twelve free two-hour lectures and workshops this year, the spring programme will begin on 23<sup>rd</sup> March and run on until 27<sup>th</sup> April.

#### **Getting Citizens Online**

Under the Department for Communications, Climate Action and Environment's *Getting Citizens Online* initiative, a five-week programme of free two-hour sessions will be delivered at the Central Library, beginning on 6th March.

#### **Donation of Japanese Translations of Irish works**

At a ceremony to mark sixty years' of diplomatic relations between Japan and Ireland, Her Excellency Mari Miyoshi presented Japanese translations of Irish literary works to the central Library on 18th February. The 100 titles make a significant contribution to the collection of Irish Literature translated into the Japanese language and will eventually form part of the Storyhouse collection at the new City Library, Parnell Square.

#### Swift 350<sup>th</sup> Anniversary

A travelling version of the exhibition *Jonathon Swift and Dublin* will go on display in branch libraries throughout the rest of 2017.

Fáilte Ireland has convened a workshop to plan an inaugural *Jonathan Swift Festival*, planned for late November. The City Library & Archives Service will participate along with other sections of the Council.

#### Historians-in-Residence

Applications for the six historians-in-residence posts closed on 25<sup>th</sup> January. Interviews took on 27<sup>th</sup> and 28<sup>th</sup> February and 1<sup>st</sup> March with a view to having the historians in post in April.

#### **Programmed events**

- Seachtain na Gaeilge (1-17 March) events will focus on story- telling and music for school and public audiences.
- Engineers Week (Sat 4 March Friday 10 March) Engineers from Dublin City Engineering Department hosted a 'Day in the working life series' for school audiences.


#### Cruinniú Na Cásca - Easter Monday 17<sup>th</sup> April

#### **Filming Update**

In the period January/ February the Film Liaison Officer has received 21 applications for filming in the city. These are from a wide variety of productions such as music videos, drama series, student productions, documentaries, advertisements and short movies. A number of projects are in the pre-production stage, such as "Vita and Virginia", staring Gemma Arterton and Eva Green which will shoot in Dublin. It is based on the true story of Vita Sackville West and the literary icon Virginia Wolf.

#### The Irish Film Board Conference

In January, The Irish Film Board convened an all Ireland regional conference exploring the benefits of filming making in Troy Studio's, Limerick. The conference examined topics such as "Ireland as a location", "film tourism" and "location requirements for filming".

Dublin City Council's Film Liaison Officer facilitated a presentation and panel discussion on "location requirements for filming" at the conference with An Garda Siochána, the Irish Aviation Authority and the Location Guild of Ireland.

#### **Locations Library**

A joint project between Dublin City Council and the Irish Film Board is underway, which will see the creation of a "Locations Library" for use by the audio visual industry. The Events Section is working on the compilation of a database of useful information and images, featuring various Council owned properties and on-street locations that are film friendly. This will be a valuable tool for the industry when in the pre-production stage and promoting Dublin as a film friendly location. The locations Library will be hosted on the Dublin City Council website.

#### **DUBLIN CITY GALLERY THE HUGH LANE**

Following the gallery's centenary theme of *Artist as Witness in Society*, our programme for 2017 will examine the artist's contribution to historical and social issues under the broad theme of *Artist as Witness: Migrations*. Migration has become the pertinent topic of discussion in the globalised modern world and in 2017 we will examine both historical immigration and emigration and the impact of migration as a principle of nature.

In developing and interrogating our Migrations theme, we will engage with diverse audiences through our inclusive in-house programme of exhibitions, talks, lectures and workshops. As part of our community and schools outreach programmes we will develop a series of workshops and projects linking the Gallery with communites across the city.

#### **Visitor Numbers:**

The gallery welcomed 12,854 visitors in January 2017, comparing favourably to 11,746 visitors in the same period in 2016. This continues the trend for visitor growth year on year.

#### **Capital Programme**

The Capital Works Programme will see the refurbishment of the 1930s wing, along with environmental upgrades throughout the galleries. These works remain on-target for commencement in Q1 2018, with completion expected late 2018/January 2019. The 1930s wing will remain closed for the majority of this time, with some other closures likely.

#### Community Based Artists Collectives Project with CREATE-CAPP

Dublin City Gallery The Hugh Lane and Create, the national development agency for collaborative arts in Ireland, are partnering to provide a major opportunity for a community based collaborative artist(s) practice to research and deliver a major new commission for spring 2018. This commission will run from 2017 into 2018 and sets out to encourage meaningful and in depth engagement with communities of place and of interest as well as the distinct architectural, socio-political and cultural landscape of the North Inner City of Dublin. 41 applications were received in response to an open call to artists and / or arts collectives born in or resident in the UK, Ireland, Spain, Finland, Hungary or Germany (partner countries within the Collaborative Arts Partnership Programme).

#### **Dublin's Culture Connects Project**


Dublin City Gallery The Hugh Lane, South East Area Office, Dublin City Arts Office, Dublin Public Libraries are collaborating on a Dublin Culture Connects Project, working with Communities in the South East Area. As part of this project, Community groups have visited the participating cultural institutions.

Ships Passing in the Night was a community engagement project involving children from the Sikh community and the Dodder Scouts, who creatively explored maritime communication, group photography, and the creative staging of images. Over three months, they worked together and in groups and on the making of a short film. The film, Ships Passing in the Night, was premiered at the Hugh Lane on 21<sup>st</sup> January 2017. In tandem 'Alight!' is a project with Coisceim exploring dance, storytelling and cabaret which was premiered on 26<sup>th</sup> to 28<sup>th</sup> February.

#### Eugeen Van Mieghem: Port Life 9th February - 11th June 2017

Deputy Lord Mayor, Councillor Rebecca Moynihan, formally launched this exhibition on behalf of the City on the evening of 8<sup>th</sup> February 2017. Sponsored by Dublin Port and curated and delivered by the gallery, *Port Life* forms part of the Dublin Port Company *Port Perspectives* programme. The exhibition has already received significant media attention, having been covered in the Irish Times and RTE Radio 1 shows Arena and Seascapes.

The exhibition of 71 works is accompanied by a 96 page hardback catalogue, with essays by Julian Campbell, Erwin Joos, Jef Vrelust and Lenore Van Der Veer. The catalogue is on sale from the gallery bookshop for €15.



#### **Hugh Lane and Dublin Port Perspectives**

In tandem with the Eugene van Mieghem exhibition, the gallery education department is collaborating with the *Dublin Port Perspectives Project*. Co-ordinated by Declan MacGonigal, this project sees Education students at NCAD engage with ten local schools through workshops in schools and gallery visits. #### Conservation work on Self Portrait by Frank O'Meara complete

This display, which reflects the Gallery's Artist as Witness: Migrations theme for 2017, explores the work of artists who, influenced by innovative new developments on the Continent, travelled abroad to develop their art practice. 

Public consultation on the Dublin City Parks Strategy closed on the 28<sup>th</sup> February, 2017. We are currently reviewing the submissions received.

#### **Play Development**



#### **Dublin City Play Plan 2012 - 2017**

A strategic review of the above plan and work on drafting the next Dublin City Play Plan will take place in 2017.

Funding applications are currently being completed for submission to the Department of Children and Youth Affairs

(DCYA) for a number of existing and additional capital play projects. To date 3 applications have been successful in securing funding to develop approximately 10 play facilities of which 4 are completed and the remainder are ongoing.

#### 1916 Play Garden

The Play Development Officer is a member of the Dublin City Council Design Team for this project and is providing ongoing support and advice. This project is a joint initiative between Dublin City Council and DCYA.

- The Play Development Officer has worked with approximately 14 schools to assist in the development of improved and increased play opportunities in the school playground
- 16 Dublin City Council staff have achieved international accredited Level 2 Awards in Playwork,
- 11 Dublin City Council housing locations have been identified to take part in the 'Outside the Box' innovative play spaces programme
- Dublin City Council provides approximately 65 playgrounds within our housing developments and flat complexes
- Parks and Landscape Services provide 57 playgrounds in our Parks

#### **ARTS OFFICE**

The Arts Office is looking forward to participation in the new structure set out by Government with Local Authorities called Creative Ireland (this is headed up by Libraries).

Projects have been proposed by the Arts Office for Cruinniú na Cásca on April 17<sup>th</sup>. It is important that Dublin City Council is working in partnership with RTE in this now annual event.

Meetings with the recipients of new Arts Partnership Grants are ongoing and will involve greater participation in the Arts locally in all administrative areas across Arts in Education, Early Years Arts, A large scale Community Play and Community Groups.

Dublin's Culture Connects will showcase upwards of twenty arts and cultural events across the city in neighbourhoods and National Cultural Institutions in February and March.

The Dublin Chinese New Year Festival has had a new growth in attendance and profile this year.

All festivals within the Arts Office Culture Night, Literature Festival, MusicTown, DCNYF now require a growth strategy for future years.

#### **Dublin's Culture Connects**

#### 1. The Passion Project

Dublin City Council (via Dublin's Culture Connects, South Central Area Office, Dublin City Public Library Ballyfermot and Dublin City Arts Office) is partnering with Ballyfermot Community Civic Centre on The Passion Project. It will take place on 8<sup>th</sup> and 9<sup>th</sup> April 2017 in Ballyfermot and Cherry Orchard and is being devised, developed, delivered and performed in collaboration and with the support of many local community groups.

Through co-creation with theatre company Brokentalkers, we will develop a contemporary, Ballyfermot/Cherry Orchard grown version of the Passion of Christ, The Passion Project.

The project will include a series of scenes from the well-known story throughout the area of Ballyfermot, indoor and outdoor over 2 days. The scenes will include dance, music, theatre and visual art. The story will be interpreted in such a way as to highlight some of the issues faced by a Ballyfermot mother living in fear for her children moving within the wrong circles, which can be potentially tragic, while at the same time showing the positive aspects that the community nurtures, such as the talent and facilities within the area. Community groups will consist of local schools, colleges, the men's shed, writing groups, women's craft groups, dance and drumming groups. There will be two professional actors headlining the performances.

Venues will consist of the local Equine centre, the local college BCFE, the streets and local parks. The project aims to include a procession right through the town, stopping in these venues along the way for performances. Some of Ballyfermot's well known talent will be included in a "last supper" showcase event. BCFE film course students will be filming the project. The Project aims to be as inclusive as possible within the locality with a view to fostering new strong community, artistic and business relationships and developing future cultural projects in the area.

A large list of groups were involved in supporting the project i.e. performances, preparation of the script, providing performance / rehearsal venues etc.

#### **Arts, Education and Learning Policy**

Dublin City Arts Office - Arts, Education and Learning Policy was passed by Council in November 2016. The document is currently in design stage and a launch is being planned for Spring 2017. The arts office team is currently working on the implementation plan for 2017.

#### **Learning With Visual Art – EU/Erasmus+ Application**

Dublin City Arts Office/The LAB Gallery hosted some key meetings in Dublin in February '17 regarding development processes for EU funding applications. This part of our work sits under the implementation of Dublin City Council's Cultural Strategy 2016-2021, and Arts, Education and Learning Policy, passed in November 2016 by Council.

One proposal we are working on is an Erasmus+ Application called 'Learning With Art' with a specific focus on Visual Thinking Strategies. This proposal is emerging from our innovative arts in education work, to date, in partnership with local schools in the north east inner city and the National Council for Curriculum and Assessment.

# Neighbourhood Arts Grants - North East Inner City

In 2016, Dublin City Arts Office has reviewed its approach to supporting the development of The Arts in Neighbourhoods. At the meeting of the Arts and Culture SPC in November 2016, the City Arts Officer proposed and received approval to conduct a pilot Neighbourhood Partnership as part of the Neighbourhood/ Arts Grants. This pilot scheme seeks to address the difficulty that formal Arts application processes can present to community groups and to provide ongoing developmental support throughout the life of the project. Applications were received and are recommended from The North East Inner City (NEIC), North Central, South Central, South East and Central Area.

#### Towards Developing a NEIC Neighbourhood Award Partnership Programme

Currently Liz Coman is meeting with each awarded group to fully brief them on a process that deepens local understanding around expectations of partnership building. Following this a strategic meeting with Arts Office team, NEIC Taskforce, and awarded projects will take place to explore what might the shape of success look like by the end of 2017; how can the projects use the LAB for their work; how a supportive and reflective approach might be supported for this group of neighbourhood arts projects.

#### I.A.W.A.T.S.T.

Interesting And Weird At The Same Time launched at the LAB (the Homecoming!!) on February 16<sup>th</sup> 2017.

The Office of Public Works (OPW) and the Department of Finance of the Stormont Executive (DoF) have been collaborating on organising art exhibitions since the late 1990s. These exhibitions involve touring artworks from both public owned collections to venues throughout the island. In recent years, the exhibitions have opened up into broader partnerships with other cultural organisations. In 2016, the OPW and the DoF collaborated with Dublin City Council, the LAB Gallery in the organisation of the annual touring exhibition.

This year's project has involved working with the curatorial team from the LAB Gallery and with the children and teachers from the Central Model Senior School in Dublin who have been using the innovative Visual thinking Strategies (VTS) method of looking at art for three years. The children from 4<sup>th</sup> class in the Central Model Senior School visited the offices of the OPW in Dublin and the DoF in Belfast to select artworks for inclusion in the exhibition. Using VTS, the LAB team led lively discussions with the children on their visits to the two art stores in Dublin and Belfast and also continued their work in the class room to select 20 artworks for the IAWATST exhibition.

IAWATST 'interesting and weird at the same time' – is the descriptive abbreviation written down by one of the children when making their selection for inclusion in the exhibition. It is an intriguing title that reflects the children's fresh and open responses through the VTS system to the historic and contemporary works in both collections.

The exhibition has run in The Printworks in Dublin Castle in November 2016, then travelled to the Alley Theatre and Gallery in Strabane in December 2016.

#### **EU Funding Research - Potential for Maker Space in Dublin**

As part of the Cultural Strategy, the Arts Office is exploring the potential for EU funding to investigate 'maker spaces' with a focus on how artists, techies, crafters and tool operators get together to inspire each other, make things and hopefully also build successful enterprises. Other cities in Europe have successfully harnessed their maker culture. Dublin wishes to connect with these cities to learn and to build strategic partnerships that will benefit makers in partner cities.

On 28th February, interested parties gathered from Dublin, Brugge and Belfast with the following aims:

- To identify the needs of makers in Dublin and partner cities
- To identify the barriers that inhibit maker culture in Dublin and partner cities
- To develop and agree (co-create) a concept and outline for a maker space project
- To understand how the North-West Europe Territorial Cooperation Programme could be an opportunity to access financial and other resources to deliver on a potential project.

#### The Tree Line Project

The Tree Line Project is a concept developed by Oonagh Young and Mary Cremin which was awarded significant funding from the Arts Council for a new project in Joyce Street and Liberty Park in the Monto. Key elements include a temporary pavilion for the park and tree planting programme for Joyce Street with an LED featuring Joyce's writing. The Arts Office has convened meetings with Parks and the Central Area office to support the development of the project.

#### Talking Statues Dublin - Fáilte Ireland

As approved by the Arts and Cultural Advisory Group, Fáilte Ireland has commenced its pilot project for 'Talking Statues Dublin' and now have proposals and agreement in principle for eight statues to have 'statues talking' using mobile phones with scripts and readers from high profile people as set out below. It is intended that this project will be rolled out on a temporary basis for a minimum of one year. Dublin City Council will require that any associated signage is of a standard and quality befitting the public realm in the city centre. #### **2017 Activities**

#### **Lord Mayors 5 Alive Challenge**

The 2017 Lord Mayor's 5 Alive Challenge kicked off on New Year's Day in the Phoenix Park with the Liffey Valley Tom Brennan Memorial 5K. The five race series is proving as popular as ever with the maximum 450 entrants signing up within an hour of registration opening. #### **Operation Transformation Walk**

Approximately 250 participants took part in this 4k walk held in Albert College Park, on January 7<sup>th</sup> 2017. Participants ranged from infants to Older Adults creating a positive intergenerational event. Similar walks were held in all counties on the same day in conjunction with RTE's Operation Transformation Programme.



#### **Change for Life Programmes**

These 8-week general health and fitness based programmes are being rolled out in Fatima, Bluebell, Poppintree and Harolds Cross between January and March 2017. Change for Life programmes consist of pre- and post-health checks and body measurements. Participants are supported through the 8-weeks with fitness classes such as Zumba, Walking/Jogging and Step Aerobics and nutrition advice. The programmes are open to all adults in the local community and feed into the Operation Transformation Dublin Walk and 5k run which took place in the Phoenix Park on February 18<sup>th</sup> 2017. The Sport Officers put measures in place to assist participants maintain healthy lifestyles following the intensive 8-week programmes.

#### **Ballyfermot and Coolock Swimming & Water Sports Programme**

These programmes are open to referrals from the local welfare officer and local youth services. The pool sessions include swim technique/fitness, water safety, snorkelling with additional sea swimming outings in the Summer. Participants must have a good baseline standard of swimming as the training is of a high intensity.

Opportunities are available for those interested to progress onto a Pool Lifeguard Course and achieve certification in this area. This may, in turn, open up employment prospects for them. However, the focus of the programme is to use the experience of successful candidates within the group in a peer to peer leadership model in order to sustain success.

#### **TUSLA Programme South City Family Support Services**

The Partnership is working with South City Family Support Services TUSLA to help build resilience for a group of young people aged 8 to 12 years of age, allowing them to find their voice. The group will be taking part in a 12-week Water Confidence / Snorkelling programme taking place in Crumlin Swimming pool on Tuesday afternoons from 3-4pm. The Programme runs from January to April 2017.

#### **Launch of Strategy Document**

The Dublin City Sport and Wellbeing Partnership inaugural Statement of Strategy, STRIDE: 2017 - 2020 was launched in the Mansion House on Monday the 20<sup>th</sup> of February 2017.

The strategy is progressive and ambitious and sets out 16 initiatives and 26 actions under the following strategic goals:

- 1. Places and Spaces
- 2. Programmes and Services
- 3. Promoting Sport and Inspiring People
- 4. Good Practice

#### 2. Matters Arising

#### 3. City Arts Officer Report

The City Arts Officer presented plans for enhancing the Neighbourhood Grants as part of the City council Arts Grants in a proposed partnership with local area offices. He reported on the Review of the City Arts Office which had taken place through 2016.

He presented the new Purpose Statement for the City Arts Office:

Dublin City Council recognises the unique and transformative role of the arts in the life of its residents, businesses and visitors. The arts are a critical component of Dublin City Council's cultural strategy and a key pillar of Dublin's cultural identity and international reputation. The City Arts Office is a developmental unit within Dublin City Council. It supports quality, access, participation, learning and innovation in the arts through collaboration and strategic partnership at local, regional and international levels.

He concluded the report by updating the Group on other Arts Office initiatives including the tour of *Stór*, a bi lingual play by Ciarán Taylor commissioned by the Arts Office as part of the 1916 centenary and which is touring primary schools in Dublin.

#### 4. Public Art Report

#### **Luke Kelly Sculpture Review Group**

The City Arts Officer presented the Terms of Reference for the Luke Kelly Working Group to consider the various issues relating to the offer from Gerry Hunt of a statue of Luke Kelly by artist John Coll and the sculpture selected through the Dublin City Council process initiated by the then Lord Mayor Christy Burke, which selected the proposal by artist Vera Klute. The proposed working group is Cllr Áine Clancy, Chair of Arts and Cultural Advisory Group, Cllr Rebecca Moynihan Chair of the Arts and Culture SPC, The City Arts Officer, Community Representative, external art expert, Anna O'Sullivan, Director of the Butler Gallery, Kilkenny and the Public Art Manager. The appointment of the community representative will take place through the PPN process.

#### **Statue of Robert Emmet**

Gerry Kerr raised the report on the proposal to relocate the statue of Robert Emmet to St Catherine's Church and requested that the Public Art Manager make further enquiries from the OPW as to why they would not support its relocation.

#### **Commissions**

The Public Art Manager presented updates on commissions including: *Voices of Memory* by Christina Kubisch; Kevin's Street Library commission awarded to Alan Phelan, the Dublin City Council San José partnership of the play *The Memory Stick* by Donal O'Kelly; The Liberties Art Commission awarded to artists James Hayes and Kirstie North; DCC OPW Dodder Flood Defence Commission *Ark* by Tom de Paor and Peter Maybury and the Wolfe Tone Street commission in partnership with the Arts Council, Children's Book Ireland and Laureate na nÓg.

#### **Proposals for Permanent Art**

#### A statue of Liam Mellows (1892 – 1922)

Gerry Buckley, Chairperson of the Liam Mellows Memorial Committee submitted a proposal on their behalf to the Arts and Cultural Advisory Group and Commemorative Naming Committee to commission 'a life size statue of Liam Mellows' in Mellows Park, Finglas. The proposed sculptor for the work is Willie Malone of Kilmainham Art Foundry. The stone work would be supplied by James McKeon of Stone Source and landscaping by Plan Design Associates. The proposers suggest that the National Graves Association become custodians of the sculpture on completion. Estimated costs supplied are €50,000 and it is intended to fundraise for the cost of the artwork.

The Arts and Cultural Advisory Group concluded that:

- Not enough detail had been provided about the actual artwork, the proposed artist (including previous work) and detailed costing and that the Liam Mellows Memorial Committee should be requested to provide more detailed information in this regard.
- If commissioned Dublin City Council should be given ownership and responsibility for its care and maintenance.
- While there is a context for commissioning a statue of Liam Mellows, as a park has
  already been named after him, consideration has to be given to the Commemorative
  Naming Policy which states 'In considering proposals for naming of infrastructure or
  erection of civic monuments or plaques, consideration will be given to what other
  infrastructure; monuments or plaques exist in honour of the person/s or event.'
- In addition, as agreed at the Arts and Cultural Advisory Group meeting in March 2016, a policy should be developed relating to the War of Independence and specifically in this case to the Civil War

#### Offer of Gift from the Government of Georgia

The Ambassador from Georgia has offered Dublin City Council a wine Kvevri clay jar which is used in ancient traditional Georgian winemaking. This method of wine making has been added to the UNESCO Intangible Cultural Heritage List. The Ambassador is flexible as to where it could be displayed but suggested a Park.

#### Recommendation

- That while this beautiful and valuable cultural object might be robust in many ways, it is probably too fragile to place in a public park, where it could be subject to vandalism or theft
- In the absence of a Civic Museum and a collections policy, there is no other internal location which is easily identifiable for the permanent display of the gift.

#### Offer of Gift from the Government of Croatia

The Ambassador from Croatia has offered Dublin City Council a gift of a Decorative Easter Egg for display indoors or externally. The painting of eggs at Easter is a tradition in Croatia and these gifts have been displayed in cities across Europe and further afield.

#### Recommendation

- There is no obvious location for the permanent display of such a gift in the public realm in a city which is offered so many gifts on a regular basis.
- In the absence of a Civic Museum and a collections policy, there is no other internal location which is easily identifiable for the permanent display of the gift.

#### Recommendation

 At the suggestion of the City Arts Officer, the Arts and Cultural Advisory Group agreed that policy and procedure should be developed relating to the offer of major gifts which are not necessarily public art.

#### **Care and Maintenance of Permanent Public Art**

The Public Art Manager reported on issues relating to the care and maintenance of public artworks including: the statue of Philip Lynott damaged by a truck; the reinstatement of the statue of Fr Mathew by Mary Redmond; the sculpture *Trace* by Grace Weir on St Stephens Green and *Inverted Oil Rig* by Alan Phelan in Fr Collins Park.

# Core Programmes

The proposed new suite of programmes will provide consistency across the city, fit in with the National Physical Activity Plan and encompass minimum criteria that will enable us to evaluate & measure the success of each programme.

AM proceeded to talk the Board through a presentation on the proposed new suite of programmes.

#### **2017 Events**

AM ran through the current list of events for 2017 and invited feedback.

AM also gave an update on the 'Beat the Street' game. This is likely to commence in September 2017 and will run for 7 weeks. The aim is to encourage behavioural change among the general public in the area of physical activity.

# Breviate of Draft Minutes of meeting of Commemorations Committee - Fochoiste na gCuimhneachán

Wednesday 18th January 2016 at 2.00pm Richard O'Carroll Room, City Hall

- 1. Minutes of the meeting of 16<sup>th</sup> November 2016 approved. Matters arising:
  - a. St. Patrick's Day Festival It was noted that a written report was presented at the January meeting of the SPC. B Teeling reported that he had spoken to the CEO of the Festival who proposes to invite members of the SPC and Commemorations Committee to a briefing on the Festival.
  - b. Lamp post banners T. Doyle reported that Civic Media had informed her that the majority of lamp posts in the North Inner city area not recommended for fixings with a few exceptions on Ballybough Road; new poles on Clonliffe Road now have fixings attached.
- 2. Apologies: Cllr. Cieran Perry
- 3. Correspondence
  - a. Letter of reply from Nessa Foley, Private Secretary to Minister for Arts, Heritage, Regional, Rural and Gaeltacht Affairs re. Sale of P Pearse surrender letter.
- 4. 1916 Garrison plaques
  - a. It was reported that the Four Courts garrison plaque was unveiled on Church St by Lord Mayor Brendan Carr on 7<sup>th</sup> December 2016 and the RCSI Garrison plaque unveiled by Cllr. Dermot Lacey, deputising for the Lord Mayor, on 12<sup>th</sup> December 2016, with many relatives in attendance at both unveilings. It was reported that the landlords of Clanwilliam House, the proposed site of Boland's Mills garrison plaque, are renovating the building and have requested a six-month delay until works have finished (circa mid-2017). The convenor of the Boland's Mills relatives group has been informed. B. Teeling reported that DCC plaques will be mapped in 2017. Cllr. Flynn suggested poster and badges of plaques. The officials will investigate and get costs for this.
- 5. 2017 Commemorations programme
  - a. Historians-in-residence programme: it was reported that a Contract for Service for the six Historians-in-Residence in DCC was advertised with closing date 25<sup>th</sup> January. The historians will work part-time for approximately nine months to continue community engagement with history across the city and build on the success of a similar programme in 2016.
  - b. Events to be commemorated in 2017: it was reported that a number of anniversaries in 2017 will be marked including by-elections, Irish Convention, Thomas Ashe death, WWI events (Battles of Passchendaele, Messines Ridge, death of Francis Ledwidge), Russian revolution, Reformation, research on Representation of the People Act 1918 (women's suffrage).

c. Lunch Time Lecture Series: It was reported that the lunchtime lecture series in City Hall in April will be on the theme 'The Great War: Remembrance and Commemoration'. This will coincide with the Assembly Memorial Chairs travelling installation from In Flanders Fields Museum which commemorates war deaths and which will be in DCLA in March; City Hall in April, and Richmond Barracks in May. Cllr. MacDonncha suggested pipe band competition to commemorate Thomas Ashe's death. Cllr. Ring pointed out that 2017 is 150th anniversary of Fenian rising. He would like more consultation on the 2017 programme. The officials will look into a consultation mechanism for programme themes.

#### d. Motion from SPC:

"As part of the decade of Commemorations, Dublin City Council to organise a series of public talks, lectures, panel discussions and exhibitions in 2017 to mark the centenary of the Russian Revolution, an event of world historical importance, exploring not only its initial successes and ultimate failures, bur exploring also the emancipator achievements of the revolution such as granting women the right to vote and contest elections, the legalisation of abortion and the repealing of laws outlawing homosexuality; and to explore also the political and cultural links between Revolutionary Russia and Revolutionary Ireland during the period beginning in 1917"

The motion was noted: the officials will look into a consultation mechanism for programme themes.

Exhibition celebrating the 350<sup>th</sup> anniversary of the birth of Jonathan Swift: it was reported that the exhibition "Jonathan Swift and Dublin" will be on display in DCLA until the end of February. A travelling version of the exhibition will tour branch libraries in 2017.

e. "Dublin Remembers: Stories from the Somme": it was reported that a travelling version will tour branch libraries throughout 2017.

## 6. A.O.B.

- a. It was reported that on 24<sup>th</sup> November 2016, Dublin City Council won a Chambers Ireland Excellence in Local Government award for its 1916 commemorations programme "Dublin Remembers 1916/2016"
- b. Cllr. Flynn raised problem of inaccuracy of information delivered on some walking tours in the city and suggested official booklet/guidelines to be produced by DCC. The officials will look into this and report back.

# o Liam Mellows Memorial - Update

Following on from the previous meeting, the Public Art Manager requested the Liam Mellows Memorial Committee to submit further information such as an artistic impression of the memorial, proposed artist including a CV, detailed costings etc. The Public Art Manager informed members that he received no reply from the Memorial Committee.

**Action:** The Public Art Manager to make further contact with the Memorial Committee and copy the Chairperson on any contact made.

# Welsh Chapel Plaque – Update

Management informed the Committee that registered letters had been sent to owners of the building, but no reply was received. Committee members were also informed that contact had been made with the tenant of the building regarding improving the look of the building with DCC's assistance. The tenant was reluctant to change the current artwork, but was agreeable to allow us to paint a section of the upper level of the building which would allow the plaque to stand out somewhat. Following a discussion on various options of erecting the plaque, members agreed that the plaque should not be erected on the façade of the building in its current state of disrepair.

**Action:** Continue to liaise with the tenant regarding improvement works. Arrange a site visit with Conservation. Incorporate into the Policy Document that our granite plaques are not suitable to be placed in the ground.

# 4. City Arts Officer Report

The City Arts Officer presented the report on the Arts Office activities with the emphasis on Neighbourhood, including the new Partnership Grants process involving local area offices. He reported on the events taking place through 2017. The events include the Dublin Chinese New Year Festival, International Literature Festival Dublin, Children's Art in Libraries, the current exhibition *A Different Republic* co-curated by Arts & Disability Ireland and Fire Station Artists' Studios and the forthcoming IAWATST exhibition in the LAB gallery.

He also informed the group members of EU funding and the meeting that will be hosted by the Arts Office in February 2017. This sits under the implementation of Dublin City Council's Cultural Strategy 2016-2021 and Arts, Education and Learning policy.

As a part of the City Arts Officer's report Iseult Byrne, Project Director of Dublin City Connects, advised on the activities and events developed within the project, such as *The National Neighbourhood, Press Play, It takes a Village, Out of the Box, Around the Table, ALIGHT!*, (Y)our Story, Fundraising Fellowship and Cultural Adult.

#### 5. Public Art Report

#### **Cecily Brennan resignation**

The Group was informed of the resignation of artists Cecily Brennan as external public art advisor du to work commitments. It was agreed that Visual Artists Ireland be invited to nominate a female and a male artist so that the group can select a replacement.

# Sculpture(s) of Luke Kelly

The Luke Kelly Working Group consists of Cllr Áine Clancy, Chair of Arts and Cultural Advisory Group, Cllr Rebecca Moynihan, Chair of the Arts and Culture SPC, The City Arts Officer, Roisin Lonergan, Director of Five Lamps Festival and Community Representative, Anna O'Sullivan, Director of the Butler Gallery Kilkenny and external art expert, and the Public Art Manager.

The issues were discussed in detail and it was recommended that the City Arts Officer make a presentation to the next SPC outlining the proposed terms of reference and methodology for the Group. It was agreed that it was desirable that the work of the Group would be completed as speedily as possible.

#### **Commissions**

The Housing and Residential Services Department in Dublin City Council has offered a budget to commission an artwork for a large scale curved wall on Wolfe Tone Street, as this unsightly wall and area in front of it, is a location for anti-social behaviour. It is expected that the feasibility study will be completed in early February. The Public Art Manager also reported on *The Memory Stick* by Donal O'Kelly, Kevin's Street Public Library public art commission, The Liberties Public Art commission, and *Ark* on the River Dodder by Peter Maybury and Tom de Paor.

#### Policy Relating to Gifts to Dublin City Council

As agreed at the last meeting regarding drafting a policy on the gifts to Dublin City Council, the City Archivist has been consulted with, who highlighted the challenges of storage in the context that Dublin no longer has a Civic Museum or Museum of Dublin. It is proposed to consult the City Archivist for an opinion before future offers are presented to the Arts and Cultural Advisory Group.

#### **Proposals for Permanent Art**

# Mother Earth Proposal by Barton Rubenstein

Sculptor and environmentalist Barton Rubinstein has made a proposal for the donation of a permanent sculpture titled *Mother Earth Award* which is intended to focus public awareness on environmental issues. The matter was discussed in detail.

#### Recommendation

It was decided not to accept the offer as the

- Offer of this gift is related to an organisation.
- Fact that this is not a unique artwork and that it is also considered as an award.
- Challenges in identification of a suitable location.
- Costs of foundations, installation and future care and maintenance.

# **Proposals for Temporary Projects**

#### Flow by Jane Groves proposed by the Temple Bar Company

Flow is a light and object based installation by artist Jane Groves for Bedford Lane in Temple Bar using translucent and coloured materials. The installation is designed to add artistic and cultural interest to the lane and also to make the space safer and to reduce the antisocial activity.

#### Recommendation

 To approve the Flow installation subject to feasibility and approval by the South East Area Office and DCC Planning and Development Department.

# **Care and Maintenance of Permanent Public Art**

The Public Art Manager reported on issues relating to the care and maintenance of public art including:

#### Cathode: Anode by Andrew Clancy in the Ballymum Civic Centre

A request has been received from the Valuers Office in Dublin City Council; to remove the sculpture which is in front of the Civic Offices, Ballymun.. The Public Art Manager explained that he had contacted the Area Office in Ballymun and also the artist.

#### Recommendation

• To approve the relocation of the sculpture to a suitable location and to keep it within the Ballymun area.

#### **Molly Malone by Jeanne Rynhart**

This statue was removed due to the LUAS Cross City works and the new location at St. Andrew's Church in St. Andrew Street proved to be very successful. It was proposed to the Group that the sculpture of Molly Malone remain at this location

#### Recommendation

 To retain the statue of Molly Malone at the present location outside St.Andrew's Church.

#### The Public Art Manager also updated on the following:

- The statue of Philip Lynott to be reinstated in a more suitable location in Harry Street, timeframe dependant on repaving works on the Grafton Street Quarter Public Realm Project.
- The stone bust of Henry Grattan to be repaired by Jason Ellis, a stone expert.
- The sculpture *Trace* by Grace Weir on St Stephens Green is hoped to be reinstated at the end of the first quarter of 2017.
- Fr.Matthew statue by Mary Redmond cannot be retained in O'Connell Street due to the new layout. Discussions on relocation are on-going.
- Reinstatement of *Inverted Oil Rig* by Alan Phelan in Fr Collins Park is hoped to commence in the first half of this year.

# **Public Realm Project at Ranelagh Triangle**

The memorial to Deirdre Kelly is being redesigned with the agreement of the family to include seating and the inscription.

## **Bordallo Project**

This proposal was tabled as an AOB on the Public Art Report as the Events Unit stated that the project had also received BAI funding to make a film and that a decision would be helpful in meeting the time constraints of this film award. The Bordallo project is a proposal to install a temporary installation of a red squirrel made of recycled material at a derelict site on the corner of Tara Street and City Quay.

#### Recommendation

 The Group discussed the proposal but thought that further detail was required form the artist and that the Events Unit be asked to convey this to the artist.

#### 6. Dublin City libraries report

Deputy City Librarian reported on new City Library in Parnell Square, Kevin Street library refurbishment, public meetings on the future of Terenure library and the changing role of libraries in the community.

New online resources are available on the premises and through library website using the membership code.

Historians-in-Residence will be involved in *Dublin Remembers: Is Cuimhin Linn* project using and promoting the extensive collections of Dublin City Library and Archives. It is hopes to appoint the historians by the end of February.

Deputy City Librarian also reported on Jonathan Swift's 350<sup>th</sup> anniversary and Dublin UNESCO City of Literature reading campaign.
