4 Motion in the name of Councillor Michael O'Brien

"To request that the practice whereby a written explanation would be circulated to councillors when emergency motions were ruled out of order, which was agreed at the Protocol Committee meeting last October and subsequently put into practice, be reinstituted.

When I raised the discontinuation of this practice at January's Council meeting, the Lord Mayor informed me that this was because the newly adopted standing orders did not contain a provision for such a circulation. I am requesting that a further amendment to standing orders be drafted to incorporate this measure."

Order: Agreed and Recommend to Council. The Members stipulated that the written explanation as to why an emergency motion was not taken did not have to be circulated until the day after the Council meeting.

7 Update on the Working Group on Parental Support

The Manager reported that the Working Group met in January and came up with a number of options including:

- The provision of a parenting room in City Hall
- The provision of Childcare during City Council Meetings
- Remote attendance at Council meetings for initial months

Following a review of City Hall, the City Architects Section determined that there was suitable space for a parenting room on the 1st floor. This would involve converting the existing Gents toilets located on the west side of the building.

All Councillors would be surveyed with regard the provision of Childcare for City Council meetings to determine if there was demand for such a facility.

The Members were concerned that older children would not be permitted in the Council Chamber and asked the Manager to clarify the position.

Order: The Manger to revert back to the next meeting with a final report from the working group.

8 Appointment to the Board of Beaumont Hospital

Order: The members agreed that Fingal County Council would nominate a candidate for the position for the remainder of the current Council term and that Dublin City Council would nominate a candidate after the next Local Election.

9 Improved support resources for Councillors - Expenses Incurred

The Chair reported that the proposed changes to the Expenses Scheme would favour Councillors from outside of Dublin disproportionately and that it was opposed by both LAMA and the AILG.

Oonagh Casey explained that the new scheme allowed for an increase in expenses from €2,667 per annum up to €5,000 per annum. However, the new scheme would operate on a fully vouched basis. Councillors would have the option of remaining on the current scheme or moving to the new one when it came into effect from July 2017.

10 Freedom of Information Request - Benefit in Kind

The Chair reported that he had circulated the response to his FOI request into Benefit in Kind for the Members information.

11 Tracking system for Legislative Change

The Members agreed that it would be beneficial if there was a mechanism by which they could be made aware of proposed legislation that directly affected the Local Government sector.

The Manager reported that An Taoiseach's website publishes biannually a list of the proposed legislative programme for government.

Order: The Legislation Programme to be listed and circulated as part of the Protocol Agenda for the purposes of noting only.

12 Provision of Facilities in Civic Offices for Councillors

The Members asked the Manager to investigate the possibility of providing a room with office facilities, e.g. telephone, PC and printing - in the Civic Offices, for use by Councillors.

Order: The Manger to investigate and report back to the Committee

13 Managers Report

- The Members agreed that Council question replies should be released at the commencement of the City Council meeting and be accessible through the Modern Gov system. The procedure whereby hard copies of the replies are also provided would discontinue when this facility became available.
- ➤ The Members agreed with the Managers suggestion that the Monthly Management Report would be more beneficial to Councillors if it were abridged. The effectiveness of the change in format would be reviewed by this committee in three months.
- Members agreed that the Protocol Committee continue be counted towards their attendance for the calculation of their monthly expenses.
- ➤ The Manager reported that an internal steering group had been set up to oversee the implementation of Public Reps system. She also highlighted to the Members that new European Data Protection legislation was in the pipeline which would have a serious effect on how the organisation handles personal information. The Manager will continue to update the Committee on the progress of the new system.
- ➤ The Members agreed the use of the Council Chamber on 26th August 2017 for the seminar on 'Living in Victorian Dublin' as part Heritage Week 2017.

- ➤ The Lord Mayor requested that the Manager investigate the procedures surrounding the support for the Office of Deputy Lord Mayor. There have been issues with allowing the DLM to use the LM car for official functions and also with the transfer of the Chain to those who are deputising for him.
- The Chair requested a report on the role of the Law Department and the Law Agent as there was a perception that they were there to support the Executive and not the elected Council.

Report to Protocol Agenda – "Liberty Hall, Irish Cancer Society Banner"

Application:

The Irish Cancer Society have requested approval from Dublin City Council for the erection of a temporary banner to be displayed on the SIPTU Building, Liberty Hall, Dublin 1 to raise awareness of Daffodil Day, which is the organisations flagship fundraising event. Permission has been received from SIPTU for use of the building should the banner request be granted by Dublin City Council.

PROPOSED DATES OF DISPLAY:

Monday March 6th - Monday 20th (2 weeks)

BANNER ON BEHALF OF:

Irish Cancer Society - Daffodil Day

OUTLINE/CAUSE OF THE CAMPAIGN:

This is the 30th anniversary of Daffodil Day – the longest running collection day in Ireland and a major fundraiser for the Irish Cancer Society. Funds raised help fund vital cancer research and support services to help those affected by cancer in Ireland.

DESIGN / MESSAGE:

We are currently working on the messaging for this. The image is of a mother and daughter in a garden with daffodils. The mother is a cancer survivor wearing a headscarf. Attached please see some previous Irish Cancer Society banners on Liberty Hall.

BENEFIT TO CITY:

The banner is designed to create a sense of hope and support for those affected by cancer and to encourage members of the public to get behind Daffodil Day.

The Planning Department of Dublin City Council is satisfied that all aspects of the application comply with the agreed policy for the erection of banners on Liberty Hall.





Report of the Parental Support Working Group

Background:

At the Protocol Committee meeting on the 1st December the following motion from Cllr. Patrick Costello was discussed:

"That Dublin City Council shall do its utmost to facilitate councillors with young children who bring their children to meetings, and shall have particular regard to facilitate councillors who are breast-feeding."

The Members of the Committee supported the overall objective of the motion and acknowledged the need to facilitate and support Councillors with young families. However it was recognised that there were many factors to be taken into account before proceeding. To this end they recommended that a Working Group be established to investigate the issues raised by Cllr. Costello's motion and which would report back to the Protocol Committee with recommendations.

Membership: Councillors Patrick Costello, Claire Byrne, Janice Boylan and Tina MacVeigh along with Deirdre Ni Raghallaigh from Chief Executive's Office formed the working group to investigate the issues.

Progress:

The Committee met on the 5th January 2017 when the terms of reference for the Working Group were accepted. These included:

- The Group would focus on council / committee meetings occurring in City Hall and applicable area offices only.
- > By legal definition children are those under 18 years of age who are not married.
- DCC employees are required to comply with "Safeguarding Children in the Workplace" guidelines. (DCC 2011)

The following issues were identified by the Working Group for consideration:

1) The Provision of a Parental Room in City Hall:

Following a survey of City Hall by the City Architects Section it was established that the most suitable place to provide the facilities would be on the first floor in the small rear space off the 'Members Cloakroom', currently in use as a Gents Toilet. The proposal has been discussed with the Conservation Officer and she see's no issues in principle. City Architects are now in the process of drawing up plans for the layout

of the room and a draft programme of works with a view to carrying them out in August 2017 during the summer recess.

2) The DCC Crèche

Corporate Services have confirmed that priority is given to staff and Councillors over non DCC applicants on the crèche waiting list. The crèche can provide once off or occasional day-care to Councillor's children, provided advance warning is given. However crèches apply staff ratios depending on the age of the child which cannot be breached. If intending to use the crèche Councillors would be advised to book the sessions as soon as the date of the SPC or area meetings are known. The cost of availing of this facility would be borne personally by the Councillor.

3) Children in City Hall

Given the risks inherent in the building, all babies or Children in the Council area of City Hall or in the visitors gallery need to be under the constant direct supervision of the councillor concerned or another adult nominated by him/her. In compliance with guidelines staff assigned to City Hall or to council meetings can have no role in the supervision or oversight of any visiting child. Members enquired whether there could be scope for councillors to bring their child into the chamber at lesser attended area and SPC meetings.

Options Considered but not recommended at this stage

Remote Voting /Teleconferencing

Maternity and paternity leave does not apply to councillors at present. Councillors often return to Council meetings very soon after giving birth. We discussed the option of remote voting, teleconferencing software and proxy voting. The electronic voting system in the Chamber is a closed system and therefore it is not possible at present to vote remotely. The cost of installing such a teleconferencing system would be prohibitive and may be difficult to manage in the Council chamber. The procedures for payment of Councillors attendance at meetings are governed by ministerial regulations derived from legislation and therefore we are restricted in implementing any variation. It should be noted that Members can still receive their full allowance if they attend 80% of their meetings annually, which allows for some periods of absence for maternity or illness without affecting overall payments. The governmental has also brought forward proposals to amend the Social Welfare Bill which will allow Councillors to access a range of social welfare benefits

Provision of Childcare outside hours:

The Chief Executive's Office carried out a survey of Members asking if they would avail of childcare facilities for the monthly City Council Meeting if they were provided. Although Members were supportive of the idea of providing such a facility, the response to the survey indicated there was little or no demand for it at present.

LEGISLATION PROGRAMME SPRING/SUMMER SESSION 2017

Office of the Government Chief Whip 17th January, 2017

Foreword by the Government Chief Whip

In our third Government Legislative Programme since taking office in May 2016 the Partnership Government has set out our legislative priorities for the first half of 2017.

After almost nine months in office and with our first Budget passed, the Government has used this Legislative Programme to focus on delivering a range of commitments in our Programme for a Partnership Government by setting out the Bills prioritised for publication and those scheduled for Pre-Legislative Scrutiny over the coming months.

As a minority Government we will continue to work with all those elected to the Dáil and Seanad at Pre-Legislative Scrutiny Stage, in the Dáil, in Oireachtas Committees and in the Seanad to debate and enact better legislation.

This Government Legislative Programme is divided into a number of sections

- The first sets out the details of 31 Government Bills to be published by July 2017.
- The second sets out the details of 33 Bills to undergo Pre-Legislative Stage in this Session.
- The third sets out the details of 69 Bills each Department plans to introduce in the longer term.
- The fourth sets out the 27 Bills which have already been published and are currently before the Oireachtas, detailing the progress they have so far made.
- The final two sections set out the 18 Acts passed and the 28 Bills published by the current Government since it took office on the 6th May 2016.

Cabinet has prioritised 31 Bills for publication in this Programme including the Affordable Childcare Scheme Bill to provide a single affordable childcare scheme, the Financial Services & Pensions Ombudsman to establish one office dealing with pensions and financial services complaints.

Among a range of Health Bills included in the Government's Legislative Programme are Bills to provide a scheme to make individual payments as a contribution towards transport costs for people with severe disabilities on low incomes, to provide medical cards to all children on Domiciliary Care Allowance, licensing supervised injection facilities and laying the legislative foundation of the New Children's Hospital.

The Government will build on the radical Housing Legislation passed before Christmas with the publication of new legislation to regulate Approved Housing Bodies.

Among the other Bills prioritised for publication over the coming months are a range of Bills from the Department of Jobs, key reforming legislation from the Department of Justice in the area of the Judiciary and the laws on Domestic Violence and significant legislative reform in the area of Sea Fisheries.

These 31 new Government Bills, together with the 27 Government Bills currently before the Oireachtas, will ensure that this Partnership Government will make progress on legislation across a wide range of issues as it enters its second year in office, in the first half of 2017.
