Motion in the Name of Councillor John Lyons:
It was proposed by Councillor J Lyons and seconded by Councillor M Flynn that "Noting recent reports of diplomatic developments by the Irish state toward full recognition of the state of Palestine, aware also that Ireland accorded the Palestinian delegation in Dublin diplomatic status in 2014, the same year that witnessed both Houses of the Oireachtas pass motions in support of Palestinian statehood, this city council will fly the flag of Palestine over City Hall for the month of May 2017 in support of the above diplomatic moves and as a gesture of our solidarity with the people of Palestine living under occupation in the West Bank and Gaza, with the Palestinian citizens of Israel denied basic democratic rights and with the over 7 million displaced Palestinians denied the right of return to their homeland."

Order: The Members were supportive of the motion but were cautious of setting a precedent on the flying of flags on City hall. The motion was put and carried.

## Voter.ie Update

The Manager gave an update on the new voter registration system "Voter.ie". She informed Members that due to the increase in gated apartment complexes, the traditional collection of information through door to door enquiries was no longer effective. The new system was based around online, self-registration using the individuals PPS number. The Franchise section had successfully used the back office aspect of the new system to create the current electoral register and it was envisaged that the frontend portal would come online in February 2018. Members of the public would have the option of using the new system or could continue to register to vote using the existing registration forms.

## Order: Report noted.

## $7 \quad$ Public Representatives System - Councillor Front End

The Manager informed the Committee that the City Council had been investigating the introduction of the Public Reps system that was currently in use in the three other Dublin Local Authorities. The system would allow Councillors to lodge operational requests from constituents which would then be assigned to the relevant Department. The Department would then issue an authorised response within 15 days through the system, which could be provided to the constituent. Ollie Douglas gave the Members a brief demonstration of the front end of the system and explained how it would allow them to see the status of all their requests in one place. The system would also assist the senior management team in analysing how their Departments dealt with queries and ensure a more coherent and consistent approach.

The Manager also informed Members that the proposed EU Directive on data protection would be introduced in March 2018 and that this would have a profound impact on many aspects of the Councils business practices including the whole area of Council questions and representations on behalf of constituents.

Although the Members were positive towards the potential benefits of the new system in terms of efficiency and consistency they were cautious about its possible negative consequences. They were generally satisfied with the response from the Departments to their queries and were concerned that the new system would act as a barrier between the elected representatives and Council officials and impair the good working relationship that currently existed.

Order: The Manager to bring a report to the next meeting outlining all the issues discussed including the resourcing, scope and impact on current procedures of the new system.

The Manager proposed that in situations where the Lord Mayor, in discussion with the Chief Executive, agrees that the City should be represented at an international event or there is a recommendation from the Department of Foreign Affairs that the City or Country be represented abroad, but the Lord Mayor and Deputy Lord Mayor are not available then the invitation should be extended to the Chairperson of the relevant SPC. The travel costs associated with attending the event would be borne by the operational Department of the SPC rather than by the individual Councillor.

- The Speaker opened the conference emphaising that Rural Ireland is far from dead \& has the potential to become an ecomimically powerful region.
- The panel recognized that different Rural areas have differnet needs \& require different solutions depending on local assets \& that Rural Ireland has the ability to become ecomically prosperous in its own right, with its key strengths of people enrgy \& resources...instead of ushering in its demise we should see Rural Ireland as a region with hudge untapped potentional \& a capacity to lead the emergence of vibrant new ecomomies.
- Kevin Thompstone dicussed developing an Atlantic Economic corridor to promote more balanced regional development. The ecomoic corridor is key to supporting enterprise growth \& job creation in the western part of the country.
- Enterprise Ireland \& the IDA have a renewed focus on investing \& supporting enterprises at regional level. Both of these agencies will continue to focus on supporting job creation in the Western region.
- Emphasis was also on the diversity and range of Irelands unique \& natural hertigage which is rooted in rural Ireland \& in communities. The protection \& promotion of our natural \& built hertigage asseets will help to maintain \& generate employment \& revenue for rural Ireland through cultural \& heritage tourism. These assets have the potential to bring much needed economic \& employment opportunities to rural communities. Continue to significantly invest in National Parks \& Nature Reserves will greatly contribute to the tourism industry in Rural communities.
- The role out of the National Broadband plan to bring high speed to the Western region is vital to ecomomic sustainability. Investment in transport links through a review of services. Support for regional Airports \& investment in Rural infracture i.e Flood relief \& other land management measures to protect our rural infracture was also dicussed in relation to sustainability.

A number of important issues were raised during this National nZEB seminar including the below.

- A discussion around the Cost Analysis of Delivery nZEB (nearly zero energy building), it is clearly the way forward for building and is much cheaper than realized.
- The Energy and Performance Monitoring of nZEB homes as compared to standard homes.
- Training construction workers to deliver Nzeb effectively, what courses and practical education is needed to bring construction workers up to the required standard
- Retrofitting of Social Housing in Dun Laoghaire Rathdown
- Step by Step discussion around Construction of an nZEB home from start to finish
- It was mentioned and discussed how to achieve compliance with Part $L$ dwellings. The minimum threshold standard was discussed in detail. I learned that member states have agreed to ensure that all new buildings are nearly zero energy buildings by 2020. In addition all new buildings occupied by Local Authorities should be nearly zero energy buildings by 2018. It was explained that nearly zero energy building means a building that has very high energy performance the nearly zero or very low amount of energy should be covered to a great extent by energy from renewable sources.
- Wexford's first nZEB Local housing scheme was discussed in detail. In Wexford there are currently 3241 people on the Housing list and there is pressure on the rental sector in 4 main towns in the county. There was 516 cases of homelessness in 2016 in Wexford. Gorey which is a commuter town from Dublin has a $41 \%$ demand for 3 bed homes. Local Developer Michael Bennett submitted a proposal for 8 nzeb units in Moyne, Enniscorthy. The energy rating on the houses is better than an A1 with an A1 minus BER. It is estimated that there will be 5.1 million people in Ireland by 2021. We need to be building 60000 units per year.

- The seminar was attended by a large amount of architects, quantitative surveyors, builders and other trademen and housing professionals.
- It was quiet technical in parts of the seminar, there was many speakers in attendance including Mr Seamus Mullin of Michael Bennett construction, Doctor Shane Colclough of Ulster University speaking on the data of energy and performance monitoring and Dragmir Tzanev of En Effect in Bulgaria.

The speaker dicussed supporting sustainable communities through making rural Ireland a better place to work \& live, by reviitalising rural villages \& town centers, through the implementation of vital initiatives such as The CLAR \& RAPID Programmes, Town \& Village Renewal Scheme \& and introduce measures that support people to live in Town centers.
- Pat Dowling the CEO, Clare County Council: dicussed new priorities \& measures for local Governement through the implementation of new cross cutting structures that can bring about a sustainable future for the Region.
- The Speakers addressed empowering local communities through the development \& support of the Public Participation Networks \& Local Community Development Committees, thus ensuring that all voices are heard \& included in the decision making processes \& that communities continue to identify their own solutions \& needs.
- The Speakers acknowleged that local authoirities have already undertaken Rural \& Regional development i.e LCDC \& the adoption of local community \& economic plans by the elcted members. The participants dicussed the framework that exist in each local authority Urban \& Rural designed to improve areas as places to work, live, invest \& visit.
- Pat Mc Donagh (local enterpener- Super-Macs) addressed the participants emphasing the need to support Entreprise \& employment, ensuring Rural Communities have the necessary skills to meet the meeds of the Labour market \& to continue to encourage innovation \& maximize assets.
- The Conference closed emphasizing the need to boost economic prosperity in Rural Ireland, while also supporting social progress through fostering culture \& creativity in rural areas thus ensuring the continually vibrancy \& well being of our local communities.

Conference opened by President Pat Daly on Thursday evening he talked about the challenges for rural villages and the achievements of AILG.
Friday morning started with Fr Harry Bohan he said the market economy was leading society and bemoaned the role of the family and community held in society.
He went through his efforts since 1968 to promote Regional Development and growth centers, the role banks played and lack of reinvestment in the community. It was rather like a basic sociology lecture that could have delivered 20 years ago. It was very much about FDI investment drives the economy how and social values and meaning of life are at the bottom of the pile

Pat Dowling Clare County CEO. He talked about enterprise hubs e working hubs. He said while its fine to have vision it requires team work to deliver and cross cutting themes. He outlined how their participative democracy works. Citizens networks

Pat McDonagh Economic boom and bust changed our international influence. He said that councils play a hugh role in defining people and communities. People connected to their place can fight back for rural lreland and try and turn around villages.
He emphasized that the Development Plan is very important to identify areas for strategic development. He also talked about tourism how every parish has a story to tell which can be connect to how emigrants want to find their roots.
We then had Pat Spillane who gave a very invigorating speech about action plan for rural Ireland. The need for people to move back into towns. He gave examples of how football managers motivated their teams and only focused on the team not the opposition.

Noel Kinahan spoke of Local public banking in Ireland. A considerable amount of work has been done to sell the idea of a Community Bank, meaning that profits are plowed back into the community. This is a system that has existed in Germany for over 100 years. He said that credit unions and post offices are too small in themselves but together could form a network throughout Ireland. This would give an opportunity to give mortgages and help SMEs start ups. The German model works on a regional basis. He said it started in Spain but that the moved away from the regional model and got too big so that is why it failed there. He was backed up by Harald Felzen who is project manager Savings bank foundation for International Co-operation from Germany. It's a very interesting concept and one that we badly need in Ireland.

Later that evening the Minister for Environment Simon Coveney spoke of his plans for housing. The most annoying aspect of this was that he spoke at us and we didn't have an opportunity to ask questions. He said there is legislation on the way for local government reform! Halleluiah

## Recommendations

I would like that AILG had more of a balanced focus between rural and urban Ireland.
Nonetheless the speakers were very interesting, especially the idea of the community Bank I also realized that the community networks spoken about by the Manager in Clare made me question what is going on in that regard in DCC?

## BACKGROUND - FUNDING LEVELS

- $363 \%$ increase in student contribution from 2007 to 2014 (€825 to €3000)
- Expenditure Higher Education as a \% of GDP (1.3\%) slightly behind OCED avg. (1.5\%)
~ $\sim$. 20.4\% decrease in Higher Education funding between 2004 and 2013
- 30,000 increase in student numbers between 2009 and 2014
- 10 of 14 Institutes of Technology in serious financial difficulty
- Ireland currently charges the 2nd highest higher education fees in Europe

## BACKGROUND - CASSELLS REPORT

- Need for additional annual funding of €600 million by 2021 and $€ 1$ billion by 2030 to deliver higher quality outcomes and provide for increased demographics
®® ๙ outcomes by expert group
- Supporting a predominantly publicly funded model would involve collecting €150m p/a from corporations


## WHY INVEST IN HIGHER EDUCATION?

- Small, open economy dependent on Foreign Direct Investment (FDI) requires accessible and high-quality tertiary education
- Multiple pillars of national policy (e.g. employability) dependent on higher education
- Significant benefit to public purse from higher education returns, including wage premium, increase taxation revenue, reduced dependency on the state, lower social transfer expenditure etc.
- Examples in other strong economically sound European countries


## INTERNATIONAL EXEMPLAR - GERMANY

- Investment in further education to provide for regional industrial demand and reduce demographic pressures on higher education
- Marginally higher \% of GDP than Ireland, efficiently delivering higher education at minimal cost to learner
- 12 high-ranking German public universities in the 2014-15 Times Higher Education World University Rankings
- Performance funding incentivises contribution to national objectives


## INTERNATIONAL EXEMPLAR - GERMANY (cont.)

- In 2015, the number of people entering higher education was the same of people enrolling in programmes in vocational training
- In Germany, evidence suggests that enrolment in non-fee states grew while it華 declined in those states with fees (though from a higher starting point) between
© 2007 and 2014
- Small free (€250 per annum) covers cost of administration
- Lowest youth unemployment rate in Europe


## HOW TO FUND HIGHER EDUCATION?

- Ireland's strong relationship between investment and return (OECD) makes a case for public funding as an investment in national prosperity
- Immediate public funding increase of $€ 1.26$ bn required to address urgent quality and sustainability challenges
- Higher education confers significant social benefit to the general population and ought to be treated as a public service


## HOW TO FUND HIGHER EDUCATION? (cont.)

- Following immediate investment, progressive investment over period recommended by the report in line with economic recovery
- Prospect of offsetting some state contribution through additional contributions to National Training Fund (NTF)

- Additional policy provision and legislative framework for Higher Education Institutes (HEls) to fundraise privately
- Increase percentage of tax revenue as a per cent of GDP (currently at 30\%) to the OECD average of $34 \%$ (re: NERI)


## IN CONCLUSION

- Research shows Income-Contingent Loans would cost the exchequer €10bn over 12 years (re: Dr Larkin and Dr Shaen)
- Dual apprenticeships and Higher Education in Germany programmes
