Cabra Area Office Report

Community Policing Forums

Cabra staff participated in recent forum meetings for Navan Road and Pelletstown and the Cabra Community Policing Forum along with the Gardai. The Pelletstown event had a particularly strong attendance with many questions raised concerning crime in the area.

LUAS

With the opening of the Luas line to Broombridge approaching, we have invited Luas management to attend a forthcoming NWAC meeting to outline their proposals for the management of the stations at Broombridge and Cabra and the access to these stations. Ciarán Browne, Project Manager LUAS Cross City, will attend the May NWAC meeting.

Mount Bernard Park extension proposal

DCC have had initial discussions with Transport Infrastructure Ireland (TII) in relation to the possibility of taking over the management of lands behind the new rail line, as an extension or as an addition to Mount Bernard Park. However, there are a number of serious issues involved, including the treatment of lands that suffered contamination by the former Coke Oven plant that operated there. DCC are currently exploring the options with TII but are not in a position to make any firm proposal until the issues have been fully assessed and costed.

Parking Issues

A number of complaints have been received regarding illegal parking in the environs of Dowth Avenue and the corner with Cabra Road. Parking Enforcement have been working with residents on this and there is an application on the TAG list regarding parking restrictions on Dowth Avenue. While the landings outside the shop units at Downey's pub are private and open to parking with the owners' permission, it is illegal to park along the pavement or to breach the Traffic Bye Laws and residents and visitors should note that Parking Enforcement are active in the area.

Carnlough Road Bottle Bank

We have continued to monitor the area and Councillor Perry has also submitted photographs and information regarding the condition of the area. This information is being made available to Waste Management. I also spoke with a nearby resident who is of the view that the bank is generally well kept but could be emptied more regularly. I understand that an impending planning application for a residential/retail development immediately adjacent is likely to be supported by local residents and that construction is expected to begin as soon as planning permission is received. This may present an opportunity for the relocation of the bottle bank although there is no specific mention of this in the application. In the meantime, it would seem appropriate to suspend plans for environmental improvement works if building works are expected to commence shortly.

Royal Canal Action Day

This will take place on April 22nd at various locations along the canal. The event coincides with An Taisce's National Spring Clean and is being organised by the Royal Canal Volunteer Group as an extended edition of the normal monthly clean up. Volunteers are invited to join at their nearest starting point from Sheriff Street to Ashtown.

Tree Planting

The tree planting Programme is now complete for 2017 but the Cabra Office has received a number of applications for planting, and is working with Parks Section and residents to assess locations that could be considered for the 2018 Programme

COMMUNITY & SOCIAL DEVELOPMENT

Team Dublin Clean-up.

This is a City Wide Initiative and many residents groups in the area will be organising clean-ups on Good Friday supported by DCC local offices. Phibsborough Tidy Towns will be organising their clean-up on Easter Saturday and plan to provide refreshments and music afterwards in the Library Garden or St Peters Court. An Taisce Spring Clean will continue throughout the month of April. St. Peters Avenue and Altona Terrace started planting and tidying on Saturday 1st April and Connaught Street had a clean up on the 25th March. The Faussagh Avenue group continue to clean and green the main thoroughfare and their work is very visible to everyone living and travelling through Cabra.

Comhairle na nÓg.

The group visited the Kippure Centre in Wicklow on a team-building exercise on the 11th and 12th April. This year they have chosen to focus on homelessness and its effects on young people. They are liaising with experts in this field of work to assess how the Comhairle can make a contribution to improve the situation during their term, highlight the situation, and make suggestions to the decision makers on this issue.

Rathborne Parent & Toddler Group

Hosted an Easter Party on Thursday 13th April from 10.30am-12 noon.

The Royal Canal Parent & Toddler Group

Meets on Friday morning from 10.30am-12 noon and is very well organised and attended.

The Clareville Centre held their AGM on 29th March.

Sympathy was extended to the families and friends of those residents who have passed away since Christmas, including the wife and brother of the Chairperson Mick Brophy. The Centre continues to provide an excellent service to all those who live there and those who attend the Centre for dinner and activities during the week.

Finglas Area Office Report

Widening of vehicular access to houses on Dunsink Avenue and Dunsink Road
The tender process is near completion. The Roads Maintenance Division has notified both the successful and unsuccessful firms. We are in a "standstill" period during which unsuccessful firms can appeal. If there are no appeals it is hoped that the work will start on site at the end of May.

Update on Kildonan Lands Project

BSM will present their draft report to the group chaired by Rita Burtenshaw, the Independent Facilitator, on the 4th May in the Finglas Office. The report will have three options. In addition to the report there will be a number of photomontages to illustrate potential of site options. Their report will then be amended before they make a presentation to next month's meeting of the NWAC.

Subsequent consultation during June will include some or all of the following steps:

- Put the plan on public display in the area office / local library / and, possibly, some community facilities;
- Plans to be shown on display boards.
- Put the plan on consultation for a period of one month;
- Give notice of the consultation in a local paper / on the DCC website;
- Distribution of leaflets about the consultation in adjoining estates;
- Draft plan will be available to view online;
- All comments will be collated / responded to in an Area Manager's report;
- Make any changes to the draft masterplan as deemed appropriate;
- Send Area Managers report to the NWAC Members seeking their approval for the Masterplan.

COMMUNITY & SOCIAL DEVELOPMENT

Community Gatherings

The Finglas East community gathering took place on Tuesday 28th March in Fr. Maloney Hall, Ballygall. Fifteen groups who are based in Finglas East area attended the event. The purpose of the meetings is to invite groups to celebrate and share information about their

organisations and to network informally with each other. It is hoped to have gatherings in Finglas West and Finglas South in June.



Finglas Arts Exhibition

The Community and Social Development Section has organised a community arts and crafts exhibition as part of the Bealtaine Festival. This event will be held on the times and dates below. We are currently linking in with local arts groups in relation to displaying art and crafts work or performing at the music event. This event will be held in St. Canice's Parochial Hall and St. Canice's Church.

Exhibition launch: Wednesday 31st May at 12:30pm.

Art exhibition opening times: Wednesday 31st May 1pm-3pm and 6pm-8pm.

Thursday 1st June: 12pm-3pm and 5:30pm-7:15pm.

St. Canices Church performance: Thursday 1st June at 7:30pm (invitation only).

Environmental Workshops:

The Community team in association with Global Action Plan will be hosting gardening workshops for members of the public attending the Older Adult Exhibition on Wednesday 24th May. A number of greening neighbourhood workshops (rejuvenation of communal open space) will take place during the summer months with community groups in the Finglas Area.

Finglas Men's Shed.

The Community team initiated the setting up of the Finglas Men's shed in March 2016. The team identified premises in the Abigail Centre. The first gathering of the shed took place on Wednesday 6th April 2016. Ten local men attended the first meeting. Over the coming months Dublin City Council refurbished the premises to include the following: new floor, new kitchen and toilet. The cost of the refurbishment was approximately €15,000. Dublin City Council also provided a pool table and chairs. The project also received a community grant. During the initial stages of their development the Community Team continued to support the group and organised trips to other Men's Sheds and advised them on events that may be of interest to the group. There are now fifteen members and they meet on Wednesday and Friday afternoons.

A number of members now work on a pollytunnel donated by Pavee Point on Wednesday and Friday mornings.

Some members of the shed have indicated that they would like to work on producing bird boxes, window boxes and seat benches. The Community team has, in conjunction with the Men's Shed, identified a suitable building for this purpose. The proposal for these additional premises will go before the Board of the Abigail Centre at their next meeting.

Dublin City Council will continue to encourage, support and work with the Men's Shed into the future.

Barnardos Spring Board Project:

Barnardos Spring Board Project provides information, support and advice to families, grandparents, children and young people who are experiencing a difficult time and who need a helping hand.

The project was based in Barry Close for a number of years but recently moved to Mulhuddart. The move took place due to anti-social behaviour and threats to staff.

The Community team worked with Barnardos to identify suitable premises in the Barry area so that the project can resume. The Board of Management of St. Josephs GNS, Barry Avenue, has agreed to let two rooms to the project.

It is anticipated that works on converting the rooms will be completed in a couple of months. Dublin City Council has supported the redevelopment of the rooms by making a contribution of €7,500. The overall cost of the redevelopment is around €25,000.

Finglas West Community Hub:

Finglas West Community Hub which is on the grounds of St. Kevin's BNS is currently not in use. The centre was closed as the facility was left in an unusable state and suffered from an infestation of rats. Issues have developed around the following:

- User groups not making a contribution towards the running costs of the facility. Annually it costs in the region €4,000.00 to run the facility.
- User groups not taking responsibility for cleaning and tidying the facility after use.
- Facility left in a usable state.
- User groups failing to attend meetings on a regular basis.
- Generally user groups failing to take responsibility for the facility.

The Board of Management of St. Kevin's BNS are concerned that continued inactivity of the facility will lead to anti-social behaviour. The facility requires a full time tenant that can manage, maintain and deliver services.

This work was undertaken with the co-operation of "The Ring Environmental Group" who had input into the design and choice of materials used. This group has been in existence for a number of years and has maintained this area to a very high standard. As this is one of the few green areas in the Cabra area, the Public Domain Team are keen to support this strong local environmental group in their valuable work.

Naming and Shaming Illegal Dumpers in Ballymun

In response to the recent Irish Business Against Litter (IBAL) reports, highlighting the high levels of illegal dumping in the West Ballymun area, DCC are utilising mobile CCTV around the Ballymun and Finglas areas to deter illegal dumping and where possible to identify the perpetrators and issue fixed penalty notices. CCTV surveillance around the Marewood Crescent area has captured images of individuals dumping bags of domestic waste on the nearby green area. DCC has installed a name and shame sign at the location with images of individuals caught in the act of dumping. This sign will be left in situ for a period and it is planned to erect similar signs in other locations where illegal dumping is prevalent.

Rugby: Thursday 3.30-4.30pm, Cabra Parkside Community Sports Complex -10yrs+ Delivered by DCSWP/Leinster Development Officer Stephen Maher.

• After School Groups: A 6 week small sided mini sports programme is continuing with 6th class pupils from the Finglas Youth Resource Afterschool Project. Activities include mini volleyball, hockey, olympic handball, athletics and basketball.

Adult Activities

A 4-week lead in programme for the Go 4 Life Games commenced with older adult groups at the Finglas Youth Resource Centre on April 12th.

A couch to 5K programme for inactive adults commenced at Mellowes Park on April 12th.

- **Primary School Girls 'Introduction to Basketball' Programme**: This 6-week programme is ongoing with 5th and 6th class pupils from St. Joseph's G.N.S. and St. Brigid's G.N.S. The sessions will cover the rules and regulations of the game alongside the basic fundamentals including dribbling, passing and shooting.
- Balance Matters/Falls Prevention: Weekly functional movement classes in Poppintree Community Sports Centre with referrals from local HSE physiotherapy. These classes will run throughout the year each Wednesday from 12-1pm and 1-2pm at a cost of €3 per class.
- A 6-week Badminton Programme continues with EVE Airdnua in Finglas targeting people experiencing mental health difficulties. This takes place on Thursdays from 11am – 12pm in Finglas Youth Resource Centre.
- An **Easter Multi-Sports Camp** will take place during the school holidays in Poppintree Community Sports Centre for local young people classed as youth at risk.
- **Sports & Fitness Ballymun** are offering specific classes for people with back pain every Monday at 12pm (in partnership with the HSE)
- Both Sports & Fitness Ballymun and Sports & Fitness Finglas have introduced a scheme whereby homeless people currently residing in nearby hotels can access the facilities at a reduced rate to assist with their physical and mental wellbeing (in association with DePaul)

FAI/DCSWP Football Development Officers – Update

- The Ballymun/Finglas Project Futsal (Football Foundation Programme) is ongoing. Sixteen students are studying to complete a FETAC Level 4 Full Award in Sports & Recreation. They are also on track to complete the FAI National D Coaching Licence. Many of the students are simultaneously studying for the ITEC Level 4 Fitness Instructors Award. The final exams for ITEC Gym Instructors will take place on May 8th.
- Coach Education: Safeguarding 1 / Code of Ethics & Good Practice in Children's Sport will take place in Leisure Point, Finglas on Monday 24th April from 6.30pm – 9.30pm.
- School Sessions: School sessions continue weekly in the following schools: Virgin Mary Girls School, St. Josephs Girls Primary School, NDSP Primary School and St. Malachy's Primary School.
- Social inclusion: Late night leagues will take place in Trinity Comprehensive School, Ballymun on Friday 9.00pm – 11.30pm on 5th, 12th, 19th and 26th May. They will also take place in Rivermount Hall, Finglas on Friday 8.30pm – 10.30pm on 28th April, 5th, 12th and 19th May.

Older Adult Programmes

- Go for Life This programme takes place every Monday from 1pm 2.30pm in Cabra Parkside Community & Sports Complex. The aim is to promote physical activity and encourage social support among the participants. The programme involves three throwing games where participants throw, lob and bowl items towards a target. The sessions are guided by the participants in terms of competitiveness. Challenge matches against other groups across the city are planned.
- Walking Football This programme is delivered every Tuesday from 11-1pm in Cabra Parkside Community & Sports Complex and every Thursday from 12-1pm in Poppintree Community Sports Centre. The session is delivered in partnership with the FAI. Open to men aged 55 years and older, it involves the same rules as ordinary soccer except players are not allowed to run. The aim of the programme is to provide an opportunity for men to take part in physical activity in a fun, friendly and social setting.
- Boccia with Whitehall Stroke Recovery Group: This programme continues every second Thursday in Whitehall Scout Den (11.30am – 12.30pm). The programme is run in conjunction with the Irish Heart Foundation.

Tai Ch

Tai Chi activity is open to all but attracting mainly older adults and takes place every Tuesday lunchtime in Poppintree Community Sports Centre.

A 6 week Tai Chi programme will be delivered with the National Learning Network, Phibsborough.

Ballymun Active Retirement Walking Group

This group meets every Tuesday at 10.15am in Ballymun Axis Centre and generally go on a 5k walk in one of the local parks. New members of all abilities are welcome.

Boxing

 Gold Sessions have commenced, these sessions are aimed at students who have shown potential in their former Bronze and Silver Sessions. They take place in the High Performance Gym, where they will partake in full-contact sparring. In these sessions, the Boxing Development Officers (BDO's) prepare them for the Showcase Finals, where they will get to display the skills they have learnt at the home of boxing in Ireland, The National Stadium. The following primary schools are participating:

> St. Canice's, Finglas St. Josephs Poppintree Our Lady of Victory, Ballymun

Transition year students from the following secondary schools are also participating:

St. Kevin's School, Finglas Scoil Eoin, Finglas St. Aidan's School, Whitehall

The BDO has also taken on a group of students from Scoil Chiaráin, Finglas. The
sessions consist of a modified version of boxing that focuses on fun, games, footwork
and accuracy. Some of the students are physically and mentally impaired while
others have varying degrees of autism, ADHD etc.

Cricket

- The Cricket Development Officer (CDO) is liaising with DCSWP Sport Officers in the area to organise the running of cricket programs for the coming months.
- From the first week of April, the 'Leprechaun Cup' competition will commence for Primary Schools right across the Dublin City area. This competition will run until June.
- **Provincial cricket sessions** continue on Friday nights from 5.00pm 9.30pm in North County Cricket Club where we have a number of players from the North West Area involved in these sessions. Players are between 10-18 years of age.
- School yard sessions will continue to be delivered in the following schools:
 - St. John Bosco NS (Cabra) Fridays 11am -12.30pm
 - St. Declan's College (Cabra) Fridays 1pm 2pm
 - Scoil Mobhi (Glasnevin) Tuesdays 11am 12.30pm
- Cricket Taster Day will take place on the 24th April, this is a joint initiative with the North Dublin National Schools Project, the Cricket Development Officer and the DCSWP Sport Officer, locations to be confirmed.
- A 6 week programme will commence on 3rd May in Finglas Parochial School and St. Brigid's National School, this is a joint initiative between DCSWP Sport Officer and Cricket Leinster.

1. Community Update

General Community

Team members attended the following meetings: Santry Community Centre Board Meeting, Aisling Transition Advisory Group, Aisling Poppintree Advisory Group, Poppintree Neighbours Day Meeting(s), Ballymun Allsorts (a new parents group that will meet in Shangan once a week), DNWAP, Ballymun Men's Shed, and Oak Park Residents. The Community team members facilitated a visit from Ballybeen Improvement Group to the Ballymun Area. This group were taken on a tour of Community Groups/Buildings in Ballymun and held discussions with local residents who gave them advice in relation to their upcoming regeneration process. Links were forged between various community groups in Ballymun and Ballybeen.

Social Inclusion

Men's Sheds

Community Team Members have had a number of meetings with the Ballymun Men's Shed to help facilitate the group's progress. Some of the Men's Shed Group is due to commence a five week woodwork course in the newly refurbished Rediscovery Centre. Meetings in relation to possible premises in DCU and Shanliss Road are ongoing.

Older Persons

Community team members linked with the following groups:

U3A, Active Living, Coultry Crafts, Sandyhill Residents, Burren Court Residents, Age Friendly Group, Whitehall Active Retirement Group. Team members organised a going away party for Pat Ledwidge, DCC Liaison Officer, which took place on Monday the 13th March at 2pm in Marewood Court. Residents from Burren Court, Ard na Meala, Sandyhill Gardens and Griffith Crescent attended this fun community event.

Ladies Groups

Community Team members provided ongoing support to both Sillogue Ladies Group and the Sillogue Neighbourhood Centre as they grow their user groups, in particular assisting with the International Women's Day Event on Wednesday March the 8th which was a great success. The team members also worked with the Centre for the final stages of planning for the Easter Bonnet Event which took place on 12th April. Ballymun Area Office is supporting the Centre to fund a new floor and good quality chairs. The Centre is becoming a real hub for local groups and educational courses.

Mental Health

Team members are continuing to meet in relation to the Green Ribbon campaign, which they hope to roll out to local groups in May. A team member joined an inter-agency sub group for the MOJO Project and a meeting will take place on Thursday the 30th April.

Environmental

The team is working with Public Domain Staff to promote the Big Clean up on Good Friday. It is envisaged to have environmental groups cleaning up their area in advance of the planting season. The team is putting together a list of local groups who will receive summer bedding plants for their area. It is hoped to roll out a phased delivery system between April and June. The team has met with GAP in relation to five greening area workshops for the year.

Events

Team members worked on an event for National Tree Planting Week with St Josephs National School. This event took place in Poppintree Park on 10th March at 10:30am. The first Festival Ideas Gathering took place on Monday the 3rd April in Axis Theatre. This

meeting focused specifically on the Halloween Festival for 2017 and was a great success with over 20 attending and exchanging ideas that will hopefully be incorporated in this year's festival.

2. Housing/Estate Management Updates

Housing/Estate Management

C.C.T.V

The initial work on integrating the two operating systems has been completed. The remaining work on the system will continue on a phased basis throughout the year.

Cleansing / Waste Management

Waste Management and the Area Office are continuing to combat illegal dumping at open spaces. These measures include using the C.C.T.V system to monitor and identify those responsible. The area office has targeted illegal dumping around Whiteacre, Forestwood and Termon Court. A number of tenants have been called and warned about their behaviour.

Clean-ups

Skip-bags have been organised for some Dublin City Council tenants in Coultry to help them to clear the rubbish in their houses and in their gardens.

Maintenance Work

Hedges at a number of tenancies in the Coultry Drive area will be trimmed in the coming weeks.

Insulation

Insulation work is nearly done in Coultry and coming to an end in Shangan.

Illegal Dumping

Public Domain in conjunction with the Project Estate Officers in Ballymun continues to target residents who are illegally dumping. There is currently a dumping programme in place to try and target households who have no bin providers. The mesh railings that were erected around the ESB box on Carton Road have proven to be very successful. There has been no illegal dumping in this area since the railings were put up. Estate management have met with residents from Knowth Court with a view to continuing the painting and estate enhancement programme that has been ongoing in 2015 and 2016.

Projects

It is a busy time with the "Big Dublin Clean-up" and National Spring Clean, with DCC providing constant support and encouragement to any resident groups taking part. We supply all clean up equipment necessary, assist with the application process and remove any bags of rubbish after clean up is complete.

Senior Citizens

There are a number of new environmental projects that Public Domain in Ballymun has identified. Sandyhill Gardens Senior Citizens Complex is one that we are currently looking at improving with assistance from the Liaison Officer and residents in the complex.

Graffiti

The graffiti programme has identified most areas in the North West area and a contractor has been appointed to start removal.

Residents Groups

Public Domain is constantly linking in with groups. We continue to provide all clean up and planting projects. New groups are coming on board to form Environmental Groups in Knowth Court, Druid Court and Shangan Avenue.

CRM

Our system for logging complaints is updated daily and all jobs delegated to appropriate supervisors. Any complaints of a public domain nature can be logged on Fixmystreet.ie

<u>Upgrading insulation</u>

The insulation and energy rating of the houses in Sillogue area is underway. This programme of works has been rolled out through the Ballymun area.

Pyrite

Remedial works are well underway for the pyrite works in the Carton Estate. We are half way through the programme with the builder taking 10 houses for remedial works at a time. The families are being re-housed temporarily in accommodation in the surrounding area for a seven week period.

Consultation for Super Depot

Dublin City Council held open meetings for the residents of Carton in the Poppintree Community Centre and the residents of St Margaret's Halting Site in the community room in St Margaret's to give information on the proposed Super Depot for the site to the front of Carton Way and IKEA. The residents were given information on the proposed use of the building and provided with an opportunity to have an input into the process before a design team are appointed. When a design team are appointed a planning application will be made.

Anti-social behaviour

There have been a number of complaints relating to anti-social behaviour in the parks mainly Poppintree Park. This issue has been raised at the Safer Ballymun meeting and a commitment to address these problems has been given by the Gardaí in the Ballymun station.

3. Ballymun Economic Development/Town Civic Alliance

Economic Strategy

An Economic Sub-Committee discussion took place on 23rd March 2017. The main item discussed was in relation to a site of 0.8 hectares to the front of St. Margaret's Industrial Estate. The site is designated for employment and enterprise opportunities in the draft LAP and it is the intention of the Economic sub-committee to ensure it stays this way.

Stimulating economic activity

Start-Up Ballymun

The next Start-Up Ballymun event will take place on Wednesday 26th April 2017 in the Council Chamber. The theme for the event is 'The Business of Health & Fitness'. Ballymun4Business (B4b)

B4b hosted a networking event in the atrium of the Civic Centre on Wednesday 15th March. There was a great turnout for the event that has resulted in a number of additional new members. The new website is now live: www.b4b.ie, it still requires some minor updates and amendments. Dublin City Council provided the funding for the website.

Enterprise Space

Food Enterprise – A visit to the Cork Incubator Kitchens in Carrigaline in Cork Co. Co. took place on Thursday 16th March. The facility supports early stage food businesses: http://www.corkincubatorkitchens.ie/ The purpose of the visit was to inform an overall piece being done to assess the viability of food enterprise space in Ballymun. The visit was very informative with some interesting outcomes. A report of the visit will be shared with the Economic Sub-Committee.

Vacant Neighbourhood commercial units – Negotiations will commence shortly with a pharmacy for unit D in Coultry. The 2 units in Shangan have been vacated by the Rediscovery Centre and will be advertised shortly.

Free Wi-Fi for Plaza – The Wi-Fi installation has been completed and is now fully functional. The Economic Sub-Committee spoke about running a local competition between local community groups to launch the Wi-Fi once the weather improves. This will be progressed over the coming weeks.

Civic Alliance Update

The next Civic Alliance meeting will be held on 1st June 2017.

The Economic Sub Committee meeting was held on 23rd March 2017. There was an update on unemployment by Mick Creedon and agreement that the Youth Guarantee Scheme should be examined to see if it can be replicated for the over 25 age group. The timeline for the LAP was outlined and it was agreed that the Committee would make a submission regarding a vacant site that is currently available for economic development and to examine the opportunities for economic and enterprise use. The Wi-Fi is now in place and working and a community event will be organised on the Plaza as the official launch. There will be another Start Up Ballymun event on 26th April - the event will highlight the Business of Sport & Fitness. B4B recently held a successful networking event to launch their new website. The Child & Family Resource Centre are at an advanced stage in launching a CoderDojo for Ballymun and will be circulating a letter requesting funding and volunteer mentors via B4b.

The next meeting of the Physical /Environmental Sub Committee will be held on 13th April 2017. The next meeting of the Social Sub Committee will be held on 24th April 2017.

Draft Ballymun Local Area Plan: The City Council invites interested parties or individuals to make submissions or observations with respect to the Ballymun Draft Local Area Plan during the public consultation stage, Wednesday 5th April 2017 to Wednesday 17th May 2017 (both dates inclusive)

A series of public information sessions will be held in the Ballymun Civic Centre, Main Street, Ballymun, Dublin 9 on the following dates:

Thursday 6th April: 17.30 – 19.30

Shopping Centre: There is no update since the last meeting. Notices to Treat have been served on two of the occupiers. Terms have been agreed with the two other remaining occupiers to relocate to the Ballymun Civic Centre.

Ballymun Northern site: Our Law Department is currently dealing with some queries from Lidl in relation to the site. When these concerns are resolved it is anticipated that the Agreement for Lease will be signed. Under the terms agreed Lidl will endeavour to lodge for planning within 8 weeks of signing the Agreement for Lease.

Housing site: Balbutcher Lane-Cranogue Road Site, Ballymun- The deadline for receipt of replies/objections from the relevant Departments within DCC was 27th March 2017.

The Acting Chief Technician of DCC's Water Service Division has advised that this Department contact Irish Water regarding the proposed disposal as the site is affected by a water main and three Fire Hydrants. As soon as Irish Water's position is established, all replies will be reviewed and assuming that there are no objections to the disposal it is proposed to offer the site to the market without delay.

Safety Fora Updates

Safer Ballymun

The next meeting of the Safer Ballymun Community Safety Forum took place on Tuesday April 11th.

<u>Drumcondra Glasnevin Community Forum</u>

The most recent meeting of this forum took place on March 29th 2017 in the Maples Hotel, Drumcondra. It was well attended by residents, local representatives and Gardaí. Gardaí gave the statistics for the period from the last meeting and advised people to be aware of their personal safety and also to lock doors, cars etc especially at night. Burglaries are dropping as Gardaí actively target criminals using the road network to carry out their crimes. There were discussions about traffic congestion in the area, repair works required for paths and roads and the 6 month trial of Option 6 on Walsh/Ferguson Road that is due to commence in the coming months. Samantha Fahy from DCU gave a presentation on how the college is trying to manage the mobility of almost 20,000 students and staff as they travel both in and out of the city and between campuses on a daily basis.

The next meeting is scheduled to take place on Wednesday June 28th.

Part 8 for Glasanaon Court, Glasanaon Park, Dublin 11.

(a) Planning and Development Act 2000 (as amended) & Planning and Development Regulations 2001 (as amended) (Part 8)

(b) Local Government Act 2001

In compliance with the provisions of Section 179 of the Planning and Development Act 2000 (as amended) and Part 8 of the Planning and Development Regulations 2001 (as amended) and in compliance with the provisions of the Local Government Act 2001 and pursuant to the requirements of the above, notice is hereby given of Dublin City Council's intention to carry out the following works:

(A) The Site

The site is located on the northern side of Glasanaon Road, Dublin 11. There are 5 no existing two-storey blocks containing 40 no bedsits, 8no 1-bed units and 1no 2-bed unit. Block No 5 fronts onto Glasanaon Road and is located behind a low plinth wall with a railing. Blocks 1, 2, 3 and 4 together with 10 no existing two-storey houses front onto Glasanaon Park.

(B) The Proposal

The development proposes the amalgamation of the existing 40 no bedsit units, 8 no 1-bed units and 1 no 2-bed unit at Glasanaon Court, (known as numbers 1 to 8; 9 to 17; 18 to 25; 27 to 30; 33 to 36; 39 to 42; and 45 to 48, Glasanaon Court), Glasanaon Park, Dublin 11 into 21 no 1-bed apartments.

It is also proposed to insulate the buildings internal walls and ground floors, replace windows and doors and introduce attic insulation.

The proposed works will upgrade the existing units to proivde fully accessible units at ground floor and are an improvement on the existing accomodation standards. The proposed works will provide higher levels of comfort for the occupants as well as achieving higher energy ratings and reducing carbon emissions.

(C) Site Planning History

There is no recent relevant planning history in respect of this site.

(D) Area Committee

At the 20th September 2016 meeting, the North West Area Committee were informed of the intention to commence the Part 8 process relating to this project.

(E) Statutory Submissions/Observations

None

(F) Internal/Consultee Reports

Drainage Department report received: No objection however conditions are recommended.

(G) Evaluation/Assessment

Implications of the Proposed Development for the Proper Planning and Sustainable Development of the area:

Land Use Zoning Objectives of the 2016-2022 City Development Plan

The site is located in an area subject to land use zoning objective 'Z1', which states 'To protect, provide and improve residential amenities'. The proposed development complies with the zoning objective for the area.

Policy Assessment:

In addition to the policies listed below Section 16.10.1 Residential Quality Standards of the Development Plan 2016-2022 and Sustainable Urban Housing: Design Standards for New Apartments 2015 are relevant when assessing applications for senior citizen accommodation.

SN7: To support and encourage the future growth of a wide range of public, social and community services essential to local community life, and to promote and seek to provide multi-use, fit-for-purpose community facilities which are suitable for all ages and all abilities, are operated according to an effective and efficient management strategy, and which are accessible in terms of physical design, location, cost of use, and opening hours.

SN25: To actively support urban regeneration in areas across the city in order to enhance social cohesion and potential for positive change in areas of social exclusion.

SN30: To promote sustainable neighbourhoods which cater to the needs of persons in all stages of their lifecycle i.e. children, people of working age, elderly, people with disabilities.

Planning Assessment

The proposed works are confined to the amalgamation of existing units, thermal upgrade and accessibility of the 5no blocks only and do not include works to the existing external environment.

Blocks 1, 2 and 3 were constructed in 1977 and currently comprise 24no bedsit units and 1no 2-bed unit. The bedsit units are approx 22.5sqm each. The first floor units have desk access. These units do not have balconies. Blocks 4 and 5 were built in 1985 and comprise 16no bedsit units and 8no 1-bed units. The bedsit units are currently 26sqm. There is deck access at first floor level and these units have balconies.

The proposed works will result in 21no 1-bed apartments for senior citizens. The proposed apartments in Blocks 1, 2 and 3 (13no units) are 45sqm each and the proposed apartments in Blocks 4 and 5 (8no units) will be 52sqm. The ground floor units will be fully accessible. The ground floor units in Block 1, 2 and 3 will be provided with wheelchair accessible terraces and the first floor units will have French type balconies which can be upgraded to full sized balconies when funding becomes available.

Section 16.10.1 Residential Quality Standards of the Development Plan 2016-2022 and Sustainable Urban Housing: Design Standards for New Apartments 2015 set out standards for apartment design. The minimum overall floor area for a 1-bed apartment is 45sqm. It is a requirement that the majority of all apartments in a proposed scheme of 10 - 99 apartments

must exceed the minimum floor area standard. It is proposed that 8no of the proposed 21no apartments will be above the minimum floor area. These units are 52sqm. While this is not that majority of apartments it is acknowledge that the units are existing and the proposed floor areas are substantially larger than the existing floor areas.

It is also a requirement that a maximum of 25-30% of 1-bed units be provided in a development of over 15no units. However the Development Plan 2016 – 2022 states that this standard may not apply to certain social housing needs and / or where there is a need for particular form of housing for older people and students having regard to the housing strategy. Therefore the provision of 21no -bed apartments for senior citizens is considered acceptable in this instance.

There are no proposals to alter the vehicular access arrangement or car parking on site. As the works will reduce the number of units on site it is considered that there will be less vehicular movements generated by the development.

Appropriate Assessment

Having regard to the nature and scale of the proposed development and the proximity to the nearest European site, no Appropriate Assessment issues arise and it is not considered that the proposed development would be likely to have a significant effect, individually, or in combination with other plans or projects, on a European site.

Recommendation:

The proposed development has been assessed and it is considered consistent with the provisions of the Dublin City Development Plan 2016-2022 and would be in accordance with the proper planning and sustainable development of the area. Accordingly it is recommended that a decision be made by the elected members of the Council to proceed with the proposed development subject to the requirements of the internal City Council Divisions set out below.

- 1. The following requirements of the Council's Drainage Department shall be complied with:
- a) There is no objection to this development, subject to the developer complying with the Greater Dublin Regional Code of Practice for Drainage Works Version 6.0 (available from www.dublincity.ie Forms and Downloads).
- b) The development is to be drained on a completely separate system with separate connections to the public foul and surface water systems.
- c) A connection from this development to the public Surface Water sewer network will only be granted when the developer has obtained the written permission of the Drainage Division and fulfilled all the planning requirements including the payment of any financial levies. All expense associated with carrying out the connection work are the responsibility of the developer. Developers are not permitted to connect to the public drainage network system without written permission from the Drainage Division. Any unauthorised connections shall be removed by the Drainage Division at the developer's expense. A licence will be required from the Drainage Division to allow the connection work to be carried out. Permission of the Roads Dept must also be obtained for any work in the public roadway.
- d) There are existing public sewers running through the site. A clear distance of three metres shall be maintained between sewers and all structures on site. The exact location of pipelines must be accurately determined onsite prior to construction work commencing. No additional loading shall be placed on DCC or Irish Water's sewers. Any damage to it shall be rectified at the developer's expense.

- e.) The developer shall carry out both a pre- and post-construction CCTV survey on the public sewers affected by this development, as agreed with Drainage Division. The pre-construction survey is to be submitted to the Drainage Division prior to works commencing on site. The post-construction survey is to be submitted to the Drainage Division for written approval and any damage to the sewer shall be rectified at the developer's expense.
- f) As no drainage details have been submitted, the developer shall submit two copies of a detailed site drainage plan directly to the Drainage Division of Dublin City Council for written approval. These plans shall be submitted not later than the submission of the commencement notice for the development, and drainage works shall not commence prior to the issuing of such written approval
- g) The development shall incorporate Sustainable Drainage Systems in the management of stormwater. Full details of these shall be agreed in writing with Drainage Division prior to commencement of construction.
- h) The developer shall ensure that an appropriate flood risk impact assessment, in accordance with the OPW Guidelines, is carried out for the proposed development.
- i) The outfall manholes from this development must be constructed in accordance with the Code of Practice for Development Works Drainage.
- j) All surface water discharge from this development must be attenuated to two litres per second per hectare.
- k) An appropriate petrol interceptor shall be installed on the internal drain from the car park. Please refer to section 20 of the Greater Dublin Regional Code of Practice for Drainage Works Version 6.0.
- I) Dublin City Council's Drainage records are indicative and must be verified on site. The Developer must carry out a comprehensive site survey to establish all drainage services that may be on the site. If drainage infrastructure is found that is not on Dublin City Council's records the Developer must immediately contact Dublin City Council's Drainage Division to ascertain their requirements. Detailed "as-constructed" drainage layouts for all diversions, extensions and abandonment of the public drainage network; in both hard and soft copy in an approved format; are to be submitted by the Developer to the Drainage Division for written approval. See section 5 of the above-mentioned Code of Practice for more details.
- m) . All private drain fittings such as, downpipes, gullies, manholes, Armstrong Junctions, etc. are to be located within the final site boundary. Private drains should not pass through property they do not serve.
