#### Cabra Area Office Report

#### Faussagh Avenue Upgrade

The proposal to landscape the grounds on front of the church car park has, unfortunately, been rejected by the Parish Council due to concerns regarding potential anti-social behaviour. We did our best to reassure them regarding the scheme but must respect their decision. However, we will proceed with plans to plant a number of trees along the avenue initially and to upgrade the planters at the shops. We are also exploring other possibilities for enhancement.

Meanwhile, we are maintaining communications with Clúid to establish what their plans for landscaping will now be and hope to have confirmation of those shortly.

#### Mount Bernard Park

#### Park extension proposal update

Transport Infrastructure Ireland (TII) has now indicated that they are not in a position to transfer the lands adjacent to the LUAS line to DCC. The main reason given is that:

TII do not have a remit for land development (other than for roads and public transport works), so they're not allowed to allocate funding to those types of works. It has always been NRA (and now TII) policy for lands acquired under capital schemes and which are surplus to requirements, that they are disposed of in an 'undeveloped' state. In the event that TII require additional lands (in the medium to long term) to support Luas maintenance functions using these lands might be an option.

While this remains TII's position it is unlikely that a transfer of the lands will proceed. The satisfactory condition of the lands would be a significant factor to be considered in any acquisition by DCC. We had previously indicated to TII that DCC would be interested in taking these lands, subject to TII paying for the necessary remediation. We would also need an agreement on liability for any contamination related issues that might arise in the future.

I will keep the NWAC informed of any further developments.

#### Playground extension

The final soil testing report has now been approved by the Parks Department. Consequently, the playground contractors have been instructed to prepare their method statement and all health & safety documents - the start date may be in advance of this meeting.

#### **Ormond Print works**

I inspected this premises with Sgt. McGilloway from Cabra Station who is very familiar with activity there. The premises has been broken into and used for drinking sessions and also for storing and watering horses. These issues have been reported to Irish Water and the Control of Horses Unit, respectively.

In addition, whoever is accessing these premises used an angle grinder to remove both new and older fences connecting the premises to the canal and the new Ratoath Bridge. Again, this would seem to be to facilitate access for horses and motor bikes onto the canal bank as well as on the premises.

Derelict Section have been notified and will review the case file and inspect as the premises is acting as a focal point for a wide range of anti social behaviour that is having a serious impact on the surrounding area.

#### Ratoath Road Flyover

- i) In association with the Ormond Print issue above, the fencing connecting the bridge to the canal at the Ashington side has been the subject of vandalism with bolts securing the fencing being removed and replaced by locks and cable ties. This appears to be to allow access to the canal for horses and motor bikes. The issue has been referred to our Roads Department who will contact Irish Rail to try and address this situation.
- ii) Irish Rail has informed our Roads Department that they have engaged a contractor to conduct remedial works to prevent further flooding on Ballyboggan Road following heavy rain. This work is scheduled to be carried out on the June Bank holiday weekend.

#### Ratoath Road - Dominican Schools

Sgt. McGilloway and I attended a meeting at the convent to review the traffic issues there regarding dropping off and collection of children. All agreed that they are not easily resolvable and the convent will review their own internal traffic arrangements. Traffic Section will conduct a speed test at the bridge where it meets the road due to its proximity to Marian School and associated support units.

#### Royal Canal Action Day

The Action Day on April 22<sup>nd</sup> was a great success with many residential and voluntary groups participating. Groups in Rathborne, Royal Canal Park, Shandon and the Royal Canal Volunteer Group all had very successful clean ups assisted by DCC Waste management and local area offices.

#### Tree Planting

The tree planting programme is now complete for 2017. However, the Cabra Office has received a number of applications for planting and is working with the Parks Section and residents to assess locations that could be considered for the 2018 programme.

#### Carnlough Road Bottle Bank

Cabra Office received a further complaint regarding the bottle bank from Councillor Perry. This has been passed to Waste Management.

#### **Finglas Area Office Report**

#### **Barry Shops**

The complex is being acquired by new owners. At a recent meeting in my office the new owners outlined their plans for upgrading the units to provide a broader range of retail activities before the year end. I subsequently visited the site with our Public Domain Officer and agreed a number of actions to be undertaken by the Area Office to support this welcome development.

#### **Liverpool Twinning**

At last September's NWAC a Motion was adopted "That the office of international relations assist the village of Finglas to establish a cultural connection/sister village relationship with an urban village in one of the following Cities currently twinned with Dublin City: San Jose, Liverpool and Barcelona."

I subsequently briefed staff from the Office of International Relations and Social Inclusion on the possible focus of a twinning and the demographics of Finglas. They then conveyed this information and the details of the Motion to the Office of the Lord Mayor of Liverpool. Unfortunately, our request became entangled in internal confusion about the intent of our request. The Office of International Relations and Social Inclusion recently renewed contact with Liverpool with the aim of reinvigorating the initiative. We await a response.

Our proposal is opportune as 2017 marks the 20<sup>th</sup> anniversary of The Twinning Agreement between Dublin and Liverpool.

#### Update on Kildonan Lands Project

BSM presented their draft report providing an overview of three potential options for the Kildonan site to the group chaired by Rita Burtenshaw, the Independent Facilitator, on the 4<sup>th</sup> May in the Finglas Office. The Group unanimously favoured option (c) for the following reasons:

- It maximises the use of the land for the provision of much needed homes.
- There are no large public buildings with unspecified uses.

The group also made a number of recommendations to the planners.

I wish to acknowledge the hard work and commitment of the members of the group which has enabled the process to reach this stage.

BSM will present their updated report at today's NWAC meeting. Subject to NWAC approval, it is intended to undertake a public consultation of the options during June.

#### Historians in residence/Grants

It is important to note that a significant number of additional complaints were also investigated as all area staff pick up complaints when carrying out daily duties but due to lack of resources all complaints are not logged.

#### Enhancements

A decorative stone wall at the entrance to St. Canices Church, on Church St, Finglas was recently damaged when a vehicle crashed into it; it has been repaired. The repair was completed by a specialist Stone Mason, in a manner sympathetic to the original design, maintaining the character of the site. Benches at Harts Corner, situated adjacent to the planted traffic island have been repainted. New gates have been installed at the laneway at Collins Place, which should reduce the extent of dumping in this laneway and which will now give access to the laneway to facilitate periodic cleaning. New tree pits, to allow for summer planting by the Finglas Tidy Towns Group, have also been installed around the trees on

Seamus Ennis Road, outside the Credit Union. Work is also ongoing on the installation of railings at the green space between Kippure and Barnamore, with the intention of preventing motor cycles from accessing St. Helena's Road, from the green area.

#### Team Dublin Clean Up 2017 Report

The 2<sup>nd</sup> Annual Team Dublin Clean Up event took place on the morning of Good Friday, April 14<sup>th.</sup> The event was well supported city wide, with residents and environmental groups in the NWA, as always, to the fore in terms of events run and numbers participating. Residents and Environmental Groups in the NWA were notified of the event by the Public Domain Team and a total of 26 groups registered to hold a cleanup event. The Public Domain Team supplied clean up equipment and support was provided after the day with bags being collected for disposal.

Excellent work was done by the environmental groups in the courts in Ballymun, where a large number of local residents turned out to further enhance their area, with weeding and edging being done. The Finglas Tidy Towns Group organised the event in Finglas Village, where a large crowd generated a festive feel, with refreshments being provided by the Public Domain Team. Good work was done by all other groups, including the Rediscovery Team on the Ballymun Road, by Phibsboro Tidy Towns on Saturday 15<sup>th</sup> and by the residents of Ballygall Senior Citizens Complex. In total over 300 bags were removed by DCC in the NWA after the weekend, providing an indication of the success of the event.

#### Enforcement

Further enforcement work has been conducted by the Public Domain Team in the NWA. In response to the high level of dumping on the green space adjacent to Barry Close and Barry Drive, residents who had previously been notified of their responsibility under the Bye Laws to have a method for the disposal of their domestic waste in place were subsequently contacted and requested to provide this information. A number of Fixed Penalty Notices were issued to those residents who failed to do so. Further enforcement work has been carried out on the Cabra Road, in particular relating to breaches of the Litter Pollution Act 1997. Title searches have indicated the owners of several multi occupancy units in the area and enforcement work will be carried out in the upcoming weeks. Enforcement activity has also been recently undertaken in several other locations in the NWA.

#### Weed Spraving 2017

The annual weed spraying programme in the NWA is expected to commence during the week starting 15<sup>th</sup> May. Weeds on public roads and footpaths throughout the area are currently sprayed twice a year in early summer and autumn. This spraying is conducted, on behalf of DCC, by contractors Greentown Environmental, who have undertaken this work for the last number of years and have become a familiar sight, operating on quad bikes and on foot in the area. Residents who wish to report locations that require attention can contact the NWA Public Domain Team, on the email below. The NWA is scheduled for a second round of spraying in mid August.

#### Dog Fouling Bins

The next batch of dog fouling bins is due to be installed in the upcoming weeks, in various locations around the NWA. These bins have proved to be extremely popular with dog owners and residents alike, with demand for their installation far outstripping the available supply. Additional dog fouling bins will be installed at Park entrances, to supplement existing ones and along routes frequented by dog owners.

Subject to the further availability of bins, requests for installations at specific locations can be made to the Public Domain Team using the email address below.

#### Assistance to Residents Groups

The participation of residential/environmental groups in the upkeep of their roads/areas is of huge importance in making the NWA a good place in which to live and work. Increased community cohesion is also achieved by neighbors working together to enhance their location. Some notable successes have been achieved by environmental groups in the

NWA, particularly in areas previously blighted by anti social behavior, such as illegal dumping and graffiti.

The Public Domain Team is able to offer assistance to groups who wish to be involved in enhancing their area. Clean up equipment can be provided and rubbish can be collected after clean ups and disposed of. Paint and painting equipment can also be supplied to groups who wish to paint walls. Other appropriate assistance is available, based around the needs identified of the particular environmental group. New or existing groups are encouraged to contact the Public Domain Team to explore what assistance can be provided to them.

# **Dublin City Sport and Wellbeing Partnership Report**

 Go For Life – The Citywide Finals of the Go for Life Games takes place on Tuesday, May 16<sup>th</sup> in Ballyfermot Sports & Fitness. DCSWP Sports Officers will bring teams of older adults from their respective areas to compete in the event and try to qualify for the National Finals on June 10<sup>th</sup> in DCU. The aim is to promote physical activity and encourage social support among the participants. The programme involves three throwing games where participants throw, lob and bowl items towards a target.

#### Activities with Finglas CTC:

A 6-week drop in soccer programme commenced with trainees from the Finglas Community Training Centre on Wednesday May 10th on the astro pitches at Finglas Sports & Fitness.

A 6-week multi sports and games session is commencing with trainees from the Finglas Community Training Centre on Tuesday May 16th in the sportshall at the Finglas Youth Resource Centre. Activities will include volleyball, uni-hockey, basketball and tug of war.

## • Afterschool Fun & Games with St. Helena Resource Centre:

Afterschool fun & games is currently ongoing with 5th and 6th class pupils from the St. Helena Resource Centre every Tuesday and Thursday throughout May. Games will incorporate physical literacy skills including movement, agility, balance and coordination.

#### • Scoil Chiaráin Special School:

A six week introduction to tennis and cycling safety initiative is taking place with special needs pupils from Scoil Chiaráin during May and June. Both of these programmes are excellent for increasing pupil's co-ordination, balance and self confidence.

#### Youth Programmes - Poppintree

A multi-sports programme will take place in a variety of venues including Poppintree Sports & Community Centre and Poppintree Park throughout May and June. These sessions are aimed at engaging youth at risk. The programme is run in partnership with local youth groups.

## Active Flag

A wide variety of activities is planned for local schools completing their Active Flag Award including fencing and 5-a-side soccer. Partners include local primary schools & NGB's.

#### Active School Week

Support will be given by the DCSWP Sports Officer to local schools in Cabra to assist with Active School Week. Active school Week consists of schools becoming more active in terms of its engagement in daily physical activities. The whole school community is encouraged to get involved through walking and cycling to school, skipathons, penalty shootouts, trying new activities and physical activity homework to get the family involved!

## • National Learning Network - Soccer Sessions

A Soccer programme for the National Learning Network is ongoing during May, aimed at engaging people experiencing mental health problems. Sessions will take place every Friday from 2pm - 3pm in Cabra Parkside Community Sports Complex.

Walking Football – This programme is delivered every Tuesday from 11-1pm in Cabra Parkside Community & Sports Complex and every Thursday from 12-1pm in Poppintree Community Sports Centre. The session is delivered in partnership with the FAI. Open to men aged 55 years and older, it involves the same rules as ordinary soccer except players are not allowed to run. The aim of the programme is to provide an opportunity for men to take part in physical activity in a fun, friendly and social setting.

#### Aqua Aerobics

An Aqua Aerobics programme takes place in Inspire Gym, Cabra, every Wednesday from 12pm - 1pm. The programme is aimed at older adults with the aim of improving water confidence, fitness and social connections. The programme is delivered in partnership with Swim Ireland and Dublin City Council and will run until June 28th.

#### Swimming Programme

A swimming programme has been developed in partnership with Dublin City Council, Swim Ireland and the Cabra Youth Service. The programme is ongoing and will finish in early June. Young people that were previously engaged in activities organised by the DCSWP Sports Officer and the youth service were identified as requiring additional support in relation to swimming.

This need was apparent as there had been a number of incidents involving young people swimming in the local canal and jumping into the Liffey etc. Community members, agencies and young people all highlighted the need for this and as such, the programme, providing a life-long and life saving skill, was developed. It runs in Sean McDermott Street Pool on Tuesday nights from 8pm - 9pm.

#### Access Programmes (Boys & Girls)

Badminton: Monday 4-5pm, Cabra Parkside Community Sports Complex - 10yrs+ Basketball: Tuesday 4-5pm, Cabra Parkside Community Sports Complex - 13yrs+ All sessions delivered by DCSWP Sports Officer Maz Reilly

- Balance Matters/Falls Prevention: Weekly functional movement classes in Poppintree Community Sports Centre with referrals from local HSE physiotherapist. These classes will run throughout the year each Wednesday from 12-1pm and 1-2pm at a cost of €3 per class.
- **Sports & Fitness Ballymun** are offering specific classes for people with back pain every Monday at 12pm (in partnership with the HSE)

 Both Sports & Fitness Ballymun and Sports & Fitness Finglas have introduced a scheme whereby homeless people currently residing in nearby hotels can access the facilities at a reduced rate to assist with their physical and mental wellbeing (in association with DePaul)

### **General Community**

Community team members provide ongoing support to Sillogue Ladies Group and ongoing assistance to the Sillogue Neighbourhood Centre as they grow their user groups, in particular assisting with the Easter Bonnet Event which took place on 12th April and the FACT (Families with Autism Coming Together) Mad Hatters Party which took place on April 27<sup>th</sup> for Autism Awareness Month. Ballymun Area Office recently funded a new good quality floor for the main room and good quality chairs for events.

### Mental Health

Team members are continuing to meet in relation to the Green Ribbon campaign, and will promote this campaign at the Ballymun in Bloom Event and Breakfast Bingo Event in Sillogue Neighbourhood Centre. Ribbons will be distributed to various community groups. Team members attended a number of meetings in relation to the MOJO Project (housed in BRYR).

### **Environmental**

The team worked with Public Domain staff to run the Big Clean Up event on Good Friday. Over twenty local groups signed up to this event. Team members are also linking with Public Domain and Waste Management staff in relation to this years' PRIDE of Place Entry for the North West Area (the residents and environmental upgrades in Doon Court, Graigue Court and Knowth Court). The team are putting the final plans together for plant deliveries in mid May and at the start of June. Further meetings have taken place with GAP Ballymun in relation to five greening area workshops for the year. Team members have been working with STAR Ballymun to help them refurbish their community garden space in the Horizon Building. Team members have been liaising with local environmental groups around their City Neighbourhood Application Forms.

#### **Events**

Community team members are working with Poppintree Community Centre, Poppintree Youth Project, Aisling Poppintree, Garda Diversion Project and St Margaret's Development Centre to hold a Family Day Event on Thursday June the 29<sup>th</sup> from 2-5pm. This day will have "overcoming diversity" as a background theme and will focus on the idea of getting to know your neighbour better. Sports activities, music and food will be provided at this event.

### 2. <u>Housing/Estate Management Updates</u>

### C.C.T.V

The initial work on integrating the two operating systems has been completed. The remaining work on the system will continue on a phased basis throughout the year.

### Cleansing / Waste Management

Waste Management and the Area Office are continuing to combat illegal dumping at open spaces. These measures include using the C.C.T.V system to monitor and identify those responsible. The area office has targeted illegal dumping around, Coultry, Belclare and Termon Court. Tenants have been called for interview and warned about their behaviour.

### **Insulation Programme**

The work on the units in Coultry and Shangan has been completed. The insulation works are now on going in Sillogue Gardens.



### Dumping

Public Domain in conjunction with the Project Estate Officers in Ballymun continues to target residents who are illegally dumping. There is currently a dumping programme in place to try and target households who have no bin providers. Any householders suspected of having no provider are written to and asked to send in evidence of their bin collection receipts. This will be followed up by a further two letters, at this point if receipts are not received they will be called in for interview in the Housing Office.

### Big Dublin Clean-Up

Public Domain organised a massive cleanup in Ballymun/Whitehall and Santry on Good Friday and more than 20 groups took part in this event. It was a huge success and as a result, some new groups are coming together to start up environmental groups in their areas and improve their roads/streets/green spaces. DCC Community staff was also on board to assist and support. Shangan Avenue made a huge effort with the amazing support of one local representative, who came down with a crew of men and helped dig out flower beds around the trees and take out huge roots, a wonderful effort by his crew and all the residents. A planting project will now take place in each tree bed. Residents in Knowth and Druid Court made a huge effort in tidying up the green spaces at each parking bay and dug the edgings all along the length of the road. It makes a huge difference and looks so much tidier. Public Domain will be working with these groups along with Community Section to do large flower beds and edging beds in the coming weeks. It was great to see local representatives Deputy Dessie Ellis TD and Councillor Noeleen Reilly present on the day engaging with residents and giving a hand with the clean ups.





### Senior Citizens

There are a number of new environmental projects that Public Domain and Housing in Ballymun has identified. A major project has been undertaken in the Albert College complex and this work will include removing overgrown bushes, shrubs and weeds in the three garden areas with a view to having them paved and some planters installed. We are hoping that some small planters due to be fitted will be easier for residents to manage and enjoy. The Public Domain team are working with the Liaison Officer in Sandyhill Gardens Senior Citizens complex and have started a planting project along with residents. There are plans to put in high planters that the residents can easily reach and plants, equipment and topsoil etc. will be provided. Two benches and a large planter are being installed in Griffith Crescent so that residents can enjoy the lovely green space there. DCC has provided shovels, a

hose, long handled shears and plants in order to assist the older people looking after the green space.

### <u>Graffiti</u>

Contractors are currently working on the list from the Graffiti removal programme run by Public Domain.

### Residents Groups

The Public Domain office is constantly linking in with groups and is always working to get new groups on board. DCC continues to provide all clean up equipment and garden equipment needed for groups to do clean up and planting projects. New groups are continuing to come on board and all the hard work by residents and DCC is having a positive effect in the area, with the result that more areas are looking to form environmental groups. DCC has made contact with new groups in Balcurris Park East, Hollytree Square and Forestwood Avenue with a view to organising a cleanup and then maybe some planting projects with Community Section.

#### CRM

The system for logging complaints is updated daily and all jobs delegated to appropriate supervisors. You can log any complaints of a public domain nature on Fixmystreet.ie

### Carton

Public Domain in conjunction with Tiglin is trying to engage with the residents of Carton Estate as there is a serious problem with dumping in this area. DCC undertook a cleanup of the green space facing Carton Drive last Saturday and filled 6 skip bags and 30 bags of rubbish which was removed by DCC staff. Young and old residents got involved and we also had residents from the Travellers site helping which was fantastic. Sharon from GAP as well as DCC Community staff was present lending a hand as always. We will continue to work with residents to improve this area and try to establish a better sense of community. Work was done by residents to the green space facing Carton Terrace and the edgings were all tidied and 2 flower beds put in which enhances the look of the area.

### Clean-ups

Skip bags have been organised for some of our tenants in the Coultry area and also for tenants in the Collins Place/ Collins Drive in the Finglas East area.

### Stimulating Economic Activity

## Start-Up Ballymun

A Start-Up Ballymun event took place on Wednesday 26<sup>th</sup> April 2017 in the Council Chamber. The theme for the event was 'The Business of Health & Fitness'. We had six

speakers from the Sport & Fitness sector share their experience of setting up and running a business. They were:

- Michael McCarthy & William Lowry, KSM
- Sean Boland, Be Well Physiotherapist
- Rob Forbes, The Irish Rugby Institute
- Stephen Connolly, Lo-Cal Kitchen
- Yvonne Brady, EVB Sport
- Annette Smith, Tennis4kids (Unfortunately had to withdraw at short notice)

There was free one to one mentoring available on the day. Eight people registered for the event and forty five attended.

### Ballymun4Business (B4b)

Since the last report B4b have hosted two network meet-ups for it members. On the 31<sup>st</sup> March a workshop on 'Wellness & Mindfulness' was delivered by Mary O'Callaghan. Fifteen of our members attended. On 24<sup>th</sup> April Pamela Connolly did a session with the group on the draft LAP that was very well received. The new website is now live: <a href="www.b4b.ie">www.b4b.ie</a>, it is almost complete and the web developer will be delivering training on how to maintain it to some B4b members. Dublin City Council provided the funding for the website.

#### **Enterprise Space**

**Food Enterprise** – The EDO has carried out some research into the viability enterprise space for small food manufacturers in Ballymun. This involved a visit to a number of different food incubators in Dublin. It also included a visit to the Cork Incubator Kitchens in Carrigaline in Cork Co. Co. A draft report of the findings has been shared with the LEO who will commission one of their food mentors to conduct a feasibility study.

### Vacant Neighbourhood commercial units

The units in Coultry have been advertised on Daft which has lead to an increase in the number of enquiries and viewings

- Negotiations are ongoing with a pharmacy for unit C in Coultry.
- Negotiations were taking place with a barber for unit D in Coultry, but have since stalled due to set-up costs

There are a number of challenges in attempts to dispose of the NC units including:

- Core shell condition that require significant capital investment
- Lengthy disposal process
- Increase in the level of vandalism on some units making them difficult to market

The EDO will look at measures to make the units a more attractive proposition. The current status of vacant units is:

### Civic Alliance Update

The next Civic Alliance Meeting will be held on 1st June 2017.

The Draft Ballymun Local Area Plan went on public display on Wednesday 5<sup>th</sup> April for a period of 6 weeks. Members of planning staff were available in Ballymun Civic Centre on Thursday 6<sup>th</sup> April, Saturday 22<sup>nd</sup> April and Wednesday 26 April to discuss and explain the process for preparing a local area plan and to assist with any queries in relation to the plan area.

The next Economic Sub Committee Meeting was held on 11<sup>th</sup> May 2017, where was an update on the successful "Start Up Ballymun" Event which was held on 26<sup>th</sup> April in the Council Chamber highlighting the Business of Sport & Fitness and updates on the WiFi, B4B and the vacant neighbourhood units.

The next meeting of the Physical /Environmental Sub Committee will be held on 22<sup>nd</sup> May 2017.

The next meeting of the Social Sub Committee will be held on 22<sup>nd</sup> May 2017. There was a meeting held on 24<sup>th</sup> April 2017 between the Department of Social Protection, Ballymun Job Centre, Dublin City Council and Councillor Andrew Montague to discuss the successful Youth Guarantee Scheme to see what lessons can be learned from it and to discuss the activation process to see if there is scope to look at the needs for Ballymun.

<u>Shopping Centre</u>: The Credit Union recently received planning permission for a new unit in the Ballymun Civic Centre. Construction of their new unit is due to commence in the near future. The Job Centre are also due to commence fit out of their unit in the Civic Centre in the coming weeks.

### Northern Site

The legal documents have nearly been completed with Lidl.

#### Housing site: Balbutcher Lane-Cranogue Road Site, Ballymun-

Sally Reddington, Senior Executive Engineer, in the Environment and Transportation Department is corresponding with Irish Water regarding the disposal of this site. As soon as Irish Waters position is established, all replies will be reviewed and assuming that there are no objections to the disposal it is proposed to offer the Site to the Market.

### Safety Fora Updates

### Safer Ballymun

The last meeting of the Safer Ballymun took place on April 11<sup>th</sup>. It was well attended on the night by residents, DCC staff, member of the Gardaí and local representatives. A presentation on "Creating Male Space" was given on the night by Kerry Lawless from BRYR – this is a new 12 week mental health programme aimed at 18 – 24 year old men. Other issues discussed on the night included drug dealing, anti-social behaviour especially in the parks, illegal dumping and the planned Clean Up Day on Good Friday.

The next meeting is scheduled to take place on Tuesday, June 13th.

With reference to the proposed disposal of the Council's fee simple interest in the premises at "Viscount House", 89 Swords Road, Whitehall, Dublin 9.

Under Indenture of Lease dated 27<sup>th</sup> April 1934, Dublin City Council demised a site at 89 Swords Road, Whitehall, Dublin 9 which is more commonly known as the "Viscount House" to John Slevin for a term of 150 years from 25<sup>th</sup> March 1933 subject to an annual rent of €19.81. Costigo Tavern Limited is the present Lessee.

Previously Council Report No. 06/2004 which was assented to by the Dublin City Council at its meeting on 13<sup>th</sup> January 2004, approved terms and conditions for the disposal of the fee simple in the premises 89 Swords Road, Whitehall, Dublin 9 to Costigo Tavern Limited. However the legalities were never completed and the terms and conditions as agreed have since lapsed.

Whitney Moore Solicitors acting on behalf of the applicant Costigo Tavern Limited has now re-applied to Dublin City Council to purchase the fee simple therein. The Law Agent has confirmed that there is a statutory entitlement to purchase the fee simple.


Accordingly it is proposed to dispose of the Council's fee simple interest in the "Viscount House", 89 Swords Road, Whitehall, Dublin 9 to Costigo Tavern Limited, subject to the following terms and conditions:

- 1. The premises is held by Costigo Tavern Limited under Indenture of Lease to John Slevin dated 27<sup>th</sup> April 1934 for a term of 150 years with effect from the 25<sup>th</sup> March 1933, subject to the yearly rent of €19.81 per annum.
- 2. That the property proposed to be disposed of comprises the "Viscount Pub", 89 Swords Road, Whitehall, Dublin 9 which said property is more particularly shown outlined in red and coloured pink on Map index No. 12656.
- 3. That the purchase price shall be the sum of €12,500 (twelve thousand five hundred euro).
- 4. That the Council shall transfer the unencumbered freehold title of the lands.
- 5. That the applicants shall pay any charges which they are liable for under the relevant legislation and shall clear all outstanding rent, rates and taxes (if any) on the property prior to the completion of the sale.
- 6. That the above proposal is subject to satisfactory proof of title.

7. That the applicant shall pay Valuer's Fees of €1,500 (one thousand and five hundred euro) plus V.A.T. together with the Council's legal fee's which will be agreed with the Council's Law Agent.

With reference to the proposed disposal of fee simple in Coultry Neighbourhood Centre, Ballymun, Dublin 9.

Section 183 Report No. 346/2014 was assented to at a meeting of Dublin City Council on the 1<sup>st</sup> December 2014.

The report proposed the disposal of Dublin City Council's fee simple interest in the common areas of Coultry Neighbourhood Centre, Ballymun, Dublin 9 to the management company, now named Coultry NC Management Company CLG.

The legal formalities have not yet completed. In compliance with the requirements of the Multi-Unit Developments Act 2011 and by agreement with Coultry NC Management Company CLG, it is proposed to vary Report No. 346/2014 as follows:

1. In addition to the disposal of the Council's fee simple interest in the common areas, the disposal shall also include the apartments, the commercial units and the community unit in Coultry Neighbourhood Centre.

The Council's fee simple interest is subject to a lease held by Ballymun Regeneration Limited for a term of 200 years from the 1<sup>st</sup> December 2005. The lease will be assigned by Ballymun Regeneration Limited to Coultry NC Management Company CLG and then merged with the fee simple interest when the proposed disposal is complete. Before the assignment of the lease completes, Ballymun Regeneration Limited will have granted long subleases to the Council in the retail/community units.

2. The area to be disposed is shown outlined red on Map Index No. SM-2014-0660-001 and Map Index No. SM-2014-0660-002.

No agreement enforceable at law is created or is intended to be created until an exchange of contracts has taken place.

The disposal shall be subject to any such covenants and conditions as the Law Agent in his discretion shall stipulate.
