#### Motions with Replies Central Area Committee Meeting 9<sup>th</sup> May, 2017

#### Motion in the name of Councillor Gaye Fagan

That this Committee agree that a Traffic Management Plan is required for East Wall and that the plan should be in place as soon as possible.

#### <u>Report</u>

A report on Traffic management Issues in the East Wall Area was carried out and presented to the committee in September 2016. The following recommendations in the report have been implemented:

- 1. Double yellow lines on all corners of the St Mary's Road North / Church Road (west and east) junctions.
- 2. Double yellow lines on all corners of the junctions of East Road/Caledon Road.
- 3. A Bus Cage on East Road approaching East Wall Road at the Dublin Bus Stop adjacent to GK Hire.
- 4. Double Yellow Lines on both sides of Shelmalier Road. Excluding entrances.
- 5. Double yellow lines on all corners of the junction of East Road/Ravensdale Road.

The following work is included on the 2017 Works Program, subject to available resources and funding:

1. Entry treatment in the form of reducing the radii at the junction of Ravensdale Road and Shelmalier Road.

The following work has been added to the Future Works Program, subject to available funding and resources:

- 1. Roundabout at West Road / Ossory Road junction to be repaired.
- 2. Roundabout at West Road / St. Mary's Road North junction to be resurfaced.
- 3. Damaged footpath on Hawthorn Street to be resurfaced.

The planners have informed me that the East Wall Area is not currently designated as a Strategic Development Zone (SDZ). Therefore, there are no immediate plans to change the traffic management arrangements for the area. However, any specific issues in relation to roads and traffic will be dealt with accordingly as they arise.

Roadworks in Dublin City are carried out in accordance with the *Directions for the Control & Management of Roadworks in Dublin City*. Each road/street has been graded according to its importance as a strategic traffic route by assigning it a Traffic Impact Number as outlined below:

Times during which Roadworks may be carried out:

Under the Directions document utility companies/contractors are required to notify all affected residents and businesses of planned works by letter drop no later than two days before works commence. This letter contains the name of the organisation for whom the works are being done, a brief description of the works and a contact number.

These Directions were last revised in June 2010 and were presented to the Transportation SPC for consideration before taking affect.

#### Report

As of 3<sup>rd</sup> May 2017, there are 268 outstanding service requests in the Central Area. This compares with 246 for NCA, 499 for NWA , 210 for SCA and 472 for SEA.

Service requests typically include pedestrian crossings, stop signs, children crossing signs, ramps, disabled parking bays, pay and display parking and parking prohibitions. Requests are generally assessed in chronological order. However, if a site visit is required, other traffic issues in the vicinity may also be assessed. If a health and safety issue is brought to the engineer's attention, then that issue is given a higher priority.

The Traffic Department is very aware of the need to improve on more efficiently responding to TAG requests and to this end since May 2017 I have assigned Andrew Geoghegan, Graduate Engineer fulltime to the Central Area. Ger Corrigan, Graduate Engineer is assigned fulltime to the south side of the city to assist the Area Engineers.

I expect the positive impact of this change in staff levels will be evident in the coming months and will revert to you in September with an update.

#### Motion in the name of Councillor Dermot Lacey

That this Committee requests the Manager to have the cycle lanes on North Circular Road, Portland Row and Seville Place examined for safety and maintenance requirements and that appropriate remedial action be taken and that the Gardaí be requested to enforce existing parking restrictions on these cycle lanes.

#### <u>Report</u>

Advisory on-road cycle lanes are in place on both Seville Place and North Circular Road (from Dorset St. inbound) where operational hours are 7am to 7pm. Parking is permitted (where appropriate) in these areas outside operational hours.

Dublin City Council's parking enforcement contractor, Dublin Street Parking Services, have been instructed to monitor the locations and will take enforcement action where necessary. The issue of illegal parking will also be brought to the attention of An Garda Siochana at the next meeting of the Traffic Advisory Group

The condition of existing cycle lanes on North Circular Road in the vicinity of Portland Row and Seville Place will be reviewed by the Area Traffic Engineer in relation to segregation.

The junction of Seville Place/North Circular Road, (5 Lamps Junction) is part of the Clontarf to City Centre Cycle Route and includes improvements to the junction for cyclists on Amiens Street / North Strand Road. The request for dedicated traffic signals for cyclists for Portland Row / Seville Place will be reviewed at this junction. A preliminary report will be prepared for the councillor within a three month timeframe on the above two items.


#### Proposed amendment to the North Lotts and Grand Canal Dock SDZ Planning Scheme in relation to Pedestrian Bridge relocation across the River Liffey

#### 1. Introduction

Dublin City Council is the designated Development Agency for the North Lotts and Grand Canal Dock Planning Scheme approved by the City Council in November 2013 and and Bord Pleanala in May 2014.

#### 2. Proposal

The North Lotts and Grand Canal Dock SDZ Planning Scheme contain objectives to provide two pedestrian bridges over the Liffey; a western bridge at Forbes Street, and one further east / downriver at Castleforbes Road. (see orange-coloured dashed arrows on the map below, from Fig 33 of the SDZ scheme).



Although the Forbes St Bridge (westernmost route illustrated above) would accommodate a desire line from Spencer Dock Luas stop and Docklands Road Station to Grand Canal Square, the NTA has requested that design work be suspended while a review of the Dart underground Tunnel (which runs directly underneath the proposed Forbes Street Bridge) takes place. If built over the Dart Tunnel, the bridge would be prohibitively expensive.

The proposed Castleforbes pedestrian bridge (easternmost one above) is close to Tom Clarke (East Link) Bridge. Facilities for pedestrians and cyclists on the existing Tom Clarke Bridge are poor at present. A feasibility study recently concluded that widening the bridge is not possible and that a new pedestrian/cyclist bridge should be provided immediately west of it. This will reduce the need for a new bridge at Castleforbes Street.

It is considered that a proposed new pedestrian bridge between the 2 proposed pedestrian bridges (as illustrated in the SDZ) together with the proposed pedestrian and cycle bridge adjacent to Tom Clarke Bridge would have a number of advantages over the existing Bridge proposals, in that they could be delivered in a shorter time frame, and less expensively that the existing proposals. The reduction in the number of bridges also allows for more quayside space for boats / tall ship events etc. It is also important to note that connectivity westwards from the southern end of the Tom Clarke bridge will improve significantly when the Dodder bridge is delivered. The main downside is that the mid location is not on a direct desire line which leads directly from the River Liffey to Grand Canal Square.

#### 3. The Next Stages

Section 169 of the 2000 Planning Act states that an SDZ Planning Scheme "Shall be deemed to form part of any development plan and any contrary provisions of the development plan shall be superseded."

Given that the SDZ was designated by Government due to its economic or social importance to the state, the correct procedure is to make an amendment to the Planning Scheme.

The procedure for amending an SDZ Scheme (under S170) has been simplified under the Planning and Development Amendment Act 2015 as follows:

- a. The Planning Authority (as Development Agency in DCC's case) applies to an Bord Pleanala (ABP) requesting an amendment, with a supporting case.
- b. ABP to decide whether amendment is "material". If the amendment would significantly increase (or decrease) the density of development in the SDZ, or change the overall objectives of the SDZ Scheme, then it must go through the full Consultation and City Council Approval process.


c. If the amendments are not material, ABP can proceed to make a decision. If the amendments are deemed significant in environmental terms, ABP may require an SEA/AA to be carried out. If material, the Board will require the Planning Authority to carry out a 4 week public consultation, and submit a report on any submissions received to them.

#### **Conclusion:**

Overall, it is considered that the SDZ Scheme should be amended to provide:

- a. A new Pedestrian bridge linking New Wapping Street and Blood Stoney Road to replace the currently proposed bridges at Forbes Street and Castleforbes Road.
- b. A new pedestrian/cycle bridge to the west side of Tom Clarke (East Link) Bridge

(see amended SDZ Fig. 35 below).



#### Recommendation;

That the Planning Authority make an application to An Bord Pleanala requesting an amendment under Section170A of the Planning and Development Act 2015 to provide;

- a) A new pedestrian bridge linking new Wapping Street and Blood Stoney Road.
- b) A new pedestrian/cycle bridge to the west side of Tom Clarke (East Link) Bridge, both to replace the currently proposed bridges at Forbes Street and Castleforbes Road.



# With reference to the proposed disposal of a further licence of Units T02-T07 and T22 of the Markets Area Community Resource Organisation (MACRO) Building, Green Street/North King Street, Dublin 7.

By way of licence dated 4th February 2016, Units T02-T07 and T22 of the Markets Area Community Resource Organisation (MACRO) Building, Green Street/North King Street, Dublin 7 which is delineated on Map Index No. SM2010-0692-001 was let under licence by Dublin City Council to the European Consumer Centre (Ireland) Limited for a period of 2 years commencing on 1<sup>st</sup> November 2015. This licence is due to expire on 31<sup>st</sup> October 2017.

It is proposed to grant a further two year licence to the European Consumer Centre (Ireland) Limited subject to the following terms and conditions:

- 1. The proposed licence shall be for the period of 2 years from 1<sup>st</sup> November 2017 subject to a licence fee of €1.00 if demanded.
- 2. The proposed licensed area is Unit T02 T07 and Unit T22, and is more particularly shown coloured pink on Map Index No. SM2012-0692-001.
- 3. The proposed licence shall be subject to a contribution fee of €21,420 per annum in respect of the cost of managing the building, payable quarterly in advance directly to MACRO Building Management CLG.
- 4. The licensee shall sign a deed of renunciation in respect of the licensed area.
- 5. The licensee shall be entitled to use the licensed area for office use only during the opening hours of the Markets Area Community Resource Organisation building which are 8.00 am to 10.00pm daily.
- 6. The licence can be terminated by either party on giving the other one months notice in writing.
- 7. The licensee shall be responsible for all outgoings including waste charges and any water charges which may become payable.
- 8. The licensee shall keep its part of the premises in good condition and repair during the term of the licence.
- 9. The licensee shall obtain public liability insurance (€6.5 million) and employer's liability insurance (€13 million) if they have employees and shall indemnify the City Council against any and all claims for compensation, which may arise from their use of their use of the property.

- 10. On termination of the licence, the licensee shall be responsible for the removal of all their materials from the premises
- 11. The licensee shall not assign, sub-let, alienate or part with possession of the subject property.
- 12. The licensee shall not erect any signage on the external or internal walls of the subject property without the prior consent of the Council.
- 13. The licence will be subject to any terms and conditions deemed appropriate by the Council's Law Agent.
- 14. Each party shall be responsible for its own legal costs.

## With reference to the grant of a lease to the Health Service Executive for property at St. Elizabeth's Court, North Circular Road, Dublin 7

St. Elizabeth's Court is a service providing accommodation for elderly people with mental health issues (a 30 bed high dependency nursing unit). It is located off the south side of North Circular Road (Phoenix Park end) adjacent to the Grangegorman site.

Dublin City Council acquired the site by agreement, in fee simple from the Eastern Health Board in 1974 and St. Elizabeth's Court was subsequently built on these lands. Dublin City Council financed the building of St. Elizabeth's Court which was originally used as a senior citizen flats complex. Dublin City Council paid the Eastern Health Board for a period of about 5/6 years in the 1980's for maintenance of the flats at St. Elizabeth's Court. Payment was then reduced and eventually ceased as the occupants were replaced by Eastern Health Board patients from St. Brendan's Hospital.

As the Health Service Executive has been in occupation of this premises for a number of years, it is now proposed to regularise occupation. Agreement has now been reached with the Health Service Executive to grant the lease, subject to the following terms and conditions:

- 1. That the subject site, known as St. Elizabeth's Court, is situated on North Circular Road, Dublin 7, with an approximate area of 0.268 ha/ 0.66 acres (see map attached for indicative purposes)
- 2. That Dublin City Council hold the fee simple interest in the subject site.
- 3. That Dublin City Council proposes to dispose of a leasehold interest to the Health Service Executive for a period of 99 years, subject to an annual rent of €10 (ten euro), with the provision for five yearly rent reviews, linked to movements in the Consumer Price Index.
- 4. If requested, in advance of the lease to the Health Service Executive being executed, Dublin City Council will grant licences to the Grangegorman Development Agency/Health Service Executive to develop the lands in accordance with planning permissions to be obtained in accordance with the Strategic Development Zone plan.
- 5. That the proposed lease will include conditions preventing the subject land forming part of any private residential or commercial development, or the inclusion of the land, for density or access purposes, in any application for planning permission for private residential or commercial development of the adjoining lands.

- 6. That the Health Service Executive shall be responsible for any VAT or Stamp Duty arising on this transaction.
- 7. That each party shall be responsible for their own fees in this case.
- 8. That should the lease remain unexecuted by 31<sup>st</sup> December, 2017, the Council reserve the right to withdraw from this transaction.

The dates for the performances of any of the requirements of the proposed agreement may be amended at the absolute discretion of the Executive Manager.

The disposal shall be subject to any such covenants and conditions as the Law Agent in his discretion shall stipulate.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.





Overall 24 entries were received this round for central area.



# North East Inner City Housing Central Area Report

## 1) Donal Barron – Area Housing Manager

## Croke Villas

Dublin City Council Architects Division have appointed the design team for the overall project and preparation of a Part 8 procedure for 76 new housing units on the site of the former Croke Villas flat complex has commenced.

At the April 2017 meeting of Dublin City Council's Central Area Committee it was agreed to initiate the Part 8 procedure for Croke Villas.

Two information sessions were organised for the local community one was held in Charleville Mall Library and the other in the Ballybough Youth and Community Centre.

Work has also commenced on the site at 4-6 Ballybough Road to deliver 17 new housing units. It is anticipated that these works will be complete in Quarter 4 2018. A leaflet drop have been organised to 500 homes in the Ballybough Area.

The Area Office will have vacant possession by 12<sup>th</sup> June when the last tenant moves to their new home. We will continue to work with the residents in the first block.

### St. Mary's Mansions

Following a presentation to the residents and Area Councillors which received a very positive response, a planning application was lodged by Cluid Approved Housing Body on 6<sup>th</sup> May 2016 for the redevelopment of this complex. Final Grant Notice was issued on the 8<sup>th</sup> August 2016.

Commencement of construction works is expected in Q3 2017. (In the meantime preparatory works will commence and an Archaeological survey of the site is underway)

The project will deliver 76 new units in this redesigned complex.

This projected completion date is March 2019.

Detenanting is not yet completed as Cluid await snagging works to be complete on a number of units they have purchased. At this stage all remaining tenants are agreeable to move and properties have been identified for them. It is hoped that all remaining tenants will be relocated by the end of June.

Entrances to the stairwells on K block have been secured as all residents on the upper floors have now moved out. There has been a marked decrease in anti-social behaviour in the complex and Gardai have increased their presence in and around the site.

## Vacant site, Railway Street

Circle Voluntary Housing Association have finalised a proposed design for a new development of 38 Apartments on Railway Street.

Circle executives made a presentation to Dublin City Councillors on 10<sup>th</sup> November 2016 to seek approval on their plan. DCC have since met residents from the adjoining Kiln and Forge Apartment complexes to discuss the proposal and they have expressed support for the project.

Circle VHA will have appointed a design team by mid June 2017 and move forward with design, planning, finance, construction.

As it is expected to take some time before any construction works take place we are currently looking at ways to better secure the site and examining whether it can deliver community events while the design, planning and tender processes are progressing.

## Ballybough House

Substantial improvement works have been carried out in this complex to upgrade the physical environment and improve measures to tackle anti social behaviour.

Upgrades included:

- New Public Lighting
- Repairs of the stairwells and installation of new security doors/CCTV
- New playground and Amphitheatre improvements and landscaping
- Painting Programme (Railings, Balcony Trims)

Works are in progress on the new door entry system and we are costing replacement doors and windows in a situation whereby additional finance was secured.

We are currently examining the potential of reconfiguring 2 flats into 1 large unit thus creating larger living spaces within the complex. Once this study is complete we will bring it to the Department of Housing, Planning and Local Government for assessment.

We are also proposing to carry out precinct works consisting of the separation of each block by means of a wall & railings, and the provision of parking facilities, playgrounds, green areas as required in each block.

## **Gloucester Place/Former IDA site**

Construction work commenced in late February 2016 and the project is progressing well with a completion of works in September 2017.

An application has now been lodged by the same developer to build more student accommodation on the adjacent site which is currently being used as the contractor's compound.

There had been an upsurge in dumping at the ESB substation beside this site, collaboration between the ESB and DCC has commenced which will see this area transformed into a community garden.

#### Apartment blocks Sheriff Street

The stairwells and common areas in the apartment blocks at Mariners Port, Crinan Strand and Spencer Dock have fallen in to a poor condition over recent years. We have recently installed new, more secure post-boxes and have begun a programme of replacing the main entrance doors and the floor covering and to paint the stairwells. These works are ongoing and should be completed by July 2017.

## **CastleforbesSquare**

17 families have moved into the complex and the remaining families will move in after completing interviews and pre-tenancy.

### Vacant Site at Poplar Row

Oaklee lodged a planning application on 30<sup>th</sup> November 2015 for a development of 29 units of accommodation at Poplar Row. Planning permission with conditions was granted to Oaklee Housing on 10<sup>th</sup> June 2016 however an appeal was lodged with on Bord Pleanala by the local Residents Association. An agreement was subsequently reached with all parties including a commitment to ensure good communications by the formation of a liaison group with DCC, Oaklee and Resident representatives when the development commences.

Oaklee Housing Trust was advised on 30<sup>th</sup> Sept 2016 of a notice to grant planning for Poplar Row.

Work on the detailed design has commenced and site surveys are currently been carried out by Oaklee's Design team. Oaklee are finalising details before going to tender.

Works are expected to commence in Q3 2017 and completion Q3 2019.

The approval for the disposal of the site was passed at the May 2017 full City Council meeting.

The City Council are to hoard off the site and improve the look through Artwork similar to the Mud Island hoarding.

### Tom Clarke House

Work commenced on site in November 2015 converting bedsits into one bedroom apartments Work on the first phase is completed and the units are allocated, work on phase 2 has been substantially completed and Tenants identified for the remaining 4 units. The Area Office and Housing Department are in the process of finalising the public domain improvements on site.

## St. Agatha's Court

Work commenced on the reconfiguration of the former Senior Citizens complex in April 2016 and completed May 2017. The Peter McVerry Trust will take over the management of the complex and allocations for the 12 units to commence 29<sup>th</sup> May 2017.

#### Luas Cross City Works

We are getting close to the end of the civils works. By September there will be little or no presence /impact from these works and most work sites will be removed. As always this is subject to site conditions. The test and trial running will then be in full swing.

The big ticket item for this month is the gauge run test of the trams on the completed tracks around mid-June. This is the first time that all the civils and electro-mechanical pieces come together and are tested as a functioning system.

Below you find a brief overview of both works packages for the summer (civils and power and systems or electro-mechanical works).

#### POWER AND SYSTEMS

### Completed Tasks MAY

During May the electro-mechanical programme was progressed to a live power situation. All brackets were attached and the poles for the overhead cabling system were in position during the first half of May. After that SSJV strung the wires and attached them to the poles along the entire project from Broombridge to St Stephens Green by 20 May. The lines are powered up since that time. It is important that the members of the public now treat the lines as live. (see images below)

#### Programme June - July

Around mid-June the first test trams will be on the tracks, initially as part of a gauge run tests. Some will take place during the day but there will also be some night tests. All traffic signal junctions will be completed by early July. There will be a gradual increase of the number of tram tests in the weeks following the initial gauge run.

It is important that people watch out for moving trams after mid-June as the tram will then become a part of the streetscape on a permanent basis with an increase in frequency as the weeks progress. Tram driver training will start during autumn 2017 with a view to open the Luas Cross City Green Line extension for passenger services in December 2017.

## **CIVILS**

#### Programme June – July

A large traffic switch happened on 28 May at Parnell West with the implementation of the change in traffic flow on Dominic Lower from northbound to southbound. This is the permanent layout for the traffic which will remain in place during Luas operations.

The focus now remains on final surfacing, paving and installation of statutory signage in areas near the tracks. These track areas get priority for completion to avoid working near live running trams once the testing starts.

The resurfacing in the road areas near the tracks for the northern city area is in the Parnell Street – Moore Street – Moore Lane and Upper O'Connell area.

During June the paving at the flats on Dominic Lower and Upper will be completed first and followed by the area near the Dorset flats.

## **Dominick Street Lower**

Detailed designs for 5-3 bed town houses, 68 apartments consisting of 5-3 bed, 50-2 bed and 12 1bed units, a community facility and retail/commercial units with 47 car spaces at basement level on the eastern side of Dominick Street are currently being worked up. These will assist in the preparation of the tender documents. We expect to go down to the Department of Housing, Planning, Community and Local Government for approval to go to tender in the next couple of weeks.

## **Constitution Hill**

The painting crew have commenced painting this complex. Ongoing meetings with Residents are taking place. Luas Cross City Staff and the Project Estate Officer are keeping Residents up-to-date on the proposed plans/works for Broadstone Gate.

#### Dorset Street & Saint Marys Terrace

The Housing Department made a submission to the Department of Housing, Planning, Community and Local Government for funding to carry out a complete refurbishment of homes, to include larger kitchens and bathrooms, better BER rating (energy improvements) new roof, lifts, landscaping, greater accessibility and boundary treatments.

The Department, after reviewing the consultant's report, has advised that the cost of refurbishment was so close to the cost of demolition and new build that they requested that this option be further

developed. So we propose to put a design team in place for new build and seek permission from the Department of Housing, Planning, Community and Local Government for funding. This is expected to happen in the second quarter of this year. Individual meetings with the residents of St May's Place will take place over the next two weeks.

### Georges Place

An environmental group has been set up and is working on improving the green areas within the complex.

#### **Blackhall Place/Marmion Court**

The extensive painting programme for the Blackhall/Marmion complex is nearing completion about two weeks left.

#### Dominick Street Upper

The Boiler replacement program is almost complete, 4 remaining.

## Ormond Square/East Arran St Area

Working with the local community we have an environmental improvement program, the area has been enhance with potting plants and flower baskets.

#### North King Street

The design team is currently working detail design and on the tender production drawings. I expect a contractor to be on site in the fourth quarter of this year. We expect to go to tender end of August, appoint a contractor and commence building by year end and it should take approximately 18 months to build the complex. This programme is dependent on getting all necessary approvals.

Site surveys will be carried out over the next couple of weeks, including the digging slit trenches, the ground will be reinstated with grass pending build.

# O'Devaney Gardens

- Design development on proposed 56 Social Housing units is proceeding
- Six flats remain occupied and efforts continue to provide suitable alternative accommodation for the residents concerned.
- The second meeting of the O'Devaney Gardens Consultative Forum took place on 6<sup>th</sup> April last with the next meeting scheduled for Tuesday 6<sup>th</sup> June.

# Aughrim Court

• Following on from discretionary funding approval quotations have been sought for improvement works to the garden areas. All works will be undertaken in line with expert advice from Parks Department.

# North East Inner City Ministerial Task Force

In the meantime the NEIC Programme Office is up and running at the Central Area Office HQ – 51-53 Sean MacDermott St. A series of meetings have been held between the Programme Office and some key stakeholders, including other Government Departments and the North Inner City Community Coalition, regarding setting up of the structures required to implement the recommendations of the report.



A newsletter has been compiled and circulated to residents and businesses in the NEIC area. The newsletter sets out details of the short term measures undertaken with the 2016 allocation of funding and invites interested parties to engage with the Programme Office as implementation of the recommendations of the Mulvey report progresses. Taoiseach Enda Kenny, T.D. and Minister Paschal Donohoe T.D. visited a number of completed projects in the North East Inner City and held a meeting with the Coalition Convenors on 29th May 2017.

## Sean MacDermott St. Swimming Pool Upgrade

Further to query at last months Central Area Committee meeting, an order has now been placed for external signage. The signage which is due to be erected w/e 23/06/2017, is *"Back-lit powder coated steel route sign with recessed white acrylic,"* to be affixed to the front and side of the building as indicated on the visual representation below.





Solutions for visual improvement of the entire façade of the pool building are still being considered. Visual samples of proposals received to date are set out below.

These proposals have not been accurately costed yet but it is anticipated that costs will be significant. To date no source of funding has been identified, however, the proposals will be retained for further consideration should additional funding become available. The final solution will be required to incorporate the new signage that will be in place at that stage.

#### Grangegorman update

- 1. Energy centre The GDA is working on the procurement of this central energy centre for the entire site. It is a core element in the delivery of a sustainable Grangegorman urban Quarter
- The West Quad The College of Business. This is being delivered as part of DIT's Programme 3
- **3.** Academic Hub The GDA have appointed a design team. The historic North House will form part of the final design
- **4.** HSE Residential Care Centre The GDA is currently out to tender for a design team for this new facility on behalf of the HSE
- 5. HSE Primary Care Centre The construction work is complete and the fit out is beginning. It is envisaged that it will be open by the end of 2017.
- 6. Public Private Partnerships (PPP), Central and East Quads (student accommodation) The PPP project was the subject of High Court proceedings. This is now resolved and it is hoped that construction will get underway this summer.
- Broadstone Gate Construction work on the new Luas Cross City is due for completion in late 2017. The stop at Broadstone will also deliver a new entrance to the Grangegorman site. The lower plaza will likely be completed later in 2018.
- **8.** Dublin 7 Educate Together, Primary School An Bord Pleanála is currently considering a request to extend the school from 16 to 24 classrooms.
