DUBLIN CITY COUNCIL SOUTH CENTRAL AREA COMMITTEE 21st June 2017

523 Councillor Paul Hand

In light of the current shortage of office space in the Dublin City Council area and the large amount of available office space in Park West, particularly Park West Plaza, that this Area Committee requests an IDA site visit to Park West to promote jobs and enterprise in the South-West Dublin City area.

524 Councillor Vincent Jackson

In view on the ongoing and systematic problems with parks in the South Central Area particularly Brickfields, The Lawns and Californian Hills Park, that Dublin City Council look into the possibility of developing a specific warden service for these parks and look at international best practice on how to respond to the serious problems we are encountering.

525 Councillor Daithí Doolan

That this Committee regrets any inconvenience caused to residents by recent developments and deliveries on Cherry Orchard's rapid build site. Dublin City Council will ensure this does not happen again and that there is regular communication with residents informing them ahead of time of any further developments.

526 Councillor Criona Ni Dhalaigh

That this Area Committee believes that it is not in the interest of good planning or community cohesion to permit an over-concentration of student and hotel accommodation in any one area of the city, especially not one as old and historic as Dublin 8 area with an existing housing crisis. We therefore note with concern the burgeoning construction or planned construction of student accommodation as follows: 380 in Mill Street, 308 Brown Street, and Brickfield Lane,400 in New Market, 471 in the Thomas Street Binary Hub, and so many which received planning permission already.

We also therefore note with concern the planned construction of 1300 hotel and AirBnB accommodation as follows, Aloft - Blackpitts - 200+ rooms, Maldon- Kevin street/Clanbrasil Street - 137 rooms, Hotel beside Fallons - Sheraton - 257 rooms, Tivoli redevelopment - 298 units, Mother Redcaps and Iveagh Market redevelopment - 97 rooms + 79 apart units, Charlemont Hilton are apparently adding extra floors – (tbc), Clayton Hotel beside the barge - 181 rooms. We further believe that a moratorium on anymore student, guesthouse, hotel, AirBnB, planning permissions for Dublin 8 be agreed until a full assessment of the impact of these 1,159 expensive student accommodation units and 1300 additional tourist accommodation on the local host community is carried over the next 5 years.

527 Councillor Paul Hand

That this Area Committee requests that the old Unilever site on Davitt Road be used for the purposes of public housing and community facilities.

To this end we request that this motion be forwarded to the Minister for Housing and Local Government to purchase the site on behalf of Dublin City Council for this purpose from the HSE, pending the completion of the new National Children's Hospital.

528 Councillor Daithí Doolan

This Area Committee recognises the Orchard Centre as a vital resource in Cherry Orchard and we congratulate the staff for the service it provides. We call on Dublin City Council to put in place a plan to resource it and to make it more accessible to community groups, residents and services.

510 Councillor Daithí de Róiste

The tragic accident that resulted in the loss of R116 touched each and every one of us. As a society we take those who work in our frontline emergency services and the daily danger they place themselves in for granted. Paul Ormsby, a Ballyfermot man, was one of those lost on that fateful night. To that end, this Area Committee calls for the renaming and dedicating of the park on Oranmore Road to his memory and that of the crew of R116 and looks for a significant memorial and plaque to be erected to mark their ultimate sacrifice.

Order: Agreed in principal. To be revisited at a later stage with consideration given to the erection of a plaque.

511 Councillor Criona Ni Dhalaigh

That this Area Committee request that a traffic audit be carried out in the Tenters' area. The audit to include how best to address the non resident parking, consideration of residents only parking, one way system on the

narrow streets and parking enforcement to address dangerous parking. Residents are extremely frustrated at the huge increase in all day parking in their area plus the added factor of workers from all the local building sites parking there as well.

512 Councillor Rebecca Moynihan,

This Area Committee ask that the Area Manager writes to the tour operators who use Teeling's Distillery in Newmarket, asking that they refrain from using their PA system while in residential areas or stopped at the traffic lights.

This Area Committee requests the Area Manager to arrange with our Traffic Management Section to undertake a traffic and environmental audit of issues relating to on street parking and overall traffic management in the Tenter's area of Dublin 8. The lack of parking spaces for residents is a major issue since the beginning of construction projects in the immediate surrounding area.

This Area Committee, protocol permitting, will dedicate the green at Spiddal Road & Oranmore Road in memory of local resident Paul Ormsby, who was tragically lost during the recent rescue operation off Galway. Order: Agreed in principal. To be revisited at a later stage with consideration given to the erection of a plaque.

515 Councillor Vincent Jackson

That Dublin City Council starts to take some responsibility for the horrific ongoing behaviour at the Californian Hills Park, Ballyfermot. A couple of years ago and dozens of questions later I can see our failure to properly manage the dumping, horses, and anti-social behaviour is turning this beautiful area into a no-go area. Drumfinn Celtic have said it is no longer feasible to bring children onto a site full of glass, rubbish, cars spoiling the area. At the recent meeting of the Ballyfermot Policing forum, serious concerns from neighbours took up a large portion of the meeting looking for answers of what Dublin City Council and An Garda Siochana are going to do to sort the issues out. I am aware of neighbours who are terrified to approach youths for fear to their homes. Why have we allowed this behaviour to take root and what are we going to do to address same? Losing the soccer, walkers from the park is a disaster. **Order: Agreed**

516 Councillor Paul Hand

That the South Central Area Committee requests that the Dublin City Council mobile library service expands its service to Chapelizod. Chapelizod is a village associated with writers such as James Joyce and Sheridan Le Fanu and has no library service. In examining this motion I would request that locations all around Chapelizod be considered for providing this service, such as the coach bus car park of the West County Hotel and any other suitable locations. **Order: Report to Councillor.**

517 Councillor Criona Ni Dhalaigh

That this Area Committee request that Dublin City Council consider

changing the parking bye laws with a view to allowing residents only parking in area's of high all day parking by non residents and in area's where a lot of development is taking place resulting in site workers parking all day.

This Area Committee notes with concern that as a result of the withdrawal of our area office funding to the local registered charity WALK, that a number of older persons with mobility issues have no access to a gardening service. We therefore call on the Area Manager to immediately resolve this problem so as to return the service to those who had it in previous years.

The Area Committee supports the request by the Ballyfermot Policing Forum for an urgent meeting with the Garda Commissioner and Minister Fitzgerald to address the lack of adequate Garda resources in Ballyfermot and the urgent need to increase the allocation of Gardaí to this Station and explore ways of ensuring increased Garda engagement and visibility with the people of Ballyfermot, Cherry Orchard, Chapelizod and Palmerstown. Order: Agreed. Agreed to write to the Minister for Justice and the Garda Commissioner.

520 Councillor Vincent Jackson

This Area Committee requests that Dublin City Council look at the ongoing traffic congestion at the Ballyfermot Primary Health Care Centre since the traffic lights were installed. Allowing traffic to turn right into Cherry Orchard Industrial Estate results in all the traffic backing up behind same as the traffic continuing up Ballyfermot Road cannot proceed as the roadway is too narrow. A simple solution is ban right hand turn, thus allowing traffic proceed and allow turning right approx. 50 Mt up on Ballyfermot, thus allowing access to Cherry Orchard Ind. Est. **Order: Report to Councillor.**

521 <u>Councillor Paul Hand</u>

That the South Central Area Committee requests that Our Lady's Hospital for sick children stop charging patients for the use of car parks on site. It is morally reprehensible to profit from another person's misfortune and I hope that this practice stops as soon as possible.

This Area Committee requests clarity on the following: - in relation to the arrival of pay by weight by various waste collectors, can Dublin City Council please indicate what proposal they have, if any, to deal with the anticipated rise in fly tipping in our communities? I cannot see how this system is better for the environment. The simple issue we need to have manufactures, suppliers reduce the volume of packaging, introduce deposit return scheme for bottles, cans etc. Re-Pak has done nothing to help reduce this chain of the waste stream which results in the destruction of so much of our parks, beaches etc. In my community on any given day I could collect 100 soft drink cans / bottles. This is an indication we need pro-active responses to reduce the stream of waste on our streets. **Order: Report to Councillor.**

CRUMLIN /KIMMAGE ELECTORAL AREA

New Public Park, Cork Street

Works to develop a 0.6 hectare neighbourhood park on the site of the demolished Chamber Court flats on Cork Street commenced in February and are progressing well. It is expected that the park will be completed by summer 2017.

St. Audoen's Park, High Street

St. Audoen's Park is included in the Liberties Greening Strategy. As part of the proposed improvements to High Street it is planned to enhance the area by improving accessibility, permeability and circulation throughout the park. A Part 8 planning application for the project was agreed at the July 2016 City Council meeting. Tenders have been submitted and are currently under assessment.

New Public Park, Bridgefoot Street/Island Street

Plans to develop a high quality neighbourhood park at Bridgefoot Street have been reactivated and public workshops were held on Thursday, 20th April in St. Catherine's Church, Thomas Street. The consultant landscape architect will now prepare proposals which will be presented at a second workshop.

Newmarket

A Public Realm Improvement Plan for Newmarket Square and its environs is now complete. The Plan describes, supports and guides the implementation of improvements to enhance the use and attractiveness of the area. Following agreement at the February Area Committee meeting a Part 8 planning application for the project was advertised on 20th February. A copy of the plan was available for inspection in the Planning Department in the Civic Office for 6 weeks from that date. The closing date for the receipt of submissions or observations was 20th April. A report in relation to the Part 8 planning application is included on the agenda for this month's Area Committee meeting

Francis Street

A Public Realm Improvement Plan for Francis Street, Hanover Lane and part of Dean Street has also been completed. The plan provides for provides for a more pedestrian friendly environment which encourages people to visit the area on foot. The plan also supports the continued commercial operation of the Arts and Antiques quarter. Following agreement at the March Area Committee meeting a Part 8 planning application for the project will be advertised on 28th April. A copy of the plan will be available for inspection in the Planning Department in the Civic Office for 6 weeks from that date. The closing date for the receipt of submissions or observations is 28th June.

Michael Mallin House

Works to convert 4 bedsits into 2×1 bedroomed units are due to commence this week. Similar work is ongoing in Basin Street to convert 8 bedsits into 4×1 bedroomed units.

Lighting Improvements

Public Lighting Department is currently undertaking improvements to lighting on some of the smaller streets between Francis Street and Meath Street to improve safety and the public realm. Lighting in the area is being upgraded to LED as part of a planned citywide changeover. A programme of painting of street lighting columns and upgrading to LED will continue subject to resources.

A flagship lighting scheme on Thomas Street and James Street is continuing and will likely be completed by mid-summer. The programme has involved installation of 58 no. 'Cuffe Street' heritage lamps along the route.

Pimlico

The Area Office has now remedial completed work to the small green at Pimlico. Works included laying a new pathway through the space, installing new lighting, repairing and repainting the boundary, restoring an area of lawn and some replanting.

Vicar Street Play Area

The Area Office has completed final works to the small hard surface play area at Vicar Street. Following work last year to repair the surface and install new play equipment, the boundary railings has now been repaired and repainted and public lighting in the area improved.

Newmarket Redevelopment

Work has been largely completed on a new 400-bed student housing, office and retail development at Mill Street. Known as UniNest 'New Mill', the complex is expected to open in stages from June and be fully occupied in September. The project has included restoration of No 10 Mill Street which will now comprise high quality office spaces.

Work has also commenced on a second UniNest development at an adjacent site on Blackpitts, due to open in 2018, while work also progresses on the Starwood Aloft hotel on the site of the former Tenters Pub, also expected to open in 2018.

The redevelopment on Mill Street, together with an emerging masterplan for privately owned sites in Newmarket, and the Council's own public realm masterplan for Newmarket represents a very significant rejuvenation of one of the more neglected area of Dublin 8.

Improvement works at Cashel Avenue and Captains Avenue

Improvement works at Cashel Avenue and Captains Avenue consisting of new parking zones, new footpaths and a plinth wall surrounding the greens were substantially completed on 28th April. The works are funded from the South Central Area Discretionary Fund 2016. It should be noted that landscaping (reseeding and planting of new trees) will take place at both locations when the spaces have been leveled.

Brickfield Park

Works to install an all weather pitch in Brickfield Park are now complete. The new pitch was funded by Dublin City Council and Sports Capital grants.

The official opening by the Lord Mayor took place on Monday, 24th April.

Drimnagh. It is planned to install 3 'Welcome to Drimnagh' signs later this month or early next month. Following consultation with local community representatives the signage will be located at Davitt Road/Kilworth Road, Davitt Road/Slievenamon Road and Rafters Road/Crumlin Road.

Long Mile Road/Slievebloom Road

Remedial works have been carried to the wall opposite the Half Way House. The cracks have been repaired and the wall re-plastered with pebble dash to match existing walls in the area. This work was funded from the South Central Area Discretionary Fund 2017.

Commemorative Plaque

The Unveiling of a Commemorative Plaque by the Associated Bluebell Communities Commemorating the 16 Executed leaders will take place on Tuesday 16th May. Local Schools, Community Groups and members of the defence force will be in attendance.

Liberties Swift Conservation Project

Eighteen Triple Cavity Swift nest boxes will be erected in St Brigids School the Coombe, and Francis street CBS in the coming days. This is a joint initiative between DCC, local schools and the Dublin Swift Conservation Group in an effort to provide much needed nest sites for these iconic City birds whose populations are in serious decline.

Swift calls will be played in an effort to attract the birds to their new nest sites and educational talks and workshops will take place in local schools.

New nest boxes have been designed here in Marrowbone Lane, they have special features that will suit buildings without overhangs. They have sloping roofs to prevent predators from perching on the boxes. The first of its kind in Ireland, they are made from a fiberglass material which will last a lifetime. They will officially be called **The Liberties Swift Box!**

Senior Citizens Complexes

Dublin City Council Community and Social Development Team will provide Senior Citizens Complexes in the Crumlin Kimmage area with a small number of bedding plants to enhance their complexes.

Residents/Environmental groups

Dublin City Council Community Team has identified a number of residents/environmental groups in the Crumlin Kimmage area for environmental enhancement projects. However on the recommendation of Dublin City Council Parks Section, groups will now plant bulbs in September instead of planting plants, as this will give more impact in areas identified with less maintenance for groups.

BALLYFERMOT /DRIMNAGH ELECTORAL AREA

Ballyfermot Road Public Realm Improvement Plan

A public consultation which was very well attended by both business owners and residents was held on 24th April in the Ballyfermot Library. The next stage will be to meet with internal stakeholders which is scheduled for 8th June 2017 and give them a month to give their consideration and comment on the plan. This will then be fed by the Consultants into the final draft.

Ballyfermot/DrimnaghCommunity Update Bealtaine

As part of Dublin City Council Bealtaine celebrations, the Council is hosting a performance of Bezzie, a powerful one woman show by Sheila Flitton at Claddagh Ct Senior citizen's complex on Thursday 18th May @ 2pm. The event is free with refreshment provided.

Weekly dance classes continue in the Ballyfermot Sports & Leisure Centre every Tuesday morning 11.00 am – 12.00 noon. The Community Gardaí from Ballyfermot Garda station will be giving a talk on home security to the Ballyfermot Senior Citizens forum at 11.30am on Thursday May 18th in Ballyfermot Civic Centre.

Installation of Remembrance Plaque in Bluebell.

On May 16th the Trees planted to commemorate the executed 1916 leaders were identified in the unveiling of a Commemoration Plaque in Bluebell.

The Cherry Orchard Summer Fair

The City Council are supporting the Cherry Orchard Summer fair which takes place over the 19th and 20th May in the Equine Centre and Cherry Orchard Park. Staff from the area office,

Sports development section and Orchard Community centre are supporting a large range of activities over the course of the two days. 

• **Green Scene** is a new summertime initiative aimed at getting more people active through better use of our parks & green spaces in Dublin City. DCSWP Sports Officers will work with partners to organize new, interesting & enjoyable games, activities and coaching sessions.

Complimenting The Green Scene will be the following:

Seen on the Green – Efforts will be made to entice well known sporting personalities to attend activities. We will promote these through a 'Seen on the Green' segment on social media and other relevant media channels. This will help build the profile of the programme and assist with securing future sponsorship.

The Green Machine – Awards/prizes will be presented to participants attending the highest number of sessions.

• **Cycle Leader Training:** A number of DCSWP Sports Officers have combined recourses to facilitate a Cycle Leader Training Course on June 28th/29th in the Municipal Rowing Centre, Islandbridge, D8. A number of adults from the South Central Area are expected to attend this training and subsequently lead a 6-week 'Bike for Life' programme prior to the great Dublin Bike Ride in September. Updates to follow.

• Aviva Stadium Tours & Boxing Taster Session:

All 5th & 6th class pupils and Transition Year students throughout the Dublin City area, including many from the South Central Area, who took part in the Startbox Programme have been invited to take part in free tours of the Aviva stadium throughout June & July (which will be guided by DCSWP/IABA Boxing Officers). Students will also experience a short coaching session and view some famous Irish, International & Olympic boxing memorabilia (this will be coupled with interesting & informative stories/anecdotes to inspire and educate the students!).

- Stanaway Park Family Fun Day This will take place on Sunday 25th June from 1pm 5pm. Activities to include athletics, archery, fencing & frisbee.
- A number of Community Sports Days will be held in Clogher Road this July from 10.30am 3.30pm on the 4th, 11th & 18th.

• Donore Community Drugs Team (Pilot TRY Programme)

The DCSWP Sports Officer is working alongside the Donore Community Drugs Team on a programme called TRY (Targeted Response at Youth). This initiative is targeting a group of disaffected young men and is a pilot programme due to run to middle of July. The young men are attending a soccer drop-in session in St. Catherine's Sport Centre on Monday evenings from 5pm to 6pm and then, depending on their individual needs, will meet with the drug team workers during the week. On Friday mornings the young men travel away from the area to take part in a range of sporting activities including Football Golf, Football Darts, Skills Zone, Jump Zone, Hill Walks etc...

• Club Support

The local DCSWP Sport Officer supports and works with the coaches from *St. Catherine's Boxing Club* & *Tae Kwon-Do Club* who both train on various evenings in St. Catherine's Sports Centre and are always willing to take on new members. Likewise with *Liberty Saints Rugby Club U13's & 17's* who train on Tuesday & Thursday nights in Liberty Park on Basin Lane.

- Bluebell Fitness Classes Two fitness programmes run weekly in Bluebell Community Centre; Zumba on Mondays from 7pm to 8pm and Aerobics on Thursdays from 7pm to 8pm. This programme is open to the community.
- Fatima Fitness Classes Two fitness programmes run weekly in the F2 centre; Step Aerobics on Mondays from 6pm to 7pm and Circuit Training from 6pm to 7pm on Thursdays. This programme is open to the community.

• Activities for Over 55's



The Office fulfils a number of functions. The Housing Management function and sheltered housing function, and the associated welfare service are provided from the office as a base. The Community Development function uses the meeting and office facilities. The Public Counter supported by the administration function deals with the Public attending the office.

It is not within my power to give any assurance that the public counter will remain open to the public on an ongoing basis. Decisions on the allocation of resources and staff are made periodically in the light of service provision needs and resource/staff availability. In respect of the Public Counter as long as there is identified and viable need and demand, and staff to service this, the public counter will not close. We will assess and monitor the public usage of this office periodically.

In line, however, with my consistent position the necessity to staff and provide "on the ground" services in Public Realm and in Community Development will remain my primary resource focus. It is more productive to have staff out engaging citizens, community and issues, than in an office waiting on callers. Furthermore it should be noted that the workload of administrative staff relates to internal administration as well as to the administration of service requests or interaction with the public. It is my intention to rationalise the internal administration workload rather than spread it over the three offices. On 17th April a stolen articulated truck damaged the CCTV pole in Cherry Orchard causing the cameras to lose their functionality. The pole was removed for health and safety reasons and the damaged cameras retrieved for assessment. A quote has been received for the reinstatement of the pole with substantial ground works and the replacement of the cameras. A second quote is awaited after which it will be decided how best to proceed with the installation of the CCTV pole with additional security to safeguard the site.

It's an old laneway that runs from Dolphins Barn to James Walk between Reuben Street and Maryland. The dumping is a consequence of both locals dumping, but commercial also based on information received, and the sheer scale of the dumping on the site. Can the site be cleared of rubbish and prevention measures be introduced.

<u>Reply</u>

The area known as the "Back of the Pipes" refers to a substantial laneway that runs from Reuben Street\Dolphin's Barn at one end to St. James's Walk\Grand Canal Basin at the other. Various segments of the laneway have been closed over the years with the last remaining segment being closed in September 2001.

Sections of the laneway have had to be cleaned on a recurring basis and in particular in 2005 the Council's Housing Department carried out a major cleanout of the section of laneway which is the source of the current complaint at a cost of \in 50,000 approximately. The current dumping is substantial and photographs show that most of it would appear to be household refuse. Further the location of the dumping seems to indicate that this dumping has to be coming from the residences adjoining the laneway of Lourdes Road, Mallin Avenue and McCarthy's Terrace.

The scale of the dumping is such that it will require the use of a JCB to clear it and at the moment this is not feasible as there is no access for same. The Council's Property Management Section is working with the Area Office to try and resolve this issue and to try to come to a long term arrangement regarding the future of the laneway so that this issue does not arise again.
