Can the Manager explain why the North West Area Committee no longer gets a quarterly Planning Enforcement report?

Given the influx of planning applications for Student Accommodation in Dublin, this committee calls on the Planning department to prepare a policy to address the genuine concerns surrounding overconcentration of such accommodation in residential areas. While the Dublin City Development Plan 2016 -2022 does refer to overconcentration, the new policy would need to be more specific in relation to acceptable numbers of developments and bed spaces within a particular radius.

we were talking about coloured or ethnic diverse communities this policy would be considered racist. As it stands it is pro-market and anti-community.

This motion proposes that Dublin City Council Management be mandated to request the Minister of the Environment to increase the economic threshold barring working families from accessing public housing. Households with income up to 80,000 net should be considered eligible to access public housing.

To ask the Manager there are cracks in the roof and inside the house upstairs and down. Could they be investigated as they may be related to pyrite in the area? (details supplied)

Q.2 Councillor Paul McAuliffe

To ask the Manager to look at the parking along (details supplied). It is very bad and Residents cannot park especially during match days

Q.3 Councillor Paul McAuliffe

To ask the Manager outline the timeline for completing the full installation of the outdoor gym scheme in (details supplied), Can he state why the current location was selected, what consideration was given to the adjoining play ground and the privacy issue which may arise.

To ask the Manager the paths along the road need to be repaired outside (details supplied) and the surrounding area.

To ask the Manager to contact Dublin Bus in relation to complaints being received from bus users on the (details supplied). Some but not all Dublin Bus drivers are skipping the part of the route after the bus leaves the Axis bus stop. This is leaving commuters stranded for hours at one end waiting for their bus to arrive. Could management contact Dublin Bus to find out why this is happening and explain the necessity of this route to be fulfilled as there is an older part of the Ballymun population without cars relying on the (details supplied) bus service.

To ask the Manager (details supplied) to investigate why the site at the east elevation has very high trees. Would Parks or Maintenance be able to reduce these trees to avoid over shadowing on the row of houses east to the school perimeter? The trees are quite spindly and look like Yew or Birch. At present there is building works going on, on the property and now may be a good opportunity with cooperation from the builder to get trees reduced a little.

Cabra Area Office Report

Blackhorse Avenue Works

On the north side of the road (Lyndon Gate to opposite Park Crescent House) the following works have been carried out:

- laid a new section of storm water sewer, and its' associated gullies and gully connections.
- Replaced a section of existing combined sewer just east of Nephin Road junction.
- A new water main and associated water connection to each house has also been placed.
- The carriageway has been completely excavated and rebuilt new (as far as final surface layer – this final layer will be carried out at the end of the Works, along with the final layer of surfacing over the full extent of the job).
- The final portion of footpath has been completed

At Workfront No. 5 (opposite the Pallet Yard, to Springfield Road – north side):

- Works commenced at this location on Wednesday, 24th May, and will be carried out under the usual two-way shuttle system using temporary traffic signals.

The contractor has now moved to the east end of the Works. This section of the works will take approximately six weeks. At that time, the Contractor will extend the length of the works to include the junction of Skreen Road. This will take approximately a further two weeks. At the end of this eight week period, the area will be reopened to vehicular traffic.

Finally, the Contractor will then work on two remaining Sections of road:

- (i) A short section east of the Springfield Road junction; and
- (ii) Between the junctions of Nephin Road and Skreen Road.

Mount Bernard Playground extension

Work commenced on the development and installation of a 'Natural Play Area' at Mount Bernard Park on Tuesday 30th May. The project should take approximately three weeks and there may also be some time added to allow grass to take etc. All going well the facility should be ready for use during the school summer holidays.

Public Lighting

Last year, Dublin City Council Public Lighting Services started a programme to replace all of the existing low pressure sodium lights (i.e. the orange coloured lights) throughout the

Council functional area with LED lights (i.e. white light) over the course of the next few years. The lighting on St. Jarlath's Road was replaced under this programme.

By using energy efficient LED light sources in public lighting installations, Dublin City Council is reducing its energy consumption and its carbon emissions footprint, and this will also assist the Council in meeting its obligation under the European 2020 carbon reduction targets.

Ratoath Road Flyover

Irish Rail has informed the Roads Department that they have engaged a contractor to conduct remedial works to prevent further flooding on Ballyboggan Road following heavy rain. This work was scheduled to be carried out on the June Bank holiday weekend but was postponed until 17th June.

Shandon Area

Badly damaged kerbs on the corner of Shandon Crescent have finally been replaced and work is under way to repair grass verges on the Road and Park which have also been damaged due to the narrowness of roads here.

Community & Social Development

Community Environmental Projects

Over twenty community groups participated in the subsidised Community Flower Sales at the Cabra Office. Community staff supported the groups in their endeavours to improve their neighbourhoods and their entries in the City Neighbourhood Competition. Many community spaces were planted by the groups using these flowers.

Christ the King Centre

Work has commenced on upgrading of the Centre: painting, installation of footpaths, landscaping and planting. The cost of the works is being covered by D.C.C. and is being overseen by the volunteer committee.

Charleville Road and Rathdown Road

A new residents group is in the process of being set up. We look forward to supporting them in the ventures.

Phibsborough Tidy Towns

This group continues to work on the improvement of Phibsborough Village. As a new initiative they are promoting a major Bin the Butt Campaign supported by the community team.

A new committee was elected and some new volunteer have joined the group.

Summer Projects

There are four Summer Projects in the area this year: Annamoe, Sharing the Journey, Riverston Abbey and a new project in St Oliver Plunketts off the Navan Road. In addition to these projects there will be activities in Ventry Park, Cabra Parkside and Naomh Fionbarra's G.A.A. Club.

European Neighbours Day

This Community Event was a great success and took place outside the Cabra Area Office. It was well supported with 20 community groups and local businesses participating. Lord Mayor Brendan Carr also attended in addition to hundreds of local people.

Notice of Intention to Lodge Formal Part 8 Planning Application

Social Housing Need

The Scribblestown site falls within 'Housing Area E' of the City Council's functional area, which includes the areas of Ashtown, Blackhorse Avenue, Santry, Whitehall, Cabra, Finglas and Glasnevin. There are currently 3,247 households which have a qualified social housing need in this area. An analysis of the ten housing areas in the city indicates that Area E has the second highest social housing need at 17% of the overall need in the city. It is further noted that some 47% of all families with a social housing need in Area E have been on the waiting list for in excess of five years.

The aim of the development at Scribblestown is to deliver 69 additional Social Housing apartments in the Finglas area. The apartments once developed will form part of Dublin City Council's housing stock and will assist to meet the considerable Social Housing need outlined above.

Site Location

The 1.05 hectare site is located on the far south western edge of Finglas, overlooking the Tolka Valley Park. In terms of providing new residential development the site is well served by existing local schools and a number of sports amenities, all within easy walking distance. Scribblestown is a well established area of the city, mostly residential in nature but complimented with commercial, community and recreational facilities. The location is considered ideally suited for new residential accommodation, particularly family type accommodation.

Tolka Valley Park situated immediately south of the subject site is an important regional park of approximately 50 hectares. The parkland has been developed to include recreational facilities such as pitch & putt golf course, football pitches and riverside walking routes.

Proposed Development

The proposed development comprises circa

- 69 Social Housing Units, including 16 no. 1 bed units, 41 no. 2 bed units and 12 no. 3 bed units,
- 1600 m2 of landscaped public open space,
- 900 m2 of Communal Amenity Space,

- 111 Surface and underground car and 78 cycle parking facilities.

Unit Arrangement

The apartments are arranged in 2 blocks utilising a varied approach to building height with a 5 – 6 storey elevation to the south (Scribblestown Lane) utilising the existing slope on the site. There is a 3 storey elevation to the north of the site in consideration of existing residential form on neighbouring sites. The site layout was developed to allow for the provision of additional public open space to the north of the site and the development of underground car parking to the southern elevation, thus reducing the traffic impact of the proposed development within the neighbouring Scribblestown community.

Space Standards

Apartment size, storage requirements, private open space and provision of communal open space has been designed in accordance with the standards set out in the Sustainable Urban Housing: Design Standards for New Apartments (2015).

Residential Courtyards (Open Space)

72% of total unit provision are Dual / Triple aspect units. The development comprises approximately 1,600 m2 of Public Open Space and 900 m2 of Communal space for resident use with overlooking private space/balconies.

Car/Bicycle Parking Provision

The scheme makes provision for 82 no. car parking spaces within the curtilage of the development and 29 car parking spaces outside of the site boundary. There are also 78 no. bicycle stands.

Public realm

The internal courtyard is naturally overlooked by apartment units and will provide a safe internal space for residents of the apartment units. Outside of this area, balconies are the predominant type of private open space serving each unit. The significant public open space provision along the northern boundary of the site is not only overlooked by apartment units within the proposed development, but is also naturally overlooked by existing neighbouring properties thereby ensuring natural, passive surveillance.

Public Consultation to date

The Project team has undertaken a number of public consultation meetings with the local residents in respect of the proposed design and has modified the original design to address some of the concerns and issues raised, including:

- Reduction in the overall numbers of units from 72 to 69;
- A 25% reduction in the no. of 1 bed units;
- The provision of an additional 22 car park spaces;
- A revised traffic management plan for the proposed development, with access/egress to the development predominately from Scribblestown Lane;
- A significant increase in the separation distance between the existing residential development and the proposed development;
- Relocation of the bin enclosure to the lower ground level with access from Scribblestown Lane.

Conclusion

The finalised proposal for the development of 69 Social Housing Units at Scribblestown, Finglas, as set out above, has been developed through consultation with local residents and the Elected Members. We hereby notify the Elected Members of the North West Area Committee of the City Council's intent to initiate a Part 8 Planning Application for this scheme in the coming weeks.

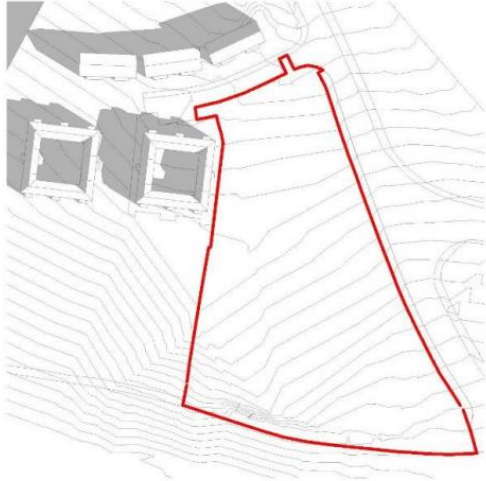




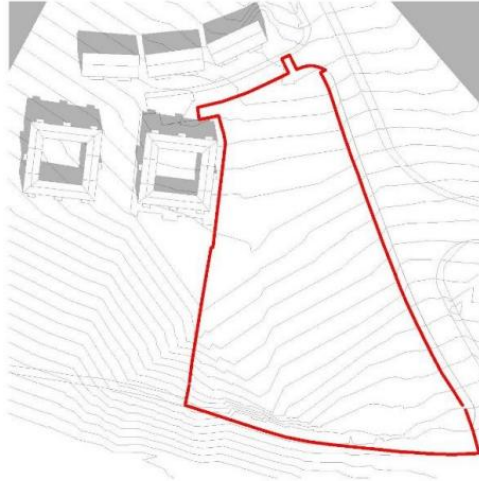

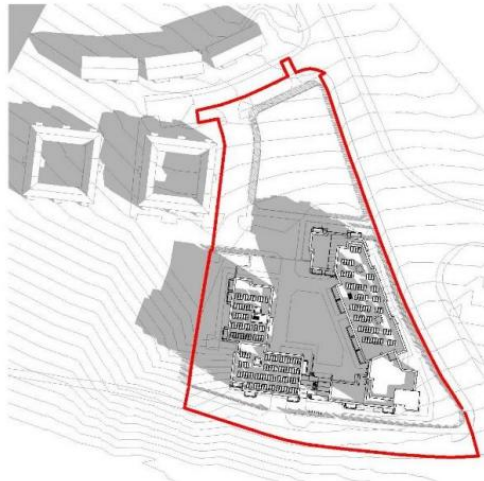

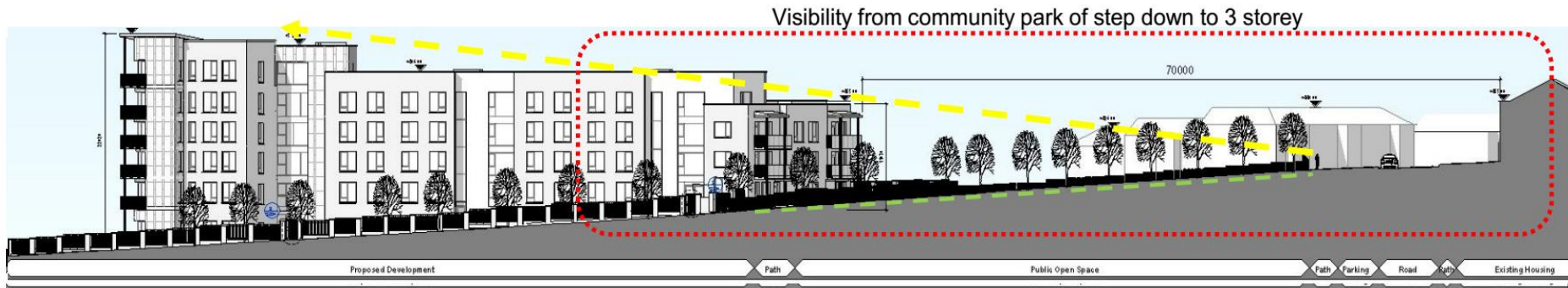

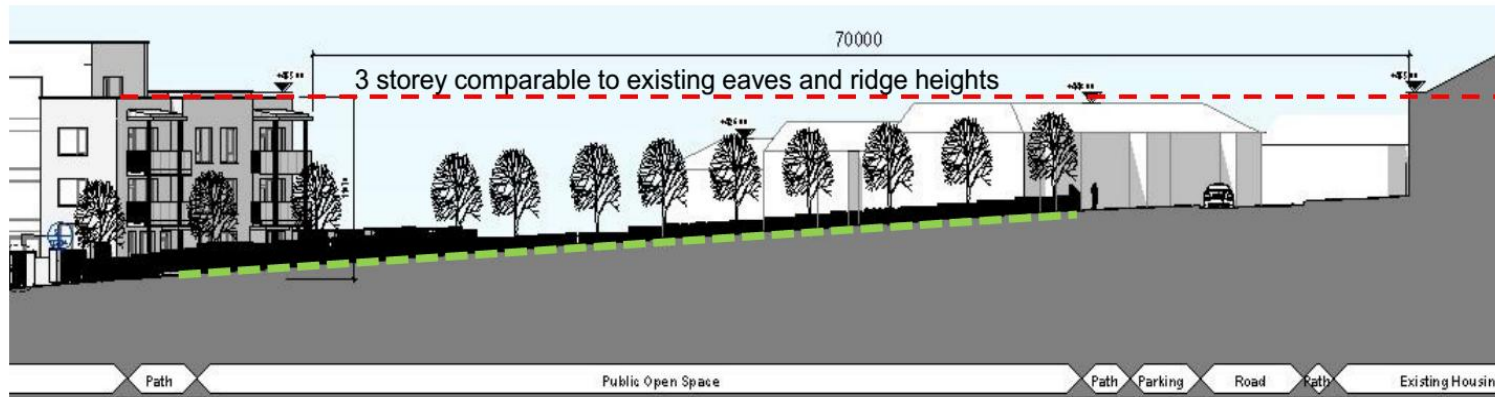
Existing Site Layout



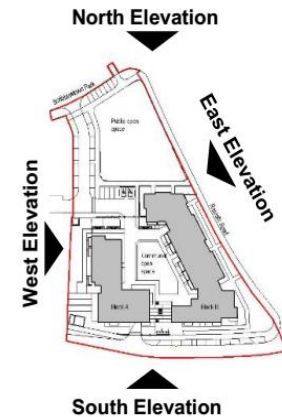
Proposed Site Layout

It is important to note that a significant number of additional complaints were also investigated as all area staff pick up complaints when carrying out daily duties but due to lack of resources all complaints are not logged.

Annamoe Parade Clean Up

In 2016 the Public Domain Team conducted works in Annamoe Parade, involving the moving of bollards to facilitate vehicle access to the cul de sac in the laneway for cleaning purposes. As a result of this work it has been possible to remove illegal dumping on a more frequent basis. A new initiative has now been commenced to again clean the laneway and remove graffiti and paint some of the walls to make the area more welcoming to local pedestrians using the lane to access the adjoining Charleville Road and Annamoe Drive

areas. This work will be undertaken jointly by both DCC Waste Management crews and by painting contractors and on completion the area will be monitored in an effort to maintain the appearance of the location. It is also proposed to utilise CCTV at this location for a period to identify illegal dumpers.

Mobile CCTV

The problem of illegal dumping persists in certain locations throughout the area, particularly on some green areas, having a detrimental effect on the quality of life of local residents. This was reflected in feedback received in the IBAL reports on Ballymun in 2016. To combat this, the Public Domain Team has deployed movable CCTV in dumping black spots in the area. Areas covered so far include Marewood Crescent, Gateway Crescent and Barry Close, and this surveillance has resulted in the issuing of a number of fines and the capturing of images for name and shame boards in the Ballymun area. Some difficulties have arisen, with vandalism of a camera and a name and shame sign, but feedback from residents where the cameras have been utilised has been universally positive. The use of CCTV will be continued over the summer months, with further green areas and laneways being assessed for camera locations.

Finglas in Bloom for the Tidy Towns

As the summer has progressed The Finglas Tidy Towns group have become a familiar sight in the village, having commenced their Tuesday night clean ups in preparation for this years competition. This work is building on the major success of the Team Dublin Clean up event, which saw large numbers of volunteers conduct a major clean up of the village. The Public Domain Team is supporting this work by carrying out a works programme in the village. Considerable work has already been undertaken. Further tree pits have been installed on Ballygall Road West and assistance provided in the purchase of flowers for planting at the location. It has also been possible to assist in the installation of a buddy bench near the site of the 1916 memorial on Seamus Ennis Road.

The flower baskets are due to be placed around the village shortly, and it has again been possible to provide additional planters around the village, with a new one installed as a permanent feature on McKee Ave. Good luck to the Finglas Tidy Towns group and to all the entrants from the NWA in the 2017 competition.

Following the very positive reaction to the three tier planters placed on Cardiffsbridge Rd last summer, these have again been placed on site for this year's summer season. It is hoped that residents in the area will enjoy them, as they bloom over the summer months.

Safety Enhancements

Following on from requests from local residents on the unsafe nature of the grass verge at the junction of Griffith Road and Fairlawn Road and its unsightly appearance, caused by illegally parked vehicles, a knee high rails has been installed. This will allow for the reinstatement of the grass at this location. Also, an unsafe area in the laneway connecting Fairlawn Road and Park has been rectified with the laying of a new tarmac surface. New railings and a barrier, to impede the passage of motor cycles travelling from the green space between Barnamore and Kippure Park on to St Helena's Road are currently being constructed and will be installed shortly, as well as a barrier on the steps connecting Kippure Park and St Helena's Rd.

City Neighbourhood Entries

Entries have been received for the 2017 City Neighbourhood Competition. A record number of 90 entries have been received from residents/environmental groups in the NWA, including a number from recently set up groups. If recent trends are repeated the NWA will have the most entrants of the five areas within the city, with the excellent work done in the area reflected in the achievements of recent years, culminating in Courtland's being the 2016 overall winners. All the entrants will be visited by the judges and the NWA winners will go forward to the citywide competition. Good luck to all our entrants.

Dublin City Sport and Wellbeing Partnership Report

- **Green Scene** is a new initiative aimed at getting more people active through better use of our parks and green spaces in Dublin City. DCSWP Sports Officers will work with partners to organise new, interesting and enjoyable games, activities and coaching sessions. It is also hoped to bring sporting celebrities on board to promote the initiative via the tagline 'seen on the green'.
- **Cycle Leader Training:** A number of DCSWP Sports Officers have combined resources to facilitate a Cycle Leader Training Course on June 28th/29th in the Municipal Rowing Centre, Islandbridge, Dublin 8. A number of adults from the North West Area are expected to attend this training and subsequently lead a six week 'Bike for Life' programme prior to the great Dublin Bike Ride in September. Updates to follow.
- **Older Adults Programmes - Cabra**
Monday 1 - 2pm; Cabra Parkside Community Sports Complex - Go for Life

Wednesday 12 - 1pm; Inspire Gym and Pool, Ratoath Road, Cabra - Aqua Aerobics
Thursday 3 - 5pm; Cabra Parkside Community Sports Complex - Bowls
- **Youth Programmes - Poppintree**
A multi-sports programme will take place in a variety of venues including Poppintree Sports & Community Centre and Poppintree Park throughout May and June. These sessions are aimed at engaging youth at risk. The programme is run in partnership with local youth groups.

The community is encouraged to get involved through walking and cycling to school, skipathons, penalty shootouts, trying new activities and physical activity homework to get the family involved!

- **Walking Football** – This programme is delivered every Tuesday from 11-1pm in Cabra Parkside Community & Sports Complex. The session is delivered in partnership with the FAI. Open to men aged 55 years and older, it involves the same rules as ordinary soccer except players are not allowed to run. The aim of the programme is to provide an opportunity for men to take part in physical activity in a

fun, friendly and social setting. Occasionally, in good weather, the group will undertake a hill-walking session instead.

- Whitehall Petanque Group
Whitehall Petanque Group is a new initiative which is part of our 'Green Scene' core programme, as outlined above. DCC Parks Division recently installed a new petanque court in Ellenfield Park, Whitehall (next to the astro pitches) and subsequently this new group has now formed. We are looking for adults over the age of 55 to join the group each week on Wednesday mornings from 10am to 11am. It is free to play and if you have never played before you will be shown how. It is a simple game to learn and can be played almost anywhere outdoors by both young and old. If you enjoy good company and friendly competition, you will enjoy playing Petanque.
- **Sports & Fitness Ballymun** and **Sports & Fitness Finglas** will hold weekly Summer Camps for 5 – 12 year olds, commencing on Monday 3rd July. The camps will entail fun games/activities and swimming sessions and will run throughout the Summer. There will also be weekend swimming lessons for children from the age of 3 upwards, commencing July 8th. Each block of lessons will run for four weeks.
- **Sports & Fitness Ballymun** are offering specific classes for people with back pain every Monday at 12pm (in partnership with the HSE)
- Both **Sports & Fitness Ballymun** and **Sports & Fitness Finglas** have introduced a scheme whereby homeless people currently residing in nearby hotels can access the facilities at a reduced rate to assist with their physical and mental wellbeing (in association with DePaul)

FAI/DCSWP Football Development Officers – Update

- Paul Whelan and Jamie Wilson have just wrapped up the Project Futsal Programme for the 2016/17 academic year. The students will now be concluding their FETAC Level 4 Award, ITEC Gym Instructors Award and their FAI Coaching Awards.

From July 3rd the FAI/DCSWP Development Officers will be delivering eight weeks of Summer Soccer Camps. These camps will be held at various club and DCC venues throughout Dublin for the duration of July and August. Paul and Jamie will head up the biggest camp which runs for two consecutive weeks (July 3rd – 7th + July 10th – 14th) and takes place in Home Farm FC, Whitehall. The camp capacity each week is 150 kids and it is hoped to attract a lot of boys and girls from the Finglas and Ballymun areas. Students from Project Futsal will also be used as paid coaches on these camps.

- Aviva Stadium Tours & Boxing Taster Session:
All 5th and 6th class pupils and transition year students throughout the Dublin City area, including many from the North West Area, who took part in the Startbox Programme have been invited to take part in free tours of the Aviva Stadium throughout June and July (which will be guided by DCSWP/IABA Boxing Officers). Students will also experience a short coaching session and view some famous Irish, International and Olympic boxing memorabilia (this will be coupled with interesting and informative stories/anecdotes to inspire and educate the students!).

1. Community Update

General Community

Team members attended the following meetings: Santry Community Centre Board Meeting, Ballymun Allsorts, Ballymun Men's Shed, Oak Park Residents, BADIG, Beo Festival Meetings, Otherworld Festival Meetings, Santry Community Centre (10th Anniversary Events), Poppintree Health for All Group, Iona Road AGM, Ellenfield Residents Group, and the LECF Seminar. The Community team are supporting five voluntary and five non voluntary summer projects in the local area. Ongoing meetings are taking place with the groups and Crosscare Representative Roisin Cloake. Additional supports have been put in place for the local voluntary projects.

Social Inclusion

Men's Sheds

The Community team attended a meeting in DCU with Samantha Fahy, Sustainability Officer for DCU and the Assistant CEO of DCU, Declan Raftery, around the possibility of Ballymun Men's Shed locating in the DCU Community Garden and of DCC providing a financial contribution towards this project. Further meetings will be arranged in the near future involving the Irish Men's Sheds Association and the Ballymun Men's Shed Committee. Ongoing meetings with Ballymun Men's Shed and the Irish Men's Shed Association are taking place.

Older Persons

Community Team Members linked with the following groups: Active Living, Age Friendly Group, Whitehall Active Retirement Group, Iona Road Active Retirement Association, and BADIG.

Ladies Groups

Community Team Members provided ongoing support to Sillogue Ladies Group and ongoing assistance to the Sillogue Neighbourhood Centre, in particular assisting with Neighbours Day/Mental Health Awareness Day, including a Breakfast Bingo which took place at the Centre.

Community Team Members are working on an ongoing basis with the new Ballymun Allsorts Parents Group and are supporting them to get up and running in the local community. This group meet on Fridays in the Ballymun Child and Family Resource Centre.

Mental Health

Team members promoted the green ribbon (mental health stigma reduction campaign) at the Breakfast Bingo Event in Sillogue Neighbourhood Centre. Ribbons were also distributed to various community groups. Team member attended a number of meetings in relation to the MOJO Project (housed in BRYP).

Environmental

The team are working alongside with Public Domain Staff and Residents to support this year's Pride of Place Entry for the North West Area (environmental upgrades have taken place in Doon Court, Graigue Court and Knowth Court and surrounding areas) and staff have attended a number of meetings in this regard. Ongoing meetings also took place with Public Domain Staff in relation to local environmental initiatives and distribution of planters, blue bags, brushes etc. The Community Team co-ordinated three local Plant Delivery Days whereby plants were distributed to 34 local community/environmental groups. This was an extremely successful initiative. The first Greening of the Area Workshops (GAP, DCC and local groups) took place in Knowth/Druid Court on Wednesday the 7th June and was a very successful day. Team Members have been working with STAR Ballymun to help refurbish their community garden space in the Horizon Building. The Community Team Members

assisted the Ballymun Tidy Towns Committee with their annual Ballymun in Bloom community plant sale which took place on Thursday the 25th May on the Ballymun Plaza.

Events

The Beo Ballymun Festival took place from the 6th to 9th June. The Community Team supported a number of the events and hosted a free concert (The Rooney's and Clann Ri Liam) which took place in the Council Chambers on Tuesday the 6th June. Ongoing meetings are taking place for the upcoming Otherworld Festival. Apart from the overall working committee, a Parade Working Group and a Community Working Group have been set up and are meeting on a regular basis. The team supported two local Street Feast Events, one in Drapier Green and the other in St Pappins Green.

Dumping

Public Domain in conjunction with the Project Estate Officers in Ballymun continue to target residents who are illegally dumping. There is an ongoing anti-dumping programme in place targeting households who have no bin providers. Residents are being interviewed by Estate Officers over the last couple of weeks to determine who their bin providers are. If residents do not have bin providers they are informed that they have ten days to set one up and produce evidence of their bin collection receipts. This is done in conjunction with a name and shame programme being run by the Public Domain Unit. Cameras are being used to catch residents who dump their rubbish and pictures are displayed publicly seeking information on the person.

Residents Groups Clean-ups

Public Domain continues to engage with residents groups who are taking part in regular clean-ups in their area and this is making a large improvement in Ballymun. We continue to provide all clean up equipment and garden equipment needed for groups to do these clean up and planting projects. We continue to endeavour to get new groups on board and encourage residents to form Environmental Groups so that they can avail of our Community Grant next summer. This money can be used to improve their streets and green spaces. We have made contact with new groups in Whiteacre Close, Whiteacre Crescent, Carton Terrace and Hollytree Square with a view to organising a clean-up and some planting projects with Community Section. A number of tenants in the Shangan and Coultry area have also requested skip bags so they can organise a clean-up of their properties. We now have groups across both sides of Ballymun actively engaging and working with us to make their areas clean.

Older Persons Unit

A number of new environmental projects have been identified by area office in Ballymun. One of these was the Albert College complex. Work involved removing overgrown bushes, shrubs and weeds in the three garden areas with a view to having them paved and some planters installed. Initial works have now been completed and we are looking to start the next phase of planting and paving in the coming weeks. This will make the area easier for residents to manage and become a place for them to sit in and relax and enjoy the gardens. We are working with the Liaison Officer in Sandyhill Gardens Older Persons complex and are continuing with a planting project started last month. Residents continue to plant, water, dig and tend to the green spaces in the complex. All equipment is supplied by the area office and plants supplied by Community Section. Residents have said that it is bringing the complex together and improving the community spirit. Residents in Griffith Close Older Persons Complex continue to look after the green space with the equipment provided by the Area Office. The complex will receive plants from DCC Community to bring some colour to the space and so they can enjoy the new benches recently installed.

CRM

Our system for logging complaints is updated daily and all jobs delegated to appropriate supervisors. Any complaints of a public domain nature can be logged on Fixmystreet.ie.

Carton

Great work was done by Ballymun resident Mr. Traynor to the green space facing them on Carton Terrace whereby all edgings were tidied and three large flower beds put in on the green space. Public Domain and Community linked in with him and provided equipment, compost and plants which enhanced the beds and the look of the area.

Planters

Residents groups who have been involved in regular clean-ups and have engaged with the area office have received large planters to further enhance the great work carried out by residents. Shangan Avenue received two planters with a nameplate on and plant boxes have been installed around all trees that line the road and planted flowers inside. Residents have expressed a new found pride and feeling of togetherness for their area as a result of all their hard work. Whiteacre Close received two planters from their involvement and clean ups. They have planted around all tree beds and carried out a weeding project on the paving stones. Knowth and Druid Court received two large planters with nameplates for all the efforts made by residents over the last two years. These areas undertook a huge painting project and have completed planting projects on every green space on both sides of the road. Residents said they are delighted that all their hard work has been recognised and rewarded by DCC.

Carton Terrace is awaiting their planter. Residents have carried out planting work on their green space and large flower beds have also been installed by residents. The planter is due to be delivered in the coming weeks. Three large planters which were donated by Irish Life, have been placed in the space in front of the swimming pool.

Pride of Place nomination

Residents in the Doon/Knowth/ Druid and Graigue Court area along with Crannog Estate and Belclare Estate have been nominated for a Pride of Place award this year. Public Domain has been working with residents to give them the best chance of winning an award. There have been clean-ups, planting projects, painting and equipment given, topsoil, plants and much more including advice and support. This is a fantastic achievement and will be a chance to show Ballymun in a positive light and showcase all the residents' hard work. Judging will take place on August 29th at 2:30pm and we will continue to work until then to give us the best chance of winning!

Insulation

All the insulation work in Shangan and Coultry is completed.

Pyrite

Remedial works are well underway for the pyrite works in the Carton Estate. We are half way through the programme with the builder taking ten houses for remedial works at a time. The families are being re-housed temporarily in accommodation in the surrounding area for a seven week period.

Anti Social Behaviour

There has been a surge in anti social complaints relating to drug dealing in the courts and Belclare. Dublin City Council has met with senior members of the Gardai to discuss ways of tackling these issues.

Economic Strategy

The next Economic sub-committee meeting is yet to be confirmed.

Stimulating economic activity

Start-Up Ballymun

Planning for the next event will begin soon. It's most likely to take place in October and the theme this time around will be '***The Business of Entertainment***'. Since, the last event our online following has grown steadily and there is now a significant awareness of the initiative. It has led to an increase in membership for B4b and created an awareness of other local service providers such as the Social Innovation Hub in the Civic Centre.

Ballymun4Business (B4b)

B4b are meeting on a regular basis and the next networking meeting is taking place on Tuesday 13th June in the Members Room. We will be rolling out a number of events in 2017 in addition to the 'Wellness workshop' already run in March:

Enterprise Space

Food Enterprise – An application for feasibility funding is being submitted to Enterprise Ireland to research the viability of creating a food enterprise hub in Ballymun. The scheme was only launched on 29th May and the deadline is Friday 9th June.

Vacant Neighbourhood Commercial Units

Pilot –

We have decided to carry out modifications work on a vacant unit in Sillogue and seek expressions of interest for a barber. At the moment we are pricing up the costs which will determine the level of detail we can go into. The unit in question is c 50 sq m. and the majority of enquiries have come from barbers seeking to expand, relocate or start up. While some of the interested parties have a steady cash-flow the main stumbling block is the capital investment required to upgrade the unit. As much as budgets will allow DCC will do some upgrade and refurbishing, - flooring, plastering, bathroom, kitchenette, suspended ceiling etc and seek expressions of interest for a barbershop in Sillogue. We are hopeful that this pilot will raise the profile of interested parties and the best application will be selected.

The units in Coultrey have been advertised on Daft which has led to an increase in the number of enquiries and viewings;

- Negotiations are ongoing with a pharmacy for unit C in Coultrey.
- Negotiations were taking place with a barber for unit D in Coultrey, but have since stalled due to set-up costs

Free Wi-Fi for Plaza – The Wi-Fi installation has been completed and is now fully functional. We have had an initial conversation with Axis about staging an event to launch the Wi-Fi.

Civic Alliance Update

The Civic Alliance Meeting was held on 1st June 2017 in the Rediscovery Centres newly opened building. Sarah Miller gave an update on the centre and its work.

The Social Sub Committee Meeting was held on 22nd May 2017, where there was an update on the progress of the Innovation Hub by Annabelle Conway. There was also an update on the Activation Process by Dave Leech, Department of Social Protection. A new working group has been set up called the Welfare Dependency Working Group, which will examine the issue and see what local actions could be taken to deal with this situation.

There was an update on the Draft LAP, the public consultation period ended on Wednesday 17th May. Three public information sessions were held in the Ballymun Civic Centre on the 6th April, 22nd April and 26th April.

The Physical /Environmental Sub Committee meeting was held on 22nd May 2017. There was an update on the LAP by Pamela Connolly. The Chief Executive's (CE) report is being prepared and will be circulated to Elected Members for consideration. The Members then consider this report and submit their motions. There will be a Special Council Meeting on Monday 13th July, and the Draft Ballymun LAP will be on the agenda for this meeting. The Planning & Property Development Department will hold a meeting with the Elected Members to discuss the CE's report prior to this meeting to assist in this process. If the Draft Plan is adopted at the July meeting, it comes into effect in early August (i.e. it takes four weeks for the LAP to come into effect, 9th August). If there are material amendments to the Draft LAP, it must go back out on display three weeks after the aforementioned meeting – i.e. 2nd August.

There was also an update on the Hampton Wood Road Link. Roads Department is assessing consultant's tenders for the design of the link road. The consultants should be appointed by the end of June. There was also an updates on the new Super Depot. Fingal County Council Planners have outlined their requirements and specifications for the building. Parks Section is nearly ready to issue a brief to consultants for the redevelopment of Cearnóg an tSeachtar Laoch.

There was no meeting of the Economic Sub Committee - Liam Barry sent out an update on Economic Activity to the Committee.

Shopping Centre: The Credit Union has secured planning permission and has submitted paperwork for a fire certificate. Dublin City Council has served notice to treat on the remaining two tenants.

Northern Site: Lidl signed a contract for the Ballymun Northern site 2 weeks ago and are due to have a pre- planning meeting this week. The next step is for them to lodge for planning. Under the terms they are to endeavour to lodge within 8 weeks of signing the contract.

Housing site: Balbutcher Lane-Cranogue Road Site, Ballymun: The position of Irish Water has been ascertained in relation to the presence of a water main affecting the site. It is hoped that the site will be marketed in the coming weeks.

With reference to the proposed disposal of fee simple in Shangan Neighbourhood Centre, Ballymun, Dublin 9.

Section 183 Report No. 345/2014 was assented to at a meeting of Dublin City Council on the 1st December 2014.

The report proposed the disposal of Dublin City Council's fee simple interest in the common areas of Shangan Neighbourhood Centre, Ballymun, Dublin 9, shown outlined red on Map Index No. SM-2014-0659, to the management company, now named Shangan NC Management Company CLG.

The legal formalities have not yet completed. In compliance with the requirements of the Multi-Unit Developments Act 2011 and by agreement with Shangan NC Management Company CLG, it is proposed to vary Report No. 345/2014 as follows:

1. In addition to the disposal of the Council's fee simple interest in the common areas, the disposal shall also include the apartments and the retail units in Shangan Neighbourhood Centre.

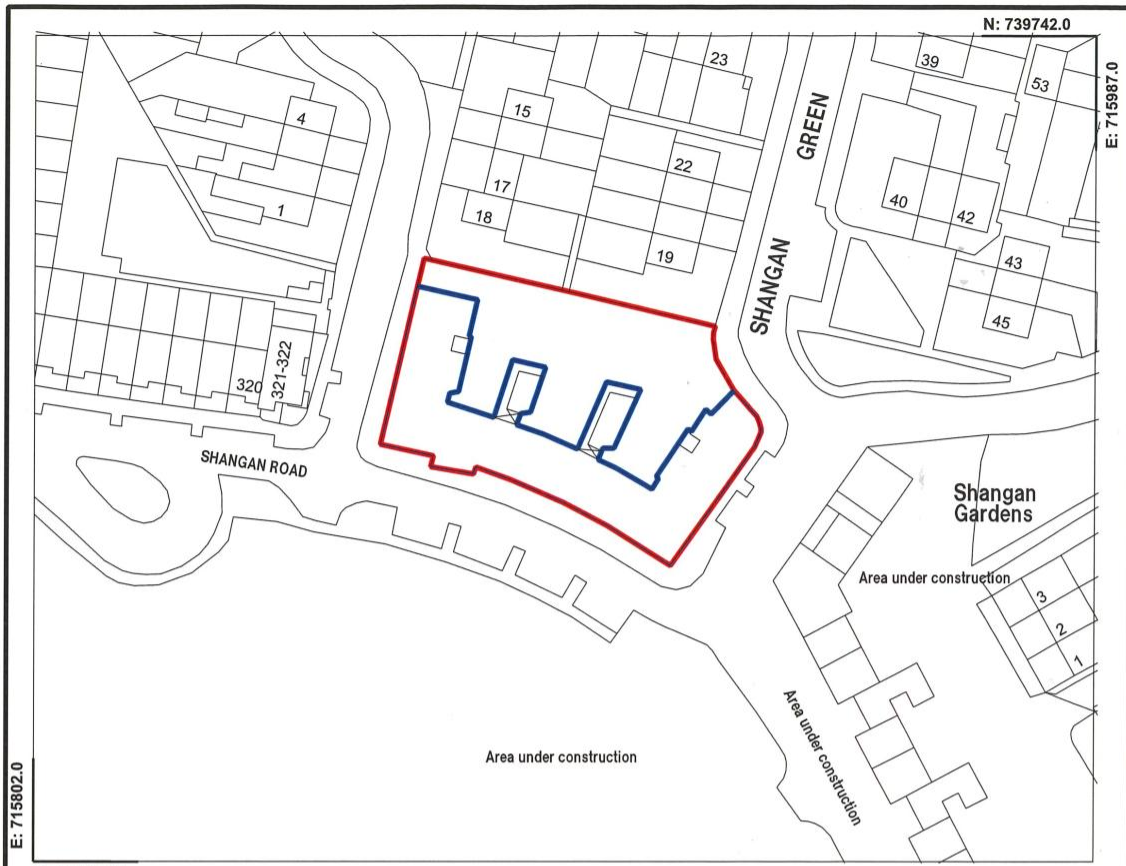
The Council's fee simple interest is subject to a lease held by Ballymun Regeneration Limited for a term of 200 years from the 1st January 2007. The lease will be assigned by Ballymun Regeneration Limited to Shangan NC Management Company CLG and then merged with the fee simple interest when the proposed disposal is complete. Before the assignment of the lease completes, Ballymun Regeneration Limited will have granted long subleases to the Council in the retail units and the remaining unsold apartments.

No agreement enforceable at law is created or is intended to be created until an exchange of contracts has taken place.

The disposal shall be subject to any such covenants and conditions as the Law Agent in his discretion shall stipulate.
