## Emergency Motion in the names of Councillors Nial Ring, Christy Burke and Janice Boylan

"That the members of this Council agree that the 2018 budgetary process will give priority to ensuring that Dublin Fire Brigade is fully resourced so that it can continue to provide an all inclusive Fire Based Ambulance and EMS service and, in addition, be sufficiently staffed and funded to provide a comprehensive and ongoing building control inspection programme".

Justification: Having regard to the recent comments made by Pat Flemming (see below), Chief of DFB, it is imperative that at this early stage we ensure that the resourcing of DFB be considered so that financial resources can be correctly budgeted for next year.

#### PAT FLEMING'S COMMENTS:

#### IRISH INDEPENDENT JULY 3RD 2017 Staff shortages may hinder Irish fire safety inspections in wake of Grenfell tragedy, Chief Fire Officer

Local authorities are best placed to inspect fire safety requirements of buildings, but are currently too short staffed to do so, according to the Dublin Fire Brigade's Chief Fire Officer.

Patrick Fleming told Morning Ireland on RTÉ Radio 1 that more resources are needed to carry out building control inspections around the country, which are set to evaluate the safety of units over 18 metres tall.

A review of staffing levels is underway, he said.

Mr Fleming acknowledged that the self-certification system employed during the Celtic Tiger had left some residents in dwellings with sub-standard safety requirements and said his "heart went out to them."

"It's our role as a statutory organisation to work with them as much as possible in order to alleviate the risk of fire and the consequences of that," he said.

This comes as Minister for Housing Eoghan Murphy announced a new taskforce to review fire safety in Ireland in the wake of the Grenfell Tower tragedy in London.

The minister has asked local authorities to review fire safety in the multistorey social housing sector and to report back in three weeks.

The Residential Tenancies Board has been instructed to notify all landlords of their responsibilities in relation to fire safety requirements. Speaking on Morning Ireland, Housing Minister Eoghan Murphy said the Grenfell tragedy would be a "game-changer in terms of how we deal with buildings for life safety inspection, fire-safety inspection and everything else".

"The first responsibility that I think we have here is to make sure there are life safety and fire-safety measures in place in all multi-story buildings," he said. He said reports from local authorities would be submitted by July 19, but did address the "lack of resources" raised by Mr Fleming.

"In terms of the work we have to do now, we're just making sure the buildings that people are working and living in are safe," he said. Mr Murphy's department intends to meet local authority chief fire officers in the coming weeks.

#### Motion in the name of Councillor Nial Ring

Having regard to the motion passed at this Area Committee in September 2016 (reproduced below for convenience) and in light of the opportunities and possibilities presented under the proposed Croke Villas development, this Committee calls on officials in Dublin City Council and Iarnród Éireann to use the redevelopment opportunity of Croke Park Villas to examine the possibility of the provision of a rail station in the immediate area which would not only serve the 16,000 residents living within 1 kilometre but would be of immense benefit to Croke Park users. The Committee also notes, as it did in September 2016, that these matters are specified by Policy MT6 of the Dublin City Development Plan 2016-2022 which states that it is the policy of DCC "to work with Iarnród Éireann, the NTA, PRA and other operators to progress a co-ordinated approach to improving the rail network....to ensure maximum public benefit and promoting sustainable transport and improved connectivity".

(FOR INFORMATION: Motion passed at Sepeteber 2016 CAC: That this Committee calls on larnród Éireann to use the opportunity presented by the opening of the Phoenix Park tunnel to expand the proposed service to include new rail stations at Phoenix Park (Infimary Road), Cabra, Cross Guns Bridge and Croke Park rather than bypass these heavily populated areas previously identified as being in need of commuter rail stations. The committee also notes that the current proposed route, whilst passing through the Northside, excludes any rail service to the residents therein with the exception of Drumcondra, thus losing an opportunity to provide the area with a viable alternative public transport service, contrary to Policy MT6 of the Draft Dublin City Development Plan 2016-2022 which states that it is the policy of DCC "to work with larnród Éireann, the NTA, PRA and other operators to progress a co-ordinated approach to improving the rail network....to ensure maximum public benefit and promoting sustainable transport and improved connectivity". Finally, if the motion is agreed, we further agree to forward the motion to larnród Éireann by way of input into the public consultation process).

#### Item 2

#### Motion in the name of Councillor Christy Burke

#### **Report**

The contract for pyrite remediation works is complete with the exception of rectification of damage to a fireplace that was caused during the works. The pyrite remediation contractor has been discharged and the fireplace and some other minor issues will be rectified by an alternative contractor.

#### Item 3

#### Motion in the name of Councillor Ciaran Cuffe

That this Committee agrees that it is expedient, and in the interests of amenity and the environment, to make a Tree Preservation Order for the London Plane tree that is slowly encroaching on the iron bench in Kings Inn Park adjacent to the entrance to the park at 1 Constitution Hill, Dublin 7, and shall also seek the designation of the bench as a Protected Structure under the Planning Acts.

#### **Report**

A 'protected structure' as defined in the Planning and Development Act, 2000 (as amended) is "Any building, structure, excavation, or other thing constructed or made on, in or under any land, or any part of a structure", including

- The interior of the structure,
- The land lying within the curtilage of the structure,
- Any other structures lying within that curtilage and their interiors, and
- All fixtures and features which form part of the interior or exterior of these (above) structures.

See Section 2.2 subsection 2.2.2 of the Guidelines for Planning Authorities on Architectural Heritage Protection (2011) <u>http://www.ahrrga.gov.ie/app/uploads/2015/07/Architectural-Heritage-Protection-Guidelines-2011.pdf</u>

The park bench referred to is a fixture situated in the landscaped, parkland grounds within the curtilage of the King's Inns and its attendant structures, located at Henrietta

Street and Constitution Hill, Dublin 7, with the following References and descriptions on the Record of Protected Structures:

- 3658: Henrietta Street, described as King's Inns and Registry of Deeds, including railings, boundary walls and gate piers,
- 3660: Henrietta Street, described as *King's Inns Library*,
- 3659: Henrietta Street, described as Kings Inns: two-storey stone cottages in grounds,
- 2030: Constitution Hill, described as *Lodge to King's Inns*, and
- 2031: Constitution Hill: described as *King's Inns: Railings, boundary walls and gate piers*,

As a fixture within the curtilage of a number of the above protected structures, the park bench, which has been partly enveloped by the London Plane to which it abuts (and indeed now forms part of) is considered to be adequately covered and protected by the definition above. If it were to be added to the RPS and to be protected structure in its own right, the question arises; - is the bench being endangered by the tree?

Accordingly, it is not recommended that this fixture is made the subject of a distinct (separate) addition to the Record of Protected Structures.

#### Item 4

#### Motion in the name of Councillor Ciaran Cuffe

That this Committee agrees that the Chief Executive present a report on actions taken by planning enforcement and environmental health on foot of the concerns raised at the Central Area Committee by the North Port Dwellers on Mayor Street and New Wapping Street, Dublin 1.

#### **Report**

There have been a number of historical complaints received from North Port Dwellers Association regarding building sites adjacent to their properties.

The complaints mainly related to breaches of permitted working hours, noise levels, airborne dust and granting of extended working hours.

All complaints have been actioned upon by the Planning Enforcement Section and Environmental Health Officers where appropriate. There are currently no outstanding cases that the Dublin City Council is aware of.

As stated during the course of the presentation given to the Central Area Committee Meeting in June relating to Planning Enforcement in the Docklands Area, there is now a detailed construction protocol in place in respect of development sites in and adjacent to the Docklands area, a copy of which has been circulated to all area Councillors. This protocol has had a very positive affect in respect of minimising, insofar as is practical the number of complaints being received in the area. We now have a dedicated Enforcement Officer who is based in the Docklands Area and deals with any complaints that are received. He also carries out pre emptive inspections on sites in the area and engages with residents and developers in order to solve any issues in as short a time as possible. If North Port Dwellers Association have any further complaints they should send them to planningenforcement@dublincity.ie and cc neil.cameron@dublincity.ie and they will be actioned upon as required.

#### Item 5

#### Motion in the name of Councillor Ciaran Cuffe

That this Committee voices its concern that our officials appear reluctant to take action to address noise complaints concerning neighbours, and calls on the Manager to initiate a pilot scheme for Summer Street, Dublin 1 and take action on foot of residents' complaints about noise pollution emanating from adjoining residential premises.

#### Report

Local authorities in Ireland deal with noise complaints under the provisions of the Environmental Protection Agency Act 1992.

In 2016 the Environmental Protection Agency published the National Protocol for dealing with Noise Complaints for Local Authorities.

This document addresses, *inter alia,* the specific challenges that exist in respect of current legislation dealing with neighbourhood noise:

"In general local authorities in Ireland do not pursue noise complaints where the source of the noise is domestic in nature e.g. noisy neighbours, house parties, domestic appliance noise etc. It is not envisaged that this situation should change unless the current legislation is amended. Local authorities should continue to advise members of the public as to how they can source information to address such matters on their own behalf. As a general rule Local Authorities should always engage with complaints where the source of the noise is commercial in nature."

In this specific case Dublin City Council has provided the residents affected with the relevant information regarding the legal remedies and mediation services that are available to them.

#### <u>Report</u>

This issue was raised by a member of the public during the consultation period both during the workshop and subsequentially via email to the Project Architect. The following query was sent to the NTA along with the response from the NTA (in italics): Query to NTA:

"As part of our public consultation we received a request from a member of the public who requested we ascertain whether or not you have plans to locate a train station in the vicinity?

We are not aware of any such plans and are developing our own plans accordingly. However, should you intend to locate a train station here, we would be obliged if you could engage with us at your earliest possible convenience".

#### Response:

"The NTA has reviewed the draft document included in your email entitle "Croke Villas Masterplan & Residential Development: draft stage 1 report" (dated the 23<sup>rd</sup> December 2016). The NTA can confirm that it has no plans at this time to locate a station in the vicinity of Croke Villas that would be impacted by the proposed development. Please contact me if you need any further information".

The scope to further pursue the proposal has now diminished to such an extent as to be futile, mainly, but not exclusively, because of the following:

- The NTA have indicated that they have no plans for a station at this location.
- The lead-in period for the initiation, design, funding, Railway Orders Etc is approximately 10 years.
- The site, especially with regards to the levels and the culvert, is not considered suitable.
- The design for Croke Villas is at an advanced stage and would be substantially delayed if reservations for a station were to be incorporated.
- The surrounding area is adequately serviced by public transport and is within walking distance/bus journey to a number of major transport hubs.
- Match day train traffic is serviced by the stations in the direct vicinity (Drumcondra, Docklands, Connolly, etc).

#### **Report**

Any change of use from retail to non-retail use would require planning permission.

Such applications would be treated on their merits with particular regard to the impact of the proposed use on the context and character of the area. In the City Centre retail core, the proposal would be assessed with regard to the relevant policies at Section 7.6.1 of the Dublin City Development Plan which seek to affirm and maintain the status of the city centre retail core as the premier shopping area of the State (Policy RD13) and to promote active uses at street level on the principal shopping streets in the city centre retail core and in Z4 district centres (Policy RD17). In all areas, the impact of the proposed use on the amenities of adjoining commercial and residential properties would be a key consideration. Any unauthorised change of use would be subject to enforcement proceedings.

### North East Inner City Housing Central Area Report

### Croke Villas

Dublin City Council Architects Division have appointed the design team for the overall project and preparation of a Part 8 procedure for 76 new housing units on the site of the former Croke Villas flat complex has commenced.

At the April 2017 meeting of Dublin City Council's Central Area Committee it was agreed to initiate the Part 8 procedure for Croke Villas. A Demolition Contractor has been appointed to demolish the Blocks.

Two information sessions were organised for the local community one was held in Charleville Mall Library and the other in the Ballybough Youth and Community Centre.

Work has also commenced on the site at 4-6 Ballybough Road to deliver 17 new housing units. It is anticipated that these works will be complete in Quarter 4 2018. A leaflet drop have been organised to 500 homes in the Ballybough Area. The Area Offices have arranged for a Electronic door to be fitted for the Residents in the First Block. The Community Section with the Parks Dept are arranging planters to be fitted in the Block

We will continue to work with the residents in the first block, until they move into their new homes on Ballybough Road .The Area Offices are also working with Jeanette Lowe, Photographic Artist to record the History of Croke Villas &the surrounding Areas .Jeanette has met the Residents who have bought into the concept, &the Ball Alley ,Jeanette had carried out similar works .In Pearse House &Charlemont St Flats pre &post detenanting .

### St. Mary's Mansions

Following a presentation to the residents and Area Councillors which received a very positive response, a planning application was lodged by Cluid Approved Housing Body on 6<sup>th</sup> May 2016 for the redevelopment of this complex. Final Grant Notice was issued on the 8<sup>th</sup> August 2016.

Commencement of construction works is expected in Q3 2017. (the Archaeological survey has now been completed)

The project will deliver 76 new units in this redesigned complex.

This projected completion date is March 2019.

St Marys Mansions has now been fully detenanted, Cluid have a 24 /7 security presence in St Marys as well as fitting large gates. The Boundary of the site will be hoarded off in the next 2 weeks, they are in the process of appointing a Contractor after a Tender Process

### Vacant site, Railway Street

Circle Voluntary Housing Association have finalised a proposed design for a new development of 38 Apartments on Railway Street.

Circle executives made a presentation to Dublin City Councillors on 10<sup>th</sup> November 2016 to seek approval on their plan. DCC have since met residents from the adjoining Kiln and Forge Apartment complexes to discuss the proposal and they have expressed support for the project.

Circle VHA appointed a design team in mid June 2017 and moved forward with design, planning, finance and construction.

As it is expected to take some time before any construction works take place we are currently looking at ways to better secure the site and examining whether it can deliver community events while the design, planning and tender processes are progressing.

### Ballybough House

Substantial improvement works have been carried out in this complex to upgrade the physical environment and improve measures to tackle anti social behaviour.

Upgrades included:

- New Public Lighting
- · Repairs of the stairwells and installation of new security doors/CCTV
- New playground and Amphitheatre improvements and landscaping
- Painting Programme (Railings, Balcony Trims)

Works are in progress on the new door entry system and we are costing replacement doors and windows in a situation whereby additional finance was secured.

We are currently examining the potential of reconfiguring 2 flats into 1 large unit thus creating larger living spaces within the complex. Once this study is complete we will bring it to the Department of Housing, Planning and Local Government for assessment.

We are also proposing to carry out precinct works consisting of the separation of each block by means of a wall & railings, and the provision of parking facilities, playgrounds, green areas as required in each block.

### **Gloucester Place/Former IDA site**

Construction work commenced in late February 2016 and the project is progressing well with a completion of works in September 2017.

An application has now been lodged by the same developer to build more student accommodation on the adjacent site which is currently being used as the contractor's compound.

There had been an upsurge in dumping at the ESB substation beside this site, collaboration between the ESB and DCC has commenced which will see this area transformed into a community garden.

#### Apartment blocks Sheriff Street

The stairwells and common areas in the apartment blocks at Mariners Port, Crinan Strand and Spencer Dock have fallen in to a poor condition over recent years. We have recently installed new, more secure post-boxes and have begun a programme of replacing the main entrance doors and the floor covering and to paint the stairwells.

### **CastleforbesSquare**

17 families have moved into the complex and the remaining families will move in after completing interviews and pre-tenancy.

### Vacant Site at Poplar Row

Oaklee lodged a planning application on 30<sup>th</sup> November 2015 for a development of 29 units of accommodation at Poplar Row. Planning permission with conditions was granted to Oaklee Housing on 10<sup>th</sup> June 2016 however an appeal was lodged with on Bord Pleanala by the local Residents Association. An agreement was subsequently reached with all parties including a commitment to ensure good communications by the formation of a liaison group with DCC, Oaklee and Resident representatives when the development commences.

Oaklee Housing Trust was advised on 30<sup>th</sup> Sept 2016 of a notice to grant planning for Poplar Row.

Work on the detailed design has commenced and site surveys are currently been carried out by Oaklee's Design team. Oaklee are finalising details before going to tender.

Works are expected to commence in Q3 2017 and completion Q3 2019.

The approval for the disposal of the site was passed at the May 2017 full City Council meeting.

The City Council are to hoard off the site and improve the look through Artwork similar to the Mud Island hoarding.

### Tom Clarke House

Work commenced on site in November 2015 converting bedsits into one bedroom apartments. Work on the first phase is completed and the units are allocated, work on phase 2 has been substantially completed and Tenants identified for the remaining 4 units. The Area Office and Housing Department are in the process of finalising the public domain improvements on site. The remaining units are been snagged and we have completed a selection process to fill the vacancies .The Area Offices have also automated the vehicular gates & pedestrian gates to eradicate illegal parking and enhance the security for the Residents.

### St. Agatha's Court

Work commenced on the reconfiguration of the former Senior Citizens complex in April 2016 and completed May 2017. The Peter McVerry Trust manages the complex. The units are now allocated.

### Dominick Street Lower

Detailed designs for 5-3 bed town houses, 68 apartments consisting of 5-3 bed, 50-2 bed and 12 1bed units, a community facility and retail/commercial units with 47 car spaces at basement level on the eastern side of Dominick Street have been completed. The costings have been sent to the Department of Housing, Planning, Community and Local Government for approval to go to tender in October. The design team are working on the preparation of the tender documents.

### **Constitution Hill**

The painting crew have completed painting this complex.

### Dorset Street & Saint Marys Terrace

The Housing Department made a submission to the Department of Housing, Planning, Community and Local Government for funding to carry out a complete refurbishment of homes, to include larger

kitchens and bathrooms, better BER rating (energy improvements) new roof, lifts, landscaping, and greater accessibility and boundary treatments.

The Department, after reviewing the consultant's report, has advised that the cost of refurbishment was so close to the cost of demolition and new build that they requested that this option be further developed. An internal design team is in place for new build and will seek permission from the Department of Housing, Planning, Community and Local Government for funding. This is expected to happen in the third quarter of this year.

### Friary Court

Our Housing Maintenance section carried out attic insulations, replaced hall doors, upgraded smoke alarms, and repairs to external balconies have been complete.

### Georges Place

An environmental group has been set up and is working on improving the green areas within the complex.

### **Ormond Square/Markets Area**

A very successful community day took place on the 27<sup>th</sup> Aug on Halston Street

#### Saint Michan's House

The painting of St Michan's House is ongoing.

### North King Street

The Department of Housing, Planning, Community and Local Government has given approval to go to tender. The design team is currently working the tender production drawings. We expect to go to tender within the next 6 weeks and once a contractor is appointed it should take approximately 18 months to build the complex. This programme is dependent on getting all necessary approvals. A sign advertising the complex will be in place by the middle of Sept.

### Luas Cross City works

The new Luas Cross City line will be officially handed over to Transdev this weekend. Transdev will commence driver training from Monday the 11<sup>th</sup> September, this means trams will be very frequent on until the official opening of the line to passengers in early December.

Overhead power cables and any support cables should be treated as "live" at all times. Any necessary works close or adjacent to these lines require a permit from the Luas operator Transdev.

### St. Bricins Park

There is a significant delay in completion of 2nd phase. Meeting with contractor to confirm revised works programme will be held next week. Approximate completion date late October early November still achievable.

### O'Devaney Gardens

- Design development on proposed 56 Social Housing units is proceeding
- Five flats remain occupied and efforts continue to provide suitable alternative accommodation for the residents concerned.

• Works in the courtyard area have commenced however pruning of trees, hedges and shrubbery will take place later in the year, most likely in September.

# North East Inner City Ministerial Task Force

Following the publication of the Mulvey report <u>Dublin North East Inner City</u> - <u>Creating a</u> <u>Brighter Future</u> in February 2017, the establishment of the Programme Implementation Board and subsequent appointment of Michael Stone as Chair in mid-June, work is now progressing on the implementation phase. Four sub-groups have been established to focus on the key areas for priority action as identified in the report:

- **Policing and Crime Prevention / Tackling Crime and Drugs** (Chaired by Chief Superintendent Sean Ward, An Garda Siochána)
- Maximising Educational / Training Opportunities / Creating Employment Opportunities – (Chaired by Caitriona O'Brien, Principal Officer, Department of Education & Skills)
- **Creating an Integrated Systems of Social Services** (Chaired by Conor Rowley, Principal Officer, Department of Children & Youth Affairs)
- **Physical Infrastructure "Refurbishment Plan"** (Chaired by Brendan Kenny, Deputy Chief Executive, Dublin City Council)

The membership of the Sub-Groups is broadly representative of key stakeholders in the area of remit including community and business representation. A small number of members have yet to be nominated by the relevant sectors.

The Programme Implementation Board and the four Sub-Groups are being supported by the NEIC Programme Office based at the Dublin City Council's Central Area Office, 52 Sean MacDermott Street and the Social Policy Section, Department of the Taoiseach. Additional staff resources have been assigned to the office to ensure that adequate support is in place to meet the anticipated increase in workload as the implementation phase progresses.

At the launch of the Mulvey report in February Taoiseach Enda Kenny announced that funding is being ring-fenced to support the implementation of the Report which will amount to  $\notin$ 5 million. To date  $\notin$ 2.5 million has been approved for a range of projects across the four priority areas as set out at Appendix 1. Delivery of these projects has or will commence in 2017.

The Programme Office is also exploring suitable structures for community engagement, including the existing North Inner City Community Coalition, to ensure that all communities and residents of the NEIC area have opportunity to communicate and participate in the North East Inner City Initiative. A second NEIC newsletter will be circulated and an open community engagement event is being organised to take place in mid-October.



## • Beat the Street

Beat the Street is an innovative walking and cycling initiative designed to get young people and communities moving by turning a town/city into a giant game. Last year 865 schools across the UK and Northern Ireland were involved in the programme which saw more than 300,000 people participating. From 13<sup>th</sup> September to 1<sup>st</sup> November 2017 Beat the Street is coming to Dublin and will be rolled out in 51 schools, primarily across Dublin South Central & South East Areas but also extending across the Liffey into the Central Area.

The aim of the programme is to inspire people to make small changes to improve their physical activity levels and health by encouraging walking or cycling as a way of getting from place to place e.g. to and from school. Beat Boxes will be placed throughout these areas that enable participants to tap with cards or fobs in order to score points and win prizes. The further the distance travelled the more points accumulated. Prizes include All Ireland Hurling and Football tickets, World Cup Qualifier Moldova vs. Ireland Soccer tickets, vouchers for lifestyle sports up to €500 and other prizes such as signed sports memorabilia.

Beat the Street's fun competitive element not only allows schools to compete against each other – it also encourages the whole family and neighbourhood to get involved meaning parents, grandparents, siblings, friends, streets etc... can form teams, climb to the top of a leader board and be crowned winner of the competition. Cards/fobs for the programme will be available to the general public from early September 2017 in Dublin City Council libraries and Sport & Fitness Centres – specific locations are listed on <u>www.beatthestreet.me/dublin</u>.

This initiative is being delivered by Intelligent Health (the creators of Beat the Street) on behalf of the Dublin City Sport & Wellbeing Partnership, Dublin City Council, Healthy Ireland, the Dormant Accounts Fund and Sport Ireland.
