**Item 1**

**Motion in the name of Councillor Nial Ring**

That this Committee instructs the Chief Executive to write to the Glasnevin Trust and ask if it their intention to include further names on the so called 1916 Memorial Wall in Glasnevin Cemetery and, if so, to detail what names are being considered for inclusion, and if public consultation will take place on any proposed addition of names.

**Item 2**

**Motion in the name of Councillor Nial Ring**

That this Committee supports the submission made by me to the Seanad Public Consultation Committee in respect of its public consultation on the Status, Treatment and Use of the National Anthem. The main points made in the submission are as follows:

my opinion, there should be no changes made to either Irish or English version. I have read and heard of proposals to change wording to lessen the militaristic tone of the Anthem but, in deference to those who wrote and translated the Anthem, we should not interfere with their work.

Also, some people have quite mistakenly assumed that the first line of the chorus "Sine Fianna Fáil..." was written after the foundation of the Fianna Fáil political party in 1926 and that somehow the name of the fledgling party could have influenced his translation work. This is absolutely untrue as my Granduncle first worked on the translation in 1916 and completed his work before 1923, well before the foundation of Fianna Fáil.

1. The foregoing statement is not just based on family knowledge and lore (a daughter of Liam is still alive and well). Historian Ruth Sherry, in her article entitled "The Story of the National Anthem", published in History Ireland (Issue 1, Spring 1996) states that Liam Ó Rinn's translation was published in the army magazine, An tÓglach, on 3rd November 1923. More persuasive and significant is the fact that an almost identical text was printed in the Freeman's Journal on 3rd April 1923, under Ó Rinn's pen name "Coinneach".

2. The Government should issue guidelines on the use of the National Anthem. This, I believe, should be on the lines of the guidelines issues in relation to the National Flag. The guidelines should also include reference to standing at attention (and how to do so) when the National Anthem is being played. It is galling to observe sportsmen and sportswomen standing "at ease" or with arms around each other whilst the Anthem is being played. Simple guidelines on this would give the Anthem the due respect it deserves.

3. I would support the National Anthem being enshrined officially in legislation in the Irish language.

4. I would ask that the Committee strongly consider recommending that the National Anthem be made a compulsory part of the education curriculum and enshrined in legislation to ensure its implementation.

5. I would submit that the guidelines, if agreed and published, should be in booklet format and distributed to every household in Ireland.

6. The success of the presentation of the National Flag to every school in the country to commemorate/celebrate the 1916 Rising has been widely acknowledged. I would submit that the committee recommends a similar programme for the National Anthem".

I have circulated the full document I sent to the Committee separately but the above are my actual submissions. The Committee intends to hold public hearings on Tuesday 5th December and I have been invited to attend and contribute to this public hearing.

**Item 4**

### **Motion in the name of Councillor Janice Boylan**

That this Area Committee calls for a full investigation into the road layout and traffic light system at Hanlon's Corner on the North Circular Road due to the high level of near misses, crashes and residents concerns.

### **Report**

It has been recommended to alter the traffic signals to allow an early cut off on North Circular Road westbound amounting to 6 seconds. This means that westbound traffic will be stopped 6 seconds prior to eastbound traffic. This will allow vehicles and cyclists to safely clear the junction eastbound including right turn movements while westbound traffic is stopped.

It has also been recommended to rescind the most westerly 6m of the yellow box opposite Annamoe road to allow cars to legally stop before the traffic lights. This should reduce the amount of westbound vehicles breaking the amber light.

### **Item 5**

#### **Motion in the name of Councillor Janice Boylan**

That this Area Committee calls on the Co-op and the LCDC to engage in meaningful discussions re the SICCAP funding so they can come up with a strategy that will resolve all issues and concerns.

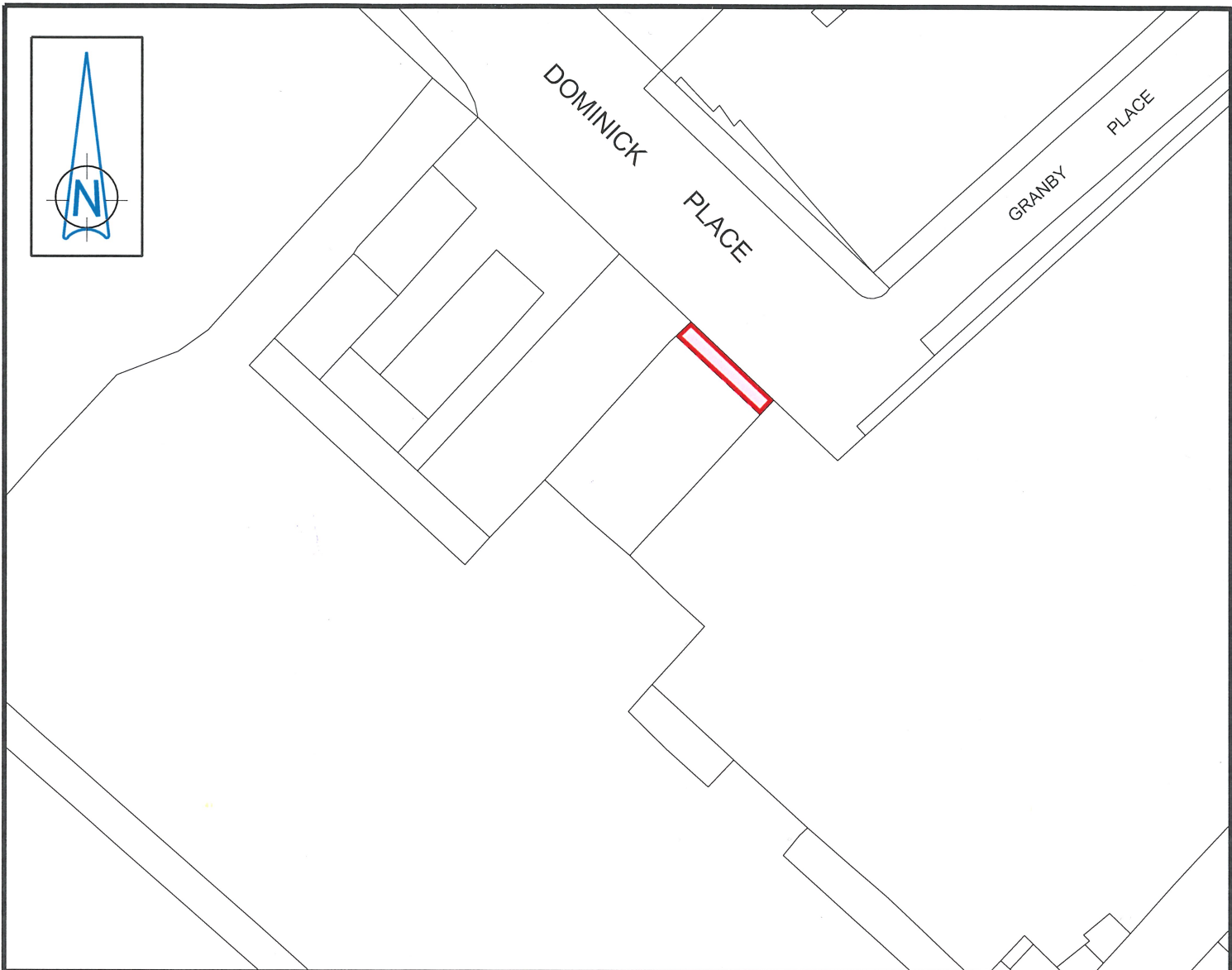
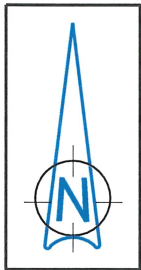

An application has been received from City Serviced Offices Limited to purchase a plot of ground at 9 Granby Place, Dublin 1. This plot of ground is part of a former laneway and has now been incorporated into their property. The plot of ground in question is shown delineated in red on Map Index No. SM-2018-0053.

The Chief Valuer has reported that agreement has now been reached with AMOSS Solicitors on behalf of City Serviced Offices Limited to dispose of the Council's interest in this plot of ground subject to the following conditions:

1. That the subject site is situated on Granby Place with an approximate area of 16 m<sup>2</sup> as shown delineated in red and shaded pink on Map Index No. SM-2018-0053.
2. That the disposal price will be €5,000 (five thousand euro) plus VAT if applicable.
3. That the purchaser will be responsible for Dublin City Council's Valuer's fee of €1,600 (one thousand six hundred euro) plus VAT.
4. That the purchaser will be responsible for the City Council's reasonable legal costs and outlays.

The disposal shall be subject to any such covenants and conditions as the Law Agent in his discretion shall stipulate.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.

## **NORTH EAST INNER CITY PROGRAMME OFFICE REPORT**

Following the comprehensive report presented to the January meeting of the Committee the update is as follows:

A provision has been made by the Department of Rural & Community Development (RAPID Programme) for a funding allocation of €2.5 M for the North East Inner City Initiative in 2018. This brings the total funds allocated since establishment in 2016 to €9.8M.

A budget Sub-Group has been established, chaired by Department of the Taoiseach, to review proposals from the four working groups for 2018 funding and make recommendations to the Programme Implementation Board. The following proposals, aligned to delivery of actions set out in the Mulvey report, were approved at the Board meeting held on 31<sup>st</sup> January 2018. Total approved €1.35M.

- **Ana Liffey Drug Project - Assertive Case Management (NEIC Specific) - €100,000**

This 1-year project aimed at tackling on-street drug dealing blackspots was approved in 2017 and is up and running since Sept. 2017 at a total cost of €155,000. The initial phase was funded (€55,000) from the 2017 allocation and this 2018 funding will see the project through to completion circa. Sept. 2018.

- **North Inner City Folklore Project - €30,000**

The Folklore Project is now set-up and operating from Unit 1, The Forge. The 2018 funding will be used to cover costs associated with the Unit i.e. rental and utilities. The balance will be used to fund development work with the project with an initial focus on professional cataloguing of existing material to be followed by report and recommendations on future direction. Other sources of funding are also being explored.

- **Programme of annual community events – €200,000**

Following a successful year of events in 2017, e.g. The Big Scream Halloween festival (5 events), The Last Picnic and local summer and Christmas events, a similar initial allocation has been approved for 2018. The Halloween Festival will remain as a flagship event and proposals for other events will be brought to the Board for approval in due course. In the meantime the Programme Office is funding a free family event to celebrate the Chinese New Year at Hill Street Family Resource Centre on Saturday 17<sup>th</sup> February 2018 from 2:00 p.m. – 7:00 p.m. All welcome.

- **NEIC Community Grants 2018 - €100,000**

The 2017 Community Grants Scheme was run successfully with 37 local projects awarded a total of €123,000. The Scheme will be run again this year with similar criteria. Details are being finalised and it is anticipated that it will open for applications before end Q1.

- **Lourdes Daycare Centre - €300,000**

Following grant of planning permission in December 2017 funding for the delivery of the project to include internal alterations and extension at Lourdes Daycare Centre has been approved. It is anticipated that work will commence on site before end Q1.

- **FAI Late Night Leagues €100,000**

Discussions are at an advanced stage with FAI, Dublin City Council and An Garda Síochána to deliver a 'Football Diversionary Programme' in the north east inner city specifically targeting young 'at risk' boys and girls to offer an alternative to crime via the power of football. Pending finalisation of operational arrangements and recruitment processes it is estimated that the Programme will commence in Q2.

- **Charleville Mall Public Library Programmes – €110,000**

The Reader in Residence (€75,000) and Coderdojo Digital Skills (€35,000) programmes run by Dublin City Public Libraries at Charleville Mall in 2017 were deemed to be successful and will be repeated in a similar format in 2018. It is a condition of this funding that the programmes be considered for mainstream funding in future years via Dublin City Council budgetary process.

- **Contribution to Iarnród Éireann - €19,830.50 + VAT**

Further to work carried out on 6 bridges in 2017 Iarnród Éireann have costed cleanup of a further 9 no. bridges (Package No. 2) and requested co-funding of €19,830.50 +VAT from NEIC resources. This request has been approved.

- **Programme Office activity costs - €75,000**

This allocation will fund the day to day activity costs of the Programme Office during 2018 to include costs associated with communications, branding, community engagement events etc. Salary costs for staff members assigned to the Programme Office have remained with their respective organisations / Government Departments.

### **Tall Ships Regatta 2018 – Business Sector €50,000**

The NEIC Business Sector, represented on the Programme Implementation Board by Feargal O'Rourke, PWC; has committed funding of €50,000 to fund costs of 50 trainees (over 18 yrs.) from NEIC communities to take part in the voyages of the Tall Ships Regatta 2018 in association with Sail Training Ireland. The event is scheduled to take place in June 2018. A recruitment process will be undertaken in consultation with Community Groups and Youth Services in the local area. **Housing Update January 2018**

**Donal Barron Area Housing Manager**

**Croke Villas**

**We continue to work with the remaining residents (in the first block) in anticipation of their transfer to their new homes.** Work is continuing on the site at 2-6 Ballybough Road to deliver 7 new housing units. It is anticipated that these works will be complete in Quarter 4 2018.

**St. Mary's Mansions**

This projected completion date is March 2019  
Ganson Building and Civil Engineering are now on site and early indication is that works will be completed on time.

**Vacant site, Railway Street**

Circle Voluntary Housing Association have finalised a proposed design for a new development of 38 Apartments on Railway Street.

Circle VHA appointed a design team in mid June 2017 and moved forward with design, planning, finance and construction. A topographical survey of the area has now been completed but it is expected to take some time before any construction works take place.

**Ballybough House**

Substantial improvement works continue to be carried out to the dwelling flats in this complex and to upgrade the physical environment and improve measures to tackle anti social behaviour.

- Upgrades included:
- New Public Lighting.
- Repairs of the stairwells and installation of new security doors/CCTV(now complete)
- New playground and Amphitheatre improvements and landscaping
- Painting Programme (Railings, Balcony Trims).
- Pilot programme of converting flats (2 into one in some cases) and new fit to increase the living space within the dwelling.

Works are complete on a new door entry system and we are costing replacement doors and windows in a situation whereby additional finance was secured.

We are currently examining the potential of reconfiguring 2 flats into 1 large unit thus creating larger living spaces within the complex. Once this work has been completed and a report produced, it will be brought to the Department of Housing, Planning and Local Government for assessment with the view of upgrading all the dwellings as they become available.

We are also proposing to carry out precinct works consisting of the separation of each block by means of a wall & railings, and the provision of parking facilities, playgrounds, and green areas for each block.

### **Gloucester Place/Former IDA site**

Construction work commenced in late February 2016 and the project is progressing very well and the project is in the final stage, including snagging and signing off and will be ready to populate in the very short term.

### **Castleforbes Square**

All the dwellings have been allocated, under the City Councils' Allocation Scheme, and the complex enjoys full occupancy.

### **Vacant Site at Poplar Row**

Works completion expected Q3 2019.

The City Council have hoarded off the site and improved the look through Artwork similar to the Mud Island hoarding.

### **Tom Clarke House**

The Area Office and Housing Department are in the process of finalising the public domain improvements on site. The Area Housing Office have also installed automated vehicular gates & pedestrian gates to eradicate illegal parking and enhance the security for the Residents.

### **Summerhill (Older persons complex)**

Funding has been given, under contract of service, to plant and clean (moss and weeding) the front area of Summerhill Senior Citizens complex with works starting on Wed 8<sup>th</sup> of November 2017. This, in conjunction with the open green area at the rear of the complex, ensures the Summerhill complex maintains its fine history of award winning flower display and gardens.

### **Brendan Behan Older Persons complex**

Funding has been approved for the upgrading and refurbishment of the community room at Brendan Behan Older Persons complex. This includes new flooring and general repairs.

### **Saint Laurence O'Toole Court**

The front garden area has been resurfaced with resin (on both side of railings), and the planting of flower beds and planters has been approved.

The construction of ramps, at the entry point of dwellings has been completed for wheelchair access. The communal room has been fitted with a new front door.

A new security gate has been constructed at the rear of the complex to stop the access and congregation of youths to the complex.

### **Oriel Street Older Persons units**

The front garden has been resurfaced with resin, the fascia and soffit are being fully replaced.

Works have started to have the external frontage of the 8 dwellings cleaned and thereafter painted (which includes the gable doors, front windows and the railings (front and rear).

It has been proposed to have the bedding flowers and planters made available to residents that wish to avail of such gardening assistance.

#### **Dominick Street Lower**

Detailed designs for 5-3 bed town houses, 67 apartments consisting of 5-3 bed, 50-2 bed and 12 1-bed units, a community facility and retail/commercial units with 47 car spaces at basement level on the eastern side of Dominick Street have been completed. The costings have been sent to the Department of Housing, Planning, Community and Local Government for approval to go to tender in January. Tender documentation is complete. Dublin City Council has commenced the tendering process for our project in Dominick Street Lower by inviting Expressions of Interest for the Works contract. This stage will take approximately 12 weeks and a maximum of six contractors will be shortlisted and invited to tender in Stage 2, subject to the financial approval from the Department of Housing Planning Community and Local Government.

#### **Constitution Hill**

An internal design team has been set up to make a submission to the Department of Housing, Planning, Community and Local Government on a recommendation for some new build and refurbishment of this complex. We expect to send the Stage 1 report the Department of Housing, Planning, Community and Local Government this month for approval.

### **Dorset Street & Saint Marys Terrace**

The Department, after reviewing the consultant's report, has advised that the cost of refurbishment was so close to the cost of demolition and new build that they requested that this option be further developed. The Stage 1 report is down with Department of Housing, Planning, Community and Local Government for approval of funding. Once approved, we will commence consultations with the local community and designs for Part 8 approval.

### **Saint Michan's House**

The painting of St Michan's House is ongoing should be complete by the end of this month Fish Market site contractor onsite since beginning of February.

### **Sean Foster Place**

The preferred bidder will be announced this month. Pending approval from the Department of Housing, Planning, Community and Local I expect a contractor to be on site in the next couple of months, it should take approximately 18 months to build the complex.

### **Dominick Court**

Upgrading of the windows and doors in this complex has commenced.

### **O'Devaney Gardens**

Tenders for the construction of 56 Social Housing units to be invited this month. Efforts continue to source suitable alternative accommodation for residents in the five remaining occupied flats. Next Consultative Forum meeting will take place on 21<sup>st</sup> February 2018.

### **Bricins Park**

Phase 2 Flats shown to prospective tenants in advance of their completion. Units proving very popular and there will be no difficulty in letting. Handover of units in Phase 2 delayed pending resolution of minor snagging issues but the allocation of units should be completed by end of February. Works on Phase 3 have commenced.

### **Aughrim Court**

Landscaping works, financed under CAC Discretionary Funding, completed.

### **Drumalee Court:**

Supply & installation of new locking mechanisms at entry points completed and keys have been distributed to residents.

Dublin 7 Educate Together School and Surrounding Area

Plans for the development of the new Dublin 7 Educate Together School are underway following the decision of An Bord Pleanála to increase the size of the school from 16 to 24 classroom building. With the project advancing towards the planning stage the GDA is also looking at how the junction of Rathdown Road and Grangegorman Upper could be treated as part of the development. In 2015 the GDA went out to local residents to get their input into the plans for the area at the time. These plans have now changed in that there is no longer a proposal to make Grangegorman Upper one way. Therefore the GDA have again gone door to door in the area to get people's input. This is now complete and the plans are at the final design phase. Once this is done the GDA will submit two planning applications, one within the SDZ for the school itself and one standard planning application for the junction.

A service check will be undertaken to establish what (if) any are located on these areas. Suitable arrangements will be put in place prior to completion of this proposal.

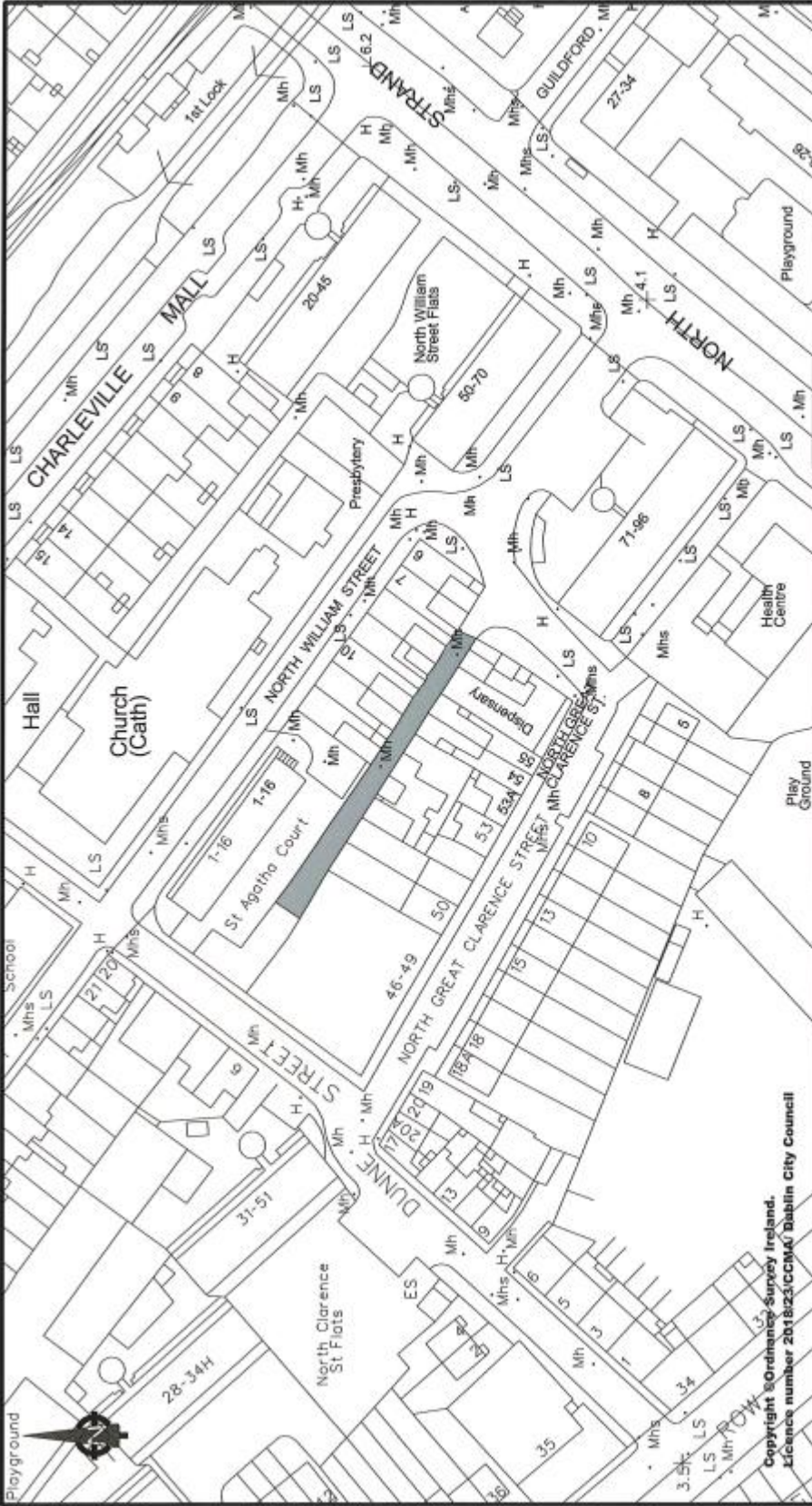
**Statutory Requirement**


The statutory procedure involves giving public notice of the proposal in one or more newspapers circulating in the City and the affixing of that notice at each end of the right of way for a period of not less than 14 days. Any objections or representations made and not withdrawn shall be considered. The extinguishment of a public right of way is a function reserved to the elected members of the City Council.

**Recommendation**

I recommend that procedures be initiated under Section 73 of the Roads Act 1993 to extinguish the public right of way over the area indicated on attached Drawing.
