Housing Update March 2018

Donal Barron Area Housing Manager

Matt Talbot Court

The balcony lights are due to be upgraded shortly to a higher specification light.

O'Brien Hall

All the internal hallways, landings and banisters are currently being painted (8 in total).

The vinyl flooring in all the hallways, stairs and landings are also due to replaced with new hard wearing, robust flooring.

Croke Villas

We continue to work with the remaining residents (in the first block) in anticipation of their transfer to their new homes. Work is continuing on the site at 2-6 Ballybough Road to deliver 7 new housing units. It is anticipated that these works will be complete in Quarter 4 2018.

St. Mary's Mansions

This projected completion date is March 2019

Ganson Building and Civil Engineering are now on site and early indication is that works will be completed on time.

Vacant site, Railway Street

Circle Voluntary Housing Association have finalised a proposed design for a new development of 38 Apartments on Railway Street.

Circle VHA appointed a design team in mid June 2017 and moved forward with design, planning, finance and construction. A topographical survey of the area has now been completed with ground works going on site Thursday 8th March but it is expected to take some time before any construction works take place.

Ballybough House

Substantial improvement works continue to be carried out to the dwelling flats in this complex and to upgrade the physical environment and improve measures to tackle anti social behaviour.

- Upgrades included:
- New Public Lighting.
- Repairs of the stairwells and installation of new security doors/CCTV(now complete)
- New playground and Amphitheatre improvements and landscaping
- Painting Programme (Railings, Balcony Trims).

• Pilot programme of converting flats (2 into one in some cases) and new fit to increase the living space within the dwelling.

Works are complete on a new door entry system and we are costing replacement doors and windows in a situation whereby additional finance was secured.

We are currently examining the potential of reconfiguring 2 flats into 1 large unit thus creating larger living spaces within the complex. Once this work has been completed and a report produced, it will be brought to the Department of Housing, Planning and Local Government for assessment with the view of upgrading all the dwellings as they become available.

We are also proposing to carry out precinct works consisting of the separation of each block by means of a wall & railings, and the provision of parking facilities, playgrounds, and green areas for each block.

Gloucester Place/Former IDA site

Construction work commenced in late February 2016 and the project is progressing very well and the project is in the final stage, including snagging and signing off and will be ready to populate in the very short term.

Castleforbes Square

All the dwellings have been allocated, under the City Councils' Allocation Scheme, and the complex enjoys full occupancy.

Vacant Site at Poplar Row

Works completion expected Q3 2019.

The City Council have hoarded off the site and improved the look through Artwork similar to the Mud Island hoarding.

Tom Clarke House

All properties now signed for and fully let. The Area Housing Office have also installed automated vehicular gates & pedestrian gates to eradicate illegal parking and enhance the security for the Residents.

Summerhill (Older persons complex)

The windows are due to be cleaned on Thursday, 08/03/2018.

Funding has been given, under contract of service, to plant and clean (moss and weeding) the front area of Summerhill Senior Citizens complex with works staring on Wed 8th of November 2017. This, in conjunction with the open green area at the rear of the complex, ensures the Summerhill complex maintains it fine history of award winning flower display and gardens.

Brendan Behan Older Persons complex

Funding has been approved for the upgrading and refurbishment of the community room at Brendan Behan Older Persons complex. This includes new flooring and general repairs.

Saint Laurence O'Toole Court

The front garden area has been resurfaced with resin (on both side of railings), and the planting of flower beds and planters has been approved.

The construction of ramps, at the entry point of dwellings has been completed for wheelchair access. The communal room has been fitted with a new front door.

A new security gate has been constructed at the rear of the complex to stop the access and congregation of youths to the complex.

Oriel Street Older Persons units

The front garden has been resurfaced with resin, the fascia and soffit are being fully replaced.

Works have started to have the external frontage of the 8 dwellings cleaned and thereafter painted (which includes the gable doors, front windows and the railings (front and rear).

It has been proposed to have the bedding flowers and planters made available to residents that wish to avail of such gardening assistance.

Dominick Street Lower

Detailed designs for 5-3 bed town houses, 67 apartments consisting of 5-3 bed, 50-2 bed and 12 1-bed units, a community facility and retail/commercial units with 47 car spaces at basement level on the eastern side of Dominick Street have been completed. The costings have been sent to the Department of Housing, Planning, Community and Local Government for approval to go to tender in January. Tender documentation is complete. Dublin City Council has commenced the tendering process for our project in Dominick Street Lower by inviting Expressions of Interest for the Works contract. This stage will take approximately 12 weeks and a maximum of six contractors will be shortlisted and invited to tender in Stage 2, subject to the financial approval from the Department of Housing Planning Community and Local Government.

Constitution Hill

An internal design team has been set up to make a submission to the Department of Housing, Planning, Community and Local Government on a recommendation for some new build and refurbishment of this complex. We expect to send the Stage 1 report the Department of Housing, Planning, Community and Local Government this month for approval. A resurfacing programme has commenced to fill in all potholes in this complex.

Dorset Street & Saint Marys Terrace

The Department, after reviewing the consultant's report, has advised that the cost of refurbishment was so close to the cost of demolition and new build that they requested that this option be further developed. The Stage 1 report is down with Department of Housing, Planning, Community and Local Government for approval of funding. Once approved, we will commence consultations with the local community and designs for Part 8 approval.

Sean Foster Place

The preferred bidder will be announced this month. Pending approval from the Department of Housing, Planning, Community and Local I expect a contractor to be on site in the next couple of months, it should take approximately 18 months to build the complex.

Dominick Court

Upgrading of the windows and doors in this complex has commenced. Environment clean up has also started.

Ormond Square

Painting programme has been complete.

Chancery House

Painting programme has commenced

Blessington Street

A complete fire protection programme will commence on Monday 12th these works will include upgrading emergency lighting, fire detection, and alarm systems. Repair or replacement of all fire doors, etc.

<u>O'Devaney Gardens:</u> Tenders for the construction of 56 Social Housing units have been invited and completed documentation is due to be returned by the end of March. Efforts continue to source suitable alternative accommodation for residents in the five remaining occupied flats. Next Consultative Forum meeting will take place on 18th April 2018.

<u>Bricins Park:</u> Phase 2 snagging ongoing, units will be allocated as soon as all outstanding issues have been addressed. Phase 3 progressing satisfactorily although recent weather conditions have had an impact.

Aughrim Court

Landscaping works, financed under CAC Discretionary Funding, completed.

Drumalee Court:

Supply & installation of new locking mechanisms at entry points completed and keys have been distributed to residents.

NORTH EAST INNER CITY PROGRAMME OFFICE REPORT

Implementation of the actions identified in the Mulvey report is continuing under the direction of the Chairman Michael Stone, the Programme Implementation Board and five Sub-Groups. A progress report on the work of the Board to date was launched by the Taoiseach, Leo Varadkar during his visit to the North East Inner City on Monday 26th February 2016. The report is available to download at www.neic.ie



Speaking at Sherriff Youth Club, the Taoiseach said: "I am delighted to be present for the publication of this report and to support the on-going effort to regenerate the neighborhood. This morning, I had the chance to visit a number of community projects and see with my own eyes the commitment and passion of so many people determined to bring hope and opportunity back to this community. The North Inner City is full of decent people, long established communities and newcomers who are proud of their neighbourhood and want the best for their children. While the community has faced serious challenges in recent years, there is a real determination to move forward. The Government is determined to back this through targeted investment and expertise."

Further to the February report to the Area Committee an additional round of funding proposals (Total €65,060), were approved at the Board meeting held on 28th February 2018: This brings the total approved to €1.102M of the €2.5M 2018 RAPID funding allocated to the NEIC Initiative by the Department of Rural & Community Development.

A pilot social employment fund of €1million has also been established (co-funded €500K – Dept. Employment Affairs and Social Protection €500k and Dept. Public Expenditure & Reform) to support priority projects/services that are adversely affected by lack of uptake of existing CE places in the NEIC area. Target groups for support are those providing services in childcare / afterschool care, eldercare and the environment. To date funding has been released for one project, CASPr to recruit 3 employees on a 30 hour week. These workers are now in place. Discussions ongoing re parameters of pilot programme with Dept of Rural and Community Affairs, POBAL and Dept. of the Taoiseach.

The new proposals approved at the February Board Meeting are as follows:

• Vantastic – Transport Service for elderly (6 month pilot project) €15,000

This partnership pilot project, operated by <u>Vantastic</u> will offer door-to-door services to elderly and mobility impaired NEIC residents to attend hospital and other medical appointments at a nominal charge to the individual users.

• Contribution to Irish Rail (Package 3) €5,500

Co-funding of railway bridge painting works at Amiens Street and Seville Place.

Pilot Barista Training course €6,240

The Local Employment Service has devised a pilot 2 week training course for 12 NEIC participants to included elements such as food hygiene. This has been identified as a requirement by the city business sector seeking to recruit employees in the hospitality sector.

Career LEAP (Local Employment Action Partnership) Training Course €24,320

Contribution to ETB towards overall estimated cost of €100K to run two courses pre-summer 2018 including training for local project workers and employment mentors from local businesses. The Career LEAP Programme, launched in Dec. 2016, targets 18-25 year olds and aims to develop the social, emotional and cognitive skills necessary for developing career identity and work-readiness. Professor Carmel O'Sullivan, Head of School of Education at Trinity, developed the programme in conjunction with Swan Youth Service, East Wall Youth and Business in the Community Ireland (BITCI). 18 prominent businesses in the Dublin area also contributed to its development.

• Youth Counselling Service €14,000

This funding will enable completion of a programme of therapeutic counselling commenced in 2017 with funding from NEIC. 32 local young people are currently availing of this service through YPAR.

Updates on previously approved proposals are as follows:

• Ana Liffey Drug Project - Assertive Case Management (NEIC Specific) - €100,000

This 1-year project aimed at tackling on-street drug dealing blackspots was approved in 2017 and is up and running since Sept. 2017 and will run until Sept. 2018 at a total cost of €155,000. The overall purpose of the targeted interventions by the Ana Liffey dedicated NEIC outreach team is to case manage individuals who are causing harm to themselves and their community due to addiction and related antisocial behaviour. The focus is on individuals who are not currently engaged with any other support service. A project monitoring group is in place. At the last meeting held on 27th February a total of 25 individuals were fully engaged in case management with the Ana Liffey ACM Team.

• North Inner City Folklore Project - €30,000

The Folklore Project is now operating from Unit 1, The Forge. The 2018 funding will be used to cover costs associated with the Unit i.e. rental and utilities. The balance will be used to fund development work with the project with an initial focus on professional cataloguing of existing material to be followed by report and recommendations on future direction. The cataloguing task commenced on Wed. 7th March. The Folklore Project was also assisted in preparation of two applications for funding under the Heritage Council's Community Heritage Grant Scheme and these were submitted by the closing date of 9th February.

• Programme of annual community events – €200,000

Following a successful year of events in 2017, e.g. The Big Scream Halloween festival (5 events), The Last Picnic and local summer and Christmas events, a similar initial allocation has been approved for 2018. The Halloween Festival will remain as a flagship event and planning will commence shortly. Report on an evaluation process undertaken by Dublin City Community Co-Operative on the 2017 Festival is awaited. Proposals on this and other events will be brought to the Board for approval of additional funding in due course.



The Programme Office funded and provided operational support to a very successful free family event organised by Hill Street Family Resource Centre to celebrate the Chinese New Year on Saturday 17th February 2018. There was an estimated attendance of 1,600 at the event throughout the day.

• NEIC Community Grants 2018 - €100,000

The 2017 Community Grants Scheme was run successfully with 37 local projects awarded a total of €123,000. The Scheme will be run again this year with similar criteria. Details are being finalised and it is anticipated that it will open for applications before end Q1. Councillors will be notified directly when the Scheme is open.

• Lourdes Daycare Centre - €425,000

Following grant of planning permission in December 2017 funding for the delivery of the project to include internal alterations and extension at Lourdes Daycare Centre has been approved. An initial amount of €300,000 funding was approved by the NEIC Board at the January Meeting. Following the completion of the tender process the full contract cost of the project will be €425,000 incl. VAT. The shortfall will be met by NEIC resources re-allocated following recent cancellation of the proposed painting of Sheriff St. Lifting Bridge. Work will commence on site in the coming weeks.

Tall Ships Regatta 2018 - Business Sector €50,000

It is delivered by our 5 dedicated IABA/DCSWP Development Officers via local schools (primary & TY level) in communities across the Dublin City area. Approx 2,000 young people take part each year.

The Programme is structured into Bronze (non contact), Silver and Gold phases. The first two phases focus on general strength & fitness, method and technique.

Training & Development

This is a 4/6 week school's programme for girls (second level). Rowing Ireland provide rowing machines and a community coach to the schools.

A Transition Year Programme compliments the above by giving students the opportunity to get on the first step of the coaching ladder and enabling them to be involved in a youth leadership role, working in a fun and interactive environment with younger students and hence, bringing value to the school.

• Olympic Values Education Programme

Students will be taught values such as fair play, respect, dignity etc... through rowing. *Get Going ... Get Rowing* will be the first programme in Ireland to roll this out.

Rugby Development Officer Update

- After the success of the Women's Rugby World Cup last year, the local Leinster Rugby/DCSWP Development Officer is currently delivering both tag & contact rugby sessions in a number of girls' schools throughout the North Central & Central Areas, while encouraging anyone who shows enthusiasm/talent for the sport to join their local club.

GDA Report – March Area Committee

The HSE Primary Care Centre will form the core of the HSE area on the Grangegorman site. The development consists of part new build and part refurbishment of the protected Laundry building. The facility will accommodate the Grangegorman and Cabra East primary care teams along with a range of other health and social care network services for the North West Inner City. There will be GP suites and public nursing, facilities for ophthalmology and occupational therapy as well as a full audiology suite, including the bone anchoring hearing aid (BAHA) programme and hearing aid repairs.

The HSE Primary Care Centre opened in late 2017 with staff from audiology moving in and commencing their service. The ophthalmology & child and adolescent mental health services will be moving in April. The GP's service is due to move in early May which likely coincides with the relocation of the Thompson Centre (Mountjoy Street).
