- 578**     **Councillor Greg Kelly**  
This Area Committee expresses its anger at Irish Water, who have left constituents in the Dublin 8 and Dublin 10 area without water after the recent bad weather. While Irish Water announced water pressure reduction we have seen areas been left without any water at all. This we know is due to the lack of investment in the water infrastructure over the years. If, as called for by the hundreds of thousands of people who marched against Irish Water, the millions of Euro had been spent on the ageing Dublin water pipes, instead of consultants and water meters, we would not have seen people without water at this time. We call on Irish Water to outline to this Area Committee its plan to upgrade the water infrastructure in the whole Dublin South Central Area, and we ask for full details of works and a timeline.

That this Area Committee commends all the staff and volunteers in the Orchard Centre in Cherry Orchard who provided homeless accommodation and a community outreach service over the recent bad weather. To this end we request that this motion be sent to the Lord Mayor's office and for all staff and volunteers to receive a civic award for their selfless dedication in helping others.

This Area Committee supports the call from De La Salle GAA club for a GAA pitch in the Cherry Orchard area as part of the Local Area Plans for Cherry Orchard.
- 581**     **Councillor Vincent Jackson**  
For many years I have sought without success the introduction of a refundable deposit scheme on all plastic bottles, beverage cans, soft drinks cans etc. I am asking that Dublin City Council lobby aggressively the Department of Environment Housing & Local Government for the introduction of such a scheme here, similar to Germany, Denmark etc. who levy 25 cents, which is refundable when you return the empty bottles, cans etc. Only last week I counted 27 bottles, cans etc. along Le Fanu Road, Ballyfermot, between Kylemore Road and Grange Cross. Our football pitches are destroyed with beer bottles as there is no value put on the bottles, hence, they are just thrown away. A deposit would sort this problem out once and for all. The plastic bag levy was instrumental in cleaning up so much of our communities when a charge was levied. This is exactly what we need in Ireland to deter litter louts.

The compactors have separate sections for brown, green and black bag waste. The provision of these pay as you go compactors gives an alternative method of disposing of waste without having to pay an annual service charge to a kerbside waste collection company. This system is particularly of interest to those households who do not generate significant amounts of waste. We ask our Waste Management Services to consider a pilot scheme for this system in a current Bring Centre in the Dublin South Central.

## **Neighbourhood Traffic Study Workshop**

The Neighbourhood Traffic Study Workshop is scheduled for the 21<sup>st</sup> of March, 2018. The venue and agenda will be announced at a later date.

## **HSE announces Merchants Quay Project CLG as preferred operator of Ireland's first Medically Supervised Injecting Facility**

The HSE confirmed on the 16<sup>th</sup> of February that Merchants Quay Project CLG is the preferred bidder to operate a Medically Supervised Injecting Facility in Dublin City Centre on a pilot basis. The awarding of the contract follows a HSE procurement process initiated last August and is subject to normal planning permission approval. An evaluation group established to review the tenders included HSE Procurement, HSE Social Inclusion, an Academic Expert, An Garda Siochana, Dublin City Council and an external Public Health expert. It is envisaged that the preferred bidder will operate the facility for an 18 month period, by means of a License to be granted under the Misuse of Drugs (Supervised Injection Facilities) Act 2017.

A key element in the success of the pilot will be a demonstration of consultation and ongoing engagement with local stakeholders from the surrounding area. Merchants Quay Project will be required to have in place a specific plan in this regard and will be required to employ a Community Liaison Worker to engage local businesses, communities and residents in a meaningful manner. An external evaluation of the pilot phase of the facility will be carried out by an independent agent engaged by the HSE. Specific structures will be put in place to ensure comprehensive operational, clinical and supervisory governance arrangements. These will include a Monitoring Committee comprising key stakeholders to oversee the facility chaired by Dr Eamon Keenan, National Clinical Lead, HSE Addiction Services on behalf of the HSE. A Clinical Governance committee will be established to ensure the facility is providing appropriate clinical intervention to attendees and that these interventions are in line with international best practice. The facility will also be required to comply with the National Standards for Safer Better Healthcare. As the HSE is required to adhere to appropriate procurement protocols, a 14-day standstill will now be observed prior to formal award.

## **Report on the Iveagh Market**

Solicitors for the developer have responded to recent correspondence issued to them requesting the developer to hand back possession of the Iveagh Market to Dublin City Council. This is currently being reviewed by the Law Agent who will advise on how the Council should proceed in this matter.

## **Park West – Cherry Orchard Local Area Plan Update 20<sup>th</sup> February 2018**

The following is an update for the South Central Area Committee on the preparation of the Park West – Cherry Orchard Local Area Plan from the Planning and Property Development Department.

Dublin City Council (DCC) is preparing a Local Area Plan (LAP) for Park West – Cherry Orchard. The preparation of an LAP is identified as an objective of the current Dublin City Development Plan 2016-2022 (Table F).

The Issues Paper (i.e. pre-draft local area plan) public consultation was launched on the 12<sup>th</sup> February 2018 with the publication of a public notice and the Issues Paper document. The consultation period extends from **Monday 12<sup>th</sup> February until Friday 16<sup>th</sup> March inclusive**.

A display was provided in the Civic Offices in Wood Quay, the Civic Offices in Ballyfermot (in the atrium and also in the reception of the Area Office) and the Orchard Community Development Centre. The South Central Councillors were circulated with a copy of the Issues Paper and the statutory notice. A range of pertinent stakeholders including social and community groups, schools and sport clubs were notified (with assistance from the Area Office). The Issues Paper and details on how to make a submission were posted on the Dublin City Council website. Use was also made of the DCC social media accounts (facebook and twitter) to help to notify members of the public. Posters on the consultation process were erected in fifteen locations throughout Park West and Cherry Orchard: -

Where possible these sessions have been teamed with local events to provide maximum exposure and community input.

In addition to the above, a press release has been provided to The Echo Ballyfermot to provide newspaper coverage on this process, due for publication on the 22<sup>nd</sup> February in advance of the public consultation sessions.

Furthermore members of the Planning Department are continuing to meet with various statutory and service agencies involved in the area, incl. The Irish Prison Service, the Health Service Executive (HSE), the National Transport Authority (NTA), South Dublin County Council. Further consultations will be planned for the area including youth consultation.

Members of the Council will be kept updated throughout this process.

### **Housing with Support Model at St Michael's**

The Housing Department has been progressing a partnership approach with the HSE on development of the site adjacent to the Richmond Barracks to provide a Housing with Support model of accommodation for older people. The intention is that the accommodation, the facilities and the support will be such as to enable people to continue to live independently in their homes as long as possible, reducing the need to move into residential care where possible or for as long as possible. The proposals is to construct 52 units of accommodation where the one bed units are considerably larger than the standard to facilitate people remaining in their homes independently as long as possible.

An expression of interest was sought from Approved Housing Bodies and Circle/Alone were successful. They prepared a stage one application which has now been approved by the Department so they have been instructed to proceed to stage 2. The Housing Department met with them to discuss a programme for moving forward and one of the elements will be consultation and communication with local interested parties. Meetings will be organised in the area over the next few months so will be in contact with you in this regards.

### **Weaver Park nominated for a European Prize for Urban Public Space**

Weaver Park, built as a green space in the heart of the Liberties, has been nominated for a for a European Prize for Urban Public Space, which is an awards initiative run by the Centre of Contemporary Culture of Barcelona (CCCB). Nominees are chosen through the CCCB's board of experts selecting recently completed public areas in Europe that "foster the public character of urban spaces and their capacity for fostering social cohesion". The prize, in highlighting the relational and civic aspects of the typically urban space, thus differs from other initiatives that are focused on the figure of the architect, and from awards given for landscape-centred projects.

### **The Living City Initiative (LCI)**

The Living City Initiative (LCI) is a tax incentive scheme to assist and encourage people to live in the historic inner city areas of Dublin City. It allows owners and investors to claim tax relief for money spent on refurbishment and/or conversion of residential property either as income tax relief (for owner occupied residential) or a capital allowance (for rented residential). It also focuses on the regeneration of retail and commercial districts by allowing owners to claim an accelerated capital allowance on money spent on refurbishment and/or conversion of commercial property.

It aims to incentivise owners/investors to carry out the necessary refurbishment and/or conversion works to upgrade existing accommodation or bring derelict/disused properties back into use. Examples include bringing vacant upper floors above shop into residential/office use or carrying out refurbishment work to your home. A property can be a house, apartment, shop or any kind of structure and can include all or part of a property.

The LCI Unit has setup a 'One Stop Shop' Advisory Team from Planning, Architects, Fire Prevention, Building Control, Conservation, Valuers and other relevant Departments. The Team is available to meet and provide advice on statutory planning and development requirements in relation to proposed refurbishment and/or conversion work before works begin. 

## **CRUMLIN/KIMMAGE ELECTORAL AREA**

### **South West Inner City Area Report**

#### **St. Audeon's Park, High Street**

Works to enhance St. Audeon's Park by improving accessibility, permeability and circulation commenced in October 2017 and are due to be completed in April/May. The reconfigured western entrance will incorporate a play garden.

#### **Crane Street/Sugar House Lane**

Works, including the widening of the existing footpaths and the narrowing of the carriageway, to enhance pedestrian access along this important and busy tourist route commenced on 21<sup>st</sup> August 2017 and are due to be completed this month.

#### **Dolphins Barn**

Following agreement at the January Area Committee meeting it is expected that a Part 8 Planning Application for a Public Realm Improvement Plan for Dolphins Barn will be advertised shortly.

#### **St. Luke's Church**

Works in relation to the conservation and adaptive reuse of St. Luke's Church as office accommodation are now complete. The City Council is creating a small urban park in the north graveyard (facing St. Luke's Avenue) and carrying out improvements to the south graveyard (access via Newmarket Square). Works to both graveyards commenced in June and are due to be completed late this month or early next month. It is planned that the park facing St. Luke's Avenue will operate with normal park opening hours whilst the south graveyard can be visited by appointment. It is proposed that the park(s) will be officially opened in May when the planting has properly bedded. It is also intended to initiate a 'green school' project with St. Brigid's NS.

#### **James Street CBS**

Works to install a 5-a-side all-weather football pitch (49.6m x 23.4m) in the grounds of James Street CBS commenced in December and should be completed later this month. This facility will provide a much needed resource for the school, local sports clubs and the wider community. The pitch will be part funded from the 2016 Discretionary Fund.

#### **Marrowbone Lane Flats**

Work has been completed to landscape the front areas of Marrowbone Lane Buildings. The project included clearing of the areas, removing dead trees and stumps, planting a new evergreen hedge, 15 no. trees and smaller planter areas. A portion of the front area has been left clear to facilitate a residents' garden. The project was support-funded by the Discretionary Fund 2018.

#### **Shopfront Improvement Scheme 2018**

Applications are currently invited for the Shopfront Improvement Scheme 2018 for The Liberties. It is hoped to support 15 projects this year and build on the success of recent years. An extension of the scheme to Dolphins Barn will be progressed later in spring.

#### **Crane Street**

A major programme of work to repave Crane Street and adjoining streets has been completed. The project involved widening footpaths on both sides of the street, laying new street surfaces, lifting and relaying antique paving, kerbs and setts to best conservation practice and renewing some services. Parking along the street has now been removed to

facilitate a more pedestrian friendly environment. The work was undertaken by KN Networks for Dublin City Council Roads Department.

### **Crumlin/Kimmage Area Report**

#### **Crumlin Village**

A contractor has been selected to upgrade the public domain of the east side of Crumlin Village from the junction with Windmill Road to St. Agnes Park, i.e. between an Post Sorting Office and the Garda Station. It is expected that work will commence on 13<sup>th</sup> March with a completion date of late July.

The works will include:

- The replacement of the existing footpath with cobble lock and slabs similar to the West side of the road

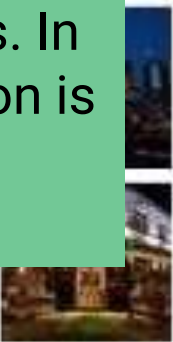

# HOME OF THE FREE

Known as **The Liberties**, the area west of Christchurch and east of Kilmainham, is one of the most important and historic in the capital city. While there are impressive plans for regeneration and development over the next ten years, the aim is to retain its unique, Dublin character. **BY STEPHANIE COSTELLO**

**N**o other place in Dublin has tapped into the cultural zeitgeist quite like **The Liberties**. From centuries old churches and cathedrals, to horse drawn carriages, colourful characters, fantastic pubs and generations of vendors selling all sorts in long established shops and markets, all human life is here - in a good way...

Once a semi-autonomous jurisdiction, The Liberties (or Na Saeirsí as gaeilge) got its name in the 12th century due to its geographic location outside the city walls. In the manner of the time, King Henry II granted to the Augustinian monks certain privileges and powers, which enabled them to control trade in the area. It's one of the oldest and most historic areas in central Dublin, spanning from the river Liffey on the north end across to Warrenmount on the south; and St.Patrick's Cathedral on the east, to St.James Hospital on the West.

Today, this multi-faceted, bustling part of the city is alive-alive-oh, and brimming with charm. Easily accessible by bus or on foot, it is a focal point for tourists and natives alike.

**"It will still be an area of majestic cathedrals and beautiful churches, a famous brewery and trendy new distilleries, lively market streets and colourful local charm."**

Walkers generally begin their Liberties jaunt in Medieval Dublin, at Christ Church Cathedral, one of the capital city's oldest and most exquisite structures: one can saunter around the famous 12th century crypts and gaze in amazement at the splendour of its artistry and craftsmanship, before heading over to Dublinia, a historical museum dedicated to our Viking

as well as the manifold musicians, who are studying and developing their craft at **BIMM college** just a few doors down. District 8, located in The Tivoli Theatre, at the Thomas Street end of Francis Street is a clubbing institution for the newest generation of ravers, where top international house and techno DJs are likely to be found on weekends. Meanwhile, The Tivoli car park has become a go to place in and of itself. There, the work of the cream of Irish urban artists can be found on display, on its towering walls.

The Tivoli is set to be redeveloped as a hotel in the coming years. Its loss will be mourned by many - but it is also a sign that developers see the huge potential in the area and are anxious to get involved. The Liberties are rising...

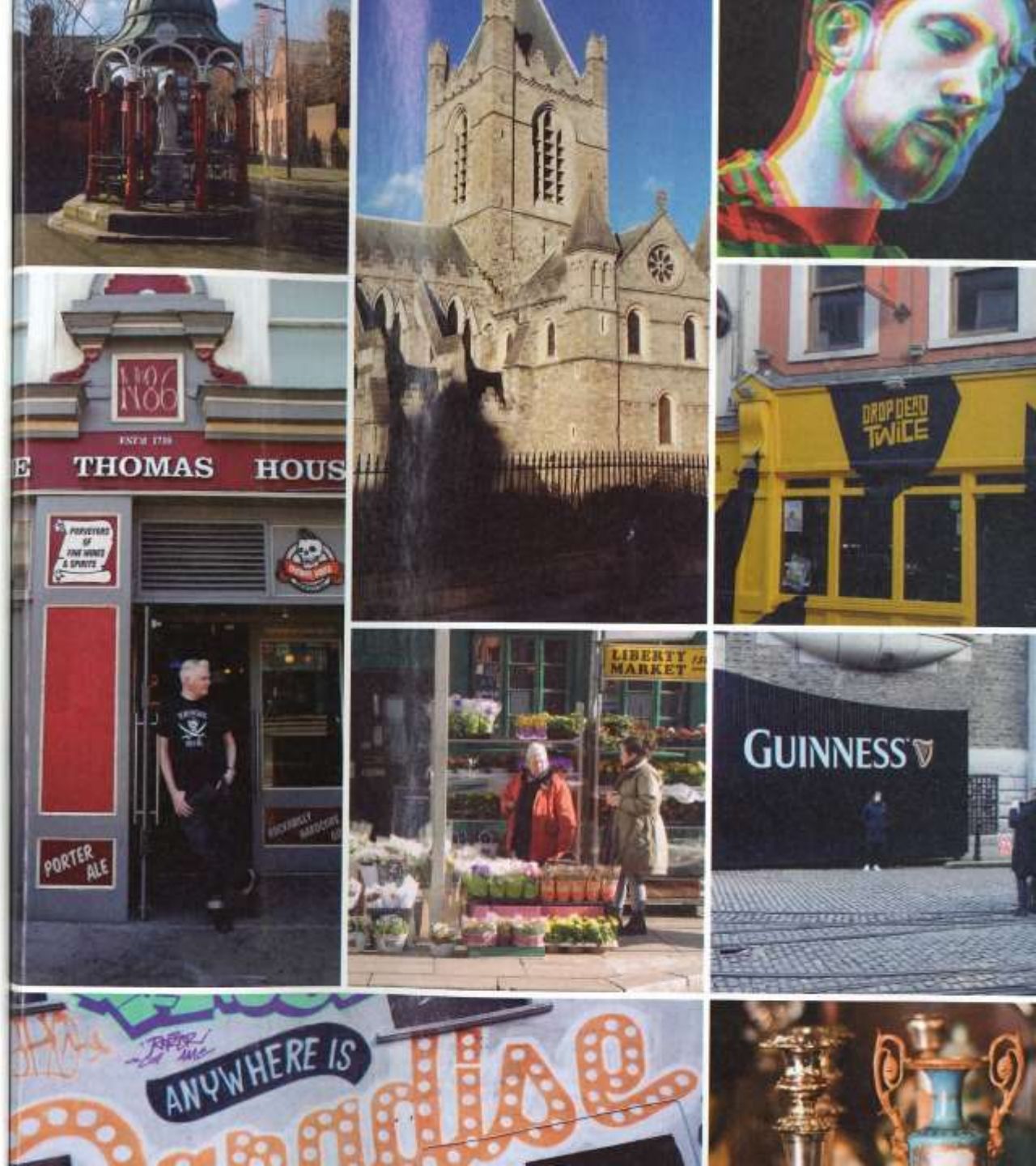
## BREWING AND DISTILLING

This area of Dublin wasn't always a prime target for cash injections and redevelopment plans. It has a strong, proud working class history with some of Dublin's oldest tenement buildings remaining an important part of the social and cultural mix.

That there was a huge divide historically between the rich and the poor of the Liberties was axiomatic: that's how things were then. Locals were all too well aware of the ill-treatment of children generally in Ireland, in what was a very divided society. Indeed it was a Liberties resident, the great Dean of St Patrick's Cathedral, Jonathan Swift, who in 1729 wrote the justly famous work of satire, *A Modest Proposal*, which highlighted the inequality, hypocrisy and double standards of the time.

During the late 18th and 19th century, however, the area became an important brewing and distilling quarter and many residents found work in the factories there. That did not mean an end to poverty. But there was work to be had, and the area was an important centre of industry.

Historic hardships only served to embolden the community spirit in the Liberties, as Nancy O'Doherty who was born and raised on Reginald Street remembers.

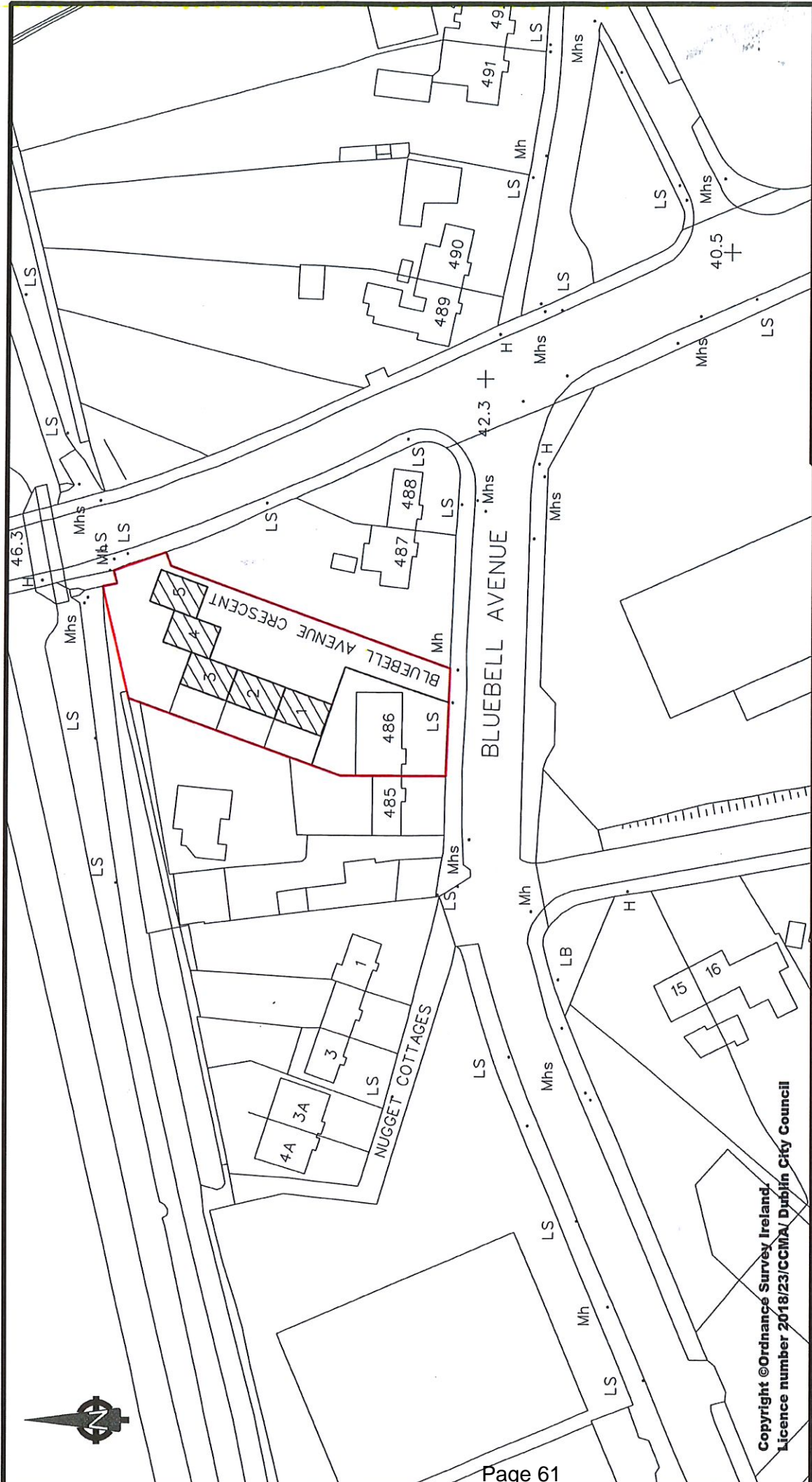

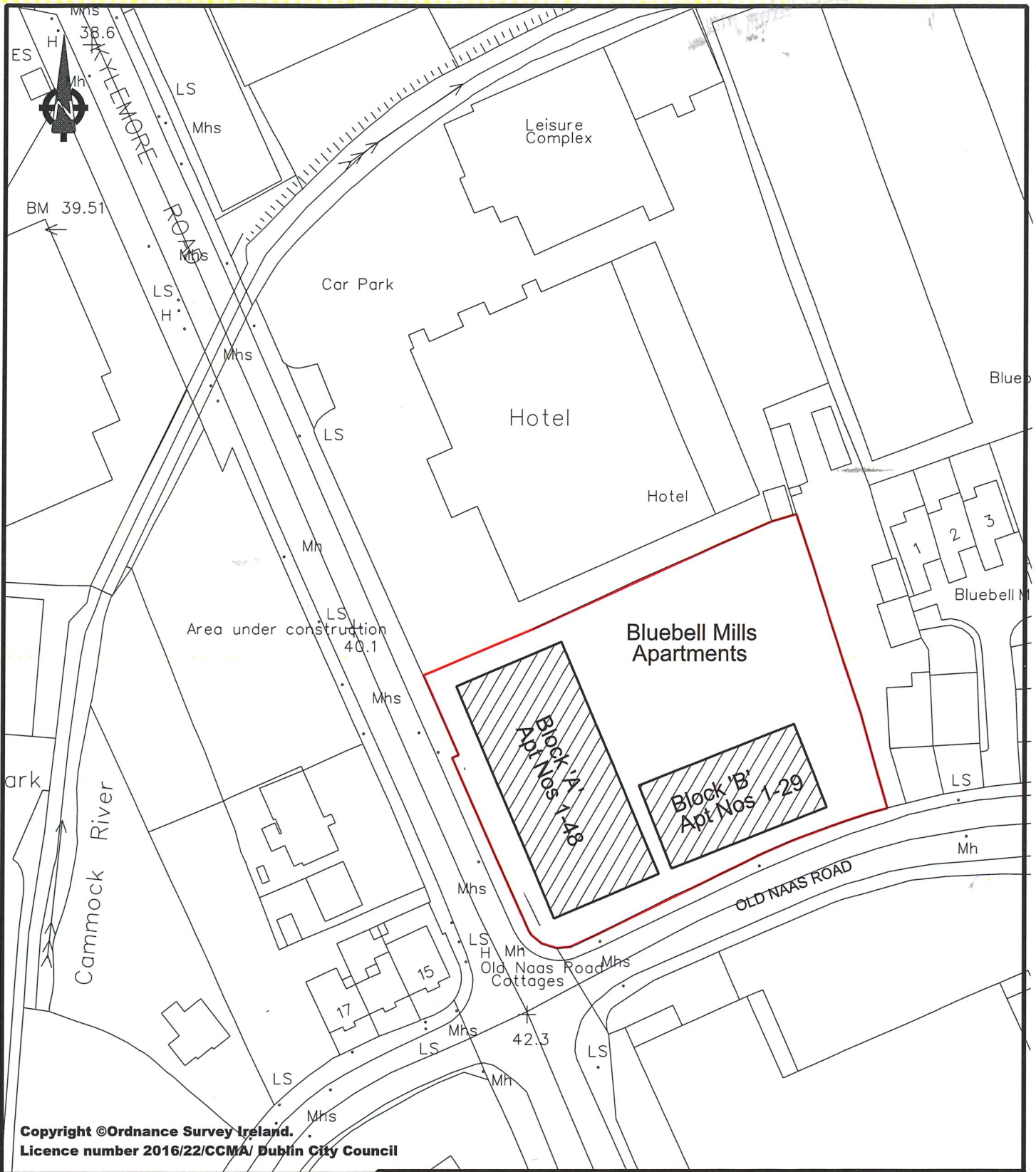

- The **Lord Mayor's 5 Alive Challenge** is a partnership initiative between Dublin City Sport & Wellbeing Partnership and the Lord Mayor's Office. The Challenge is in its 6th year and has encouraged hundreds of people to take up regular exercise over the past 5 years.

This year we went back to our roots and targeted people who were interested in taking up jogging for the first time or those who had started and need some encouragement to keep it going. For 2018, we also introduced Mentors - people who have completed the Challenge in previous years and who will run with slower joggers/walkers to encourage them around the course.

The Challenge is to complete 5 Dublin road races –

If one of the registered participants can't make one of the races, they can substitute for one of the parkruns organised by [parkrun Ireland](#). DCSWP Sport Officers have secured places in the challenge for their 'Couch to parkrun' participants in an attempt to further their running development.

- **Get Dublin Walking:** DCSWP Sport Officers, in partnership with the HSE and DCC Community Section are rolling out a series of walking groups across the city under the banner of 'Get Dublin Walking'. Get Dublin Walking Programmes running in the South Central Area include:
  - *Brickfields Park* – every Saturday morning at 9.30am, in partnership with Fatima Groups United. The aim of this programme is to filter participants into the parkrun to create a sustainable pathway for people to walk or run on a regular basis.
  - *Swinging 50's Club* – A walking group for females aged 50+ from the Ballyfermot area. The local DCSWP Sport Officer is supporting the groups to explore more challenging walks outside of the immediate area.
  - *Ballyfermot Walkers* - Commenced in mid January, the group meets every Monday and Wednesday at 7pm from Ballyfermot main church. Open to all ages and gender, this walking group is run in conjunction with the DCC Community Section.
  - *Kylemore CTC* – A group of students (16 – 22 years) from the Kylemore Community Training College have commenced a pre-class walk on Friday mornings at 9am, facilitated by the local DCSWP Sport Officer.

- **Change for Life:** DCSWP Sport Officers combined resources to deliver a community based health related fitness programme to members of the public in across Dublin City. The programme ran in tandem with the Operation Transformation TV show and combined weekly exercise sessions, nutritional advice and structured walks to help improve overall health, wellbeing and quality of life. Sessions commenced in January in Bluebell & Fatima.

Many participants also took part in the OT Run on Feb 24<sup>th</sup> in the Phoenix Park – a fantastic achievement!

The programme culminated in a celebration evening in the Mansion House on Friday, March 9<sup>th</sup>, where their achievements were acknowledged and information provided on how participants could continue with their journey to a sustainable healthy lifestyle.

- **Men on the Move** - a free physical activity programme that is aimed at adult men who have been inactive for a while and want to get back to exercising and improve their fitness levels. It involves twice weekly exercise sessions made up of a combination of aerobic, strength & flexibility components. The programme will run in 3 areas for 12 weeks starting in January. - **Fit4Class**  
Dublin City Sport & Wellbeing Partnership teamed up with Athletics Ireland to offer Fit4Class programme to primary schools across the City. Fit4Class, which commenced on the 12<sup>th</sup> of February, is a 10-week programme aimed at introducing primary school children from junior infants to fourth class to athletics in a fun, engaging and non-competitive environment. It focuses on the use of games to develop fitness whilst enhancing agility, balance and coordination - all fundamental to long term physical athletic development. Participating schools have been given an equipment bag and resource booklet. 5 schools (one in each administrative area) have also been offered pre and post programme fitness testing i.e. 20 metre sprint, standing long jump and standing vertical jump.

- **Champions**  
This multi-sports programme is aimed at adults with intellectual disabilities and is run in partnership with St. John of God Menni Services. It is ongoing every Monday from 11am – 12pm in Sport & Fitness Ballyfermot.
- **Thrive**  
Thrive is a referral programme geared towards engaging people with mental health difficulties. This can range from people who suffer with anxiety or depression right through to people who may have suffered an acquired brain injury and need assistance in re-integrating into their communities from a personal independence, social & general wellbeing viewpoint. Some current ongoing *Thrive* programmes include –
  - *Fatima; Tuesdays from 11am – 1pm (in partnership with Fatima Groups United)*
  - *Cycling Programme for women in partnership with STAR Realt Nua ETB & Ballyfermot Outward Bounds Adventure Centre (Wednesdays 10.30am – 12.30pm)*

She is currently working with a D10 youth group aged 15 – 26 years & a St. John of God Menni Services Group aged 18 – 26 years to help them both achieve the award.

Under Indenture of Lease dated 2<sup>nd</sup> of November 1937 Dublin City Council demised a site at Davitt Road close to intersection with Benbulbin Road, Inchicore, Dublin 8 to Laurence Gartlan for a term of 150 years from 20<sup>th</sup> May 1937.

By Indenture of Assignment dated the 14<sup>th</sup> November 1969 a portion of this lease the subject of this report, was assigned to Patrick Solon for the residue of the term thereof. Patrick Solon has applied to Dublin City Council to acquire the Council's fee simple interest therein and the Law Agent has confirmed that the applicant has a statutory entitlement to acquire said fee simple interest.

Accordingly it is proposed to dispose of the Council's fee simple interest in the site at Davitt Road close to intersection with Benbulbin Road, Inchicore, Dublin 8 to Patrick Solon subject to the following terms and conditions:

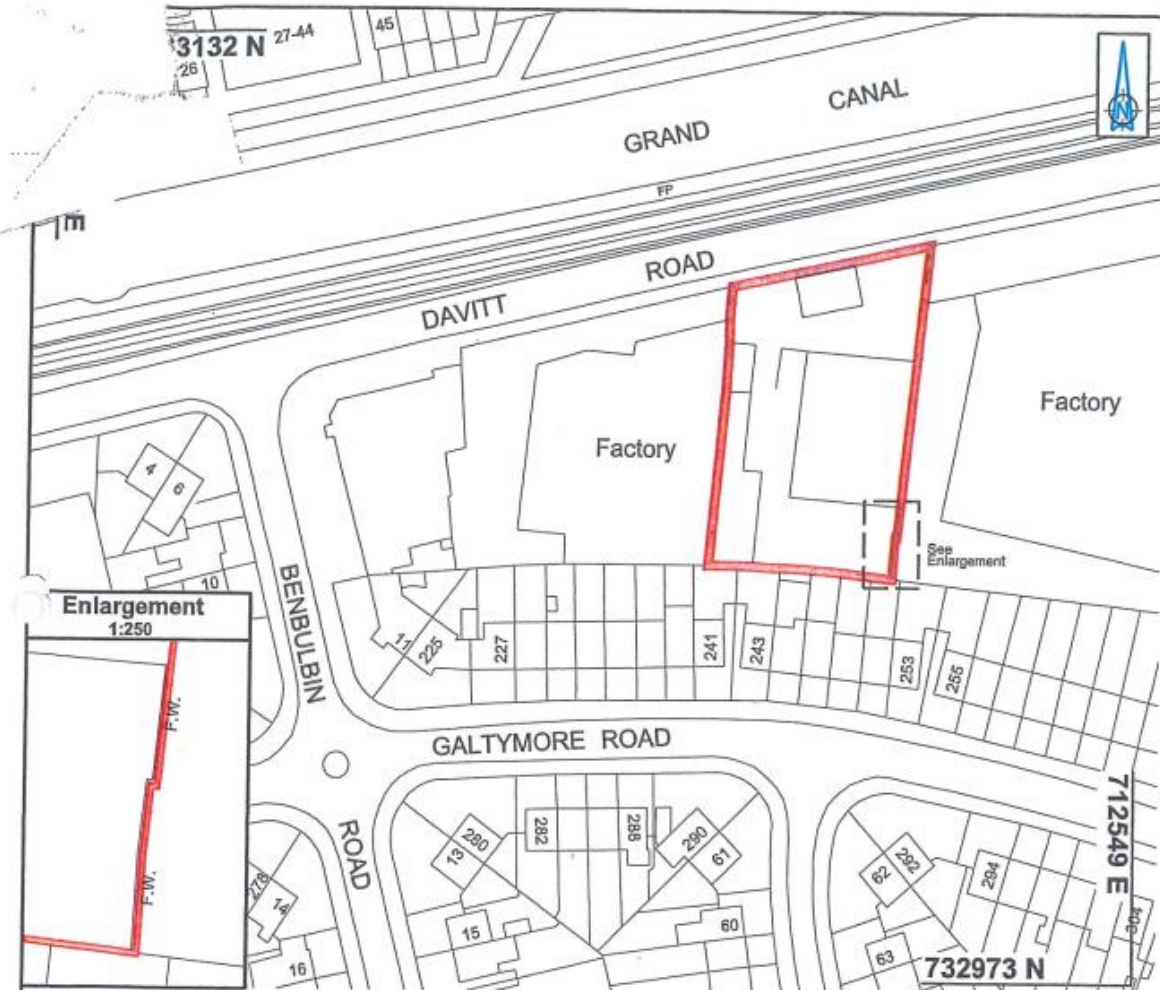

5. That the applicant shall pay Valuers Fees of €1,200 (one thousand, two hundred euro) plus V.A.T, together with the Councils legal fees, which will be agreed with the Councils Law Agent.

The title issues are now resolved.

The Chief Valuer has confirmed that the disposal can proceed on the same terms and conditions as contained in the original agreement as follows;

1. That the area being disposed of is as shown hatched and coloured in pink on attached drawing no.99/31.3.201/3 prepared by Iarnród Éireann. The plot has an area of 427.5 m<sup>2</sup>
2. The compensation payable to Dublin City Council is €6,349 (six thousand, three hundred and forty nine euro)
3. Each party will be responsible for their own costs and legal fees in this matter.
4. CIE will provide a 2 metre high concrete block wall, capped and faced with stone, between the points marked X and Y on the attached map, and will make good the adjacent ground disturbed by the works. CIE will bear the full costs of these accommodation works.
5. These terms and conditions and other terms as deemed necessary by the Law Agent, will be incorporated into a legal agreement which will be prepared by the Council's Law Agent and completed by both parties.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.

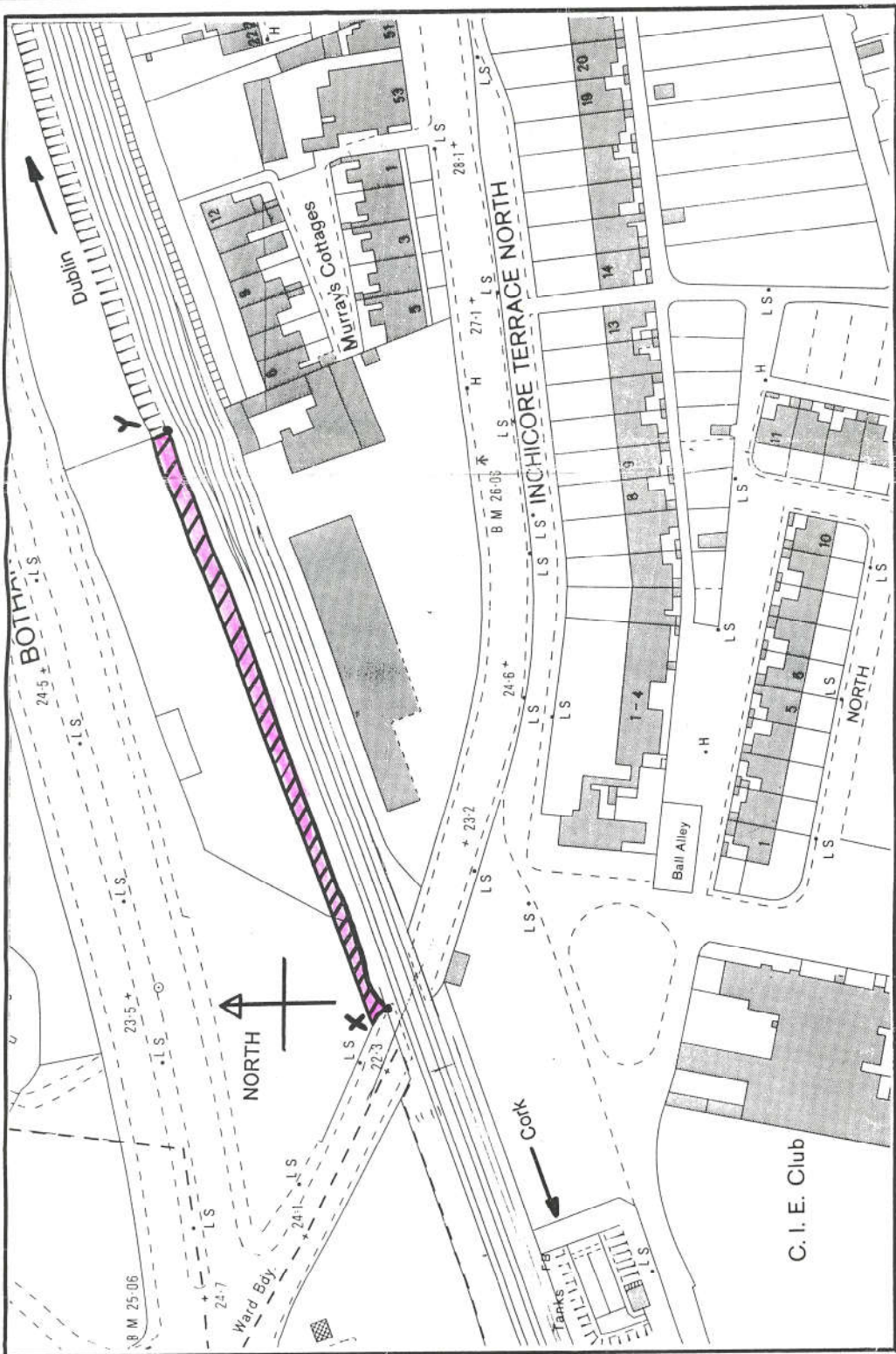
