MINUTES OF THE CENTRAL AREA JPC MEETING

HELD ON THURSDAY 22 MARCH 2018

1 Minutes of Central Area Joint Policing Sub-Committee meeting held on 11th December 2017

Minutes agreed.

Members praised Gardaí and Council staff for their work during the severe weather alert. They also expressed their gratitude to Dublin Fire Brigade, hotel staff and residents for the safe evacuation of people during the fire at the Metro hotel.

3 **Presentation by An Garda Síochána**

Presentation noted.

Chief Supt. Ward informed the Committee that 89 convictions have occurred since the prescription drugs legislation was enacted.

The 40 new Gardaí will arrive 3rd April and will receive special training in relation to issues unique to the North East Inner City. They will be deployed across the 3 Garda stations in the Division.

Members thanked Chief Supt. Ward and Council officials for a very successful St. Patrick's Day.

Members expressed concern with the length of time the Divisional Community Policing Office takes to issue a response to them. Chief Supt. Ward to investigate the matter and report back to the Committee.

Members expressed concern on the length of time it takes Gardaí in Bridewell Station to call to victims after they report a crime. Chief Supt. Ward to investigate and report back to the Committee.

Cllr Burke asked for figures relating to arrests for intoxication to be made available. Chief Supt. Ward to bring statistics to a future meeting.

4 Presentation by Michael Stone, Chairperson of the Programme Implementation Board for the North East Inner City Initiative

Presentation noted.

Members commended the NEIC Programme Office and Task Force for the excellent community engagement and thanked Michael Stone for the presentation and update on matters progressed.

Proposal for the extension of Garda CCTV cameras in the North Inner City

The NEIC Programme Implementation Board has approved funding to support the installation of additional CCTV cameras at the locations listed below:

- Ballybough House
- Courtney Place
- Poplar Row
- Charleville Mall
- Mountjoy Square
- Sheriff Street / Laurence Place
- The canal walkway at the rear of the Davin Stand in Croke Park and
- The cycleway route from Sheriff Street to Newcomen Bridge.

These cameras will be directly linked in to Store Street Garda Station. The selected areas are fully supported by An Garda Siochana.

It will require the consideration and approval by the Central Area JPC and in this context I would appreciate if it could be listed for our next meeting and details circulated to all members beforehand.

Community Impact Assessment

The first stage of assessment with residents is now completed. The second stage which involves triangulation research involving evidence based statistical information from relevant stakeholders is underway. In order to validate views of residents we will undertake structured conversations with Gardaí, DCC staff and other relevant groups such as youth services. This should be completed in time for our next scheduled meeting with steering group on Tuesday 12th June.

C.P.F. Review

Following on from C.P.F. board of management meeting held on 15th February an executive committee is now established.

The remit of the executive board will be wide-ranging with emphasis on implementing recommendations contained within the Brundell review and taking account of recommendations from the Mulvey report. In addition all aspects of C.P.F. activities will include strategic planning, board representation, roles and responsibilities for staff, review of aims and objectives and development of financial and operational governance. Regular reports will be furnished to management board.

Tasks will be assigned to board members in order to facilitate achieving above goals with regular feedback and communication with management board.

Halloween Festival

We have convened a number of meetings with relevant stakeholders in preparation for this year's festival. Establishment of steering committee is nearing completion. Interviews for festival director are now concluded and an appointment has been made. Review of 2017 festival is concluded and available. One of the key recommendations from the review focuses on engagement of children under 10 years, more engagement from local residents and new communities. To that end we intend to establish a number of sub-groups similar to the youth group to engage with above mentioned groups.

Community Activity

We continue to meet regularly with local residents groups. While some groups have indicated that levels of drug dealing have diminished due to Garda activity and other activity such as construction work drug dealing and intimidation remain the main area of concern for residents.
