
# Issues associated with good weather

The good weather can bring a different set of issues for the City Council Waste Management staff.

The City Council are working closely with An Garda Síochána in relation to this matter.

In recent weeks new signage has been tinstalled along the canal advising the public that it is illegal to drink in public places.

The signages are part of a recent campaign and learned from strategies previously undertaken in Temple Bar to address similar problems especially associated with good weather.







This is a joint initiative by Dublin City Council and the Temple Bar Company to reactivate 4 laneways in Temple Bar. (Crampton Court, Copper Alley, Bedford and Adair Lanes)

The aim of the initiative is to foster a clean and safe environment and to respond to successive successive states and safe environment and to respond to successive successive

Rolled out in 2014, it is a creative approach to enhance the public space and to increase activity and draw people to the laneways.

Improvement works on the laneways has continued. Coloured sail canopies were installed in Adair Lane in 2017. An aerial sculpture 'Flow' was installed in Bedford Lane in May 2018 and the art work in Crampton Court is currently being updated.
