



With reference to the proposed grant of a further licence of Kiosks 1 & 2, Liffey Boardwalk, Dublin 1.

By way of Licence Agreement dated the 7th November 2006, Kiosks 1 & 2, Liffey Boardwalk, Dublin 1, outlined on Map Index No. PD2006-0017 and Map Index No. PD2006-0018 were demised by Dublin City Council to Cruises Coffee Kiosks (Dublin) Limited for a four year period commencing on the 14th November 2005, the latest agreement dated 13th February 2014 expired on 13th November 2017.

Cruises Coffee Kiosks (Dublin) Limited has applied to Dublin City Council for a new agreement. Accordingly it is now proposed to grant a new four year Short Term Business Agreement for Kiosks 1 & 2, Liffey Boardwalk, Dublin 1 to Cruises Coffee Kiosks (Dublin) Limited, subject to the following terms and conditions.

- 1. That the property comprises two kiosks, No.1 & 2 at Liffey Boardwalk, Dublin 1 which are shown shaded in pink on the attached maps index no. PD2006-0017 and PD2006-0018 (both of which are for identification purposes only).
- 2. That the proposed four years Short Term Business Letting Agreement shall commence from 14th November 2017.
- 3. That the rent shall be a sum of €9,500 (nine thousand and five hundred euro) plus VAT, per annum, to be paid monthly in advance by direct debit.
- 4. That the Tenant shall be responsible for the payment of all outgoings including rates, charges, fees, bills waste charges, water and electricity and any other utilities and charges that may become payable in respect of the proposed area during the period of the letting.
- That all other terms and conditions for this Short Term Business Letting Agreement are as detailed in the previous licence agreement between Dublin City Council and Cruises Coffee Kiosks (Dublin) Ltd. dated 13th February 2014.
- 6. That the Tenant shall sign a Deed of Renunciation.
- 7. That this agreement shall include any amendments and/or other conditions as are deemed appropriate by the Council's Law Agent.
- 8. That each party will be responsible for its own costs of this transaction.

APPENDIX 17 – GUIDELINES FOR RESIDENTIAL EXTENSIONS

17.1 Introduction

These guidelines contain general advice and design principles for residential extensions. The Planning and Development Regulations, 2001, (as amended) give exemptions for the construction of extensions to residential dwellings and there is a wide range of works which will fall within these exempted development provisions. The applicant's architect or agent should be able to advise on the extent of these exemptions and whether proposed works would require planning permission to be obtained.

Given the wide variety of house types and styles within Dublin city, it is not possible to deal with every type of addition. Rather, this document sets out a number of general principles that should be addressed in all cases and which will be applied by the planning authority in assessing applications for permission.

The guidelines should be interpreted in the context of the Development Plan Core Strategy, which promotes a compact city, sustainable neighbourhoods and areas where a wide range of families can live.

17.2 General Principles

New extensions, whether they are single or two-storey, have an effect on their immediate environment and accordingly the following general principles should be addressed in all proposals for extension. Proposals should:

- Not have an adverse impact on the scale and character of the dwelling.
- Have no unacceptable effect on the amenities enjoyed by the occupants of adjacent buildings in terms of privacy and access to daylight and sunlight.
- Achieve a high quality of design.

The following sections of this guidance document feature these principles in greater detail.

17.3 Residential Amenity Issues

It is important to make sure that any extension does not unacceptably affect the amenities of neighbouring properties. This includes privacy, outlook, daylight and sunlight. It is advisable to discuss your proposal with your neighbours prior to submitting a planning application.

17.4 Privacy

Extensions should not result in any significant loss of privacy to the residents of adjoining properties. Generally, windows overlooking adjoining properties (such as in a side wall) should be avoided. Where essential, the size of such windows should be kept as small as possible and consideration should be given to the use of high-level windows and/or the use of obscure glazing where the window serves a bathroom or landing.

Balconies will only be allowed where they are well screened and do not adversely overlook adjoining properties. The use of the roofs of flat-roof extensions as balconies can often lead to problems of overlooking.

17.5 Relationship Between Dwellings and Extensions

In cases where the backs of dwellings face each other or where the side of one dwelling faces the rear of a neighbouring property, a certain degree of separation is required to avoid any overbearing effect of one dwelling upon the other. With the emphasis on increased residential densities and the consequent incorporation of a variety of unit types and sizes in schemes, the requirement for 22-m separation in such cases may no longer be applicable in all instances.

The acceptable reduction of such distances, however, requires a high standard of building design and layout particularly having regard to the height and inter-relationship between buildings, the use and aspect of rooms and relative floor levels. The exact distances applicable in such cases will be determined on a case-by-case basis having regard to the above criteria and other relevant development plan standards.

The planning system does not give neighbours 'a right to a view' and does not always prevent people's view from being blocked. However, extensions should be designed so as not to dominate or appear overbearing when viewed from adjoining properties.

17.6 Daylight and Sunlight

Large single or two-storey rear extensions to semi-detached or terraced dwellings can, if they project too far from the main rear elevation, result in a loss of daylight to neighbouring houses. Furthermore, depending on orientation, such extensions can have a serious impact on the amount of sunlight received by adjoining properties.

Consideration should be given to the proportion of extensions, height and design of roofs as well as taking account of the position of windows including rooms they serve to adjacent or adjoining dwellings.

17.7 Appearance

Most houses were originally designed and built as completed entities and did not take account of any need to incorporate future extensions. It is therefore necessary when considering the design of an extension to take account of the following criteria:

- The extension should not dominate the existing building and should normally be of an overall shape and size to harmonise with the existing house and adjoining buildings; the original appearance should be the reference point for any consideration of change that may be desired.
- The materials used should ideally be the same as those used on the existing building; features such as windows and doors on the new extension should relate to those on the original building in terms of proportion.
- Extensions to the front, which significantly break the building line, should be resisted.

17.8 Subordinate Approach

The subordinate approach means that the extension plays more of a 'supporting role' to the original dwelling. In general, the extension should be no larger or higher than the existing.

17.9 Materials

Care should be taken in all extensions to ensure that the new extensions integrate with the original building as far as possible. In addition to appropriate form and scale, the maximum use of matching materials between old and new will greatly assist this integration. Considerable care and thought should be given to materials, which harmonise with the existing building and consideration should be given to the changes which occur in their appearances due to age and weathering. The illustrations shown below give an example of how to integrate a new extension successfully with the original building.

17.10 Contemporary Extensions

Although the general advice in this document is to match the existing building and to fit in with the neighbourhood, Dublin City Council also supports good contemporary designs. A contemporary or modern approach, providing unique designs, can offer a more imaginative solution to an unusual dwelling type or a contrast to a traditional building and are still required to take account of the design issues outlined in this document. Contemporary solutions should not detract from the character of an area and undeniably, if well designed, can make a positive contribution to the streetscape and the character of the area.


17.11 Roof Extensions

The roofline of a building is one of its most dominant features and it is important that any proposal to change the shape, pitch, cladding or ornament of a roof is carefully considered. If not treated sympathetically, dormer extensions can cause problems for immediate neighbours and in the way a street is viewed as a whole.

When extending in the roof, the following principles should be observed:

- The design of the dormer should reflect the character of the area, the surrounding buildings and the age and appearance of the existing building.
- Dormer windows should be visually subordinate to the roof slope, enabling a large proportion of the original roof to remain visible.
- Any new window should relate to the shape, size, position and design of the existing doors and windows on the lower floors.
- Roof materials should be covered in materials that match or complement the main building.
- Dormer windows should be set back from the eaves level to minimise their visual impact and reduce the potential for overlooking of adjoining properties.


17.12 Porches

It is important to try to avoid abutting porches close to existing windows, and where front doors are paired, a joint scheme with the neighbouring owner should be considered. The design should complement the main house.

17.13 Sustainable Design

Dublin City Council encourages and supports a sustainable approach to new build, alterations and extensions. Extending your home provides an ample opportunity to incorporate sustainability into your scheme. Practices such as the re-use of building materials, e.g. roof tiles/slates and bricks, increased insulation and rainwater harvesting techniques, to name but a few, will improve the environmental performance of a property.

17.14 Solar Panels

An increasing number of homeowners are using solar thermal panels that produce hot water and photovoltaic panels that produce electricity. Solar systems can be installed in the roof space of a dwelling similar to roof lights. Any solar thermal panels that are installed on or in roofs should not unduly dominate the roof and should be sensitive to the character, colour and style of the existing roof. The Planning and Development Regulations 2007 (S.1 No. 83 of 2007) set out planning exemptions for micro-renewable energy technologies for domestic houses including solar panels, heating systems and wind turbines.

17.15 Green Roofs

A green roof is a roof of a building that is partially or completely covered with vegetation and soil, or a growing medium, planted over a waterproofing membrane. Green roofs benefit our environment by enhancing biodiversity, reducing flood risk (by absorbing heavy rainfall and reducing or slowing down run-off) and also provides insulation.

A service check will be undertaken to establish what, if any, are located at this area. Suitable arrangements will be put in place prior to completion of this proposal.


Statutory Requirement

Recommendation




Cluid have advised that "The project is progressing well. The demolition phase is complete and the contractor has begun new sections of works; including internal partition walls and heightening of external walls etc.

Substantial improvement works continue to be carried out to the dwelling flats in this complex and to upgrade the physical environment and improve measures to tackle anti social behaviour.

- Upgrades included:
- New Public Lighting.
- Repairs of the stairwells and installation of new security doors/CCTV(now complete)
- New playground and Amphitheatre improvements and landscaping
- Painting Programme (Railings, Balcony Trims).
- Pilot programme of converting flats (2 into one in some cases) and new fit to increase the living space within the dwelling.

Works are complete on a new door entry system and we are costing replacement doors and windows in a situation whereby additional finance was secured.

We are currently examining the potential of reconfiguring 2 flats into 1 large unit thus creating larger living spaces within the complex. Once this work has been completed and a report produced, it will be brought to the Department of Housing, Planning and Local Government for assessment with the view of upgrading all the dwellings as they become available.

We are also proposing to carry out precinct works consisting of the separation of each block by means of a wall & railings, and the provision of parking facilities, playgrounds, and green areas for each block.

Oaklee Site at Poplar Row



The City Council have hoarded off the site and keys have been handed over to contractor and is now on site. New extended hoarding currently being erected. Surveys to adjoining premises currently being carried out.



Tom Clarke (Older persons complex)

Cleaning and upgrade works to gardens throughout Tom Clarke House now complete. CCTV camera installed and painting of complex now complete. Age action carried out clean up of complex 22nd June organised by DCC Liaison Officer.

Killan Court

Dominick Street Lower

Detailed designs for 5-3 bed town houses, 67 apartments consisting of 5-3 bed, 50-2 bed and 12 1-bed units, a community facility and retail/commercial units with 47 car spaces at basement level on the eastern side of Dominick Street have been completed. Tender documentation is complete. Dominick Street Lower 4 tenders were received and are currently being examined we expect to have a preferred bidder by Mid to End of August

Constitution Hill

An internal design team has been set up to make a submission to the Department of Housing, Planning, Community and Local Government on a recommendation for some new build and refurbishment of this complex. We expect to send the Stage 1 report the Department of Housing, Planning, Community and Local Government this month for approval. A Cost Benefit Analysis report is also being prepared.

Dorset Street & Saint Marys Terrace

The Department, after reviewing the consultant's report, has advised that the cost of refurbishment was so close to the cost of demolition and new build that they requested that this option be further developed. The Stage 1 report is down with Department of Housing, Planning, Community and Local Government for approval of funding. A Cost Benefit Analysis report is also being prepared.

Once approved, we will commence consultations with the local community and designs for Part 8 approval.

We are still at tender discussions in advance of contract award.

Dominick Court

Upgrading of the windows and doors in this complex has now being completed. Environment clean up has also started and a painting programme in the complex has now commenced.

Henrietta House

Painting programme has commenced.

St Peters Court

The painting of this complex has commenced.

Rory O'Connor House

This complex is currently being inspected to determine the existing level of fire detection that exists regarding smoke, heat & carbon monoxide in Rory O Connor House. This survey is a visual inspection only, covering the topics of Fire Safety, Structural Condition, Ventilation, Sanitary Facilities, Heating Facilities & Lighting.

Blessington Street

A complete fire protection programme has commenced, these works will include upgrading emergency lighting, fire detection, and alarm systems. Repair or replacement of all fire doors, etc

Georges Place

A roof refurbishment programme will commence in Georges Place with the next 2 weeks, residents will be notified prior to commencement.

O'Devaney Gardens:

The one remaining resident in O'Devaney has accepted an offer of alternative accommodation and will move out shortly. We hope to be in a position to commence demolition works on the last two flat blocks in the next couple of months. Careys, the contractor responsible for the construction of 56 new units under Phase 1 of the regeneration programme, has taken possession of the relevant site. An Information Session for those local residents who live close to the construction site was held in the Ashling Hotel on 3rd July last and was followed on the 4th by an official sod turning event

Bricins Park:

Phase 2 has finally been handed over and allocations are underway. The units are finished to a very high standard and are proving very popular with applicants. Works on Phase 3, including the Community Room & Kitchen are progressing steadily with an anticipated completion date in August.

NORTH EAST INNER CITY PROGRAMME OFFICE REPORT

The NEIC Programme Implementation Board (PIB) chaired by Michael Stone, and the four sub-groups have been up and running for a year. At the PIB meeting held on 27th June 2018 there was a review of progress on the 54 actions identified in the Mulvey Report "*Dublin North East Inner City - Creating a Brighter Future An Outline Plan for the Social and Economic Regeneration of Dublin's North East Inner City"*. Mr. Kieran Mulvey attended the meeting for a discussion with the Board on progress to date.

In summary the current status of 54 actions is as follows:

- o 9 actions complete or substantially delivered with ongoing work
- 37 actions are in progress / ongoing
- 4 have been flagged as being outside the scope of existing NEIC structures
- 3 not started
- 1 not proceeding

The full list of Mulvey actions with individual updates is attached at Appendix 1.

2018 Funding

A further round of proposals were approved for funding by the PIB at its meeting held on 30^{th} May 2018. This brings the total 2018 funding approved to \notin 2.98m. A full list of 2018 funded proposals is attached at Appendix 2. Work is underway on delivery of these projects by a range of agencies and are being overseen by the relevant Board Sub-Groups.

NEIC Community & Family Events

The approved funding included an allocation for a programme of local community events (Mulvey Action 3.12). A number of local events, supported by NEIC funding, have taken place in recent weeks e.g. Bloomsday in the Monto 16/06; Mud Island Open Day 16/06; Seville Place Girl Guides Family Day 16/06; Crinniú na Nóg, Liberty Park 23/06; Hill St. FRC Multicultural Family Fun Day 29/06;

Further events are being planned to take place in the coming months with the support of the NEIC Programme Office.

- Monto Festival 21st & 22nd July
- The Festival of Nations, Mountjoy Square Park 18th August

- The Last Picnic, Mountjoy Square Park 30th September.

Planning is also underway for the flagship event i.e. The Big Scream Halloween Festival. The Festival Director has been appointed and the Steering Committee and working groups have been established.

Sean MacDermott St. Pool

With the support of NEIC funding, a partnership agreement between Dublin City Council and Swim Ireland to extend the public opening hours of Sean MacDermott St. Swimming Pool will get underway in mid-August on a 9 month trial basis. The new partnership arrangement will facilitate the opening of the pool 7 days a week with Swim Ireland opening the facility on the days that are currently closed to the public i.e. Saturday p.m., Sunday and Monday. The existing facility and new opening hours will be promoted widely through a marketing campaign that will get underway in late July /early August.

Community Engagement Event

Following the successful NEIC Community Engagement event held in Larkin Community College earlier this year the Chairman of the Programme Implementation Board intends to hold a series of smaller scale community engagement events in the coming months to raise awareness and give local residents an opportunity to input to the work of the Board. The first of these events will be held in the Community Room at Peadar Kearney House on 17th July 2018 4:00 – 6:00 p.m. All are welcome.

Newsletter

The third NEIC newsletter is being prepared and will be circulated to all residents and businesses in the area in the coming weeks.

DUBLIN CITY SPORT & WELLBEING PARTNERSHIP REPORT

10TH JULY 2018

• Dublin Sportsfest

General:

DCSWP's flagship event will take place during European Week of Sport (September 23rd – 30th). The focus will be on encouraging participation across all ages, backgrounds & abilities and, importantly, sustainability. The festival will comprise of a week-long programme of activities, comprising of pre-existing events and the delivery of specific one-off events & promotions across many of DCC's facilities, parks and urban spaces.

Website & Calendar of Events:

A holding page currently sits on the URL: dublincity.ie/sportsfest, informing people that the event is coming soon and providing contact details for anyone who wishes to find out more information or get involved. It is hoped that we will have our calendar of events up on the site within a number of weeks. The calendar will continue to evolve as more events are added.

Pre-Existing Events:

We are delighted to confirm that the Great Dublin Bike Ride, the Laser Run World Championships & Parkrun/Junior Parkrun have all formally agreed to allow us to market their events as part of Dublin Sportsfest. In relation to Parkrun, we will look to 'turn parkrun blue' on Sept. 29th by encouraging all participants in Parkruns across the city to wear blue for Sportsfest!

DCC Facilities & NGB Participation:

All DCC sport & recreation facilities have been informed that there is an expectation on them to participate in the week by delivering an innovative event, open day or special promotion. It is an opportunity for them to showcase their facility & avail of the marketing and promotional push that Dublin Sportsfest will hopefully bring. A number of the centres have already put plans in place to deliver free swimming lessons to local schools etc...

We are currently contacting all National Governing Bodies for the various sports to see if they will get involved. The response to date has been positive with the FAI, Volleyball Ireland, Leinster Cricket, Tennis Ireland, Rowing Ireland, Leinster Rugby, Ladies Gaelic Football & Tug of War keen to get involved.

Response from Clubs to Date:

We issued a call out to sports clubs at the beginning of June, informing them what Dublin Sportsfest is all about, how they could get involved, why it would be in their interest to do so and to invite expressions of interest. The deadline is June 29th and so far we have had 5 formal expressions of interest although we expect that number to at least treble based on phone queries, e-mail correspondence & social media activity. We will not treat June 29th as a hard deadline & fully expect further engagement from clubs after this date. Some examples of responses to date include:

- Good Counsel GAA will host an open weekend on Sept 29th & 30th to include an Operation Transformation style programme, GAA skills demo, Puc Fada, Irish Dancing Classes, Meet & Greet with County Stars and to showcase their Healthy Clubs Initiative.
- St. Bernadette's Boxing Club, Santry, plan to host an army style assault course event on Portmarnock Beach on Sept 23rd. They will invite other sporting clubs from the locality to take part in 'club v club' and 'coach v coach' challenges.
- Ierne Social & Sports Club, Drumcondra, will host an open day on Sept 27th with free access to activities for older adults in the local community & beyond. Activities include pitch 'n' putt, bowls, tennis, snooker & table tennis.

Launch:

We will launch Dublin Sportfest during the first week of September @ Irishtown Stadium. The plan is to have Dublin Sportsfest ambassadors there on the day – a mix of well known sporting personalities and everyday people who use DCC sporting facilities on a regular basis – in addition to dignitaries & media. Taster sessions for various sports will be ongoing at the venue and we will invite local schools & other groups to ensure the venue is a hive of activity on the day!

Commercial Partner / Means of Promotion:

We are currently in talks with Lidl to see if they can come onboard as a partner with a view to providing refreshments at many of the Sportsfest events taking place during the week.

We will 'dress the city' by way of lamppost banners along a section of the quays and in other prominent places across the city such as O'Connell St, Merrion Square & Stephen's Green North. A large banner will cover the front of the DCSWP office building on Palace Street. A JC Decaux billboard campaign will run from 12th August – 8th Sept in addition to 20 poster sites (usually on hoarding surrounding derelict buildings or spaces). We will contact Dublin Bus, Luas & the National Transport Authority to see what possibilities there are for promotion on public transport.

Flyers will be distributed to libraries and similar outlets. Branded assets such as bunting, teardrop flags & t-shirts will be used at Sportsfest events taking place across the city. We will also run a 'reverse graffiti' guerrilla marketing campaign and distribute Sportsfest branded social media photo frame props to clubs for use at their event. Images can then be shared to maximise promotion.

The promotional campaign will take place across all social media platforms and some elements of radio in order to gain as much traction as possible for Dublin Sportsfest.

EVENTS

Please see below a flavour of some of the bigger events planned:

Sports Stadium @ Dalymount Park

Venue booked for Monday 24th September. We hope to host a Walking Football event for older adults on half the pitch and run cricket / tag rugby taster activations for schools on the other half. We hope to link with D.I.T. Grangegorman & the Bohemians Foundation on this event.

Dublin Sportsfest Seminar: Olympic Values & Insight into Elite Sport

In conjunction with our team of Boxing Development Officers (who deliver an annual Olympic Values Educational Programme to schools), we have provisionally booked the Wood Quay Venue on Tuesday Sept 25th (afternoon) to deliver a seminar broader in scope than the above. It will

give an insight into elite sport and what it means to be an Olympian via presentations, motivational speeches and Q&A session.

We will obviously need some major sporting personalities (Olympians & other elite) to agree to appear on the day and if they could bring trophies or medals along all the better! The invited audience will consist of TY students sourced via the GAISCE Awards or nominated directly by schools citywide. Capacity is 120.

Liffey Odyssey

We envisage a flotilla of craft (rafts, canoes, kayaks) to sail at a leisurely pace from the Rowing Centre in Islandbridge to the East Link. Our friends in Ballyfermot Youth Service Adventure Centre will lead this event and will also be responsible for promoting it amongst other the Youth Services citywide in an effort to recruit additional craft & also participants.

Docklands Event

Event to take place on Thursday 27th September (National Fitness Day) in partnership with Ireland Active. We are currently in the process of trying to secure the space on Grand Canal Quay, just in front of the Bord Gais Energy Theatre and have applied to the relevant management company for a permit for same.

The vision is for a day full of activity comprising of open air fitness classes (pre-registrations will be required), pre-work tai chi and post-work silent disco alongside some other ancillary fun activities. We will probably look to bring an Event Management Company on board. The event will be promoted amongst the corporate organisations and local businesses in the area in addition to the National College of Ireland.

Glow Sports

DCSWP will purchase two glow packs at a cost of approx. 2.5k each to enable us to deliver a number of 'glow' events during the week of Sportsfest and beyond. Glow football and Glow spin are the most popular manifestations to date but the concept is transferrable to many different sporting & fitness activities. It is hoped a number of DCC Sport & Recreation facilities will agree to host glow events during the week. This particularly appeals to teenage girls, a demographic we are keen to engage with.

Trinity Tag

Trinity College have agreed to expand a tag rugby tournament for freshers, scheduled for Wed Sept 26th, to include a number of local schools as their way of reaching out to the local community for Dublin Sportsfest.

NEIC

The Senior Sports Development Officer working in the area is currently exploring the possibility of delivering an Olympic Handball event and a special 'Gaelic for Mothers & Others' Programme during the week of Sportsfest.

Sports History

As part of the Festival of History, a talk on the 'Impact of World War 1 on Sport in Ireland' will take place in Pearse St. Library on Sept 29th. The organisers are happy for this to be added to the Dublin Sportsfest schedule. The possibility of doing some kind of a Sport History Cycling Tour is also being looked at.

• Sport for Young People – Small Grants Scheme

The aim of the grant is to increase participation by young people throughout Dublin City in sport and physical activity. Grants were advertised in mid-May via email to Clubs and Sports Contacts, newspaper advertisement and via social media. Deadline for receipt of applications was Friday, June 29th at 4pm.

• Bike Week (9 – 17 June)

Bike Week is a National initiative that took place from the 9th to 17th of June. Dublin City Sport & Wellbeing Partnership sourced funding via the Environment & Transportation Department and used this to deliver a number of bike related activities across the city during this week.

During Bike Week, the Sport & Wellbeing Partnership launched 2 new Bike Hubs which have been established at Dublin Municipal Rowing Centre, Islandbridge and East Wall Water Sports Centre.

• The Green Scene

Dublin City Sport & Wellbeing Partnership is putting together a schedule of activities to take place on Green Spaces around the City during the summer months. Activities will comprise of multisport and more general physical activity to target various demographics within the community.

Schedule of activities to be finalised. Please contact your local Sport Officer for more details.

• Go for Life Games (Older Adults)

The Go for Life Games involve three sports that can be played in singles, pairs and teams: Lobbers - adaption of Petanque and Boules Flisk - adaption of Frisbee and Horseshoe Pitching Scidil - adaption of Ten-Pin Bowling and Skittles The emphasis of the Games is on participation and fun. They are played in a non-competitive way (as much as possible!) with participants encouraged to umpire their own game.

The aim of the Go for Life Games is to involve older people in recreational sport. The National Finals (June 9th) took place in DCU and were run by Age & Opportunity with the support of Local Sports Partnerships and the HSE.

In the lead-up to the National Finals, DCSWP Sport Officers organised Regional Finals (Northside & Southside) in addition to delivering an ongoing League and Friendly games. The Southside Finals took place in Sport & Fitness Ballyfermot on 23rd May and the Northside Finals took place in Cabra Parkside on 24th May.

• Move for Health - Strength, Balance & Fitness Class for Older Adults

Are you interested in improving your *strength, balance & fitness* in a fun social environment? If so this class is for you. A qualified instructor will take you through a series of gentle exercises once a week for 10 weeks. This initiative is a collaboration between Dublin City Sport & Wellbeing Partnership and HSE Primary Care Physiotherapy Teams. Boxing

The *Startbox* Initiative, a partnership between the IABA and Dublin City Sport & Wellbeing Partnership, represents an ideal way for young people (10 - 17 years) to first engage with amateur boxing, Ireland's most successful Olympic sport. It is delivered by our 5 dedicated IABA/DCSWP Development Officers via local schools (primary & TY level) in communities across the Dublin City area. Approx 2,000 young people take part each year.

The Programme is structured into Bronze (non contact), Silver and Gold phases. The first two phases focus on general strength & fitness, method and technique. The Gold phase introduces an element of contact to those participants who have displayed a particular talent & enthusiasm for the sport.

During the Summer months the IABA/DCSWP Development Officers take a break from *Startbox* to deliver an Olympic Values Education Programme in June. It includes 3-D Printed exact replicas of various Olympic medals. July & August are geared towards the Startbox Aviva Stadium Experience (which includes a stadium tour). These innovative programmes are aimed at primary schools for their end-of-term trips (OVEP) and then latterly to Youth Projects & Summer Camps throughout June & July. Groups attending this month include the Dublin North Central Mental Health Service, the Hay Project, St. John of Gods, Stoneybatter Youth Services, Bradóg Youth Services & NYP2.

Rowing Development officer Report

• Get Going ... Get Rowing - General

This initiative, jointly supported by DCSWP, Sport Ireland, Healthy Ireland, Active School Flag & Trinity College, has been successfully rolled out for a number of years by Rowing Ireland's Leinster Women's Development Officer, Michelle Carpenter. This is a 4/6 week school's programme for girls (second level). Rowing Ireland provide rowing machines and a community coach to the schools.

A Transition Year Programme compliments the above by giving students the opportunity to get on the first step of the coaching ladder and enabling them to be involved in a youth leadership role, working in a fun and interactive environment with younger students who will be taught values such as fair play, respect, dignity etc...

• 2017/2018 Review

So, we take stock of the *Get Going...Get Rowing* programme a few weeks from the end of what has been a bumper academic year in terms of introducing rowing to new schools and students.

We held our biggest ever #Blitzit event in Dublin City on Friday 10th November with over 900 students attending the third annual competition in Trinity College Dublin. We also had our #Blitzit *Splash and Dash* on the water in Grand Canal Dock on Friday 20th April 2018 which was a tremendous success. The sun shone, the weather stayed dry and we had 57 crews from our Dublin schools taking part, in addition to our partners who contested the partner's race. This event is the culmination of the indoor coaching and on-the-water sessions provided by the programme.

The *Get Going ... Get Rowing* programme will be complimented by Summer Camps for those students who wish to take their introduction to rowing to the next level and create a pathway to sport and physical activity for life.
