## MINUTES OF THE NORTH CENTRAL AREA JPC MEETING

HELD ON MONDAY 16 APRIL 2018

1 **Minutes of meeting held on 15th January, 2018**

Order: Agreed

2 **Parking and Traffic issues in and around access to the shops at Clare Hall - Tom Brabazon**

Order: Item deferred to next meeting 16<sup>th</sup> July 2018

3 **Safety Forum Updates:**

Order: Elaine Mulvenny and Deirdre Murphy updated the Committee on the local safety forums. Vanessa Carey had sent her apologies; Clongriffin/Belmayne report was circulated after the Agenda.

**Order:** Elaine advised The Edenmore Safer Forum was held on the 17th of January and the 21st of March and attended well by the local community on both occasions. At the January meeting Garda Eoin Beatty informed residents the Garda Clinic in Edenmore has been opened 36 times since it started. It was agreed at this meeting that Garda Beatty would notify the community group a few hours in advance of the clinic being open in order for them to advertise it on social media (this is now in practice). Cllr Gilliland commended the Garda Clinic in Edenmore and how it was a great addition to the community. There are two Community Garda assigned to Edenmore. Residents have expressed safety concerns regarding the drug problems, and anti-social behaviour issues of some tenants, the Area Housing Manager and Project Estate Officers will look into this anti-social behaviour

The Donaghmede Safety Forum was held on the 10th of January and 14th of March and is continued to be well supported by the local community. Most incidents of anti-social behaviour are concentrated around Howth Junction Dart Station, with the lift being a particular problem. However, the North Central Area has an excellent relationship with Iarnród Éireann and continues to work in conjunction with them and the Garda to resolve and alleviate the problems. The new lift system that is now in operation at the station is an example of this success. The volume of traffic and pedestrian safety issues regarding the Hole-in-the Wall roundabout in Donaghmede remain a source of major concern. The Grange Abbey residents have expressed their concerns around this issue due to the new development on the former Columban Missionary site.

Deirdre advised Joy-riding and burning out of cars continues to be a major issue in Darndale and a cause of concern for the residents. Since Christmas the Public Order Unit is deployed in Darndale every Thursday – Sunday. This issue has been raised at the JPC Local Strategic meetings where Superintendent Donnelly suggested if using pre-cast

concrete barriers like those used during road and motorway works could form part of a solution to this ongoing criminal behaviour. A meeting is to be arranged in the coming weeks with the transportation department and the local Parks Management to ascertain if these can be used. If such barriers are available it is proposed to trial this arrangement for a period at one of the worst access sites in the vicinity of residents' homes. Deirdre has been in contact with Roads Construction regarding the request for 4 new chicanes to go on the road from the Bell Building up as far as the dressing rooms in Tulip.

Cllr Moran advised that residents are living in fear of joyriding, Cllr Gilliland spoke about the culprits wearing balaclavas to avoid detection. Ardmheara Mícheál Mac Donncha queried flexibility in terms of resources to prevent the anti-social behaviour. Superintendent Donnelly advised when patrol cars respond they are being smashed and stoned mostly by onlookers and the audience. That is why the Public Order Unit is in place for the last 5 months Thursday – Sunday. In this time 62 cars were seized under Section 41, 42 stolen cars recovered and 3 seized. Cllr O'Moore spoke about the request at the last JPC for extra resources. Chief Superintendent Curran advised there are 40 new Garda in the last 4 months recruited and there will be another 40 in June, altogether over the next 9 months there will be 80 new recruits. Cllr Mahon asked how many garda have been lost and how getting extra garda doesn't seem to be resolving the issue. Chief Superintendent Curran confirmed 10 or 15 have been lost and also it takes time to train the new recruits. Cllr O'Toole spoke about the design of the new houses in Moatview and if there is a link between the cameras in Darndale and Coolock. Aidan spoke about how the CCTV in Darndale is being enhanced and a link will be re-established back to Coolock Garda Station in the next week or so. Aidan will liaise with Superintendent Donnelly regarding this. Cllr O Toole also asked about scrambler bikes – where are they coming from, Superintendent Donnelly advised they are bought as Christmas presents or stolen. Dave Dinnigan advised it is difficult for the guards, they solve the issues in one area and the perpetrators move on to another, don't want the road network in Darndale looking like a hostile environment. **Dave will speak with Deirdre regarding setting up a campaign regarding scrambler bikes' coming up to Christmas.** Aidan also spoke about the formal process to interview tenants regarding anti-social behaviour and any reports received are dealt with formally.

#### 4 **Presentation on Case Management - Garda Valerie Brennan**

**Order:** Garda Valerie Brennan gave a presentation on Case Management. In DMR North there are over 150 garda trained in case management. In Coolock there are 13 targets/Profiles with 683 charges to date in total.

Garda Brennan answered a number of questions from the JPC Committee regarding: 1) criteria for selecting offenders for case management, 2) what happens if the Guard is transferred or leaves, 3) how the court system deals with case management and 4) are new Garda recruits in Templemore being trained on case management.

#### 5 **Garda report's -**

**Order:** The Garda discussed the statistics for DMR North. Superintendent O'Connor advised there is a big problem with people leaving their cars opens with laptops etc in them. Operation Thor, Hybrid, Creeper and 'Hi Viz' have contributed to operations, with designated checkpoints being carried out by both uniform and plain clothes units, which have helped in the detection of crime and high visibility policing throughout the Raheny/Clontarf Sub-Districts. There is a deficit of Sergeants and Inspectors, more of them are needed. Superintendent Donnelly is down an Inspector due to Colm Healy's promotion and transfer. Councillor O'Toole requested that on behalf of the JPC Committee to pass on our good wishes to Colm.

Superintendent Donnelly spoke about The TAG (Teenager and Guard) Programme aimed at promoting positive engagement between young people and the Guards held over last 3 months. Approximately 20 Transition Year Students participated in six sessions over a period of three months. This is the first time TAG has been done in the Coolock District. Chief Superintendent Curran advised that teenage engagement is very powerful. The Councillors had a number of questions for the Gardai 1) Will Inspector Healy be replaced 2) How has the Grow House case progressed? 3) Are there plans to re-locate

the HSE clinic in Darndale 4) Anti-social behaviour at the Stardust Memorial. Chief Superintendent Curran advised Inspector Healy will be replaced through the recruitment process, The Grow House case has progressed and there are 2 people in custody. The HSE make the decision in relation to the location of the Clinic in Darndale. Superintendent Donnelly advised no residents have made contact regarding anti-social behaviour at the Stardust Memorial, he will enquire re same. Cllr O'Muiri asked is there a reduction in the theft of tools from vans in the area. Superintendent Donnelly advised that there has been a significant decrease in the Coolock district. Regarding car theft most of those taken are older cars without immobilisers, new cars stolen are broken up and shipped abroad for parts. Cllr Moran asked are the stolen cars still coming out from the inner city, Superintendent Donnelly advised they are not.

**6 CCTV Raheny - Elaine Mulvenny**

**Order:** Elaine advised DCC are trying to identify the culprits in Raheny responsible for the anti-social behaviour. DCC are going to see how the CCTV enhancements in Darndale work out and will implement something similar in Raheny. The clinic in Edenmore is a success.

**7 North Central JPC Sub Committee Draft Plan 2018 - For discussion (Plan to follow)**

At the meeting Deirdre circulated the Draft work Plan 2018 to the committee and advised she will e.mail them within 2 weeks to see if they are in agreement, or if they want to make changes.

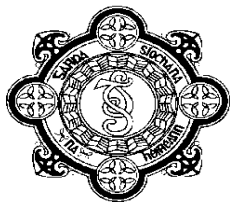

<p><b>Crime Prevention Matters and Other Information</b></p>	<p>(A) Operation <b>Thor, Hybrid , Creeper</b> and <b>‘Hi Viz’</b> have contributed to operations, with designated checkpoints being carried out by both uniform and plain clothes units , which have helped in the detection of crime and high visibility policing throughout the <b>Raheny/Clontarf Sub-districts</b>.</p> <p>(B) Investigations into major incidents are ongoing and there have been several successful operations, as well as <b>successful Court Prosecutions</b> in this quarter.</p> <p>(C) <b>Anti-social behaviour</b> is being tackled through targeting local amenity areas during the summer months and there are also several area’s being designated as <b>‘Hot Spots’</b> and high visibility policing, whether it is members on foot patrol or on Mountain bike patrol have led to successful increase in Public Order detections throughout the District. <b>School Talks</b> are carried out with an emphasis being put on <b>Cyber Bullying</b> and for Juveniles to be aware of supports which are there if they find themselves victims of this type of crime. There also has being the implementation of a Garda Youth Development Project in the Kilbarrack/Raheny Area and the Donnellycarney Area.</p> <p><b>Call back initiatives</b> have been put in place for persons who are victims of <b>Burglary incidents, Domestic Violence incidents and Sexual Assault incidents</b>. The victims of crime are visited and given crime prevention and security advice from members, this has proven to be quite successful and greatly appreciated by the persons’ concerned. There also has been the implementation of a Pedal Cycle Identity Card which has proven to be very helpful in combating theft of Bicycle Crime.</p> <p><b>An ‘Older Person’ strategy</b> has also been developed and several Christmas parties were held throughout the District by Community Policing members.</p> <p>(D) There are <b>7 Garda Reserves</b> allocated to Raheny/Clontarf Sub - Districts and Policing of amenity areas required an increase in Garda Resources at varying times in the summer to help Police the area.</p> <p>(E) There is <b>1 Sergeant and 6 Gardai</b> attached to Community Policing and they have all Neighbourhood watch schemes in operation in their designated areas, they are all ELO trained and Mountain Bike Operatives. - engage with locals in the North Central area who have a genuine interest in and passion for motocross to explore ways of eliminating the use of scrambler and quad bikes in our public parks and residential estates.

## **Work Plan 2018**

### **North Central Area JPC Sub Committee**

#### **1.0 Background**

- 1.1 The revised JPC Guidelines (April 2014) has a requirement to develop six year and annual strategic plans. It is now a requirement that such plans be linked directly to the Dublin City Council's Local Economic and Community Plan (LECP) and to the Citywide JPC. The LECP and Citywide JPC strategy identified 3 strategic objectives for the North Central Area JPC Sub-Committee.

##### **Strategic Objectives:**

- I. Community Safety – Policing - Joy-riding, CCTV, Crime data**
- II. Anti-social behaviour – joy-riding/burning out of cars, business night time economy**
- III. Street crime/issues – graffiti/dumping**

- 1.2 This North Central Plan JPC Sub Committee Plan provides for 2017.

#### **2.0 North Central JPC Plan main objectives**

This plan provides for:

- a) Statutory compliance,
- b) Consultations and recommendations between elected representatives and community and business,
- c) Reviewing the levels and patterns of crime, disorder and anti-social behaviour (including the patterns and levels of misuse of alcohol and drugs),
- d) The factors underlying the levels of crime, disorder and anti-social behaviour in the area,
- e) Advising Dublin City Council and the Garda Síochána .
- f ) and the JPC Sub Committee will support and monitor the four local policing fora and their recommendations.

#### **3.0 Overview of JPC Sub Committee approach and achievement focus**

- 3.1 The main purpose is to contribute to a safer North Central Area with the emphasis on;
- a) Joint partnership approach to achieving safer community gains and conveying views to Garda Divisional management,
  - b) Policy and evidence based with pragmatic approaches and solutions,
  - c) Positive messages be transmitted while problems are addressed,
  - d) Build on the experience to date and mindful that objectives are often achieved using a small focussed group of people.

- e) Influencing local policies, plans and regulations & making recommendations to vary bylaws and legislation.

#### **4.0 Meetings of Area JPC Sub Committees and Local Community Police Fora 2017**

- 4.1 There will be four meetings of the JPC Sub Committee and meetings every 2 months of the Safer Forums (Local Police Forums). Details are in the appendix. Times and dates will be circulated in advance of all local police forum meetings to councillors, business, community and other organisations members.

#### **5.0 Actions Arising: (The new guidelines advise on at least 4 high priority objectives).**

- i. Crime prevention - Joy-riding, burning out of cars, CCTV  
- Park and open space safety (quad/scrambler bikes).*
  - ii. Garda reports outlining crime data.*
  - iii. Anti-social behaviour/street crime - graffiti/illegal dumping and burning of same.*
  - iv. Advice on home burglaries and robberies of business premises – support for crime victims.*
- 5.2 A separate report will issue on each of the three Citywide JPC strategic themes :
- i) crime/police data (suggestions and issues are invited before review commencement),
  - ii) night time (suggestion and issues are invited before review commencement)
  - iii) graffiti/dumping ( work in progress).
- If possible a sub-group should be established to assist in the report and expressions of interest are welcome at this meeting.

#### **5.3 Action areas suggested are:**

- a) Joy-riding/burning out of cars Through Safety Fora meetings, JPC Local Strategic meetings and JPC meetings this issue will be addressed.
- b) Anti-social behaviour, litter and graffiti black spots  
Reports and actions on persistent anti-social behaviour, public order, and graffiti black spots through the Safer Forums.
- c) North East Drugs Task Force co-operation  
The NEDTF will be invited to raise items and provide reports including at Safer Fora.  
Local Police Forum reports to JPC  
Forum reports will be presented to the JPC meetings at every other meeting.
- d) Increasing business involvement with JPC  
Through the DCC North Central Business Fora and other means , efforts can be made to increase an input from business to the JPC structure.
