The Chair extended her congratulations to the 3 former Councillors of this SPC who were elected to the Dáil, Jim O'Callaghan, Kate O'Connell and Seán Haughey. A special meeting of the City Council to co-opt members on to the various committees will take place on Wednesday 16th March 2016. This SPC will have 3 new members.

1. Minutes of meeting held on 11th January 2016

Action: Agreed

2. Draft Report on revision of Street Performance Bye-Laws 2016

a. Revised Street Performance Bye-Laws 2016 (Draft)

b. Submissions

After a discussion it was decided to defer this item as there was not a full complement of members until the 3 new members are co-opted on to this Committee. It was agreed to set up a forum to consider the report before the next SPC meeting consisting of two people from each of the interest groups i.e. residents, buskers, businesses and including members of this SPC.

Cllr O'Farrell requested a report on the public consultation process carried out by DCC on this issue.

Action: Set up Forum to report before the next SPC meeting. Meeting to be convened as soon as possible.

3. Report on Filming in the City

Management informed the members that the Facilitator engaged to complete the consultation process has not quite finalised her report. It is now believed that a suitable revised framework for the regulation of filming in Henrietta Street can be implemented and that we can move towards lifting the current moratorium on the granting of filming permits.

There is already a Code of Practice for the regulation of filming in Dublin City as agreed between Dublin City Council and the Irish Film/Television sector and some time ago a special and additional set of guidelines were agreed for filming in Henrietta Street. It is now proposed that any new agreed procedures/rules coming out of the this facilitated process should be integrated into these two documents thus creating a revised single and comprehensive Code of Practice for the regulation of filming in Dublin City (with a specific emphasis on Henrietta Street). It was noted that a stronger regime of monitoring and enforcement will be implemented.

Action: Draft Code of Practice to be brought back to this Committee.

4. Report on Implementation of Cultural Strategy, Ray Yeates, City Arts Officer

Ray Yeates gave a verbal report on the implementation of the Cultural Strategy to date. The new Cultural Strategy for Dublin City Council (adopted January 2016) is made up of a series of long term priorities and actions over five years to achieve the purpose of the strategy to reposition culture and cultural expression as a corporate priority.

Sixteen long term actions are set out in Dublin City Councils Cultural Strategy from Communication to Education and local neighbourhoods.

This will be a standing item on this Agenda.

The Chair informed members that a large number of submissions from Arts Organisations were submitted for the Development Plan and suggested an informal meeting be convened to discuss ideas and motions in relation to the arts.

Action: Keep on Agenda.

5. Report on Dublin City Local Economic and Community Plan 2016 - 2021

In December 2015 Dublin City Council agreed and adopted this plan.

The Dublin City LECP is made up to two documents:

- A six year strategy document outlining the rationale and context for each of 12 high level goals.
- An Action Plan for 2016 with specific objectives and actions relevant to the LECP high level goals; the Action Plan will be updated annually during the lifetime of the Plan.

This will be a permanent agenda item setting out all goals and objectives from the LECP that are relevant to the work of this SPC.

Action: Keep on Agenda

6. Temple Bar Cultural Trust - New Vision – Terms of Reference and Membership

It was agreed to set up a Committee consisting of 4 members from this SPC and 4 members from the Economic Development and Enterprise SPC to oversee an overall new vision for Temple Bar. Cllr R. Moynihan (Chair), Cllr C. Byrne, Cllr. S. McGrattan and W. White will participate on this Committee. It was also agreed to have 2 Councillors from the South East Area.

Draft Terms of Reference are set out in the report of the Assistant Chief Executive. It was recommended that this Committee be immediately established and that the Group should consider and finalise these draft Terms of Reference with a view to initiating a Public Procurement process to select a suitable consultancy team for this important commission.

Action: Establish Committee as soon as possible. Amend report to include 2 Councillors from the South East Area and agree draft Terms of Reference.

7. Motion submitted by Cllr Mary Freehill:-

"In the interest of protecting Temple Bar Cultural Quarter that all monies accrued from sale of Buildings be ring fenced by the City Council for exclusive use in the TBCQ. This is to ensure that the area's cultural quarter will be properly maintained and developed which is in line with the original purpose of the area and basis for receiving EU funding. Furthermore to ensure prudent management of this fund that a working group be established by the SPC to provide a strategic plan for the governance and viability of the area"

A discussion took place regarding accrual of monies made from the Temple Bar area being ring-fenced for exclusive use for Temple Bar Cultural Trust. It was stated that future monies made from the sale of properties in Temple Bar should be ring-fenced for the Temple Bar area.

Management clarified that the Temple Bar Cultural Trust Board has agreed this principle but it will be a matter for the full Council to decide on what issues within Temple Bar such funds would be expended on e.g.

- Maintenance / sinking fund for T.B.C.T. owned cultural buildings
- Improvement of the public domain areas in Temple Bar
- Possible purchase of other sites / buildings in Temple Bar

Action: Motion agreed

8. Presentation on Draft Tree Strategy – Marc Coyle, Asst. Parks Superintendent

Marc Coyle gave a presentation. The Draft Tree Strategy aims to provide a coordinated approach to the management of the city's trees which will promote a vision of a capital city where public trees are managed effectively and sustainably to enhance the city environment in which to live, work and visit.

The Draft Tree Strategy will go out to Public / Stakeholder Consultation from the beginning of April with a deadline date of Friday 29th April 2016. All observations / submissions can be e-mailed to <u>treestrategy@dublincity.ie</u>

Action: Go to public consultation for a 4 week period. Come back to this SPC in July for approval.

The Chair suggested that Items 9 and 12 be taken together.

9. Presentation on Library Service Developments – Brendan Teeling, Deputy City Librarian

A number of new digital services are now available to users of Dublin City Public Libraries including eBooks and eAudiobooks, Zinio Digital Magazines, Mango Online Language Learning plus Free Online Training.

Action: Welcomed and noted.

12. Report on the proposed new City Library at Parnell Square Margaret Hayes, Dublin City Librarian

Dublin City Librarian informed the Committee that they are currently awaiting approval of the Stage 2(a) report by the PSCQ Foundation. It is hoped to bring a sketch design presentation of the project to the next SPC meeting in May.

Action: Presentation to the May SPC Meeting.

10. Management Update

Members asked numerous questions under this Item. It was suggested that relevant staff contact the members directly with replies.

Action: Relevant staff to contact members directly with replies.

11. Report on Draft Dublin City Parks Strategy – Ciaran O'Neill, Senior Executive Landscape Architect

The Parks and Landscape Services are currently finalising the draft of the first Dublin City Parks Strategy.

The strategy in summary looks at the wide range of resources and services under the Parks Services portfolio and determines policy and arising actions to seek the vision of a greener and more livable Dublin.

The draft strategy will be open to public consultation this year before being finalised at SPC for approval.

Action: Go to public consultation before being finalised at this SPC.

13. Report on Draft Invasive Alien Species Plan for Dublin City.

Following a presentation to the SPC at the January meeting, Dublin City Council Invasive Alien Species Action Plan (2016-2020) was approved to go to public consultation which ran from 22nd January to 12th March 2016. Arising from this consultation, four replies were received and have been replied to. One amendment was made to the draft document based on a request from the Office of Public Works to be included as a key landowner in future implementation in cooperation with the City Council. **Action:** Approved.

Report on filming in Henrietta Street

Members will be aware that following serious difficulties in relation to filming in the Henrietta Street area Dublin City Council implemented a six month moratorium on the granting of permits for filming in this very important and historic street.

Immediately after the moratorium was put in place we commissioned an Independent Facilitator **(Ms Yvonne Thunder**) who has undertaken a very comprehensive consultation process with all the various stakeholders including the residents and residents on the street.

It is very clear from the report of the facilitator that production companies and their crews did not always adhere to the various conditions set out in their filming permits granted by Dublin City Council or in accordance with the Code of Practice and partnership that had been developed between Dublin City Council and the Film Industry. This non adherence has been particularly prevalent in relation to filming in the Henrietta area. We welcome the ready acceptance from the Film Industry (as outlined in the facilitators report) that the existing Code of Practice was not working properly.

While it had never been intended that Dublin City Council would provide an intensive monitoring and enforcement regime for filming in the city or indeed for Henrietta Street because the Code of Practice was supposed to be self regulating and filming was to be compliant with the conditions of the permit/s. It is very clear now that Dublin City Council will have to implement a strong monitoring and enforcement role on any new Code of Practice/Guidelines for filming particularly in areas of historic and environmental importance, such as Henrietta Street.

Accordingly it is proposed to implement the following:

The existing Code of Practice/Guidelines for filming in the city (which has a specific set of conditions for Henrietta Street) has been thoroughly reviewed, revised and strengthened (Copy attached)

All the recommendations from the facilitator (see attached) are now embedded in this new Code.

We are proposing an increase on filming charges for Henrietta Street only (A premium of 25% on top of existing fees) and that such fees will be ring fenced for enhancement work on the Public Domain area of Henrietta Street.

We have appointed a full time Filming Liaison Officer (**Ms Lynn Daly** in our Events Section) to monitor and enforce the new Code of Practice/Guidelines and to work closely with both the Film Industry and local interests including residents.

With any enforcement process there has to be penalties for non compliance and therefore it is proposed that Dublin City Council will consider withdrawal of a permit granted where full compliance is not being adhered to or refuse to give a new permit where there were previous problems.

We very much recognise the importance of the Film Industry in this country particularly in Dublin City and we want to support and facilitate it as much as possible. In doing so, we will work closely with the Locations Guild of Ireland, Irish Film Board and Screen Producers Ireland and others. But we do have to balance this positive activity with the needs and convenience of local residents and business at the various filming locations in the city and hence this new Code of Practice and Guidelines.

The existing moratorium on the granting of permits for filming at Henrietta Street will be lifted next week.

I recommend to this Strategic Policy Committee that the attached revised Code of Practice/Guidelines for filming in Dublin City be approved.



Report on Implementation of Cultural Strategy

Priority 2

To increase cultural participation and practice through:-

Conduct cultural audits (qualitative and quantitative) in all city areas paying particular attention to developing cultural clusters, in the context of the revised development levy funding.

This specific action of the City Council Cultural strategy is included in the latest draft of the City Development Plan.

A Cultural audit was conducted in Docklands as part of the SDZ process and has proved valuable in identifying deficits in cultural provision and opportunities for private sector funding through the Docklands Arts Fund.

A Cultural audit seeks through a combination of quantitative and qualitative research to list the cultural assets and deficits of a defined city area. Given the Unesco definition of Culture as adopted by Dublin City Council is:-

"the set of distinctive spiritual, material, intellectual and emotional features of society or a social group, that encompasses, not only art and literature, but lifestyles, ways of living together, value systems, traditions and beliefs". (Unesco 2001)

It follows that these cultural audits will include all aspects of Culture from the Boxing Club and all other sporting activities to artistic initiatives and organizations to Arts in Schools, Public Art, Libraries, Community Halls and as importantly not just 'hardware' but the 'software' skills and professional ability locally or not yet available. Audiences and Audience Development, Participation Education and Learning as well as opportunities for professional cultural practitioners will feature in the audits. The audits are intended to guide Dublin City Council in the area of Cultural Development and to embed cultural provision throughout communities. As part of the Development Plan if these cultural audits are comprehensive and identify deficits, they could become a consultative tool in Public/Private Partnerships helping citizens to have their areas become cultural destinations as well as impact local quality of life. The impact of cultural expression on tourism, economic development and as an alternative to anti social activity is well documented.

The audit should set out realistic goals and achievable targets guided by Dublin City Council.

Given the scale of work required due consideration is being given to the quality and quantity of the resources required and the brief needed by the Auditors to be commissioned.

The Dublin City Local Economic and Community Plan 2016 – 2021 (LECP)

The Dublin City LECP sets out twelve high-level goals for the six-year period of the Plan. The goals were identified through public and stakeholder consultation undertaken in 2015. Each high-level goal contains a number of specific objectives and actions to achieve those objectives planned for 2016. The monitoring and review of the Action Plan is the responsibility of the Local Community Development Committee (Chaired by Councillor Daithí Doolan) and the Economic Development and Enterprise Strategic Policy Committee (Chaired by Councillor Paul McAuliffe). Each of the goals and objectives has been attributed to the relevant SPC. This report sets out the goals and objectives that will be permanent agenda items for this Arts, Culture and Recreation SPC. Actions under these goals and objectives will be reported on by the Arts Office, Libraries, Galleries, Sports Development and Recreation, Culture and Parks and Open Spaces as appropriate.

High-Level Goals and Objectives for the Arts, Culture and Recreation SPC



Goal 1: Ensure that all residents and visitors, regardless of social or cultural background, feel a sense of ownership and engagement with the City, feel safe in their communities and are welcome to fully participate in the community, social, cultural, business and political life of the City.

• Objective 1.1 Enhance quality of life in the City by supporting individuals and groups to actively participate in their communities



Goal 2: Work in partnership with communities to promote social inclusion, tackle poverty and disadvantage, and promote participation, empowerment and positive social change.

Goal 6: Maximise opportunities and support for the creative industries and cultural and artistic sectors to develop. Promote the Irish language and access to cultural experiences for all through the provision of diverse cultural artistic programming.

- Objective 6.1 Promote the development of the creative industries, bringing together individuals, organisations and businesses for the development of the sector
- Objective 6.2 Develop and promote a community based infrastructure to encourage the use of the Irish language
- Objective 6.3 Enhance participation in arts and cultural activities and events with access for all
- Objective 6.4 Promote the Decade of Commemorations in the City



Goal 7: Identify and support the growth sectors such as tourism,

technology, food chain, education, retail and green business that will create, sustain and grow quality employment and self-employment opportunities for all.

• Objective 7.1 Identify and support growth sectors

• Objective 7.2 Sustain and grow quality employment and self-employment opportunities for all



Goal 8: Promote access to a range of education, training and developmental opportunities starting in early childhood, leading to a culture of lifelong learning and an appropriately qualified and skilled workforce.

- Objective 8.1 Promote and support quality early childhood and education supports for children, including supporting parents, early year's practitioners and teachers to help children achieve their full potential
- Objective 8.3 Enhance access to and awareness of lifelong learning opportunities for adults
- Objective 8.4 Provide targeted training and educational opportunities to match current and future skills needs



Goal 12: Enhance the recognition of Dublin as a globally connected city region and as the national economic generator.

- Objective 12.1 Build mutually beneficial economic and other links with key cities globally, while also continuing to bid for, and host, leading international events and festivals
- Objective 12.3 Promote Dublin as a dynamic and resilient place to do business

PROPOSED NEW CITY LIBRARY, PARNELL SQUARE

Project Stage 2(a) Sketch Design

We are awaiting approval of the Stage 2(a) report by the PSCQ Foundation. A sketch design presentation of the project will be brought to the SPC meeting once the approval process is complete.

Site Investigations for the project have been approved and a commencement date will be issued shortly.

Digital

The City library will unlock the opportunities offered by new digital technologies to expand the potential of the library's rich resources, providing the engine for enhanced service delivery throughout. The library will be saturated in digital potential. It will be as fundamental to service delivery as the collections and the staff. To ensure that the design of the library's digital infrastructure is able to keep pace with user expectations a digital advisor is working with the library team to develop the ICT brief.

Music


Representatives from *First Music Contact* and *Music Network Ireland* were briefed recently on the elements of the Music Hub. It is intended that an advisory/consultation group will be drawn from the music community, covering all genres and the areas of music learning, composition and performance, linking strongly to our themes of *Learn Create Participate*.

Pilot music project

The Central Library, in partnership with Mount Carmel Secondary School, has arranged a 10 week violin tuition course for 8 transition year students. The course has been running for 3 weeks and the music tutor reports that the students are engaged and enthusiastic about learning this instrument. The Library acquired 10 violins and these are on loan to the school for the duration of the course. This initiative represents an important step in preparation for the music hub facility in the Parnell Square Project as it builds local links and provides students access to music in a way that was not previously available. It offers the library service an evidence based approach to developing this service. This will be strengthened in the PSQC development.

The overarching aim of the plan is the conservation of biodiversity within the city which reflects the Strategic Objectives of Ireland's National Biodiversity Plan (Actions for Biodiversity 2011-2016). RTÉ Radio One's *The Dawn Chorus* has become a radio phenomenon in Ireland. Every summer, for more than two decades, Derek Mooney and his *Mooney Goes Wild* team have broadcast the sounds of early morning birdsong into Irish homes on RTÉ Radio One, the main national radio station. This year through collaboration with other European countries, the Dawn Chorus will be broadcast across Europe across countries including Russia and Norway. Fourth World Congress of Biosphere Reserves, Lima, Peru



The Dublin Bay Biosphere Coordinator, Dr Jenni Roche, attended this event in March 2016. She delivered a talk on our work to over 1,000 delegates and was a speaker on the panel in a workshop on Branding and Communication, thereby raising the international profile of Dublin Bay Biosphere. She made numerous contacts including staff of the UNESCO MAB Secretariat, the International Coordinating Council and other Biosphere Coordinators from all over the world. The Lima Action Plan for UNESCO's Man and the Biosphere Programme and its World Network of Biosphere Reserves 2016-2025 was developed and adopted http://bit.ly/1qFy5XY and will be influential in the management of Dublin Bay Biosphere. New Biospheres were designated, including our neighbour the Isle of Man, bringing the World Network of Biosphere Reserves to 669 sites in 120 countries.

Dublin City Council and the Department of Children and Youth Affairs worked in collaboration to host a 1916 themed *Children's Play* **Day** on Easter Monday, 28th March in Merrion Square Park as part of the hugely successful RTE Reflecting the Rising event programme in Dublin. Thousands of families attended this free programme of fun, games and entertainment in the Park where children had the opportunity to

play the games that children played in 1916. The *Children's Play Day* included children's street rhymes and games, including, marbles, penalty shoot-outs, relays and obstacle courses. The event also tapped into children's imagination with creative messy play, art, and bugs n beasties, dress up, kite making and the opportunity to perform their *party pieces* through drama games. Young and old enjoyed bouncing around on a giant inflatable donut, giant nests were built as children created their own play spaces while some children created handmade skipping ropes which were used for traditional skipping games.

From it's opening night in The Mansion House with Irish Chamber Orchestra, through to Trad Rising showcasing top young traditional musicians, Opera Theatre Company performing Handel's Ariodante in St. Patrick's Cathedral , MusicTown with over 60 events, enjoyed by over 11,000 people, showcased the vast musical talent and vibrant musical culture that permeates the City. Fáilte Ireland supported the development of festival, conducting audience benchmarking research. Plans are already underway for next year's festival to be held April 7th – 17th April 2017. We will shortly be announcing a new commissioning strand and a call for proposals. In the meantime, as part of the Arts Office Bealtaine programme, Mary Coughlan's *House of III Repute*, developed as part of MusicTown, will tour to community venues throughout the city.



The LAB Gallery exhibitions programme

Artists John Beattie and Sabina Mac Mahon were invited by the LAB, in collaboration with The ESB Centre for the Study of Irish Art (CSIA) and the National Gallery of Ireland (NGI) to explore the concept of visual commemoration in relation to the history of the 1916 Easter Rising drawing on significant events such as the National Gallery of Ireland's 1966 exhibition Cuimhneachán 1916: A Commemorative Exhibition of the Irish Rebellion 1916, which marked the Golden Jubilee of the Rising, as a source of critical analysis. PERFORMING NGI.988, the resulting exhibition, features an ambitious new work developed over the past year. The exhibitions received a 5* review in the Irish Times. A public seminar exploring history, art and myth making in relation to 1916 will be held at the National Gallery in May.

Arts, Education and Learning Policy – DRAFT

Dublin City Arts Office *Draft* Arts, Education and Learning Policy has being circulated for input from key external and internal strategic stakeholders from formal, non formal and informal education. Responses are being collated and the final document will be presented to the Arts and Cultural Advisory Group on 16th May.

Visual Thinking Strategies Beginners Practicum Training – 14/15 April @ The LAB

Dublin City Council (DCC) and the National Council for Curriculum and Assessment (NCCA) partnered on this exciting pilot training initiative that aligned with both organisations objectives in building visual thinking and increasing access for children and young people to the arts in their local community.

Participating galleries included – The LAB Gallery, Dublin City Gallery, the Hugh Lane, Oonagh Young Gallery and Artbox. A group of 28 participants (art teachers, primary teachers, gallery educators, artists and staff from DCC and NCCA) were introduced to a new approach to learning called Visual Thinking Strategies, by lead VTS trainer, Yoon Kang O'Higgins.

The LAB Gallery has been leading the testing of this method within its local arts-in-education initiative Project 20/20. Here are some short films about this work to date with Lynn McGrane, Jenny Brady and partner school, Central Model Primary school.

Young People from across the city gathered at LIFT Youth Arts Festival to represent youth arts and unpack the developmental process of working with young people across different artforms. Young Dublin aims to support young people in the development of their artistic practice in and out of schools and to listen to what young people have to say about arts and culture in Dublin City. One aspect of the project includes a publication entitled 'Arts and Culture in Dublin City: Conversations with a Dozen Young Dubliners' which sets out to understand how a selection of young people, aged 12-18 years, engage with arts and culture in Dublin City.

DCC 1916 Rising centenary programme

The 1916 Commemorations Programme continues with full details on the website at <u>http://www.dublincity.ie/decadeofcommemorations</u>.

The commemoration programme of lectures and talks in branch libraries finished in mid-March 2016. Preliminary figures show that 1,725 people attended the talks.

There were four performances of the special commissioned play 'Mid-wife of a Nation', highlighting the role of women in 1916 Rising. The show had its premiere in Ballyfermot Library and has been very well received.

Cllr Michéal Mac Donnacha, representing the Ardmhéara, launched 'Little Stories, Little Prints' in the Central Library on 15th March. The exhibition shows responses by print-makers to the commemorating of 1916. Three print-making workshops were held in the Central Library during April for Friends of the Elderly, St. Michael's House and for Bolton Street College students. The exhibition will be on view at Rathmines Library during May.

Dublin City Public Library staff promoted services, photographic collections and the libraries and archives commemorative programme at the *Reflecting the Rising* event in Smithfield on Monday 28. It was a fantastic day where staff mingled with re-enactors and musical performers to recreate atmosphere of 100 years ago. This event featured on RTE news.

GARRISON PLAQUES

A series of unveiling of new commemorative plaques at 1916 Garrison sites is underway. The first two plaques, at Marrowbone Lane Garrison and the Mendicity Institution Garrison, were unveiled by the Ardmhéara on 24th April, the 100th anniversary of the start of the Rising. The ceremonies involved a Colour Party from the Air Corps, councillors and large numbers of relatives of those who fought at these garrison sites.

My Area in 1916

In this project second-level students in six schools have been working with an historian to research their locality in 1916.

The students have collaborated in the production of a book which will be launched on 19th May at Ballybough Community Youth And Fitness Centre.

LIBRARIES MANAGEMENT SYSTEM (LMS)

Dublin City Council is the project manager for the implementation of a new Library Management System, Sierra, in all public libraries in Ireland. Ten novels are on the shortlist, including four novels in translation (from Brazil, France, Germany and Spain), *Academy Street* by Irish author Mary Costello, and novels from India, Jamaica and the USA. The winner will be announced by An t-Ardmhéara on 9th June.

The media promotion of the shortlist included an emphasis on the City Council's ownership of the Award and the dropping of 'IMPAC' from the name.

DUBLIN UNESCO CITY OF LITERATURE

The UNESCO City of Literature office is resourced by Dublin City Council and managed by the public library service.

One City One Book 2016

The Dublin programme of events for the *Two Cities One Book* festival was launched by the Ardmhéara in the Mansion House on Wednesday 9th March. Events include a coach trip for 100 people to Belfast on Saturday 16th.

Sport and Wellbeing Partnership - Activities

Late Night League and Cross City Final

The Late Night League (LNL) is an initiative funded by Irish Public Bodies Insurance (IPB) and driven by the F.A.I., An Garda Síochána, Dublin Local Authorities, Department of Children and Youth Affairs and Dublin Bus. It is aimed at engaging young people at risk in a healthy diversionary programme during prime 'anti-social' hours as well as improving relations between the Gardai and this often difficult to reach target group.

On Friday 8 April 2016 approximately 350 players from 20 Greater Dublin 'LNL centres' all travelled to Sport & Fitness Irishtown, Ringsend, Dublin 4 to partake in the Finals of the tournament.

The winners as were as follows:

- Under 16 Europa League: Leicester FC
- Under 16 Champions League: Whatever FC
- Over 16 Champions League: Donabate FC

Besides the natural competitive element of the Finals Night, the most sporting teams were also rewarded for 'good citizenship' behaviour with tickets for Ireland's upcoming match against Holland.

Lord Mayors 5 Alive Challenge

On Friday 15 April a presentation evening for participants of the Lord Mayors 5 Alive Challenge was held in City Hall.

The challenge consists of 5 races linked to the Dublin annual race calendar which are approximately 5Km in distance starting on New Year's Day in Phoenix Park and finishing on 2 April 2016 in St Anne's Park.

2016 has been the most successful year since the challenge began 4 years ago with 354 people taking part including the Lord Mayor Críona Ní Dhálaigh.

This initiative is a joint effort by the staff of the Lord Mayor's Office and the Dublin City Sport and Wellbeing Partnership.

Indoor Rowing School Blitz

On Wednesday 20 April 2016 the Indoor Rowing Blitz took place in City Hall. On the day, approximately 200 children (170 Primary School and 30 Secondary School) competed against each other in their respective categories.

The Blitz was the culmination of an indoor rowing programme rolled out in 12 Primary Schools and 3 Secondary Schools across the city from January to April 2016 that enabled approximately 1000 children to row for the first time.

The programme and blitz was an initiative led by the Staff of East Wall Rowing Centre and supported by the Dublin City Sport and Wellbeing Partnership and Rowing Ireland.

Common Ground Project Summary

This project was first suggested during the visit to Orlando for the Florida Parks and Recreation Association Conference in 2015 which included number of visits to various Recreation Services throughout the City of Orlando, City of Lakeland and the City of Dunedin.

Due to the similarities in service provision contact continued on my return to Dublin and a number of ideas to continue and develop the relationship between the recreation services were discussed. It was decided that an initial small joint endeavour should be proposed and is currently being developed. To plan and implement a joint mirrored venture between Dublin City Council's Recreation Centres and the City of Orlandos' Recreation Centres.

St Laurence O'Toole's Recreation Centre, Sherriff Street, has been chosen as the site for the project. It will involve both children and senior citizens from the locality growing fruit and vegetables, and a major part of the project is the promotion of healthy eating and a healthy lifestyle. It is intended that a number of health and nutrition talks and classes will be provided.

DUBLIN CITY GALLERY THE HUGH LANE

2016 Programme – Artist as Witness in Society

The Artist as Witness in Society 1916-2016 programme for the gallery is very well received, with interest from local, national and overseas visitors.

Along with the rehang of the collections, audiences can view High Treason – Roger Casement, Our Kind by Alan Phelan, NO MORE FUN AND GAMES by Jesse Jones and our most recently opened exhibition, **Liam Gillick's** *What's What in a Mirror*

What's What in a Mirror was officially opened by Cllr. Micheál MacDonncha, (deputising for An t-Ardmheara Críona Ní Dhálaigh) on Wednesday 27th April at 6.30. Internationally renowned artist Liam Gillick's socially engaged practice involves an installation of eight desks and stools within the Gallery's transitional spaces.



Visitors are encouraged to sit at the desks write, read, check their phone or just look in the mirror – their backs turned to the art – either observing themselves or fellow visitors behind them. The desks are offered as sites of self-reflection and aesthetic absorption in this centenary of the 1916 Rising. Beside each desk is a hornet's nest, to symbolise the chaos that could ensue should it be disturbed.

The design of the desks is reminiscent of the revolutionary designs of c.1916, and audiences are invited to use the desks to reflect on the events of that time.

The artist Liam Gallic gave public talk on his work on Thursday the 28th April in the Sculpture Hall

This exhibition runs until 25th September 2016.

Fundraising

Having identified the need for strategic fundraising, the Board of Trustees engaged Mary Apied to compile research and produce a report recommending the optimum conditions and strategy for fundraising. Following consultation with Board members, members of Dublin City Council executive and staff members, the final report "Recommendations for fundraising" was presented to, and adopted by, the Board, at its meeting of 9th March 2016. The Development sub-committee of the Board is progressing action on the recommendations of this report and an update will issue to the next SPC meeting.

Marketing Partnership:

Recently established Dublin North Attractions Alliance (DNA) is a cooperative marketing partnership created for the benefit of all of its members. The goal is to promote Dublin's North City Centre as a must see destination for all international and domestic visitors to Dublin; to establish a primary discovery trail distinguished by the range and quality of authentic attractions unique and shared stories specific to this part of the city making it a compelling visitor experience. The primary stakeholders are Dublin City Council, Fáilte Ireland and Tourism Ireland.

Membership includes the Henrietta Street Dublin Tenement Experience (opening in Summer 2016), GAA Museum and Croke Park Stadium; Old Jameson Distillery; Glasnevin Cemetery; Botanic Gardens and the GPO.

"Dublin's DNA is a unique and fascinating trail comprising some of the city's most vibrant attractions that are a key not only to the character of Dublin city, but also to its people and the people of Ireland.

Visitor Numbers:

The hugely successful Easter celebrations saw 4,900 people visit the gallery. The gallery normally closes on Mondays (including Bank Holidays), in line with museum practice in Ireland, however we decided to pilot opening on Easter Monday. The outcome was that over 1800 people visited on Easter Monday. Following from that success, we are now proceeding to trial opening on the June bank holiday for comparison.

Our visitor numbers for the first three months of this year 1st January to 31st March are 51,614. This represents an approximate 15% increase on last year. The comparisons for the last three years are as follows:

2014: 45,3532015: 44,7372016: 51,614

We are piloting a new footfall counting system in partnership with Smart Dublin. This platform – Senseye, is a web based footfall solution which can be linked to apps such as weather and beaconing to better understand the customer and improve the customer experience. This free trial is for four weeks only, at which stage we will assess the cost/benefit of buying the service.

Refurbishment of 1930's wing

Meetings are ongoing with City Architects in preparation for the upgrade of the 1930's wing. The galleries in that space will close during refurbishment. In order to determine what other gallery closures may be necessary, we will take advice in relation to the impact of any works on the surrounding environment. It is hoped that works will commence in late 2017.

Acquisition

At its meeting of 9th March 2016, the Board of Trustees approved the recommendation of the Acquisitions, Loans and Exhibitions (ALE) subcommittee to accept the offer of a gift of a painting by Lilian Tomasco entitled "Lightly Lifting the Hidden Unfold 2015" (*see image on right*). This work is oil on linen and measures 152 x 139.7cm.

Liliane Tomasco is a professional artist whose original use of photography and moving image informs her painting practice.



The acquisition of Lightly Lifting the Hidden Unfold will advance the understanding of the place painting plays

in the contemporary art practice, enhance the gallery's contemporary collection of paintings and contribute to the continuum of still life painting in all of its formats represented in the gallery's collections from the late 19th century to today.

Education

School tours are a major feature in the galleries at this time of year as teachers programme pre-Leaving Certificate visits. Members of our panel of professional and experienced tour guides deliver these tours. Cost is €30 per tour.

Coffee conversations given by a range of lecturers are held every Wednesday at 11am. The conversations focus on a different art work each week. The relaxed and informal nature of these conversations has proved to be very popular with up to 30 people attending at any one time. The cost is \in 5 per conversation which includes a tea/coffee.

Childrens art classes, Sunday sketching, Life Drawing and mixed media workshops take place over Saturday and Sundays and are fully subscribed.

Events in the gallery

Dublin City Gallery The Hugh Lane collaborates with festivals and events in the city, by hosting elements of those festivals in gallery space, thus offering an added dimension for visitors to enjoy, and broadening the reach of the gallery.

Festivals that we are engaging with in the coming months are:

 24^{th} – 29^{th} May, spoken work project by STANO as part of the International Literature Festival Dublin

28th May 12.30 – 15.30 – Dublin Dance Festival - Ioannis Mandafounis & Aoife McAtamney will perform One One which will aim to connect with the audience through dance

The hugely popular Sunday at Noon concert series continues to draw a crowd. The programme celebrates its 40th year in operation this year. Entrance is free.

The event takes place on the $27^{th} - 29^{th}$ May from 11 a.m. - 6 p.m. approx each day.





We are reviewing the lamp post banner availability and will report on this at the next meeting. Cllr. 5. Naming of East Link Bridge

An application was submitted by Cllr Nial Ring to name the East Link Bridge after Tom Clarke, 1916 proclamation signatory. A letter of support from the Tom Clarke Memorial Committee was submitted along with a letter of consent from Helen Litton, who is the great niece of Kathleen Daly (Tom Clarke's wife).

Action: Application agreed. Prepare report to submit to the March City Council meeting for approval.

6. Amendment of Application Form

A discussion took place regarding amending the application form to ensure all applications are made in good faith and all information on the person / event to be commemorated are fully disclosed. Management informed members that an e-mail to the Asst. Chief Executive was received from Cllr Tom Brabazon regarding erecting a bronze type plaque inside the clubhouse of St. Laurence O'Toole G.A.A. Club. The proposed plaque was to include a copy of the Proclamation highlighting the signatories who were also members of the club. Also to be included are 80 members of the club who participated in the Rising. After a discussion it was agreed that this application does not come within the guidelines of the Dublin City Council Commemorative Plaque Scheme.

Management informed members of a number of plaques that SIPTU are looking to erect at various locations around the city to commemorate men and women who served with the Irish Citizen Army during the period 1913 – 1923. It was noted that the words "*with the support of Dublin City Council*" was on the plaque although no funding came from DCC towards the plaques it was felt that this wording should be removed if plaques proceed. 3. City Arts Office – Short brief on plans for 2016

City Arts Officer Ray Yeates gave an update on the strategies and plans for the Dublin City Arts Office for 2016. He gave a verbal update on the plans for the initiative with cultural partnerships between National Cultural Institutions, Local Area Offices and local communities. He also reported on plans to undertake cultural audits in the five local areas within Dublin City Council.

4. Dublin City Public Libraries – Report

Brendan Teeling presented an update on the Libraries Services including the commemorations programme for the 1916 Easter Rising, the Two Cities One Book and Library Service Developments. Brendan Teeling announced an initiative by Dublin city libraries called 'Borrowbox' to enable digital download of ebooks, audiobooks, newspapers and magazines. Gerry Kerr complimented the library service on this initiative, stating that it was a major breakthrough in increasing accessibility to libraries for those who find it difficult to visit libraries

5. Dublin City Gallery The Hugh Lane – Report

Barbara Dawson gave an update on the programme and events that the Hugh Lane Gallery have planned for 2016. She also highlighted consultation which is taking place regarding the official title of the gallery. This is being undertaken in response to the confusion arising from its present name.

6. Public Art

Ruairí Ó Cuív presented the Public Art Report.

- a. The proposal from the Arts Council to temporarily display a bust of Seamus Heaney in Sandymount Green to mark the 50th anniversary of the publication of Death of a Naturalist was supported. It was agreed that the period of display should be six months.
- **b.** The Group was informed of the removal of the sculpture *Mr Screen* by the IMC Cinema Group. This sculpture by Vincent Browne was commissioned as part of the Dublin Millennium Sculpture Trail, 1988 and sponsored by the Sculptors' Society of Ireland, Dublin Millennium, The National Lottery and Dublin Cinema Group. The Public Art Manager explained that he was in communication with the Cinema Group with a view to having the work returned to an agreed location in the public realm.
- c. A proposal by Paul McCarthy that a permanent monument or statue dedicated to renowned artist Harry Clarke be commissioned and located near Frederick Street and Parnell Square, was not supported. The Group believed that if funding was available it would be better used to purchase works by the artist for display in Dublin City Gallery The Hugh Lane. This would be particularly appropriate as the artist was born in the area. A proposal to display examples of his work on JC Decaux advertising panels or to create a guide or mobile application of Harry Clarke works on public display was supported subject to available funding. Dr Paula Murphy also proposed that as much of his work is behind closed doors it would be a good idea, if there was funding, to have as much of the work as possible in the different locations, opened to the public on one day in the year and to give this event good publicity. This idea was supported by the Group.
- **d.** A proposal by the *Stoneybatter and Smithfield Peoples History Project* to install a monument or plaque dedicated to the civilians killed on North King Street during the 1916 Easter Rising was considered by the Group. This proposal had already been approved by the Commutative naming Committee. The Group supported the proposal for the installation of the plaque as the most appropriate form of commemoration.
- e. Monument to Margaret Keogh: This proposal from the Margaret Keogh Memorial Committee was to erect a monument along the River Dodder in commemoration of Margaret Keogh who was killed by British Soldiers in July 1921 during the War of Independence. The Arts and Cultural Advisory Group did not support the proposal as details of the design and sources of funding were not clear. The Group discussed the wider implications of commemoration during the centenary years of the War of Independence and the Civil War and proposed that a policy be developed which would examine the issues of how best to mark these events.

7. AOB

Cllr Mannix Flynn raised the issue of a proposal from the Parks and Landscape Services to construct a pavilion behind the Rutland Fountain. He expressed grave concerns about the project and the processes which surrounded its presentation within Dublin City Council. He stated that he thought it should have been presented to the Arts and Cultural Advisory Group and the Commemorative naming Committee. After a discussion it was agreed that the matter of whether the proposal should be referred to these forums would be referred to the Deputy Chief Executive for opinion.
