#### Motion carried forward from February Meeting.

This Area Committee calls for inspections of all homeless accommodation in the North Central Area used by Dublin City Council to be conducted by the Health Information and Quality Authority (HIQA), starting with an inspection of the family hub accommodation in the North Central Area.

This Area Committee notes that the playground audit conducted by Dublin City Council in 2017 identified Kilbarrack, Harmonstown and Raheny as the three areas in Dublin North Central most in need of play facilities for children and young people, supports the calls of local groups in Harmonstown for a new playground for their area, calls for the inclusion of sufficient funds for the new playground in Harmonstown in the capital programme 2019-2020 and calls on the Dublin City Council to immediately commence the community consultation for the new project.

#### 7 Motions

- a Motion in the name of Councillor Alison Gilliland The North Central Area Committee recognises the importance of sustainable community development across our area but in particular on the Lawrence Lands currently encompassed in the Oscar Traynor Land Initiative for housing development. Recognising the particular physical constraints of this site bounded on the west side by the M1/Port Tunnel, on the northside by the Oscar Traynor Rd and on the south and east sides by well-established residential areas, the North Central Area Committee calls on DCC to lead the development of a fully comprehensive traffic, public transport, cycle and pedestrian infrastructure and connectivity plan for this site and its immediate hinterland (Kilmore West, Woodlawn/Aulden Grange/Santry Court/Larch Hill, Lorcan Estate) and including the site's ability to effectively connect with Northside Shopping Centre and Santry Village. This infrastructure and connectivity plan should seek to to be realisable in conjunction with the timelines for development on the lands in question.
- b Motion in the name of Councillor Larry O'Toole That this committee commends the Parks and Public Domain staff for the excellent work in preparing the Stardust Park and Memorial for the recent annual commemoration.
- c Motion in the name of Councillor Michael O'Brien That this area committee supports the campaign to maintain the playschool operating from St Francis of Assisi in Belmayne which as matters stand will not be accommodated in the new permanent school building. We call upon the school authorities to reverse their decision not to include the playschool and call upon Dublin City Council to provide whatever practical assistance they can to help ensure this vital facility survives.

#### Current processes underway to identify additional properties

The City Council has established a communication forum with other Local Authorities, State Agencies and Approved Housing Bodies in relation to the recording and where possible the sharing of data on vacant properties. There is a dedicated vacant housing database to record all properties reported to it and the City Council continues to liaise with Landlords, Estate Agents, Property Owners and the General Public to help identify vacant properties in the City. The Housing Department has established a vacant housing register which has recorded 349 residential properties by accessing data from the CSO, Geodirectory, Vacanthomes.ie and internal databases.

The City Council has undertaken a total of 245 site inspections with regard vacant properties. A further 29 inspections are scheduled and 12 title researches are currently in progress for potential vacant properties.

### THE LORD MAYOR'S 5 ALIVE CHALLENGE 2019

The Lord Mayor's 5 Alive challenge is back for 2019! The initiative is a partnership programme between Dublin City Sport & Wellbeing Partnership and the Lord Mayor's Office. The Challenge is now in its 7th year and has encouraged hundreds of people to take up regular exercise over the past 6 years.

Last year the initiative went back to its roots and targeted people who were interested in taking up jogging or novice joggers who needed some encouragement to sustain progress. The focus on encouraging new and novice joggers to sign up to the challenge continues in 2019. In 2018 the challenge also introduced Mentors to accompany slower joggers and walkers and encourage them along each route. The mentoring aspect of the challenge also continues with 30 mentors appointed to support participants in the 2019 challenge. Each mentor has completed the 5 Alive challenge in previous years.

The Challenge is to complete 5 Dublin road races between January and April 2019. Details of the races are outlined below. In the event that a participant is unable to complete the 5 races they will have the opportunity to substitute a race for one of the city's Parkruns. Dublin hosts free 5k Parkrun in 5 locations across the city every Saturday morning. Details on times and locations can be found at www.parkrun.ie.

Over 400 participants have registered to take part in this year's challenge which commenced in the Phoenix Park with the New Year's Day Road Race on Tuesday 1<sup>st</sup> January 2019. The second race, the AXA Raheny 5 Mile race, took place on Sunday 27<sup>th</sup> January in St Anne's Park. Participants included the Lord Mayor Nial Ring who on completion of the race cheered on fellow contenders! The third race, the Garda Cross Country 2 and 4-mile country race took place on Saturday 2<sup>nd</sup> February in the Phoenix Park.

### **CHANGE FOR LIFE 2019**

Change for Life is an 8 week programme that aims to improve the health of local communities through a partnership approach designed to support people to become more physically active on a regular basis and adopt a healthier diet. The programme runs in tandem with the RTE Operation Transformation TV show.

The programme was first developed in 2013 when a partnership was developed between Dublin City Sport & Wellbeing Partnership, Fatima Groups United, Health Promotion & Improvement, HSE Dublin Mid-Leinster and Dolphin Health Project. This partnership identified a need to tackle the issues of obesity and low physical activity levels in a new and innovative way

While weight loss was considered an important aspect of the programme it was also felt that there were many other health indicators that could be improved through participation in the programme such as aerobic fitness, body fat percentage and blood pressure. Improving the psychological well-being of participants was also considered an important outcome of the programme. Following planning and consultation meetings between the partners it was decided to run a diverse health & fitness programme aimed at having a positive impact on the overall health and wellbeing of the participants.

The 2019 Change for Life programme commences in early January and is being rolled out in fourteen communities over an 8 week period. The programme provides fitness assessments, a 5K timed walk (repeated at week 8) and nutritional/dietary advice. Independent nutritionists gave a series of talks on healthy eating habits and dietary information such as portion size and calorie counting. Weekly weigh-ins to assess progress will also be provided.



# Proposed Junk Collection 2019

REPORT TO THE MEMBERS OF THE NORTH WEST & NORTH CENTRAL AREA COMMITTEES

Allocated Discretionary Spend

North West Area €216,000

North Central Area €216,000

Public Domain Teams from North West Area and North Central Area have met with Waste Management with regard to the Proposed Junk Collection.

According to Waste Management If the Junk Collection is to be re-introduced it must be carried out by direct labour, as this was a core duty for Waste Management Staff prior to it being abolished. Therefore, this work would have to be carried out on an overtime basis over weekend periods. This will affect the value for money element to the proposal.

Waste Management have given approximate cost and no. of Households they will be able to cover within the allocated funding above.

Total Households	108,473
No. of Households North West Area (cso 2016)	48,355
No. of Households North Central Area (cso 2016)	60,117

Working over 44 weekends for 2019 it is possible that the allocation of funding as above will cover maximum 17,000 households between the two areas.

This would give a percentage of households serviced between the two areas at:

North Central: 14.14%

North West: 17.58%

This figure indicates that over 80% of households will not be serviced in 2019 by the proposed collection.

### Alternatives for 2019

Public Domain Teams discussed alternatives for both the long term and projects that could be carried out within 2019.

### Option 1.

Locally arranged collections in conjunction with well-established residents' groups. This would entail arranging skips/grab truck within estates and allowing residents to dispose of household junk in this manner. In order for this to operate smoothly we would need residents' groups heavily involved.

Cost per collection: (Dependent of size of estate) €600 to €2000

### Option 2.

Amnesty Day within our Depots for the collection of Household Junk. This would be arranged with Waste Management and Public Domain Teams.

### Option 3.

Large scale clean ups of roads/areas as per the large scale multi departmental clean ups that took place in 2018 i.e. R139, River Road and Ratoath Road.

### The above options are the most practicable for 2019 and can all be applied throughout the year.

We discussed numerous other options: reduction in the cost of the current offer of the bulky waste collection from  $\leq 40$  to  $\leq 20$  or an increase in the number of items from 5 to 10, however this would have to be a citywide initiative and given that South Central Area have confirmed that they are not planning to use this money for waste management initiatives this would not be a viable option.

We also discussed the idea of engaging with Re-Discovery Centre to explore the idea of having ongoing recycling days in the area, operated and managed by them. This would take some time to negotiate and manage and would not be practical to offer it for 2019.
