With reference to the proposed grant of a further licence of the 1st Floor of the premises at No. 22 Buckingham Street Lower, Dublin 1 to Professor Joe Barry and Maureen O'Sullivan (on behalf of The North Inner City Drugs Task Force CLG – NICDTF).


By way of Agreement dated 24th February 2014 the 1st floor of the premises at No. 22 Buckingham Street Lower, Dublin 1, which is more particularly delineated on Map Index No. PD2008-100 together with the common area coloured in yellow was let under licence by Dublin City Council to Professor Joe Barry and Maureen O'Sullivan on behalf of The North Inner City Drugs Task Force (NICDTF) for a period of 11 months from 3rd August 2013 and subject to a licence fee of €127. The latest licence dated 22nd February 2018 expired on 2nd March 2018, D309 dated 7th September 2017 refers.

Accordingly, it is proposed to grant a further licence of the 1st floor of No. 22 Buckingham Street Lower, Dublin 1 to Professor Joe Barry and Maureen O'Sullivan on behalf of The North Inner City Drugs Task Force CLG subject to the following terms and conditions.

- 1. The licence shall be for a period of 2 years commencing on 3rd March 2018.
- 2. The licensees shall not have exclusive use of the property which is more particularly delineated on Map Index No. PD2008-100 and the Council shall be entitled to enter and use the property with prior agreement from the North Inner City Drugs Task Force.
- 3. The licence can be terminated by either party on giving the other one month's notice in writing.
- 4. The licence fee for the period shall be €127 per annum provided that the premises continues to be used for non-profit making community purposes only.
- 5. The licensees shall pay an agreed contribution towards the service charges for the building.
- 6. The licensees shall not assign or sublet the premises.

- 7. The licensees shall indemnify the City Council from and against all actions, damages, costs, proceedings, claims or demands in connection with the use and occupation of the said premises, including the shared area by means of an insurance policy in the sum of €6.5M in respect of Public Liability and €13M in respect of Employers Liability against any claim by any person, employee or invitee of theirs.
- 8. The licensees shall accept its part of the premises in its present condition and shall be responsible for any repairs and decoration necessary to make it safe and suitable for the activities to be carried out therein.
- 9. The licensees shall keep its part of the premises in good condition and repair during the term of the licence.
- 10. The licensed area shall be available for use by the North Inner City Drugs Task Force (NICDTF) from 6.00am to 10.00pm daily.
- 11. On termination of the licence the licensees shall at their own expense remove all materials not belonging to Dublin City Council and shall leave the property clean and cleared to the satisfaction of the City Council.
- 12. The licence will be subject to any terms and conditions deemed appropriate by the Council's Law Agent.

With reference to the proposed grant of a further licence of Unit 7, Liberty Corner, James Joyce Street, Dublin 1 to the Wexford Centre Project CLG (Company Limited by Guarantee).

By way of Agreement dated 26th September 2013, Unit 7, Liberty Corner, James Joyce Street, Dublin 1 which said Unit is more particularly delineated on Map Index No. SM2013-0519 was let under licence by Dublin City Council to the Wexford Centre Project CLG for office use for a period of 11 months commencing on 23rd September 2013 and subject to a licence fee of €1,000 (Order of the Executive Manager D351 dated 24th September 2013 refers). Wexford Centre Project CLG provides youth services including the provision of holidays for young people from the Inner City.


The latest licence dated 26th June, 2017 expired on 22nd April 2018 and the licensee is currently over holding under same. The Central Area Office has no objection to the renewal of a further licence.

Accordingly it is proposed to grant the Wexford Centre Project CLG a further licence of Unit 7, Liberty Corner, James Joyce Street, Dublin 1 subject to the following terms and conditions:

- 1. The licence shall be for the period of 2 years commencing on 23rd April 2018.
- 2. The licensed area which is more particularly delineated on Map Index No. SM2013-0519 shall be used by the licensee for office use only.
- 3. The licence shall be subject to a licence fee of €1,000.00 (one thousand euro) per annum.
- 4. The unit may be used from 9.00 am to 6.00 pm daily. The licensed area may only be used outside of those hours with the expressed permission of the City Council.
- 5. Keys to the premises shall only be held by official representatives of the licensee who shall be responsible for their use and all security issues associated with their use.

- 6. The licence can be terminated by either party on giving the other one month's notice in writing.
- 7. The licensee shall be responsible for all outgoings including electricity, water, rates and any taxes or service charges which may be due on the licensed area.
- 8. The licensee shall be responsible for its own waste removal from the premises and shall make its own arrangements for same.
- 9. The licensee shall be responsible for the maintenance of the internal shutters.
- 10. No car parking spaces are provided in association with the unit/licensed area.
- 11. The licence is personal to the licensee and shall not be capable of transfer, sub-licence, assignment, mortgage or charge.
- 12. The licensee shall keep the licensed area in good condition and repair during the term of the licence and shall not make any material changes to the subject property without the prior consent of the Council.
- 13. The licensee shall abide by all protocol, systems and procedures laid down by Dublin City Council in relation to the premises.
- 14. The licensee shall obtain a high level of public liability insurance and employers' liability insurance (if applicable) which shall indemnify the Council against any and all claims arising from the licensee's use of the premises. The Council will have an absolute right to set a minimum level of public liability and employers' liability insurance and to review the figures on a yearly basis (the current minimum levels are €6.5million and €13million respectively).
- 15. On termination of the licence, the licensee shall be responsible for the removal of all materials not belonging to the City Council from the premises.
- 16. The licence will be subject to any other terms and conditions deemed appropriate by the Law Agent.
- 17. The grant of a new licence shall be subject to the proposed licensee signing a Deed of Renunciation, renouncing any rights under the Landlord Tenant Legislation.

GROUND FLOOR PLAN LIBERTY CORNER, UNIT No 7



With reference to the proposed disposal of the fee simple in a property at 38-39 Bolton Street, Dublin 1 to the Arlington Novas Ireland Company Limited By Guarantee.

Arlington Novas Ireland Company Limited By Guarantee, an Approved Housing Body and registered charity, proposes to refurbish the property at 38-39 Bolton Street, Dublin 1 to provide 4 individual en-suite bedrooms with various communal facilities in each house, i.e. a total of 8 units of accommodation. The proposed accommodation will meet the housing needs of single persons or couples or families experiencing homelessness in accordance with Dublin City Council's Housing Allocations Scheme (generally referred to as The Scheme of Letting Priorities).

It is proposed to dispose of the City Council's fee simple interest in this property at 38-39 Bolton Street, Dublin 1, to Arlington Novas Ireland Company Limited By Guarantee, as shown outlined in red on the attached map index number SM-2018-0230, subject to the following terms and conditions, which the Chief Valuer considers fair and reasonable:

- 1. The City Council shall dispose of the fee simple in the subject property under the terms of the Low Cost Sites Scheme.
- 2. The purchaser shall lodge a planning application to refurbish / develop residential units (the "Development").
- 3. The disposal price shall be in the sum of €127 (one hundred and twenty seven euro) plus VAT (if applicable) per residential unit.
- 4. The Development shall comply with the planning permission granted and all other necessary statutory approvals.
- 5. The title shall be transferred when the development is completed to the written satisfaction of the City Council's Housing Department and the Mortgage Deed is executed.
- 6. The Development shall be funded through the Capital Assistance Scheme (CAS). The Development must be fully completed and made fit for occupation within the time frame agreed between the Executive Manager of Housing and Community Services and the purchaser.
- 7. The purchaser and its contractor and professional team shall be permitted to enter onto the subject property under a twelve month Building Licence agreement, on standard terms to be agreed, for the purposes of commencing the approved development.
- 8. The purchaser shall satisfy the Council that it has adequate public liability and employers insurance and shall indemnify the City Council against any claims for compensation that may be made arising from its usage of the site. The current levels


- of insurance are €6.5 million public liability insurance and €13 million employer's liability insurance.
- 9. The purchaser shall insure the buildings during construction against fire and all other insurable risks with an approved insurance company and pay all necessary premiums. The insurance shall be in the joint names of the parties and will be for such an amount as will provide cover for full reinstatement values of so much of the buildings as is erect at any time together with a sum for professional fees and removal of debris charges.
- 10. All roads and footpaths works shall be completed to the written satisfaction of the Council.
- 11. There is an inhibition on the title that the subject property can only be used for social housing purposes.
- 12. The Council shall have 100% nomination rights to all of the units constructed on site.
- 13. Should the subject property cease to be used for social housing purposes at any stage, then the units will revert free of charge to Dublin City Council subject to and with the burden of the Capital Assistance Scheme Charge.
- 14. A charge in favour of Dublin City Council for the CAS shall remain on the title for a term of 30 years. The applicant shall comply in full with the Deed of Mortgage in respect of the CAS charge.
- 15. In the event of the applicant's bankruptcy or insolvency, Dublin City Council reserves the right to take possession of the site and all of the housing units, (partially completed or otherwise), at no cost to the Council, save in the case of a financial institution which has entered into a mortgage with the purchaser subject to and with the burden of the Capital Assistance Scheme Charge.
- 16. The purchaser shall not sell, assign, sublet or part with possession of the property or part thereof without obtaining the written consent of the City Council, with the exception of tenancy and licence agreements with tenants or licensees for supported housing.
- 17. Each party shall be responsible for their own legal fees.
- 18. The purchaser shall be liable for the payment of VAT or Stamp Duty should any payments arise from this disposal.

The dates for the performances of any of the requirements of the proposed agreement may be amended at the absolute discretion of the Executive Manager.

The disposal shall be subject to any such covenants and conditions as the Law Agent in his discretion shall stipulate.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.

A check will be undertaken to establish if any services (public or private) are located on referred area. Suitable arrangements will be put in place prior to completion of this proposal.

Statutory Requirement


The statutory procedure involves giving public notice, of the proposal, in one or more newspapers circulating in the City and the affixing of the same notice to each end of the referred right of way for a period of not less than 14 days. Any objections or representations made, and not withdrawn, shall be considered. The extinguishment of a public right of way is a function reserved to the elected members of the City Council.

Recommendation

I recommend that procedures be initiated under Section 73 of the Roads Act 1993 to extinguish the public right of way over the area as indicated on attached Drawing.



It has been brought to the attention of this department that the practice of residents allowing their dogs to wander unaccompanied or under effective control is occurring regularly in your

CONTROL OF DOGS ACT, 1986 (& AMENDMENT ACT 1992)

Section 11 enables Dog Wardens and the Gardai to seize stray dogs, including dogs not under proper control.

order proper control.

Stray dogs may be seized by the dog wardens and brought to the dog pound where they will be kept for 5 days. After these 5 days, the dog becomes the property of the dog pound and may be re-homed. An owner reclaiming a dog during this 5 day period is subject to any relevant lines (charges that must be paid before the dog can be handed back.

Housing Report March 2018

Avondale House:



The Mural at Avondale House is almost complete.

External Insulation Scheme:



The scheme for exterior insulation of houses and upgrading of heating has been completed in Eastwall. The contractors have now moved on to DCC properties on Tolka Road.

Tom Clarke House:



The erection of an external Bin Chamber at Tom Clarke House has been completed and keys have been distributed to each of the residents.

Croke Villas / Ballybough Road:



Works on the frontal rendering and brickwork to the front of 1-6 Ballybough Road continues and is due for completion by September 2019.

We continue to work with the remaining residents (in the first block) in anticipation of their transfer to their new homes in 2019. Work is continuing on the site at 2-6 Ballybough Road to deliver 7 new housing units. The roof structure has now been tiled and completed. Cladding to the front of the units is now under way and is due for completion September 2019.



Foundation works of new Handball alley are now complete. Ground and first floor brick work has near completion with second floor beginning. Construction on the new Croke Villas Apartments will commence once the Handball Alley is completed.

St. Mary's Mansions:



Cluid have advised that "The project continues to progress well." The raising of the external walls continues with the second floor extension nearing completion on two of the four blocks.

Dominick Street Lower

Detailed designs for 5-3 bed town houses, 67 apartments consisting of 5-3 bed, 50-2 bed and 12 1-bed units, a community facility and retail/commercial units with 47 car spaces at basement level on the eastern side of Dominick Street have been completed. Duggan Brothers have commenced on site, they have mobilised the site compound, and welfare facilities. Carried out archaeological investigations, and completed site clearance. This month's work will include stone bed for piling rig and commence pile drilling. Planned working hours are 7 am to 7 pm Monday to Friday and 8 am to 2 pm on Saturday when required.

A monthly information meeting takes place between Duggan's and the neighbours around the site. These meetings have been productive. A draft leaflet will be produced by Duggan's for the meeting and agreed, which will then be distributed to the local people and businesses.

The Gaelscoil is expected to go to planning in the second quarter of next year.

Constitution Hill

An internal design team has been set up to make a submission to the Department of Housing, Planning, Community and Local Government on a recommendation for some new build and refurbishment of this complex. The Stage 1 report is with the Department of Housing, Planning, Community and Local Government for approval. A Cost Benefit Analysis report is with the Department. This report led to a number of clarifications being sought from the Department, these have been answered and are now with the Department. We are currently setting up a design team.

Dorset Street & Saint Marys Terrace

The Department, after reviewing the consultant's report, has advised that the cost of refurbishment was so close to the cost of demolition and new build that they requested that this option be further developed. The Stage 1 report is down with Department of Housing, Planning, Community and Local Government for approval of funding. A Cost Benefit Analysis report is with the Department. This report led to a number of clarifications being sought from the Department, these have been answered and are now with the Department. Once approved, we will commence consultations with the local community and designs for Part 8 approval.

Sean Foster Place

We went out to tender on Sean Foster Place a number of months ago, unfortunately this prove to be unsuccessful and we were unable to award the contract. coming weeks with construction commencing by the end of the first quarter. Stage four funding has been approved by the Department of Housing, Planning, Community and Local Government. Duggan Brothers Ltd are the preferred bidder and we are in discussion to award the contract.

St Michan's House

A roof replacement programme has commenced in this complex, weather permitting it will take approximately 12 weeks to complete. Blocks A and B is complete and work is ongoing with the remaining blocks.

Blackhall/Marminon

Tenders have been received for the roof refurbishment of this complex, we expect work to commence early next month.

Constitution Hill

A contractor will commence working on installing a garden on the old playground at the south end of this complex in the coming weeks. A photo montage will be distributed to all residents in the next week. We expect some of the trees from Sean Foster Place to be relocated to this garden.

Dick Whelan, Area Housing Manager

O'Devaney Gardens:

Construction works on Phase 1 are proceeding and a completion date by mid 2020 remains the target. The latest date for the return of completed tenders in respect of the next phase was extended by one week and those tenders are currently being reviewed.

Bricins Park:

The newly refurbished units in Phase 3 have been shown to prospective tenants and the allocation process is underway. A sixteen camera CCTV system has been installed and handover of the completed Kitchen/Community space area is expected to take place in the next fortnight.

NORTH EAST INNER CITY PROGRAMME OFFICE REPORT

2019 FUNDING

Expenditure of the €6.5 million allocation to the north east inner city for 2019, under the Department of Rural & Community Development Community Enhancement Programme, will be overseen by the NEIC Programme Implementation Board and five Sub-Groups. The bulk of this funding will be approved for strategic priorities identified by the Sub-Groups within their respective areas of remit i.e.

Sub-Group 1. Tackling Crime and Drugs;

Sub-Group 2. Education, Training and Employment;

Sub-Group 3. Creating an Integrated System of Social Services;

Sub-Group 4. Improving the Physical Landscape; and

Sub-Group 5. Addiction Treatment and Rehabilitation Services.

To date the Strategic priorities identified by each Sub-Group are as follows:

Sub-Group 1 – Intensive focus on tackling open drug dealing in Liberty Park and environs

Sub-Group 2 – School Attendance "Attendance is everybody's business"

Sub-Group 3 – Advancing interagency service delivery

Sub-Group 4 – Public Realm Plan and Greening Strategy

Sub-Group 5 – Integrated approach to drug and alcohol services provision

The Programme Implementation Board is also open to consideration of proposals from community-based groups if such proposals can clearly demonstrate potential to contribute to implementation of the recommendations set out in the <u>Mulvey Report – Dublin North East Inner City – Creating a Brighter Future</u> in new, innovative and collaborative ways.

The most appropriate route for submission of such proposals is via the North Inner City Community Coalition representatives on the Programme Implementation Board (Fergus McCabe and Noel Wardick). Alternatively, proposals can be e-mailed directly to the NEIC Programme Office neic@dublincity.ie or submitted in hard copy marked for the attention of Linda Roe / Michael O'Riordan, NEIC Programme Office, C/O Dublin City Council Central Area Office, 51-53 Seán McDermott Street Lower. Proposals will then be forwarded to the relevant Sub-Group for consideration.

UPDATE ON 2019 FUNDED PROJECTS

On recommendation of the Budget Sub-Group a further round of projects was approved by the Programme Implementation Board at its meeting held on 27th February 2019. This brings the total 2019 funding allocation to date to €4,432,950 (of €6.5M). The full list of approved projects / programmes is set out on Appendix A.

The latest funded proposals include the following:

Reader in Residence and Coderdojo Digital Skills

The Reader in Residence (€37,500) and Coderdojo Digital Skills (€17,500) programmes run by Dublin City Public Libraries at Charleville Mall in 2017 and 2018 were deemed to be very successful and will be repeated and developed further in 2019. It was a condition of the 2018 NEIC funding that the programmes be considered for mainstream funding in future years via Dublin City Council's budgetary process. The programmes will be co-funded with Dublin City Council this year with a view to full mainstreaming in 2020.

The NEIC funding has enabled Dublin City Public Libraries to develop the Reader in Residence model which is now being expanded to a wider geographical area. The overall statistics are as follows, a full report on the Programme is available on request.

The Coderdojo Digital Skills Project offers children and young people living in the NEIC area the opportunity to learn basic computer programming for free by attending a CoderDojo in their local DCPL library. At Dojos young people learn about technology in fun, safe, and creative club environments. They develop deep technology skills, but also through the experience and environment, learn a host of transferable skills including, creativity, problem solving, communication, leadership and teamwork.

On an average week three coding sessions are delivered, two for 7-12 year-olds on a Saturday morning in Charleville Mall Library and one on a Wednesday afternoon for teenagers. It caters for between 30-40 children and young people over an average week. The CoderDojo Foundation has been very supportive of the project and have donated multiple copies of their Nano books for each library in the DCPL network. A full report on the NEIC funded Digital Skills Project is available on request.

NEIC Community Grants Scheme 2019

Following approval of €100,000 funding the 2019 NEIC Community Grants Scheme will open for applications by end March and this will be widely promoted across the community development sector. As in 2018, in order to facilitate seasonal proposals this year's scheme will be being run in two rounds Round 1 Spring/Summer with a closing date of Tuesday 30th April 2019 and Autumn/Winter to be advertised in Sept. The purpose of the Scheme is to financially support North East Inner City communities in delivering their own projects locally to benefit the defined NEIC area. Priority will be given to applicants that can be linked to delivery of actions and recommendations contained in the Mulvey Report. For the 2019 Scheme it has been agreed to focus on two priority themes i.e.

Theme 1. Environmental awareness and improvement

Theme 2. Active Living, Recreation and Wellbeing

NEIC Greening Strategy - Implementation Phase 1

The NEIC funded Greening Strategy is now a working document with no material amendment following the period for public submission which concluded in Dec. 2018.

In addition to the longer-terms projects currently underway i.e. re-development of Mountjoy Sq. Park and Diamond Park, a range of smaller scale greening projects for Phase I implementation (2019) were costed, recommended by Sub-Group 4 and approved by the NEIC Board for funding in the sum of €350,000. The selected projects are as follows:

- o Belvedere Plaza (NCR Junction with Belvedere Place:
- Guild St. Plaza (St Sheriff St. / Spencer Dock junction;
- o James Joyce Street tree planting;
- o Greenwall at Seville Place; and
- o Tree planting on 1 no. residential street to be identified.



OTHER UPDATES

Community Events

Following the approval by the Programme Implementation Board of a funding allocation for 2019, planning is well underway to deliver a series of local community events in 2019 similar to 2018. Event highlights currently being planned for the north east inner city include collaborations with the Five Lamps Arts Festival 2nd – 7th April 2019; NEIC "Try-a-Tri" Triathlon event Sunday 7th April in association with An Garda Siochána and Triathlon Irl.;

and Gospel Rising Festival 2019 to take place on 17th – 19th May http://gospelrising.com//. Further details on these events will be brought to the April meeting.

Chinese New Year Celebration at Hill Street Family Resource Centre



The annual Chinese New Year Community Celebration, hosted by Hill Street Family Resource Centre in partnership with the North East Inner City Initiative, took place on Saturday 9th February from 14.00-19.00. The event has grown significantly in recent years and in the interest of public safety it is no longer possible to hold it within the site of Hill St. Family Resource Centre. The NEIC Programme Office worked with HSFRC and to programme and produce a spectacular public event on Hill St. itself. Approximately 3,800 people attended throughout the day. This local event was promoted as part of the citywide Dublin Chinese New Year Festival.

NEIC Social Media Strategy

The Programme Office, working with Together Digital, is developing a media strategy for the next 4 months to raise the profile of the NEIC including promoting community and sporting events, opportunities in training and education, and the wide range of new initiatives and supports. Recognising the importance of communications and outreach, the Programme Office hopes to focus on the many positive aspects of this area and it's strong and vibrant community.

Sean MacDermott St. Swimming Pool

With the support of NEIC funding, the partnership agreement between Dublin City Council and Swim Ireland to extend the public opening hours of Sean MacDermott St. Swimming Pool has been underway since mid-August. The partnership arrangement facilitates the opening of the pool 7 days a week with Swim Ireland opening the facility to offer 39 hours public swimming on Saturday p.m., Sunday and Monday. Dublin City Council continued to

accommodate a range of local schools, clubs and community groups Tues. – Fri. A further round of promotional activity will be run in the lead up to the final three months of the trial period. In the meantime, discussions will continue between Dublin City Council, NEIC and Swim Irl. regarding the future beyond the trial period.

Measuring the Impact of the North East Inner City Initiative

In December 2018 the Programme Office publicly invited tenders from suitably qualified and experienced research organisations to produce a report setting out recommendations and indicators on how best to evaluate the impact of NEIC Initiative. Following completion of the tender process *Just Economics Research Ltd.* have been commissioned. Just Economics bring a wealth of experience in evaluation of regeneration and social programmes from the UK and Ireland and specialise in developing cost-effective methodologies that are practical to implement and accessible to stakeholders.

Evaluation is seen as crucial part of the Initiative to demonstrate the impact that the investment is having to date. Moreover, it will enable the Board to consider what elements are working well and identify areas for improvement in the future. The next stage of the process will involve a series of workshops with the members of each of the NEIC Sub-Groups.

1. DCSWP MARCH – APRIL HIGHLIGHT EVENTS & PROGRAMMES

THE LORD MAYOR'S 5 ALIVE CHALLENGE 2019

The Lord Mayor's 5 Alive concludes on 30th March with the BHAA Dublin City Council 4 mile race on Saturday 30th March. The 5 Alive challenge is a partnership programme between Dublin City Sport & Wellbeing Partnership and the Lord Mayor's Office. The Challenge is now in its 7th year and has encouraged hundreds of people to take up regular exercise over the past 6 years.

Last year the initiative went back to its roots and targeted people who were interested in taking up jogging or novice joggers who required some encouragement to sustain progress. The focus on encouraging new and novice joggers to sign up to the challenge continued in 2019. In 2018 the challenge also introduced mentors to accompany slower joggers and walkers and encourage them along each route. The mentoring aspect of the challenge also continues with 30 mentors appointed to support participants in the 2019 challenge. Each mentor has completed the 5 Alive challenge in previous years. Over 400 people registered to participate in this year's challenge which commenced in the Phoenix Park on New Year's Day.

In the event that a participant is unable to complete the 5 races they have the opportunity to substitute a race for one of the city's Parkruns. Dublin hosts free 5k Parkrun in 5 locations across the city every Saturday morning. Details on times and locations can be found at www.parkrun.ie. Details of the final 2019 5 Alive races are outlined below;

BOXING DEVELOPMENT OFFICER UPDATE

➤ The Startbox Initiative, a partnership between the IABA and Dublin City Sport & Wellbeing Partnership, represents an ideal way for young people aged 10 – 17 years to first engage with amateur boxing, Ireland's most successful Olympic sport.
