DUBLIN CITY COUNCIL SOUTH CENTRAL AREA COMMITTEE 20th February 2019

677 Councillor Hazel de Nortúin

This Area Committee condemns the recent attacks on the De Le Salle site. This Area Committee also recognises the hard work done by local residents to see the site as a whole used for the community and will support their efforts going forward in every way we can. Given the lengthy planning process we're calling on DCC to lease the land on a short-term basis for furthering its use by the community and also keeping it secure.

That this Area Committee agree that DCC/Minister for Heritage engage with the HSE to get conservation led improvements to the Quaker burial ground site on Cork Street, and that a study of its historic importance, who is buried there etc. be carried out. That Dublin City Council take action once and for all to address the poor heating situation in the Long Meadows Pitch & Putt Club House on Sarsfield Road, Ballyfermot, Dublin 10. I have called to the club on a couple of occasions and the staff and chairperson have told me, despite the contractor calling out, the heating is not fit for purpose. I witnessed an electric bill of over €2,000 as they try and heat the building with small electric heaters.

South West Inner City Area Report

Update on Kilmainham Mill

Stakeholder engagement has begun with Save Kilmainham Mill Campaign and the Residents Association. Bi-monthly meetings with both groups commence on the 21st of February and the Project Manager, Darragh Cunningham is in regular contact with both groups.

Some basic site clearance work has been done to clear foliage at the rear of the Mill at the mill race and along the river. These works are basic health and safety works enabling the relevant specialists safe access around the building. The works were carried out following consultation with a licensed archaeologist, the Save Kilmainham Mill Campaign and the Residents Association who were in full support.

A grant application has been made by Dublin City Council to the Historical Structures Fund (HSF) for the amount of €200,000. If successful the (HSF) funding and additional DCC funding will enable emergency stabilisation works to the building itself, roof repairs, propping of floors, mesh on windows, clearing of guano and other bio-hazards etc. These works will make the building safe for further surveys to commence. An asbestos survey should be commissioned in the coming weeks. Future usage options are yet to be explored until such a time as the building is safe to fully access.

Shopfront Improvement Scheme 2019

The Area Office's Liberties Business Area Improvement Initiative has announced the latest tranche of funding available under the Shopfront Improvement Scheme. This year the scheme will cover The Liberties, Dolphins Barn, Rialto and Clanbrassil Street (Leonard's Corner area). Applications are invited by 5th April. It is hoped to support 15 projects.

Urban Regeneration: The GEC (Guinness Enterprise Centre) Expansion

The Guinness Enterprise Centre has announced a €10m investment in its Taylors Lane premises to double the existing floor space and allow it to accommodate up to 160 startups and companies employing over 700, as well as 200 coworking spaces. The centre is supported by Dublin City Council through its LEO Office. A planning application has been submitted to Dublin City Council.

This announcement comes ahead of a major regeneration plan for the 12acre St. James's Gate Quarter by Diageo (with the first planning applications expected later this year) and the preparation by The Digital Hub Development Agency of a masterplan for its so-called Windmill site to the north of Thomas Street. In addition, a new workshare operator, Iconic Offices, will open its latest facility called The Grainhouse at 151 Thomas Street (former IAWS) in March. The scheme will accommodate 700 people when fully open.

BusConnects

The NTA has published outline plans for a number of high capacity corridors through South Central Area including Liffey Valley to City Centre, Clondalkin to Drimnagh, and Greenhills to City Centre. The Area Office is currently reviewing the suggested change proposed by

BusConnects and the implications for Area Office public realm projects and the wider development agenda in the area. More details at www.busconnects.ie.

St. Audoen's Park, High Street

Works to enhance St. Audoen's Park by improving accessibility, permeability and circulation commenced in October 2017 are substantially complete with the park due to reopen in Spring 2019. The reconfigured western entrance will incorporate a play garden.

Francis Street

A Part 8 Planning Application was agreed at the September 2017 City Council meeting to provide for a more pedestrian friendly environment which encourages people to visit Francis Street and its environs on foot. The plan also supports the continued commercial operation of the Arts and Antiques quarter.

The environmental improvement scheme comprises improvements to the public realm the full length of Francis Street, Hanover Lane and part of Dean Street. The proposed works will include the following:

- Improvements to kerb build-outs
- Footway repaving
- Raised junction plateaus
- Kerb buildouts to formalise parallel parking and loading bays
- Landscaping
- Greening
- Bicycle stands,
- Carriageway resurfacing
- Raised pedestrian crossings and ramps
- Public lighting improvements

Detailed design work commenced in 2018 with a view to inviting tenders in quarter 22019. It is expected that construction works will commence in late 2019/early 2020.

Meath Street

We are in the final stages of the preliminary design phase. We would hope to have another internal consultation by the end of February and another public consultation in March.

Francis Street

The Francis street EIP is continuing into the detailed design phase. It is envisaged that construction will commence in the autumn of 2019.

Dolphin's Barn

The Dolphin's Barn public realm improvement plan is awaiting resources from the Environment and Transportation Department to progress to the detailed design stage.

Bluebell

Work commenced in June 2018 on the Tallaght to Inchicore cable project and includes:

- The demolition of the former ABC Hall
- Provision of approximately 36 community allotments

The Hall was demolished late last year whilst the allotments are expected to be completed in April. Applications for the allotments were invited from Monday, 4th February.

Bluebell Community Council Report

Bluebell Community Council has recently opened their new office at no 1 Bernard Curtis House. This office will provide information to residents, community groups, and all the

relevant agencies and service providers. Bluebell Community Council has selected Mr. Kieran Rose as Independent Chairperson and Clifford Sullivan as Legal and Business Consultant. Brian Maher of GVA Planning and Regeneration LTD has been retained by Bluebell Community Council to draft a plan for the area. A meeting between Planning Department, the Area Office, GVA and representatives of the Bluebell Community Council is scheduled for Tuesday the 26th of February.

CRUMLIN/KIMMAGE AREA REPORT

Crumlin Area Office Report

Opening Hours

Due to reduction in staff numbers, a review of opening hours may be required, with a possible temporary reduction in opening hours.

Stannaway Court, Senior Citizens Complex

New gas boilers have been installed in all units. Bord Gais have completed the installation of new gas lines and moved meters to the gable end of each block. Old gas lines will now be removed and insulation works can commence. Insulation works are due to commence before the end of February. New composite doors have been ordered and have a six week lead in to delivery and installation. It is likely to be mid to end of March when doors are installed.

St. Agnes Park - Respond VHA

Final snagging works are continuing but there is no confirmed handover date as of it yet. Respond has advised that all units have now been offered to and accepted by nominated applicants. Tenant induction has also been completed. Respond expect the units to be fully occupied by the end of February. It has been clarified that tenants will not be charged a deposit but will have to pay a week's rent in advance.

Raleigh Square- Tuath Housing Association

Works are progressing on these units and they are on course for handover at the end of June 2019. Tuath have advised they will be seeking nominations from Allocations for the 33 units in early June.

Rafters Lane - WALK VHA

Construction works are well underway on site. Due to the restricted access and confined nature of the site, the contractor has been given permission to bring in deliveries through Lissadel Court on one day a week. Deliveries are only allowed between 12.30pm and 2.30pm on Tuesdays and this arrangement is working well at the moment. The practical completion date for this project is July 2019.

CCTV at Benbulbin Road and Lissadel Road

A new 360-degree camera with a range of 500 meters was installed on Benbulbin Road. This camera was providing high quality footage but was attacked and damaged. The camera has been repaired and was reinstalled on the 15th February. The contractor is trawling through footage to try and identify the individuals responsible for damaging the camera.

We have requested a report from the Crime Prevention Officer in relation to improvements that can be undertaken in Brickfield Park to address anti-social behavior in this area. The Parks Section are currently removing trees at the Benbulbin end of the park which should allow greater visibility.

Cooley Road

Bollards have now been installed on the footpath at Cooley Road at the Children's Hospital. This will help alleviate illegal parking which has resulted in a number of serious accidents and ongoing traffic delays.

Community Report

The SWIC/Crumlin Kimmage Community and Social Development Team continue to support new and existing community/residents groups and organisations who are actively engaged in their communities throughout the year.

Maryland Grotto

The final stage of the environmental enhancement of the Maryland Grotto is now under way, this entails the plastering and painting of the feature wall at the grotto, and some new plants to rejuvenate the area. It is envisaged to hold a community celebration here during the summer.

Dublin City Council's Area Office is delighted to be associated with the LOVE DUBLIN 8 Community Fair which is taking place in St Patrick's Cathedral on Tuesday 26th February.

Over one hundred and twenty local groups will participate in this event including: Social & Community Groups & Networks, Voluntary Agencies, Adult Education, Youth Groups, Schools, Art / Culture / History Groups and local Businesses to name but a few. The event will commence at 5.20pm with an Evening Song recital by the St. Patrick's Cathedral Choir. Doors will open to the public at 6.15pm

Historian in residence, Cathy Scuffil, will give one of her many and interesting talks about the Dublin connection to the "Way of Saint James" on the 20th March at 2.30pm in St James Church parish hall.

Following the successful Better Links Stronger Communities Tidy Towns Conference 2019 last month, a number of communities are now energised and motivated to get ready for their spring cleaning city neighborhood competitions.

Crumlin Walkinstown Local Forum History Subgroup Historical Exhibition

Following on from the success of last years Open Day, Dublin City Council Community Development Team is assisting the Crumlin Walkinstown Local Forum in hosting an Open day for Community Groups on Saturday 9th of March between 11.00am - 3.00pm in the school hall, Scoil Una Naofa. The event will be an opportunity for groups to network among themselves as well as with the wider community.

Lá le Prátaí at Flanagan's Fields

St. Patrick's Day is the traditional day for planting early crops of potatoes and once again the Back of the Pipes Residents Association will be hosting their annual "Lá le Prátaí". This much loved community event will take place in Flanagan's Fields in Reuben Street. Local residents will gather to plant potatoes and take part in the Patrick's Day Celebrations. Residents can expect some amazing culinary delights cooked from locally sourced food from the community garden not to mention great music and craic.

BALLYFERMOT/DRIMNAGH ELECTORAL AREA

Housing and Environmental Issues

Cherry Orchard

The contractors, MDY, are back on site since Tuesday 12th February and they have been mandated to carry out all outstanding works. They expect to have the remaining thirty-six houses ready for occupation within the next six weeks. Prior to this, some sub-contractors were back on the site under the direct provision of CHI. That work related to street lighting and enabling works in preparation for the main contractor returning. Applicants are being contacted by CHI and interviewed in preparation for offers of accommodation.

Elmdale

The new housing units in Elmdale in Cherry Orchard will be ready for letting shortly on a phased basis. We expect that nineteen (19) units will be ready over the coming weeks and the Ballyfermot Area office is awaiting confirmation from Architects Section that the paperwork is in order and that the keys can be collected. The nineteen units consist of 11 two bedroom units and 8 three bedroom units. We intend to hold additional viewings as the units become available for letting and all prospective tenants will be viewing the units before they make a final decision. As with the previous Rapid build units in Cherry Orchard, we will set up interviews with MABS, Citizen information and the Community Welfare Officer before the prospective tenants sign for their tenancies. We have had expressions of interest from over 300 applicants in the units.

Cornamona Court

The tender process for this scheme has recently concluded and a report recommending an award of contract has been issued. Approval is now being sought from the Department of Housing, Planning and Local Government to award the contract.

Environmental Works

Outstanding work for Barneville include a stone planter with the name of the estate engraved to be installed at the entrance to the estate. The playground company have taken delivery of the play equipment and will be on site before the end of February to discuss the location of the football goals and standalone basketball hoop. Sites have been identified throughout the area for additional trees which will be planted in the Spring.

Outstanding works for California Hills include the crowning of trees and the planting of bulbs. It is hoped to upgrade two wheelchair accessible gates in the near future to prevent access to the Park by scramblers and horses.

Chapelizod

A Chapelizod Steering Group meeting was held on 6th February at which Parks Dept. and Public Domain staff were also in attendance. Issues around derelict sites, new developments, tidy towns proposals and the general upkeep of the area was discussed. Members were also invited to agree a date for a public meeting regarding the Springvale site. The date of 28th February to hold the public meeting with the residents of Chapelizod in St. Patrick's School to discuss the proposals for the Springvale site was agreed.

Business Community/Christmas

The Area Office intends to arrange a meeting with the business owners in the Spring to discuss the impact of the improvements to the streetscape and to work with them with new initiatives. We are hopeful that the row of shops adjacent to the Gala building will be painted soon as organised by the owners and it is hoped that this will encourage other shop owners to link with us regarding their own shop fronts.

Community Report

Community Environmental Projects

The City Council is working with the Bluebell Environmental Group and local interests to redesign and redevelop the grass area opposite the shops.

The Community Team is supporting transition year students from Mercy Secondary School, Goldenbridge to take part in the Young Social Innovation Programme. The girls hope to link in with older people in Bulfin Court and participate in environmental projects like planting and clean-up's in the area.

Ballyfermot Environmental Project

The Ballyfermot Environmental Project will be opening its 2019 activities with a series of community clean ups which will take place over a four-week period. The first two will commence in the Drumfinn Park area and Cherry Orchard's Croftwood Gardens. These environmental projects are joint collaborations between the Council, local residents, and various community groups and educational agencies.

California Hills Math's Eyes Project's

The California Hills Math's Eyes Project's planning stage is complete as the overall project nears fruition. It is planned that the final phase of the project will see an unveiling in early March following extensive collaboration between DCC's Community and Parks Departments, St. Dominic's school and Tallaght IT.

Coiste Bhailethormaid

Coiste Bhailethormaid is an exciting new Irish language and cultural heritage project designed to enhance and further promote all thing Irish in the Ballyfermot area. This local Coiste already has a full schedule of events lined up for March's Seachtain na Gaeilge festivities with its centerpiece being a full Ceili for over two hundred second year students from local schools being hosted in the Ballyfermot Community Centre. The City Council is

hoping to establish a similar group in the Drimnagh area to organise events for Seachtain na Gaeilge. Banners promoting Irish and Seachtain na Gaeilge will be placed along the main street, Ballyfermot aided by funding from the 2019 Discretionary Fund.

History / Heritage group

There is a big interest in local history in the Dublin 12 area. Dublin City Council brought those interested together and a new History / Heritage group has been established. The Council will support the group through providing seed funding, speakers, and organise visits to historical points of interests. The Council hopes that a committee will form and the group will grow. The next meeting will be held in Good Counsel GAA club on Wednesday the 6th of March.

Social inclusion

- Community Development is supporting Inchicore Works Resident Association to set up a Men's Shed.
- Meetings are ongoing with Community Development, the H.S.E. and the Oblate Community Employment Scheme to extend and retain the daily meals produced in La Touche Court. It is also proposed to book a number of practitioners to host a series of talks on health and wellbeing.
- A new walking group has been established in Inchicore supported by Dublin City Council. The Ring Walkers Group meets Monday to Friday at 9am and 7pm and family walks will be on Saturday at 4pm and Sunday at 12:30pm. The Council has also supplied hi-vis vests and walking leader training for group members.
- The Council is working with the Ballyfermot Resource Centre to organise classes to set up an ukulele band. The first classes will take place on 22nd Feb at 11:30AM
- The Ballyfermot /Chapelizod Partnership grants are now open. The Community team have worked with local organisations to submit applications for LCDC Local Facilities Enhancement Fund and Creative Ireland for Cultural events.

Cherry Orchard

Christmas Panto - "The Fairies and the Shoemaker", Basement Productions Theatre Company.

We were very happy to have our second Christmas Panto in the centre during the month of February. The Panto took place on the weekends of 2nd 3rd 9th & 10th with a 3pm show each day. These shows were open to the public and had a good attendance. There was also a special show put on, on 31st January for St. Ultan's school which was greatly enjoyed by the younger pupils and teachers alike. This was an opportunity for the Parents and Young Children from Cherry Orchard and Ballyfermot as well as other areas to come to a Pantomime and experience the fun and laughter enjoyed by so many other children around this time of year. Most if not all attending would not have this opportunity if it was not brought to the centre. Many thanks to all involved in putting on such a successful event which was attended by nearly 400 people.

Mica's New Hair Salon in the centre.

Our new venture is coming along nicely with customers coming and going and creating a great buzz in the building. It is an appointment only service and appointments are made directly through Mica the lady who operates it.

Sequence/Ballroom Dancing Classes.

This group meet every Wednesday and Friday mornings 11-12.30pm. The group are together less than a year and have grown from 4 members to over 40. A great bunch of people and always inviting new members.

Afternoon Activity Clubs.

Our children's clubs every afternoon Tues-Friday are going strong with over 60 children attending weekly.

Boxing Club.

This well-established club is going great and has a waiting list for new members.

New Baton Twirling/Majorettes Group.

Elite Twirling Academy started with us at the beginning of February. So far the group are going great and have a large number of children attending. The group have reached out and have members of the Traveling community as well as some homeless children attending. This is a great thing for all involved and we are giving as much support as we can to the organisers.

Men's Music Shed.

This group who started not too long ago with us have grown greatly in numbers and confidence. From small beginnings around 5 men they now have over 20 in the group. Not bad for a group who are together less than a year.

Bingo Nights.

We have two bingo nights in the centre. Monday and Wednesday's. This is a popular past time especially for our older people.

Cherry Orchard Tae Kwan Do Club.

This group are together around a year and have taken on new members over that time. They are with us Tuesday and Thursday evenings.


St. Vincent de Paul Food Bank.

THE LORD MAYOR'S 5 ALIVE CHALLENGE 2019

The Lord Mayor's 5 Alive concludes on 30th March with the BHAA Dublin City Council 4-mile race on Saturday 30th March. The 5 Alive challenge is a partnership programme between Dublin City Sport & Wellbeing Partnership and the Lord Mayor's Office.

The Challenge is now in its 7th year and has encouraged hundreds of people to take up regular exercise over the past 6 years.

Last year the initiative went back to its roots and targeted people who were interested in taking up jogging or novice joggers who required some encouragement to sustain progress. The focus on encouraging new and novice joggers to sign up to the challenge continued in 2019. In 2018 the challenge also introduced mentors to accompany slower joggers and walkers and encourage them along each route. The mentoring aspect of the challenge also continues with 30 mentors appointed to support participants in the 2019 challenge. Each mentor has completed the 5 Alive challenge in previous years. Over 400 people registered to participate in this year's challenge which commenced in the Phoenix Park on New Year's Day.

In the event that a participant is unable to complete the 5 races they have the opportunity to substitute a race for one of the city's Parkruns. With reference to the proposed grant of a further licence for the use of part of the premises at Longmeadows Pitch & Putt Club, Sarsfield Road, Ballyfermot, Dublin 10.

By way of Agreement dated 18th October 2011 part of the premises at Longmeadows Pitch & Putt Club, Sarsfield Road, Dublin 10 which said part is more particularly shown outlined red and coloured pink on Map Index No.SM-2019-0188 was let by Dublin City Council under licence to Longmeadows Ballyfermot Pitch & Putt Company Limited for a period of 11 months from 1st July 2011 and subject to a licence fee of €100 (one hundred euro).

This licence was subsequently renewed and the most recent licence agreement expired on 30th November 2017 and the licensee has been overholding under same. The Council's Parks and Landscape Services Division of the Community, Recreation and Amenity Department have confirmed that they have no objection to the granting of a further licence on similar terms and conditions.

Accordingly, it is now proposed to grant a 3 year licence for use of part of the premises at Longmeadows Pitch & Putt Club, Sarsfield Road, Dublin 10 to Longmeadows Ballyfermot Pitch & Putt Ballyfermot Company Limited subject to the following terms and conditions:

- 1. The licence shall be for a further period of 3 years commencing on 1st December 2017.
- 2. The licence fee shall be €100.00 (one hundred euro) per annum.
- 3. That the licensee shall be required to sign a Deed of Renunciation.
- 4. The premises which is more particularly shown outlined red and coloured pink on Map Index No. SM-2019-0188 shall be open solely for use in connection with the activities of a pitch & putt club at a minimum of between the hours of 7.30am and one hour before dusk.
- 5. The licensee shall be liable for all outgoings associated with that part of the building used by the licensee.
- 6. The licensee shall at all times adequately secure the building against entry by unauthorised persons or damage by third parties and maintain a safe and secure environment for all users of the facility including the taking of all reasonable steps


to prevent undesirable persons gaining access at any time which shall include the locking of all doors, windows and all other apertures of whatsoever nature located within the licenced area.

- 7. Dublin City Council will arrange a fire and security maintenance and monitoring contract. The licencee will pay 50% of the call out charge in relation to key holding and alarm response service.
- 8. The licence shall be non-transferable.
- 9. The licensee shall provide and maintain services within the pavilion such as catering facilities and shop as agreed with Dublin City Council and shall provide club hire as required.
- 10. There shall be a prohibition on the sale or consumption of intoxicating liquor on the premises except with the written consent in advance of the licensor, along with the licensee obtaining a Court order and complying with all statutory requirements in this regard.
- 11. The licensee acknowledges and agrees that the building is a no smoking area in its entirety.
- 12. The licensee to inspect on a regular basis the state of repair and condition of the unit and to immediately notify same to Council. The cost of repairs will be incurred by the Council unless caused by the negligence of licensee or invitee, employee etc. The licensee shall keep the premises in good condition during the term of the licence and shall not remove or permit the removal of the fixtures, fittings and appliances from the building.
- 13. The licensee shall operate and run the facility on behalf of Dublin City Council in accordance with the principles of good business management and further, with a view to maximising the potential of the Pitch & Putt Club as a sports facility.
- 14. The licensee shall prepare and produce financial accounts and other relevant information in accordance with Dublin City Council's requirements.
- 15. The licensee shall take out and produce Public Liability Insurance in the sum of €6,500,000 (six million five hundred thousand euro) and Employer's Liability Insurance in the amount of €13,000,000 (thirteen million euro) for any one incident with a recognised Insurance Company with offices in the State and the policy shall indemnify the Council against any liability as owner of the premises.
- 16. The licensor shall insure the building on its block policy of insurance for all its buildings in respect of fire, damage, damage through storm or tempest in accordance with the normal fire insurance policy. The licensee shall be responsible for insuring its' own contents.
- 17. The licensee shall not erect or exhibit any sign, board, placard, poster or advertising matter or any flag or banner on or outside the facility without first obtaining the written consent of the licensor.
- 18. The licensee shall be responsible for keeping the immediate environs of the licensed part of the building and the Pitch and Putt course clear of litter.
- 19. This licence does not confer any rights under Landlord and Tenant Law and may be terminated by the Dublin City Council, giving two months notice, for any breach

- of the conditions of the licence and such other terms regarding termination as determined by the Law Agent.
- 20. Each party shall be responsible for their own legal fees in the transaction.
- 21. If the Company formally disbands the facility will be passed back free of charge to Dublin City Council.
- 22. On termination of the licence the licensee shall at their own expense remove all materials not belonging to Dublin City Council and shall leave the property clean and cleared to the satisfaction of the Council.
- 23. The licensee shall organise the order of play on the course and generally ensure appropriate behaviour of those using the course and pavilion. The licensee shall facilitate individual and group pre-booking. The licensee shall undertake day-to-day housekeeping such as lighting, heating, cleaning and keeping in good order the facilities in and around the pavilion including the supply of cleaning materials, towels, toilet rolls etc.
- 24. The licensee shall provide reliable, experienced and trained personnel at all times to deliver the required level of service.
- 25. Initially EV chargers were installed throughout the City by ESB E-cars. The ESB as statutory undertakers did not have to seek permission for the installation of the chargers. Due to funding issues the ESB ceased rolling out EV chargers and now only maintain/upgrade the existing EV chargers.

The Department of Transport established a Low Emission Vehicles (LEV) Taskforce Working Group in 2017. The working group is led by the Department's Climate Change Unit and comprises members from the Department and members from the Department of Communications Climate Action and the Environment, the Department of Housing Planning Community & Local Government, the Department of Public Expenditure & Reform, the Department of Finance, the CCMA, Sustainable Energy Authority of Ireland (SEAI), Transport Infrastructure Ireland (TII), the National Transport Authority (NTA) and the ESB.

The objective of the working group is to present a range of 2020-2025 vehicle growth scenarios, recommend a revised national LEV target for 2020, accompanied by a roadmap and to link these growth rates to a range of stimulus options and public leadership measures. The working group surveyed parking operators, both private and local authority and sought parking operator's views regarding the installation of charging infrastructure in their facilities and potential incentives to encourage more widespread deployment.

The Council as co-chair of the Smart Docklands Energy Action Group agreed in 2018 to investigate the feasibility of installing EV chargers and undertook to undertake a trial installation on Sir John Rogerson's Quay. It is expected that this EV charger will be commissioned in Q2 2019 and this experience will inform the Council's policy on the possible further roll out of EV chargers.

<u>Reply</u>

It is the policy of Dublin City Council to maintain the stock of 3,000 plus litter bins and to ensure that bins are located at the most effective locations to cater for the needs of the city population. The policy is to ensure that bins are located in close proximity to significant litter generators and in areas of high pedestrian footfall. Significant litter generators and areas of high footfall include:

- Neighbourhood shops
- Schools / Educational Facilities
- Shopping centres
- Leisure areas
- Community centres / Facilities
- Major bus stops / Transport hubs
- Main thoroughfares / Arterial routes
- Car Parks

It is not the policy of the Waste Management Department to install bins in residential areas. In order to ensure that bins are located in the most appropriate locations to cater for levels of demand and to ensure that bins are adequately serviced and maintained Dublin City Council is using technology to assist in managing this aspect

of the service through QR code reporting, asset mapping and the use of smart bin technology. In 2017 /2018 as part of the objectives of the Litter Management Plan 2016 – 2018 over 120 dog fouling specific litter bins were installed in the 5 areas in conjunction with the area Public Domain teams. There are no further plans for the installation of such bins as these bins have had limited success in tackling dog fouling and have a low capacity. The criteria used for siting these bins at the time were:

- Areas of high footfall dog walking
- Proximity to Parks
- Proximity to open green spaces

In 2018 the roll out of a number of smart bins took place following a successful trial of these units. The installation of these units has been concentrated in confined city centre areas on service route basis as this is the optimum way in which to benefit from the technology. As part of the installation 50 units were located throughout the 5 areas again in areas agreed with local Public Domain teams to assess whether the locations identified would benefit from the increased capacity of the units. 4 additional units were installed in the South Central Area following receipt of funding for these units from the area department.

A further installation of these units in the North Inner City was undertaken by the North East Inner City Task Force and a recent installation in Dublin Docklands has been undertaken by Smart Dublin / Dublin Docklands office. Both of these installations have been carried out with the agreement of the Waste Management Department in respect of the locating and servicing of the units.

There is no variation in the application of the criteria or policy in relation to the locating or supply of litter bins between the 5 areas.
