7 Motion in the name of Councillor Anthony Connaghan

The Manager arranges for a re-design of the roundabout at the junction of Mellowes Road and Finglaswood Road which would lead to less confusion for drivers approaching when oncoming cars are turning right.

To ask the Manager to arrange for a speed ramp between 39 and 63 Abbotstown Avenue. Cars regularly speed along this section of road and there are lots of children living along here.

To ask the Manager to arrange for an inspection of the footpaths along Mellowes Road. Residents have reported the poor condition of these paths for a long time but are consistently told the roads are in satisfactory condition when it is visibly clear that this is not so on many parts of the road.

To ask the Manager to arrange for tree planting along the top end of Mellowes Road (81 onwards) where there are barely any trees in comparison to other roads in the area.

To ask the Manager to arrange for housing maintenance to call back to (details supplied) to carry out works which were due to be done within 6-8 weeks in April please? New vents, installation and some other works were due to be carried out.

Q.19 Councillor Emma Murphy

Residents have stated that they have reported horses as they were concerned for their safety & welfare but little or nothing is done. I also have had issues when contacting DCC regarding the (details supplied). Can the manager detail how many staff locally or across the city are dedicated to working for the (details supplied) and the best way for the public and councillors to contact them.

To ask the Manager if DCC can look into the anti social behaviour taking place on the green on (details supplied). Railings were put in place but there is still anti social behaviour taking place.

This issue is constantly raised with me as there is constant anti social behaviour, motorcycles racing through the estates and open drug dealing taking place. Life for residents is being made a living hell. Some of the anti social behaviour is taking place in & around DCC properties according to some residents. Residents have been in touch with Gardaí but there has been no change in the situation, it is becoming a desperate situation.

Traffic in the morning is nearly always backed up (details supplied), the situation is worse than the old railway crossing. Cabra Area Office Report

<u>Blackhorse Avenue – Section 2, Road Improvement Scheme</u> An update on progress to date was circulated to residents in October.

Chapel Crescent

We have engaged Westside Engineering to install a railing on top of the existing boundary wall as a safety measure to prevent children in particular from scaling the wall or otherwise putting themselves at risk .This is in response to resident's requests and subsequent investigation.

Dalymount Park Project

As Shelbourne FC has now agreed to share Dalymount with Bohemians, the redevelopment project can now be progressed. A Project Steering Group team involving officials from Dublin City Council, Bohemians, FAI and Shelbourne has been set up. The Area Office will be represented by Aidan Maher and Fergus Synnott.

The purpose of the Steering Group is as follows:

- > To provide and assist Dublin City Council and the Council's appointed design team in the designs plans of Dalymount Park
- > To encourage and strengthen a working and functioning relationship between Dublin City Council, Bohemian FC, Shelbourne FC and the local community.
- To work towards the goal of having a top class municipal stadium managed and owned by Dublin City Council and shared between Bohemians FC, Shelbourne FC and the wider local community.

DCC are currently in the process of compiling tendering documents for a design team for the project, with the project being completed in 2020 at the earliest. However, no funding stream has yet been identified.

The DCC project leader, Don Daly, has been invited to present an overview and update to the December NWAC meeting.

Faussagh Upgrade Project

A topographical survey of the pavement along Faussagh Avenue between Quarry Road and Ratoath Road has been completed. The work has been undertaken on behalf of the Roads Department to determine the location and extent of underground services in advance of upgrade measures, such as the installation of tree pits. Parks Services are working on a design proposal for the scheme which will be submitted to the parish priest for consideration by the Parish Council on the section of land at the front of the church grounds.

The target date for the completion of the main works is summer 2017.

Dublin City Council is providing support to the Gardai to ensure that the cctv camera on the road is operating effectively.

Liam Whelan Bridge

I have reported the recent graffiti to the LUAS Liaison Officer who has promised to have it removed as soon as possible.

Newsletter with updates on progress recently circulated to residents.

Mt Bernard Park

The Children's Play Officer, Debbie Clarke, held a meeting in the Cabra Office on the 10th October to outline plans for the further development of the children's play area to parents. She is now following up on issues raised and will hold a further meeting with parents, which is yet to be scheduled.

Ormond Print premises

Derelict Sites Section have inspected this site and judged it as not warranting action under the Derelict Sites Act.

Phibsborough Local Environment Improvement Plan

A nomination is sought from amongst councillors to represent the North West Area on the Implementation Group which is being established. It will also include a representative from Central Area.

Shandon Gardens canal bank wall

We are still awaiting a response from Waterways Ireland on the request for co-funding of the repairs and reinstatement.

Tolka Valley Greenway Park

Unfortunately there have been a number of antisocial incidents that have impinged upon local residents in Rathborne, and Pelletstown. I am arranging a meeting with Cabra Gardai and the Parks Supervisor to see how security can be improved. Parks Section has introduced measures to restrict motor bikes in the park.

COMMUNITY & SOCIAL DEVELOPMENT

Halloween

Halloween was relatively quiet in the Cabra Area due to the co-operation of residents, the efforts of the Public Domain and Housing Maintenance crews removing bonfire materials in advance, and also the support of the Gardai. The outstanding bonfire materials were removed from locations at Ashington, Killala and Dunard after they had been allowed to cool. Alternative activities were very successful, particularly the Halloween Night Event in Naomh Fionnbarra. A mini festival was held in Naomh Fionnbarra G.A.A. Club on Halloween night with a "Haunted House" and disco catering for over 1,000 people. Cabra Mens Group contributed considerably in the management of the entire evening.

St. Eithne`s Ring Residents and Ventry Park Residents organised similar events in their respective areas.

All events were supported by the City Council.

Cabra Drive

A new residents association has formed recently in Cabra Drive as a result of the overall Pride Of Place activities.

Phibsborough / Glasnevin.

Phibsborough Tidy Towns are continuing with their ongoing activities and in particular the Royal Canal Bank Residents Group's local environmental improvements which cover an area from the Royal Canal to Phibsborough Library.

Arrangements are being put in place to facilitate the Lighting of Christmas Trees in Cabra.

Barry Area

The Local Area Office, the Anti-Social Policy Unit, Dublin City Council's legal representative and the Finglas Drug Sergeant have arranged a meeting this month with a view to moving forward with initiating legal proceedings for the recovery of the dwelling that is causing serious problems in the Barry area.

Fairlawn Park

Kelly Blocks were installed at 9 Fairlawn Park to stop individuals using it as a walkway between Prospect Hill and Fairlawn. This has not worked as more of the 9" thick wall was dismantled to gain access.

This property has been registered with the Derelicts Sites Section and contact has been made with the Management Company dealing with this property with a view to resolving the issue.

Barnamore Park

There are still issues of anti-social behaviour around 25 and 25A Barnamore Park, particularly 25A which is constantly being dumped in and was recently set on fire.

25A Barnamore Park is registered with the Derelict Sites Section and every effort is being made to contact the owner.

25 Barnamore Park is not being registered with the Derelict Sites Section, as it does not meet the criteria at present. However, it is being monitored and will be reviewed.

Scribblestown Flat Roofs

Approval has been granted for the ten remaining flat roofs to be completed in the Scribblestown development. Works is due to commence within ten days.

Saint Finbarr's Court.

The review of the proposed apartment size for the units in St. Finbarr's Court is ongoing and is expected to be completed in the next two weeks. Subject to a further review with the planner the Part 8 process is due to be then launched.

There are five tenants left in Block 2 St. Finbarr's Court. Alternative accommodation has been identified for four tenants and they will be relocated as soon as the repair works have been completed. A suitable vacancy is being sought for the remaining tenant.

Rapid Housing - St Helena's Drive Update

ABM Construction has started work on the construction of 39 houses at St. Helena's Drive.

One house has been dropped from the plan to allow the extension of back gardens of house numbers 11 to 17 Gortmore Drive.

The construction of the 39 houses will take approximately 32 weeks.

Update on Kildonan Lands Project

Due to the lengthy period required by the consultation process the timetable for completion of the Brady Shipman Martin (BSM) masterplan report has been extended.

Arising from a recent incident WFTRA have decided to withdraw from all engagement with Dublin City Council, the Dublin Regional Homeless Executive and the various statutory agencies and service providers in the Abigail Centre. Pending resolution of this hiatus no date has been fixed yet for the next meeting of the Development Group. However, a meeting with WFTRA and the Deputy Chief Executive will be held soon. It will be an open Agenda. I will be in attendance.

COMMUNITY & SOCIAL DEVELOPMENT

Community Grants Scheme 2017

Applications under Dublin City Council Community Grant Scheme closed on Friday 28th October. Community and Social Development Staff assisted a number of groups with completing their applications and will begin processing grants shortly with a view to presenting a draft list of recommendations to Councillors in early January 2017.

Finglas Halloween Festival 2016

The Finglas Halloween Festival "Finglas Fright Night," took place in the Finglas Civic Centre on Monday 31st October from 6.00pm to 9.00pm. The numbers attending continues to grow each year. People travelled from many parts of the city to attend the event.

There was a wide variety of entertainment for families to enjoy on the night, from carnival rides, bouncy castles, old fashioned game stalls, maze of misery, a spooky graveyard, magician, face painting, fancy dress competition, food stalls, fireworks display and the main music stage.

The event was advertised with flyers, and advertising boards were posted throughout the Finglas area. We decided not to use the festival website: instead, we focused on social media to help with the promotion of the festival. The festival now has a Facebook page and a Twitter account. Both accounts were very active with over 7,000 hits on the Facebook page alone. The main Dublin City Council social networking pages, including our Fire Brigade pages, also promoted the festival.

The event is managed by the Community and Social Development team with the assistance of staff in the area office, leisure centre and parks department. The event management, including health and safety was contracted to Cuckoo Event Management. The construction and derig of the site was also contracted out. Civil Defence and Order of Malta attended the event. An Garda Síochána attended and, with the assistance of the security company, monitored the crowds throughout the festival site.

The Finglas Youth Resource Centre hosted the refreshment area for volunteers. They also hosted the maze of misery, which included some of their young people performing in the maze. The Centre had a six week arts programme leading up to the festival which culminated in their interactive graveyard on the night itself. The youth centre also managed the stage entertainment. The majority of entertainment on the night was performed by local young people. It is very encouraging that the youth centre reported an increase in young people wanting to be involved in the festival.

Each year Dublin City Council invites local community groups to help with ticket sales for all the attractions. Ticket sales go towards the groups fund raising efforts. It should be noted that the success of the Halloween Festival would not happen without the input of so many dedicated volunteers.

- Businesses in the industrial estates in the NWA visited by a Litter Warden and a member of the Public Domain team, given a leaflet and advised on the need to secure flammables in the weeks prior to Halloween.
- Regular inspections of voids and green areas were conducted by Public Domain Staff throughout the NWA to check for the presence of stockpiling.
- Co-ordinating Conferences were convened with the Gardai in the Finglas/Cabra and Ballymun areas and attended by DCC Public Domain, Waste Management, Housing and Parks Staff. This ensured a high level of communication and co-operation in the lead up to and over the Halloween period.
- Flammables were collected by Waste Management, Parks and Public Domain Crews as located or reported.
- Approximately 250 tyres, 150 pallets and large quantities of wood were removed prior to the Halloween weekend.
- Additional grab lorries were provided through DCC Parks for use in the NWA over the Halloween Period.

Actions over the Halloween Weekend:

- In co-operation with the Gardai, Waste Management and Parks, stock piles, including an estimated 350 tyres, over 400 pallets and large quantities of wood were removed from over 40 locations over the three days of the Halloween weekend. In all, this constituted nine grab trucks and several trailer loads of bonfire materials removed throughout the NWA over the three days.
- The assistance of the Gardai was required at many locations, including five locations where Public Order Personnel were deployed to protect crews in the removal of stock piles or built bonfires.
- The Halloween Fright Night Festival in Finglas and the Ballymun Otherworld Festivals were very successful in diverting young people from bonfires and contributed to reducing the number of fires in the area.
- The NWA Public Domain Office was staffed from 8am-5pm from 29th 31st Oct. This was of particular benefit on Halloween afternoon as calls from members of the public reporting bonfire material were passed to crews and several stock piles removed as a result. In addition, Public Domain staff worked from 5.30am on 31st Oct, directing Parks staff to locations containing stock piles for removal.

Post Halloween clean ups

• Clean ups are ongoing in the NWA in conjunction with DCC Waste Management Parks and Housing.

Now that Halloween is over the emphasis has moved on to dealing with the annual leaf fall throughout the area. To achieve this DCC Waste Management have provided personnel dedicated to the removal of leaves, in particular on main roads. The Public Domain Team are also providing bags and equipment to groups and individuals to enable them to run leaf clean up events in their areas and are organising for bags of leaves to be collected.

Laneway Closed on Faussagh Avenue

Gates were recently installed to close the laneway adjacent to 54 Faussagh Avenue. This location has long been subject to illegal dumping and anti social behaviour and the public right of way was extinguished a number of years ago. It is anticipated that the presence of the gates will alleviate the problem for businesses with entrances onto the lane and for residents of adjoining dwellings.

Finglas Village 1916 Memorial Unveiled

The Finglas Village 1916 Memorial was unveiled by the Lord Mayor Brendan Carr on Saturday 12th November 2016 at an event held on site at The Seamus Ennis Road in Finglas Village. The monument, originally proposed by the Finglas Village Renewal Partnership in 2015 to mark the 100th anniversary of the Rising, was funded by the Partnership in cooperation with DCC and local business and community groups. The monument is constructed from sea grey polished marble and contains the National Flag and the flag of the

main organisations who took part in The Rising, The Irish Volunteers, Cumann Na Mban and The Irish Citizen Army. Seven trees will be planted shortly by DCC Parks in the area behind the monument to commemorate the seven signatories of the Proclamation. The presence of the monument at a high profile location in the village will ensure that the events of the 1916 Rising and their importance in the foundation of the state will continue to be marked in years to come in the Finglas Area.

Sports and Wellbeing Partnership Report

Marathon Kids is a citywide running programme developed to encourage 6th class pupils to embrace healthy, active lifestyles. The aim of the programme is to inspire children to run; and over eight weeks accumulate the equivalent distance of a Marathon – 26.2 miles! Resource booklets have been given to all pupils to assist with motivation and learning.

DCC Sport & Wellbeing Partnership have teamed up with Fingal County Council to build on the very successful programme rolled out by Fingal in 2015, which saw 22 primary schools and over 600 kids take part in this unique event. The 2016 programme commenced in September (with many schools from the NWA taking part) and will climax in a 'final mile' event and celebration to be held in the National Sports Campus, Abbotstown, on Sunday November 20th.

After-School Fencing Programme (Primary)

This is a 3-week programme involving pupils aged 8-10 years from a local DEIS School. Young people participating on the programme have been referred by the Home School Liaison Officer as requiring additional supports. The programme commenced on Thursday 10th November and will involve participants taking part in a fencing programme. As part of this programme they will learn the basic skills and etiquette of fencing. The programme is delivered in partnership between the primary school, parents, Home School Liaison, DCSWP Sports Officer and fencing coach.

Late Night League

The Late Night League is a very successful citywide initiative that is delivered in partnership between the FAI, DCSWP and An Garda Síochána. This is a 4-week programme involving young males from the local area. The programme will begin on Friday 18th November in Aughrim Street Sports Complex from 7-10pm. The aim is to give participants the chance to socialise with their peers on a Friday night in a safe and fun environment. The programme will culminate with a citywide final in Irishtown stadium on Friday 9th December.

• Christmas Activities (Cabra)

A programme of Christmas activities will be organised in conjunction with the Local Youth Service & Community Development Project. Activities will take place in the local GAA club, the youth service and also off-site such as trips to Kiltiernan Ski Club, Ice Skating and Stadium Tours etc.

Older Adult Programmes

Go for Life – This programme takes place every Monday from 1-2pm in Cabra Parkside Community & Sports Complex. The aim is to promote physical activity and encourage social support among the participants. The programme involves three throwing games where participants throw, lob and bowl items towards a target. The sessions are guided by the participants in terms of competitiveness. Challenge matches against other groups across the city are planned.

Walking Football – This programme is delivered every Tuesday from 11-1pm in Cabra Parkside Community & Sports Complex. The session is delivered in partnership with Cabra Development Programme and the FAI. The programme is open to men aged 55 years and older. It involves the same rules as ordinary soccer except players are not allowed to run. The aim of the programme is to provide an opportunity for men to take part in physical activity in a fun, friendly and social setting.

- **Ballymun Older Adults Sports Day:** Poppintree Sports & Community Centre, Friday December 9th, 11am -3pm (includes a variety of sports)
- Outdoor Activities Programme: Weekly outdoor pursuits programme throughout November for young people in the Poppintree/Ballymun area. Activities include mountain biking, kayaking and rafting.
- Boccia with Whitehall Stroke Support Group: DCSWP Sports Officer will be delivering some Boccia sessions over the course of 6 weeks beginning on November 17th. It is hoped to have a tournament on the final day.

Multi-Sport After School Programme with St. Helena Resource Centre:

1. Community Update

Ballymun

Events

The Otherworld Festival 2016 took place on Monday the 31st October beginning with the newly revamped colourful community parade setting off from the two sides of Ballymun, Shangan and Poppintree, connecting up and arriving at the Ballymun Plaza for the opening of the main event at 6pm. The emphasis this year was on inviting even more community groups from the local area to become involved in and play a greater part in the Festival. New groups that came on board this year included Doon Court Residents, Belclare Park Residents, Ballymun Mens Shed and Baile an tSeachar Laoch Residents. Among the new Festival standouts were

- 1. The fabulous and magical Spirit garden designed by local community artists in collaboration with BRYR Youth Project, Aisling Project, Poppintree Youth Project and local schools.
- 2. The Witches Brew Café, organised and run by the Sillogue Ladies group, which offered tea/coffee and spooky home baking with proceeds going to Pieta House.
- 3. A silent disco, which allowed young people to dance while wearing luminous paint and
- 4 Spooky storytelling sessions in Axis Theatre.

All elements of the festival were extremely successful and included: Circus Gerbola, Kiddies Carousel Rides, Setanta GAA Trad Tent, Main Stage Events/Acts with Giant TV Screen. The event culminated with a fantastic Fireworks Display at 8:45pm. The festival is organised by the Ballymun Festival Steering Committee in association with DCC, Axis, Gardai, Local Youth Projects, schools and community groups. The festival attracted over 5,000 people and was extremely successful.

<u>Christmas Tree Events</u>: The team members are working with local communities on Christmas Tree Ceremonies. Dates agreed are as follows:

- Friday the 2nd December, Ballymun: Renaming of Plaza Event from 5pm, (Ballymun plaza to be renamed as Cearnog an tSeachtar Laoch with a new sign erected), Christmas Tree lighting event from 6pm. Lord Mayor Cllr Brendan Carr will be in attendance at this event.
- Drumcondra: 3pm. Details to be confirmed.
- Friday the 9th December, Santry, Santry Community Centre, time to be confirmed.

Social Inclusion

Ballymun Safety Week:

The Community Team helped with a number of elements of Ballymun Safety Week including judging the schools poster competition and assisting with the launch. They also organised and held a safety information evening for Older People which took place on Thursday the 20th October at 6pm. This was organised in conjunction with Local Community Gardaí, Fire Brigade Service, Citizens Information and Third Age. It attracted a number of local people including members from a new active retirement group from Iona Road.

Men's Sheds:

Team members assisted in the organisation of and attended the Irish Mens Sheds Association National Conference in Belfast on Saturday the 22nd October, and continue to

work as an IMSA advocate for North Dublin Area. A meeting took place with a psychologist from St Michaels House around the idea of setting up a specific men's shed for their service users

An additional community event to be agreed with Ellenfield Residents for Whitehall Area.

Environmental

Work is continuing with local environmental groups as we move toward the bulb planting season. Work was carried out with local residents and GAP to enhance planting beds in Gateway Gardens and in Ard na Meala.

General Community Development

The annual Community & Social Development Grant Scheme closed Friday the 28th October. A number of community groups were assisted with filling in forms. Ongoing encouragement is being given by team members for groups to be set up under more formal structures that will allow them to access more funding, allowing the groups to become more sustainable. Meetings took place with Santry Community Centre, Poppintree Early Learning Centre, Aisling Transition, Active Living Ballymun, Sillogue Ladies Club, Magenta Crescent Residents and a local consultation took with residents of Magenta Hall and the Parks Department around new plans for the enhancement of the tree boundary at Swords Road.

Cabra, Phibsborough, Glasnevin, Pellettstown.

Halloween

Halloween celebrations were very successful this year. A mini festival was held in St.Finbarr's G.A.A. Club on Halloween night with a "Haunted House" and disco catering for over 1000 people. Cabra Mens Group contributed considerably in the management of the entire evening. St. Eithne's Ring Residents organised a similar event on the "Ring" as did Ventry Park Residents in Ventry Park. All events were supported by the City Council.

Stoneybatter Pride of Place.

A new residents association has formed recently in Cabra Drive as a follow on to the overall Pride Of Place activities.

Phibsborough/Glasnevin.

Phibsborough Tidy Towns are continuing with their on-going activities and in particular the Royal Canal Bank Residents Group's local environmental improvements from the Royal Canal to Phibsborough Library.

Christmas Events.

Arrangements are being put in place to facilitate the Lighting of Christmas Trees in Phibsborough, Stoneybatter and Blessington Basin.

2. Housing/Estate Management Updates

C.C.T.V

Ballymun Community CCTV system has two separate operating systems, one of which is reaching the end of its useful life and requires replacement. This is being planned at present. The entire system has undergone planned preventative maintenance in recent weeks, this work included checking all of the cameras and updating the monitoring station in the control room.

Cleansing / Waste Management

Waste Management and the area office are continuing to combat illegal dumping at open spaces. These measures include using the C.C.T.V system to monitor and identify those responsible. The area office has targeted illegal dumping around Coultry, Druid and Knowth Court and St Margaret's Road, a number of tenants have been called and warned about their behaviour.

West Ballymun Update

Halloween

Dublin City Council have made a huge effort to ensure a speedy clean up after Halloween period. There is still some debris smouldering and that will be removed as soon as it is safe to do so. The Public Domain Officer in the Ballymun area, Cleansing, Parks and Estate Management all played a part in ensuring all reports of hoarding bonfire material was responded to. As a result the volume of bonfires on the west side of Ballymun was reduced in comparison to other years. A number of spots that would have been used for bonfires in the past were not used (Belclare Green, Cranogue Road, and Balcurris Park).

Courts

Estate Management have met with residents from Knowth Court with a view to continuing the painting and estate enhancement programme that has been ongoing in 2015 and 2016. The more established groups are getting ready to review the year and set their targets for 2017 with the help of the Sillogue Neighbourhood Centre facilitators Linda and Val. Speed ramps have been installed on Carraig Road to reduce speeding. Dublin City Council has engaged a contractor to repair and resurface paving slabs in identified courts. Bollards have been installed in Cranogue Road as a traffic calming measure also. Dublin City Council is working with the residents of Druid Court with a view to identifying areas that need improvements in the public lighting in the courts. Estate management carried out 12 interviews relating to reports of illegal dumping in the Poppintree area. All of those who attended for interview had to submit proof of their waste collection. Dublin City Council is working closely with the Public Domain Team in tackling the issue of illegal dumping in the area. There has been an increase in the amount of graffiti in the area. This has been logged and is to be removed.

East Ballymun Update

Pyrite

Pyrite works are in progress in the Carton Area on the first five houses. Families were moved temporarily into the local area and are expected to be home before Christmas, the expected date for moving back is the end of November. All residents will be informed of potential move dates and phases in the coming weeks. This will be done by letter drop and calling door to door. Anybody with enquiries can contact Connell McGlynn on 222 5730.

Halloween Clean Up

The Cleansing Section and the Public Domain Section in conjunction with the Area Offices were busy clearing illegal dumping ahead of Halloween. An information campaign was ongoing in industrial estates and housing estates for the need to keep all sorts of materials secure and prevent illegal dumping on the run up to Halloween. This resulted in a large amount of burning material being removed from the area and reduced the amount of bonfires in the area to two fires, which the Parks Section cleared in the following days.

Coultry/Shangan/Forestwood

The local office is engaging with new community groups in Shangan, Whiteacre and Coultry which resulted in new neighbourhood initiatives. GAP is engaging locals in these projects such as clearing parking bays, tree pits and footpaths. Work on the tree pits in Forestwood and Sallowood is now complete. Residents continue to work to keep these areas tidy and work on planters, monitor the upkeep of gardens and green spaces. Most areas now have active resident involved in keeping the area in good shape. Dublin City Council continues to supply equipment and the planting materials required. Dublin City Council are currently getting tenders/ prices to have all houses treated and washed in the Woodhazel and Coultry Terrace areas.

Shangan Avenue

Issues with snagging and solar systems in Shangan Avenue will finally be resolved in the coming weeks. The solar contractor has been in the area in the past two weeks fixing and replacing solar panels and will continue resolving any issues with the internal solar system.

3. Ballymun Economic Development/Town Civic Alliance

1. Economic Strategy

The Economic Sub-Committee is due to meet on 17th November 2016. The EDO set up meetings with the IDA and CBRE to identify employment opportunities for the area. These meetings were also attended by Pamela Connolly (LAP) and Fiona Cooper, DCC Planners.

2. Stimulating economic activity

i 'StartUp Ballymun' 26th October 2016 - (detailed report is attached)

'Growing Your Business in a Digital World' took place on 26th October 2016. Seventy seven people registered for the event with a further twenty five registering on the day. Nearly seventy people attended.

The event included presentations from six experienced entrepreneurs who shared their knowledge on all the different cloud based tools they use to run their business. In addition there were presentations from the LEO Office Dublin City on the website grant of €2.5k and one to one business mentoring.

ii. Ballymun4Business (B4b)

- The network meets every two weeks. The last two meetings have been held in Adult Read & Write and SVP
- There are now thirty active members
- The tender for a new website closed on Friday 21st October. The proposals that were submitted will be reviewed on 10th November with a view to selecting a successful bidder.
- A banner of the B4b group is now on display on the Towers Pub. It has lead to a number of enquires about B4b
- A number of small initiatives are in the pipe-line including pay and display angels for a morning in the car-park to acknowledge the launch of the banner.
- In the process of opening a new bank account.

iii Enterprise Space

Two new businesses connections were made as a direct result of the role of EDO. A food start-up contacted me through the Start-Up Ballymun event in April looking for space in Ballymun. A connection was made with John Eniola in the old enterprise centre in St. Margaret's Industrial estate and a deal was struck. The business is due to open shortly.

I was contacted via the DCC website about available space to run a business that services Airbnb clients. Again a connection was made with John Eniola in the old enterprise centre and the business is now up and running.

iv. Vacant Neighbourhood retail units – The Economic Development Officer now has access to the vacant DCC units. A brochure has been produced to market each of the units and 'To Let' signs have been produced. The current status of vacant DCC units is:

Civic Alliance Update

The next meeting of the Civic Alliance is scheduled for 1st December 2016. A meeting of the Social Sub Committee will be held on 14th November 2016. Items to be discussed include an update on Innovate Dublin. A meeting of the Economic Sub Committee will take place on 17th November where Liam Barry will give an update on the 'Start Up Ballymun' event held on 26th October. The next Physical/Environmental Sub Committee meeting will take place on 24th November 2016.

<u>Update on the Shopping Centre:</u> An Bord Pleanala oral hearing for the Ballymun CPO has been adjourned to the 24 November 2016. Terms have been agreed (subject to Planning Permission) with Ballygall Credit Union for relocation to the Ballymun Civic Centre.

<u>Update on the Northern site Ballymun</u>: A number of proposals were submitted by the deadline on the 2nd November. These proposals are currently being assessed and further clarifications on a number of issues have been sought. A deadline for return on these clarifications is 12 noon Monday 7th November 2016.

<u>Update on the Housing site:</u> Draft disposal brief for a site at Balbutcher Lane/Cranogue Road to be brought before this North West Area Committee meeting.

4. Safety Fora Updates

Safer Ballymun

The Safer Ballymun week was launched at the last Safer Ballymun meeting on October 18th by Councillor Andrew Montague (Deputising for the Lord Mayor). Councillor Montague welcomed everyone to the meeting and stated how important it is to ensure Ballymun is a safe place to rear a family and to work. He made reference to his own family and how Safer Ballymun is a great forum to deal with issues of safety in the area.

Residents from Doon and Knowth Court gave a review of the estate enhancement works and painting programmes they have been involved in throughout the year. There was a display of before and after pictures. The residents won numerous awards for the work they have carried out during the year. The meeting was well attended and finished with light refreshments. The next Safety meeting is scheduled for 13th of December at 7pm.

The Safety Week was very well received in the community with great participation by local schools and senior citizens. The Community Garda held a number of Safety talks in the Senior Citizen complexes. There was also the open day in the Garda station that was visited by the schools and residents. This is always very well attended. BRYR organised games in the parks. The Community section held an information evening for Senior Citizens in the civic offices that were well attended. BADIG held an information afternoon in the Axis.

Halloween

Safer Ballymun would like to commend the work that was carried out by Dublin City Council staff in the lead up to and over the Halloween period.

Drumcondra Glasnevin Community Forum

The final meeting of this Forum this year is scheduled to take place on Wednesday 7th December. Please note the change of venue to the Skylon Hotel in Drumcondra.

Other Updates

Ballymun LAP

It is expected that the draft LAP will be published before the end of the year. The draft Housing and Tenure Report to assist in the preparation of the Draft LAP is complete and an information session was held with local Councillors on 8th November. The draft Bat Survey has been completed and requires review before its inclusion in the LAP.

Metro North

The NTA has informed us that they are to appoint a design team to undertake detailed route options analysis for New Metro North, which will determine an emerging preferred route, including exact route alignment and station locations, which would then go for public consultation.

Ballymun Infrastructure

A submission for funding was made by Dublin City Council to the Local Housing Infrastructure Activation Fund (LIHAF) for some of the remaining pieces of infrastructure in Ballymun to release housing sites:

- 1. New road link from Balbutcher Lane North linking into St. Margaret's Road to release the Balcurris 10/Naul Park lands
- 2. Sillogue Avenue Main Street Link Road, Sillogue Avenue Realignment and Gateway Crescent Extension to release sites in and around Sillogue including the old flat block sites
- 3. Shangan Road Main Street Link Road and Shangan Road attenuation area to release the site of the former Shangan flat blocks.

The Hamptonwood Link Road is being progressed separately. Subject to approval of the capital budget, funding for this is now to be provided in 2017 and 2018, with consultants to be appointed in 2017 to progress the scheme. The Draft Capital Programme also includes Balcurris Road Extension, Sillogue Avenue / Main Street Link Road for 2017 and 2018 and Gateway Crescent Extension for 2018 and 2019. All schemes are dependent on Section 48 contribution funding, or their inclusion in the LIHAF.

Shopping Centre

The Bord Pleanala Oral Hearing on the Ballymun Shopping Centre Compulsory Purchase Order (CPO) commenced on 26th October (ABP Ref No:29N.CH3290), but was deferred for a month to allow for possible negotiations. Agreement has been reached with the Credit Union who will be moving to the Civic Centre. The OPW are moving any remaining items from the Garda station and legal documentation is ready so that transaction should complete in the next few weeks.

Northern Site

A number of tenders were received in respect of the Northern site and are being assessed currently.

Attendance

A total of 77 people registered for the event with a further 25 people registering on the day. In all nearly 70 people were in the Council Chamber for the event. This represented a 150% increase on the April 2016 event. Furthermore attendees travelled from all over the City & County meaning we delivered on our objective of this being a North Dublin event. The Council Chamber provided an ideal venue and for most people it was their first time visiting. The free parking across the road meant the event was easily accessible.

It is therefore proposed to dispose of the City Council's interest in this site in fee simple to the ESB subject to the following terms and conditions:





With reference to the proposed grant of a lease of New Unit FG, plus one basement car space at Ballymun Civic Centre, Ballymun Main Street, Dublin 9.

Dublin City Council acquired freehold interest in the Ballymun Shopping Centre on 15th December 2014. As part of the de-tenanting process the Ballygall Credit Union Limited (formally Ballymun Credit Union Limited) are in the process of surrendering their leasehold interest in Units 20 & 21 Ballymun Shopping Centre and have agreed to relocate to the Ballymun Civic Centre.

In respect of the relocation it is proposed to grant Ballygall Credit Union Limited a 20 year lease in New Unit FG, Ballymun Civic Centre, Ballymun Main Street, Dublin 9 plus one basement car space number 68 subject to the following terms and conditions.

- 1. That Dublin City Council shall grant a lease for Unit FG, Ballymun Civic Centre which shall extend to approximately **179 sq.m.** or thereabouts, plus one basement car space number 68, shown outlined in red and coloured pink on attached Map Index No. SM-2016-0513 for a term of **twenty years.**
- 2. That the Ballygall Credit Union Limited shall lodge a Planning Application in respect of the Ballymun Civic Centre unit, with the consent of Dublin City Council, within four weeks of Council approval, or as soon as practically possible on a date mutually agreed between the parties.
- 3. That this proposal is subject to the receipt of full planning permission for the new Credit Union unit in the Ballymun Civic Centre.
- 4. That within four weeks of the final Grant of Planning Permission the Council shall grant a three month Works Licence to the Ballygall Credit Union Limited for the unit, for the fee of €1, if demanded.
- 5. That the licensed area shall be provided by the Council in shell condition with a party wall constructed
- 6. That all works shall be agreed in writing with the Council's Architect prior to the commencement of such works.

- 7. That the lease shall commence immediately upon the expiry of the Works Licence or as soon as practically possible on a mutually agreed date, for use of the demised area for the retail trade or business of a Credit Union.
- That the initial rent for the first five years of the term shall be the sum of €50,000
 (fifty thousand euro) per annum, payable quarterly in advance by standing order or electronic funds transfer.
- That the rent shall be subject to five yearly rent reviews to the market rental value of the unit at that time, on a vacant possession basis disregarding tenant improvement works.
- 10. That a break option in favour of the lessee/ Ballygall Credit Union Limited shall be granted at the end of year five, ten and fifteen. Written notice of intention to operate the break option must be given not less than six months prior to the break option date.
- 11. That the Ballygall Credit Union Limited shall be responsible for fully repairing and insuring the demise.
- 12. That the Ballygall Credit Union Limited shall be responsible for the payment of rates, facilities/service charges, building insurance, waste collection, utilities, taxes and all other charges for the demised area and car space.
- 13. That the Ballygall Credit Union Limited shall not assign or sublet the demise without prior written consent of the Landlord which shall not be unreasonably withheld.
- 14. The Ballygall Credit Union Limited shall not carry out any structural alterations or erect any external signage without the prior written consent of Dublin City Council.
- 15. That the Council shall retain a right of access for the purposes of maintaining services running through the unit.
- 16. That the Ballygall Credit Union Limited shall indemnify Dublin City Council against any and all claims arising from its use of the property. The Lessee shall hold Public Liability Insurance (minimum of €6.5 million) and Employers Liability Insurance (minimum of €13 million) and contents insurance.
- 17. That the lease agreements shall contain covenants and conditions as normally contained in agreements of this type.
- 18. That the Ballygall Credit Union Limited shall be responsible for the payment of any Stamp Duty that may arise on the creation of the lease.
- 19. That each party shall be responsible for their own fees and costs incurred in this matter.
- 20. That upon the granting of the Works Licence, or as soon as practically possible, the Council shall use its best endeavours to remove the sculpture from outside the new Credit Union Unit in the Ballymun Civic Centre, subject to all necessary approvals being obtained.

- 21. That each party shall be responsible for their own fees and costs incurred in this matter.
- 22. That this proposal is subject to satisfactory proofs of title.

The disposal shall be subject to any such covenants and conditions as the Law Agent in his discretion shall stipulate.

The dates for the performance of any of the requirements of the proposed agreement may be amended at the absolute discretion of the Executive Manager.

No agreement enforceable at law is created or is intended to be created until exchange of contracts has taken place.
