M97 Councillor Michael Pidgeon

To ask the Director of Services to see that Dublin City Council will devise a traffic calming plan for Islandbridge. The area is seeing huge footfall due to the nearby parks, and the new residential build has made it more into a village in its own right. The stretch of road is treated as an arterial route, with limited opportunities to cross the road. Greater provision for pedestrians and cyclists is needed.

Following on from the report: Rapid Assessment and Community Response to suicide and suspected suicide in Dublin South - commissioned after the rise in suicides in the Ballyfermot area, one of the further research pieces was around the connection between suicide in young women and domestic violence. Since then we've entered into a pandemic and we've seen a clear increase in domestic violence as one of the underlying conditions of the restriction of movement. Ballyfermot/Cherry Orchard doesn't have its own dedicated Domestic Violence worker and relies on the services in other areas. I'm asking that Dublin City Council, with support of the members, write to the Tusla DSGBV and support the call for a Domestic Violence Worker dedicated to the Dublin 10 area - for reasons outlined. Also that Dublin City Council provides a space within their properties in Ballyfermot and Cherry Orchard to ensure ease of access to this much needed service.

That all the Councillors for the South Central Area are asking that the Parks Dept. look at Grattan Crescent Park, Inchicore as a matter of urgency to look at addressing the following issues, following on from a petition signed by 230 local people. The Park has seen a major increase of anti-social behaviour with syringes being found, rough sleeping in the park, ongoing alcohol consumption. The park needs serious attention and it needs to be cleaned on a regular basis, signs need replacing where necessary, play equipment needs to be checked regularly to ensure it is safe, a bin is needed in the actual playground area to deter littering, out of control cow parsley weeds and buddleia next to the River Camac is out of control

and needs to be cut back. Residents are looking for an online community consultation process to be done as a way of influencing future upgrades in the park and ensure sustainability.

We are all very well aware of the recent substantial planning application for the Davitt Road of Drimnagh, Dublin 12. However, this and many other recent planning applications shows the need for a proper master plan for the Drimnagh area to ensure that needs come before profit as all too often development comes into an area without any due consideration of the community infrastructure. Drimnagh Residents Association are anxious that such a masterplan inform all future land uses and ensures proper integrated sustainability. Looking at the area, they are trying to ensure that Davitt Road does not become a long narrow lifeless area. Hence it needs proper public lighting, cycle lanes and the general area needs a traffic management plan looking at one way systems all to offer this well-established community an opportunity to grow and prosper.

Given the recent allocation of funds with the specific purpose of transforming outdoor spaces within our cities and towns as welcoming, vibrant places; also given the positive impact this will have on local economy; also given that the recent URDF strategy document has advocated for these facilities as part of the regeneration of the area this Area Committee agrees to:

- Trial the extension of the Inchicore Road Contra Flow Cycle Path from the junction of Inchicore Road and Memorial Road to the junction of Tyrconnell and Davitt Road.

- To provide planters that will segregate an outdoor seating area outside the Black Lion pub.

I regret that transportation policy seems to be informed at political level as opposed to community need. Hence if your area doesn't have senior politicians at Government level your area is forgotten about. I would ask that cycling infrastructure such as Dublin Bikes, which I have sought for many years are brought to the City County boundaries as a matter of urgency. Walkinstown, Drimnagh, Ballyfermot, Chapelizod and Cherry Orchard are the forgotten cousins in relation to this infrastructure.

SOUTH WEST INNER CITY ELECTORAL AREA

SOUTH WEST INNER CITY AREA REPORT

Francis Street Environmental Improvement Scheme – the Area Office is awaiting clarification from Roads Design & Construction on the proposed start date for this project.

Meath Street & Environs Public Realm Improvement Scheme – draft plans for Meath Street will be on public display along the street from Thursday 15th April for two weeks. Two online public information sessions are being held on Tuesday 20th April at 11am and 6pm. This informal consultation will allow the design team to gain initial community feedback on the emerging design for the street ahead of a planned Part 8 in summer.

Bridgefoot Street Park and Median: Covid restrictions have delayed work on the park, we are awaiting notification of a restart date.

A smaller project to green the median along Bridgefoot Street is now rescheduled to October to facilitate tree planting during the winter planting season.

James Street Median and Cromwell Quarters: a planting scheme and associated public realm works to the median at James Street and the steps at Cromwell Quarters is hoped to commence in July.

Local Area Greening and Street Tree planting: the Area Office and Parks Department are exploring a number of smaller greening projects for Carman's Hall, Blackpitts and Reuben Street/ Haroldville Ave and St Anthony's Road in Rialto. Surveying work will be undertaken over the summer to inform potential locations and allow wider engagement on the plans.

Oisín Kelly Park/ Basin Lane: various works are proposed to improve public realm here including repair and upgrading of the main boundary wall, relaying of footpaths in the area and the introduction of street trees. It is hoped to being the boundary wall work in late May/ June depending.

Cork Street: HSE Estates is currently inviting ideas from the community for a 5 year rolling programme of conservation and environmental works to its historic complex at Cork Street (Bru Chaoimhin, Weir Home and Quaker Burial ground). The call out is until 30th April.

Newmarket: Temporary uses in the public realm are being examined, which may form part of the City Recovery Plan.

Dolphins Barn : Funding for improvements in this area has been allocated and a programme is being prepared.

Economic Development

MODOS for Dublin 8 – Circular Economy Training: The Area Office is partnering with The Digital Hub to deliver this training programme for SMEs in Dublin 8 in June. A callout for applications will issue shortly.

Shop Front Improvement Scheme: the Area Office continues to invite applications for the shopfront scheme in SWIC. Dublin City Council is also currently offering grants to Tourism and Hospitality businesses across the city to facilitate outdoor dining. The scheme is funded by Fáilte Ireland.

KILMAINHAM INCHICORE NETWORK

Turvey Park:

Community and Institution collaboration is paying off. Vast improvements can be seen down in Turvey Park and it's down to the hard work of keen local gardeners in conjunction with DCC. It is of great credit to see how local residents working with DCC can lead to huge improvements to an area. Well done to all involved.

Camac Flood Alleviation Scheme Public Consultation:

A Virtual Information Event will take place on April 28th at 7pm. The event is being hosted to update interested stakeholders on the works that have been completed so far and to what works will be carried out in the near future. Bus Connects:

Bus connects completed its 3rd round of non-statutory public consultation in December 2020. All submissions are being reviewed and considered for the finalization of the Preferred Route Options Reports. It is expected that the statutory planning applications will be submitted to An Bord Pleanála (ABP) during June or July for its consideration and determination.

A formal statutory public consultation process will then be undertaken by An Bord Pleanála as part of their deliberations. During this process, the final Environmental Impact Assessment Report for each Scheme, plus Preferred Route Option Reports and Traffic Impact Assessments will be published and available for viewing. The public will again have the opportunity to have their views heard and considered by An Bord Pleanála as part of the process of their consideration of the proposals. For more information go to:

Civic and Community Space Subcommittee:

A co-design process with Bucholz McEvoy Architects has led this subcommittee. A Progress Report has already been sent to DCC and a Final Report will be sent once ratified by IRCF.

Meanwhile Activity and Community Building Subcommittee:

A new subcommittee is in the process of being set up to facilitate engagement between Local People – Sharing, Working together, Inclusion, cohesion, building trust, community ownership, pride in our neighbourhood.

Public Art Process Subcommittee:

This new subcommittee is in the process of being set up.

Education Subcommittee

The next meeting of this subcommittee is provisionally planned for Thursday 28th April.

Residential Informal Focus Group

As part of an early INFORMAL process around the design of the residential homes at Emmet Road, the Integrated Design Team are interested in having a conversation with future possible residents. A small focus group of people is being collated to engage in this conversation

Inchicore Sports Centre

Aaron Callaghan, Manager of Inchicore Sports Centre, is happy to meet with local groups and discuss access and usage of Inchicore Sports Centre. This is being facilitated through IRCF.

Kilmainham Mill

A construction team to carry out the enabling works for the mill is awaiting the easing of level 5 covid restrictions in order to work on the mill buildings.

Newcomen Bank Building:

Howley Hayes Architects has been appointed as the Architect led multi-disciplinary design team to carry out the phase one preliminary design process. A minor stripping out / enabling works package is being created.

A consultation process on the potential usage will commence shortly.

COMMUNITY

Iveagh Markets Folklore Project

As a follow up to the re-grouping of the 'Have You Memories of Dublin's Iveagh Markets' evening, a virtual get together evening was organized by the SWIC Community Development Team. For those who could not attend on the night and the many who did, a series of follow up telephone interviews will be taking place over the next few weeks.

All the stories and memories will be collected/recorded as part of an Oral History/ Folklore project commemorating Dublin's Iveagh Markets.

Swift Apartments for the Liberties

Just as swallows mark the beginning of summer in the countryside, the sight and sound of swifts in our cities is a true indication that summer has truly arrived. This year, migratory swifts returning to the Liberties are in for a pleasant surprise, as 12 new swift nesting boxes have been installed in the grounds of the beautiful convent of Warrenmount in Dublin 8.

Swifts are totally dependent on our built environment for breeding purposes as they nest in nooks, crannies, and crevices in older buildings, they also nest under roof tiles. Sadly due to the modernisation of our towns and cities swifts are running out of places to nest and their populations are in serious decline.

Thanks to the enthusiasm of swift enthusiasts like Sister Pauline Galey from Warrenmount Adult Education Centre, our Liberties swifts may be with us for some years to come.

Organised by DCC Community Development Section SWIC in conjunction with The Dublin Swift Conservation Group. Special thanks to DCC Civic Maintenance Section for their assistance.

Ceannt Fort - Environmental Improvements

Work has commenced at the entrance to Ceannt Fort Estate. The area has received a new look with the removal of the existing overgrown shrubbery and some trees, and by replacing with new trees and a new planting scheme. Also the area damaged at the entrance to the play area has been repaired. The yellow box on the roadway was fully reinstated following works.

Annual Spring Planting Initiative

The Community Development Team plans to again supply various community groups with a small amount bedding and perennial shrubs to encourage groups to undertake and maintain environmental work in their local area. The team is in the process of contacting groups and hopes to arrange the supply and delivery of same in the coming month. Groups will be requested to sign up to strict safety protocols with regard to receiving plants and communal planting will also be discouraged, in line with COVID 19 safety requirements.

Where the Wild Flowers Grow

This summer, Rialto's bee population and other pollinating insects will have something to feast on. Over the last two weeks 500 packs of native wildflower seeds have been given to local households, gardening groups and children's homework clubs. The seeds were packed into individual envelopes by local volunteers and distributed throughout the area. Residents also received a leaflet with information and tips on:

- Creating a wildlife friendly garden
- Encouraging wild birds, setting up nest boxes and bird feeding stations
- Anti - litter and dog fouling information
- How to protect and enhance local biodiversity
- Information on the National Pollinator Plan 2021
- The information reached over 4,600 people on Facebook. Feedback has been enormously positive.

This pilot project was organised by Rialto Environment Group in association with the Community Development Team.

Local History Talk - The Estate of Rialto Court

The Estate of Rialto Court, Street and Cottages is a distinct urban enclave which has witnessed much since the early 1880's when Sir Edward Cecil Guinness requested the Dublin Artisans Dwelling Company (DADC) commence building homes for his brewery workers at Rialto.

Once again Dublin City Council's Historian in Residence Cathy Scuffil presented a wonderful online talk on this historic part of Dublin on Thursday 15th April, 2021.

This event was hosted jointly by Dolphin's Barn & Inchicore Libraries in association with the local Area Office.

Public Domain

Four hundred meters of graffiti removed from the public domain at Thomas Street James Street, High Street, Cornmarket, Inchicore Village, Kilmainham-Bow Lane, Rialto.

PMAC completed gum removal and an intensive wash of Inchicore Village from Emmet Road to Grattan Crescent and Tyrconnell Road on April 9th.

Waste Management Public Domain Crew deep cleaned at Harcourt Lodge, Bulfin Estate and Rialto. Clean-up equipment was delivered to High Road Kilmainham, Harman Street and IEG.

A community lead clean-up took place on St. Albans /Raymond Street Lane. Public Domain provided skips and clean-up equipment. Community and public domain are working with the Mallin Avenue community on an environmental project. Meetings were held with Waterways Ireland to identify boundaries and responsibilities in relation to infrastructure maintenance.

BALLYFERMOT/DRIMNAGH ELECTORAL AREA

Park West/Cherry Orchard LAP

An application for funding for various projects, which was made to the Urban Regeneration and Development fund in 2020 was not successful on this occasion. Other funding opportunities will be pursued as they arise. As per the recent briefing to local Councillors, work on the preparation of a part * application for site 1 is ongoing, and should be presented to the Area Committee in September. Sites 4 and 5 are being advanced by the LDA. Surveying of the park will commence shortly.

HOUSING PROJECTS

Chapelizod/Springvale Site

71 Units

The Springvale site has reopened for construction work from 12th April. The timeline for completion of works is being reassessed because of the site closures.

3.8 Acre Site at Sarsfield Road

176 Units

The first meeting of the sub group of the SWG will take place on Friday 16th April. This group has been established to progress issues that arise between the full meetings of the SWG. Items for discussion include update on funding application to DHLGH, progress on the feasibility study on potential expansion of Sarsfield House for additional community facilities, discussion about potential refurbishment of Fr. Bidone Court and progress on distributing an Information Note to local residents living in areas close to vacant site at Sarsfield Road.

Cornamona Site

61 Units

The Cornamona site has reopened for construction work from 12th April. The timeline for completion of works is being reassessed because of the site closures.

Crumlin Road/Rafters Lane Site

Part VIII approval given for the proposed demolition of the former Scoil Eanna and Funeral Home on lands bounded by Crumlin Road, Rafter's Road and Rafter's Lane, Crumlin, Dublin 12. The redevelopment of the site will be the subject of a separate Part VIII Planning application. The library development will be a separate development.

Bluebell

City Architects is awaiting a response regarding their Stage 1 submission to the DHLGH.

Lissadell Maisonettes

Refurbishment works are still ongoing on the vacant two-bed maisonettes and will be let under Choice Based Lettings. One unit let in April with six vacant units remaining for refurbishment.

Skate Park Le Fanu Park

No further works have taken place due to Covid 19 restrictions but An Garda Siochana continue to monitor the area and there have been no further reports of anti-social behavior.

Kylemore Park

The upgrade of the Park has not been completed and some small works remain outstanding due to travel restrictions which has impacted the contractor.

Markievicz Park

Upgrade of picnic table and seating, installation of benches etc. still under discussion with supplier.

Ballyfermot Civic Park

Awaiting contract signing which is due shortly at which time a clearer programme of works will be devised over the coming months. Discussion ongoing regarding the proposed alterations to the tribute garden to accommodate a larger entrance from the civic centre plaza.

Ballyfermot Civic Centre

Discussions are ongoing with MABS regarding the relocation of their office space in the building. This is to facilitate the relocation of the café from the first floor to the ground floor to link with the upgrade of the civic park. It is likely that the HSE will be using the building for non covid vaccinations for about 5 weeks in the near future.

COMMUNITY DEVELOPMENT REPORT

Environment

Each of the five neighborhoods have local Environmental Groups and the Council Staff continue to support their work.

The Ballyfermot Environmental Group launched a monthly Community Clean Up on Saturday April 10th. It was great see 5 groups of residents from Drumfinn, Le Fanu, Cherry Orchard, Park west and the Clifden areas take part to clean their streets.

Strict social distancing was adhered to with residents wearing masks and keeping their distance from each other.

The next Community Clean Up will take place on Saturday May 8th. Residents interested in getting involved can email friendsofthesouthcentralarea@dublincity.ie

Momentum is building in Cherry Orchard for street clean ups with three streets already signed up for the next clean up on May the 8th.

The Tidy Drimnagh Committee has organised street leaders who coordinate regular clean-ups every month. On the 10th of April they concentrated on green areas and outside local shops.

The Walkinstown Residents Association plan to re-establish their clean ups in the coming weeks.

The Bluebell Environmental Group have a canal clean-up planned for Saturday the 17th of April at 10:30 and will be joined by the Bluebell Community Angling Club and The Inchicore Environmental Group. Socially distancing will be in place.

Chapelizod Tidy Towns have distributed equipment throughout the community to individuals to carry out individual /street Clean ups.

The City Council is funding the Cherry Orchard Community Garden to provide 1000 trays of bedding plants that will be distributed to local organisations during the month of May. This initiative will replace the Plant Sales for 2021.

The Ballyfermot Youth Organisations working together as "Unsung Youth" received funding to host, online events with a Grand Finale on June 8th, a Community Arts project and a vocal coaching course.

Ring Street Youth Centre received funding to organise a weekend online workshop with Robert Murphy, actor better known as, Buffy the Olympia Panto Queen.

Older People

The Community Call Helpline continues to be managed by Community Development Staff. The Helpline Ph. 2228555 operates 5 days a week to respond to requests for local supports, though the Helpline is not receiving many calls, it remains available to support vulnerable people at this time.

Community Knitting Project

The knitting project, established by the City Council and promoted by the Bungalow, Walk and Drimnagh knitters has been a great success. Older people have been provided with knitting packs and collectively have knit over 25 blankets that have been distributed through our sheltered housing schemes. The Council hope to set up knitting classes and clubs as a social outlet when the restrictions are lifted.

Bealtaine

The Council will organise webcam talks during the month of May, through the Church webcams to mark Bealtaine. Webcam Talks have taken place from three of the main churches in the area and have been a very successful way to contact residents that are restricting their movements.

The Council are working with the local Youth Organisations to organise planting of the communal areas in some of the sheltered Housing complexes during May.
