The Lord Mayor opened the Meeting and invited the City Planner to outline the process. The City Planner advised that this stage of the Development Plan process is to give strategic direction to the executive in drawing up the Draft Development Plan in line with planning legislation. Recommended strategic policies for each theme are set out in the CE proposed Draft Plan and on foot of which councillors submitted 301 motions. The response to these motions are in CE Report 316/2021. All motions agreed at this meeting will be incorporated into the Draft Plan while at the same time ensuring it is not repetitive and that it is internally consistent and user friendly. The matrix of motions will be used to manage the meeting.

The meeting administrator highlighted the councillors' responsibilities under the Code of Conduct in particular sections 4, 5 and 6 which deals respectively with conflict of public and private interest, councillors and the planning process and lobbying by third parties. Councillors must indicate to the meeting administrator if they or a connected person has a conflict of interest to any motion on the agenda so that the conflict and motion number can be declared, minuted and the councillor withdraws from the meeting until the item is dealt with.

Members were requested to email in advance the Lord Mayor and the meeting administrator with any motion to which they have a conflict. This will allow the Lord Mayor to pause the meeting while the administrator removes the individual from the meeting for the period of the debate on the indicated motion.

A roll call will be taken for first meeting. The meeting will be adjourned each evening until business concluded. Councillors present on one evening will be considered present for all evenings

It was also agreed that Votes when required will be taken by Modern.gov. All members should log in in advance of the meeting. Those who cannot gain access when vote called should indicate their desire to vote by raising virtual hand. Votes can only be made through modern.gov or orally on meeting.

The meetings will work through the motion chapter by chapter in numerical order with the exception of Chapter 14 which will be discussed on Wednesday after all other chapters are discussed.

- Motions will be taken as proposed by the main proposer or in the case of a Party/Group motion by the respective Group Leader and seconded by the Lord Mayor. For the Lord Mayor's own motions the Deputy Lord Mayor will second.
- Speaking time: Proposers will be allocated 90 seconds to speak to their motion. All other speakers will be allocated 1 minute.
- ➢ If there are no objections to a motion agreed or a motion agreed as amended then no speakers will be taken. Discussion will focus on motions where there is disagreement.

Taking of Motions Agreed by CE

The Lord Mayor will call for any objections to the motions:

- if there are no objections the motion will be put for verbal agreement
- ➤ if there are objections the objectors have 1 minute to express their objections
- > the motion will then be put to a vote
- > an Elected Member can request that their objection be noted for the minutes

Taking of Motions Agreed as Amended

The Lord Mayor will indicate that the Motion is agreed as amended and ask the proposer of the motion if they agree with the amendment

- if the proposer agrees with the amendment the Lord Mayor will call for any objections to the motions
 - if there are no objections the motion as amended will be put for verbal agreement
 - if there are objections the objectors have 1 minute to express their objections
 - o the motion as amended will then be put to a vote
- if the proposer does not agree with the amendment the original motion will be subject to the vote/debate
 - o the Lord Mayor will call for any objections to the original motion
 - if there are no objections the original motion will be put for verbal agreement
 - if there are objections the objectors have 1 minute to express their objections
 - the original motion will then be put to a vote

Taking of Motions Not Agreed by CE

The Lord Mayor will indicate that the Motion is not agreed and ask the proposer of the motion if they agree

- ➤ If the proposer agrees with the CE Response the motion will not be put and will be considered withdrawn
- > If the proposer disagrees with the CE response the motion will be put to a vote

Re-zoning proposals: It was agreed that all the re-zoning proposals would be dealt with at Wednesday evening's meeting. Proposals that are not controversial will be agreed without debate. Others will require a debate and following the debate will be voted upon to either:

- agree the proposed re-zoning and therefore leave it in the draft plan to allow for public consultation
- or reject the proposed re-zoning and therefore remove it

Richard Shakespeare, Assistant Chief Executive, Planning and Property Development Department, apologised for the way in which the zoning maps were brought to the attention of the members, and stated that it was an error on the side of the executive.

The meeting held on Monday 8th November continued in committee at 22.15 to discuss procedural issues. The meeting resumed on Tuesday 9th November at 18.15 and adjourned at 23.05. The meeting resumed on Wednesday 10th November at 18.15 and adjourned at 19.05 to enable Councillors to meet by Area. The meeting resumed at 20.05.

The meeting progressed over the three nights and the matrix was used to facilitate this with members issuing their directions to the executive. All items were dealt with.

Finally it was proposed by the Lord Mayor and seconded by the Deputy Lord Mayor

"That Dublin City Council, having considered the proposed Draft Dublin City Development Plan 2022-2028, in accordance with Section 11 of the Planning and Development Act 2000 and the amendments agreed to the proposed Draft Plan, hereby resolves that the Draft Dublin City Development Plan 2022-2028 is now prepared and that notice of the preparation of same be published and that the Draft Plan be put on public display in accordance with Section 12 of the Planning and Development Act 2000".

A full list of all decisions on the motions is detailed in **Appendix A** attached and details of recorded votes are in **Appendix B**. The meeting concluded at 00.20am on Thursday 11th November 2021 when all the business on the Agenda was completed.
