Q.1 Councillor Noeleen Reilly

To ask the Manager to clear the drains around (details supplied). Residents on both sides are complaining of a smell of sewage in and outside of their properties.

Q.2 Councillor Noeleen Reilly

To ask the Manager to look at repairing the footpaths on Belclare Drive, they are in a very poor condition for residents living there and it is the main walkway for residents in Poppintree to the Park.

Q.3 Councillor Noeleen Reilly

To ask the Manager to repair the walking path in Poppintree Park there are several defects all along it which may cause injury.

Q.4 <u>Councillor Noeleen Reilly</u>

To ask the Manager for an update on the housing development on Berryfield and if this can be expedited given the level of anti-social behaviour on the site.

Q.5 Councillor Noeleen Reilly

To ask the Manager to investigate and repair the footpaths on Dunsink Drive.

To ask the Manager when will the repairs to the road at the entrance of (details supplied) commence.

To ask the Manager for an update when the footpaths in Pinewood will be repaired, they are in very poor condition.

To ask the Manager for an update on the tree replacement programme in (details supplied), what has been replaced to date and what other locations are planned for replacement trees.

Q.11 Lord Mayor Caroline Conroy

To ask the Manager to reduce the height of the bushes along Coultry Gardens /Coultry Park to approx. 1 meter tall. Can they also thin out the undergrowth/ground ivy and trim the bushes to the entrance into this mini park. There are no sight-lines from the road into the playground which makes it feel unsafe. From a biodiversity point of view, now is the ideal time for cutting back the hedges and by keeping them to 1 meter tall, rather than full removal, they will still be used by small birds as nesting sites in the spring.

Q.12 Lord Mayor Caroline Conroy

To ask the Manager can we find a suitable place to plant a Miyawaki Forest in Dublin North West. Miyawaki forests grow in two to three years and are self-sustaining. They help lower temperatures, reduce air and noise pollution, attract local birds and insects, and create carbon sinks. One suggested place is near Ballymun Library.

Q.13 Lord Mayor Caroline Conroy

To ask the Manager to explain why there was no consultation with residents in Hillcrest about the 5G pole that is being put in place now.

Q.14 <u>Lord Mayor Caroline Conroy</u>

To ask the Manager why the area that has been developed as a sensory pocket park is being dug up by a utility company. Discretionary funding has been used to develop this area as a benefit for the community especially for children with special needs.

Q.15 Councillor Anthony Connaghan

To ask the Manager to arrange for a housing maintenance inspection of (details supplied). The tenant reports the need for works to the bathroom and also the kitchen.

Q.16 Councillor Anthony Connaghan

To ask the Manager to arrange for the tarmac landing alongside St. Joseph's GNS on Barry Road to be resurfaced. There are many potholes and trip hazards along this highly utilised stretch which is well used by kids and adults alike going to the two local schools and many people who use the bus stop here. Is there potential for planting/greening along here.

To ask the Manager to arrange for additional lighting to be installed at the end of (details supplied). Residents have reported that the lighting is very poor here and people can barely see where they are going.

To ask the Manager to arrange for the repair of the bathroom window at (details supplied)

To ask the Manager to arrange for the repair or replacement of the back gate at (details supplied).

To ask the Manager to arrange for the open hole in the concrete at (details supplied) to be covered over. It was reported to me that a child broke their leg here previously.

To ask the Manager to arrange for the gullies between (details supplied) to be cleared.

To ask the Manager to arrange for an inspection of the shower at (details supplied) where the tenant has reported heating issues.

To ask the Manager to arrange for a permanent repair to the road surface at the WFTRA bus stop. This has been temporarily repaired for several years and is constantly broken up with pieces of tarmac strewn around the place. I have reported this on numerous occasions and would like the issue to be resolved.

To ask the Manager to arrange for a review of the Insulation at (details supplied) where many residents have reported issues such as damp/mould etc.

To ask the Manager if there plans to improve the cycle lane at (details supplied)

To ask the Manager to provide an update on the improvement to the signage at (details supplied)

1. Local Area Plan Update

Ballymun Main Street

A new fitness club, METATRON will open its doors this month in one of the units of the Aspen Building. There will be an official launch in January 2023. We wish the new Business Owner every success.

Vacant DCC units

Shangan Neighbourhood Centre - negotiations are still ongoing with all 3 parties interested in the Shangan units. A further update will issue in January.

Site 6 - Coultry, Main Street

On the 23rd November Housing and Community Services met with O'Cualann in relation to progressing a proposal under the Cost Rental Equity Loan model for site 6. A further update will issue Q1, 2023.

Sites 8 (West of Coultry Park) and 9 (Coultry Park)

Housing and Community Services have written to Empower the Family seeking an update on progress in relation to their proposals for the site. Documentation has being completed for the Expression of Interest on this site and will issue early in 2023.

<u>Site 11 – Sillogue Avenue and Site 13 – Sillogue Road</u>

A survey has been arranged for Sites 11 and 13 which is due to be completed in early December. Once complete it will issue with the Expression of Interest to the AHB protocol for the two sites which DCC Housing has now compiled.

Site 12

An update on proposed plans for site 12 will issue early in the New Year in advance of proceeding to Part VIII.

Site 14 - Balbutcher Lane

Details in relation to the revised density are being finalised in advance of a Part VIII submission.

Site 19 - St. Joseph's

A Further Information (FI) Request has been issued in respect of Planning Application 4853/22. Dublin City Council's Housing and Community Services Department is currently liaising with O'Cualann and the relevant Departments to expedite the completion of the FI response. A further update will issue in January.

Site 25 – Parkview

A Planning Application was registered on 18th November by O' Cualann for phase two of site 25 for works including:

- 1. Single storey crèche
- 2. 32 x Affordable Purchase homes in for blocks (2 x 2-bed and 30 x 3-bed)
- 3. 2 x 4-bed sheltered housing units
- 4. The extension of Parkview Road
- 5. Landscaping works

Site 30 - North City Operations Depot

The construction of the North City Operations Depot continues to progress well.

The main structural work to the Administration and Welfare Building is complete. Work at roof level to install plant is substantially complete. Works are ongoing to complete final

weathering of the roof light wells. Installation of roof paving and sedum blanket will follow. Externally works have progressed with the finishes to the curtain walling and many of the external doors have been fitted. The glass balustrade to the south balcony on the first floor has started and there are some capping's and flashings etc. to be completed following completion of the balustrade works.

External precast edge panels are completed on the Multi Storey Car Park (MSCP). Internal concrete works are now complete and application of floor coatings has commenced.

2nd fix Mechanical & Electrical installations are almost complete in the Central Stores and Workshops. Sectional doors are now installed. Super-flat floor now laid in the Central Stores ground floor. Preparation works for floor painting are nearly complete with floor painting to start shortly and joinery etc. to follow.

The Salt Barn's glulam frame is complete. Work on the final roof covering and timber cladding to walls is ongoing.

The Civic Amenity Site (CAS) Office roof works will commence in the coming days. Mechanical & Electrical installations are continuing.

The permanent east side access is in use by the Contractor as the main construction access. Works to the northern access (opposite IKEA / Decathlon) are continuing with kerbing works to form the central island now mostly complete. The Contractor has now moved some of their site compound to the CAS area and they are using the CAS access for staff vehicles. The Contractor is carrying out ongoing works around the existing traffic lights which will remain operational. New traffic light installations at both junctions are agreed between Dublin City Council and Fingal County Council. Junction design work is ongoing. Footpath works external to the boundary wall are substantially complete along Carton Way including lighting, kerbing and laying tarmac.

There have been some more delays to the project programme and assuming no further delays the scheduled completion of construction is early 2023. There will be a fit-out period after that for furniture and IS configuration. It is still anticipated that the depot will become operational in Q1 of 2023.

Sillogue Infrastructure Scheme

The new Sillogue Avenue carriageway is open from Sillogue Road to Ballymun Road. The two new sets of pedestrian lights are now operational. Dublin City Council engaged in a communication campaign to make locals more aware of these new lights, particularly at the Holy Spirit National School where many drivers were not obeying the red light. Compliance appears to have improved but will continue to be monitored.

The new drainage pipes and manholes are approx. 90% completed in Sillogue Gardens. The mainline drainage should be completed by the end of the year. In the New Year work will continue on building the new gullies and connecting these to the new network followed by construction of new footpaths.

The new footpath, carriageway and permeable parking bay has opened in-front of the crèche. Kerbing footpaths and parking bays have commenced in the Celtic cross area to the rear of houses 96-111. The new parking bays and footpath in the 'triangle' area at the east end of Sillogue Gardens are nearing completion and should be open to the public by the end of the year.

There is a temporary traffic diversion for the cars accessing/exiting the cul de sac at 3 houses (42 to 53 Sillogue Gardens) to enable the drainage work. However, this will be completed before Christmas and reopened as normal for the Christmas period.

The site will be closed from close of business on the 22nd December and will reopen on Tuesday 3rd January. It is not intended for any residential entrance (front or back) to be closed over the Christmas period. All fencing will be removed from areas where possible. The site will remain under manned security for the duration of the Christmas period.

2. Community and Social Development

General Community Development

The Community & Social Development Section (CSDS) attended a range of meetings in relation to events and provided support to many initiatives as outlined below in the past few weeks:

Social Inclusion Initiatives

Trauma Informed Ballymun

The Community & Social Development Officer has been working alongside the Ballymun Drugs Task Force, Tusla, Easy Street team and Star Ballymun on the progression of the Trauma Informed Ballymun Initiative. At this stage some funding has been secured from the Sláintecare fund and a facilitator has been contracted to work on the initial stages of the rolling out of this programme early in 2023.

Inclusion and Integration Week

The CSDS organised a range of enjoyable events and activities during November under the banner of DCC Inclusion and Integration week which included:

- An intergenerational historical walk in Santry Demesne.
- A rock climbing session for local residents in recovery.
- Gala Concert for Older Persons.
- An open day in Ballymun Men's shed.
- A disability sports showcase session in Trinity Comprehensive.
- A health and wellness family day in Ballymun Family Resource Centre.
- The relaunch of FACT Autism Support Group.

The Gala Concert was organised in collaboration with Active Living Ballymun and included many of the original committee members of this long running community group. Over 120 older persons attended this fun social and recreational event which was the first opportunity for many of these residents to meet up at such an event since December 2019, pre Covid.



The CSDS also co-organised the come and try taster sports event on the Plaza as part of the Ballymun Health and Fitness Summit 2022.

The team were also part of the organising group for Poppintree Health for All Mental Health Week in November and supported a range of local initiatives during this time.

Formal Launch of the Ballymun Sláintecare Health Community projects

On Friday 2nd of December the Ballymun Sláintecare Health Community projects were formally launched. The Sláintecare Healthy Communities Enhancement Fund will allow for the installation and upgrading of local amenities in Ballymun including the further enhancement and development of Balcurris Park. Plans include the installation of a new community "Reflective Garden" space which was proposed and designed by a local community group in collaboration with the Parks Department, the CSDS and the new DCC Slaintecare Local Development Officer, Patricia Tallon.

In addition to the Reflective Garden further plans will increase overall access to and promote the use of Balcurris Park through the provisions of new accessible walkways and the installation of a natural play area that will support community healthy place-making and wellbeing.

This is a collaboration with existing community partners, who are a key asset to the programme as they are already embedded in the community. To support this work a financial contribution has been allocated from the 2022 seed funding resources to the Ballymun Fun Run Committee who are organising a Santa Dash and two fun runs to take place in Trinity Comprehensive on Friday the 9th December. Over 1,000 students have registered for this seasonal health and wellbeing initiative.

Support is also being provided to the Ballymun Network for Assisting Children and Young People who are building a 'trauma-informed' Ballymun to better understand and work with individuals impacted by trauma and living with the consequences. Supports are also in place for the Play Therapy Project being driven by the Primary Principals Network, Young Ballymun and Ballymun Family Resource Centre. This initiative is currently funded under the Ballymun Social Regeneration fund. This collaboration is to better mobilise available resources to address local needs.

The Dublin City Healthy Communities Programme collaborates with key frontline HSE and Primary Care services delivering health and wellbeing programmes to support improved mental and physical health such as stop smoking services, healthy eating groups, mental health and parenting.

Environmental

The CSDS have been working with the Aisling Project Ballymun, Poppintree Youth Project and local artists on a creative recycling project whereby young people will take part in a number of educational/art workshops and produce miniature Christmas trees from recyclable products. Funding for this project was sourced through Creative Ireland Funding.

Additional Events/Community Initiatives

Christmas Tree Lighting Event

The Christmas Tree Lighting Ceremony and Santa Grotto Event was organised by the CSDS and took place on Friday the 2nd December, both inside and outside the Ballymun Civic Offices. Music was provided by Our Lady of Victories Boys School Band and singing was provided by Dame Stuffy, the Northside Sensations and Virgin Mary Girls School Choir. This was a fun and festive family event for all who attended with each child visiting Santa.

Additional Activities

The Community team are further supporting festive Christmas activities in Burren Court, Setanta GAA and the Poppintree Community Walking Group.

3. Economic Development Update





Jingle Mingle

The B4b networking annual 'Jingle Mingle' event took place in Musgrave Market Place on Thursday 8th December. The. award-winning international motivational speaker Gerry Duffy attended to help inform how to set and achieve goals for 2023. The event is open to all local business and organisations in Ballymun.

Trinity Comprehensive Business Breakfast

The annual Trinity Comprehensive Business Breakfast took place on Tuesday 22nd November in the school. The purpose of the gathering is for the LCVP 5th & 6th year students to learn first-hand from business owners and also provide a networking opportunity for those businesses. Special guest was Eileen McHugh, Hair Together, a Ballymun entrepreneur who has set up an award winning social enterprise teaching teenagers the basic skills of barbering and hairdressing.



Shop-front enhancement scheme

The latest business to benefit from the North West Area Shopfront enhancement fund was SOS Barbers, Finglas Village. This is a new business that used the grant to replace old signage of the previous tenant.



Ballymun CoderDojo



The Ballymun CoderDojo continued to run 2 Dojos on Saturday mornings during November. Noeleen Doyle who has been appointed Communications Manager with CoderDojo dropped in for a visit. The new role will be committed to enhancing networking among Dojos, sharing resources and ideas that will help with attracting volunteers and sustaining Dojo's in the long-term. December Anti-dumping initiative

To support the centenary of St. Canice's Church, Finglas, the Area Office installed high specification planters and a bench to enhance the front of the church and make it more aesthetically pleasing. The church de-commissioned five parking bays that were a health and safety concern.
