"That Dogs in parks and open spaces shall be kept on a leash, other than in areas designated as off-leash areas, or at times specified by the City Council. Dogs must be kept under effectual control at all times. Dogs (other than guide dogs or assistance dogs) shall not be permitted in public playgrounds. A person shall not cause or allow any Restricted Breed, as defined in the Control of Dogs Regulations 1998 (as amended) belonging to him/her, or in his/her charge to enter or remain in the park unless such dog is kept securely muzzled and led on a sufficiently strong leash not

exceeding two metres in length by a competent person over 16 years of age."

Reply:

It is acknowledged that our Parks Bye Laws need to be reviewed and updated. The requirement "That Dogs in parks and open spaces shall be kept on a leash, other than in areas designated as off-leash areas" would be a beneficial change which would give local communities and neighbourhoods greater say over what parks and what areas of parks would be best suited for dogs off lead. We are trialling this in St Annes park and the North Bull Island at present.

The process for making and changing Bye Laws is a statutory process contained in Part 19 of the Local Government Act 2001 and the Local Government Act 2001 (Bye-laws) Regulations 2006. It involves a public consultation which would undoubtably generate a great deal of comment, feedback and stakeholder engagement. At present the Parks Service is not in a position to commence such a resource heavy process but this review could commence in 3 2024.

Urban95 Project

A Steering Group has been established to progress work on the Urban95 Project, following involvement in a 7 week on line programme and a city to city engagement working with London School of Economics. Urban95 is a project that aims to improve the experience for toddlers and their care givers, it's called Urban 95 as 95cm is the average height of a Toddler. The Steering Group will oversee a pilot programme that is working to capture the experience of toddlers through engagement with their care givers, and will pilot initiatives aimed at improving the experience of toddlers in the city. An internal vision and external vision statement has been drafted that will establish a framework for a future work. Dublin will be provided with expertise of an external organisation for a period of six months to inform and guide the pilot

Liz Coman, Les Moore, Cllr Cat O'Driscoll, Mary Mac Sweeney and Ray Yeates are supporting this work. Discussions have also been held with Deirdre Scully to identify ways that the City Development Plan provides for toddlers in the built environment.

The Dublin pilot will examine play in the city, consider pop up events perhaps in newly pedestrianised areas such as Caple Street, with an ambition to develop the understanding and capacity of decision makers to design with Toddlers in mind. There will be an opportunity to showcase existing good practice, to learn from other cities and to ensure that the needs of toddlers are considered along-side other groups, such as older person and people with disabilities, as part of the design process.

Next Steps:

- 1. The Your Dublin Your Voice survey panel will be used in Q 1 2024 to gather views and information from Dublin residence on their experiences and ideas for future implementation.
- 2. It is also intended to capture good practices within Parks Department for formal and informal play and how this is included in the design process for parks and open spaces.
- 3. A short artists in residencies programme will be explored to support engagement across four Departments to support the aims of the pilot. The 4 Departments we would like to work with are as follows: Culture, Recreation and Economic Services, Housing, Transportation and Smart Cities/Transformation.
- 4. Plan and deliver Play Pop Ups in pedestrian street
- 5. Plan and hold seminar to discuss findings and opportunities for wider implementation of toddler friendly design

Bown + Bacon, collections display, 19 July 2023 - 7 January 2024



The renowned English photographer Jane Bown (1925 – 2014) photographed Francis Bacon in his studio at 7 Reece Mews, London, to accompany an interview for *The Observer* by Miriam Gross in 1980. This display features a selection of Bown's photographs of Bacon at 7 Reece Mews, recently donated by Jane Bown Estate, along with selected items from the Gallery's Francis Bacon Studio Archive. *Bown* + *Bacon* is accompanied by a publication, which includes texts by Barbara Dawson, Logan Sisley and by Luke Dodd and a reprint of Bacon's 1980 *Observer* interview.

Andy Warhol Three Times Out

6th October 2023 – 28th January 2024

"To really know Warhol is to love him. This exhibition at the Hugh Lane Gallery goes beyond the iconic images we're familiar with and delves into the depth of Andy Warhol's personal journey and artistic evolution. It's a must-see showcase that unveils the private sketches, self-portraits, and intimate works, providing a new dimension to the man behind the pop art legend. Don't just see Warhol; experience him in a way you never have before." Cent Magazine

Hugh Lane Gallery's critically acclaimed 'Andy Warhol Three Times Out' opened on Friday 6th October, and will run till 28th January 2024.



The Exhibition comprises over 250 artworks on loan from museums and private collections in the US, Canada, Europe and the Warhol Museum in Pittsburgh, all of which were installed at the end of August.

Tickets for Andy Warhol Three Times Out went on sale on the 14th of August with 1,500 sales in the first hour, and over 40,000 tickets sold to date In the first month of the Exhibition, October, we welcomed 37,197 visitors to the Gallery. This is the highest monthly total, since we began recording visitor numbers in May 2006.

Allocated time slots, using a new online ticketing system, manages our visitor entry times, prevents overcrowding and awards each visitor the space to enjoy the art exhibition.

To ensure the exhibition is as accessible as possible, online tickets for Wednesday mornings are free of charge (until 12.30) and a range of concession prices are in place for all tickets for Seniors, Job Seekers, unwaged people and people with a disability. Almost 5000 Free Wednesday Tickets have been booked. Concession tickets (Senior 65+/Job Seeker/Unwaged/Disability/Student) make up 24% of total ticket sales.

Our pricing strategy recognises that charging a fee for the Warhol exhibition is essential in helping to offset the costs involved in bringing an exhibition and programme of this international calibre to Dublin, and involved an initial phase of research and analysis of the pricing structure of other cultural experiences in Dublin city to ensure we were positively aligned, while remaining as accessible as possible.

In addition, there has been huge demand for school tour groups. We are welcoming up to 4 x school tour groups every weekday. School tours are subsidised, seeing a cost of €30 per school to ensure the exhibition acts as an inspiring educational resource.



A catalogue accompanying the exhibition featuring essays by numerous art historians and experts is now available for purchase from the Gallery Bookshop.



Education

A superb programme of talks, film screening, art workshops, community engagement and more has been curated by Gallery's Education team exploring themes arising from Andy Warhol Three Times Out. Our primary schools city-wide project Zooom@ Hugh Lane Gallery is now in Phase VI and we are also facilitating huge demand for tour requests to visit the exhibition. Among our community outreach projects is High Expectations, a year long Early Years artist residency with artist Helen Barry in collaboration with Ozanam House and NEIC.

WE CAN CAN is an Education and Community Outreach project by visual artist **Liliane Puthod** in response to *Andy Warhol Three Times Out* at Hugh Lane Gallery.

Based on Andy Warhol's famous Campbell's Soup paintings and sifting it through the lens of Irish culture, the project is built on four chapters titled *Can of Beans*, *Silver Can, Revolving Can* and *Humming Can*, each exploring media and themes used by Andy Warhol as a way to initiate a dialogue around the production of singular and multiple objects within an everyday environment.

Focusing on the 'can' as an ordinary object, the project began with an extraordinary visit to a local site of production, Batchelors Beans Factory with Cabra For Youth. This inspired unique ink drawings of cans which were used to create WE CAN CAN's beautiful wallpaper. The ink drawings were further developed into multiple silkscreen prints at Damn Fine Print. In addition to Cabra For Youth, the three other participating groups are Lourdes Youth and Community Services (LYCS), Dublin 1, St Mary's Secondary School, Glasnevin and Beneavin De La Salle, Finglas. Over the coming months, each will respectively visit Colorman, Irish Film Institute and Dublin Digital Radio as well as engaging further through exhibition visits and art workshops in our Education Space with filmmaker Helena Gouveia Monteiro, tinsmiths James Collins and Tom McDonnell and Dublin-based band Acid Granny.

Reflecting on the handmade versus manufactured object, the echoing title WE CAN CAN captures the many layers of production and scale present in Andy Warhol's extensive series of works, from commercial to fine art, craft trade to mass-production, unique drawings to repetitive prints, experimental to mainstream.

With the incremental addition of artwork made during this project, Gallery 6 becomes a space to question the relationship between time, value, individuals and society.

Chapter 1: Can of Beans with Cabra For Youth, Batchelors Beans Factory and Damn Fine Print.

Chapter 2: Silver Can with Lourdes Youth and Community Services, Colorman Packaging and Printing Company, James Collins and Tom McDonnell with Pavee Point Roma Centre.

Chapter 3: Revolving Can with Beneavin De La Salle College, Finglas, Irish Film Institute (The Irish Adverts Project) and visual artist Helena Gouveia Monteiro.

Chapter 4: *Humming Can* with St Mary's Secondary School, Glasnevin, Dublin Digital Radio and band Acid Granny.

This project by visual artist Liliane Puthod is co-curated with Jessica O'Donnell, Head of Education and Community Outreach and Cleo Fagan, Education Curator.

Comhairle Cathrach Report to Arts, Culture, Leisure and Recreation SPC 27th November 2023

Following meetings of the Subcommittee established to explore cultural uses and occupancy of the former DIT School of Music on Chatham Row, an interview process of seven shortlisted candidates occurred on November 10th 2023.

The seven organisations interviewed were. The Dublin Music Alliance, Pallas Projects, Flux, The Dean Arts Studio(current occupant), The Gaiety School of Acting and the Irish Theatre Institute.

Each candidate made a presentation on their proposed use of the building from a Public, Semi-Public (rentable) and Private use by Artists or cultural practitioners. The interview also addressed Governance, Financial and organisational capacity and sustainability.

The Interview Panel members were; Cllr Cat O Driscoll (Chair) Cllr Claire Byrne, Marry MacSweeney Exec. Manager, Ray Yeates City Arts Officer and Sarah Searson Arts Curator (Extern). The standard of the presentations was universally high and the Panel gave due consideration to each applicant according to the criteria agreed namely;

- 1. Track Record of Applicant 30%
- 2. Quality of the Offer 30%
- 3. Feasibility 20 %
- 4. Financial Resources and Governance 20%

The Panel set 80% as the qualifying mark to be attained. Three candidates scored above 80%; Flux, Pallas and the Irish Theatre Institute, the Panel decided that that all three should be ranked in order of their score and that the first ranked Flux would be the first preference of

Dublin City Council to negotiate with for occupancy of the building. It is hoped this process would conclude by end March 2024. However if for some reason negotiations did not prove successful at that time Dublin City Council will reserve the right to proceed to the next ranked candidate.

Although this was a good outcome for the future use of the building, the Panel acknowledged in written feedback to each candidate the calibre of their application and interview. The current occupant Dean Arts Studios may continue on a month by month occupancy if they wish by arrangement with teh Property Section until the new occupant is contracted by Dublin City Council.

It is intended that a trial period of a one year Licence to occupy will be negotiated at first and if successful a lease will then be agreed.

LIBRARIES

Dublin City supporting libraries nationally - Update

Dublin City Libraries have managed the National Library Management system on behalf of all library authorities in the country since 2020. In addition to maintaining and supporting the system, DCL also manages the national helpdesk

The number of queries received by the helpdesk has grown considerably over the last four years. In the first 3 quarters of 2023, 3,888 queries were handled (avg. 18 per day).

EVENTS

Dublin City Council Events Community Fund.

The current total stands at €25,324. In accordance with the report "Event Safety and Minimal Charging for Public Events" submitted to the SPC Committee in February 2023, the total will be distributed equally amongst the five area offices for the purpose of funding events in the community.

SPORT AND RECREATION

The DCC Sports Plan underway. Public consultation to be completed during August/September 2023 including input from young people. Plan to be adopted by year end.

ARTS OFFICE

The Arts Office are engaged with Turley to produce a Toolkit and Guidance Document for Developers in relation to the 5% provision for Creative, Community, Cultural space in new developments.

PARKS & LANDSCAPE SERVICES

Communication Boards – Dublin City Council Playgrounds

The first of Dublin City Council's new Communication Boards was recently unveiled in Herbert Park by the Lord Mayor of Dublin Daithí de Róiste and the Minister for Children, Equality, Disability, Integration and Youth of Ireland, Roderic O'Gorman.

Dublin City Council will be installing these Boards in all their park playgrounds over the coming months. The rollout of the Communication Boards follows the announcement earlier this week of a three-year plan for Dublin to become an autism-friendly city.

Communication Boards are primarily a communications support, with particular benefit to children or adults who are either pre-verbal or non-verbal and/or have communication difficulties.

The plan to install Communication Boards in city parks is an initiative of the Lord Mayor of Dublin, Dublin City Council Parks section with the support of the charity Finding Charlie's Voice.

LIBRARIES

Finglas Library will be officially opened by the Lord Mayor on Saturday 9th December at 11 am.

Dublin City Libraries have advertised to award a contract of service for a **Storyteller in Residence for Children**. The Storyteller in Residence for Children will deliver a programme of activities designed to promote literacy and encourage the habit of reading and library usage among young people. The resident will liaise with Dublin City Libraries' Events and Partnerships and Community, Children's Services and Social Inclusion sections to promote the library service to children within and beyond our library branch network.

New assistive and innovative technologies and services available in library branches

Funded through Dormant Accounts 2023, 18 branches now provide Acorn Age Friendly tablets for lending. More details <u>here</u> on our Age Friendly initiatives.

A <u>Tovertafel</u> (magic table) has been purchased for the new Finglas Library. Magic tables are also available in the Central Library and in Walkinstown.

Two Sensory Cubbies purchased for Central and Ballyfermot Libraries. More details <u>here</u> on our range of sensory services

Following the success of the <u>Library Locker</u> in Drimnagh, a second locker will be available for the community and users of Darndale Village Centre.

In partnership with the LGMA and with funding from the Department of Children, Children's Literacy Collections are being placed in the Visitor's Centres of five Prison Libraries.

Dublin City Libraries received a grant from the ALL Strategy Fund for €14,200 to set up a 'Library Literacy Champion' programme. The training initiative will conclude in December. This project was funded by SOLAS under the Adult Learning for Life strategy. 29 members of staff participated in the four month programme.

The **2023 Dublin Festival of History** ran from 25th September to 15th October with 200+ inperson and online events in libraries and other venues around the city.

Following an open call process, 16 internationally renowned digital artists have created stunning visuals and graphics for the iconic GPO and Custom House buildings. Both buildings will be transformed into a high definition visual canvas. The winning artwork on each building will be announced early next month after consideration by a panel of internationally-recognised judges.

Entrants of the children's art competition will be projected onto the side of Palace Street. Following on from last year's success, Donal Fallon as part of his "Three Castles Burning" podcast will again commission a podcast of the history of the 2023 'Dublin City Council Dublin Winter Lights' locations .

Andy Warhol Three Times Out 6th October 2023 – 28th January 2024

Over 250 works on loan from museums and private collections in the US, Canada, Europe and the Warhol Museum in Pittsburgh are included in this substantial exhibition of Andy Warhol Three Times Out. Organised by Hugh Lane Gallery, Andy Warhol Three Times Out has been five years in the making and includes works on loan from private collections and major institutions based all over the globe, including the Warhol Museum in Pittsburgh, Pennsylvania, US.

Future Exhibitions

Sarah Purser: Artist, Collector Activist

12 June - 20 October 2024

Sarah Purser (1848 – 1943) was a hugely influential figure in Irish artistic circles, both as an artist and as an organiser. This exhibition, drawn largely from the HLG collection, will present her life and work from three different perspectives: artist, collector and activist. Purser was born in 1848 in Dún Laoghaire and studied in Switzerland, Dublin, and Paris before establishing herself as a leading portraitist in the city. Hugh Lane Gallery has a fine collection of her work, with sensitive portraits of Edward Martyn, Maud Gonne, W. B. Yeats and others. She was also an active collector and numerous works from her collection were given in her memory through the Friends of the National Collections of Ireland, which she had founded in 1924. Purser was an energetic advocate for the visual arts in Ireland and her home at Mespil House was a meeting place for various cultural figures. She founded the stained glass studio, An Túr Gloine. She arranged the 1901 exhibition by Nathaniel Hone and John Butler Yeats that was a catalyst for Hugh Lane's interest in modern art, which in turn led to the founding of Hugh Lane Gallery. It was later through her efforts that Charlemont House was secured as the permanent home for the gallery.

Online Collection

Hugh Lane Gallery's online collection has been updated and intergrated into the Gallery's new website. It can be accessed through the homepage or via https://onlinecollection.hughlane.ie.

Education

A superb programme of talks, film screening, art workshops, community engagement and more has been curated by Gallery's Education team exploring themes arising from Andy Warhol Three Times Out and includes an ambitious programme of events taking place in DCC Public Libraries throughout the city. Our primary schools city-wide project Zooom@ Hugh Lane Gallery is now in Phase VI and we are also facilitating huge demand for tour requests to visit the Warhol exhibition. **We Can Can** is an Education and Community Outreach project by visual artist **Liliane Puthod** in response to *Andy Warhol Three Times Out*. Based on Andy Warhol's famous Campbell's Soup paintings and sifting it through the lens of Irish culture, the project is built on four chapters titled *Can of Beans*, *Silver Can, Revolving Can* and *Humming Can*, each exploring media and themes used by Andy

Warhol as a way to initiate a dialogue around the production of singular and multiple objects within an everyday environment. With the incremental addition of artwork made during this project, Gallery 6 becomes a space to question the relationship between time, value, individuals and society. **Chapter 1:** *Can of Beans* with Cabra For Youth, Batchelors Beans Factory and Damn Fine Print. **Chapter 2:** *Silver Can* with Lourdes Youth and Community Services, Colorman Packaging and Printing Company, James Collins and Tom McDonnell with Pavee Point Roma Centre. **Chapter 3:** *Revolving Can* with Beneavin De La Salle College, Finglas, Irish Film Institute (The Irish Adverts Project) and visual artist Helena Gouveia Monteiro. **Chapter 4:** *Humming Can* with St Mary's Secondary School, Glasnevin, Dublin Digital Radio and band Acid Granny. Also among our community outreach projects is *High Expectations*, a year long Early Years artist residency with artist Helen Barry in collaboration with Ozanam House and NEIC.



Comhairle Cathrach Report to Arts, Culture, Leisure and Recreation SPC 27th November 2023

Arts & Cultural Advisory Group

Arts and Cultural Advisory Group Notes of Meeting held on Monday 4th September 2023, 9.30 a.m. City Hall

Present: Cllr. Cat. O'Driscoll; Cllr. Patricia Roe; Mary MacSweeney; Ray Yeates; Logan Sisley: Ruth McGowan, Adekunle Gomez, Ciaran Taylor, Willie White.

In Attendance: Paula Farrell Chair: Cllr. Cat O'Driscoll

Minutes of previous meeting held on 3rd July 2023 were approved.

Matters Arising: Cllr O'Driscoll confirmed that she brought the matter of identifying the existence of brown field 500 seat venue spaces within the canal boundaries, which is currently unknown, to the attention of the Chair of the Planning SPC.

Cllr. O'Driscoll linked in with the Local Community Development Committee (LCDC), Carolyn Moore, regarding the programming of Africa Day. It was agreed that the LCAD is a good place for the event to 'sit'. Carolyn Moore committed to organising a meeting with stakeholders in September or October 2023 to which ACAG members would be welcome.

Hugh Lane Report: Logan Sisley presented the Hugh Lane report. He reported that Future exhibitions include Andy Warhol's Three Times Out which will exhibit at the Gallery from 5th October – 28th January 2024. The installation consists of more than 250 works on loan from museums and private collections in the US, Canada, Europe and the Warhol Museum in Pittsburgh. Tickets for the exhibition went on sale in mid-August with 1,500 sales in the first hour. Art & the Outdoors, a two day family art event took place on Parnell Square North on the August Bank Holiday weekend. The programme included artist-led outdoor drawing and printmaking, events, all guided by professional artists from the HL panel. The numbers visits to the gallery over the weekend totalled 1,935, significantly up from the average.

The Arts Office Report

Ray Yeates presented the Public Art Report including an update on the commissions across all three strands of the Dublin City Public Art Programme:

Strand 1 - The Citizen Commissioners process is reaching Stage 4 (of 6) whereby the participants, having engaged with different artforms are now entering the phase where they become involved in mini commissions across different artforms. The second Citizen

Commissioners pilot project is in Dolphin House, Dublin 8. An Arts Coordinator will be appointed in September to further develop Citizen Commissioners in Dolphin House.

Strand 2 - *Liffey Love* by Rhona Byrne is being launched on Culture Night at the Poolbeg Yacht and Boat Club. This commission involves collecting plastic from the River Liffey and transforming it into social sculptures which will be located on the north campshires.

Strand 3 includes - Pulse by Alva Gallagher: Installation and testing has been completed. The 'Lighting Up' ceremony will take place on the 17th of October; **Temple Bar Square Commission:** The artwork *Cityscape with Sleeping Dog* by Isabel Noland has been fabricated and will be installed as part of the paving in the square at its expected completion before the end of 2023; Commission for Dartmouth Square: Andy Fitz was awarded this commission for a sculpture inspired by Lafcadio Hearn. The commission which is funded by ULSARA and DCC is to be located in Dartmouth Square; Commission for Lemon Street: Approved by ACAG and the South East Area Committee, this commission is related to the public realm improvements in the Grafton Street area; C2CC: Funding is being sought from the National Transport Authority (NTA) for a public art commission relating to the active travel route from Clontarf to City Centre. A proposal for an open competition with the theme of 'Travel and Mobility' has been submitted to the NTA; Fitzwilliam Cycle Route: Dublin City Council is assessing tenders for the capital works. The Public Art Officer is engaging with the commissioned artist Lucy Andrews for a sculpture to be located on the traffic island at Leeson Street and Adelaide Road: Monument to the Women of the Revolution: The budget required for a monument of a suitable scale on O'Connell Street is currently underway. It is intended to launch this work before the end of 2023; O'Connell Plinth, City Hall: A brief has been prepared for an open call for a new temporary commission for the O'Connell plinth; NTA Per Cent for Art Funding: The Public Art Officer is liaising with the DCC Environment and Engineering Department to seek to maximise the Per Cent for Art Funding available to DCC relating to active travel capital projects.

Care and Maintenance

The statue of Molly Malone was defaced with heavy black paint on in August. A foundry was engaged to remove the paint and to repatinate the sculpture. The memorial to the victims of the attack on the Miami Showband was defaced with graffiti. This has been removed. The strings on the guitar on the statue of Philip Lynott were broken from the insertion of plectrums under them. The foundry which cast the statue has been engaged to replace the strings with stronger welds. It has been proposed that these plectrums be removed regularly to avoid such damage again.

Referring to the care and maintenance of public art, Cllr. O'Driscoll noted that it is invisible work and enquired as to what the cost is of damage repair work to public art (as opposed to upkeep) on an annual basis. RY confirmed that there is no formal budget for this specific purpose. Repair work is carried out on a discretionary case by case basis under the remit of Local Area Offices. The response to repair work is quick and the artist is usually involved. Cllr. O'Driscoll confirmed that she will link in with the Joint Policing Committee regarding the matter of targeted damage to public art in the city. Willie White enquired if the data base of public art could be made public. Referring to funding being sought from the National Transport Authority (NTA) for a public art commission relating to the active travel route from Clontarf to City Centre, as noted in Strand 3 of the Public Art Programme, Ciaran Taylor queried the lateness of liaising with the NTA on cycle routes and asked if the drawdown of funding was still waiting for approval. RY confirmed that the process of drawing down funding can be lengthy and difficult despite the efforts of the Arts Office.

RY reported that he received confirmation from Housing that 10 sites have been designated for 5% Culture Community Art funding. The questions will now be, how to support these sites, who will run and fund them and how to design and co-design them. This will require a

lot of strategic discussion. The deficit of artist workspaces will be addressed in time. In the meantime a lot of competition will ensue. Diago have reached out to the Arts Office in relation the Rupert Guinness Theatre. Found spaces have their limitations and discussions are currently underway with Diago about a feasibility studio for the theatre. Matters relating to ownership, capital cost, who would run it and the level of community involvement would all form part of the feasibility study. RY recently toured the Ambassador Theatre on O'Connell Street. This is a potential 750 seater venue. There are two potential venues within the building. Currently use is made of the lower bank of seating while the top area is an exhibition space. The configuration however is odd and it is currently unclear if capital would be available to update the premises. A joint feasibility studio could be undertaken. Referring generally to the empty buildings in O'Connell Street, RY noted that the powers of the City Council are limited and citied the Kylemore building as an example of the bureaucratic difficulties that can be encountered in relation to empty buildings on the street. The gap between inspiration and implementation can be wide. Cllr. O'Driscoll affirmed that rules are in place in relation to buildings on O'Connell Street and while the empty spaces are not part of the remit of ACAG, a 'Vision' piece highlighting public art and gender balance on the on the street will to be brought to Council by Cllrs. O'Driscoll and Roe.

The City Arts Officer presented a Report on increasing Arts Grants to ACAG. The lack of increase in Arts Grants for more than 15 years as well as lack of applications for Arts projects in certain Administrative Areas of the City, notably the North West Area and North Central, has been noted by the Elected Members. In addressing how to apply new resources to Arts Grants, Dublin City Council wants to address the reasons why certain communities are not connecting with professional Arts funding either from DCC or the Arts Council. Some of these deficits include: a lack of a tradition of professional arts and infrastructure both in qualified people and appropriate buildings in certain parts of the city; arts funding being seen as bureaucratic and difficult to apply for by community groups and a lack the administrative support / structure locally.

In order to increase Arts Grants funding in a targeted way, the Arts Office is now proposing that the Arts Grant fund increase by €250K (from €550K to €800K) in 2024 through the creation of a €50K Arts Fund in each of the five Administrative Area. This increase in funding will be a partnership between Area Offices and the Arts Office throughout the calendar year that allocates funding to Arts Projects, Arts Programmes, local Arts organisations and individual artists living in the designated Administrative Area. This will be a developmental process that recognises talent and builds capacity to attract further resources. Grants from €2-€5K will be made by local Councillors on the agreed recommendations of the Area Manager, Community Development Officer and the City Arts Officer. To balance these proposals the main fund normally allocated to the categories of Projects, Revenue, Neighbourhood and Bursaries should also be increased by €250K in 2025 leading to a doubling of Arts Grants over the next two years. This two pronged approach strengthening the Centre City and the suburbs is vital as a new foundational Arts initiative post Covid and acknowledges the increased visibility and importance of the Arts in Dublin.

RY noted the importance of smaller scale projects which feed in to larger scale ones and suggested that given the lack of professional arts funding assistance in some areas of the city, a Developmental Fund would be advantageous. Increased funding will be good for applied projects. Cllr. O'D confirmed her support for this approach noting that a developmental and community approach sits well with the City Council. WW agreed that the city wants a stake in the arts and artists and reiterated that it is about the value not the money. Adekunle Gomez agreed that it is important that local groups feel they can tell *their story*. Emphasising service *impact* as well as service provision, RY spoke of the value of engaging artists who have not been traditionally engaged in funding processes and convening artists with new approaches who can put out good projects.

CT asked what roll the Area Offices would have in this process. He enquired if they would be suggesting projects for funding and what would the checks and balances be. RY confirmed that the Arts Office would consult with Area Management first and while ascertaining the quality of projects, the Arts Office would err on the side of inclusion over excellence. CT suggested that the arts grants should to be filtered through professional artists perhaps by way of a local community panel. Asking if 2024 and 2025 grants could be linked, Cllr. O'Driscoll confirmed that Council budgets are undertaken on an annual basis only and that if the development ethos is approved this may be easier to achieve going forward. WW reiterated the importance of having targeted funding with a particular emphasis on youth communities. In relation to the proposal that funding will be made by local Councillors on the agreed recommendations of the Area Managers, Community Development Officers and the City Arts Office, Cllr. O'D recommended that an external person should also be involved in this process and that mechanisms be put in place to ensure the purpose of the new grant. Cllr. O'D suggested that this proposal may have to go to SPC and the Area Committees on its way to Council and that the Arts Office could be involved in the Area Office discussions. Cllr. Roe emphasised the importance of grants being about community and not Area Offices.

Conclusion:

ACAG endorsed the proposal from the City Arts Officer to increase Arts Grant.

Creative Hubs: Following a hugely successful summer programme, Creative Hubs Autumn programme begins in October with a tour of the 2023 Performance Production commission, **Grey Matter**, in partnership with **Draoicht**. The autumn programme will also include a new series of short residencies in invited schools with artists Luke Casslery, Gabi and Orugbo; an Early Years Resdidency Programme and multidisclpinary workshops programme for schools. It is expected that Creative Hub will be expanded to a 4th Creative Hub library from November. In September an open call will be announced for the **2024 Visual Arts exhibition Commission** in partnership with **IMMA**

North West Area Research: Turley and Thrive this week launched the first part of the research into the arts in the North West Area. The survey aims to gather quantitative data and perceptions of the arts in the area. Going forward, further focus groups will dig deeper in to the survey responses to form part of Dublin City Council's Partnership Framework with the Arts Council. The final report on the research will be due to be completed by Christmas 2023. **Artane Place Artist Workspaces:** Artists are now preparing to move into the two singular units of Artane Place imminently. The construction on 35a that houses 10 units has entered its second phase and is expected to be completed by end of autumn 2023. **Creative Places Darndale** has entered the final year of the Arts Council award period. Plans are underway for the 3rd years programme. A facilitation session will be hosted by the Arts Office to enable the steering committee to reflect on the learning of the past 2 years and aims to begin planning an application to the Arts Council for funding for a 4th and 5th year.

Following an enquiry about the dissemination of the North West Area research piece from Cllr. O'Driscoll. RY confirmed that following a meeting with Areas Officers and management, a detailed list was created to in order that this research reach as many people as possible.

The LAB Gallery -

'HOLDING ON lightly': Previews on September 14th, and runs until December 4th 2023. Taking place in the cube space of the LAB Gallery, artist Elaine Grainger presents a new body of work through installation, sculpture, drawing and performance. **Culture Night:** On Friday 22nd September, tours of the current exhibitions will take place in The LAB Gallery.

They will be delivered by the artists (Elaine Grainger and Diaa Lagan), who will mediate their work. The gallery will remain open to the public until 8pm

AOR:

Referring to arts events for children (Creative Hubs) and building audiences for the future, AG enquired if Children's Arts in Libraries could expand in other parts of the city. Cllr. O'Driscoll suggested that Assistant Arts Officer Liz Coman be invited to make an input on her work with children's projects at an upcoming ACAG. This invitation can also be extended to the Hugh Lane Gallery. WW drew attention to the need to target teenagers as well as children. RY suggested a young person's ACAG could be potential for the future.

RY updated ACAG on the progress of the Harry Clarke museum. This is a capital project. The building on Parnell Square has been identified and a report on the project has been made to the Arts SPC. Disability access will form a large part of updating the building. A project team, including the Hugh Lane, will form part of the development. Cllr. O'Driscoll will visit the site imminently.

An update was also provided on the Chatham Row tender process. RY confirmed that 26 applications were received. The Shortlisting has been completed. An interview panel will be formed within 3 to 4 weeks with interviews planned to take place by the end of October. The gap identified is in terms of managing the building. A proposal for it to form a Co-Op was rejected. A turn-key approach could be taken. Lease negations are scheduled to take place in approximately 3 months and it hoped to be up and running by 2024.

In response to a question from AG pertaining to the Ivy Market, Cllr. O'Driscoll confirmed that it does not come under the remit of ACAG but rather a separate Council committee on Markets in the city. ACAG is not the correct forum for it.

The next ACAG meeting will take place on 6th November in the Richard O'Carroll Room, City Hall.



Comhairle Cathrach Report to Arts, Culture, Leisure and Recreation SPC 27th November 2023

Arts & Cultural Advisory Group

Arts and Cultural Advisory Group Notes of Meeting held on Monday 6th November 2023, 9.30 a.m. City Hall / Hybrid meeting

Present: Cllr. Cat. O'Driscoll; Cllr. Patricia Roe; Cllr. Hazel de Nortúin; Mary MacSweeney; Sinead Connolly: Ruairí Ó Cuív: Ruth McGowan, Adekunle Gomez, Ross Keane: Sunil Sharpe.

In Attendance: Paula Farrell Chair: Cllr. Cat O'Driscoll

Minutes of previous meeting held on 4th September 2023 were approved.

Matters Arising: Referring to the minutes of the ACAG meeting held on 3rd July, at which Ross Keane expressed concerns about the degeneration of Temple Bar, anti-social behaviour in the city and his request for members of Temple Bar Cultural Trust to attend ACAG to report on the matter, Councillor O'Driscoll confirmed that she wrote to the Chairs of both the inner city and city wide Joint Policing Committees on the matter. The issue will be put on the agendas of the Committees with a view to the formation of a Task Force in due course. Temple Bar Cultural Trust have not yet confirmed their attendance at ACAG.

Following a request from Cllr. Roe for an update on the progress of the Rupert Guinness Theatre, Cllr. O'Driscoll confirmed that there has been no further update since the City Arts Officer met with Diageo a number of weeks ago.

Cllr. O'Driscoll confirmed that a date for Africa Day has not yet been settled on.

Hugh Lane Gallery Report:

Michael Dempsey presented the Hugh Lane report. Andy Warhol's Three Times Out opened on the 6th October and continues until January 2024. The Gallery is facilitating a huge demand for tour requests to visits to the exhibition. An average of 1,300 visitors a day visited the Gallery during its first 10 days. A programme of talks, film screenings, art workshops and community engagement has been curated by the Gallery's Education team exploring themes arising from the collection. The Gallery is also hosting **WE CAN CAN** CAN, an Education and Community Outreach project by visual artist Liliane Puthod in response to the exhibition. Members of ACAG congratulated the Gallery on the success of the exhibition.

Libraries report:

Ciara Dardis reported that Dublin City Libraries will be working in association with the Dublin Book Festival which runs over 5 days November. Ten Libraries will act as venues for audiences to attend sessions by numerous authors. Libraries, in association with the Hugh Lane Gallery and Creative Ireland, will also host a series of events for the duration of the Andy Warhol *Three Times Out* exhibition. Beginning in November, events will include workshops aimed at adults, teenagers, children and those with neuro-diversity. The Creative Hubs autumn series will take place at the existing Creative Hubs branches (Ballyfermot, Cabra and Coolock) and at a 4th new Hub in the Central Library. The 4 venues will feature in an autumn programme with The Ark, with performance and workshops in music, dance, drama and visual art.

The Arts Office Report

Public Art: The Public Art Officer provided an update on the commissions across all three strands of the Dublin City Public Art Programme. In addition, the Public Art Officer presented the proposal *The Blue Trees* from Konstantin Dimopoulos intended to raise awareness about deforestation and the importance of trees to people by painting trees blue with water-based and biologically-safe paint. He presented issues which had been raised in discussions with Parks, Biodiversity and Landscape Services that despite the excellent intentions, the project could 'lead to adverse comment'. Members of the Group while extoling the project did not support funding the project outside any formal process. The Chair also pointed out that Dublin City Council had a strong biodiversity strategy and that the arts were well integrated into this.

Maintenance of Public Art

The Public Art Officer presented a report on the care and maintenance of public art. The report was welcomed by the members of the Group stating that it gave great insight into the issues arising from the care of a sculpture collection in the public realm. In addition to focus on individual artworks there was a discussion about approaches to the overall care of the collection. This discussion included the need for art expertise to guide approaches to conservation and cleaning but at the same time highlighted the value of close working relations between the Arts Office, Heritage Office, Parks, Biodiversity and Landscape Services and all the Area Offices. It was agreed, that in addition to a reactive approach to incidents of vandalism, a systematic approach to maintenance was also desirable.

Mary MacSweeney confirmed that the budgetary cycle is currently at a stage where it will be possible to review the funds that could be used for the maintenance of public art. Cllr. O'Driscoll suggested that each Administrative Area could make a contribution to its upkeep and restoration and that a dedicated fund for this purpose and a collaborative approach with the Area Offices, Parks and the Arts Office would speed up the process of maintaining and restoring public art. Both Cllr. O'Driscoll and Ruth McGowan suggested that a public awareness campaign of the budgetary impact of vandalism on the civic space would be very welcome. Cllr. O'Driscoll said that she will bring the matter of the maintenance and restoration of public art to the SPC along with the suggestion of there being a public media campaign to raise awareness of the value of public art.

Arts Office report:

Sinead Connolly presented the Arts Office report and noted that as part of Dublin City Council's Partnership Framework with the Arts Council, Turley and Thrive have been conducting qualitative and quantitative research on hard and soft infrastructure in the North West area. The data collection phase is now coming to a close and the final focus group will take place this week. The final report on the analyses of this data is due by year's end.

SC confirmed that the recipient of the 2023 ARC-LAB Gallery Curatorial Scholarship, in partnership with IADT, will work with Dublin City Arts Office on programming and research into curatorial strategies. The ARC-LAB Scholar is funded as a full-time student on the IADT MA in Art and Research Collaboration (ARC), which is an 18-month practical Masters programme taught in the LAB. This year's recipient of the scholarship, Clara McSweeney,

has a particular interest in exploring reactivating overlooked and ignored spaces in the urban environment through various artist's works. The outcome of Clara's curatorial project will be presented in the LAB Gallery as part of the gallery's public events programme in 2025.

Artane Place Artist Workspaces: The Arts Office has been working with Xestra management to convert unused spaces into artist workspaces. The first two artists have now moved into two individual studios in the Artane Place business park (formerly Butterly Business Park). The construction work on unit 35a, formerly the Stardust building, is currently underway and on track for completion before Christmas 2023. 35a will comprise of 10 individual artist studios

Creative Places Darndale: Creative Places Darndale has entered into the final year of the Arts Council award period and plans are underway for the 3rd years programme. A facilitation session which brought together the artist coordinators and steering Committee of CPD was hosted on 28th of September. The session provided space to plan for the future functionality of the steering committee and to plan for possible funding for a further year 4/5 of Creative Places. The Arts Office has been asked to chair the steering committee for year three with the intention of ultimately appointing someone local as chair to steer the project.

The Lab Gallery is currently exhibiting 'Shahid شُنَاهِ'. This exhibition is running from September to December 2023 and features works from Basil Al-Rawi and Diaa Lagan. Diaa Lagan hosted an Introduction to the History of Arabic Calligraphy workshop in the Gallery on the 4th of November. 'HOLDING ON lightly' is also running at the Gallery until December 2023 and features the works of Elaine Grainger. Diaa Lagan did a walk though of his work and the exhibition 'Shahid شَنَاهِ' on Culture Night 2023. Elaine Grainger also performed to activate her exhibition HOLDING ON lightly throughout the night.

Exploring & Thinking Practice Sharing Event and Bursary Award 2023 is a collaborative framework for early childhood arts in the Dublin region and the four Dublin local authorities. The Exploring and Thinking Research Evaluation and Sharing Day is supported by The Arts Council's Invitation to Collaboration Award which will take place on November 16th 2023 in Malahide Castle.

Arts Infrastructure Sunil Sharpe welcomed the partnership with the Arts Office and Arts Council but noted that the City Council pushes for more spaces in the city generally. He asked if, within the context of the SPC led Arts infrastructure Steering Group, that a definition of arts infrastructure could be clarified or expanded. Regarding the Turley and Thrive North West area research project currently underway, SS asked if this was a repeat of previous research recently produced by Turley. Sinead Connolly clarified that the partnership with the Arts Council and the Arts Office is a dialogue on arts infrastructural development. Definitions pertaining to arts infrastructure will be addressed within the context of the Developers Toolkit currently being developed by the Arts Office. The previous research conducted by Turley provided a light touch map of hard infrastructure in the North inner city. The current research takes a deeper dive in to the soft Infrastructure of the area in conjunction with potential partners of the Arts Office in the region.

AOB:

AK requested an update on the plans for the Monument to the Women of the Revolutionary Decade. Cllr. O'Driscoll confirmed that there is currently a Working Group focusing on this. RÓC confirmed that the major issues to be settled was the location of the proposed monument. He also stated that the competition for the monument will be an international one. The Arts Office is also looking at international examples of monuments to inform the project budget and is planning to have a symposium as part of the launch of the commission to focus on the role of women during the decade.

Following a question from Ross Keane about the proposed increase in Arts Grant Awards, Cllr. O'Driscoll confirmed that the report on this matter came to the SPC in September. Budgets will be finalised in the coming weeks.

Cllr. Roe also enquired about the potential wider use of the Ambassador Theatre for arts in the city, possibly in a Meanwhile Use capacity. Councillor O'Driscoll confirmed that she is awaiting a reply from the Planning and Urban Form SPC whom she wrote to in relation to linking in with the Arts SPC on the issue of derelict buildings in the city.

A site visit to Kilmainham Mills, Dublin 8, took place on November 1st. Further sites visits to the Mills for ACAG members can be arranged going forward. There is potential opportunity for the site to be used as a Meanwhile Use space. This will form part of a future vision of how the space will be used going forward. Consultation is ongoing.

Ruth McGowan enquired about the proposal submitted by The Giant Company Project and the presentation of part of the proposed installation in Dame Street. RÓC confirmed that the project was referred to ACAG from the Panning Department which requested the advice of the Group. He confirmed that the Group had advised against the proposal for the Ambassador due to scale and impact on the historic city core. SS asked if the founder of The Giant Company, Paddy Dunning, could be invited to speak at an upcoming SPC, expressing the view that people in the private sector need to be brought to the table in relation to the arts in Dublin. Mary Mac Sweeney agreed that a process should be in place within the Council that could engage with private individuals and suggested that this might tie in with the guidelines on new developments.

Cllr. O'Driscoll noted that the upcoming Workshop on the European Green Deal for Circular Festivals, which addresses how to take a circular approach to festivals, is taking place in the Morrison Hotel on 7th November and is open for ACAG members to attend.

The dates of the 2024 Arts Culture Advisory Group meetings have not yet been confirmed.

3. Lá Mór na Gaeilge, 2024

Mícheál Ó Nualáin reported from the feedback, suggestions made after this year's LMnaG and at the meeting in the Mansion House it is clear that:

- a change of location required from Parnell Square to Smithfield due to lack of shelter from the weather. There is a lot of shelter and space for children and Smithfield is a very open space.
 Money will be saved because the road does not need to be closed and a traffic plan will not have to be put together.
- A well-known band must be found for the day to act as ambassadors for the day and to attract young people to come to the event.
- Date change required due to bank holiday weekend complications. 28 April 2024 is tentatively recommended (this date has yet to be confirmed).

MÓN is to meet Steph Farrell (who has been working with us on LMnaG for the past two years) to discuss information about event planning and costs.

DH – happy to change to the Smithfield. She was not willing to change the date. She suggested that an event management company should be used and if necessary ask for money from the Chief Executive. She suggested that more restaurants be available on the day and that school pupils with Irish be found to help on the day.

NOM – willing to change to the Smithfield. Question about an available building.

JdeS – He said Smithfield will not be available for the bank holiday weekend and the date needs to be changed if we are to use that site. It was suggested that a new date and location should be tried. **MMcD** – willing to try changing location and date.

RY – We have been using people and services for the last two years that take care of the infrastructure and provide safety for the event and BÁC le Gaeilge focuses on the events and providing publicity. He believes that the cost will increase because we will be seeking to provide a larger program in a larger space.

BÁC in Irish:

Mícheál Ó Nualáin reported on elements arising from the BÁC le G advisory committee meeting and the 13/09/23 meeting with MÓN; DdeB & DOC.

- Approaches and methods for Businesses, to promote visibility and hearing of the Irish language - 10 shops to be selected on an pilot basis as examples; to spread the word, and to implement proper monitoring so that the same Irish language services are provided in the different bodies.
- Use 5 methods to advertise the Irish language service in these businesses. Different propaganda. The aim of this is to increase the opportunities for speech and interaction through Irish in the City

4. Irish 365 - (Ray Yeate)

Ray spoke about the issue of how to make the Irish language available in an innovative way internally within the Council and he mentioned the money that had been set aside from Creative Ireland so that the Irish language would be used creatively in the Council and in the work of the Council. Through discussion with Julian de Spáinn (CnaG), Daithí de Butléir from the CnaG is now working with the Council on a pilot program which will last 9 months, has been put together by him in the last three weeks.

DdeB gave a powerpoint presentation regarding **Gaeilge365** - reinforcing the impact of the Council's services with creativity to increase the number of daily Irish speakers in Duling. A training program (3 months) which focuses on providing leadership and creativity to Council staff members so that they can then promote the Irish language in their own area of work.

Action – RY to distribute the power point document to the committee after the meeting. **DH** - raised a question about a social night in Irish for Council employees. There was a small discussion on this and RY mentioned that a night of that kind could be organized at the launch of the training course or at its end.

5. Expanding the membership of the sub-committee -

The Chairperson raised a question about additional members.

Action - OmcM to send reminder to Brendan Teeling in the Libraries to nominate someone for this committee.

DOC - retiring February 2024 but happy to stay on the subcommittee afterwards. The committee agreed to that.

6. New development plan and designation of new developments through Irish

JdeS raised a question about the new Development Plan and the system that is being set up so that only Irish names can be placed on the construction of new housing. OMcM said that she would disseminate information at the next meeting to explain the system as it currently stands and the scenarios associated with it. JdeS stated that it would be happy to help if possible and recommended the system used by GaillimhleGaeilge to overcome these difficulties. (Establishing a Place Names Committee).

7. Regular meetings of the Irish Subcommittee -

The Chairman asked that meeting be organised every second month from now until April. That is to organise a meeting of the Sub-Committee for December, February and April. Definite dates yet to be arranged.
