## DUBLIN CITY COUNCIL SOUTH CENTRAL AREA COMMITTEE 19th July 2023

#### M262 Councillor Michael Pidgeon

That this area committee writes to the Minister of Education, seeking an additional secondary school for Dublin 8.

There are only enough secondary school spaces for one in three children finishing primary school in Dublin 8. In 2021, there were 17 primary schools with 3,421 pupils, but only 1,022 secondary pupils.

In Dublin 4, there is a ratio of 13 people to every 1 secondary school place. In Dublin 8, that jumps to 39.

There are currently five secondary schools in Dublin 8: all religious, all teaching through English. Just over half (53%) of people in Dublin City Council are Catholic, with nearly a quarter non-religious (23%). This area committee requests (a) improved funding for the existing secondary schools in the area and (b) a new, mixed, non-denominational school, perhaps at a location such as the old SIPTU College on the South

Circular Road. We also ask that the Minister, or her school planning team, meet with local representatives and parents.

#### M263 Councillor Daithí Doolan

This committee takes the opportunity to congratulate Dublin City Council, community groups, youth services and residents associations for the great success of both the Drimnagh Summer Festival and the Ballyfermot-Cherry Orchard Arts Festival.

#### M264 Councillor Máire Devine

The loss of the Tivoli Theatre and other cultural spaces is keenly felt by the Dublin 8 community. The Rupert Guinness Theatre on Watling St has been lying empty over 20 years. It would be an amazing asset for Dublin to get this fabulous building refurbished and brought back to life. This Committee requests that DCC commence engagement with Diageo and reach agreement for a renewed cultural space to serve the Liberties and the city.

#### M265 Councillor Máire Devine

Yet again this committee demands that the Iveagh Market's essential stabilising works be commenced immediately. That the Francis Street doors be opened at agreed times to allow public visibility (behind the locked gates so there is no issue re health and safety) and that the tender package be inspected by interested parties and fast tracked with the urgency that the fragility of the building requires.

#### M266 Councillor Máire Devine

That this committee welcome the recent safety report on Robinsons Court compiled by AGS. The overdue installation of gates is recommended but somewhat vague. We request a more thorough technical report that demonstrates how this will be achieved and timeline for these works be provided.

#### M267 Councillor Máire Devine

This Committee agree to inviting senior pupils and their teacher from Inchicore National School to present to members in the late Autumn.

#### M268 Councillors Vincent Jackson and Maire Devine

That the South Central Area Committee Councillors are in agreement of the appeal to An Bord Pleanala against DCC decision to include this fine manufacturing facility as a RZLT and the subsequent annual cost this will impose on the Botany Weaving Mill on Emerald Square Cork Street, Dublin 8, that this imposition will make the facility unsustainable leaving 75 jobs in the balance and threatening the future of two additional mills in the Republic. It is the intention of the local Councillors to look for a variation of the Dublin City Development Plan at the earliest opportunity. The retention and sustainability of viable employment opportunities must be retained within our City.

#### M269 Councillor Vincent Jackson

That Dublin City Council look at the current Housing List to streamline the number in operation. The current situation leaves people languishing at the top of the list without any real understanding of why they are never offered anything and indeed go down the list. Accepting we have a serious housing crisis, people waiting for many years seeing developments we have supported not getting a look in calls into question these multiple lists.

#### M270 Councillor Vincent Jackson

That Dublin City Council please again look at our policy <u>not to spray</u> weeds within our communities at street verges, footpaths etc. We are letting our communities down no end and whilst not wanting to spray with dangerous chemicals, we need a balance as we are losing our communities support. All people see are weeds from road side kerbs, verges small grassed areas outside homes needing to be cut but DCC as it is ruining any chance of getting people involved in clean-up's etc. as the weeds are a never ending battle. Other Local authorities are still spraying at these important visual locations which trap litter, waste etc.

#### M252 Councillor Hazel de Nortúin

The grass areas on both sides of the road could be linked in with the environmental plan and flower display that's on the roundabout at Kylemore. This is a key entry point into Ballyfermot and could be far more effective in its display of the area.

That Dublin City Council give an update on progress made with the development of Brickfield Park dressing rooms and to ask management to give further updates every three months.

This Area Committee expresses deep concern at reports of apartments in Davitt Road apartments are subject to illegal short term letting.

This is contrary to the original planning permission and only serves to further deepen the housing crisis.

This Area Committee asks that Dublin City Council investigates the matter fully and a report is made available at the next South Central Area Committee meeting outlining what action is to be taken.

In light of the serious traffic congestion on Galtymore Road, between the junction of Carrow Road and Galtymore Road and the junction of Galtymore Road and Benbulbin Road will DCC implement agreed traffic calming as a matter of urgency so as to remove any further threats to the 123 bus service along Galtymore Road.

#### M256 Councillor Vincent Jackson

That Dublin City Council consider the installation of an all-weather football pitch at the Tarmac surface on Drumfinn Road Ballyfermot Dublin 10. The Ballyfermot Youth Reach have approached me looking to see if DCC could do this work and they would help manage the facility during the days as there centre is adjacent to the open space. I am very confident a number of sports groups would be delighted to get involved in the operation and management if consideration could be given to enhancing this facility.

#### M257 Councillor Vincent Jackson

That Dublin City Council please look into providing a pedestrian / Zebra Crossing from Blackditch Road Ballyfermot near the junction with Le Fanu Road Ballyfermot Dublin 10. The new skate-board park / playground is used by thousands of children and youth on a weekly basis. The road is very busy here with traffic movements and many near accidents have happened. I am asking this be looked at as a priority.

#### M258 Councillor Vincent Jackson

That TAG be asked to look at the installation of yellow lines at the Junctions of Gurteen Avenue, Ballyfermot Dublin 10 and Drumfinn Avenue. Residents are having a very difficult time with some people parking directly on the bend leaving cars exiting Gurteen Avenue having to move half way out onto the road to check if there is ongoing traffic coming along. It is an accident waiting to happen.

#### M259 Councillor Sophie Nicoullaud

To ask Traffic Department to urgently find a solution to remove road blockages in Drimnagh to avoid having buses waiting for road clearance. That DCC agreed in principle with bus drivers' Union and Dublin Bus to take all necessary measures to solve the situation at the moment has a negative impacts on working conditions and bus users. In the long term with all the new apartment complexes being built in the area, I would ask DCC to demonstrate to us and to the residents how traffic will be managed. One way streets have been proposed for years to solve some of the issues and nothing has been changed.

#### M260 Councillor Sophie Nicoullaud

Construction on the De La Salle site on Ballyfermot Road in Ballyfermot has commenced with some 27 breaches of pre-commencement conditions. Residents have never received any communication from the developer Dwyer Nolan. Dust is blowing everywhere out of control, entering homes, cars being covered with a thick layer of dust on a daily basis and no arrangement for car wash and house window cleaning from the developer to compensate the residents. Report of work starting before 7 am in the morning, road cleaning happening only on the side of the site creating muck almost covering yellow lines on the opposite side. I am urging Planning enforcement to solve all of the pre-commencement conditions as soon as possible. I am asking that the developer provide a

contact person to liaise with the residents and that window cleaning be done for the residents at the cost of the developer and that vouchers are given to residents with vehicles.

That DCC Housing Department liaise with Tuath and Havitat management at the Davitt Road Apartments to make sure the Part V tenants living there who were on Dublin City Council housing lists have full access to the playground and all facilities within the complex as soon as possible.

#### SOUTH WEST INNER CITY ELECTORAL AREA

#### **Public Realm & Capital Programme**

**Francis Street:** A suite of planters with trees have been installed on Francis Street and Dean Street, completing the landscaping element of the Francis Street Environmental Improvement Scheme. In total, 33 trees and a variety of planted areas offering year-round colour have been added to the street.

**Dolphin's Barn:** Landscaping work is now largely completed at Dolphin's Barn, adding a Sustainable Drainage System (SUDS) planted area with trees, tree planters, seating and cycle parking. The Area Office is currently awaiting Transportation Section's assistance on the second element of this project to reduce guardrails and improve signs and markings.

**Cork Street & St Luke's Avenue:** Tree planters and a number of seasonal bedding planters have been installed on Cork Street, making a marked visual improvement to the street. A proposal to add greenery to the long wall at St Luke's Avenue/ Weaver Street will be implemented later in the summer.

**Bridgefoot Street Park:** A new café has opened in the park. The Mug Shot Café is being run by PACE social enterprise.

**St James's Walk Linear Park:** Phase II works continue. It's expected the refurbished east end of the park will reopen in late July/August.

#### Kilmainham to Thomas Street Cycle Route Suir Road to Thomas Street Interim Scheme June Update

The scheme is seeking approval for delivery as planning exempted development under Section 38 of the Roads Act.

The Active Travel Programme Office (ACTPRO) are confident of receiving this approval in the very near future which will allow publication of the completed public consultation report and the construction procurement process to begin.

The ATPRO have been finalising the detailed design / construction pack and continue to engage internally with the appropriate teams with a view to begin delivery of the section of the Route from Rialto Bridge to Marrowbone Lane at Summer Street South during the summer months this year.

The Thomas Court, James Linear Park and Suir Road Junction elements of the Interim Scheme will be delivered in a second phase later in the year.

Design consultants have been appointed and continue to work through the project life cycle for the more permanent scheme to follow during or post 2024 which will ultimately link the scheme to Kilmainham.

#### **Grand Canal Premium Cycle Route - Portobello to Blackhorse Bridge**

The Grand Canal Greenway (Blackhorse to Portobello) is currently at the Concept Development and Options Selection Phase. The Active Travel Programme Office (AcTPrO) had identified this project as a priority project for the AcTPrO design office. The AcTPrO design office is expected to begin work in Q3 2023. The Strategic Assessment Report is being finalised and is expected to be submitted to the NTA for approval by the end of June 2023.



#### **Economic Development**

Shopfront Improvement Scheme 2023 SWIC: 20 project applications were received and are being supported by this year's scheme across SWIC.

#### **Inchicore Library Building**

A Condition Survey of the former Library Building, Emmet Road, Inchicore, Dublin 8 is now complete. The report will be examined in detail before a plan is prepared and made available to Councillors and other stakeholders. Access to the building will be considered as part of future proposals.

<u>Kilmainham Inchicore Network</u> - next meeting 19<sup>th</sup> June 5.30pm, 6 Tyrconnell Road (postponed from 29<sup>th</sup> May)

#### KIN Strategic Planning Process

Revised draft KIN Vision and Strategic Plan overview presented at April KIN meeting and circulated to members for feedback agreement, acceptance and implementation from 19<sup>th</sup> June 2023 meeting.

#### Bus Connects Route 7 – Liffey Valley to City Centre.

An Bord Pleanála wrote to KIN re the response from NTA to KIN's submission on this route. KIN have until 5<sup>th</sup> July 2023 to respond. A draft is currently being prepared and will be circulated to members for their consideration and comments.

<u>Inchicore Regeneration Consultative Forum</u> – next meeting Monday 19<sup>th</sup> June 7pm (postponed from 29<sup>th</sup> May 2023). 6 Tyrconnell Road.

The decision deadline on the Emmet Road Development planning application to An Bord Pleanála of 11th April has expired and DCC have no further update from An Bord Pleanála in relation to a revised date.

**IRCF Education Subcommittee** meeting Friday May 12<sup>th</sup> at Mercy Secondary School Reviewed previous meeting (Nov 2019) and discussed what has changed. Nominations for Chair of IRCF Education Subcommittee requested – Michelle O'Kelly will stay in the role. Next meeting scheduled: Thursday 24 Aug 2023 10.30am, Mercy Secondary School.

#### Community of Practice Shared Learning Experience Regeneration 4th Event

Thursday 29<sup>th</sup> June at 9.15am, F2 Centre.

The purpose of the session on Thursday 29<sup>th</sup> June is two-fold;

- To review progress in implementing all the agreed actions
- To collectively engage with a presentation from Professor Padraic Kenna in which he seeks to clarify and set out the steps involved in the regeneration of Local Authority and surrounding areas in an Irish context. It summarises government guidance and highlights the stages where community input can be most effective.



#### Housing

#### **Oliver Bond Regeneration**

Local area Office met with Oliver Bond Celtic - We are awaiting a proposal to be made by them to host a 5-A-Side event on the pitch in the complex.

The Estate management Team are working in conjunction with our Community Section and the Residents Committee to hold three events over the course of the summer in three separate areas of the complex, to improve community development and interaction and also to deter Anti-social behavior.

The Project Estate Officer carried out an age profile report on the youths of the complex so events arranged could be geared towards all relevant ages.

We have engaged the Try Project and Solas Project to seek their assistance in dealing with the youths who are engaging in serious Anti-social behavior.

Choice Based Lettings: Four of the five units that were offered and viewed have been accepted by selected applicants.

#### **Bonham Street Volumetric**

It is envisaged that units will be ready to let Q3 2023. DCC have designated a Project Officer (Eric Brennan) to engage with residents. <a href="mailto:eric.brennan@dublincity.ie">eric.brennan@dublincity.ie</a>

#### **Basin Street**

The proposed variation of rezoning the Basin View Site was passed on 12<sup>th</sup> June 2023 by our Elected Representative, the variation will go out to public consultation which will run for a four week period.

We are in the process of rolling out the Building Community Resilience Project and interviews of all professional stakeholders is near completion, next step will be interviewing the community.

The SWIC public safety meeting was held 14/06/2023 in St James Primary School in Basin Street. It is the first time in many years that the meeting was held nearer to Basin Street and there was a positive and successful turn out.

#### Mary Aikenhead

Works are reaching completion on the new bin chambers for the complex.

The local Area Office has begun the process of setting up a residents committee in Mary Aikenhead House.

#### **Tyrone Place**

A property for the Project Estate Officers Clinic still has not been sourced after discussions with the local family resource services, who use the community rooms in the complex. However the discussions are ongoing for use as a temporary measure.



#### **Islandbridge Court**

A new residents committee has been established in the complex. We have also a unit selected to hold weekly clinics which will cater for Islandbridge/Memorial Courts and also Sarah Place. These clinics should commence in the coming weeks.

#### **Dolphin House Regeneration**

The Dolphin House Regeneration Masterplan was approved on the 4th Feb 2021 by the Dolphin House Regeneration Board. We are progressing the masterplan in conjunction with the Dolphin House Regeneration Board and the Dolphin House Community.

#### Regeneration Board

The Regeneration Board have been advised of revised timeline for the masterplan which will reduce the delivery of Phase 2.

Phase 1B to proceed for planning permission in July. The Housing Delivery Manager and the Area Housing Manager will meet with the residents who are opposed to this ahead of submission.

#### De-tenanting

Three families relocated to Block F Herberton. Thirteen families remaining. The Area Housing Manager and the Project Estate Officer met with the remaining tenants of the long block who have a de-tenanting priority.

#### Interim Playground Facilities

The new playground and additional surface works have been completed. Date to be agreed for official opening. Dog Wardens have been contacted informing them of the situation of dog fouling. Signage has been erected. Bins due to be installed in June. Safety Barrier to be installed outside of the bollards at the entrance – agreed with Santry steel.

Double Yellow Lines completed.

#### Old Football Pitch Site

Inspections carried out and quotes received to enhance and upgrade the area. Public Lighting are investigating the reinstatement of the floodlighting. – Quotes for upgrading received – consultation processes still ongoing. Housing Delivery Manager & Area Housing Manager to meet with Regeneration Board Co-ordinator Thursday June 15<sup>th</sup> June to progress.

#### **Community Centre**

Fire Safety Audit commenced – awaiting report.

A number of upgrading works & repairs have commenced to include roof repairs, gutter replacement, boiler upgrade and electrics repaired in the home work club.

Quotes for further works to include ramps, handrails and fire doors received.

#### Painting of Complex

The foreman has advised they are off site for the moment due to the weather. They are working on internal jobs for now. They have completed the painting of the railings along the canal. Painting crew back onsite and they will complete the painting of all the railings and also have the hoist onsite to paint the balcony walls. — No change on this — still on schedule.



#### St Teresa's Gardens Development Site

On-going reports of anti-social behavior on the site, teenagers accessing the units above Donore Boxing Club – Area Housing Manager met with the Project Manager Martin Donlon on-site on the 16th May and it has been agreed that all windows in the units in the front block will be secured. Housing maintenance will complete this over the coming weeks. Ongoing dumping in and around the site. Project Estate Officer has implemented a regular cleaning programme. Housing Delivery Manager Laura O Gorman has confirmed that the demolition will be carried out in two phases and is likely to commence Quarter 4.

#### **Margaret Kennedy Road/Court**

The Area Office have engaged a specialist door company to assess the front door of Margaret Kennedy Court. On-site meeting took place on Tuesday 16th May with Housing Manager and Housing Maintenance to discuss alternative options for access to Margaret Kennedy Court. Housing Maintenance have agreed to cover the cost and arrange installation.

Two 3 bed properties currently secured on Mary Kennedy Road, one threat to life, one serious ASB. Alternative accommodation has been secured for the threat to life case and the property has been recovered. These properties will in due course be advertised through CBL.

#### Cork Street / Chamber St Volumetric - 55 Units

Current Estimated Completion of scheme - end of Q2 2023

It is anticipated that these units will be allocated under CBL.

An on-site meeting took place between DCC and residents of Oscar Square to address concerns raised about the installation of the ESB access gates installed at the boundary of the development in Oscar Square. Residents believe these gates will become a magnet for ASB and youths entering the new development. Residents requested that a metal sheet be installed on these gates so they cannot be used as a climbing frame. DCC design team have agreed to liaise with the ESB & Sisk to find a solution, advised this could take a number of months.

DCC have designated a community liaison (Laura Kenny) to engage with residents.

#### Reuben/Herberton

The Project Estate Officer has started a drop in clinic in the F2 Centre. This is for locals who have any housing or maintenance queries that they wish to have dealt with. This clinic operates one day a week from 10.00am -12.00 noon.

Herberton 39 units Part V.

On-going remedial works -28 of the 39 units have been allocated – selections for all units are completed.



#### **Ash Grove**

Funding of €5,000 has been allocated for improvement works, to include cleaning and planting. Awaiting quotes.

Allocations - SWIC 2023 - 39 units allocated to date.

#### **COMMUNITY**

#### **Blooming Lovely**

A large range of pollinator friendly plants have been distributed to residents groups and organisations throughout the SWIC this last few days.






#### **Ballyfermot Heritage Trail Map**

This space offers various massage treatments along with Reiki and meditation to groups and individuals in the community. Bookings by appointment only.





 Clanbrassil Street/Harold's Cross Bridge – there is no right filter light to go from canal towards Harold's Cross. Right turners here get out one or two cars at a time maximum and it causes back up problems along the canal that could be alleviated by a short filter light. Can this be reviewed and improved?  Donore Avenue/Sally's Bridge – cars coming from Clogher Road turning right onto the canal have a filter light, but from other directions, there are no filters causing backups. As this junction is being redone to incorporate wraparound pedestrianisation, can the traffic signals and filters be reviewed to optimise traffic flow?

#### Reply

The junction of Harold's Cross Bridge is a heavily used junction for pedestrians, cyclist public transport and private vehicles in all directions, it has been optimised as much as possible to help keep traffic moving including allowing some time for the right turning movements from Parnell Road towards Harrold's Cross.

At this time there are no plans to install a filter light at this junction as to do would greatly reduce traffic optimisation and cause delays to public transport. We will continue to review the junction and make changes where appropriate.

The junction of Donore Avenue/Sally's bridge is currently being upgraded as part of Active Travel scheme. This involves the installation of a wraparound pedestrian crossing as well as facilities for cyclist. As this is part of this active travel project, there are currently no plans to install an additional filter light at the junction as this would result in delays to all uses and in particular delays to public transport. Once the new operation is installed it will be monitored and reviewed in order to ensure any delays are kept to a minimum

Please note also that the existing public lighting on Hamilton Street are planned to be upgraded to LED this year under the Lighting Infrastructure Upgrade project. These works are expected to be completed by the end of 2023. Until the upgrade works are

completed, routine maintenance work on the existing street lighting will continue to be carried out

#### Waste Management Report - July 2023

#### **RE: Collection of Green Waste Clippings**

With regard to green waste, Parks & Landscape Services have advised the following:-

"In accordance with a more sustainable policy with regard to amenity grass maintenance to support the establishment of wildflower rich swards, DCC will only be maintaining open spaces/greens and will not be cutting grass margins in residential estates.

Residents who wish to maintain a more manicured margin can do so. This policy is in keeping with the policy of every other local authority in the country. Support for Tidy Towns and environmental groups who wish to contribute to the appearance of their neighbourhood streets will be available by contacting their local public domain officer."

Should Resident Committee's/Environmental Groups wish to cut the grass margin, it is DCC's preference that the cut grass should be left in place to allow for return of valuable nutrients like nitrogen back into the soil in accordance with best practice and as outlined in the document attached. While Waste Management are fully supportive of the Parks and Landscape biodiversity policy and the Environmental Protection Agency policy on grass cycling, we are mindful of resident's groups hard work in maintaining their local areas.

Where Residents Committee's/Environmental Groups wish to maintain a more manicured margin, and wish this grass to be collected then they should <u>only</u> use Waste Management services new "Compostable bags". These bags will be collected, subject to prior engagement with waste management staff and the local public domain teams, and when resources are available at times agreed between the Resident Committee's and Waste Management Staff. We would like to reiterate that collection of cut grass and presentation for collection should only be carried out on <u>rare</u> occasions as Waste Management services have not planned for this service, and the servicing of such is demanding on resources. It should be noted that large green spaces are not included in this service.

Green waste from private gardens should not be presented for collection and should be disposed of within the brown bin. Green waste presented by private residents will be regarded as illegal dumping and could be subject to a fine of €150.00

#### **HELL & BACK 2023**

Ireland's largest and toughest obstacle course challenge is back this year. DCSWP will have local youth services to support its youngest and most daring participants Training programmes are being provided across the city and South Central Area during the summer for young people in the lead up to the 7km adventure challenge in Kilruddery, Wicklow in August.

#### **Active Cities Box Up Stations**

As part of the Active Cities Dublin initiative (funded through Dormant Accounts and Sport Ireland), the Sports Partnership have purchased two Boxup storage stations to be used for storing sports equipment in outdoor parks.





These unique stations are designed to store a variety of sports and exercise equipment that can be accessed by the public free of charge for up to 3 hours. The user just downloads the Boxup app on their phone which then enables them to choose the sporting equipment they would like to borrow. The locker is then opened and the equipment made available to them. The App, which is registered to the user using a document of identification, will also provide user data and feedback.

The Boxups will provide more opportunities for people of all abilities to get active and will encourage increased use of parks sporting facilities and open spaces.

The boxes are solar powered providing an economical and environmentally friendly way of providing better access to new and existing activities. DCSWP have ordered two units one to be placed in Mt Bernard Park, Cabra and the second in Sundrive Park, Kimmage.
