3. (details supplied) is covered by the 30 km/h Slow Zone sign, indicating the lower speed limit the area is a Home Zone/Slow Zone, which warns motorists that it is a residential area and to expect children. The Area Engineer does not recommend the provision of extra traffic calming measures at this location.

General Matters

Finglas Employment Initiative:

The Local Area Office has initiated contact with all the major infrastructural investors in the Finglas Area with a view to providing employment opportunities to local people with regards to the LUAS and various other projects happening in the area. New members to include Colaiste Idé, The Finglas Training Centre which will add depth to the level of services to be offered under this project. All Post Primary Education Centres have been contacted with a view to engaging young people in training/education/third level courses to prepare for all employment opportunities that will occur as a result of investment in infrastructure, accommodation, education, business and retail.

The next meeting will take place on the 17th November 2023.

Finglas Business Association

The Local Area Office is contacting businesses in the Finglas Area with a view to creating an effective forum that encourages and supports local businesses to connect and engage in the economic and community enhancement of the Finglas Area.

Scribblestown

The Area Office initiated a mini competition from the Consultants Framework. There was no uptake from the contractors due to leave commitments and the short timeframe.

The Area Office has initiated a full tender competition and to that end has compiled all the relevant paperwork to proceed to the procurement process. End dates and evaluation process has yet to be finalised. However, it is expected that the process will be fully complete by the end of the year with survey start dates in mid-January.

All homeowners have been appraised of the taking in charge process and to that end were provided with relevant request form for completion. There has been a very slow response to date.

Berryfield

The Housing, Community and Public Domain Sections are working with the residents in Berryfield and the surrounding area with a view to alleviating some of the issues that have been identified by residents. Walls have been cleaned off and the Public Domain and Housing Teams have authorised a number of clean-ups.

Small Scale Works

Works under this scheme are continuing. Further works will be completed by the end of the year that will further enhance the Finglas area.

Neighbourhood Transport Scheme

Neighbourhood Transport Schemes are aimed at addressing the problems in residential areas affected by transport issues such as cut-through traffic, speeding and other dangerous issues.

The aim of the scheme is to allow for more walkable and calmer streets where the priority is given to pedestrians, cyclists and sustainable transport.

These schemes typically involve implementing filtered permeability measures (i.e. bollards and/or planters installed across the road) to reroute motorised traffic out of residential areas and onto the main roads. The schemes are initially installed for a 6 month trial period following public consultation and with the support of councillors. The effectiveness of the trial is evaluated during the trial which includes analysing traffic surveys and further public consultation. An evaluation report summarising the results is presented to councillors and councillors advise whether to install the scheme permanently or remove it.

The area around Willow Park Avenue/Grove was initially selected. However, having consulted with Local Councillors who provided some feedback from the local community, the scheme was withdrawn.

The Area Office will continue to work with the Neighbourhood Transport Engineer, Local Councillors and the community to seek suitable areas for improvement.

Teen Spaces

Funding has been sought for a second Teen Space in the Finglas South area. If successful, the Area Office will need to secure some additional funding in order to achieve the ideal space with relevant services to ensure what has been requested can be provided.

Preliminary investigation regarding costs, location etc are ongoing.

City Neighbourhood Awards

Congratulations to all involved and especially to Lakeglen who were overall winners. This is as a result of all the hard work by the communities with the support of our Public Domain

and Community & Social Development teams. The North West Area have every reason to be proud of these achievements.

Dublin City Council, Finglas Area Office in conjunction with Finglas Library launched an exhibition of photographs by Mr. John Sunderland. The exhibition focused on the development of St. Canice's Abbey & Graveyard. The exhibition will remain in the library for "History Month"

**NOTIFICATION OF PROPOSED VARIATION NO. 4 TO THE DUBLIN CITY
DEVELOPMENT PLAN 2022-2028 RELATING TO SDRA 3 – FINGLAS VILLAGE
ENVIRONS AND JAMESTOWN LANDS, TO INCORPORATE THE APPROVED
JAMESTOWN MASTERPLAN 2023**

1.0 Introduction

Notice is hereby given pursuant to Section 13 of the Planning and Development Act 2000, as amended, that Dublin City Council (DCC) intends to propose a variation to the Dublin City Development Plan 2022-2028 (the Development Plan) to amend SDRA 3 – Finglas Village Environs and Jamestown Lands to include:

- Deletion of section B ‘Jamestown Lands’ of SDRA 3 and replacement with the recently approved Jamestown Masterplan 2023 (the Masterplan).
- Modification of figure 13-3 to reflect the Jamestown Masterplan.

DCC’s Planning and Property Development Department published the Jamestown Masterplan on 21 September 2023, made according to the requirements of SDRA 3 of the Development Plan. The Masterplan is a detailed refinement of the SDRA framework set out in the Development Plan for 43 hectares of Jamestown Industrial Estate lands at Jamestown Road, St Margaret’s Road / McKee Avenue, Finglas, Dublin 11.

Following a public consultation process from 27 March to 15 May 2023 (both dates inclusive), the Masterplan was approved at the monthly council meeting on 3 July 2023. Changes to the content of the Draft Masterplan were made following the public consultation process, as set out in report nos. 142/2023 and 150/2023 of the Chief Executive and as amended by motions agreed at the Council Meeting on 3 July 2023.

The Jamestown Masterplan represents an urban design-led and evidence-based approach to the regeneration of this strategic land bank, capitalising on significant state investment in public transportation in accordance with national and regional policy objectives relating to compact and sustainable growth. Accordingly, it has the capacity to deliver new homes, create

new and support existing jobs, along with the provision of associated community and educational uses, all underpinned by exemplary urban design principles.

While the Masterplan is given statutory effect by SDRA 3 of the Development Plan, it is proposed to incorporate the approved Masterplan into the Development Plan. This will give full legal status to the Masterplan.

2.0 Environmental Assessments

In accordance with the SEA Directive (2002/42/EC) and the provisions of Schedule 2A of the Planning and Development (Strategic Environmental Assessment) (SEA) Regulations 2004-2011 (the SEA Regulations), the approved Masterplan was screened for Strategic Environmental Assessment (SEA). A screening for Appropriate Assessment (AA) was carried out having regard to Article 6(3) of the Habitats Directive. DCC as the Competent Authority, having considered the SEA and AA Screening Reports prepared by DCC, and having consulted with the prescribed environmental authorities, has published final determinations along with the approved Masterplan. A Strategic Flood Risk Assessment (SFRA) and Surface Water Management Strategy was also prepared. The approved Masterplan, along with the aforementioned reports and determinations are available:

In accordance with the provisions of the Planning and Development Act 2000, as amended, and the Planning and Development Regulations 2001, as amended, the proposed variation will be subject to further SEA and AA screening and determinations will be issued.

As required by legislation, Dublin City Council is carrying out consultation with prescribed bodies including:

- The Environmental Protection Agency.
- The Minister of Housing, Local Government and Heritage.
- Development Applications Unit of the Department of Housing, Local Government and Heritage.
- The Minister of Environment, Climate and Communications.
- The Minister of Agriculture, Food and the Marine.
- Adjoining planning authorities (South Dublin County Council, Fingal County Council, Dún Laoghaire-Rathdown County Council).

DCC as the Competent Authority, will issue final determinations on the requirement for SEA and AA that will accompany the proposed variation.

3.0 Process

Pursuant to Section 13 of the Planning and Development Act 2000, as amended, the proposed variation will be placed on public display for a period of 4 weeks, commencing end October / early November (exact date to be confirmed). During this time, members of the public and interested parties will be invited to make submissions. A Chief Executive's Report will be prepared and issued to the elected members of Dublin City Council, no later than 8 weeks

after commencing the public consultation process. The consideration of the proposed variation and the Chief Executive's Report shall be completed not later than 6 weeks after the submission of the Report to the elected members. In accordance with Section 251 of the Planning and Development Act, the period between 24 December and 1 January (both dates inclusive) shall be disregarded when calculating appropriate periods or other time limits referred to in the Act or in any regulations made under the Act. The members, having considered the proposed variation and Chief Executive's report, may, by resolution as they consider appropriate, make the variation, with or without modifications, or they may refuse to make it. The Chief Executive intends that proposed Variation No. 4 and the accompanying Chief Executive's Report be considered at the council meeting in February 2024.

The day was a great success, well attended and there was positive feedback from participants to further develop the above programmes and activities in the community. Our Community team and Sports Development Officer will follow up on same.

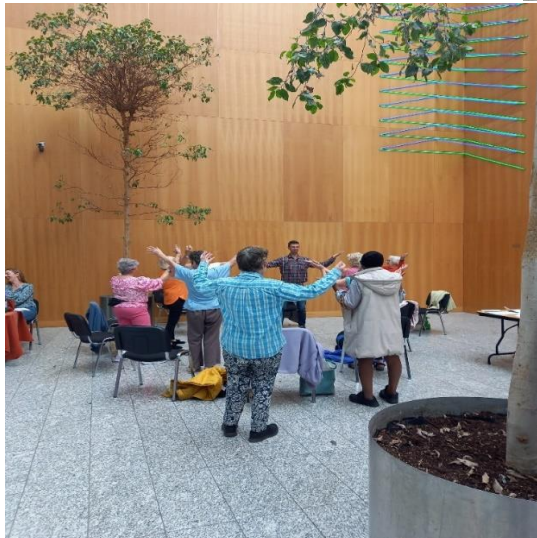


Coultry Gardens Fun Day

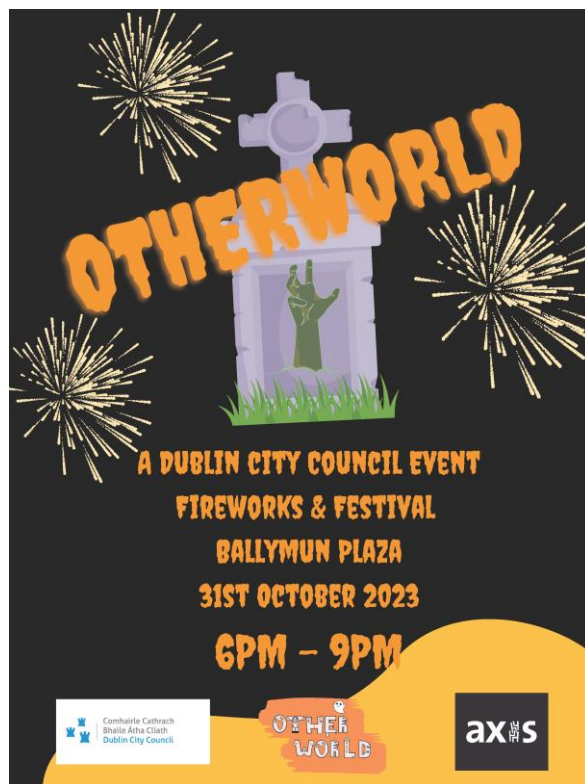

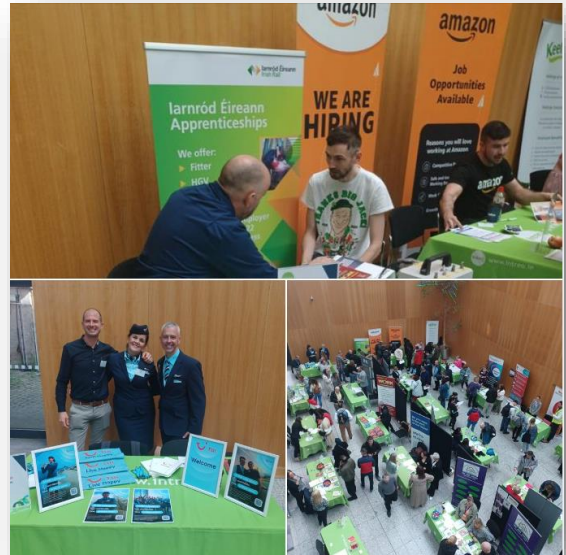

By way of licence dated the 1st October 2019 Dublin City Council granted a 3 year licence to The North Dublin Citizens Information Service CLG for the use of two amalgamated office units, at ground floor level, Ballymun Civic Centre. The last licence expired on 30th September 2022 and terms and conditions have now been agreed in relation to the granting of a 3 year Short Term Business Letting. The area to be let is shown outlined in red and coloured pink. The group have shared use of the area shown yellow on Map Index SM-2019-0338.

It is therefore proposed to grant a 3 year Short Term Business Letting to The North Dublin Citizens Information Service CLG subject to the following Terms and Conditions which I consider to be fair and reasonable:

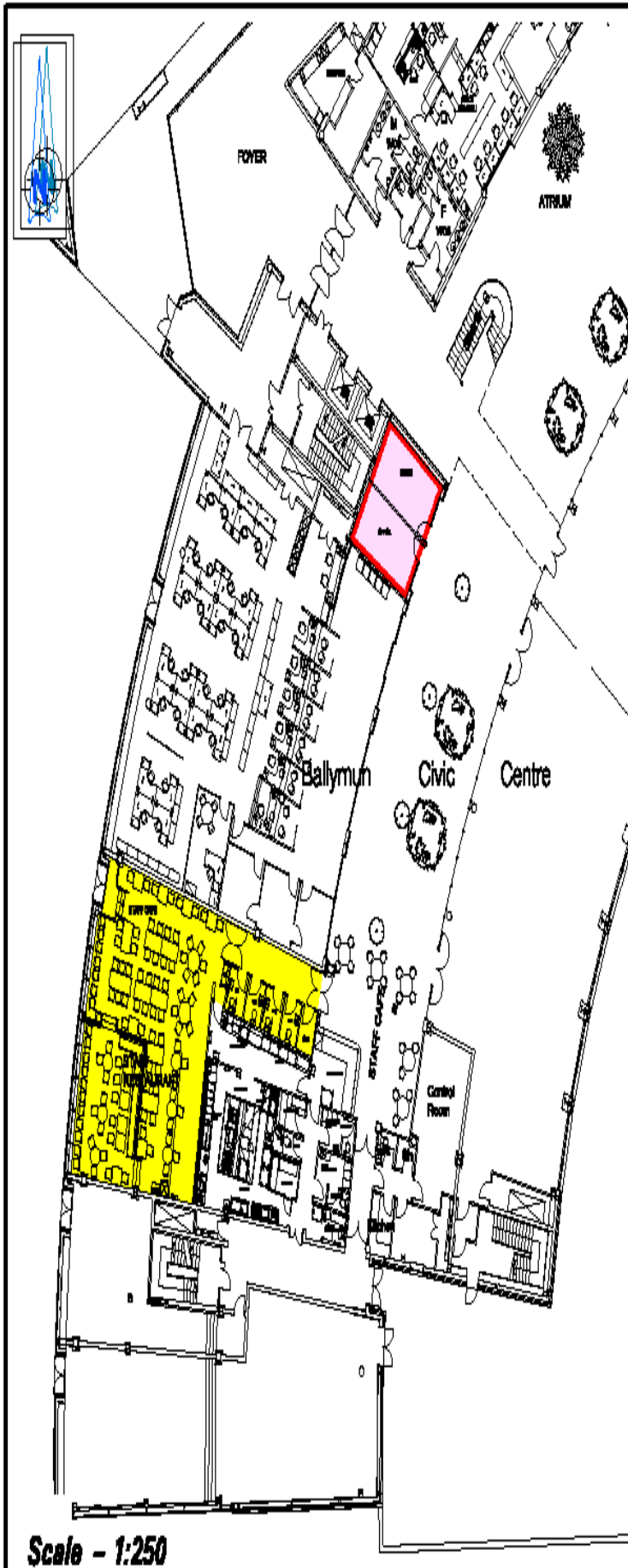
1. That the subject property comprises a ground floor office unit shown outlined in red and shaded pink plus, shared use of the area coloured yellow, on the attached copy map SM-2019-0338.
2. That Dublin City Council shall grant a three year Short Term Business Letting from the 1 October 2022.
3. That the commercial letting fee shall be €10,400 (ten thousand & four hundred euro) (VAT not applicable) per annum.
4. That the subject property shall be used solely as a Public Information Centre with a minimum of 25 (twenty five) public opening hours per week: 9.30 am to 12.30 pm x 5 mornings plus 2.00 pm to 4.30 pm x 4 afternoons.
5. That the lessee shall pay an abated letting fee of €200 (two hundred euro) (VAT not applicable) per annum, payable annually in advance by standing order or electronic funds transfer, provided term 4 above is fully complied with, otherwise the commercial letting fee shall be payable.
6. That the lessee shall be responsible for the payment of rates, facilities/service charges, utilities, building insurance, waste collection, taxes and all other charges for the letting area.

7. That the lessee shall indemnify Dublin City Council against any and all claims arising from its use of the property. Public Liability Insurance (minimum of €6.5 million) and Employers Liability Insurance (minimum of €13 million) shall be required.
8. That this letting is personal to the North Dublin Citizens Information Service CLG and the lessee shall not assign, sublet or part with possession of the property or any part thereof.
9. That the letting may be terminated by either party upon giving one month's prior written notice.
10. That the lessee shall be responsible for internal repairs including all plate glass.
11. That the lessee shall keep and yield up the licensed area clean and tidy.
12. That the lessee shall not carry out any structural alterations to the property.
13. That the lessee shall sign a Deed of Renunciation of renewal rights.
14. That the lessee shall abide by all protocols, systems and procedures laid down by Dublin City Council and the Building Managers of the Ballymun Civic Centre.
15. That each party shall be responsible for their own fees and costs incurred in this matter.

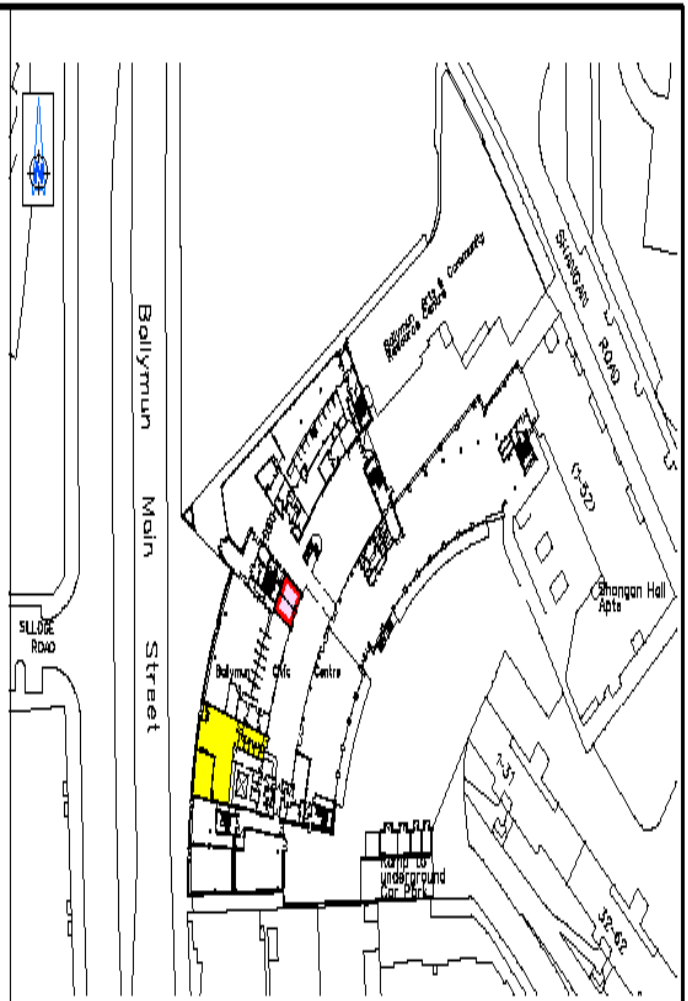

Graffiti removal September

In September 265 sq. meters of graffiti was removed in North West Area.

To date 1178 sq. meters of graffiti has been removed during the period of January 2023 to September 2023.

We are expecting an increase for the month of October with Halloween approaching and we will deal with each issue as quickly as possible. Extra resources will be in place over the next few weeks to handle the extra volume of work.

Halloween

The Public Domain Team are working closely with the Garda and other DCC departments to arrange for the collection of bonfire material prior to and on the day of Halloween. Additional resources have been secured to assist with the clearing of bonfires in the NWA over the Halloween weekend. Social media posts from the North West Area will be delivered on a regular basis in the coming weeks, and we will be posting daily reminders to report stockpiling in the days leading up to Halloween.

Teams will be on the ground from Saturday 22nd to Tuesday 31st to remove any stockpiling of bonfire materials.

Anti-Dumping Initiative

The NWA was allocated € 12243.09 in funding year 2023. The Public Domain Team coordinated the Mattress and WEEE Amnesty Days as part of this project. Two separate events were held to promote the reduction of Electrical Waste and Mattresses. One in Finglas Civic Offices, Mellows Road, Finglas, D. 11 and one in Ballymun (Trinity Comprehensive School), Main Street, Ballymun, D 9. The events were held over 4 hours each day on the 16th & 23rd September, 2023 and proved to be very successful. Recycle IT recorded over 1000 Items, 4.343 Tonnes of Electrical waste was removed. Over 200 Mattresses were collected. We are hopeful that this will reduce the number of mattresses dumped and discarded over the Halloween period. It also promotes the recycling message at a more local level.



Weeding

The weeding contractor has completed their contract for 2023 in the North West Area. The use of acetic acid and its efficacy will be reviewed by the Public Domain Officers citywide and recommendations will be made to improve the service in 2024. In the meantime additional weed control resources have been allocated to the areas. Particularly overgrown areas will be serviced by Contractors and in-house staff by manual removal.

Leaf Collection Scheme



The Public Domain Team has recently received new biodegradable leaf collection bags. The obvious advantage of a biodegradable bag is its capacity to entirely decompose into natural components, which can reduce the breakdown time to as little as 90 days in some situations. Compostable bags have numerous other advantages such as lowering landfill contributions. In addition, there are fewer greenhouse gas emissions and lower water and energy usage during manufacturing. When composted properly, compostable bags are safer for humans, animals, nature and the environment and they provide excellent fertiliser. These new compostable bags have been distributed to groups and can be ordered through the following channels:

Leaf composting course

The Public Domain Unit successfully ran two leaf composting courses in conjunction with doctor compost at the locations Willow Park Grove Finglas and Belclare Lawns Ballymun. Composting is a fantastic way of re-purposing waste and creating peat-free and nutrient-rich compost for growing. It's about re-connecting with the earth and going back to our roots. For a long time horticulture and growing has depended on peat-compost. We have seen the devastation this has had on our bogs and peatlands.

We need to transition away from peat-compost and embrace alternatives. Composting is a great start. Watch our event to hear how you can act to save peatlands.

2023 – Linking in with National Events & Initiatives

The primary goal of Dublin City Sport & Wellbeing (DCSWP) is to provide opportunities for everyone to get involved in sport & physical activity regardless of age, gender or ability. In 2023 DCSWP continues to align the planning and delivery of programmes with national and international events. This strategic approach helps maximise promotion of the service, adds momentum to local programmes and initiatives and ultimately increases reach across communities in Dublin City.

Please see below highlight programmes for October 2023.

Marathon Kids 2023

Marathon Kids is an 8 week physical education program covering daily short runs, physical & mental health education, nutrition, exercise and lots of fun. The programme is a national initiative aimed at primary school students at 4th, 5th and 6th class level. David Gillick, ambassador for Marathon Kids visited the 50+ schools (including schools from the North West area) participating in this year's programme during European Week of Sport/Dublin Sportsfest 2023.

Staffing News

Sport Officer (x2) and Sport Inclusion and Integration Officer roles (x 2. 3 year temporary) have been advertised. Closing date for application was 12 September. The Shortlisting/Eligibility/Interview process is to follow shortly.

DCSWP SIMS (School Information Management System) For Schools Motor Sport Programme Highlight Programme

DCSWP and Active Cities, in partnership with Nicci Daly and Formula Female, launched the Dublin City Council SIM For Schools Program across five schools in each administrative area during European Week Of Sport/ Sportsfest 2023. The programme engages transition year classes in girls' schools providing the opportunity to take part in this novel motorsport programme, utilising simulator rigs that DCSWP has purchased. The programme is delivered by Nicci Daly. Nicci is a Member of the Ladies Hockey Team who won the Silver Medal at the 2018 World Cup, and was a member of the team that represented Ireland at the 2020 Olympics in 2020. Nicci's family is steeped in the Irish motorsport history, and Nicci herself worked as a data engineer for Juncos Racing in Indycar from 2016. In the USA Nicci has developed a programme aimed at introducing motorsport opportunities for school aged girls, while also overlapping and interweaving stem elements that will compliment academic curriculums, using the interactive platform of simulator rigs.

This new and exciting DCSWP programme runs for 6 weeks, as students work through a progressive curriculum with overlapping interweaved elements, developing technical knowhow, racing skills, team promotion and design. There will be ongoing friendly competition as well as a final event between the schools. There is also potential opportunity for final participants to participate in a high profile final event at Gamer Fest 2023 in the RDS, as well as experiential finish day in Mondello with actual in-car experience. The Programme has also been approached by TG4 who want to do a piece on the programme and organisations such as Curry's/World who are interested in further sponsoring the programme.

- **In the North West Area (NWA) the six-week programme was launched in Trinity Comprehensive, Ballymun on Friday 29th September.**

Sport for Young People Small Grant Scheme 2023

170 applications have been received from clubs across the city including the North Central Area (closing date 2nd June 2023). Sport Ireland Contribution for 2023 is €80,000. The first phase of the assessment is complete with phase two in progress.

This is a priority for DCSWP and clubs will be notified in the coming weeks. Once confirmed, a list of NWA clubs can be provided for the committees' information on request.

Active Cities (Citywide)

- BoxUp

As part of the Active Cities Dublin initiative the Sports Partnership have purchased two Boxup storage stations to be used for storing sports equipment in outdoor parks.

These unique stations are designed to store a variety of sports and exercise equipment that can be accessed by the public free of charge for up to three hours. The user downloads the Boxup app on their phone which then enables them to choose the sporting equipment they would like to borrow. The locker is then opened and the equipment made available to them. The App, which is registered to the user using a document of identification provides user data and feedback.

The Boxups will provide more opportunities for people of all abilities to get active and will encourage increased use of parks sporting facilities and open spaces units have to date been placed in Mt Bernard Park, Cabra and Sundrive Park, Kimmage as part of the pilot city parks roll out.

Athletics in the Community

Couch to 3/5k and walking programmes continue in the NWA area in partnership with the Co-funded Athletic Officers. Officers continue to engage with schools in the Daily Mile and school track and field programmes. As above the Marathon Kids programmes continues in primary schools in the NWA area.

Boxing in the Community

The **Startbox** Initiative, a partnership between the IABA and Dublin City Sport & Wellbeing Partnership, represents an ideal way for young people (10 – 17 years) to first engage with amateur boxing, Ireland's most successful Olympic sport. It is delivered by our 5 dedicated IABA/DCSWP Development Officers via local schools (primary & TY level) in communities across the Dublin City area. Approx 2,000 young people take part each year.

The Programme is structured into Bronze (non contact), Silver and Gold phases. The first phase focuses on general strength & fitness, method and technique. The Silver Programme consists of higher intensity sessions & limited contact and the Gold phase takes it to another level (combination of first two levels and progression to contact).

The programme has expanded over the years to include young participants from 7 – 10 years (second class +)

- The StartBox Bronze programme is currently being rolled out in schools by the NWA Boxing Development Officer. The Silver stage of the programme will commence in St. Joseph's National school, Ballymun from Tuesday 24th October (four programmes)

Cricket in the Community

- The DCSWP Cricket Officer continues to support inclusive programmes and engage with the following NWA primary schools/youth centres via softball cricket introductory sessions.
 - Sunshiny Youth Centre, Finglas. Wednesdays from 5-6pm
 - St. Brigid's GNS, Finglas. Wednesdays from 1-2pm

Football in the Community

➤ **Late Night Leagues**

Late Night leagues form part of the DCSWP/FAI Youth at Risk Programme which aims to mitigate anti-social behaviour by providing social/sporting outlets for young people. In the NWA programmes will recommence in October every Tuesday (males age 10-14 years from 25 October), Wednesdays (females age 10-14 years from 26 October) in various FC clubs in the Finglas area and on Fridays in Trinity Comprehensive, Ballymun (mixed age 12-16 years from 29 September) from 9-11pm. The leagues are delivered in partnership with An Garda Síochána and local Youth Services.

➤ **Girls Future Stars Programme**

The Future Stars programme, Finglas is targeted at young female's age 8-12 years. Its aim is to encourage young females to participate and form pathways to local clubs. The programmes is delivered in partnership with Rivermount FC every Wednesday.

➤ **Futsal In The Yard programme**

This is a six week indoor programme aimed at primary school students age 10-12 years in the Finglas area.

➤ **Football Against Racism**

This intercultural programme is currently being delivered in schools in the NWA to coincide with European Football against Racism Week (commenced 16th October). The initiative focuses on in-class education followed by sessions which give young people practical skills on how to deal with racism.

➤ **Disney Playmakers Programme**

This programme target young females age 4-7 years. The programme is delivered in Ballymun United every Saturday from 10-11am.

➤ **FAI Coaching**

- FAI 9 v 9 Workshops continue aimed at young people age 16+ years. Workshops are delivered every Wednesday from 6pm I Leisure Point, Finglas South
- PDP 1, 7X7 and 9X9 coaching continues in Coláiste Íde and PDP 1 in Trinity Comprehensive, Ballymun.

➤ **Football For All (Disability)**

The National Learning Network Blitz days continue once a month in Clontarf pitches. The citywide programme is aimed at encouraging participation in the sport for adults with additional needs (includes participants from the NWA).

Rowing in the Community

The Get Going Get Rowing indoor rowing schools programme continues in schools across Dublin City.

Rugby in the Community

➤ **School Development**

The Rugby Development Officer continues to focus on the delivery of programmes at on first year level. Eight classes in three NWA schools are currently being delivered on a weekly basis:

- Newcross College, Finglas West
- Beneavin De La Salle College, Ballygall,
- St. Kevin's College, Ballygall

These schools will compete in a first year blitz at the end of October. In late October and into November and December focus will be on reviewing the programme in schools listed above and introducing a new development programme to primary schools in the NWA.

➤ **Inclusion**

Rugby programmes previously rolled out in S. Michaels, Finglas will resume following the mid-term/Halloween break.

➤ **Youth At Risk**

The Monday Night Rugby programme is delivered in partnership with Poppintree Youth Project and will continue until Christmas. Following the programmes' success, plans are currently being put in place to partner with other NWA youth projects and develop links.

➤ **Division 4 Rugby**

In November and December the Rugby Development Officer will revisit I will be getting in contact with all the 1st year groups who are now at second year level to scope out interest in progressing to full contact division 4 rugby. In many cases this will be the first time these schools have entered competitive competition. It is hoped that building these pathways will lead to school representation in the 2023 council cup.

Swimming in the Community

DCC/DCSWP appointed a Co-funded Swimming Ireland Development Officer in 2022 to increase opportunities for everyone in our communities to get involved with swimming and enjoy the benefits of water based physical activities. A new DCSWP Swimming Development Officer was appointed over the summer 2023 period. Details of programmes and initiatives will be included in the next area report.
