M280 Councillor Michael Pidgeon

That this Area Committee supports including St. Alban's Road, Greenville Terrace and Washington Street into the red tariff zone for paid parking. All the streets are currently pay and display in the green tariff zone, and now face high parking demands during events at the National Stadium.

M281 Councillor Vincent Jackson

That Dublin City Council please look at having a public monument erected in the Inchicore / Kilmainham area of Dublin in memory of those from the Area who gave their lives for the cause of freedom in 1936 in the international brigade and who fought against the fascist forces of General Franco in Spain. A large number from the Inchicore / Bulfin area made the ultimate sacrifice here.

M282 Councillor Vincent Jackson

That Dublin City Council please ensure transparent community consultation is provided for as part of the LDA proposals for Affordable, cost rental and social housing in the Cherry Orchard Area for far too long the area has got social housing and have always had to wait for community facilities we must learn from the past and ensure that once and for all we provide the facilities and services needed in this large area.

M283 Councillors Vincent Jackson and Daithí Doolan

That this Committee thanks all the groups in the South Central Area for the fantastic work in providing so many family friendly activities over the Halloween Season, Gardaí, Community Development Staff, Sports Development Officers, Youth Services, Community Groups Parish Groups all provided a great experience for all in a safe, fun way for all.

That this Area Committee welcomes the proposal from Inland Waterways Ireland to establish a slipway at the desired location of the Grand canal adjacent to Dolphin House that will allow access for all to enjoy and add to the proposed amenities that are planned to increase the use of this blue way in our area.

That this Area Committee request that the relevant council departments seek to compel the National Boxing Stadium to produce an agreed traffic management plan to provide parking for their clients which will prioritise consideration for their neighbours and mitigate the ongoing significant influx of visitor traffic in local residential streets.

This Committee expresses concern at the lack of testing for PFAS forever man-made chemicals-in our drinking water. These complex chemical pollutants are of huge concern to human and environmental health and the lack of urgency for testing is worrying. We request that a report be compiled and presented to elected members to inform how best we can mitigate the hazards that these chemicals represent.

For the Director of Services to plan for a full local consultation and community engagement process with all Bluebell residents on the development of DCC land by the LDA. That a public meeting in Bluebell inviting all Bluebell residents is set up. That each resident is delivered a leaflet with a presentation of the plan in each mail box. That an office is set up in Bluebell to display the plans at all time, that the office would be staffed on a regular basis on a set day and time to allow the community to engage with the LDA and DCC on this. It is critical that the planning process is inclusive and participative from the start.

For the Director of Services to organise and meet reps from residents group in Drimnagh about the issue around the roundabout at Galtymore Road and Sperrin Road. To invite Barry McDonald of Dublin Bus and bus drivers unions reps and DCC Road engineer. Buses can't go through the island especially when cars are parks illegally. There is no pedestrian crossing marking. The next bus models will be bigger, this roundabout needs to be reviewed. That an Garda Síochána be present at the meeting on site as well.

M273 Councillor Hazel de Nortúin

To request that DCC acquire one of the unused retail units in Park West (beside the Train Station) for a short period, to establish an information centre for the proposed developments by the Land Development Agency and inclusive of the Local Area Plan which will see thousands of units developed in the area.

The scale of the development proposed will change the face of the area, both physically and socially. Residents and communities would benefit from a visual and informative display of retail and residential units. **Order: Agreed.**

M274 Councillor Hazel de Nortúin

This Area Committee is calling for an immediate response to the level of vacant properties in the D10 area. We agree to call on the CEO and Housing Manager to provide support that will include a budget that will allow for short term solution to returning the voids back into housing stock and a long term support for the Local Area Office that will allow the process of allocation to progress.

The Area Committee notes the closure of a number of venues in recent years, and acknowledges the need for the increased use of all arenas and event spaces in the city, including the National Stadium. To ensure this increased use is managed appropriately and causes as minimum disruption as possible to surrounding residents, this Area Committee calls on Dublin City Council to engage directly with management of the National Stadium, which is a 2,000-seater venue, to seek prior notice of all events taking place at the venue and to put in place tailored parking enforcement plans on surrounding streets to ensure compliance with the Parking Control Bye Laws 2020.

That this Committee demand from the Cherry Orchard implementation board that residents and group reps from the Cherry Orchard response group be added as full members of the implementation board. It is a matter of transparency, democratic debate and decision making, and inclusion.

To ask The Director of Services for a traffic management assessment and recommendations for the length of Kilmainham Lane due to safety concerns.

Based on the assessment of the Transport Advisory Group Area Engineer there is traffic calming on the road due to Kilmainham Lane, D8, being a narrow road with staggered parking. The traffic along Kilmainham Lane is being naturally calmed because motorists have to stop and pull-in to let other motorists pass and this slows down the overall speed of the motorists on the road.

The Transport Advisory Group will assess Kilmainham Lane during the morning and evening peak traffic flows.

There is one heritage column, bracket and lantern that marks the start of Ceannt Fort.

The remaining lamp standards are all standard poles and lights typically supplied by overhead cables from the nearby houses to the poles.

The existing bracket and lantern on the one heritage column can be replaced with a more sympathetic heritage scroll bracket and lantern and arrangements will be made to do this work before the end the year.

However there are no plans to upgrade the remaining lamp standards to heritage columns, brackets and lanterns as the cost to do work is excessive because it would involve opening the ground to lay ducts and cables in addition to supplying the heritage equipment.

The works to Herberton Junction as part of the South Grand Canal Cycleway Improvement scheme have not yet been completed. This is due to the recent Liquidation of the main contractor SIAC Construction. In its final configuration the junction will have bollard protected cycle lanes continuing up to the traffic lights, with cycle lanes continuing on through the junction.

There are currently no plans to install right turn filter lights at this location. It is hoped that the outstanding works will commence in Q4 2023/Q1 2024.

To ask the the Director of Services to outline work to date to find a space to deliver a community sports pitch in the Inchicore area following the decision not to include a pitch in the Emmet Road/St. Michael's project. Reply

Dublin City Council are fully committed to providing a pitch for the community in the Inchicore Area.

A number of locations were identified and assessed however, none were deemed suitable i.e. Turvey Park, Core Youth and Mercy Secondary School.

It has always been the Council's preferred option to locate the replacement playing pitch in the school grounds of Mercy Secondary. In order to achieve this ambition the Area Office have engaged on numerous occasions with the school over the last two years however, the Board of Management met and finally decided not to proceed with the project.

Dublin City Council are willing to work closely with the local community and local Councillors to deliver the pitch and would welcome any suggestions for potential locations.

To ask the the Director of Services to urgently investigate the installation of traffic calming measures on Rialto Street, which owing to the new one-way system on St. James's Walk, will now see an intensification of traffic activity. A car has already overturned on its side following a speeding incident in recent days.

Reply

There is traffic calming measures already provided on Rialto Street, D8; it is within a 30kph Slow Zone, there are 4 speed ramps on the road including a raised table at the junction of Rialto Street with South Circular Road, it has a 3.5 tonne limit and Pay & Display and Permit parking on both sides of the road.

The Transport Advisory Group will assess Rialto Street and recommend a speed survey be conducted.

In the July Director of Services Report, it stated: *Painting of Complex: Painting crew back onsite and they will complete the painting of all the railings and also have the hoist onsite to paint the balcony walls. – No change on this – still on schedule.* When pressed on what this "still on schedule" meant, I was told later in writing: *The painters are back on site in Dolphin House,* during the period of bad weather they were doing indoor work only, I don't have a date of completion. Now in October, I'm informed by local residents that they haven't seen the painters apart from two weeks during the summer. Can you confirm when, or at this stage, if painting of the complex will be completed in 2023? This is just the latest example of basic asks being half-done or not responded to at all.

Reply

The painting crew will be back onsite in the middle of this week (week commencing 16th October). Priority jobs previously disrupted the ongoing works.

The stairwells in the older blocks have now been completed. The railings are due to be painted initially and then painting will commence in the newly built apartments commencing with Block A.

Public consultation for the playground construction in Chapelizod will commence End '23/Early '24. This will inform works which will involve running a tender competition to appoint a contractor and subsequent construction on site. Playground would be anticipated to be completed by end 2024.

Tenant Insitu Scheme has already been explored, however it has not been approved as the applicants need is for 1 bedroom and their current tenancy is a 3 bedroom. We are unable to buy the current tenancy and then rehouse them when they reach their position on the list as they would not be eligible for a Transfer for 2 years when they sign for a Transfer. Also, there would be no legal obligation for them to leave the tenancy when reached on the list and could stay in 3 bedroom tenancy when only need a 1 bed.

The applicants may be eligible for HAP which will provide them with financial assistance towards the cost of renting another property. Should the applicants wish to apply for the HAP scheme, they should make contact with the Allocations Section with current income details where a Housing Advisor can provide information and advice on the scheme. It is noted on the applicants file that they were previously issued a HAP pack in April 2023. If the applicants should be unsuccessful in sourcing another private rented tenancy in the next three months and are within 28 days of the notice of termination, they can present to Parkgate Hall where they can be assessed for the homeless HAP payment.

It may benefit the applicant to increase their areas of choice as it may increase their chance of being housed in a shorter timeframe. Housing Advisors are available (Monday – Friday 2pm - 5pm) to discuss options with the applicants should they wish to amend their application to include additional areas of choice.

Dublin City Council allocates properties based on time on the list and currently there are applicants on the waiting list of longer standing who have to be considered as suitable vacancies arise. It is not possible to indicate accurately the prospect of an offer for any applicant. The number of vacancies arising will be a determining factor in the length of time applicants could expect to be on the waiting list.



The Ballyfermot area is included in the Liffey Valley to City Centre scheme which is currently with An Bord Pleanála for a decision. If granted planning permission by An Bord Pleanála, it would introduce continuous bus priority, segregated cycling

facilities, and improved pedestrian crossing facilities. Details of the scheme can be found at <u>https://liffeyvalleyscheme.ie/</u>

As part of the Environmental Impact Assessment Report (EIAR) a traffic and transport report has been prepared. The report predicts that there will be a reduction of 53% in the number of people travelling by car, an increase of 58% in people travelling by bus, and an increase of 45% in people walking and cycling.

REPORT TO THE SOUTH CENTRAL AREA COMMITTEE MEETING: 15TH NOVEMBER 2023

- Proposal: LAW: Planning and Development Act 2000 (as amended) Planning and Development Regulations 2001 (as amended) Part VIII
- Applicant: Dublin City Council, South Central Area Office
- Location: Meath Street, Dublin 8
- **Proposal:** Proposal to undertake public realm improvements to Meath Street and its immediate environs. The plan provides for changes to the public realm including footpaths, kerbs, carriageway, street furniture and fixtures, street lighting and the allocation of parking and loading bays along the street. The plan also provides for the addition of street trees, landscaping and public seating.

Meath Street is located within the Thomas Street & Environs Architectural Conservation Area. The proposed works are adjacent to protected structures on Meath Street.

Plan Ref no: LAW 4301/23

The proposed Part 8 development was presented to the South Central Area Committee on 21st June 2023. The proposals were put on public display from 15th August to 12th September 2023. The plan and particulars of the scheme were available for inspection on Citizen Space, the City Council's online consultation portal and at the Civic Offices, Wood Quays and South Central Area Office public counters. The closing date for submissions and observation was 25th September 2023.

It is the intention of the South Central Area Office to present this Part 8 to the City Council at its meeting on 4th December 2023. **The approval of a Part 8 is a reserved function of the City Council.**

OBSERVATIONS

229 observations have been received for this Part 8 Application. The largest proportion of observations were supportive of the scheme, a proportion were neutral (perhaps generally supportive but with reservations or particular areas of concern), and a small number were not supportive. The issues raised can be summarized as follows:

Street Design

- General welcome for the refurbishment of the street
- Welcome repaving, extension of footpaths, refurbishment of carriageway
- Support for use of continuous footpaths/ raised table crossings at junctions

- Requests to amend location of parking spaces
- Requests to amend location of loading bays
- Provision for funerals at St Catherine's Church (hearse, mourning coach, visitor parking etc)
- Provision of benches/seating/ concern at the antisocial potential of benches/seating
- Provision of accessible parking/ provision for less able bodied users
- Access to adjoining streets
- Queries regarding compliance with DMURS/ design details
- Queries regarding the two-lane, right and left turn junction with Thomas Street

Street Culture and Perceived Gentrification

- Concerns at the changing nature of business on the street
- Support for additional café culture/ resistance to growth of café culture on street
- Concerns regarding specific uses
- Welcome the reinvigoration/ renewal of the street
- Welcome the provision for market stalls and moves to formalise on-street trading
- Request to respect the essential character/heritage of the street 'the heart of the Liberties'
- Street should 'move with the times'
- Support for independently owned retail/businesses on the street
- Comments regarding the extent of consultation on the plans, engagement with local residents and businesses

Bins and Waste Collection

- Requests for additional bins to be installed on Meath Street
- Suggestions to install undergrounded bin chambers on Meath Street
- Request to discontinue or reform bag service
- Request to install large recycling bins close to Meath Street

Trees and Green Infrastructure

- General support for the addition of trees on the street
- Suggestions on tree species
- Request for water filling station
- Request for EV charging
- Request for SUDs measures, rainwater planters

Parking Matters

- Concerns at the reduction in car parking provision
- Welcome the reduction in car parking and greater focus on pedestrians
- Concerns of impact on parking on adjoining streets perceived distance to Thomas Street Car Park
- Queries regarding time limited pay parking

Pedestrianisation

- Requests to pedestrianize the street
- Suggested alternative routes for traffic
- Calls for partial pedestrianisation/ open street events

In addition, a submission was received from the Dept. Housing, Local Government and Heritage largely relating to the retention of heritage paving and the suggested reinstatement of traditional paving features such as fanned corners.

CONSULTATION

Non-statutory consultations were held early in the preliminary design process to obtain views of the public on proposed realm improvements to Meath Street and its immediate environs. Consultations with local residents and businesses were undertaken in October 2018 and early 2019. These events which highlighted the issues and aspirations of the community for Meath Street and which helped to shape the initial concept design, prepared in June 2019.

Work commenced in 2020 to develop a preliminary design based on the initial concept. Community engagement sessions were held in April 2021 to present the preliminary design and gain feedback. A draft design was also placed on display on Meath Street at this time. A number of adjustments to the design were made following comments raised during these meetings.

As part of the design process extensive engagement was undertaken with technical departments and other stakeholders within Dublin City Council to ensure that the proposal is fully consistent with current plans and policies of the City Council as well as national guidance and standards.

The proposal were also advised to various Disabled Persons Organisations (DPOs) for their comment.

CONSIDERATION BY THE PLANNING AUTHORITY

Rationale for the Proposed Development

The vision for the scheme is to provide for the renewal of the public realm of Meath Street in The Liberties. The supporting statement which details the various elements of the proposed public realm improvement scheme, also includes several detailed historical and environmental appraisals which were carried out to inform the final proposals.

Historically, the evolution of Meath Street saw it thrive as a commercial hub for many decades up until the 20th century. However, Meath Street has seen retailing decline over the last 20 years, it is understood that this is due to a combination of several factors, including competition from larger scale retailers and general changes in shopping habits. This has resulted in the proliferation of empty commercial premises and underused buildings along the street, as well as a steady reduction in more traditional pavement trading and in clothes and grocery sales. Although a number of new uses have emerged such as small offices, unfortunately these activities have limited street presence, however, the presence of cafes have the potential of re animating the street scene.

A detailed evaluation of the existing physical public realm of Meath Street highlighted the dominance of car parking along the streets with a consequential diminished pedestrian space and a poor visual environment. The pedestrian realm at present is characterised by the following:

- Less than optimal pavement widths;
- Lack of seating and places to enjoy sitting;
- Lack of visual coherence in details;
- Poor quality surface materials;

• Lack of greenery;

Surveys were conducted to assess both the existing number of car parking spaces and parking needs. Total car parking on Meath Street at present equates to 41 spaces. Additional parking was observed at weekends but was not fully utilised. There is provision for 40 bike parking spaces at present.

Assessment

Compliance with Planning Policies and Objectives

The Design Manual for Urban Roads and Streets 2013 aims to encourage more sustainable travel patterns and safer streets, designers must place pedestrians at the top of the user hierarchy, enhance pedestrian realm and provide easy crossing points at key junctions of the emerging route network.

The Dublin City Development Plan contains a number of policies of relevance. In accordance with the National Transport Authority strategy, a hierarchy of transport users is supported, with pedestrians, cyclists and public transport users at the top of this hierarchy, having their needs considered first in the planning of transport provision.

Section 8.5.7: Car Parking (ch8) of the City Development Plan, recognises the need to further control and manage on-street parking across the city to safeguard and enhance city living for people. In these terms, Policy SMT25 seeks to manage on-street car parking to serve the needs of the city alongside the needs of residents, visitors, businesses, kerbside activity and accessible parking requirements. Similarly, Policy SMT26: 'Commuter, Shopping, Business and Leisure Parking' seeks to discourage commuter parking and to ensure adequate but not excessive parking provision for short-term shopping, business and leisure uses.

Having regard to the above, the Planning Authority considers that the proposal accord the City Development Plan as it would reduce the amount of on- street parking along Meath Street and discourage all-day parking so that drop-off and pop-in shopping parking are facilitated. In comparison to the existing arrangements along Meath Street, the Planning Authority considers that the proposal represents a better balance in terms of parking provision and the needs of other street users and prioritise street space for pedestrians. The submitted Supporting Statement details how the scheme aligns with DMURS, where possible, and notes supporting reports completed such as vehicular tracking and Road Safety Audit.

Policy SMT8 of the City Development Plan supports public realm enhancements that contribute to place making and liveability and which prioritise pedestrians in accordance with Dublin City Council's Public Realm Strategy ('Your City – Your Space'). Meath Street also forms part of SDRA 15 – Liberties and Newmarket Square, and the Planning Authority noted that Public Realm improvement is a key objective for Meath Street. Many of the SDRA's guiding design principles have been incorporated into proposed public realm improvements.

The Planning Authority therefore considers that the proposal delivers an appropriate design response as follows:

- Improves access and permeability through the provision of a quality, accessible public realm with improved walking and cycling infrastructure.
- The layout has been designed to accord with the principles of DMURS.
- Urban Greening and Biodiversity: through the integration of greening and biodiversity measures via the introduction of micro greening measures including tree planting.

- Reduces the dominance of car parking and the resultant poor visual environment, particularly at the northern end of Meath Street, which would aid in enticing pedestrians from the adjoining Thomas Street.
- Create opportunities for future event markets and other street uses. Discrete electrical service points are proposed to serve potential clusters of temporary stalls that would retain and enhance the distinctive commercial character of Meath Street which has historically, evolved as a commercial hub, with the Liberty Market being a focus of activity both within the buildings and spilling out onto the street as it does at present.

Overall the Planning Authority considers that the proposed public realm improvement scheme accords with the policies of the Dublin City Development Plan 2022-2028 through the provision of a safe and comfortable street environment which protects and enhances the individual character of Meath Street.

The Planning Authority considers that the public realm improvements on Meath Street is part of a wider policy context for street improvements in the city. The proposal has been developed in accordance with detailed consultation with the Council's internal Departments, the general public, and the policies in the relevant statutory plans and guidance documents.

The proposed scheme will result in substantial improvements to the existing public realm and will enhance the pedestrian users' experiences of Meath Street and the surrounding junctions.

The proposed development is considered to be in accordance with the proper planning and development of the area and is in accordance with the relevant planning policies and objectives and national guidelines.

RECOMMENDATION OF THE PLANNING AUTHORITY

The Planning Authority considers the proposed development to be consistent with the provisions of the Dublin City Development Plan 2022 -2028 and in accordance with the proper planning and sustainable development of the area. It is recommended that the Elected Members approve the proposed development and that the proposing Department should have regard to a number of standard conditions.

CONCLUSION

The Area Office recognises that the Planning Authority considers that the proposed development to be consistent with the provisions of the Dublin City Development Plan 2022 - 2028 and in accordance with the proper planning and sustainable development of the area. The proposal has been developed in accordance with detailed consultation with the Council's internal Departments and with the general public. Accordingly, it is the Area Office's intention to bring this Part 8 to the City Council for approval.

Halloween 2023 Public Domain Report South West Inner City

CONTEXT

This is the Public Domain Report for Halloween 2023. The reports outlines the Area Office's reactive programme and complements our proactive and very substantial community engagement programmes focused in the inner city and in Kilmainham / Inchicore.

APPROACH

The South West Inner City launched the Halloween 2023 campaign in October. Meetings with all relevant stakeholders were conducted from September 2023 both at area and at corporate level. It was agreed from the outset that a multidisciplinary approach delivering a co-ordinated plan to (a) reduce the harm caused by Bonfires to the environment and (b) facilitate alternative activities for young and old to participate in.

DELIVERY & COLLABORATION

Intelligence lead operations and tracking the movement of bonfire materials yielded excellent results. Persistent removal of identified stockpiles ensured D8 was largely free of any bonfire damage. Waste Enforcement conducted inspections of sites identified by Public Domain and attended an unsecured industrial estate where 200 tyres were removed from the area over the Bank Holiday weekend.

The Gardaí played a pivotal role in stopping the movement of pallets and tyres on streets and at various sites across the city notably: James St, environs of Vincent Street West and Dolphins Barn/Rialto. The Garda helicopter aerially reviewed a number of locations identified by the SWIC Halloween Campaign Team on Sunday 29th October. A contractor truck was made available to Kevin St Garda Station nightly from October 25th to October 30th halting the movement of pallets and tyres locally.

There was great cooperation and resource sharing between South East and South Central in Dublin 8 and as a result there was only one small bonfire which took place in School St Flats.

The main tranche of the 2023 Halloween Campaign began Friday 27th October. Five teams comprising of Housing and Public Domain staff operating in pairs worked across the entire LEA from 27th to 31st October to identify & track bonfire material movement. The campaign concluded on 31st October 4pm.

The Clean-up operation began on November 1st Waste Management and Parks have responded very quickly to remove bonfire residues and stockpiling remnants from Green Spaces and adjacent roads and footpaths.

All bonfires in flat complexes in the city area very small. There were two very small fires along perimeter St Michael's Estate lands and a small fire in Basin St and Oliver Bond Flats.

Exchange of title for lands at junction of James's Walk and Forbes Lane, Dublin 8.

Dublin City Council has been in occupation of the area coloured blue on Map Index No. SM-2023-0506, at the Forbes Lane Depot, Dublin 8, since the 1970s. Eircom Ltd hold the title to this area coloured blue.

Eircom Ltd are in occupation of the adjoining premises and Dublin City Council hold the title to this area outlined red on Map Index No SM-2023-0506.

Agreement has been reached for an exchange of title with Eircom Limited, subject to the following terms and conditions which the Chief Valuer considers fair and reasonable:

- 1. That Eircom Limited shall transfer the Fee Farm Grant interest dated 16 December 1865 and the 300 year leasehold interest from 1 January 1938, in the plot shown coloured blue on attached copy map SM-2023-0506, comprising an area of approximately 1,166 sq.m or thereabouts to Dublin City Council.
- 2. That Dublin City Council shall transfer the Fee Farm Grant interest dated 12 January 1866 in the plot shown coloured pink on attached map SM-2023-0506 which is located within the telephone exchange site and comprises an area of approximately 331 sq.m. or thereabouts.
- 3. That the Council shall pay Eircom Limited a consideration of €10,000 (ten thousand euro) plus VAT (currently 13.5%) in settlement of the exchange.
- 4. That both parties shall clear any outstanding charges, rent or taxes (if any) on the relevant plots prior to the completion of this transaction.
- 5. That each party shall pay their own fees in this matter.
- 6. That the above proposed exchange is subject to each party producing satisfactory proof of title to the areas mentioned above.
- 7. No agreement enforceable at law is created or intended to be created until exchange of contracts has taken place
