Q1 Councillor Darragh Moriarty

To ask the Director of Services for the Council to provide a detailed breakdown in tabular form of the timelines, milestones and expected completion dates of those milestones with respect to the refurbishment of Donore Avenue Community Centre, Dublin 8. Numerous incomplete updates have been given to Councillors, none of which clearly state **when** DCC expects to have the centre open and in operation for community use.

Reply

As outlined previously it is as yet not possible to provide an accurate date for the reopening of Donore Community Centre. DCC have been working with the Design Team led by Cotter & Naessens Architects to ensure delivery of the project within the earliest timeframe, within the context of a significantly complex reinstatement project. All surveys, stabilisation works and weather proofing of the building have now been completed and the design team will be in a position to provide a greater level of detail of the scope of works required and also consequently the duration of these works. This information will be available by the end of February.

The next stage will include the development and completion of a tender package between March and May, following which tenders will be issued to the market in June. It is anticipated that a contract will be awarded in August. As highlighted above the duration of the works will only become clear once the scope has been established. The reinstatement of Donore Community Centre is of the highest priority to DCC and we will continue with any and all efforts to progress with the implementation of the programme with the greatest efficiency.

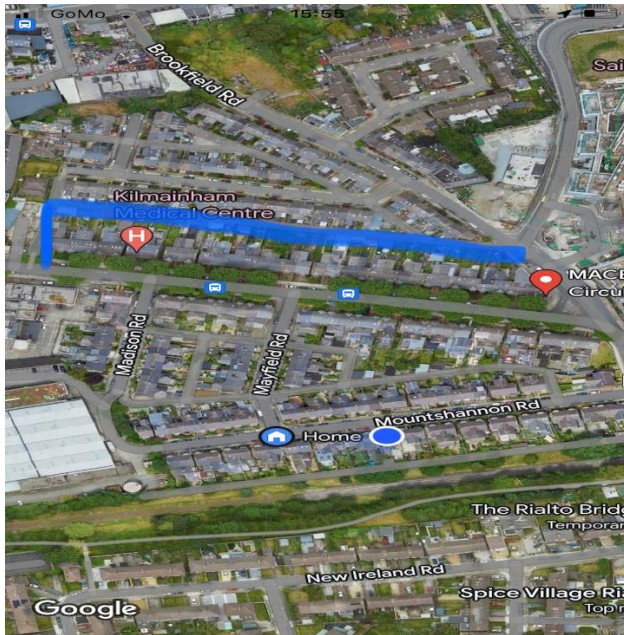

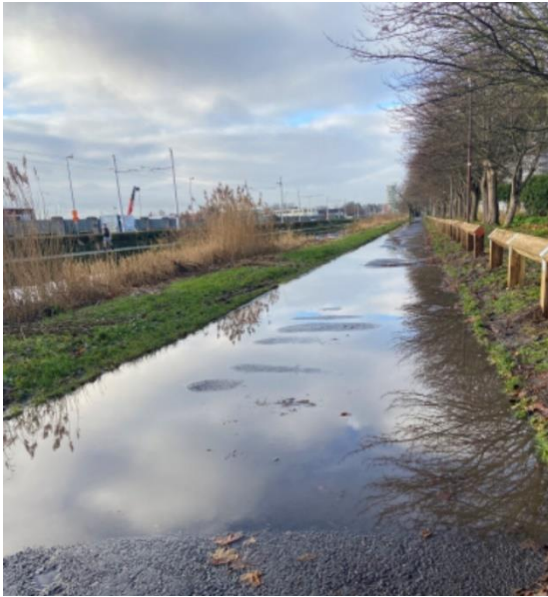

Reply

Representatives of the South Central Area Office, the Flood Defence Projects Office, Waterways Ireland and Roads Maintenance met on site regarding a previous flooding problem; on 13th May 2022. The problem appeared to be drainage pipes from this area owned by Waterways Ireland were blocked mainly with leaves, soil and other debris. These were subsequently cleared by Waterways Ireland which seemed to solve the problem at the time. If Waterways Ireland agreed to let Dublin City Council clear these pipes and remove the debris off-site this might solve the problem on a more regular basis.

This is the only drainage system in the area. There are a number of high voltage ESB cables and trees in the area which would make any new drainage system to the Camac river very costly, probably a significant six figure sum. Putting a higher surface on the canal walk would also cost a six figure sum.

Dublin City Council will engage with Waterways Ireland to try reach a resolution on the appropriate maintenance plan for the area.

This existing signage incorrectly labels 1-14 Lansdowne Valley Crescent as 1-14 Kilworth Road. Further down the road are the properties which are actually 1-14 Kilworth Road.

Lansdowne Valley Crescent is a development located on Kilworth Road and Cooley Road and these are the names of those two roads. Lansdowne Valley Crescent is actually a development and not a road. The signage associated with this development would be the responsibility of the management company for the development Lansdowne Valley Crescent. Since we have the nameplate manufactured and being fitted with a stand we will mount it at the Davitt road side of the development but I will maintain the Kilworth Road nameplates as is, as their positions are correct.

Dublin City Council collaborated extensively with the Sons of Divine Providence and the Department of Housing, Local Government and Heritage to agree a pathway that allowed the project progress. Substantial progress was made on identifying and resolving issues with a number of Council Departments involved at various stages. A development agreement will include Title Exchange and allow the project advance to stage 2.

The identified proposal is a 176 unit development in three blocks. The proposal allows for one block of 60 sheltered units to be owned and managed by the Sons of Divine Providence (an AHB) with Dublin City Council operating intergenerational social housing from the other two blocks. Dublin City Council would retain nomination rights for all 176 dwellings in this proposal.

In December 2023, a new Housing Delivery Project Manager was appointed to oversee this project. Their evaluation of project files has been initiated and recommenced in earnest following the Christmas break. A meeting of the Sarsfield Working Group is expected to be convened in the first quarter of 2024.

CS04	Programme for the Preparation of Local Area Plans/Village Improvement Plans To implement a programme for the preparation of Local Area Plans/Village Improvement Plans and to prioritise areas in accordance with the strategic objectives of the core strategy including those areas which are experiencing or likely to experience large scale development and regeneration.

Also, table 2-15 related to objective CS05 below references Crumlin – Kimmage in the category of Local Environmental Improvement Plans.

It is an Objective of Dublin City Council:	
CS05	Programme for the Preparation of Local Environmental Improvement Plans To implement a programme for the preparation of Local Environmental Improvement Plans and to prioritise areas in accordance with the strategic objectives of the core strategy.

Crumlin and Drimnagh are served by an existing Quality Bus Corridor along Drimnagh/Crumlin Road which is proposed to be upgraded to a Bus Connects route (Tallaght Clondalkin to City Centre), an application for which has been lodged with An Bord Pleanála. This will provide an improved environment for cyclists as well as bus priority and additional pedestrian crossings. The area is also served by the red Luas line.

Reply

Thank you for your query relating to the Energy Efficiency Retrofit Programme. Due to the volume of properties involved, which is 12,000 houses approximately, it is a roll out programme and areas/estates must be targeted in their entirety from both an operational and magnitude/economies of scale perspective. The programme has proved hugely successful to date and will run for a number of years, subject to continued Departmental funding support, until it reaches its conclusion. Consequently, it is not feasible to target individual properties in any area/estate citywide. We endeavour to spread the works across all areas in an equal and fair manner where possible. We are not currently working in this area, however, I can confirm that this area is on our list for survey and inclusion, if eligible, when works commence in this area in the future.

Unfortunately it is not possible under this programme to insulate the attic only as requested. The Department of Housing, Local Government and Heritage Energy Efficiency Retrofit Programme does not permit single measures such as attics only to be installed, all measures on a property must be actioned in one installation under the programme rules issued from the Dept.

We have no record of any issue with the door, but we will log this now for the tenant and any necessary works will be carried out.
