No. 182/1997 - Road Traffic (Traffic and Parking) Regulations, 1997, section 36 Prohibitions on Parking (2) a vehicle shall not be parked – (g) in any place, position or manner that will result in the vehicle obstructing an entrance or an exit for vehicles to or from a premises, save with the consent of the occupier of such premises;

(k) In a manner in which it will interfere with the normal flow of traffic or which obstructs or endangers other traffic;

To ask the Manager to confirm if the right turn filter light from Glasanaon Road to Ballygall Road West is working and why it is not always used in the traffic light sequence.

Reply

The right turn filter light from Glasanaon Road to Ballygall Road West is working, but only runs when certain criteria are met.

All day running of this right turn filter signal was previously trialled. This caused extra traffic delays along Seamus Ennis Road which resulted in increased bus journey times through the junction, delaying hundreds of bus passengers. Dublin Bus submitted complaints of these delays, and the data from the traffic signal Bus Priority system also highlighted increased bus journey times. At this time, the Bus Priority team are not in favour of making the change to all day running of the filter light.

The SCATS traffic management system, which operates these traffic signals, now automatically activates the right turn filter signal only when real time data indicates high levels of congestion on Glasanaon Road and when it will not impact on public transport journey times. It also runs when bus priority measures are activated for buses waiting on Glasanaon Road.

As Dublin City Council prioritises sustainable transportation in the city, all efforts are made to reduce public transport delays. We will continue to monitor the operation of the signals and makes amendments as required where there is scope to do so.

- 6 Group Housing Sites (Avila, Northern Close, Kylemore Grove, Bridgeview, St Marys Park & Grove Lane Houses only);
- 2 Mixed Developments (Cara Park & Labre Park Houses & Bays); and
- 4 Unauthorised Sites (Wards Field, Area A Belcamp, Tara Lawns & St Dominic's

The following sites are in the Ballymun and Finglas area with work outlined under each site:

- St Margaret's Redevelopment New consultation underway. Assessment of site layout to be completed by Architects and Engineers. TAU Architects are working on draft designs to include a mix of modular homes and upgraded Bays with extended Day Houses.
- St Joseph's Park Re-allocation of 4 abandoned Bay's in process.
 Allocations of 3 Bays are fully complete with the final allocation currently in process.
- Avila Park 3 House Build Engineer has been appointed to complete design proposal. Consultant QS are putting together costings for Department submission.
- St Marys Park Temporary Bays to be installed on site to help alleviate overcrowding. Consultant QS has completed new costings and funding application is being drafted for submission to the Department

The following report has been received from the National Transport Authority.

The "E-spine" changes in the north-west area include routes E1, E2 and 19.

Routes E1 and E2 will each run every eight minutes at most times, from Northwood (E1) or IKEA (E2) via Ballymun and Phibsborough to the city centre, then continuing to UCD and either Ballywaltrim (E1) or Dun Laoghaire (E2).

Route 19 will run between the Airport and Parnell Square via IKEA, Ballymun and Drumcondra, every 20 minutes at most times.

It is intended to introduce these changes during 2024, subject to reviews of operational readiness and the level of funding available.

These changes follow on from the introduction of new orbital routes N4 and N6 during 2022. A further orbital service, route N2, will be introduced at the same time as the "E-spine". It will run between Heuston Station and Clontarf Road Station via Broombridge and Griffith Avenue.

The Authority closely monitors the reliability and capacity of all service changes following introduction.

Can a yellow box be considered or any other measures to allow easier entry and exit.

Reply

It is not recommended to install a yellow box at the location. Yellow boxes are intended to prevent blocking of road junctions. Side road traffic flows should be

significant and the side road should serve a minimum of fifty houses or a major traffic generating facility.

These guideline are in place to avoid a proliferation of yellow boxes in the city which have substantial maintenance costs associated with their implementation.

The proximity of the pedestrian traffic lights near the details supplied junction would leave inadequate space for a vehicle to stop at the lights. This would cause a health and safety issue due to drivers speeding up to avoid stopping on the yellow box. Due to the particular position of the house there is very little the Area Engineer can do in this regard.

With reference to the proposed disposal of the Council's freehold interest in the property known as Site at Seamus Ennis Road, Finglas, Dublin 11.


Under indenture of lease dated the 2nd March 1978 Dublin City Council demised a site at Seamus Ennis Road shown outlined in red on map index SM -2023-0316 to Finglas Credit Union Limited for a term of 99 years from the 29th September 1971 for an annual rent of £291.50. The current passing rent is €21,000 per annum. The lessee has applied to Dublin City Council to acquire the Council's fee simple interest in the property.

The Law Department has confirmed that as there are rent reviews as part of the lease, the lessee is not entitled to acquire the Council's title in this property in accordance with Section 16 of the Landlord and Tenant (Ground Rents) Act 1978. The Senior Executive Officer for the Department has agreed to dispose of the fee simple on a non-entitlement basis.

Accordingly, it is proposed to dispose of the Council's freehold interest in the property known as Site at Seamus Ennis Road, Finglas, Dublin 11 to Finglas Credit Union Limited, subject to the following terms and conditions:

- 1. That Dublin City Council holds the Fee Simple Interest in the property known as Site at Seamus Ennis Road, Finglas, Dublin 11 as outlined in red in attached copy map Index No. SM-2023-036 for identification purposes.
- 2. That the property is held under Indenture of Lease dated 2nd March 1978 for a term of 99 years effective from 29th September 1971, and that Finglas Credit Union Limited is the current lessee of this interest.
- 3. That the disposal price of the Freehold Interest shall be in the amount of €300,000 (three hundred thousand euro) plus VAT if applicable.
- 4. That the Applicant shall be prepared to pay all rent, rates and charges outstanding up to and including the date of sale.
- 5. That the Applicant shall pay the Dublin City Council's Valuers fee of €2,250 (two thousand two hundred and fifty euro) plus VAT and plus the Council's legal fees plus VAT
- 6. .That this proposal is subject to the necessary approvals and consents being obtained.

1. Local Area Plan Update

Turnpike, Santry Cross

We are continuing to advertise these units and facilitate site visits. It is listed on Daft and enquiries can be made to liam.barry@dublincity.ie there were 2 viewings during December. For further information: Commercial property for rent in The Turnpike, Santry Cross, Ballymun, Dublin 9 (daft.ie)

Shop-front Improvement Scheme

5 grants totalling €15,000 were approved in 2023 from businesses in the Ballymun and Finglas area. Three of these business have drawn down their grant as well as one carried over from 2022. There is a balance of €6k to be drawn down in 2024 from grant approved in 2024. The Shop-front Improvement Scheme will be rolled out again in 2024 if local DCC funding can be identified to support the initiative. Promotional material and information will be prepared once funding is secured.

Site 14 (part of site) Proposed City Farm Project

Following on from the update provided in the June 2023, North West Area Committee report. The City Farm Committee engaged a specialised consultant to work with the City Farm Committee to review the current proposed Ballymun City Farm Business Plan and to make recommendations on areas that the City Farm need to address in order to develop a robust viable Business Plan for submission to the City Council. As agreed Dublin City Council contributed €12, 950 towards the cost of completing the works.

Dublin City Council outlined their requirements and timelines to the City Farm Committee in writing on the 20th March 2023 and again on 27th July with slightly amended timelines as the process to engage a Consultant had taken longer than anticipated.

While the timelines set by Dublin City Council were not met, on the 18th December 2023 we received a Ballymun City Farm, 2023 Business Plan Review, prepared by SLR Consulting Limited, in association with Nevin Associates and Haller Clarke. The document was circulated to all the relevant DCC officials along with a request to ascertain suitable meeting dates in January. Further information re meeting date and a copy of the document to following once meeting date confirmed.

2. Ballymun Social Regeneration Fund 2024

A sum of €1,700,000 is allocated to the Ballymun Social Regeneration Fund for 2024. This funding is to continue to support the process of social regeneration in the area. The social regeneration objectives for Ballymun are set out in Sustaining Regeneration – A Social Plan for Ballymun. Applications for the 2024 fund closed on December 15th 2023. 22 applications in total were received. The total amount of funding applied for was €2,270,719, which is €570,719 over the allocated budget of €1.7m.

The Assessment Panel are meeting on several dates in January 2024 to consider each application/programme proposed under this fund to ensure that the criteria as stipulated was met, all supporting documentation was in order and the service provision outlined in the work plans is in line with the objectives as set out in Sustaining Regeneration – A Social Plan for Ballymun.

All applicants will be notified of the outcome by Friday 26th January, funding for successful groups will commence on February 1st 2024. A further detailed report on the allocations of funds will be presented to the February or March Area Committee meeting.

3. Community and Social Development Update

General Community Development

The Community and Social Development Team are currently completing reviews of 2023 projects and are working on the 2024 Ballymun Community plan. The team have met with the Finglas Community Team and are currently organising meetings with Axis Ballymun and various groups in relation to collaborative ideas for 2024.

The Community and Social Development and Adult Education Grants for 2023 are currently being processed and will be issued to groups early this year.

Marewood Christmas Event

The Ballymun Community & Social Development Team collaborated with the Sillogue Neighbourhood Centre to host a Community Christmas Event for local senior citizens, local groups and the Poppintree Walking Group. This took place in Marewood Court Community Room on Thursday 14th December 2023 and there was a great turnout. Everyone enjoyed a lovely afternoon of music, dancing and festivities.



Intergenerational Christmas Afternoon Team

The Community Team held an Intergenerational Christmas Event in the Ballymun Civic Offices on Wednesday 6th December. We linked in with Trinity Community Care to invite some of their clients to come along. Afternoon tea was served and there were lots of Christmas songs and dancing. Local groups, students from Trinity Comprehensive and young people from BRYR attended to enjoy a lovely afternoon of music and dancing.



Sensory Christmas Event

Following on from the success of our Halloween Sensory Sessions the Community & Social Development in collaborated with Axis Ballymun on a Christmas Sensory Friendly Experience for children with additional needs and sensory sensitivities. This took place on Tuesday 19th December in the Axis Theatre and it was a great success enjoyed by all the children and their families.





Introduction Pickleball Programme

In conjunction with Pickleball Ireland, a 6 week introduction beginner's programme is commencing on Friday January 12th at Poppintree Sports & Community Centre from 12-2pm. A successful taster session took place in October as part of positive ageing week, so there is definitely interest in this new initiative. Pickleball is a hybrid game incorporating elements of tennis, table tennis & squash, it is very popular with older adults & people with impaired mobility.

Disposal of Site 1, Parkview, Parkview Road, Ballymun, Dublin 11 to Ó Cualann

Cohousing Alliance CLG.

Housing and Community Services has requested the disposal of Site 1, Parkview, Parkview Road, Ballymun, Dublin 11, as shown delineated in red on Map Index No. SM-2023-0300, to Ó Cualann Cohousing Alliance CLG, an approved housing body and registered charity, who propose to develop the site. A previous planning permission was granted under Reg. Ref. 1582/05 for 266 units and a crèche but this development was not completed.

The Ballymun LAP, which was adopted by the Elected Members in 2017 and extended in 2022 until 2027, identified residential and potential crèche uses at the Parkview site, the Elected Members will be aware of the need for additional crèche facilities in Ballymun and the proposed crèche would help meet this need. The community crèche model would see the operator identify statutory funding to address issues such as affordability and assisted learning. This would allow a mix of fee-paying and supported families accessing its services.

Ó Cualann Cohousing Alliance CLG is funding this development through construction finance debt to Ó Cualann Cohousing Alliance CLG from either Home Building Finance Ireland (HBFI) or Allied Irish Banks (AIB).

The property comprises an area of approximately 1.26 hectares and is shown delineated in red on Map Index No. SM-2023-0300.

The Chief Valuer has reported that agreement has been reached with Ó Cualann Cohousing Alliance CLG to dispose of the City Council's freehold interest in Site 1, Parkview, Parkview Road, Ballymun, Dublin 11 for the development of Affordable Houses and a Community Crèche subject to the following terms and conditions:

- 1. That the subject site is located at Parkview, Parkview Road, Ballymun, Dublin 11 and it is shown outlined in red on attached map SM-2023-0300. The site extends to approximately 1.26 hectares or thereabouts.
- Planning permission (ref 5252/22) for the development of a community crèche and 34 affordable houses granted by the Council on 24th July 2023 was appealed to An Bord Pleanála and this disposal is subject to the decision of the Bord case ref PL29N.317818.
- That the Council shall dispose of the Freehold title in the subject site under the terms of the Low Cost Sites Scheme, to the purchaser, following the receipt of the requisite approvals.


- 4. That the disposal price shall be €127 (one hundred and twenty seven euro) per residential site and crèche unit i.e. 35 units in total. In the event whereby planning permission is subsequently granted for more units on the site, the disposal price shall be adjusted on a pro-rata basis to reflect this.
- 5. That the site shall be disposed of in its current condition and title transfer shall be subject to a building covenant that the affordable houses and crèche development, on the subject site shall be completed in compliance with planning permissions granted and all other statutory approvals and consents including, inter alia, fire regulations, buildings regulations etc.
- 6. That should the construction of the affordable housing units and crèche, on the subject site not be practically complete within 22 months following the transfer of title, or, in the event of the purchaser's bankruptcy or insolvency, Dublin City Council reserves the right to take possession of the site and all of the housing units and crèche, (partially completed or otherwise), at no cost to the Council, save in the case of a financial institution which has entered into a mortgage with the purchaser for the purpose of financing the development of the site.
- 7. That the development of the site will be subject to an Affordable Housing Fund Application to be submitted by Dublin City Council.
- 8. That the benefit of the planning permissions and design of the scheme shall transfer to Dublin City Council free of charge in the event that the purchaser does not proceed or complete the development.
- 9. That prior to the transfer of title if necessary, the purchaser and its contractor and professional team shall be permitted to enter onto the site and connect to any drainage or other services as required, subject to the prior written consent of the relevant Dublin City Council Department, under a Building Licence agreement, on standard terms to be agreed, for the purposes of commencing the approved development.
- 10. That the purchaser shall be responsible for all costs in relation to the planning process and the development of the site as approved, including any relocation of services and boundary works.
- 11. That the development of the site shall be completed via one continuous building contract, with all infrastructural elements completed as a priority. All new roads and footpaths serving the development shall be completed to taking in charge standard and to the written satisfaction of the Council's Environment and Transportation Department. A suitable bond shall be lodged with Dublin City Council prior to the commencement of the development in accordance with the conditions of a grant of planning permission for the site.
- 12. That there is an inhibition on the title that the subject site can only be used for affordable housing and community crèche purposes.
- 13. The purchaser will be responsible for completing all development works including all snagging works, landscaping etc. The purchaser will provide the completed units in full compliance with all statutory consents and in Turnkey Condition (see term 14 below).
- 14. That the completed units are deemed to be in the 'Turnkey Condition' referred to in 13 above when they reach an accepted level of 'Practical Completion. This means they are completed in accordance with the Planning Permission granted and that: (i) the Housing Units in the development are capable of beneficial use and occupation and (ii) that any items of work outstanding or any other defects are of a minor and trivial nature only and are such that their completion or rectification would not interfere with or interrupt such use and (iii) where the Building Control (Amendment) Regulations 2014 require that a completion certificate be included on the Statutory Register before the Housing Units can be opened, occupied or used. Practical Completion shall not be deemed to be reached until the Certificate of Compliance or Completion has been

- submitted to the building control authority and relevant particulars thereof have been included in the Register maintained under Part IV of the Building Control (Amendment) Regulations 2014.
- 15. That the Affordable Purchase dwellings shall be made available and sold under the terms of the Dublin City Council Scheme of Priority for Affordable Dwelling Purchase Arrangements, as provided for under the Affordable Housing Act 2021 and Affordable Housing Regulations 2022, and to be agreed by the Elected Members of Dublin City Council.
- 16. That each party shall be responsible for their own legal fees.
- 17. That the purchaser shall be liable for the payment of VAT or Stamp Duty should any payments arise from this disposal.
- 18. That the legal agreement shall include any amendments and / or conditions deemed appropriate by Dublin City Council's Law Agent.
- 19. That the above proposal is subject to the necessary approvals and consents being obtained.

The dates for the performance of any of the requirements of the proposed agreement may be amended at the absolute discretion of the Executive Manager.

No agreement enforceable at law is created or is intended to be created until an exchange of contracts has taken place.

PUBLIC DOMAIN REPORT JANUARY 2024

Overview 2023

The Public Domain Team had an extremely busy and productive 2023. Many highlights over the last 12 months includes the spring clean-ups, City Neighbour awards completion, Halloween 2023 event, Leaf Collections Initiative and the Christmas tree lighting.

Graffiti removal

To date 1427 sq. meters of graffiti has been removed during the period of January 2023 to December 2023.

Illegal Dumping: 2497 incidents recorded to date

Enforcement: All Businesses in the North West Area are contacted throughout the year prior

to Halloween reminding them of their responsibilities under the Littler By Laws

Over 4500 leaflets where delivered to the Finglas and Ballymun Areas running up to Halloween.

Over 350 waste enforcement notices were delivered in the Ballymun and Finglas areas.

Better Ballymun

The successful Better Ballymun day was held on March 3, 2023, with strong support from the Public Domain and Community Development Teams. These teams provided significant resources towards all aspects of the project in the weeks leading up to the event. Both local and national media outlets covered the event, including a report on TV3. The day was marked by a vibrant atmosphere, with input from all the lead groups and schools in the area. A range of initiatives and clean-up activities were carried out, such as planting and painting. The Trinity Comprehensive School and Ballymun Tidy Towns deserve special recognition for their pivotal roles in making the project a success. The team would like to extend heartfelt congratulations to both groups. The Next Better Ballymun day will be held March 1st 2024.
















Team Dublin Clean Up

IBAL June Report 2023



Ballymun: 30 out of 40 towns / cities surveyed. Moderately Littered Ballymun has moved from 31st to 30th place since last IBAL report.

A strong performance by Ballymun with notable improvements at some formerly heavily littered sites e.g., Ballymun Green Car Park. There was plenty of evidence of community initiatives e.g., Better Ballymun posters / Trinity Comprehensive school poetry project / Climate themed Traffic Light Box Art / Trinity Comprehensive History Trail and Tidy Towns sponsored planter boxes. Ballymun Road and Ballymun Town Centre were very much deserving of the top litter grade. The two most heavily littered sites have been stubbornly so for many years – Balbutcher Lane and the Bring Facility at Shangan Road.

The Public Domain Team twinned with a strong community response endeavour to improve areas throughout Ballymun and Finglas 2024.

Kellogg's Environmental clean-up Ballymun in conjunction with Ballymun Tidy Towns

North West Area Public Domain and Community Teams supported Kellogg's and Ballymun tidy towns during a clean-up and replanting of planter boxes.

The Public Domain Team distributed all the equipment and arranged for collection of bags from the clean-up. Congratulations to all involved for their efforts in this initiative. The Public Domain Team going forward will engage with Kellogg's and other companies to deliver similar enhancements and clean-ups







Anti-Dumping Initiative

The NWA was allocated € 12243.09 in funding for 2023. The Public Domain Team coordinated the Mattress and WEEE Amnesty Days as part of this project.

Two separate events were held to promote the reduction in Electrical Waste and Mattresses. One in Finglas Civic Offices, Mellowes Road, Finglas, D. 11 and one in Ballymun (Trinity Comprehensive School), Main Street, Ballymun, D 9. The events were held over 4 hours each day on the 16th & 23rd September, 2023.

Recycle IT recorded over 1000 Items, 4.343 Tonnes of Electrical waste was removed. Over 200 Mattresses where collected. We are hopeful that this will reduce the number of mattresses dumped and discarded over the Halloween period. It also promotes the recycling message at a more local level. As part of the ADI fund 2024 the Public Domain Team will apply for funding for two more pop up recycling days in September 2024





Ballymun Information board and seating area

Public Domain Unit in working with Ballymun Tidy Towns have delivered the installation of an Information Board and seating area accessed by a new gravel path. The project was completed April 2023 ready for the summer months to be used by locals. Ballymun Tidy Towns will plant additional plants around the seating area in 2024.





City Neighbourhood Awards 2023

Our NWA Dublin city annual neighbourhood participants did the area proud again this year getting favourable results on the award night in Croke Park.

Congratulations to all in Ballymun and Finglas

These excellent results reflect the hard work done during 2023 by our Tidy Towns Groups, businesses, senior citizen complexes, and last but not least community groups and residents in both areas. We would like to congratulate all individuals for their ongoing commitment and dedication to their groups. The work that they undertake is very much of value to the North West Area and Dublin City Council greatly values and appreciates their input and great effort in the area and the Public Domain Team will continue to support in any way we can.

North West Area Halloween







As in previous years the NWA Public Domain Team, collaborated with numerous DCC Departments (Parks, Waste Management, Waste Enforcement, DFB, and Housing) to remove as much stockpile materials as feasible. They also worked alongside Gardaí from Ballymun and Finglas as part of "Operation Tombola" to remove stockpiled material and reduce the negative impacts of bonfires in the area. This collaborative effort commenced on Saturday 21st and concluded on the afternoon of 31st October.

Approximately 4306 information leaflets describing the dangers of bonfires and detailing DCC contact information were handed to residents near areas where bonfires are commonly conducted.

In total, there were 23 burning/bonfires locations, 10 in Ballymun and 13 in Finglas, the majority of which were minor, with minimal damage evident. The successful Amnesty Day, held in September, also significantly reduced the number of mattresses illegally disposed in the run up to Halloween. Over 63 tonnes of stockpiling material was removed in the led up to Halloween. Waste Management Services have indicated that the total figure of stockpiled material collected was **493 tonnes** citywide, which is slightly up from the 2022 figure of **441 tonnes**

The below table highlights the reduction of purpose built bonfires containing pallets and tyres for Halloween night. Overall the domestic waste fires where minor in comparison. Going forward the Public Domain Team will continue to work hard to deliver higher detection of bonfire materials and strive to lower the number of bonfires in the area.

1. Dublin City Sport & Wellbeing Partnership Highlights January 2024:

Linking in with National Events & Initiatives

The primary goal of Dublin City Sport & Wellbeing Partnership (DCSWP) is to provide opportunities for everyone to get involved in sport & physical activity regardless of age, gender or ability. DCSWP continues to align the planning and delivery of programmes with national and international sporting events in 2024. This strategic approach helps maximise promotion of the service, adds momentum to local programmes and initiatives and ultimately increases reach across communities in Dublin City.

Lord Mayor's 5 Alive Road Race Challenge 2024

The Lord Mayor's 5 Alive is back for 2024 and is aimed at novice walkers/joggers/runners and people wanting to get back on track with their fitness goals.

Sports Leadership Programme – Finglas Youth Resource Centre

Sports Leadership UK is a programme that aims to provide young people with the confidence, skills and behaviours necessary to lead physical activity sessions in their school/community setting. This year DCSWP offered the programme to Finglas Youth Resource Centre.

Young people at Transition Year level from different schools within the NWA community attend 21 tutor learner hours developing leadership behaviours and skills in order to plan, structure and deliver physical activity sessions to a group of younger children. As part of the programme participants are assessed on their performance and if successful they will receive an internationally recognised qualification from SLUK. The programme has been running from late September 2023 and concludes at the end of January 2024 with a planned social action piece in the community delivered by the 16 leaders.

3. Active Cities, Dublin City – NWA Update

NWA Active City Programme Plans 2024

As agreed with the NWA Office in November 2023, the Active Cities Officer will arrange a meeting in early 2024 with all stakeholders currently providing programmes/activities in the Ballymun to identify gaps in provision and to ensure that there are no overlaps. From there DCSWP will have a clearer picture of what is required in the area in 2024.

Orienteering – Poppintree Park

Plans are being finalised to launch the Orienteering courses that have now been physically signposted throughout Poppintree Park in the NWA. In total eight parks throughout Dublin city have had orienteering maps uploaded on to Maprun which is an online portal that is used to access orienteering routes.

Poppintree is the first of the parks in the DCC area to have the signage installed. DCSWP's Active Cities Officer plans to meet with the Ballymun Health & Fitness Local Community Group in the coming weeks to arrange a local launch of the signs.

The Active Cities Officer is also engaging with local P.E teacher Paddy O Reilly, Ballymun Trinity Comprehensive School, Ballymun regarding the delivery of a programme whereby local scouts will use the course along with Transition Year students.

Plans are also being put in place to liaise with local NWA primary schools around the idea of teaching younger primary school children to use the course and follow on with one-day orienteering events where younger children attend along with a grandparent/other older member of the family as an intergenerational event.

Cycle with Confidence

Plans are being put in place to deliver another 'Cycle with Confidence' programme for adults in the NWA at the Decathlon cycle course which has been made available to DCSWP at no cost.

> Freestyle Soccer Event

Documentary evidence from the world cup freestyle soccer event in Ballymun United last September is currently being collated by DCSWP/Active Cities as part of the submission to the Guinness Book of Records.

4. DCSWP NWA Co-Funded Programmes

Athletics in the Community

Couch to 3/5k and walking programmes continue in the NWA area in partnership with the Co-funded Athletic Officers. Officers continue to engage with local schools in the Daily Mile and School's Cross-Country 2024 programmes. Couch to 3 & 5k and the launch of the Couch to 5k podcast are in the planning stages for March/April.

In January/February Holy Spirit GNS Primary School, Ballymun will participate in the Primary School Athletics programme every Monday from 9.30am.

Boxing in the Community

The **Startbox** Initiative, a partnership between the IABA and Dublin City Sport & Wellbeing Partnership, represents an ideal way for young people (10 – 17 years) to first engage with amateur boxing, Ireland's most successful Olympic sport. It is delivered by our 5 dedicated IABA/DCSWP Development Officers via local schools (primary & TY level) in communities across the Dublin City area. Approx. 2,000 young people take part each year.

The programme is structured into Bronze (non-contact), Silver and Gold phases. The first phase focuses on general strength & fitness, method and technique. The Silver programme consists of higher intensity sessions & limited contact and the Gold phase takes it to another level (combination of first two levels and progression to contact).

The programme has expanded over the years to include young participants from 7 - 10 years (second class +)

- Club training sessions in partnership with Finglas Cricket Club take place in Poppintree Park every Saturday from 10am (mixed 11-17 years)

Skills and Tag Rugby Programme

To be delivered in Trinity Comprehensive, Ballymun with participants from Poppintree Youth Project and Trinity Comprehensive every Monday from 6pm aimed at young people age 13-17 years.

Swimming in the Community (citywide)

DCC/DCSWP appointed a Co-funded Swimming Ireland Development Officer in 2022 to increase opportunities for everyone in our communities to get involved with swimming and enjoy the benefits of water based physical activities. A new DCSWP Swimming Development Officer was appointed over the summer 2023 period.

Men's wellness, female wellness, Foróige, Foundations youth project and Vision Sports swim programmes continue in Sean McDermott swimming pool with participants from across the city including the NWA.
