

#### Reply

Shanliss Avenue is currently traffic-calmed with 5 No. ramps which are appropriately spaced to offer optimum traffic calming. As per the traffic management guidelines, it is poor design to have traffic calming features that are spaced too closely, as it encourages harsh braking and consequent heavy acceleration in-between.

Additionally, free parking is available along the street, which offers traffic calming by reducing the available carriageway width and raises driver's awareness to their surroundings.

Shanliss Avenue is a 30km/h Residential Speed Zone with signage provided at the junction of Santry Avenue and Shanliss Way to alert drivers. Recently, a Slow Road marking was recommended under lamp standard no. 6, and it is going to be installed in due course. Therefore, no additional traffic calming is recommended.

The City Council is currently progressing refurbishment plans for these two commercial properties. It is intended that the refurbished units will be used to house tenants who have reduced mobility needs.

An Architect has been appointed to the project and will present the City Council with a detailed design proposal for these units in the near future.

Following this engagement, the City Council will prepare and issue a tender for the refurbishment works associated with same.

Thereafter it is estimated that the refurbishment works will take approximately 12 months subject to the necessary statutory approvals being obtained.

The City Council undertakes regular reviews of the condition of the properties and will continue to do so until the refurbishment of same are completed.

#### **General Matters**

#### Kildonan Housing Project

The project is to be delivered in two phases. The first phase will see the construction of mixed tenure housing of approx. 136 housing units. The project team is currently working towards a Stage 2 Funding Approval application, which is expected in Q4 2024. Site Surveys are ongoing.

The provision of affordable homes in Phase 2 is also under consideration.

#### Finglas Employment & Training Working Group

The next meeting of the group is due to take place on Friday 26th April.

The Finglas Area Office is continuing to publicise the group within the local area. Work is ongoing to finalise an event which aims to promote the supports and opportunities that will available to potential employers and employees.

A sub group is being formed in order to prioritise activities and to formalise short, medium and long term goals for the group.

#### Finglas Business Group

The Finglas Business Breakfast on the 21<sup>st</sup> March 2024 went well and provided opportunities for networking. There were approximately 40 attendees and David Weldon from Transport Infrastructure Ireland delivered a presentation on the Finglas LUAS project and the economic benefits for the area.

The Finglas Village Improvement Scheme has been requested as the subject of the next presentation.

## Finglas Village Improvement Scheme

A non-statutory public consultation was held from the 12/02/2024 to the 15/03/2024 (5 week period), with a public information evening held on the 29/02/2024. A total of 70 submissions were received via the online consultation hub by the closing date. Other submissions were made via email and at the Public Information Event on 29th February 2024. In order to inform of this consultation a total of 9,300 leaflets were distributed. There was also promotion though social media and DCC Alerts. A total of 24 residents attended the information evening.





A Public Consultation Report will be produced in Q2 2024. Subject to the NTA's approval, the scheme will proceed to Detailed Design and Procurement Phase. The scheme is expected to commence construction in Q1 2025.

#### Finglas Area Roundabouts Scheme

The Preliminary Design for the Jamestown Road Roundabout has been completed. The Project Appraisal and Business Case have been submitted to the NTA for approval to proceed to detailed design. The AA and EIA screening reports have been completed. We are also coordinating with Fingal County Council on the requirement for a Section 85 agreement (one LA performing for another). It is expected that detailed design will be completed by Q2 2024, followed by the preparation of tender documents for the appointment of a contractor. Approval to proceed is awaited from the NTA to proceed to detailed design/tender for McKee Avenue/St Margaret's Road/Lidl junction. Construction is to commence in 2024 subject to NTA approval and funding availability.

#### Finglas LUAS Project

A full update will be presented to the Area Committee at the April Area Committee Meeting.

#### **Bus Connects**

The NTA currently expects to introduce new routes E1, E2, N2 and 19 in Q2 of this year. Routes 4, 11, 13, 145 and 155 would be replaced by the new services. During Q2 of 2025 we would introduce new routes F1, F2, F3, L89 23 and 24. Routes 9, 40,

40b, 83, 83a and 140 would be replaced.

New routes N4 and N6 were introduced in the Finglas area during 2022.

## **Community Recognition Fund**

#### Dublin City Council Allocates €2m to Support Local Communities

Dublin City Council would like to announce the allocation of €2,140,584 in funding under the Community Recognition Fund.

The Community Recognition Fund (CRF), established to acknowledge the invaluable contributions made by communities across Ireland in welcoming and hosting arrivals from Ukraine and other countries, aims to bolster community resilience and cohesion.

The funding will be directed towards projects located in Dublin City, towns and villages hosting Beneficiaries of Temporary Protection and/or International Protection Applicants, including those identified for the Rapid Build Homes Programme. These projects are intended to benefit the entire community, aligning with the fund's objective to develop facilities for future use by all members of society.

Dublin City Council emphasises the importance of community engagement in shaping the allocation of funds. Proposals submitted by the local authority will be developed in consultation with impacted communities, Local Community Development Committees (LCDC) and elected representatives. These proposals must align with Local Economic and Community Plans and demonstrate targeted investment in areas with the highest concentration of new arrivals.

Eligible projects for funding must be capital in nature, delivering medium to long-term benefits for the community. They should be capable of implementation between 2025 and 2026, with a minimum expenditure of 50% of the allocation required in 2025. While the focus is on larger-scale projects, with individual funding ranging from €50,000 to €500,000, smaller initiatives will be considered provided they meet the minimum threshold.

Projects eligible for funding include the development, enhancement or refurbishment of community and cultural facilities, sports facilities, school facilities open for community use, equipment purchases for local clubs and organisations, transport infrastructure, initiatives addressing dereliction and refurbishment of vacant buildings for community use.

In a departure from previous approaches, Dublin City Council will reserve a portion of its allocation for proposals submitted under the third application window, ensuring flexibility to address evolving community needs.

Notification of initiation under Part 8 Planning and Development Regulations 2001 (as amended)

Proposed Development of 110 Residential Dwellings on grounds at the Former Church of Annunciation, Cardiffsbridge Road, Finglas, Dublin 11

Dublin City Council wishes to give notice that it intends to initiate the process leading to an application under Part 8 of the Local Government Planning & Development Regulations 2001 (as amended) for the construction of a residential development comprising 110 residential dwellings at a site c.0.78 ha at the site of the former Church of Annunciation on Cardiffsbridge Road, Finglas, Dublin 11. This site will be developed as part of the National Social Housing PPP Programme.

#### **Site Location & Context**

This site at Cardiffsbridge Road, Finglas is located around 5.7km North West of the City Centre and lies broadly north of the Tolka Valley Park. The site is located in Finglas West, at the corner of the Cappagh Road (R103) and the Cardiffsbridge Road (R103). The site is located immediately west of Coláiste Eoin north of Coláiste Íde College of Further Education. The Church of the Annunciation was formally located on the site and is proposed to be relocated north of the subject site. The subject site is 0.78 ha (net area 0.71)

#### **Proposed Development:**

The development proposal presented here was developed by the Design Team in response to a design brief developed by Dublin City Council. The proposed development has undergone an iterative design review process with key stakeholders including representatives from North West Area Office, Housing Department and DCC technical teams in consultation with the Project Technical Advisors.

The complex ranges in height from 4 to 5 storey consisting of 110-unit residential scheme for Older Persons, with Community, Arts and Cultural facilities, as per the SDRA zoning requirements. The community space is located at ground floor level, overlooking the public open space, and addressing Cardiffsbridge Road, with residential apartments predominantly to upper levels.

The proposed development includes:

- One apartment block ranging from 4 to 5-storeys, containing: 110 residential units (106 no. 1-bed and 4 no. 2-bed); and 434 sq.m. of community, arts and cultural facilities.
- 15 no. car parking spaces and 87 no. cycle spaces.
- 935 sq.m. of public open space and 609 sq.m. of communal open space.
- One vehicular and pedestrian access and one dedicated pedestrian access off Cardiffsbridge Road.
- Boundary treatments, public lighting, site drainage works, internal road surfacing and footpath, ESB meter rooms, plant rooms, stores, bin and bicycle storage, landscaping; and
- All ancillary site services and development works above and below ground.


DCC Housing Department with the Project Architects held a public information session on the 28 November 2023. The consultation was well attended by members of the public. The team presented designs at a point in time during design development.



#### **Housing Sites Update**

#### Site 14

Dublin City Council were required to address issues with the original design (previously presented to NWAC Councillors) to ensure alignment to the New City Development plan requirements. A design review took place and the Design Team are currently finalising the design plan. It is our intention to present the plan to the North West Area Committee members by end of May.

#### Site 21 Balbutcher Lane

Construction of 12 houses underway all foundations and floor slabs are in place and the timber frame construction is almost complete on 6 houses. Work is been carried out by O Hanlon & Farrell Ltd engaged by O Cualann.

#### Site 25 - Parkview

Planning was approved for construction of senior living apartments. O Cualann plan to commence construction on site in the coming month or so once contracts are agreed with Tuath Housing and subject to land transfer with DCC.

The 2<sup>nd</sup> phase of the Parkview site for 34 units and a crèche is still subject to an An Bord Pleanála appeal process, a decision was due on 21<sup>st</sup> March 2024, but has again been delayed due to backlog of cases.



#### POPPINTREE SPORT AND COMMUNITY FACILITY



Poppintree Sport and Community Facility is currently undergoing some external refurbishment work. The refurbishment works include painting the facilities exterior walls, resurfacing the all-weather pitch, installation of fencing, tarmac, basketball hoop and CCTV. The ground works will also include levelling the grass mounds, to increase the opportunities to use of this area and improve visibility to the all-weather Pitch. Contractors have been appointed and initial works have started. It is anticipate that this work will be completed by June 2024. The total cost of the refurbishment is €283,213.17 excluding VAT. Westside Civil Engineering is appointed to complete the ground works and Sole Sports Limited is appointed to resurface the all-weather Pitch.









The Manager and staff in the facility are planning to work in partnership with the anchor tenants of the facility, The Sport and Recreation Section and the Community Section to schedule organised activities to engage and encourage the community to use this area. The pitch will be available for local sports teams and clubs to book. The prices for booking will be in line with all Dublin City Council facilities and will incorporate peak and off peak hourly rates. Any clubs and teams that are interested in using this area are encouraged to make contact with the facility to find out more details.



#### Grant of a 5-year licence at Silloge Park Golf Course, Ballymun Road, Co. Dublin

Culture, Recreation and Economic Services Department has requested that The Trustees of Silloge Park Golf Club be granted a further 5 year licence to operate a golf club at Silloge Park Golf Course. Silloge Park Golf Club is affiliated to the Golfing Union of Ireland and the Irish Ladies Golfing Union. The area in question is shown delineated in red on Map Index No. SM-2018-0062.

The Chief Valuer has reported that agreement has now been reached with The Trustees of Silloge Park Golf Club for the granting of a 5 year licence, subject to the following terms and conditions:

- That Dublin City Council own and maintain Silloge Park Golf Course, Ballymun Road, Co. Dublin. The subject property is shown outlined in red on attached map SM-2018-0062.
- 2. That Dublin City Council shall engage a Service Provider to manage the running of the golf pavilion at the subject property. (A new contract with the Service Provider commenced on the 1 January 2024).
- 3. That Dublin City County shall grant The Trustees of Silloge Park Golf Club a licence to operate a golf club at the subject property. The Licensee shall not use the property for any other purpose.
- 4. That the Licence shall be for a term of 5 years, commencing on the 1 October 2023. This licence is personal to The Trustees of Silloge Park Golf Club and the Licensee shall not assign, sublet or part with possession of the property or any part thereof.
- 5. That the Licence fee is to be 1 euro per annum if demanded. VAT is not applicable.
- 6. That for the effective management of Silloge Park Golf Course, the membership of Silloge Park Golf Club will be limited to 350 members per annum, which can be a combination of full members and pay and play members. The membership limit may be reviewed by the Council, in conjunction with the Golf Club and the Service Provider and any changes to membership numbers must be agreed with the Council.
- 7. That Dublin City Council, The Trustees of Silloge Park Golf Club and the Service Provider shall agree to meet annually to review the current arrangements.
- 8. That any future agreements with The Trustees of Silloge Park Golf Club and the Service Provider or any other party must be agreed in advance in writing with Dublin City Council.

- 9. That Silloge Park Golf Club shall be affiliated to Golf Ireland and shall remain in good standing with Golf Ireland.
- 10. That Silloge Park Golf Club shall operate women's, men's and juvenile sections in the Club.
- 11. That the membership fee for the Club will be set by The Trustees of Silloge Park Golf Club. These fees or any proposed changes will be subject to the prior written approval of the Dublin City Council.
- 12. That the Service Provider shall collect all club membership fees and shall distribute the full fees (without deductions) annually between Silloge Park Golf Club (the Licensee), the Service Provider and Dublin City Council (the Licensor) as set out below from the 1 January 2024. The Service Provider will provide an annual report detailing the collection and distribution of membership fees to the Licensor:

Silloge Park Golf Club	17%
Service Provider	18%
Dublin City Council	65%

- 13. That the Licensee shall meet with the Licensor on an annual basis.
- 14. That the Licensee shall indemnify the Council against any claims, injury or damage caused by its members and shall take out and produce to Dublin City Council Public Liability Insurance in the sum of €6,500,000 (six million, five hundred thousand euro). Employer Liability Insurance (if applicable) in the sum of €13,000,000 (thirteen million euro) for any incident and Product Liability Insurance in the sum of €6,500,000 (six million, five hundred thousand euro) with an insurance company authorised by the Central Bank of Ireland and operate in the Republic of Ireland.
- 15. That the Club shall have the use of an agreed area of the existing Pavilion at Silloge Park Golf Course where the Club's business can be conducted.
- 16. That the holding of all competitions shall be subject to consultation and agreement with the Council and the Service Provider.
- 17. That priority tee times for Club members competitions are Tuesday first light until 11.30am, Thursday 9.00am to 11.30am and Sunday 10.00am to 1 pm. From the end of May for 12 weeks there is also a Friday night club from 6pm to 8pm. On the Captains. Presidents and Charity days the times will be 10am to 3pm, dates for which shall be agreed in advance with the Service Provider. For the good management of the golf course, priority tee times can be extended or reduced as agreed between the Licensor and the Service Provider. Members who wish to play outside of priority tee times must do so in accordance with the guidelines as agreed between the Service Provider and the Licensor.
- 18. That the Licensee shall sign a deed of Renunciation and the granting of this Licence to The Trustees of Silloge Park Golf Club shall not confer any rights under Landlord and Tenant Law.
- 19. That the Licence may be terminated by the Council at any time, subject to a minimum of three months' notice in writing to the Licensee.

20. That the licensed area shall be subject to a wayleave to Uisce Éireann as shown coloured yellow on the attached map. This may not be the final wayleave area, as Uisce Éireann have not yet confirmed the exact area they require for their proposed underground orbital sewer, planned as part of the Greater Dublin Drainage Project.

Please note: An Bord Pleanála granted permission for this project in November 2019 but this decision was quashed in November 2020 by the High Court. The High Court remitted the planning application to An Bord Pleanála in July 2021 and I understand that the application is ongoing with An Bord Pleanála.


- 21. That Dublin City Council alone shall, negotiate all terms and conditions of the wayleave with Uisce Éireann, whether or not the Licensee is served with a wayleave notice by Uisce Éireann. Uisce Éireann has yet to confirm if works will be carried out via above ground works or below ground works. The Council shall update the Licensee in due course, in relation to all practical aspects of the works. The Council shall endeavour in its negotiations with Uisce Éireann to minimise the impact of the works (as much as practically possible) on the Golf Course operations.
- 22. That the Licensee shall accommodate Uisce Éireann with access to the Golf Course when they are constructing the orbital sewer.
- 23. That the each party shall be responsible for their own fees and costs in this matter.
- 24. That the Licensee shall be responsible for the payment of any Stamp Duty liability that may arise on the creation of this Licence.

The pay as you play income from Sillogue Park Golf Course is not included in this arrangement.

The dates for the performance of any of the requirements of the proposed agreement may be amended at the absolute discretion of the Executive Manager.

No agreement enforceable at law is created or is intended to be created until an exchange of contracts has taken place.

#### Report Graffiti North West Area – April 2024

In March 37 sq. meters of graffiti has been removed in North West area.

To date 409 sq. meters of graffiti has been removed during the period of January to March 2024.

#### Weeding Removal Programme 2024

A Contractor has been appointed and the 1st round of the Weed Removal Programme will commence in the North West Area on 15th April 2024. The treatment being used again this year is New Way Spray. The environmental benefits of using these alternative methods include - they are glyphosate free, the application method produces significantly lower carbon emission compared to that of other methods (flame/ hot foam), New Way Spray contains 240g/L acetic acid - naturally occurring and bio-degradable, safe for the environment - breaks down naturally in water. All streets/roads assigned prior to the 1st treatment date will receive 4 treatments throughout the season. These treatments will take place in April, June, August and October.

#### Better Ballymun

Better Ballymun day was held on 15<sup>th</sup> March, 2024. The Public Domain and Community Development Teams were proud to support this fantastic initiative again this year. Significant resources towards all aspects of the projects were provided in the weeks leading up to the event. The day was marked by a vibrant atmosphere, with input from all the lead groups, businesses and schools in the area.

The Public Domain Team in consultation with the Better Ballymun Group identified and recommended a number of areas to be planted, which were problem areas and illegal dumping black spots. Increased emphasis on raising awareness of illegal dumping, litter and recycling was promoted this year

A leaflet pack was supplied to Trinity Comprehensive who distributed the information on the day to residents in and around our illegal dumping black spots in Ballymun. This pack consisted of - illegal dumping reporting information, Environmental Group Information, Recycling Centre information.

A range of initiatives, clean-up activities and planting projects were carried out on the day and equipment was provided for over 30 clean ups taking place.

Some of the areas included in the planting projects were Sillogue Gardens, Owensilla, Whiteacre Park and Shangan Park.

There were also other activities such as Recycling Centre demo video, a popup market on The Plaza, tree planting, painting, making and installation of swift bird boxes, cleaning, to name but a few.

The students of Trinity Comprehensive School deserve special recognition for their pivotal role in making the project a success and the team would like to congratulate them on another successful day.
