DUBLIN CITY COUNCIL SOUTH CENTRAL AREA COMMITTEE 15th May, 2024

M325 Councillor Vincent Jackson

This Area Committee please look at improving the physical environment of the Dowland Road area of Walkinstown Dublin 12. I regret looking at the damaged footpaths, poor surface of roads and general lack of maintenance of the area leaves a lot to be desired. I am asking Dublin City Council to do a full review on the area and come back with a report indicating a time span to make progress on improving the area. The general area has the potential for serious trip hazards.

M326 Councillor Vincent Jackson

This Area Committee please note that due to change in weather patterns that it's no longer possible to depend on using public football pitches in the winter / spring months that serious consideration be given to providing funding to develop a full size all weather football pitch in the Ballyfermot Area. The current facilities at the Ballyfermot Leisure Centre provide space for training only and are not sufficiently large to allow regulation games take place. Opportunities for funding are available from Lottery Funding etc.

M327 Councillor Vincent Jackson

This Area Committee please look for Dublin City Council on a pilot basis to do an extensive clean-up of general open spaces in the Cherry Orchard area in order to try and deter systemic dumping by a few. Local residents and DCC have from time to time done great work cleaning up open spaces only for the efforts to be undone by a few who think its ok to fly tip waste, having a cleansing crew doing a deep clean and maintaining it for a couple of months could and should have a very positive impact.

M328 Councillor Hazel de Nortúin

This Area Committee recognises that there's a high level of vacant housing in the Cherry Orchard area and that for numerous reasons there's been a need for family supports with residents off all backgrounds. This Committee calls on the Director of Services to direct supports into the Cherry Orchard area with a dedicated Project Estate Officer that's based in Cherry Orchard and is 'on the ground ' working with families who need their support. There's been a large volume of allocations in the Ballyfermot/Drimnagh ward and there's recognition of the work carried out by housing staff. There is, however, acknowledgement that we need more support in the area.

M329 Councillor Máire Devine

This committee expresses dismay at the serious AS/Criminal behaviour that has made life intolerable for the residents at Herberton Apartments, Block D, Rialto. We call on DCC to attend to the maintenance issues and robustly address the marauding gangs that have taken over the public

spaces and communal lobbies terrifying residents and visitors. We further request that a dedicated community development worker be deployed to deal with the numerous issues and reclaim these spaces for the community.

M330 Councillor Máire Devine

This Committee acknowledge that the installation of the protective gates at Robinsons Court, Dublin 8 was agreed by members a year ago. The delay is unacceptable and we ask that a report be presented by the manufacturing company to members detailing the issues encountered with a definite urgent date provided for these necessary works.

M331 Councillor Kelsey May Daly

This Area Committee condemns the unfair segregation of social housing tenants at Newmarket Yards. To have developed legislation to integrate social housing tenants with private tenants to negate the negative impact of deprivation in communities then to only separate them both physically and through denial of access of areas that allow such integration i.e. communal areas goes against the ideology that informs this practice and does not produce the results found in studies on the matter. This area committee recognises this as discrimination of social housing tenants and does not support such policies and practice.

Reply

There are several different types of tenure in the Herberton Estate including City Council tenancies, Clúid Housing tenancies and private tenancies and there are also some units that are owner occupied. One of the blocks is also owned by a private company.

The City Council have been in discussions with the Management company regarding improvement works in the Estate such as door security measures and cleaning of communal areas. The funding has been provided to implement these measures in the Blocks where the City Council have tenancies.

In addition, the City Council, the Management Company and the Gardaí held a meeting on Monday 8th April regarding the anti-social behaviour and the policing of the Estate. It is envisaged that these meetings will continue to be held on a regular basis.

The City Council is also aware that residents who are not City Council tenants also had a meeting with the Management Company regarding difficulties they are experiencing.

The Local Estate Officer also holds a weekly clinic where the City Council tenants can discuss their issues.

Carrey Issuer DAC approached the Development Department for consent to landscape the linear strip which front their lands at St. Luke's Avenue, Dublin 8, along with a small area to side/rear of the development. The sole possible future use of the two plots (shown in pink above) was as public realm/public open space and with this in mind the Council consented to the Developer including the strips in their planning application for the purpose of landscaping them to enhance the streetscape. Agreement was reached with City Valuer's Office and the Parks, Bio Diversity & Landscapes Services Division regarding the Public Open Space and a licence was issued to the Developer to allow them landscape the lands involved. A comprehensive Landscaping Scheme was developed and approved by a Council Senior Executive Landscape Architect with the scheme's completion being subject the satisfaction of the Parks, Bio Diversity & Landscapes Services Division. A twenty year service level agreement for the maintenance of the installation was also agreed with Parks, Bio Diversity & Landscapes Services Division.

Parks, Bio Diversity & Landscapes Services Division have confirmed that they did request that railings with gates be installed in discussions with the Developer's Project Landscape Architects. The railings function to protect planting areas while they are establishing themselves and the overall performance/issues of the space can be reviewed by the Parks Services at a later date when the plants are bedded in.

Planning permission has been granted to Respond Housing CLG to demolish the existing structure and build 6 older person units. Negotiations are ongoing between Dublin City Council and Respond CLG for a disposal of the title in the site to Respond CLG, on the basis that the subject property can only be used for building social housing purposes.

The site was inspected on 10th April, 2024. The Development Department will organise for the site to be cleared and going forward the site will be monitored on a regular basis.

Engagement with local organisations and groups has begun to gauge the level of interest and allocate slots. At least 19 on water events – kayaking, SUP, Water polo will take place. Once design plans are agreed, the next stage includes: finalising plans for presentation and public display (expected May/June 2024); risk assessment and a cost and programme summary. Once feedback received and considered then detailed design, bill of qualities for landscaping elements and planting schedules will be prepared. Tender documents for procurement of contractors, including a maintenance plan, will be prepared and a tender process will follow. It is expected that contractors should be on site for 6 to 8 weeks, in the second half of 2024.

Inchicore Library

The process of refurbishing the old Inchicore Library Building has been gathering pace in Q1 of 2024. Architects are currently reviewing the existing plans to decide on which form of universal access will facilitate the most efficient way to enter the building for all, whilst also maintaining the Historic and Unique character of the front of the building. This work is being carried out with a view to not only remaining within the scope of the Part VIII planning consent but also reengaging with the previous design team to keep the project costs affordable. Dolphins Barn Heritage Panel, Located at Linear Park Dolphins Barn (Image contains St. John's Church)



Historic information for both panels was provided by South Central Historian in Residence Cathy Scuffil.

The name 'Dolphin' – relates to David Dolphin, a Knight of Kilmainham who was granted lands extending to the area in the Norman era. The Celtic Cross monument on the crossroads marks the spot where,

during penal times, the local Catholic community worshipped secretly in a small wooden barn. In 1798, a small stone chapel on St. James's Terrace was erected and served the local community until 1892 when the present church was built.

Cork St/ Donore Avenue Heritage Panel, located junction Cork Street and Donore Ave landscaped seating area (Image -The Fever Hospital and House of Recovery)



The Fever Hospital and House of Recovery, built on the Widow Donnelly's Orchard, Cork Street. In the 1950s, when Cherry Orchard (Ballyfermot) Fever Hospital opened, the Cork Street Fever Hospital became Brú Chaoimhín, a community nursing home. This closed in 2011, the site is now used for HSE services.

Community Participation

Community Festivals

The City Council will continue to provide support to festivals taking place in the area and access to professional support and advice from an event management company regarding event plans, risk assessments and park permits which can be difficult for local voluntary groups to navigate.

Community Development staff are currently involved with the following Groups:

Cherry Blossoms: The Cherry Blossom Festival is now underway and will continue with events in Cherry Orchard until the final event on Tuesday 30th April, a concert in the Most Holy Sacrament Parish Church, Cherry Orchard. Link to brochure:

Ballyfermot Festival: Planning is underway for the Ballyfermot Cherry Orchard Arts Festival which takes place from the 7th – 14th July. The next public meeting is in the Ballyfermot Civic Centre at 7.00 PM on Tuesday 23rd April. The Council will support the family fun days in Markievicz Park & Cherry Orchard Park.

Walkinstown Festival: Planning is now underway for the Walkinstown Festival which is planned to take place on Sunday 1st September. The initial festival committee planning meeting was held on 19th March with a follow up meeting due to take place on 16th April. Fund raising has already commenced alongside implementing actions aimed at extending the level of diversity and inclusion within the festival activities for this year's event. To this end DCC Community staff will assist in identifying any new communities that can be invited to attend the festival and participate in the festival line-up.

Chapelizod Festival: The Chapelizod Festival takes place from the 1st – 7th July.

Drimnagh Festival: Drimnagh Festival will be undergoing some changes for 2024. Planning and fundraising meetings are due to commence in April where festival date, content details and proposed changes will be agreed and confirmed.

The Council will also support local residents groups to host local play events in local parks and/or green spaces during the summer months.

Opera in the Park:

The council will also organise Opera in the Park in Ballyfermot and Drimnagh on local greens during July. Dates to be confirmed.

Sheltered Housing Complexes

The City Council has been working with the residents in Fr. Kitt Court to reestablish an annual activity programme to animate the Common Room. Fr. Kitt Spring activities programme commenced on February 27th and will continue until 19th June when the programme will be reviewed in advance of resuming an Autumn Winter Programme. Activities take place on Tuesday afternoons e.g. flower arranging & chair yoga with board games on Wednesday Afternoons. This programme will extend into May and June ending with Afternoon Summer Sizzle Tea Dance in garden area at Fr. Kitt Court.

The Lord Mayors afternoon tea: On May 10th a number of age friendly groups from Bluebell & Drimnagh will enjoy afternoon tea at the Mansion House with the Lord Mayor including Bluebell Sister Shed, Senior Citizen Group and Ladies Club. AGE Friendly Programme/Bealtaine Events

For the month of May the overall South Central age friendly programme will be running in connection with Bealtaine. The uptake for the age friendly events has increased since January and all weekly events are now at 90% capacity, with the exception of the tea dances which are oversubscribed. The senior population of Ballyfermot and surrounding areas are reconnecting with friends and services in the area and are encouraging other seniors who are living alone to attend events.

Walkinstown Age Friendly Spring/Summer Programme commenced on 5th March and has included Holistic days, history talks, dance, Bingo and an Easter tea dance with an Easter bonnet competition. Weeding Programme 2024


Below are Maps highlighting the Roads in the Ballyfermot/Drimnagh LEA that have been selected for weed spray treatment in 2024. The blue line indicates the local authority boundary and the orange identifies the selected roads for treatment. The roads selected covers approximately 56km, in the area which has an estimate road network of 129km. This is the total allocated budget for the Ballyfermot/Drimnagh LEA for weed treatment, plus additional spend from the Local Area Office.


As you can see, we cannot treat all roads in any one year, hence we are implementing a 3 year cycle so that all the roads in our network will get at least one treatment every 3rd year.

Some of the major roads were also included e.g. Ballyfermot Road, as these are high profile roads. This process will be reviewed annually to ensure its effectiveness, while also endeavouring to fairly distribute the limited resources available for weed spraying.


Treatments are due to commence the on the 15th April onwards, weather permitting.

All reports of abandoned vehicles are fully investigated, all abandoned vehicle investigation requests should be routed through Dublin City Council's citizen hub portal. Please note each investigation can take up to 6 weeks to complete, as it may require our staff to write to An Garda Siochana and/or the Motor Tax Office to obtain ownership details on any reported vehicles. When ownership details are obtained the Abandoned Vehicles section are required to inform the registered owner, that their vehicle was reported as abandoned and requesting that they inform them of the vehicles status. If, following a full investigation a vehicle is deemed abandoned, it will be removed and may be stored for up to a month. During this time it can be reclaimed by the owner once all applicable and accumulated fees are paid.

- A vehicle will not be designated as abandoned if it displays current Tax, Insurance or NCT certificates.
- A vehicle cannot be designated as abandoned if the registered owner of that vehicle informs the Abandoned Vehicles section that it is not abandoned.
- Abandoned Vehicles section do not remove or investigate reports of suspected abandoned vehicles which are located on private property only those reported on the public roads, laneways or spaces.

Notification of initiation under Part 8 Planning and Development Regulations 2001 (as amended)

Proposed Development of 108 Residential Dwellings the Site of DCC Road Maintenance Depot at Marrowbone Lane & Forbes Lane, Dublin 8

Dublin City Council wishes to give notice that it intends to initiate the process leading to an application under Part 8 of the Local Government Planning & Development Regulations 2001 (as amended) for the construction of a residential development comprising 108 apartments at a site c. 0.56 ha at the Road Maintenance Depot, Marrowbone Lane and Forbes Lane, Dublin 8. This site will be developed as part of the National Social Housing PPP Programme.

Site Location & Context

The site is located at the existing DCC Road Maintenance Depot, which is due to be relocated. The site is bounded by Marrowbone Lane to the east and Forbes Lane to the north. An existing Eir exchange building is to the west and The Malthouse apartment block to the south.



Figure 1: Site Location Plan.

Proposed Development:

The development proposal was advanced by the Design Team in response to a design brief developed by Dublin City Council. The proposed development has undergone an iterative design review process with key stakeholders including representatives from South Central Area Office, Housing Department and DCC technical teams in consultation with the Project Technical Advisors.

The complex ranges in height from 5 to 7 storey consisting of 108 apartments at a site c.0.56 ha which will consist of the following:

- The demolition of the existing sheds, warehouses, garages and site clearance
- Two apartment blocks (Block A and Block B) comprising 108 residential units (64 no. 1-bed, 31 no. 2-bed, 13 no. 3-bed)
 - ➤ Block A ranges from 6-7 storeys.
 - Block B 5-storeys.
- The removal of the existing boundary wall fronting onto Forbes Lane and Marrowbone Lane and subsequent widening of Forbes Lane to facilitate an active travel route.
- 165 long-stay and 54 short-stay bicycle parking spaces and 2 car parking spaces.
- 190 sq.m of community, cultural and arts space.
- 520 sq.m of public realm space and 700 sq.m of communal open space.
- One vehicular accesses point is proposed from Marrowbone Lane. A pedestrian and cycle access route is proposed at Forbes Lane which also provides emergency vehicle access.
- Boundary treatments, public lighting, site drainage works, internal road surfacing and footpath, ESB substation and meter rooms, stores, bin and cycle storage, plant rooms, landscaping; and
- All ancillary site services and development works above and below ground.

DCC Housing Department with the Project Architects held a public information session on the 14 November 2023. The team presented designs at a point in time during design development.



Health Improvement Programmes in the SCA

- Fatima Fit chair aerobics classes aimed at older adults. Every Thursday from 12 noon in the F2 Centre, Rialto.
- > HITT exercise class aimed at young people who are at risk of or who have dropped out of school. The programme commenced in late April in Ballyfermot Civic Centre.

SCA and Citywide Community Wellness Programmes

The following programmes are delivered in partnership with the HSE and are referral only. Programmes focus on supporting individuals with underlying medical conditions.

- Chronic Obstructive Pulmonary Disease (COPD) Gym and Class sessions every Tuesday and Thursday from 10am in Glin Road, Community Centre, NCA (mixed, all ages)

Active Cities (Citywide)

Active Cities initiatives in the planning/delivery stages include:

Boxing in the Community

The **Startbox** Initiative, a partnership between the IABA and Dublin City Sport & Wellbeing Partnership, represents an ideal way for young people (10 – 17 years) to first engage with amateur boxing, Ireland's most successful Olympic sport. It is delivered by our 5 dedicated IABA/DCSWP Development Officers via local schools (primary & TY level) in communities across the Dublin City area. Approx. 2,000 young people take part each year.

The programme is structured into Bronze (non-contact), Silver and Gold phases. The first phase focuses on general strength & fitness, method and technique. The Silver programme consists of higher intensity sessions & limited contact and the Gold phase takes it to another level (combination of first two levels and progression to contact).

The programme has expanded over the years to include young participants from 7 – 10 years (second class +)
