



**With reference to the proposed grant of a licence of Unit 5, Killarney Court,

Council Report No. 353 of 2016 which was assented to by the Dublin City Council at its monthly meeting held on 5th December 2016 approved terms and conditions for the grant of a further licence of the premises at Unit 5, Killarney Court, Dublin 1 which said premises is more particularly delineated on Map Index SM2010-0101 to Hands on Peer Education Limited (H.O.P.E.) to use for community purposes.

The proposed grant is not yet completed and the Council's Law Department have advised that the correct registered name of the proposed licensee according to the Companies Registration Office is H.O.P.E Hands on Peer Education CLG (Company Limited By Guarantee).

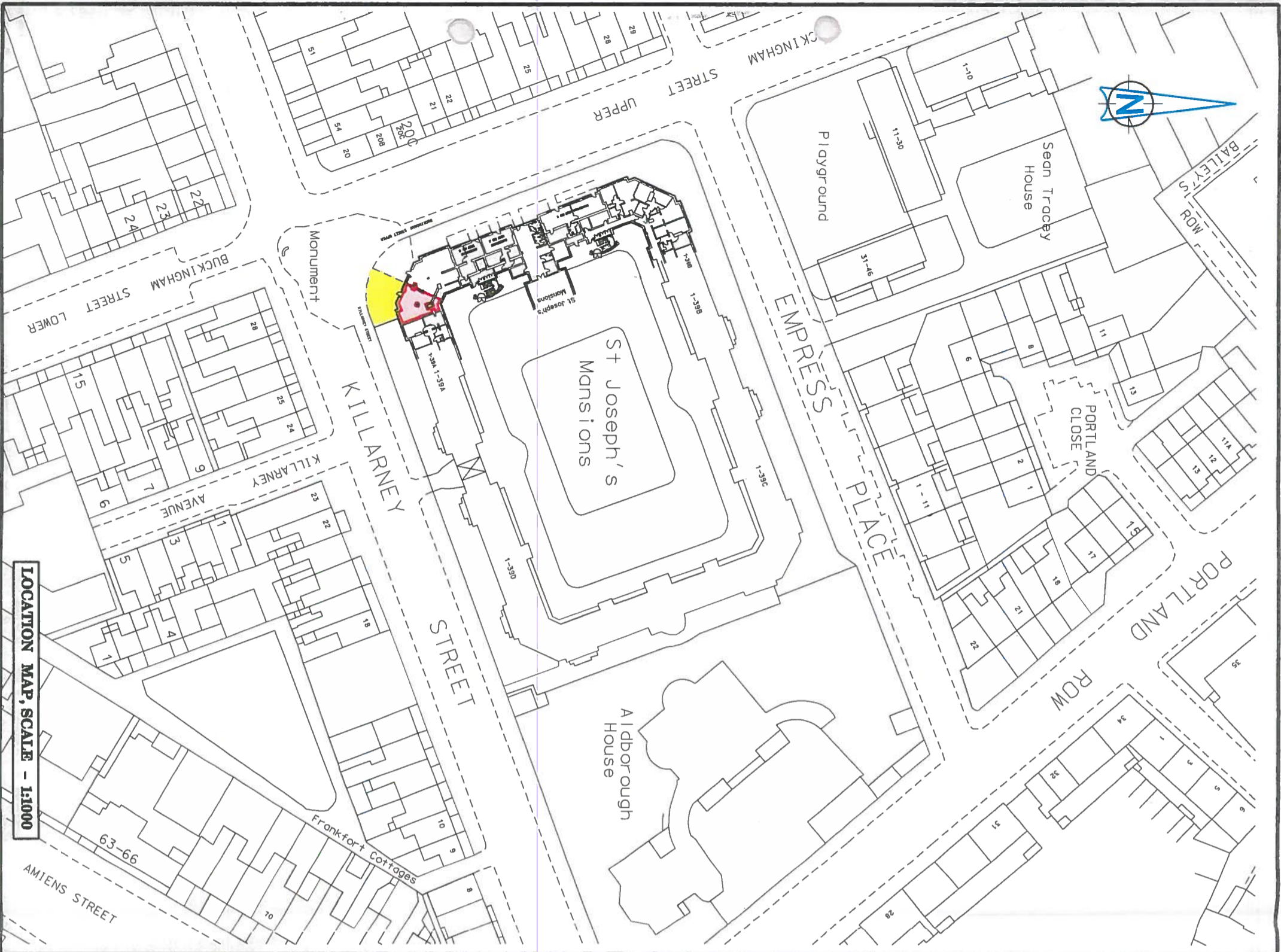
The dates for the performance of any of the requirements of the proposed disposal may be amended at the absolute discretion of the Executive Manager.

The proposed disposal shall be subject to such conditions as to title to be furnished, as the Law Agent in his discretion shall stipulate.

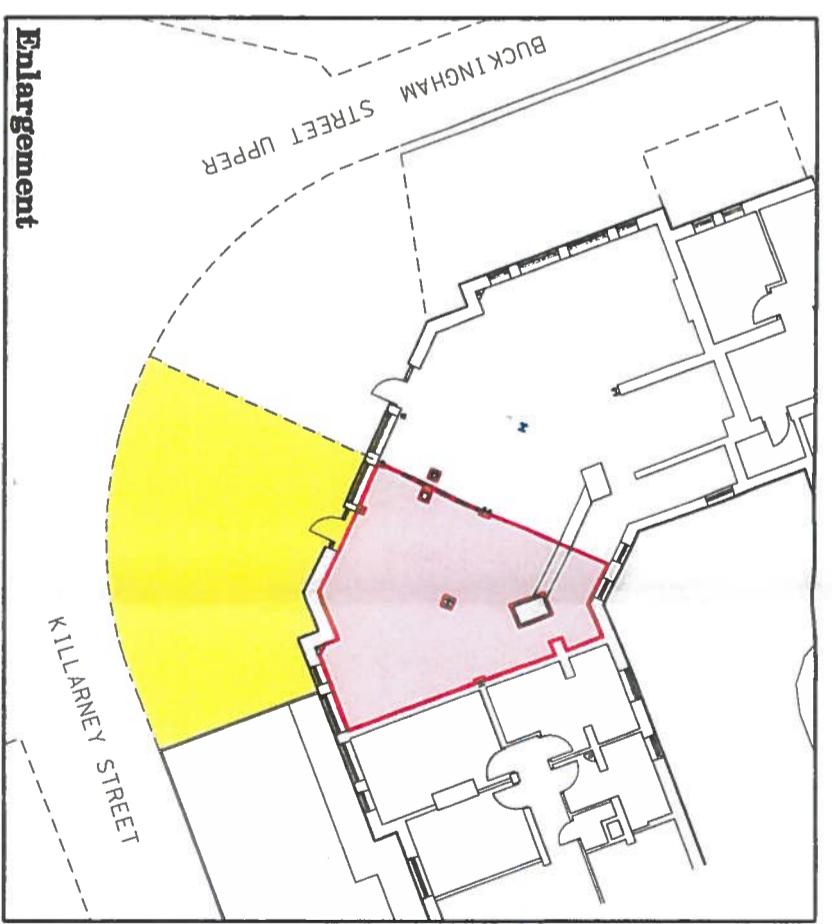
No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.
