#### Reply

As there is a degree of commercial sensitivity on this issue I will not be able to provide a comprehensive update. I can say that with the intervention of Minister Catherine Byrne and through her request the support of the Minister for Finance we have been able to make direct contact with the holders of the loan. We are currently clarifying with Development the real value of the Mill on the market in its current state, and without planning permission for its conversion into residential apartments. Any participation by City Council in bidding for the Mill is dependent on Development and Senior Management and would relate to cost/benefit considerations and a solid commercial case for purchase, restoration and development.

The Mill is a protected structure but is not currently listed on the "at risk" register. The sitting tenant in the Mill is an issue in any purchase offer that would be made by anyone. The site that the Mill sits on is a National Monument and in this regard we will be raising it's future with relevant Government Ministers.

It is our opinion that the Mill if it were developed as a mixed use commercial venture would create an invaluable tourist and business hub in the Kilmainham quarter augmenting existing attractions. In this regard the Mill would need to recognise and celebrate the industrial heritage, while generating income from rental to crafts, food and artistic cultural enterprises that would attract visitors and locals. The costs of refurbishing the Mill and putting it to use would be considerable. One possibility would be a public –private partnership which would be clear about it's obligations to deliver community benefit and facilitate community presence and involvement while at the same time securing a business plan that would generate income to maintain and operate the Mill.

# Q17 Councillor Críona Ní Dhálaigh

To ask the Area Manager what the protocol is regarding waste management provider's responsibility to clean up after they collect bags? Residents in the Dublin 8 area are frustrated that any spillage or mess created during removal is not cleaned up, and can lie for days or they request DCC to clean it or go out and clean it themselves.

#### <u>Reply</u>

Private waste contractors are responsible and expected to clean up and remove any waste that spills during the emptying of their customer's bins or collection of their refuse bags and they could be subject to fines if they fail to do so. In order to issue fines however we would have to be able to associate refuse on the street with a specific waste collection company and prove that this same waste ended up on the street because of improper collection by that company and not as a result of improper presentation by the householder. It is the householder who remains responsible for their waste until it is actually collected by a company and if waste on the street is there as a result of overflowing bags or torn open bags by animals then

they are the people who would be subject to a littering fine rather than a collection company.

The cost of policing waste companies during their street collections to determine if litter on the street is there as a direct result of poor collection practices or failure to clean up afterwards would be prohibitive. All collection companies are aware of their responsibilities in this area and we do have litter wardens who patrol the areas to ensure that householders are presenting waste in a proper manner.

In reality however it is extremely difficult if not impossible to associate litter on the street with a particular collection company or individual householder and regretfully it then falls back on the City Council to ensure that the street is properly cleaned according to an established schedule.

There are already two ramps on the Gurteen Road. This stretch of road is approx 215m long and would meet the criteria for two ramps. Unfortunately any more ramps on the road would not be allowed. Regarding signs, at the entrance to the road there's a "school ahead" (W141) sign. DCC do not provide "Slow Down" signs in residential areas where the speed limit is 50kmh or lower as this would lead to proliferation of such signs throughout the city. The onus is on the motorist to drive with due care and at a speed appropriate for the prevailing conditions

Due to the lack of public land in Drimnagh and the fact that Drimnagh is probably the only community in Ireland with a population over 10,000 people without a library, every possibility needs to be looked at.

#### Reply

The plan to provide a library service for the people of the Drimnagh and adjacent areas has long been identified as a key objective for Dublin City Public Libraries. Identifying an appropriate, available site has proven complicated. As part of the search, Libraries Management have considered a number of options in the area, however, a site that meets best practice criteria for the location of a public library has yet to be identified. These criteria include: being a focal/central point of broad-based community activity, accessibility by public transport, proximity to primary streets and transit routes and having a high level of traffic and pedestrian flow. The criteria are aimed at maximising potential usage of the library from as wide a geographic area as

possible and usage by the community at large, therefore presenting value for investment of public monies. Final location of the library also requires consideration of the likely impact on the existing libraries Walkinstown and Dolphin's Barn.

The site suggested is unlikely to satisfy our criteria: libraries management will continue to investigate sites in the area.

In the meantime the Drimnagh area will continue to be served by the mobile library service and by branch libraries in the adjacent areas of Dolphin's Barn and Walkinstown. Libraries will also explore provision of deposit collections in key community locations and the development of a cooperative outreach programme of story reading, homework support and educational and recreational activities in the area.

## Six important facts about tree topping per ISA:

- Topping will not make trees safe-it actually creates hazardous tree situations.
- Topping destroys a tree's ability to produce food.
- Topping invites disease, insects, defects and rot.
- Topping is expensive and a waste of money.
- Topping creates increased maintenance needs.
- Topping makes trees ugly.

Acquisitions in each area are currently allocated to Band 1 cases and/or other Bands if there are adequate casual vacancies in the area to meet the requirements of our commitments under the Scheme of Lettings Priorities 2013. The overall quotas for the year have not changed but homeless allocations will be prioritised in the early months to alleviate the very critical situation for homeless families and the risk of not having adequate supply of emergency accommodation available to homeless families. There is no deviation from the Scheme however, and allocations will be balanced between bands in line with existing practice.

All homeless allocations are made based on time of list and not based on the type of emergency accommodation the family is occupying.
