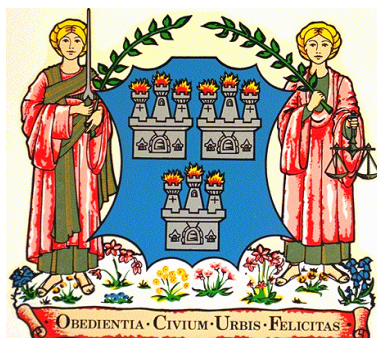

1. The Lord Mayor opened the meeting by expressing condolences on his own behalf and on behalf of the City Council to the families and friends of the following recently deceased :
 - The Crew of Rescue 116 who died in a crash off the County Mayo Coast on 14th March, Dara Fitzpatrick and Mark Duffy whose bodies have been found and Paul Ormsby and Ciaran Smith who are still missing.

- Maureen Haughey, who died Friday 17th March 2017, mother of former Lord Mayor of Dublin, Seán Haughey
 - Martin McGuinness, former Deputy First Minister of Northern Ireland who died Tuesday 2^{1st} March 2017
 - The people who died in London following the attacks at the Palace of Westminster on 22nd March
 - The people who died in St. Petersburg, with whom Dublin has signed a Friendship Agreement, Petersburg following the blast on an underground train
- All stood for a minute's silence as a mark of respect for the deceased.

The Lord Mayor then congratulated Councillor Janice Boylan on the birth of her Baby boy, Bródy, who was born on Sunday 19th March weighing 7lb 9ozs. He also sent best wishes for a speedy recovery to Councillor Tina MacVeigh.

He then proceeded to thank all those involved in St. Patrick's Festival and to acknowledge the work of the St. Patrick's Festival Committee. In particular he thanked all the staff of Dublin City Council who were involved in the Festival in very many ways. These included Dublin Fire Brigade, Chief Executive's Department including the Mansion House staff, the Library Service, Events Team and the Waste Management Teams who were complemented in the media for the speed with which they cleaned the city after the night's festivities. He also thanked the staff of the Waste Water Division who have responsibility for the Lord Mayor's Coach, particularly Joseph Reynolds, who looked after the Coach for the last time at this Parade as he is retiring this year.

The Lord Mayor then informed the Members that the Report of the Moore Street Consultative Group was published on Wednesday 30th March. He thanked all involved in this work under the Chairmanship of Councillor Micheál MacDonncha. The report will go to the Planning SPC and then to the City Council.

The Lord Mayor then went on to thank Councillors for their support during the ongoing situation at Clerys which has been resolved. He wished the new development the best of luck and said he looked forward to its impact on the North Inner City. Many Members paid tribute to the Lord Mayor for his role in resolving the situation.

The Lord Mayor then reminded Members that there will be a Special City Council Meeting on the 18th May in relation to the Poolbeg SDZ. He proposed that the meeting would be followed by an adjourned May Monthly City Council to deal with the motions on the Agenda. Members agreed to this proposal. The Lord Mayor then congratulated the Dublin GAA Football Team on their recent win and wished them every success in the final against Kerry.

The scheme will apply from the date it is made until the 30th anniversary of that date. The scheme may be reviewed periodically by the planning authority having regard to circumstances prevailing at that time.
Dublin City Council will receive the contributions to be made under this scheme and pay them to NTA or such other body as may be authorised to perform its functions in accordance with an agreement to be made with it. Pending completion of that agreement Dublin City Council will retain the contributions collected and pay to NTA or such other body as may be authorised to perform its functions when the agreement is concluded. The agreement with NTA or such other body as may be authorised to perform its functions will provide that the contributions received by Dublin City Council under this scheme shall only be used for the LCC project"

It was proposed by Councillor D Lacey and seconded by Councillor A Feeney "That Dublin City Council notes the contents of Report No 137/2017". The motion was put and carried.
49. Topical Issue – The Members discussed the Bus Eireann Dispute
50. Emergency Motion – The City Council suspended Standing Orders to agree the following emergency motion without debate -:
"This Council instructs the Chief Executive to refrain from releasing press statements in the name of Dublin City Council that are not reflective of the agreed position of the elected members. The press statement released by the Chief Executive on 7th March in relation to the Dublin Fire Brigade dispute was contrary to the position of the elected members who passed an emergency motion at the January council meeting supporting the current Dublin Fire Brigade Emergency Medical Services. The Chief Executive is free to issue statements in the name of the Council Executive"

51. The City Council agreed to defer the following motion in the name of Councillor T MacVeigh to the next meeting of the City Council to be held on the 8TH May 2017 "To honour the memory of Savita Halappanavar, who tragically lost her life as a consequence of the Irish State's barbaric and antiquated attitudes to women's reproductive rights, that a street in our capital city be named in her memory"

52. The City Council agreed to a proposal by Councillor L O'Toole that Motion No 2 in his name on the Agenda Paper be swapped with Motion No 19. Accordingly it was proposed by Councillor C O'Moore and seconded by Councillor G Kelly - :

"To call on the Irish government to ratify, as soon as possible, The Convention against Trafficking in Human Organs which was adopted by the Council of Europe on 9 July 2014 in order to criminalise illegal organ transplantations [1]. The Irish Government has already signed this convention, but is yet to ratify it.

To call on the Oireachtas Foreign Affairs committee to follow through on the pledge made by the Oireachtas Sub Committee on Human Rights to "investigate to the maximum extent possible" [2], persistent, credible reports of forced organ harvesting and other severe human rights abuses imposed on Falun Gong practitioners and other prisoners of conscience in China.

To call on the Chinese government to end its practice of forced live organ harvesting of prisoners of conscience. And release all illegally detained Falun Gong practitioners in China"

The motion was put and carried.

53. The following motion submitted by the North West Area Committee was agreed by the City Council *"The North West Area Committee notes the lack of transportation and infrastructure in the North West Area and welcomes any solution including the proposed Metro North. We call for it to be given a full evaluation by the Minister"*.

The meeting concluded at 9.30pm in accordance with Standing Orders and all items remaining on the Agenda were deferred to the next meeting of the City Council to be held on the 8th May 2017.
