In addition, a 30 km/h speed limit has been proposed for Rathdown Park as part of phase 3 of the Dublin City Council Speed Limit Review 2016. Rathdown Park / Rathdown Drive have on street parking which narrows the available carriageway width. These roads are traffic calmed to ensure slower vehicle speeds Upon exiting the car park vehicles should be travelling at slow speeds which are appropriate and be conscious of pedestrians in an urban environment. Under the Road Traffic Act "A person shall not drive a vehicle in a public place without due care and attention". Following investigation a "children crossing" sign (W142) is recommended at Rathdown Park (at junction with Rathfarnham Road) as it is the entrance to a housing estate from a main traffic route.	0	27/01/2017

The total width of Rathfarnham Road is 11m to accommodate an inbound nearside bus lane and offside vehicular lane and an outbound advisory cycle lane and vehicular lane. There is no adequate width to accommodate a double D traffic island on this road. As a result vehicles may drive on the advisory cycle lane causing a potential hazard for cyclists. • It is not a safe location due vehicles turning out at Lidl through Rathfarnham Road and could produce a potential accident. • Furthermore, there is a pedestrian crossing 50m from this location.
