On 13<sup>th</sup> April 2017 the Tánaiste & Minister for Justice and Equality, Frances Fitzgerald T.D., announced a new grant aid scheme for community-based CCTV systems. Under the scheme, eligible community groups may apply for grant-aid of up to 60% of the total capital cost of a proposed CCTV system, up to a maximum grant of €40,000. A total of €1million is available nationally; scheme will run for 3 years with funding of €1 million available each year.
